### **Report of Annual Meeting**

The Fourteenth Annual Meeting of the Duluth Branch of the Woman's Auxiliary was held in the crypt chapel of Trinity Pro-Cathedral, Duluth, June 2nd, 1910.

The opening service at 9:30 a. m. consisted of a celebration of the Holy Communion with a sermon by the Bishop of the Diocese.

At half past ten the meeting was called to order for business, with the President, Mrs. J. D. Morrison, in the chair.

Roll call was responded to by delegates from the following parochial branches: St. Paul's, Duluth; Trinity, Duluth; St. John's, Lakeside, Duluth; Epiphany, Beaulieu; St. John's, St. Cloud; St. Paul's, Breckenridge.

The President read her address, giving a survey of the various departments of the Diocesan Branch and appealing to the members of the Woman's Auxiliary for renewed effort as individuals to increase the membership and influence of the association.

Mrs. Cameron Mann, wife of the Bishop of North Dakota, being introduced, the meeting rose to greet her. She gave an enthusiastic report of what has been done in the North Dakota Branch, by determining to do, and working toward definite aims.

A motion that the minutes of the last annual meeting stand approved as printed in the Thirteenth annual report was carried.



The Corresponding Secretary's report was read and approved.

The Treasurer's report was read and referred to the Finance Committee: Mrs. McBain, Mrs. J. Lonegren, Mrs. Evered.

The following nominating committee was appointed by the President with instruction to report after luncheon: Miss R. Hunter, Mrs. William A. Pryor, Mrs. Thomas S. Wood.

A letter of greeting from Miss Emery was read by the President.

Deaconess Rutledge, one of the guests of honor, spoke to the women of the Auxiliary of her work in Manila, describing the home life and conditions of the natives; telling of the special need of settlement work, of hospitals and schools. She also suggested that even small gifts of articles for the chancel would be acceptable.

An address of greeting, followed by noonday prayer, was given by the Dean of Trinity Pro-Cathedral.

The following reports were accepted: Junior Auxiliary, Little Helpers, Box Custodian, Church Periodical Club, the Committee on Plans of Work, and the Diocesan Box Committee.

On motion it was decided that the offering of The Little Helpers be used as recommended by the Secretary of that branch.

The Secretary of the Church League of the Baptized having removed from the Diocese, there was no report. Many expressions of regret were heard because of the absence from our meeting of the Secretary, Mrs. F. B. Millard, of Willow River.

A report of parish work was given by Mrs. A. Carlson, of St. Cloud.

Luncheon was served in the Guild Hall by the ladies



of St. John's, Lakeside; Holy Apostles', West Duluth; St. Luke's and St. Peter's, West End.

Calling the meeting to order for the afternoon session, the President spoke of the loss of a son by death in the family of one of our Indian clergy, and of the means by which it was hoped to obtain a memorial.

Mrs. Lonegren reported the organization of a society called "The Silver Guild" in honor of the Rev. Percy Silver. It was suggested that the Guild be affiliated with the Woman's Auxiliary; and the methods of the Guild were recommended to the committee on Plans of Work.

The Chairman of the Finance Committee announced the Treasurer's report correct.

As at the Triennial meeting held in Richmond in 1907, resolutions were carried making officers of Diocesan Branches only eligible as delegates to the next meeting, upon motion it was voted that we create additional officers in the Branch in order that our Diocese may be properly represented at the Triennial meeting to be held in Cincinnati, October 5.

The report of the nominating committee was read, and on motion the Secretary was instructed to cast the ballot electing the following officers:

Standing committees were appointed by the President.

The President gave an explanation of the methods and aims of the church League of the Baptized.

Resolutions from the North Dakota and Connecticut Branches regarding representation at the Triennial meeting were read by the President and the following resolutions presented for the consideration of the Duluth Branch:

**RESOLVED:**

1. That the delegates to the Triennial be elected by each Diocesan or Missionary Branch of the Woman's Auxiliary, or appointed by the Bishop, from the active membership of the Auxiliary.

2. That each Diocese shall be entitled to five delegates, and each Missionary District to three delegates, with the privilege of alternates; and that their names be sent to the General Secretary at least one week before the Triennial meeting.

3. That the Presiding Officer at the Triennial be nominated by a Committee appointed by the President of the Branch in the Diocese where this meeting is held, and elected at the first business-meeting.

By vote the resolutions were adopted and the Corresponding Secretary instructed to send copies to Presidents of the Diocesan Branches.



Upon motion it was voted that the morning offering of \$8.50 be devoted to the Central Expense fund.

Upon recommendation it was voted that the \$18 in the treasury of the Junior Branch be used as follows:

### Corresponding Secretary's Report

In reviewing the work of the Auxiliary in the Diocese of Duluth, the Corresponding Secretary finds that there are eleven organized branches with a membership ranging from one to fifty. Two of these branches have been organized within the last year.

Gifts of articles for the Diocesan Box, as well as money have been received from eight parishes, where there are no organized branches, making a total of nineteen parishes in the Diocese, contributing to the work of the Woman's Auxiliary.

It has been suggested that in parishes where it is impossible to organize branches for contributing money to the general fund, that Study Classes be formed sup-



plementary to the Diocesan Branch. These could be made live and attractive meetings by using some of the enthusiasm and methods which are devoted to clubs. Excellent outlines of study can be had and the "Spirit of Missions" of itself would prove most interesting and instructive. A few such study classes here and there would soon become a great power.

During the year the Secretary has distributed numerous leaflets from the Missions House in New York among the several branches, also annual reports of the Diocese and from the Board of Missions.

Of the twenty report blanks sent out only seven have been filled in and returned. The Secretary would urge on the branches the necessity for these blanks being promptly returned as they are valuable in making out the Secretary's report.

However, in spite of some discouragement, we trust that this work of the church kindergarten for the very little ones, too young for the Sunday school, but not too young to be trained and guided to the baby prayer and the baby gift, has been the beginning of a lasting result in the lives of some of our children, now growing up, who continue faithful in this lesson so early begun.

Our parish secretaries have as usual shown every desire to promote our work. One gathered the mothers and children together for an afternoon party; hymns, a prayer, and the opening of the boxes, with a short explanation of the aims and the work of the branch evoked every interest in the hearts of those present.

It was a surprise to some to learn how widely this work has extended from its simple beginning; being now active in 66 dioceses, with a year's gifts of almost six thousand dollars.

Our efficient secretary at Willow River we part from with much regret. At Minneapolis, where her home will be, is a flourishing branch of our society to which she may transfer her interest, and we hope her successor at Willow River will find her duties made easy by the good work already begun there.

From our Little Helpers will go nine dollars, next October, to the great triennial thank-offering of the women, children and babes of the church. One of our



delegates will have the pleasure of offering this gift then, and it is not yet too late to have the gift enlarged if any of our readers wish their little ones, not already in our band of helpers, to have a share in this "giving of thanks and meek service."
