### REPORT OF ANNUAL MEETING.

The Sixteenth Annual Meeting of the Duluth Branch of the Woman's Auxiliary was held in Trinity Pro-Cathedral, Duluth, June 6, 1912; the business meeting being preceded by a celebration of the Holy Communion with a sermon by the Bishop.

Following the address of welcome and cheer by the President, Mrs. J. D. Morrison, roll call was responded to by delegates from parish branches, as follows: Epiphany, Beaulieu, 1; St. Paul's, Brainerd, 1; Prince of Peace, Cass Lake, 1; St. Paul's, Duluth, 11; Trinity, Duluth, 9; Christ Church, Hibbing, 1; St. John's, Lakeside, Duluth, 2; St. John's, Red Lake, 2; St. Stephen's, Paynesville, 1; Holy Apostles, Proctor, 2.

Christ Church, Crookston, 1; St. Paul's, Duluth, 2.

Upon motion it was voted that the minutes of the last annual meeting be accepted as printed in the Fifteenth Annual Report.

The Corresponding Secretary's Report was read and approved.

The Treasurer's Report was read and accepted.

The President called attention to the matter of apportionment; and instructed the delegates, that in order that offerings from the Auxiliary may be credited on Parish and Diocesan apportionment, all money



coming under that head should be sent direct to the Treasurer of the Woman's Auxiliary, to be sent by her to the Diocesan Treasurer and by him to the Board of Missions. In this way the Woman's Auxiliary, the Parish, and the Diocese, each are credited with the amount given.

The report of the "Little Helpers" was read, and the motion that it be accepted and money applied as suggested by the Secretary, was carried.

Noonday prayer was offered by the Rev. Mr. Hedlund of Crookston.

The report of the Secretary of Juniors was read and approved.

The report of the Secretary of the Church Periodical Club, Mrs. F. C. Berry, was read and accepted.

It was voted that Mrs. Berry be given a vote of thanks for her valuable suggestions.

The Report of the Secretary of the Church League of the Baptized, was read and accepted.

Following a discussion, the suggestion was approved, that Parish Guilds be asked to contribute to the United Offering as well as to the Diocesan Box.

The meeting was adjourned for luncheon, served by the ladies of St. John's, Lakeside, and St. Andrew's, Park Point, to be again called to order at one o'clock and opened with the singing of a missionary hymn.

Miss Grace Lindley of New York, was introduced by the President and the entire meeting rose in welcome. Miss Lindley addressed the women of the Auxiliary on the value of prayer and of the fulfillment of opportunity.

Miss Johnson, daughter of the clergyman of



White Earth, gave an interesting talk on industrial work among the Indians of Red Lake, where she is now a missionary worker, supported by the United Offering.

Miss Baker, lately returned missionary, from St. Hilda's school, for girls in Wuchang, China, being introduced and welcomed, gave a talk on the value of the work being done in China; the intellectual growth of Chinese women; the attitude of men of China toward the educated woman; and of the need of money for the furtherance of the work there.

Upon motion it was voted that the morning offering be given, as a nucleus, toward building a home for the workers at St. Hilda's school.

Reports were given by the Educational Vice Presidents: Mrs. W. H. Gemmell reporting for the Mississippi Valley Deanery, and the President reading a letter from Mrs. J. A. Brown of the Red River Valley Deanery, and a verbal report of Mrs. F. W. Paine's work in the Duluth Deanery.

The nominating committee presented the names of officers appointed by the Bishop, and the list was duly approved as recorded on page 2.

Two minute reports were heard from the following branches: St. Paul's, Brainerd, Mrs. W. H. Gemmell; Epiphany, Beaulieu, Mrs. Kah-o-Sed; Prince of Peace, Cass Lake, Mrs. Parshall; Holy Apostles, Duluth, Mrs. N. B. Morrison; St. Paul's, Duluth, Mrs. Kempton; Trinity Pro-Cathedral, Mrs. W. E. Jones; Christ Church, Hibbing, Miss Davidson; St. John's, Red Lake, Miss Johnson; St. Stephen's, Paynesville, Mrs. T. C. Hudson.

By vote, the President was empowered to appoint



delegates to the Sixth Missionary Department Meeting to be held at Grand Junction, Colorado.

A balance of \$2.50 toward the assessment of the Diocese for the expense of the Department Meeting was reported, and the following pledges made to complete the necessary five dollars; St. Paul's, Duluth, \$1.50; Prince of Peace, Cass Lake, \$1.00.

Pledges were given to General Missions: St. Stephen's, Paynesville, \$5.00; to Diocesan Missions, Trinity Pro-Cathedral, \$25.00.

The meeting was closed with the singing of the Doxology and adjourned.
