REPORT OF ANNUAL MEETING.

The Seventeenth Annual Meeting of the Duluth Branch of the Woman's Auxiliary was held in St. Paul's Church, Duluth, June 5, 1913; the business meeting being preceded by a celebration of the Holy Communion.

The business session opened with noonday prayer by the Rev. Wm. H. Ward. One of the prayers, being, as formerly resolved, for every annual meeting, the prayer from the Burial Service, beginning "Almighty God, with Whom do live the Spirits of those who depart hence." This is offered in memory of Mrs. Twing, the Founder of the Woman's Auxiliary. We are so apt to forget to whom, under God, we owe our great foundation, that it was thought fitting to include this prayer in our regular Opening service. The roll call was responded to by nine parishes: Holy Apostles, Proctor, 2; Christ Church, Crookston, 1; St. Paul's, Duluth, 17; Trinity, Duluth, 5; Christ Church, Hibbing, 1; St. John's, Lakeside, 2; Good Shepherd, Leech Lake, 1; St. John's, Onigum, 1; St. John's, Red Lake, 1; St. Colombia, White Earth, 1; Royalton, unorganized work, 1.

JUNIOR BRANCHES.

Christ Church, Crookston, 1; St. Paul's, Duluth, 1.

The President in her address of welcome, which will be found in the July issue of the Duluth Churchman, urged the forming of new Junior branches, since

the future of the missionary work depends so much on the training of the children.

Upon motion it was voted that the minutes of the last annual meeting be adopted as printed in the Sixteenth Annual Report.

The report of the Corresponding Secretary was read and approved.

The meeting adjourned for luncheon served by the ladies of St. Paul's, and was again called to order at half past one o'clock, being opened with the singing of a missionary hymn.

The Treasurer's report was read and, after having been referred to an auditing committee, was approved.

Reports of the following officers were read and adopted: Secretary of the Junior Auxiliary, Secretary of the Little Helpers, Box Custodian, Secretary of the Church League of the Baptized.

Owing to illness, there was no report from the Secretary of the Church Periodical Club.

The Educational Committee reported aggressive work done in the distribution of literature and in the gaining of new subscriptions to the Spirit of Missions, and a district meeting held in Brainerd at the time of the deanery meeting.

The reports of the woman missionary workers at Onigum and Red Lake were very encouraging. They told of the industrial work and also of the missionary work done by the Indian women.

The nominating committee presented the names of officers appointed by the Bishop, and this list was approved.

It was voted that the morning offering be turned into the Central Expense Fund.

The suggestion of the President, that the Episcopal Churches of Duluth give a missionary pageant to raise missionary money for the Junior Auxiliary, was enthusiastically received. It was voted that Mrs. Morrison be requested to prepare an outline for this pageant and that it be given next fall.

The President then pointed out to the delegates the clause in the constitution which makes necessary the payment of all moneys from the various branches to the Treasurer of the Society. This should be done at least a week before the Annual Meeting that her report may be full and accurate. Several complaints have been made that money sent was not properly reported from New York. In these cases it has been owing to the fact that the money was sent too late to be incorporated in the Treasurer's regular report.

The President then introduced Miss Smith, the Extension Secretary of the Minnesota Diocese, who gave an inspiring and helpful address on Methods of Mission Study.

Short reports were given by the representatives of parish branches.

Nominations for delegates to the General Convention to be held next fall in New York were as follows: Mrs. A. W. Ryan, Mrs. Page Morris, Mrs. T. S. Wood, Mrs. James D. Morrison from the Woman's Auxiliary, and Mrs. James Wanless from the Junior Auxiliary. By vote the Secretary was empowered to cast a ballot in favor of these delegates.

It was voted that the following nominating committee be accepted: Mrs. Page Morris, Duluth; Mrs. Ward, Fergus Falls; Mrs. Durant, Hibbing; Mrs. J. E. Bowers, Duluth, Mrs. Hedelund, Crookston.

A motion was carried that a vote of thanks be extended to the ladies of St. Paul's Church for the luncheon.

The meeting closed with the singing of the Doxology.

JUNIOR AUXILIARY.

I have to report from Crookston (Christ Church), a Junior Branch of 25 members. This branch is organized under the name of St. Katherine's Guild, but studies about missions, and gives to missions, as well as to parish necessities. It was organized a year ago, and has accomplished much under the able leadership of Mrs. Hedelund, wife of the Rector. At Little Falls there is a Junior branch, with eight members, under the leadership of Miss Lucy Warner. Hibbing reports a membership of ten, with Miss Florence Davidson as leader. For lack of a leader, the branch of Trinity Pro-Cathedral has suspended active work, but has good hope of resuming its activities in the autumn. The former very efficient leader, Mrs. Spangenberg, moved to St. Paul, much to the regret of the children, who loved her dearly. Trinity Juniors, however, sent their usual Christmas Tree box to the Indian School at Vermilion Lake, valued at \$25.59.

BRANCH.

Letters and leaflets have been duly sent out to the branches on the secretary's roll; but less has been accomplished this year than formerly, due perhaps to the little members growing older and so entering the Sunday School and their places not being filled up by other little ones. But we are glad to know that the mothers whose children belong are quite interested and fully aware of the far reaching influence of the earliest lesson this society strives to teach, and they cordially acknowledge how quickly even the very young children form the habit of dropping the pennies into the box, while the older ones become glad and eager to do their part in this simple work of prayer and gift, together, for other little children. This thought is an encouragement (were it needed) to the branch secretaries to persevere in enlisting the mothers and babes into our band. The board asks the sum of \$5,000, which indicates the power of many small helpers towards completing a large result; and that amount has been given more than once before in the history of this work.

Then, too, our Little Helpers will have their tiny gift added for them to the great triennial Thank offering of the women, children and babes of the Church, to be made in New York next October.
