ANNUAL REPORT OF THE JUNIOR AUXILIARY.

Owing to sickness, the secretary was unable to send out the blanks to be filled and returned, so that our reports seem meagre. At a late date, the corresponding secretary sent out some blanks, but so far, we have but five responses.

St. Andrew's Branch, Cloquet, reports the sum of \$59 raised, \$34.83 of which was given in their own parish, and therefore does not count in the Missionary report. Twenty-five dollars they gave to general Missions.

The Church of "Our Saviour," Little Falls, reports two boxes sent, one to Cass Lake Indian School, and one to St. Mark's Hospital, Nenana. They are valued at \$10 and \$4.75 respectively.

St. Peter's, Duluth, reports the making of a quilt, valued at \$2.50 to be sent next Fall, and two scrap Books (value 50 cents), also \$5.00 sent for General Missions and 50 cents to Current Expense Fund.

St. Paul's Branch, Duluth, reports eleven members. They have been very successful in raising money. They have sent \$15 toward the apportionment of the Parish, and at Christmas they sent a box to Nebraska, valued at \$30.

St. John's Branch, Lakeside, has given the required amount of fifty cents to Central Expense; one dollar to the United Offering, and three dollars to General Missions.

Trinity Cathedral Branch, has 15 members. They sent a box valued at \$6 to Cass Lake, and in money they sent \$10 to Archdeacon Parshall for relief of

destitute Indians, \$15 to the Board of Missions for Bishop Rowe's work in Alaska, and \$5 to General Missions, to apply on the Parish apportionment. They also joined with the S. S. in a box to the Vermilion Lake Indian School Xmas tree, valued at \$14.25.
