MINUTES OF THE ANNUAL MEETING, 1920

The Twenty-Fourth Annual Meeting of the Duluth Branch of the Woman's Auxiliary was opened in Trinity Cathedral, June 2nd, 1920, at 9:30 a. m. Conjointly with the clergy and delegates attending the Diocesan Convention, the women made their Corporate Communion.

At the close of the Service, the business session was opened in the Bishop's Chapel, with Mrs. Morrison in the chair. The Roll Call showed an attendance of twenty—a small but interested group. This number was augmented later. The minutes of the last Annual Meeting were approved as printed in the Journal. The reports of the Corresponding Secretary-Treasurer were read and approved, the financial report subjected to the Auditing Committee's approval. By vote it was decided to publish last year's report of the Box Committee in this year's Journal, since it was accidentally omitted last year. Then followed reports of the various departments of work, viz.: The United Thank Offering, reported by Mrs. Le Quesne, Treasurer of that fund, showed a total of nearly \$1000 and brought out the suggestion that the Second Sunday in September be generally observed in the Diocese as Blue Box Sunday; The Junior Auxiliary, reported by Mrs. La Londe, President, showed 13 working organizations in the Diocese, and 75 communications sent out; The Church Periodical Club, reported by Miss Warner, who was unable to be present, showed a year of splendid activity; Mrs. Jamar's report on the State of the Auxiliary-at-Large was full of interest and enjoyed by all; The Little Helpers' report showed a total offering of \$16.58, which was disappointing to Mrs. Miner, our faithful Secretary, who begged for renewed interest in this branch of the Auxiliary work. All of these reports were accepted as read.

It was decided by vote that the Juniors' Central Expense fund be paid by the Auxiliary.

The President gave her Annual Address, welcoming the delegates as members of one household, the Church, and carefully explaining to them the new changes which have come into the Auxiliary since the Triennial last October, closing with an earnest plea that every Church woman make the Auxiliary work a vital factor in her life.

Luncheon was served at 12:30 by the guilds of the several city parishes in Trinity Hall. One hundred and ten guests sat down to a most delicious repast.

The afternoon session opened at 2:00 p. m. in the Guild Room of St. Paul's Church. The Rev. Joseph A. Ten Broeck of Calumet, Michigan, addressed the women on the plan of the Church Service League, explaining its purpose and showing how he had made a practical application of the idea in his own parish, uniting all the parish activities under the one head of the Woman's Auxiliary with five departments, viz., Missions, Social Service, Religious Education, Personal Religion, and Parish Aid. He particularly emphasized the work of Americanization as part of every parish program.

Mrs. William Sargent spoke informally of the Americanization work done during the year by the Cathedral branch of the Auxiliary, especially of the assistance rendered the Home Demonstration Bureau and the Neighborhood Visitor of the Board of Education. Mrs. Couper, President of the Cathedral branch, spoke of the various ways by which her branch had reached out into the five fields of service; the parish, the community, the diocese, the nation and the world.

A motion was made and carried to appropriate \$5.00 from our Central Expense fund to pay our quota of the general expenses of the Provincial Synod.

The following resolution was read by Mrs. Couper and was adopted by a rising vote:

"Whereas Mrs. J. D. Morrison, the wife of our beloved Bishop, has for twenty-one years faithfully and zealously served as President of the Diocesan Branch of the Woman's Auxiliary, and whereas she

has herself stated that she must decline re-election, feeling that this is the psychological moment for such action, inasmuch as the Auxiliary is passing into a new and larger life,

"Therefore, Be it Resolved,

"That we, the members of the Woman's Auxiliary in Annual Session, do hereby express our great appreciation of Mrs. Morrison's many years of devoted and unstinted service. Her leadership has always been an inspiration and its influence will continue to be a benediction upon the Diocese."

Mrs. Morrison gracefully thanked the women of all the Auxiliary branches for their support during her twenty-one years as President.

The Auditing Committee reported the Treasurer's accounts to be correct.

The report of the Nominating Committee, whose list of names had been approved by the Bishop, was adopted as read.

The report of the Committee on Constitution and By-Laws was, with a few amendments, adopted as read. It will be found at the close of this report.

Members were asked to sign petitions at the close of the meeting and to write personal letters to Congressmen and others that legislation become effective to protect the natives of Alaska from the inroads made by the Salmon Canneries upon their chief source of food supply, the fish of the Alaskan waters.

Mrs. Parshall, our Mission worker at Cass Lake, gave a splendid account of her work and recommended that a fund be started for the education of an Indian boy looking to his entrance into the Church's ministry, that he might, as far as education and equipment go, take equal rank with his white brother. The recommendation was unanimously adopted, and the Parshall Memorial Scholarship became a fact by the immediate pledging of nearly one hundred dollars. It was the sense of all the members present that this scholarship be the united work of the Diocesan Auxiliary.

Mrs. Couper, the new President, took the chair, and as her first official act appointed a Committee composed of Mrs. J. D. Morrison, Mrs. F. W. Paine, Mrs. H. F. Parshall and Mrs. J. G. Ward to devise ways and means to complete a fund of at least two hundred dollars for the H. F. Parshall Memorial Scholarship, to be in the hands of the Bishop by the first of August of this year.

With the presentation to the retiring President of an exquisite corsage bouquet of roses and lilies-of-the-valley from the Auxiliary, the Annual Meeting of 1920 adjourned.

REPORT OF TREASURER OF UNITED THANK OFFERING

The amount from our Diocese which was carried to Detroit and presented at the great Triennial Service in 1919 was Nine Hundred Forty-three Dollars and Forty-nine Cents (\$943.49).

At the Triennial of 1916 we sent Three Hundred Twenty-seven Dollars and Eight Cents (\$327.08). We were glad to have nearly trebled this amount in 1919. We might have trebled it really, for three branches sent in an amount totalling forty-three dollars and sixty-six cents (\$43.66), but the draft was returned to us from New York too late to apply.

REPORT OF CHURCH PERIODICAL CLUB

We have Seven Librarians in the Diocese and some other scattered work is being done.

The Guild, Grace Church, Royalton (Mrs. E. H. McGonagle, Librarian), subscribes for 2 copies of "The Witness" for clergymen.

The Guild, St. Paul's Church, Virginia, gives 2 subscriptions to "The Witness" and sends one other church paper and odd magazines.

St. Paul's, Duluth, until recently, had Mrs. L. W. Micks for Librarian, sends 9 magazines regularly.

Trinity Cathedral, Duluth, has Mrs. L. W. Micks for Librarian, but she received her appointment too late to make a report.

St. James, Fergus Falls (Mrs. James S. Brown, Librarian), reports 4 magazines regularly.

St. Stephen's, Paynesville (Mrs. T. C. Hudson, Librarian), reports 5 magazines sent regularly.

St. John's, St. Cloud (Mrs. Frank Beaver, Librarian), reports 2 magazines sent regularly and miscellaneous magazines sent at odd times.

Church of Our Saviour, Little Falls (Mrs. H. H. Tanner, Librarian), reports 3 subscriptions to magazines besides those of "The Witness" and "The Spirit of Missions" for the Carnegie Public Library in the town; 8 magazines sent regularly; "Old Young Churchman" sent monthly to 4 families and 1 Church School; miscellaneous magazines sent frequently to 7 different addresses; used material of The Christian Nature Series and odd Pussy Pictures to a mission worker; six weeks' subscription to "The Witness" sent to all the families in the parish during the General Convention and Nation-Wide Campaign.

In a small way we are trying to keep Church books of various kinds in circulation. They were sent to four isolated Church women and kept in circulation in the Parish, especially during the Lenten season.

Three dollars were sent to the Treasurer of the Church League of the Isolated and the names of several isolated people were sent to the Secretary that they might receive the magazine published for them. Many of the addresses of the magazines sent are furnished by the National Secretary.

If any officer of a Guild or of a Church School would like to have addresses for magazines or for Church School Lesson material, which is very much needed in weak parishes, the Correspondent would be glad to furnish addresses if she is communicated with.

The work has been disappointing, since nothing has been gained in outside parishes. A new Secretary from St. Cloud or Duluth might get better results.

Twelve working Junior Auxiliary Branches are reported at the present time.

Seventy-five letters and post cards have been written since last November and twenty-two have been received.

Ten leaflets on Mission Work in Africa have been sent to Junior Branches.

Ten Copies of the Junior Prayer have been sent out.

Thirteen sets of Missionary Questions have been sent to Junior Branches, the best set answered and returned to receive a pennant.

The following Parishes and Missions are reported as having organized Branches of the Junior Auxiliary:

St. Paul's, Brainerd; St. Paul's, Duluth; Trinity Cathedral, Duluth; St. James, Fergus Falls; Our Saviour, Little Falls; St. John's, Moorhead; St. Stephen's, Paynesville; Breck Memorial Mission, Ponsford; Good Samaritan, Sauk Centre; St. John's, St. Cloud; St. Helen's, Wadena.

At St. Paul's, Virginia, the Rector has appointed a Junior leader and an organization is soon to be expected. At St. Peter's, Cass Lake, Mrs. Parshall promises to organize a band in the autumn.

At the Triennial in 1916 a plan was proposed for the Junior Auxiliary, to be experimental 1919. This plan was to do all the Children's Missionary Work through the Sunday Schools. The plan has been tried, and at Detroit last October a resolution was passed separating the Junior Auxiliary from the organization of the Woman's Auxiliary, yet keeping in touch with the Woman's Auxiliary by retaining a Junior Officer in each Diocese as a member of the Woman's Auxiliary Board and one member of the Woman's Auxiliary as a member of the Junior Board.

This resolution also expresses the purpose of the Junior officers to merge the Junior Auxiliary as speedily as possible into the Church School Service League with a National Central Committee and a Diocesan Central Committee.

WOMAN'S AUXILIARY

Diocese of Duluth

CONSTITUTION

ARTICLE I.

Name

The name of this Association shall be the Duluth Branch of the Woman's Auxiliary to the Presiding Bishop and Council.

ARTICLE II.

Object

The object of this Association is—

(a) To unite all the Parishes and Missions in this Diocese in the Missionary work of the Church.

(b) To promote the study of Missions, to encourage prayer for Missions and to disseminate Missionary information throughout the Diocese, especially among the children of the Church.

(c) To promote Religious Education and to engage in Social Service Work.

ARTICLE III.

Membership

SECTION 1. Every baptized woman in this Diocese is a possible member of this Auxiliary, and every one who contributes systematically becomes an enrolled member.

SEC. 2. All Parish Societies who so desire, may become branches of this Association by appointing a Secretary-Treasurer and notifying the President of their intention to work in unison with this Association. The Secretaries of Parish Branches are required to report to the Diocesan Officers all work done outside their own limits, **and to transmit to them all moneys.**

ARTICLE IV.

Officers

The officers of this Association shall be a President, a First Vice-President, a Second Vice-President, a Manager for each Deanery, a Recording Secretary and a Corresponding Secretary and Treasurer, a Secretary of the "Little Helpers," a Secretary of the Church Periodical Club, and a Treasurer of the United Thank Offering. At the Annual Meeting there shall be elected a committee of five who shall represent each section of the Diocese, and this committee shall nominate Officers of the Branch to the Bishop, who shall have the power of appointment at his discretion. They may then be approved by the delegates at the Annual Meeting. These officers, when so appointed, shall, with the Chairmen of the Standing Committees, constitute the Executive Board.

ARTICLE V.
Duties of Officers

SECTION 1. The President shall preside at all meetings, visit and organize Branches, and take general charge of the work under the direction of the Bishop.

SEC. 2. The duty of the First Vice-President is to preside in the absence of the President, to be Chairman of the Committee on the Diocesan Box, and to assist the President as called upon by that officer.

SEC. 3. The duty of the Second Vice-President shall be to preside in the absence of the President and the First Vice-President and to assist as called upon.

SEC. 4. The Managers of Deaneries shall endeavor to stimulate the formation of new Parish Branches, to infuse greater Missionary spirit throughout their Deaneries, and shall seek to increase intelligent interest in the Missionary work of the Church. At least one general meeting shall be held in each Deanery during the year. Each Manager shall make a statement at the Annual Meeting of the work done in her Deanery.

SEC. 5. The Corresponding Secretary shall correspond with the General Secretary and find out where help is needed, and of what kind; shall inform the Parish Secretaries and arrange about their work. As Treasurer she shall receive and forward all money offerings except the United Thank Offering, and shall pay out money only as voted by the Executive Board.

SEC. 6. The Recording Secretary shall take the minutes of all meetings and prepare an Annual Report.

SEC. 7. The Treasurer of the United Thank Offering shall send out Blue Boxes on request, and shall by correspondence urge every woman in the Diocese to participate in the United Thank Offering. As Treasurer, she shall receive and bank on interest all United Thank Offering moneys, and shall take or send by one of the delegates the accrued amount to the Triennial Meeting. She shall make a full report at the Annual Meeting.

SEC. 8. The Secretary of the "Little Helpers" shall superintend the work of her department in consultation with the other Diocesan officers.

ARTICLE VI.
Representation

Each Parish may be represented at the Annual Meeting by not more than seven delegates, but in voting each Parish shall vote as a unit.

ARTICLE VII.
Amendments

This constitution may be amended at any Annual Meeting by a vote of two-thirds of the Parishes present.

BY-LAWS

I.

An Annual Meeting of this Association shall be held at the place of the Diocesan Convention the day following its session.

II.

Special meetings may be called by the President at such time and places as she may designate.

III.

The Officers of this Association shall be appointed annually.

IV.

In case of vacancy in any office, the same may be filled by the Executive Board with the approval of the Bishop, the officer so appointed to serve until the next Annual Meeting.

V.

The reports of the Parish Branches shall be sent to the Diocesan Secretary by May 25th each year.

VI.

It is expected that each Parish Branch will contribute not less than \$1.50 annually to the central expense fund.

VII.

The order of business of the Annual Meeting shall be—

1. Offices of Devotion.
2. Calling of the Roll.
3. Reading of the Minutes of last Meeting.
4. Reports of Officers and Committees.
5. Reports from Parishes.
6. Miscellaneous Business.

VIII.

The offering at the opening service of the Annual Meeting shall be devoted to Central Expense.

IX.

These By-Laws may be amended at any Annual Meeting by a majority vote.
