Address of the Bishop.

I always look forward to this meeting with pleasure, for it gives me happiness and encouragement to meet the earnest members of the Woman's Auxiliary. We have to come in contact with coldness, lukewarmness, unfaithfulness, to appreciate the help which the earnest, uncompromising disciple of Christ gives. The more I see of the workings of the Auxiliary, the more am I impressed with the very low estimate which the association places upon its efforts, and the failure of the individual members to appreciate the greatness and far-reaching effect of their labors. The Lord God is so great, and His labors for us so transcendent, that everything we do becomes dwarfed into insignificance by comparison. Yet, the greatness of effort in God's Kingdom is not measured by the results, as we see them, but by the self sacrifice which the effort requires. We do not think so much of the humility of the Son of God in becoming man; or of His labors, when weary and hungry He sought to bring to the minds of men the greatness of God's truth; but of His sacrifice on the Cross. It is the self sacrifice at which God looks. This is the criterion of the effort. We may be dealing with small things, and what we do may appear to the world trifling, but He who numbers the hairs of our heads, and watches over the sparrows, rewards the effort according to its sincerity. Nothing is unimportant which is done for God's service, done unselfishly, done to add glory to God, however little it may be. We must not look so much at the *deed*, as at *ourselves*. If God has given us a work to do, we must not think it does not amount to much. Naaman objected to washing in the Jordan, but he was cured of his leprosy by it. It seems a very small thing to give a few pennies each month, and to take a hot walk for five or ten minutes of prayer. Is it small? Yes, very small, when done unwillingly; but great, when done for God's Kingdom; great, when done because we desire to do what we can for the ad-

vancement of God's truth, that His will might be done on earth as it is in Heaven; great, when we willingly submit to the discomfort of the walk, and gladly contribute what we can, because we wish to serve God, in a small way, if we cannot in a large way.

I suppose we get tired of the struggle at times. The flesh is weak, and we are always looking for results, which never come—in the way which we think they ought to come. But then, if we did not struggle, we should be totally unlike the Master, whose life was one continuous struggle. We must be willing to fill up some of His sufferings. Not to struggle, not to labor, not to work, is to lead a selfish life, a life away from God. There are no cessations to His labors. He ceased to create, but He did not cease to sustain. If we cease to struggle, we must cease to pray "Thy Kingdom Come." To pray "Thy Kingdom Come," and not to work for its coming, is mockery. The struggle must last as long as life lasts. Even now in Heaven the glorified Redeemer works for us. He appeared to Saul in the way, and He spoke to John, when on the Isle of Patmos. We must not grow weary of the struggle, or look forward to the time when there will be no struggle, for it is in the struggle that we grow strong, that we learn more and more the value of Christ's life, and His struggles for us. Gethsemane can have a meaning to us only when we are seeking to save human souls *by our labors*. We can enter into the sorrows of the Lord only when we sorrow over the hardness of hearts, and know something of the pain which rebuffs and mistaken motives bring. The cross must be carried to obtain the crown.

Yes, you must keep the Cross ever before your eyes. This is every Christian's duty, but the need of keeping that dying and praying Holy One before your eyes comes with special force to all those who are engaged in the active work of God's Kingdom. There is great danger in carrying on what I will call the worldly side of religion, without constant intercourse with the Master, while doing that work. Our Master went out and taught, and healed the sick, and twice cleansed the temple. There was a worldly side to His life,

if I may so speak. There must be a dealing with worldly things, if we are to save souls, living in the world. There is a necessary machinery in doing any work, and this machinery must be cared for. Our Lord recognized this. He watched those who cast money into the treasury, and praised one who had given money which represented self sacrifice. He taught the people to obey those who sat in Moses' seat, and after He ordained the Apostles, He said, "He that hath a purse, let him take it, and likewise his scrip." St. Paul taught us, "They which preach the Gospel should live of the Gospel." It is true Satan tempts us while on our knees, but he more easily besets us when we engage in what I have called the worldly side of religion, that part of it which is necessary to carry on the machinery of God's Kingdom. You have clothing and materials for mission boxes to provide, money to collect, the difficulties and trials of those about you to look after. In many ways you are engaged in maintaining the machinery of the Kingdom, in caring for the needs of many. This side of your work is liable to cause bickering and heartaches, and perhaps coldness of spirit, unless you engage regularly in prayer, unless you make a special effort to take part in the prayers of the association, unless you pray constantly, "Thy Kingdom come."

I speak of this, because I feel sure you are beginning to realize it. I say I feel sure, I do feel sure, for things have happened which I can understand in but one way, viz: As manifestations of the Lord's direction and care. I may mention some of these things, that you may understand what I mean. In a most unexpected way, a check for three hundred dollars was sent me for missions in the Diocese; for the first time we have a full quota of clergy; we have stronger men, and men more adapted to the work than ever before; better work and better results have been accomplished; peace and good will seems to rule everywhere. Now I know that God does not bless those who do not pray, so I am sure you do pray, but I want to beg you to pray more, to let nothing interfere with the meetings for prayer; to make a special supplication each day for the advancement of God's Kingdom; to say "Thy

Kingdom come" with a full, realizing sense of the meaning of those words. The more you pray, the more will you be freed from the temptations of Satan in your work, and the more will you realize the importance of your effort; and the more will you be encouraged to struggle on.

Address of Diocesan President.

What means this invincible hope, this dauntless courage of the women of the Church, banded together from the "Everglades of Florida to the Glaciers of Alaska?" One word is written over all, Christlike; one watchword inspires all—"In His Name." The Woman's Auxiliary is an organization of the Church. It is created by proper authority to do a particular work. It has its various organized methods; it has its officers, hears reports, and it is in all respects like a thousand other organizations. It is but an outward and visible sign of the work done by Christ. Thus He goes on to complete His work. Take this view of your work, women of the Church. "It is the secret of the Saints in all ages."

It is manifestly important that we, during this conference, take counsel among ourselves as to the adoption of some method of enlarging our field of work and devising ways and means of increasing our receipts. Expect success. Look for it. Claim it. "Launch out into the deep of greater faith in God, ourselves and each other."

Each branch acting on its own responsibility, and yet connected by invisible links of discipline of the Auxiliary, carries with it a strength of purpose and greater desire to continue our labors in a field where "duty, responsibility and influence go hand-in-hand."

It should be the object of each branch regularly to advocate the necessity of this obligation, and the Auxiliary should

work in such a way that the missionary cause will be presented to each parish in a form best adapted to secure a permanent and profound effect.

The Church that apologizes for doing nothing for missions abroad because of its weakness and poverty, owes its feebleness to the lack of missionary effort. If we but knew it, it is because we have such burdens to be borne in home work that we need the stimulus and strength imparted by active missionary work for the distant and destitute.

As Bishop Brooks used to say, "Such excuses resemble the plea of a parricide who first kills his own father and then pleads the pity of the court in remitting the penalty in view of his orphanhood." The gathering of two thousand missionaries in New York, forming the Ecumenical Conference, demonstrates the missionary's value to the world.

President McKinley said in his address, "If we are not our brother's keeper, we can be our brother's helper. I am glad of the opportunity to offer, without stint, my tribute of respect to the missionary effort which has wrought such wonderful triumphs for civilization." He also adds, "They have braved disease and danger and death, and in this exile have suffered unspeakable hardships. They count this labor no sacrifice." "Away with the word in such a view and with such a thought," says David Livingstone. "It is emphatically no sacrifice—say rather it is a privilege."

Let our enthusiasm be rekindled, our efforts redoubled; the privilege is ours, women of the Auxiliary.

The possibilities are boundless, the probabilities are uncertain for the united offering, unless those present at this meeting pledge themselves to meet this obligation and make a determined effort to make the offering at the Triennial Convention worthy of the Florida branch. I feel assured we can if we try make the amount \$500.00. I would suggest that we bend our energies in this direction, concentrating pledges until this amount has been collected.

I need not impress upon you that this outside work must not be done to the detriment of the systematic offering; notwithstanding this strong plea for missions beyond our bor-

ders, our first duty is to our Bishop's work for Missions in the Diocese. I feel that both can be accomplished by earnest, serious work.

It is with hesitation that the Diocesan Committee asks your attention and advice in regard to the change of the day of the Annual Meeting.

To some of you it is a surprise that our meeting is on Friday, practically after the Council. The reason for this change is that the Council is unwilling that the Bishop should be absent from the Council on Thursday, it being an important day, requiring the presence of the Bishop.

It is for you to decide whether Friday is a suitable day or select some other, when the Bishop can give us his undivided time, which he earnestly desires that the Woman's Auxiliary should have for the service of the Annual Meeting.

That "Auxiliary Day" is being generally observed throughout the Diocese, is a step in the right direction, thereby marking the sixteenth of March as the day of organization of the Auxiliary.

I would suggest we urge the Bishop and clergy in the Diocese to have one service during Lent to be known as the Missionary Service, the offertory to be given to the Woman's Auxiliary to increase this receipt for missions.

The evening service will draw a larger number of persons, who may become interested in the missionary work. If the subject is well represented by a spirited address, much good may be done for the people and for missions.

The Babies' Branch held its annual meeting on Holy Innocents' Day at the rectory, Gainesville. Mrs. Clarence C. Leman has shown superior qualifications for organizing and bringing into active work this branch of the Auxiliary work. It no longer totters, but is quite able to stand alone. The total amount collected was \$36.78. There are now organized the Gainesville Branch; the Green Cove Spring Branch, Mrs. Kate Delap, secretary, organized August 20, 1899 with five members; Archer, Micanopy and Albion Mission Stations Branches, Mrs. G. W. Gilmour, secretary.

The Junior Auxiliary is well organized and doing good,

substantial work, and always deserves honorable mention. The steadiness of purpose and unfailing interest evinced by the young girls, shows their training. They will be ready to fill our places as we fall out of rank.

The Periodical Club still needs your care and earnest co-operation to bring it to the standard of excellence necessary to success. It is no easy burden for our efficient Secretary to carry, unless she meets with greater encouragement. Give it your cordial indorsement for the ensuing year. I am sure the results will be gratifying to Mrs. Arnold, the pleasure great to those who receive the books and papers.

It is said the success of woman's work is not so much a question of mental capacity, as it is of concentration and the right kind of endurance; and yet in every sphere of life we need to beware of mental indolence. It is most secret and insidious, and at the same time the most effectual enemy to all progress. If we are, indeed, an industrious society, let us show it by increased mental activity, infusing fresh vigor and new vitality into every part of the Auxiliary.

Report of Recording Secretary.

Next came a discussion on the change of day for the Annual Meeting. The following resolution was offered and carried:

Whereas, The changing of the day for the Annual Meeting of the Woman's Auxiliary to Friday, the last day of the Council, leaves too little time for the transaction of business;

Resolved, That we request the Bishop to change the day of the Annual Meeting, in order to give more time for the business of the Auxiliary.

On motion, the meeting was adjourned until 8 p. m. Friday.

At 8 p. m. the meeting was again called to order.

The minutes of the previous session were read and approved.

There being no further business, on motion, the Annual Meeting was declared adjourned.

Reports of Parishes.

APALACHICOLA—TRINITY CHURCH.

Trinity Apalachicola Branch of the Woman's Auxiliary of the Diocese of Florida, has held its meetings during the past year on the first Monday of each month, in the Church. The Litany service is always used for opening, and the prayers for missions for the closing of the service.

The membership and attendance has been small, consisting of the faithful few, such as are to be found in all parishes, but the interest has been stimulated and the work helped by the preparation of papers each month by members of the Auxiliary appointed by the Directress, the topics and texts being taken from those suggested in the leaflet supplied by the Woman's Auxiliary to the Board of Missions. One new member has been received and another begins membership with the month of May.

We have felt that the lack of interest in missionary work, particularly Foreign Missions, is caused to a great extent by insufficient knowledge of the great things being done and remaining to be done in that field. We have, therefore, tried to give more time to the study of Foreign Missions, and have been helped by the gift from our former Directress of a subscription to the "Spirit of Missions," for the benefit of this branch.

The house-to-house collection of a mite offering for the Bishop's work in the Diocese, suggested by him to the Auxiliary on his visit in January, 1899, at a time of much financial depression, has been kept up by the faithfulness of our Directress, she having made the collections more frequently than anyone else. Each communicant of the Church, not a member of the Auxiliary, is asked to give ten cents per month, and collectors are appointed at each meeting, with the result that

our systematic offering for the year ending May 1, 1900, is \$83.70, as against \$53.70 for the year ending May 1, 1899.

Auxiliary Day was observed in this parish with a celebration of the Holy Communion by the Rector, and the offering for foreign missions was \$2.75.

GAINESVILLE—HOLY TRINITY CHURCH.

It is with pleasure that we report a new departure in our work this past year. In addition to our systematic giving we have taken up the systematic study of Missions, endeavoring in an humble way to follow the precept, "First know, then pray, then give"—believing that intelligent giving is, like mercy, twice blessed.

Our plan is for different members, previously appointed, to prepare papers. Our Rector has given us his hearty support, kindly conducting the meetings. Our first subject was, "History of the Church in America," followed by "Colonial Church in Virginia," and "A History of the Gainesville Parish," taken from the Parish Register, supplemented by many interesting personal reminiscences.

We had an exhaustive study of the Alaska Mission, including its history, present condition and woman's work. This covered several meetings and resulted in an "Alaska Tea," the proceeds of which were given to that mission. Papers were read at subsequent meetings on: "Southern Flor-

ida," The Work of Rev. O. P. Thackara, Arizona, Navajo Indians, Idaho, Oklahoma, Wyoming and Montana Missionary Jurisdictions. For Montana, slips containing questions on the subject, to be answered at the following meeting, were distributed.

Auxiliary Day was observed by a service with Corporate Celebration. The Rector read a paper on the "Society for the Propagation of the Gospel." Other subjects considered were: "Board of Missions," "History and Aim of Woman's Auxiliary," "Junior Auxiliary and Babies' Branch."

In regard to the number of contributors, though our parish has lost heavily by removals and deaths, the Auxiliary still numbers 61 faithful contributors, as against 66 by last report. This excellent showing is due largely to the persistent efforts of our efficient Treasurer, Mrs. W. W. Hampton, who makes vigorous efforts to fill every gap made by departing members and who, as regularly as the month rolls around, sends forth her little ones with a bag and book, not forgetting small change and pencil, so that no one has any excuse to delay payment of dues. Her statement is appended below.

We sent to Dr. Carter one barrel of clothing for the Carabelle storm sufferers.

With this report I yield my office as Directress to one to whom we are indebted for much valuable assistance in the past, Mrs. E. K. Foster, ex-President of the Southern Florida Branch.

Looking back upon the work of our branch during the past year, we feel grieved and disappointed to find that from a financial standpoint of view it falls behind that of the previous year.

It is hard to determine just where the fault lies, except through the failure of some to pay what they promised, and by death, and also by the reduction of the incomes of some of the most liberal contributors. The monthly contributions have fallen off considerably. The new contributors we gain each month, do not make up the deficiency, because they rarely give as liberally as those who have contributed for so many years.

The interest and efforts of our Directress, Mrs. Williams, are unfailing; and when the different collectors are prevented from doing their duty, she takes the work upon herself instead of getting a substitute.

We realize there must be some of the communicants that we do not reach; so let it be the duty of each of us continually to make efforts in that direction, so that all may have the opportunity to give.

The systematic offerings for the past year averaged \$52.14 5-6 per month, making a total of \$625.78. There is a deficit of \$71.82 over the regular contributions of the previous year. In August we gave \$25.00 toward the Thackara Memorial Fund. In December, as our Christmas work, we gave \$5.00 to St. Stephen's Mission, La Villa; \$5.00 to All Saint's Mission, South Jacksonville; \$5.00 to St. Mary's Mission, Springfield; and candy to the amount of \$2.10 to the Junior Auxiliary for their box sent to Starke.

We have received so much encouragement and commendation from the Bishop for all work we have done, that it deepens our regret to know that we have not accomplished more. But we will enter upon the new year with more determined efforts.

REPORT OF

Diocesan Secretary for the Babies' Branch of the Junior Department of the Woman's Auxiliary.

On Holy Innocents' Day, 1898, there was organized a Babies' Branch of the Junior Department of the Woman's Auxiliary, or "Society of Little Helpers," in Holy Trinity, Gainesville. At that time twenty little ones were brought by their mothers to the church, and after a baptism, which was an object lesson, the branch was organized and furnished with boxes, leaflets and membership cards. This branch now numbers thirty-three. As this work was a memorial to a little one but recently called to Paradise, it was earnestly desired by the mother and secretary to extend it over the Diocese. Through the courtesy of Mrs. Weed, Diocesan Secretary of Junior Department, and by appointment of the Bishop, I assumed the Diocesan Secretaryship. In the following summer three branches were established; one at Green Cove Springs, with a membership of five; one at Waldo, with five members; and another in the mission stations of Archer, Arrendondo and Albion, with three members. In October a branch was organized in St. John's, Jacksonville, with twenty members. It is both gratifying and encouraging that, in each of these instances, the secretaries volunteered for the work. In January, 1900, circular letters, with leaflets enclosed, were sent to the clergy, requesting suitable names for secretaries. Four encouraging answers were received; as a result, two branches are in progress of formation—one at Apalachicola and the other at Monticello. In another year I trust many branches may be added. It is a sore disappointment that I cannot personally plead for your aid in establishing this beautiful and helpful Babies' Branch in every parish in the Diocese. However, I beg that you will give this work your prayers and loving thought, and, carrying it home in your hearts, interest someone to undertake the duties of a parish secretary. I append financial report.

CONSTITUTION
OF THE
Florida Branch of the Woman's Auxiliary.

I.

This Association shall be called the Florida Branch of the Woman's Auxiliary.

II.

The object of the Association is to pray for GOD'S blessing upon the Church, and to obtain contributions for missionary work.

III.

Any person may become a member of this Association who may be admitted thereto by the Directress of one of the Parochial or Mission organizations.

IV.

There shall be a President, Vice-President, Diocesan Treasurer, Recording Secretary, and Corresponding Secretary appointed by the ecclesiastical authority of the Diocese.

V.

This Association shall have an organization in every Parish and Mission. The Rector, or Missionary in charge, shall appoint a Directress, Secretary and Treasurer, whose duty it shall be to divide the Parish, or Mission, into districts of convenient size, assigning to each a Collector, or

Committee of Collectors, who shall, each month, collect the pledges; once a year to procure from the Rector, or Missionary, a list of members of the Parish or Mission, and to try to secure from each member a contribution of one cent a day.

In case a Parish or Mission is vacant, the Bishop may appoint the officers.

VI.

There shall be a Diocesan Committee, composed of the President, Vice-President, the Diocesan Treasurer, the Recording Secretary, the Corresponding Secretary and the Directress, or the accredited representatives of the Directresses.

The President, or the Vice-President acting for her, and any of the three of the above named officers shall constitute a quorum for the transaction of business.

In case both the President and Vice-President are absent from the Diocese for more than one month, then one of the Secretaries of the Diocesan Committee may call the meeting to order, and any of the three above named officers shall constitute a quorum for the transaction of business.

VII.

The President of the Association shall have general supervision of the Association, and shall decide in all cases of dispute. The Vice-President shall act for the President when she is absent from the Diocese for more than three months. When requested by the President, the Vice-President may act for her, at any time. When acting for the President, the Vice-President shall exercise all the authority of the President.

The Diocesan Treasurer shall have charge of the funds of the Association, and shall keep a correct account of the same. She shall make disbursements according to the direction of the ecclesiastical authority of the Diocese.

The Recording Secretary shall keep, in a book provided for that purpose, the minutes of the Diocesan Committee, and attend to such other work as the President may request.

The Corresponding Secretary shall, under the direction of the President, correspond with the organizations in the Parishes and Missions, and obtain information concerning their management and general welfare, and give such advice as the occasion may require.

The Treasurer shall remit to the Diocesan Treasurer on the first day of each month the funds which they have in hand.

VIII.

The Diocesan Committee shall meet on the first Wednesday of each month, and may be called together at any time by the President.

The Parochial or Mission organizations shall meet on the first Monday in each month, and may be called together by their respective Directresses at any time.

All meetings, wherever and whenever held, shall be opened with prayer.

IX.

This Constitution may be altered by the Bishop of the Diocese, after giving one month's notice of the proposed change to the officers of the Association.

RULES OF ORDER

OF THE WOMAN'S AUXILIARY SOCIETY MEETING.

1. Opening Service and Address by the Bishop.
2. Roll Call by Branches.
3. Address of President.
4. Report from Branches.
5. Treasurer's Report.
6. Secretary's Report.
7. Report of Church Periodical Club.
8. General Business.

RULE I. After the opening service, the President shall take the chair and call the meeting to order, when the order of business shall proceed.

RULE II. When a member is about to speak, she shall rise, and with due respect, address herself in an audible voice to the chair, confining herself strictly to the point in debate.

RULE III. No member shall speak more than twice on the same subject without permission of the house.

RULE IV. While the President is putting any question, the members shall continue in their seats and not hold any private discourse.

RULE V. Every member present shall vote when a question is put, unless excused by the house.

RULE VI. When a question is under consideration, no motion shall be made, unless to lay it upon the table, to postpone it to a certain time, to commit it, to amend it, or offer a substitute; and motions for any of these purposes shall have precedence in the order herein named.

RULE VII. A motion to lay on the table shall be decided without debate.

RULE VIII. A motion to adjourn shall always be in order, and, if unqualified, shall be decided without debate.

RULE IX. No motion shall be considered as before the house unless it be seconded.

RULE X. All committees shall be appointed by the President unless otherwise ordered.

RULE XI. The reports of all committees shall be in writing and shall be entered on the minutes, unless otherwise ordered.

RULE XII. Before the final adjournment of the meeting, the minutes of the last day's proceedings shall be read, corrected (if necessary), and approved.
