Address of the Bishop.

It is always a pleasure to meet the members of the Woman's Auxiliary. This Association has done so much in cases of emergency, and has been so brave and unfaltering when difficulties and calamities have come upon us that I feel I am addressing warm friends when I speak to the members. The Association was organized when the Diocese was in great trouble, when the Missionaries were poorly paid and poorly fed; when, often, they had to wait a long time for their mite. Since the organization of the Woman's Auxiliary, there has never been a time when the Missionaries were not promptly paid, except in one instance—during the yellow fever epidemic of 1888—and then the payment was deferred one month.

When my thoughts turn to all which the Association has accomplished in the Diocese, both spiritually and financially, naturally I think of the power of woman. Let me say a few words on this subject.

If I can say anything which will make you realize more your power, I think I will have helped to induce you to extend your influence even more than you have done in the past. Humanly speaking, the great work of the Master was the elevation of woman, making her the mistress of the hearth, the protector of the fireside. The purity of the home which the Master brought about through the elevation of woman, was the strong factor in making permanent Christian civilization. Woman's natural refinement fitted her to become the Master's servant in carrying out His mission of reformation and elevation. She guarded the home from evil, and elevated the feeling of regard in

the household. Her refinement smoothed off the rougher sentiments of the other sex and made home a delight and a school of refined pleasure. It was woman's influence at home which helped to develop true manhood and made plain the distinction between bravery and brutality. Her tender sympathies and her quick intuitions enabled her to enter into the real difficulties of the heart life and to put her finger on the real cause of lukewarmness. She became an angel of mercy, carrying with her wherever she went comfort and happiness, giving strength where weakness developed and giving courage and hardihood where despair destroyed the energies and made living almost an impossibility.

The power of woman! She has ever entered into the details of life which really make up life, which give to life its brightness or its darkness. Where men were striving about what seemed great to them, she came in to bring together the little things of life which changed the whole aspect of its conditions. Her tender sympathies gave joy and renewed energy when the struggle seemed hopeless. Ever uplifting and ever cheering the despondent, she has influenced every movement for good, has advanced every enterprise which had in it the amelioration of suffering, the enlightenment of the benighted, or the suppression of evil. Her tender sympathies and quick intuitions made her a master in determining falsehood and deception, and enabled her to unravel the complex motives of human nature. No hasty criticism ever turned her aside, no false judgment ever made her relinquish her affections, no clamor founded upon prejudice ever made her swerve from her purpose. The constancy and determination of woman has saved many righteous undertakings and has carried to a successful conclusion many seemingly weak enterprises.

But more than all, her devotional nature has lifted her above the seen and carried her into the realms of the unseen. The guiding hand of God has been looked to

when the clouds seemed dark and unpropitious; when overwhelming disaster seemed imminent. She has ever lived the life which the Master has pointed out so clearly as the only contented life, as the only life which a true, trusting Christian can live, a life which deals with the present evils and enjoys the blessings of God day by day. The love of God has been easy for her to understand and to appreciate, because the responsive chord in her breast taught her in an unmistakable way the true meaning of God's providences. Prayer, praise, devotion came natural, because she recognized the highest good and felt the sympathy of Christ as a less delicate nature could not. Her devotion has brought her face to face with the tender, suffering, enduring, loving Master, and she has entered into His life as few men have, teaching her the power of an unselfish life, free from the trammels with which the love of the world clogs and drags down the soul. Unselfish devotion, courageous endurance and loving trust have marked the life of woman and have given her an influence in the developing of the world, in lifting it above brute force, in guiding it to a higher and holier life, which many have failed to appreciate or understand.

And this power which God has given you to use and which you have used for the good of mankind, I speak to you of, because I would have you know I realize how much good you have done and how much good you are capable of doing. I know the difficulties of getting together for a few minutes' prayer; I know the journeys which some have to take, and the drawbacks which they have to overcome; yet the difficulties are all known to God, and these make the devotions even more pleasing in His sight, because they are the petitions of self-sacrifice. These five-minute prayers go up to God as a sweet-smelling incense, and bring back God's benediction and blessing and the ministrations of the holy angels, the messengers of God. What shall I say? You have done

so much to advance God's Kingdom by your prayers and your aims, I know you have His blessing. You have done so much to cheer and comfort me in my work, have done so much to give me courage and perseverance, that I know not how to tell you of it, or how to express my appreciation. I can only pray God that His Holy Spirit will ever keep you in the knowledge of your God-given power, will ever give you strength to exert your influence to the utmost, and will ever guide you into the way of truth and righteousness.



Address of Diocesan President.

I have cherished the hope that the closing of a quarter of a century and standing on the threshold of a new century might mark an advance in the work of the Auxiliary. This hope has been realized. While we have done nothing to challenge the attention, we have kept above the average in our receipts, notwithstanding we have faced difficulties trying to men's souls, to say nothing of the courage of women.

Scarcely had the echoes of the Annual Meeting held in Fernandina died away before St. John's branch of the Auxiliary was scattered far and wide, houseless and homeless, by the burning of Jacksonville. The work of the Auxiliary prostrate in the ashes; St. John's Church, a "gem of ecclesiastical architecture," a mass of ruins. At the first glance it seemed that the destruction was so entire, so complete, that it must necessarily result in the cessation of the work. Not so! With splendid courage and oneness of purpose, the small band gathered together their broken energies, rallied from the staggering blow, and commenced work again. You can well appreciate what a crown it was to their efforts in the strengthening of the branch and rendering it possible that the collections of the branch should be greater than in former years. Such work deserves more than honorable mention. It is not out of place to mention in connection with the revival of the work of St. John's branch the timely assistance from Holy Trinity branch, Gainesville, and St. John's, Tallahassee, whose gracious gifts probably gave the impetus to the remnant of life and energy of the sorely stricken branch. With such examples of courage and gracious giving the other branches will be roused to bet-

ter and more effective work. Both prayers and alms are sorely needed. The spiritual side is absolutely essential to preserve the vitality, and should never be ignored. It is a distinct and unquestioned duty that we heed the call to prayer and the call to service. Perseverance is a rare and difficult virtue; the struggle wearies, the spirit falters, the courage flags and readily yields to the siren voices of rest and ease. Let it not be said we began well but did not persevere to the end. Even in a bad cause perseverance imparts a tremendous power to win; but when the cause is good, success must crown the labors of those who persevere to win. We wish to fit ourselves in this matter of Christian service to be the instruments that shall accomplish an end, and this, women of the Auxiliary, lifts us to a higher and larger view of the whole subject. Who of you here this morning has not read the story of Blaise Pascal and the Port Royalist. That marvelous man who, coming out of comparative obscurity, made the whole Church of Rome tremble at the courage with which he challenged its errors. But do you know that Pascal the philosopher, the Christian teacher, began his life as a boy of eighteen in a mechanic's shop, where he spent week after week and month after month in vain endeavor to manufacture a calculating machine? Now then, when Pascal set himself to that task, he made not merely the one model, or two, or a dozen, but fifty. He made them in steel, he made them in brass, he made them in ebony, he made them in ivory. Baffled and defeated, at one time he turned back to the beginning and went over the whole complicated business again and again; and though this instrument never received recognition on the part of the scientific world, thus dooming him to disappointment, he was himself by that supreme discipline, that persistent and resolute endeavor, educated to be an instrument in the hand of God. For out of that baffled endeavor, out of successive failures, stumbling and falling, gave him the resolute purpose, the almost di-

vine persistency, which has made his name immortal.

Though we are beaten back, but refusing to be conquered, there comes a spirit of resolute courage to overcome the difficulties that beset our pathway through the mission field.

It is said that "the root of spiritual bravery is unworldliness; such bravery is not the courage of impulse, but the sustained fortitude of principle. It is not a flash which burns for a moment and then goes out, but it is a steady flame which illumines character and shines along the pathway of life, growing brighter and brighter to the end."

I would not diminish in any degree the legitimate demands of society, but I would emphasize with all the force I possess against the spiritual paralysis creeping over our fair country, caused by the indulgence of methods questionable for people professing and calling themselves Christians. Pause and think how much could be accomplished by perseverance and unworldliness. Woman's influence directed in the right channel is a powerful lever in controlling public sentiment; indeed, her best work is that of influence. Unseen power is the strongest; it persuades and controls. May I not ask your co-operation in a service so rich in possibilities? I feel assured that the effort will not be barren of results.

In a letter from Miss Emery, she says: "In your Diocese there are fifteen Parishes and Missions, which, apparently had no show whatever in the work of the Auxiliary last year. Could not an attempt be made to obtain from the women in each one of these some contribution for our offerings? In every Parish where there is a Branch, there are women who do not know of it and so do not care. Cannot you institute some plan for telling them? Cannot every interested member of the Auxiliary take as a special duty this year the work of interesting some one uninterested?"

In the above paragraph I present to you the thought of the United Offering which, as she says, is made up of the gifts of all women, from the oldest to the youngest, from the richest to the poorest, from those in our most crowded cities to those lonely ones on the river highway of Alaska or among the mountains of Japan. I would fail in my duty as a diocesan officer if I did not press this matter of the United Offering. The *Spirit of Missions* says: "To be a diocesan officer means to use the persuasive influence among the women throughout the diocese and a co-operation with every other officer of the diocesan branch in extending that influence."

I feel assured that you will lend your assistance in diffusing this influence until every woman in the Church is bearing her part in extending the Mission work in the Diocese and beyond its borders.

The United Offering is the grand searchlight of Missions, sweeping its long rays of white light in every nook and corner, from the Atlantic to the Pacific, from the glaciers of Alaska to the Everglades of Florida. The United Offering was made in Grace Church, San Francisco, on Thursday, October 3d, 1901. The amount was \$106,560.34.

With regard to the united offering of 1904, the officers of the Auxiliary meeting in San Francisco, on Monday, October 7th, 1901, unanimously resolved, "that the United Offering of 1904 be given to the Board of Missions for Woman's Work in the Domestic and Foreign fields, including the training, sending and support of women workers. This is to be interpreted to include Brazil, Haiti, Cuba and Mexico. It is also to be understood that this resolution includes sick and disabled women workers." The Florida Branch contributed as its share of the offering \$365.

Our duty is clear and strong. It is manifestly important that we provide for distant missionary fields as we have done in other years. A generous thoughtfulness for other churches will be another link in the chain which

unites the Church on earth. We did well in 1901; let us do better in 1904, and make our share of the offering \$500, commencing this year to set aside a round sum for the Triennial of 1904.

We have all the departments of the Auxiliary well organized for service. The Junior Auxiliary Babies' Branch and the Periodical Club are well supplied with efficient officers. We have faithful, devoted women who fill the Parish offices, untiring in their efforts and unfailing in patience, who deserve more than honorable mention. They bear the brunt of the fight, for they are the collectors. Added to this we have the inspiration in the cordial support of the Bishop, who in one of his admirable addresses says: "The needs and necessities of the Woman's Auxiliary are the needs and necessities of the Church. The Auxiliary forms a part of the Church organization of the Diocese. What I want you to do is to rise to the true appreciation of your position and the authority which belongs to the Woman's Auxiliary. The Church sends you to collect moneys, to ask for aid, to induce persons to join our organization. You do not go as beggars; you go with authority, and you consequently offer a privilege to those to whom you go. The Woman's Auxiliary has not been sufficiently assertive. You have no apology to offer when you go to people and ask them to become members of your Auxiliary. If they have any love for the Church, have any interest in the work of the Diocese. they will listen to your appeals."

In quoting these graceful and gracious words of commendation, I would impress you with the strong necessity of redoubled effort to keep up the standard of excellence accorded the Auxiliary. In this high endeavor we must be continually forgetting the troubles and vexations that are behind and reaching forth into those things which are before and so pressing on to the goal. Let us begin the new year and the new century with renewed courage; make our work more aggressive. Surely the beautiful se-

renity of the Church, its reverent conservatism, its hallowed enthusiasm for old ideals must bring us greater success in widening the influence of the Florida Branch of the Woman's Auxiliary. In all your efforts, hold fast to them.

Before closing, I would like to add a few words expressing the deep sorrow that was and is still felt at the loss of our well-beloved friend and co-worker, Mrs. Mary R. Burton. For twenty-five years she labored for the Woman's Auxiliary as its Treasurer and Corresponding Secretary, and to her is largely due the success of the organization. Every member of the Florida Branch has at some time felt the influence of her guiding hand; therefore it would seem fitting that we unite in placing a suitable memorial in the Church she loved so well.

It is also my sad duty to speak of the death of our dear and revered Honorary Secretary, Mrs. Mary A. E. Twing. Many of you will recall her visit to Florida in the interest of the Woman's Auxiliary. Her death in San Francisco while attending the Triennial Convention seemed a fitting end of a long and useful service crowned with success. We hope the committee will place some memorial in the chapel of the school in China with the funds raised by the Florida Branch.

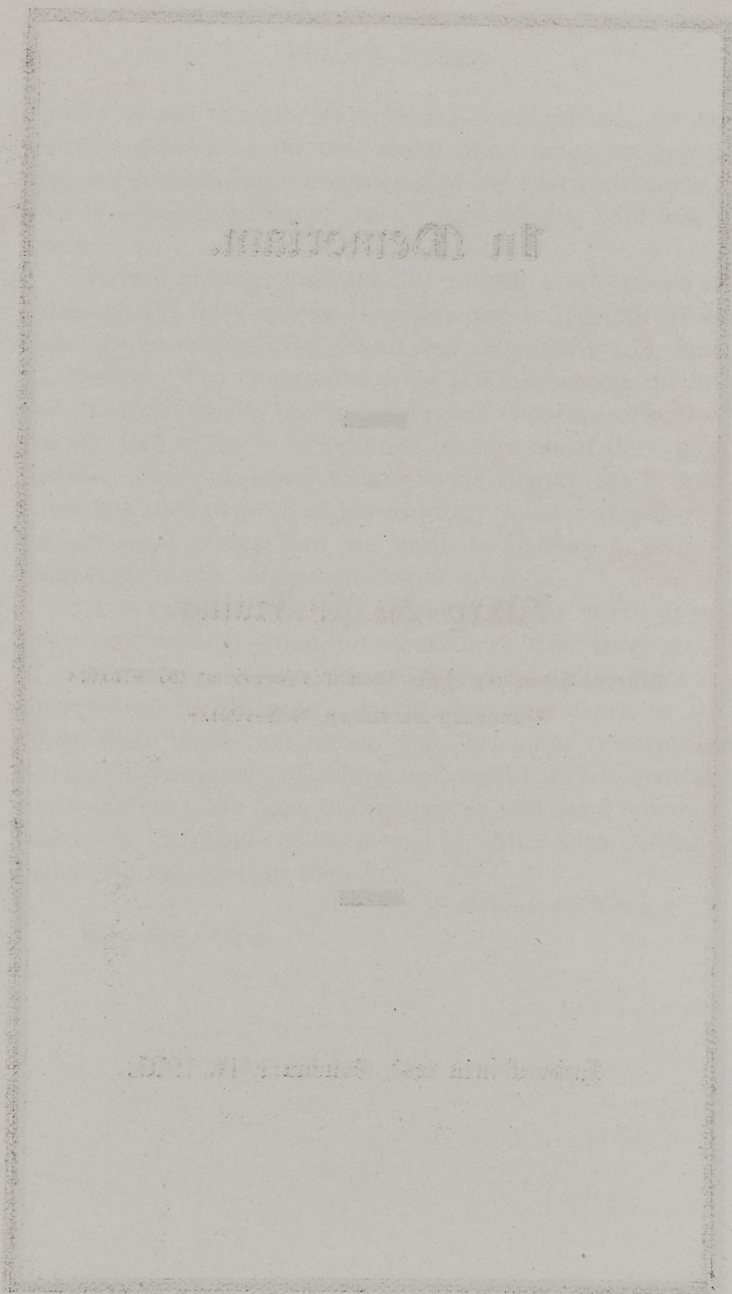

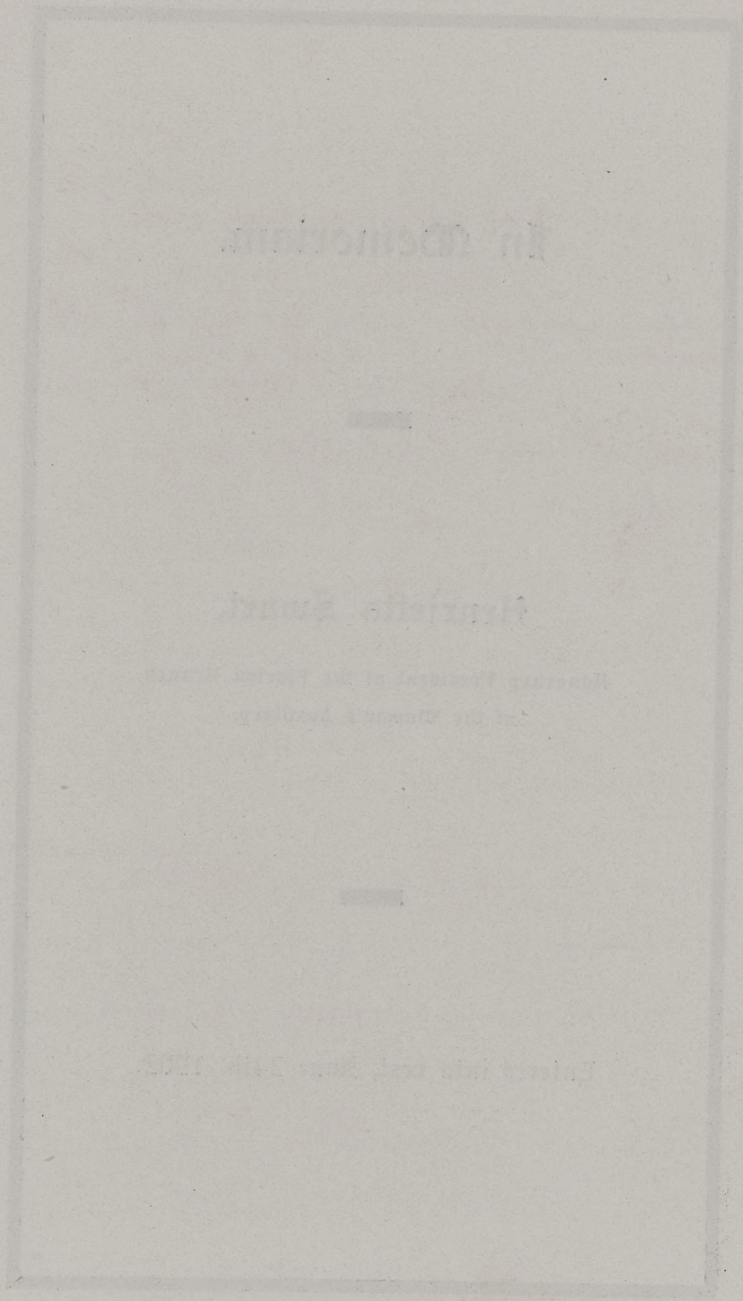

ST. JOHN'S CHURCH.

With the almost complete annihilation of the city on May 3d, there was a momentary gloom cast upon St. John's Branch of the Woman's Auxiliary, and some said, "Why should we be sending money outside of the city, when we are accepting charity from all over the country?" They seemed to forget that others dependent upon us must live, also. But our hopes were raised when, at the June meeting, we found that the Holy Trinity Branch at Gainesville had kindly come to our assistance and sent \$37.75, which, with \$15.90 that had been collected in two districts just before the fire, enabled us to send \$53.65 in May for our April collection.

Our monthly meetings have all taken place except the one on May 6th immediately following the fire. At the annual meeting held in Fernandina, \$25 was pledged for Miss Thackara's work among the Navajo Indians, and \$100 was already promised to the United Offering. The Altar Society kindly volunteered the loan of \$25, which was accepted in order to meet the latter pledge.

Through the unfailing efforts and spirits of our Directress, Mrs. Williams, a sewing circle has been formed by which we have been enabled to fulfill our pledges, and can also pay off our indebtedness. This work has also undoubtedly been the means of increasing the interest in our Branch, for each month new contributors are reported.

Our band of workers was broken in October by the death of Mrs. John C. L'Engle, who was one of our oldest and most faithful collectors, therefore a gloom was again cast upon our number.

The regular monthly contributions for the year amount to \$581.83, making an average of \$48.48 $\frac{7}{8}$ per month. There was a falling off this year of \$25.85 in the systematic offering; but this is not much, when we consider how many difficulties we have had to overcome. In August we sent \$109.60 to the United Offering. Christmas we expended \$35.50 on a tree, St. John's Sunday School deriving the benefit, as well as the following Missions: St. Stephen's, St. Mary's and All Saints. In February we sent \$5 toward Mrs. Twing's memorial. The Auxiliary Day collection was \$24.43, which was given to Foreign Missions. This was the largest amount we had ever sent. We have just sent \$25 for Miss Thackara's work. The total of our work, outside of the monthly collections, is \$199.63, which is \$127.73 more than last year, showing that we have actually done more work.

Constitution
OF THE
**Florida Branch of the Woman's
Auxiliary.**

I.

This Association shall be called the Florida Branch of the Woman's Auxiliary.

II.

The object of the Association is to pray for GOD'S Blessing upon the Church, and to obtain contributions for Missionary Work.

III.

Any person may become a member of this Association, who may be admitted thereto by the Directress of one of the Parochial or Mission organizations.

IV.

There shall be a President, Vice-President, Diocesan Treasurer, Recording Secretary, and Corresponding Secretary, appointed by the ecclesiastical authority of the Diocese.

V.

This Association shall have an organization in every Parish and Mission. The Rector, or Missionary in charge, shall appoint a Directress, Secretary and Treasurer, whose duty it shall be to divide the Parish, or Mission, into districts of convenient size, assigning to each a Collector, or Committee of Collectors, who shall, each month, collect the pledges; once a year to procure from the Rector, or Missionary, a list of members of the Parish, or Mission, and to try to secure from each member a contribution of one cent a day.

In case a Parish or Mission is vacant, the Bishop may appoint the officers.

VI.

There shall be a Diocesan Committee, composed of the President, Vice-President, the Diocesan Treasurer, the Recording Secretary, the Corresponding Secretary and the Directress, or the accredited representatives of the Directresses.

The President, or the Vice-President acting for her, and any of the three of the above named officers shall constitute a quorum for the transaction of business.

In case both the President and Vice-President are absent from the Diocese for more than one month, then one of the Secretaries of the Diocesan Committee may call the meeting to order, and any three of the above named officers shall constitute a quorum for the transaction of business.

VII.

The President of the Association shall have general supervision of the Association, and shall decide in all cases of dispute. The Vice-President shall act for the President when she is absent from the Diocese for more

than three months. When requested by the President, the Vice-President may act for her, at any time. When acting for the President, the Vice-President shall exercise all the authority of the President.

The Diocesan Treasurer shall have charge of the funds of the Association, and shall keep a correct account of the same. She shall make disbursements according to the direction of the ecclesiastical authority of the Diocese.

The Recording Secretary shall keep, in a book provided for that purpose, the minutes of the Diocesan Committee, and attend to such other work as the President may request.

The Corresponding Secretary shall, under the direction of the President, correspond with the organizations in the Parishes and Missions, and obtain information concerning their management and general welfare, and give such advice as the occasion may require.

The Treasurers of the Parochial Branches shall remit the funds which they have in hand to the Diocesan Treasurer on or before the fifteenth day of each month; the Treasurer of the Junior Branch shall remit each quarter, and the Treasurer of the Babies' Branch once a year.

VIII.

The Diocesan Committee shall meet on the first Wednesday of each month, and may be called together at any time by the President.

The Parochial or Mission organizations shall meet on the first Monday in each month, and may be called together by their respective Directresses at any time.

All meetings, wherever and whenever held, shall be opened with prayer.

IX.

Each Parochial Branch, and the Junior and Babies' Branches shall report the condition of the work to the

President of the Auxiliary of the Diocese every quarter.

X.

This Constitution may be altered by the Bishop of the Diocese, after giving one month's notice of the proposed change to the officers of the Association.

RULES OF ORDER

OF THE WOMAN'S AUXILIARY SOCIETY MEETING.

1. Opening Service and Address by the Bishop.
2. Roll Call by Branches.
3. Address of President.
4. Report from Branches.
5. Treasurer's Report.
6. Secretary's Report.
7. Report of Church Periodical Club.
8. General Business.

RULE I. After the opening service, the President shall take the Chair and call the meeting to order, when the order of business shall proceed.

RULE II. When a member is about to speak, she shall rise and, with due respect, address herself in an audible voice to the Chair, confining herself strictly to the point in debate.

RULE III. No member shall speak more than twice on the same subject without permission of the house.

RULE IV. While the President is putting any question, the members shall continue in their seats and not hold any private discourse.

RULE V. Every member present shall vote when a question is put, unless excused by the house.

RULE VI. When a question is under consideration, no motion shall be made, unless to lay it upon the table, to postpone it to a certain time, to commit it, to amend it, or to offer a substitute; and motions for any of these purposes shall have precedence in the order herein named.

RULE VII. A motion to lay on the table shall be decided without debate.

RULE VIII. A motion to adjourn shall always be in order; and, if unqualified, shall be decided without debate.

RULE IX. No motion shall be considered as before the house unless it be seconded.

RULE X. All committees shall be appointed by the President unless otherwise ordered.

RULE XI. The reports of all committees shall be in writing and shall be entered on the minutes, unless otherwise ordered.

RULE XII. Before the final adjournment of the meeting, the minutes of the last day's proceedings shall be read, corrected (if necessary) and approved.

He gives further notice of a new Article IX, and the numbering of Article IX as Article X. The new Article IX reads: Each Parochial Branch and the Junior and Babies' Branches shall report the condition of the work to the President of the Auxiliary of the Diocese every quarter.
