

Address of the Bishop

It is always a pleasure to meet the members of the Woman's Auxiliary, for I know I am meeting with those who have the same interest at heart which I have; I know I stand face to face with those who sympathize with me in the work for the Master, and who are earnest, and anxious to further the blessed labor of extending GOD'S Kingdom.

I have often followed in spirit the faithful women who go from door to door seeking to collect the few pennies each month, and in thought I have sympathized with them, as they were turned away empty handed, and have felt for them as they were met with discouragement from one and another.

But after all, no matter how frequent the rebuff, there is no cause for discouragement, and no reason to feel aught else but sorrow for those who do not show an interest in the holy work. When GOD'S Messenger comes to a house, and is not received as a Messenger from the Holy One, GOD'S opportunity is rejected, the privilege is declined, and a misfortune has befallen the hapless inmates.

We want to get rid of ourselves in doing GOD'S work, and bear in mind we are GOD'S Messengers. We must do our part, and leave the result in the Master's hands—Unless the Spirit of GOD makes our words effectual, we shall talk in vain.

We ought to rely more upon the Holy Ghost, and speak as He gives us utterance.

I sometimes wonder if we go forth in the power of the Lord, trusting to the Holy Spirit to give us strength, and wisdom, and utterance; or whether we go forth in our own strength, relying upon our persuasive powers, and trusting to our importunity.

But there is still another side, which we ought not to forget. The servant is not above the Master.

The multitude took up stones to cast at Him. You all know how He suffered in the end of His life. Yet He was always patient, and continued His labors in spite of the opposition with which He met from those who ought to have welcomed Him, and supported Him in His work—He was wounded in the house of His friends; but the very opposition, and destructive policy of those in authority, made manifest His patience, His endurance, His sympathy, His love. Even on the cross He prayed for His murderers.

We are weak, and a very little suffering turns us away from our duty. Still there is such a thing as having a burden too heavy to bear; and at times it does seem as though our strength must give way, and we must fall under the load.

The cross is often heavy. The Master was borne to the earth by the weight of His cross, but there was found one to bear it for Him; the mad executioners compelled Simon the Cyrenian to bear it. We may be sure when our cross becomes too heavy, the Master's hand will relieve us.

I speak to you in this strain not because you have neglected your work, but because you are women, and have been given special spiritual powers, and a special capacity for holy work. There were three women and one man at the cross.

What happened there, I suppose will always occur. Woman is naturally more religious than man—It was through woman that the world was civilized. The Lord made her Mistress of the hearth.

You have done much—without your aid and work the Diocese would be in a sad condition, and my mail, bad enough as it is now, would be more full of pleadings, earnest pleadings, for the word of GOD.

The question has arisen in my mind whether you can do more; whether you fully realize you are GOD'S Messengers, and appreciate the gifts which you have received to work under the direction and care of the Holy Spirit? I am most grateful and most thankful for your aid and help.

You have helped me by your prayers, and you have fed the hungry, and have cheered the spirits of the workers in GOD'S vineyard.

We are in need of more money in the missionary treasury, and I appeal to you, and ask you, if you can do more?

I trust the systematic offering will be increased during the coming year, and that when we meet next time we shall find, through the spirit of GOD, we have grown stronger, wiser, and more earnest.

Address of Diocesan President

The thirty-fifth Annual report of the Woman's Auxiliary to the Board of Missions contains the following statement:

"It is interesting to notice in the year's reports from such branches as Alabama, Florida, and Georgia, that the officers dwell upon this sense of responsibility, the purpose of the Auxiliary to aid the Board, and the increasing need of understanding and appreciating its aims."

I would be lacking in my duty if I failed to grasp every opportunity to present to you, women of the Florida branch, the aims and needs of the Woman's Auxiliary, to the Board of Missions.

Do you realize that I am one of over nine hundred officers? And in accepting the office of president of the Florida branch that I have assumed a personal responsibility—that I must try in every way that lies in my power to acquaint the uninterested with the inspiring duty and blessed privilege of sharing in this work for missions.

If I emphasize strongly, it is my duty.

The aims of the Auxiliary are to create a deeper missionary knowledge, and interest among our women, young people, and children, and to form in them habits of daily prayer, constant reading and study, systematic and conscientious giving for missions of the Church. That GOD'S work perpetually demands greater supplies is the grand evidence of its progress and success.

It is your earnest co-operation I ask, interest the uninterested, surely by an investment of influence we could carry our work higher—woman like man, may be said to be a mysterious bundle of forces, moving through society, carrying blessings or blightings, gets its meaning from the capacity of others to receive its influence.

"We unconsciously exhale our influence for good or for evil, if our heart glows with love it warms, if frozen with selfishness it chills, if corrupt it poisons, if pure hearted it cleanses."

Let us use our influence for the upbuilding of the missions—spread our knowledge of the great work to be accomplished by the women—tell the uninterested of the great group of noble women who journeyed into the swamps of Africa, and the

mountains of Asia, and the frozen fields of Alaska, making their way as missionaries of mercy and healing, Knights of the Red Cross and Veritable Daughters of the King, no cottage so remote as not to feel this new influence.

Are there not young women in the Diocese of Florida willing to join this band of women and devote their lives to this work for the Church?

Miss Thackara's example is a noble one, added to Miss Parkhill's—the gift of personal service is not lacking in the past from Florida—also by being more thorough and systematic and far reaching in our methods, with more frequent and united prayer, the development of study classes, though we may be far from the center of missionary work, seeing but seldom the workers in the mission field, we can study the lessons that come to us, fresh records of the hardships endured, sometimes of advance, then the story of hinderance.

Shall we fail to respond? Let us give a pledge of fresh endeavor. We could not flag and hesitate while under the influence of their example, let it prove a source of inspiration—Shall we begin with the Auxiliary Apportionment? "This expressed wish of the Board is the one practical work which the Board of Missions has set before the Woman's Auxiliary in recent years: that it shall contribute yearly to its treasury \$100,000 that may be applied toward the annual appropriation to the mission field. The call came through the General Secretary of the Board in San Francisco, 1901; and his influence and encouragement have been a constant aid in making the work toward this end a habit in the life of the Woman's Auxiliary." The amount the Florida Branch is asked to contribute is, Women \$60.00; Juniors \$10.00; Babies Branch \$70.00.

Your Diocesan officers feel assured that you will respond cheerfully to the apportionment plan. While emphasizing the strong necessity for the Florida Branch, keeping in touch with the Board of Missions, it must not be done at the expense of the mission work within our own diocese. The systematic offering must not decrease, but must be increased. I stated in my last annual address, that if only two thousand persons in the Diocese would give one cent a day the result would be seven thousand, three hundred dollars per annum. Let the officers of the branches take the Parish lists, go to every person named, and ask them to aid in carrying on the Bishop's work. The Northern, Eastern, Southern and Western parts of the diocese must come to the rescue—the reports in the Parish Leaflet and Florida Church News leaves no branch in doubt of the amounts contributed.

When the next General Convention meets in Richmond, in October, 1907, it will be to observe the three hundredth anniversary of the planting of the church in America.

There is to be a Thank-offering for three hundred years of English Christianity from the men of the church—At the same time the united offering of the Woman's Auxiliary will possibly be placed on the same altar. "Who will make it? The women and girls of the Woman's Auxiliary to the Board of Missions, and all other women and girls they can get to help. Here are some in China, and there are others in Mexico and in Africa; so far apart in miles, and so close in heart, who will unite to make it. Where and when will they make it? They will make it in Richmond, Virginia, on Thursday, October 3, 1907, when the representatives of the Woman's Auxiliary from New York to California, from Maine to Texas, from Alaska to Brazil will meet to make this united offering. Why will they make it?

Because for eighteen years, over and above the work of every year, each third year they have been accustomed to show their thankfulness by bringing their united gift to this united Service of Holy Communion.

For what object will they make it? They will give \$10,000 to put up some mission building. The remainder of the gift will train young women to be missionaries. Will send them into the mission field and support them there, and will care for them if disabled.

How can we help to make it?

If we have a united offering box, and have sent its contents each six months since October, 1904, to our treasurer to be put at interest, we must not let a day or week pass without dropping something in to send to the treasurer as a last remittance. If we have had no mite box, but have sent a yearly check, let us make this last equal to those of former years; larger if we can.

If we have not given heretofore let us give now in a measure to show that we appreciate what the greatness of such a united gift should be, made by women united in a common love for one Divine Lord, in one Holy Church, at work for one great end."

In my great desire to influence you I have quoted several paragraphs from a leaflet sent out from the Missions House— Shall we not respond generously to the call for the united offering? We gave \$464.00 three years ago. Let us carry five hundred dollars to Richmond this great thanksgiving year! I am sure with the united effort of the Woman's Auxiliary, the Juniors and the Babies Branch this amount can be collected.

"Is not the crowning glory of mission work, that they who have learned the love of Christ shall pass His story on to those who do not know, that they, too, may have the blessed knowledge of His love?"

Report of Recording Secretary

The Seventeenth Annual Meeting of the Florida Branch of the Woman's Auxiliary was held at Gainesville, May 15, 1907.

The Bishop of the Diocese opened the meeting at 9:00 o'clock A. M. in Holy Trinity Church, by a celebration of the Holy Communion, and an address to the women of the Association.

The Bishop was assisted by the Rev. F. H. Craighill, Rector of the Parish.

After the service, the members of the Association assembled in the commodious new Hall of the Elks Club, which had been very kindly placed at the disposal of the Woman's Auxiliary.

Immediately before the meeting was called to order Mrs. John Freeman Young, the President, was presented with a very handsome silver mounted ebony gavel, by the Association, Mrs. J. G. Ruge making the following very happy presentation speech :

"Madam President, Co-officers, and women of the Auxiliary :

It is with sincere appreciation that I am privileged to feebly express our esteem and gratitude for our beloved President, who is ever willing and ready to assist us in any of our difficulties, and who through years of faithful service is as a wall of strength to us all ; I tender to you Madam President in behalf of the Woman's Auxiliary this gavel, the emblem of authority, and we feel sure that in the use of this, as inscribed with our love and affection, that you will always continue to command the further good faith of your co-workers."

The President expressed her thanks and appreciation in a few gracious words.

The business meeting was then called to order.

The report of Mrs. Wm. M. Stockton, President of the Babies Branch, was read by the Secretary.

On motion the Reports were all accepted.

The Treasurer's Report, owing to the absence of that Officer on account of illness, was read by the Secretary, and was received and approved.

The Corresponding Secretary read a report which was accepted,

Mrs. Drew Williams offered the following resolution :
Resolved : That the offertories on Auxiliary Day and at our Annual Meetings be given for Diocesan Missions.

Before adopting the resolution, Mrs. J. G. Ruge wished an explanation of how the apportionment for General Missions would in future be raised, if these offertories which have hitherto been used for this purpose, should be kept in the Diocese.

Considerable discussion ensued in regard to a proposed plan of assessing the Branches according to their numerical strength, and the President appointed a Committee on Assessment consisting of the following members : Mrs. Craighill, Mrs. Ruge, Mrs. Arnold, Mrs. Whitney and Mrs. Drew Williams.

Mrs. Ruge then moved the adoption of Mrs. Drew Williams' resolution which was carried.

Mrs. Stewart Worden spoke of the difficulties encountered by collectors in making people understand the objects of the Auxiliary Association, and Mrs. Drew Williams reminded her of the Bishop's words of the morning, when he said collectors should simply consider themselves Christ's Messengers.

Mrs A. E. Gray offered the following resolution which was adopted :

Resolved : That each delegate present at this meeting, be appointed a committee of one to thoroughly canvas her district, and endeavor to interest and induce all baptized members of the Church to become contributors to the Woman's Auxiliary Association.

Mrs. Gilmore spoke very earnestly in behalf of the Babies Branch.

Mrs. F. H. Craighill extended an invitation from Holy Trinity Branch to the delegates, to attend a reception at the residence of Mrs. E. E. Cannon, from four to six o'clock this afternoon, and to take a drive about the city on Thursday afternoon.

On motion of Mrs. Drew Williams the delegates accepted the kind invitations of Holy Trinity Branch.

The President called the attention of the delegates to the importance of redeeming the pledges made at the last Annual Meeting for the United Offering, and requested them to make a greater effort, as the desired amount of \$500.00 has not yet been pledged.

Resolved: That we realize the need of more workers in the vineyard, and will try to find and encourage suitable young women in the Diocese, who wish to devote their lives to the work of the Church.

Mrs. Arnold offered the following resolution which was adopted.

Resolved: That the Woman's Auxiliary wishes to express its deep appreciation of the valuable services of the collectors. By their quiet, regular and self-sacrificing work the Systematic Offering is kept up, and though their names are not in evidence in the Annual Reports, they are written in letters of gold on a higher Honor Roll.

Mrs. J. M. Jones offered the following resolution which was adopted.

Resolved: That the delegates to the Seventeenth Annual Meeting of the Woman's Auxiliary extend most hearty thanks to Holy Trinity Branch, for the kind hospitality and lavish entertainment enjoyed by them during this visit; and be it further

Resolved: That a vote of thanks be given the Elks Club, for the use of its comfortable hall for our meetings.

Mrs. W. W. Hampton replied to Mrs. Jones, and presented the delegates with pretty Calendars as souvenirs of their visit to Gainesville, whereupon she was given a rising vote of thanks.

After a short intermission to allow the Secretary to arrange her minutes, they were read and approved.

On motion the Seventeenth Annual Meeting was then adjourned sine die.

Report of Corresponding Secretary

During the past year the Auxiliary has moved steadily forward. There have been a few changes in the list of Parochial Officers. Some of our most faithful workers have been compelled to retire on account of ill health or removal; but the fact that the vacancies thus caused have been promptly filled, shows that their spirit still dominates the Branch and the work will not be allowed to lapse. The Diocesan Committee note with regret the resignation of Mrs. B. F. Jordan, President of the Babies Branch and Vice-President of the Woman's Auxiliary, after several years of faithful and efficient service. The Bishop has appointed in her place, Mrs. Wm. M. Stockton, an experienced and enthusiastic worker.

Our most progressive move during the year was the adoption of the Parish Leaflet or Florida Church News as our official paper, and much of the Corresponding Secretary's work has been in connection with its subscription list and in gathering material for the Auxiliary Page. The Diocesan Committee assured the Editor that they felt confident of being able to secure at least one hundred and fifty subscribers, but, to our regret, all activity in that direction ceased suddenly when less than half that number had been reached. We have long felt the need of a regular paper as a means of communication between the Diocesan Committee and the Branches, and this excellent little paper is ours to use, without any expense to us and it does seem we are missing an opportunity in not doing our utmost to secure the requisite number of subscribers.

It is gratifying to note the more general observance of Auxiliary Day, when a continuity of prayer ascends from the Woman's Auxiliary of Florida for a blessing on their work and on the labors of those whom they are trying to help.

Missions study and regularly organized Mission Study Classes have become an established fact in our Diocese and their influence is felt throughout our work. Some of the text books recommended by the Educational Secretary are as absorbing as any romance.

At the last Annual Meeting we cheerfully voted the collections on Auxiliary Day and at the Annual Meeting of 1907 to our beloved Bishop to help him through a crucial year, and we rejoice to find a decided increase in our contributions to Diocesan Missions. But it is to be regretted that our Auxiliary Apportionment is still unpaid.

The Auxiliary Apportionment has never been brought prominently before the Branches, owing to the fact that the two collections mentioned have heretofore covered our assessment. It has been decided that this is an uncertain and irregular way to raise a definite sum and a Committee has been appointed by the President to apportion the small amount (\$60.00) among the Branches. This will leave us free to dispose of these collections as we think best.

It would be well if the Branches in their zeal for outside work would remember that "designated" contributions count on our apportionment, while "specials" do not. Perhaps some members not familiar with Miss Emery's Reports, fail to see the distinction.

A "Designated Contribution" aids the General Board of Missions in paying its pledges to some particular field or missions and is counted on our Apportionment. As we are an Auxiliary to the General Board it is our duty to help it to the extent of our Apportionment, before indulging in "Specials," and do not forget that "Designated" Contributions are counted on our Apportionment.

After the Apportionment comes the United offering for sending women workers into the field. Of course, all of these objects are in addition to our regular systematic work.

There is much encouragement in this great truth, so ably expressed in a recent Sunday School Magazine:

"THE MISSIONARY WORK OF THE CHURCH IS THE WHOLE BUSINESS OF THE CHURCH AND IT IS THE BUSINESS OF THE WHOLE CHURCH TO GIVE THE WHOLE GOSPEL TO THE WHOLE WORLD AS SPEEDILY AS POSSIBLE."

CONSTITUTION
OF THE
FLORIDA BRANCH OF THE WOMAN'S
AUXILIARY.

I.

This Association shall be called the Florida Branch of the Woman's Auxiliary.

II.

The object of the Association is to pray for GOD'S blessing upon the Church, and to obtain contributions for Missionary Work.

III.

Any person may become a member of this Association, who may be admitted thereto by the Directress or one of the Parochial or Mission organizations.

IV.

There shall be a President, two Vice-Presidents, Diocesan Treasurer, Recording Secretary and Corresponding Secretary appointed by the ecclesiastical authority of the Diocese. The President of the Junior Branch and the President of the Babies' Branch of the Auxiliary, shall be, *ex-officio*, Vice-Presidents of the Auxiliary.

V.

This Association shall have an organization in every Parish and Mission. The Rector, or Missionary in charge, shall appoint a Directress, Secretary and Treasurer, whose duty it shall be to divide the Parish or Mission, into districts of convenient size, assigning to each a Collector, or Committee of Collectors, who shall, each month, collect the pledges; once a year to procure from the Rector, or Missionary a list of the members of the Parish, or Mission, and try to secure from each member a contribution of one cent a day.

In case a Parish or Mission is vacant, the Bishop may appoint the officers.

VI.

There shall be a Diocesan Committee, composed of the President, the Vice-Presidents, the Diocesan Treasurer, the Recording Secretary, the Corresponding Secretary and the Directresses, or the accredited representatives of the Directresses.

The President or one of the Vice-Presidents acting for her, and any three of the above named officers shall constitute a quorum for the transaction of business.

In case both the President and Vice-Presidents are absent from the Diocese for more than one month, then one of the Secretaries of the Diocesan Committee may call the meeting to order, and any three of the above named officers shall constitute a quorum for the transaction of business.

VII.

The President of the Association shall have general supervision of the Association, and shall decide in all cases of dispute. One of the Vice-Presidents shall act for the President when she is absent from the Diocese for more than three months. When requested by the President, the Vice-President may act for her, at any time. When acting for the President, the Vice-President shall exercise all the authority of the President.

The Diocesan Treasurer shall have charge of the funds of the Association, and shall keep a correct account of the same. She shall make all disbursements according to the direction of the ecclesiastical authority of the Diocese.

The Recording Secretary shall keep, in a book provided for that purpose, the minutes of the Diocesan Committee, and attend to such other work as the President may request.

The Corresponding Secretary shall, under the direction of the President, correspond with the organizations in the Parishes and Missions, and obtain information concerning their management and general welfare, and give such advice as the occasion may require.

The Treasurers of the Parochial Branches shall remit the funds which they have in hand to the Diocesan Treasurer on or before the fifteenth day of each month; the Treasurer of the Junior Branch shall remit each quarter, and the Treasurer of the Babies' Branch once a year.

VIII.

The Diocesan Committee shall meet on the first Wednesday of each month, and may be called together at any time by the President.

The Parochial or Mission organizations shall meet on the first Monday in each month, and may be called together by their respective Directresses at any time.

All meetings, wherever and whenever held, shall be opened with prayer.

IX.

Each Parochial Branch, and the Junior and the Babies' Branches shall report the condition of the work to the President of the Auxiliary of the Diocese every quarter.

X.

This Constitution may be altered by the Bishop of the Diocese, after giving one month's notice of the proposed change, to the officers of the Association.

RULES OF ORDER.

Of the Waman's Auxiliary Society Meeting.

1. Opening Service and Address by the Bishop.
2. Roll Call by Branches.
3. Address of President.
4. Report from Branches.
5. Treasurer's Report.
6. Corresponding Secretary's Report.
7. Report of Church Periodical Club.
8. General Business.

RULE I. After the opening service, the President shall take the chair and call the meeting to order, when the order of business shall proceed.

RULE II. When a member is about to speak, she shall rise and, with due respect, address herself in an audible voice to the Chair, confining herself strictly to the point in debate.

RULE III. No member shall speak more than twice on the same subject without the permission of the house.

RULE IV. While the President is putting any question, the members shall continue in their seats and not hold any private discourse.

RULE V. Every member present shall vote when a question is put, unless excused by the house.

RULE VI. When a question is under consideration, no motion shall be made, unless to lay it upon the table, to

postpone it to a certain time, to commit it, to amend it, or to offer a substitute; and motions for any of these purposes shall have precedence in the order herein named.

RULE VII. A motion to lay on the table shall be decided without debate.

RULE VIII. A motion to adjourn shall always be in order, and, if unqualified, shall be decided without debate.

RULE IX. No motion shall be considered as before the house unless it be seconded.

RULE X. All committees shall be appointed by the President unless otherwise ordered.

RULE XI. The reports of all committees shall be in writing and shall be entered on the minutes, unless otherwise ordered.

RULE XII. Before the final adjournment of the meeting, the minutes of the last day's proceedings shall be read, corrected if necessary, and approved.
