### Address of the Bishop

These annual meetings always bring up the struggle of the past with its failures and its glorious achievements. When we look back we see much left undone. If we are to go on increasing in strength and influence we must consider the points of vantage which might have been occupied, the advance which we might have made had we shown more energy and placed our trust more perfectly in the over-ruling power of the Master. No one can say truly she can not accomplish a work for the Master till she has tried in the right way.

First, then, the trial. We hesitate to undertake Christ's work very often because we feel our incapacity or because we think we have not the time. Certainly no one has the capacity to do Christ's work. One of the mysteries of the Lord's dispensation is the fact He has intrusted the preaching of the Gospel and the care of His church to weak, fallible men. Yet so has the Lord determined and it is not for us to say He has made a mistake. We are distinctly taught to pray for wisdom. We have not the capacity, but are we willing the Lord being our Helper. And the time. Somehow we find time to do the things we are most anxious to do. The question of time is largely a question of earnestness. We all have some time which we can give to the Lord. Perhaps some more than others, but busy people usually have more time at their command than those who have few pressing occupations. When we have a daily round of important duties time becomes so valuable we learn how to economize the flying moments and usually find it possible to give a portion of our time to outside demands.

And when we speak of trying to serve the Master in the right way we mean in His way. Peter, John and Paul were not strong men in one sense. They all lacked wisdom. They were zealous, earnest, energetic, but Peter seemed to be overconfident of his own powers, and failed because he did not rely on the Lord. St. John had a violent temper which led him to harsh things. St. Paul had the same fault. Yet these men did a great work for the Master, because they learned they had but one thing to do, viz.: to work energetically and leave the result in the hands of the Lord. They learned what every worker in the Lord's vineyard has to learn, He gives strength, capacity, power when it is needful. In other words the power to do things comes from the Lord. This is what we are apt to forget. We think

we must have the power before we undertake a mission. If we thought we had the strength we should not rely on the Lord and then we would be like St. Peter, failing even unto the denial of the Lord, when we ought to defend His cause. The Lord wants men and women who will trust in Him. But to trust in Him means to live closely to Him. To trust in Him means a life of prayer.

One of the weak points in the Woman's Auxiliary is the way in which the members attend the monthly meetings. No one knows better than I do the self-sacrifice and the devoted earnestness of the Woman's Auxiliary. I often told you how grateful I was for the help, the support, and the strength which you have given me. Yet I have deplored the carelessness of some of the members. A few minutes' prayer seems to be considered such a trifling thing. We are not heard because of our much speaking. Nor are we heard because of the goodness of our prayers. Our prayers are heard because of the goodness of the Lord and because of our earnest endeavor. Where the endeavor is wanting then, of course, our prayers are worth nothing. Certainly if we desire God to bless our work we will pray for the blessing. We can not try to advance God's kingdom unless we put ourselves and all we do in His hands. I wish there was more real earnest trust in God. I am quite sure the importance of meeting together to pray for God's blessing and God's guidance is not appreciated. I wish to press the need of more constant prayer. It is through intercourse with God that we receive wisdom and impulse. God's hand is laid upon us when we look up to Him. When He lays His hand upon us the impulse comes and like the prophets of old we feel impelled to speak and to do. I would like to see a greater number joining in the prayers at the monthly meetings.

I am sure if the trouble was taken to attend these meetings for the sake of asking God's blessing on the work, there would be an increase of enthusiasm and the Woman's Auxiliary would become even a greater factor than it is in the advancement of God's kingdom. I do not wish you to think I do not fully appreciate all you have done. Unless we had your aid many of the mission stations would be closed and the trials of the Diocese would be multiplied. I am most grateful for all you have done. I can not be grateful enough. You have held up my hands and strengthened me in many a dark hour. I would not urge a greater reliance on the Master did I not know full well you had trusted in Him. The more we trust Him the more He gives us power to do. It is amazing the way in which He works when we trust Him fully. The success and value of our work depends upon our trust in Him. My charge to you then is to trust Him more and more.

### Address of Diocesan President

The gladness of reunion in St. Augustine is clouded, for we miss the sunshine of the dear face now bathed in eternal light, our loved Vice-President, Mrs. Edwin Gardner Weed. In the councils of the Auxiliary she was gracious and sweet, wise and kind, full of calm dignity, and, as one said of her, "of gentle strength and strong gentleness." Her life and character were an inspiration. A woman who, not by what she said or did but simply by being what she was, exerted an influence as potent as it was unobtrusive. Many and eloquent words have been written and spoken of her; her good deeds have been commended; her exquisite charity recounted; her exalted station described. But in our memories she will live as in the fullest and highest and noblest sense a Southern gentlewoman—nothing else would befit her; nothing more need be spoken of her. The Julia M. Weed, branch of the Junior Auxiliary, has been organized as a fitting memorial. The initial step has been taken by the young girls whom she often gathered together in her own home. Although dead, she seems still to speak to them and to beseech them to turn their faces to what is lofty and good, and to be earnest workers in God's holy church. "Her ways are ways of pleasantness and all her paths are peace."

Now may I commend to you women of the Florida branch of the Woman's Auxiliary the much loved and devoted daughter, Miss Margaret Gould Weed, who at the earnest solicitation of the Diocesan officers and members of the Auxiliary has consented to fill the office of Vice-President.

Hearing of the trials and discouragements in many parishes and missions, we have waited with anxious misgivings for the Treasurer's report. We find the sum total more than we had any season to expect. It shows what steady, earnest work will accomplish; it also demonstrates the fact there are some faithful women in each

parish "who really care." It is said often that obstacles are the stepping stones to success. In the chemistry of business, men are tried by fire. Do not flinch, however fierce the fire, only the scorch of the flame can harden the steel for its work. "Concentrate, put it all in your initiative, your enthusiasm, your whole ability to see far, to think clear, to develop old ideas and create new. Every ounce of your personal efficiency, every pound of your power to plan and build." Give to the Auxiliary your best work; well trained effort is always needed. One of our Bishops says: "The glory of the Woman's Auxiliary is the patient, loving devotion of women to the little things, not small but great in successful achievement."

One of the hopeful signs that the work of the Auxiliary is spreading its influence and throwing great waves of white light into the dark places is the increased interest in the Mission Study Classes, and what is even better the Bible Classes that are organized and sustained by the earnest devotion of even those who leave the busy whirl of society to be refreshed and strengthened by Bible study. St. Paul says: "Preach the word; be urgent in season, out of season, reprove, rebuke, exhort." These words help us to approach our task with increased courage, and perhaps to carry it on with increased efficiency. With the courage born of experience, give the glad hands of encouragement to the Juniors. Help the little ones. The day is not far distant when into these little hands will be given the work of the Auxiliary. Related to the Juniors by a bond so close that it is difficult to define where the influence begins are the *Little Helpers*. The Babies' Branch, the nursery of the Church—they form the reserve force, from which we must fill the broken ranks of the little Christian soldiers. Lose no opportunity to further the influence of the training school for missions. Let every eye sparkle in response, and every heart answer to the call.

Now comes the "Church Periodical Club" to claim your attention. To the reorganization of this very important department of the Woman's Auxiliary I wish to call especial attention: I commend to your kind care our Diocesan Correspondent, Mrs. John E. Hartridge, who will explain, "What it is, what it does, what it needs."

Before closing my address, I wish to emphasize the strong necessity for greater activity in the work for Diocesan missions. The needs of the Diocese are a constant source of anxiety to the Bishop. I wish we might inspire greater zeal. The meetings for prayer and information have kindled much zeal for missions, and quickened the spiritual life of those who have taken part in them, but there are so many who have never been reached. Reach out,

spread the influence of the Auxiliary until it reaches the height and breadth of the Diocese! While the Woman's Auxiliary is acknowledged as a powerful lever in the mission work of the Diocese there is much work to be done, many feeble missions to be strengthened by our united efforts. Now I would ask your earnest support for the *Florida Church News*; let us cheerfully pledge the same amount for the support of this Diocesan paper that was contributed last year. The assistance we give makes it possible for the paper to be published. The United Offering has become a part of our organization—it keeps us in touch with the great throbbing heart of the world beyond the seas; it is the great searchlight, shedding its white light in the dark places, crowded with sickness and sorrow. You will respond to the call, I am sure, as generously as you did to the Triennial in Richmond.

In conclusion, I would earnestly impress upon you women of the Auxiliary the great importance of regular, conscientious, systematic work. Organization is a great force of nature and society. The foremost thinkers believe organization the best medium of conducting public affairs. Why not adopt this practical suggestion in our woman's work for the Church?

### Report of Corresponding Secretary

It is encouraging to report the organization of two new Branches this year, one at Madison and one at All Saint's Church, South Jacksonville.

In looking over the reports that have been sent in to the Treasurer for the Annual Meeting, a sad state of affairs is manifest. Out of eighteen reports, eleven show a decrease in the Systematic Offering and the other seven only a slight increase. One Branch, St. Andrew's, Jacksonville, shows a wonderful increase, the number of contributors having been doubled during the year.

The previous year we were hard pushed to make up the United Offering, and the energy applied to that end helped every other fund to thrive.

This year there seems to have been a relaxation of effort as though the Systematic Offering could take care of itself.

I wish every member of the Auxiliary could have the benefit of the "heart to heart" talks of our dear Bishop, with which he sometimes favors the Diocesan Committee. I feel sure each Branch would do as did the officers of St. John's Branch, Jacksonville, who immediately pledged themselves to raise an extra amount outside of the Systematic Offering, as a special gift to the Bishop, and the one hundred dollars they sent him, to quote his own words, enabled him "to pay the missionary stipend of one of the clergy for three months" and gave him "twenty-five dollars to help out the stipend of another."

One thing the Bishop told us was that he had sent a thousand dollar clergyman to one of his missions, solely on faith, not knowing where one penny of his salary was coming from.

Can we not make this one hundred dollars from St. John's, which their Directress assures me they expect to raise again next year, a nucleus of a "Bishop's Special Fund," for which we could work outside of our Systematic Offering of one cent a day?

The *Florida Church News* has been regularly supplied by the Corresponding Secretary with Auxiliary notes, and is improving each month under the able editorship of Rev. W. T. Cavell.

The Sewing Circle still creates the contingent fund, upon which we have drawn for all these amounts needed, outside of the Systematic Offering.

During Lent a Mission Study Class was held every Thursday afternoon, the subject being "The Progress of the Church in Japan." These Classes, we feel sure, have a tendency to increase the interest in foreign Missionary fields.

CONSTITUTION OF THE FLORIDA BRANCH OF THE  
WOMAN'S AUXILIARY

---

I.

This Association shall be called the Florida Branch of the Woman's Auxiliary.

II.

The object of the Association is to pray for GOD'S blessing upon the Church, and to obtain contributions for Missionary Work.

III.

Any person may become a member of this Association, who may be admitted thereto by the Directress of one of the Parochial or Mission organizations.

IV.

There shall be a President, three Vice-Presidents, Diocesan Treasurer, Recording Secretary and Corresponding Secretary appointed by the ecclesiastical authority of the Diocese. The President of the Junior Branch and the President of the Babies' Branch of the Auxiliary, shall be, ex-officio, Vice-Presidents of the Auxiliary.

V.

This Association shall have an organization in every Parish and Mission. The Rector, or Missionary in charge, shall appoint a Directress, Secretary and Treasurer, whose duty it shall be to divide the Parish or Mission into districts of convenient size, assigning to each a Collector, or Committee of Collectors, who shall, each month, collect the pledges; once a year to procure from the Rector or Missionary a list of the members of the Parish, or Mission, and try to secure from each member a contribution of one cent a day.

In case a Parish or Mission is vacant, the Bishop may appoint the officers.

VI.

There shall be a Diocesan Committee, composed of the President, the Vice-Presidents, the Diocesan Treasurer, the Recording Secretary, the Corresponding Secretary and the Directresses, or the accredited representatives of the Directresses.

The President, or one of the Vice-Presidents acting for her, and any three of the above named officers shall constitute a quorum for the transaction of business.

In case both the President and Vice-Presidents are absent from the Diocese for more than one month, then one of the Secretaries of the Diocesan Committee may call the meeting to order, and any three of the above named officers shall constitute a quorum for the transaction of business.

#### VII.

The President of the Association shall have general supervision of the Association, and shall decide in all cases of dispute. One of the Vice-Presidents shall act for the President when she is absent from the Diocese for more than three months. When requested by the President, the Vice-President may act for her, at any time. When acting for the President, the Vice-President shall exercise all the authority of the President.

The Diocesan Treasurer shall have charge of the funds of the Association, and shall keep a correct account of the same. She shall make all disbursements according to the direction of the ecclesiastical authority of the Diocese.

The Recording Secretary shall keep, in a book provided for that purpose, the minutes of the Diocesan Committee, and attend to such other work as the President may request.

The Corresponding Secretary shall, under the direction of the President, correspond with the organizations in the Parishes and Missions, and obtain information concerning their management and general welfare, and give such advice as the occasion may require.

The Treasurer of the Parochial Branches shall remit the funds which they have in hand to the Diocesan Treasurer on or before the fifteenth day of each month; the Treasurer of the Junior Branch shall remit each quarter, and the Treasurer of the Babies' Branch once a year.

#### VIII.

The Diocesan Committee shall meet on the first Wednesday of each month, and may be called together at any time by the President.

The Parochial or Mission organizations shall meet on the first Monday in each month, and may be called together by their respective Directresses at any time.

All meetings, wherever and whenever held, shall be opened with prayer.

#### IX.

Each Parochial Branch, and the Junior and the Babies' Branches

shall report the condition of the work to the President of the Auxiliary of the Diocese every quarter.

## X.

This Constitution may be altered by the Bishop of the Diocese, after giving one month's notice of the proposed change, to the officers of the Association.

### RULES OF ORDER OF THE WOMAN'S AUXILIARY SOCIETY MEETING

---

1. Opening Service and Address by the Bishop.
2. Roll Call by Branches.
3. Address of President.
4. Report from Branches.
5. Treasurer's Report.
6. Corresponding Secretary's Report.
7. Report of Church Periodical Club.
8. General Business.

Rule I. After the opening services, the President shall take the chair and call the meeting to order, when the order of business shall proceed.

Rule II. When a member is about to speak, she shall rise and, with due respect, address herself in an audible voice to the chair, confining herself strictly to the point in debate.

Rule III. No member shall speak more than twice on the same subject without the permission of the house.

Rule IV. While the President is putting any question, the members shall continue in their seats and not hold any private discourse.

Rule V. Every member present shall vote when a question is put, unless excused by the house.

Rule VI. When a question is under consideration, no motion shall be made, unless to lay it upon the table, to postpone it to a certain time, to commit it, to amend it, or to offer a substitute; and motions for any of these purposes shall have precedence in the order herein named.

Rule VII. A motion to lay on the table shall be decided without debate.

Rule VIII. A motion to adjourn shall always be in order, and, if unqualified, shall be decided without debate.

Rule IX. No motion shall be considered as before the house unless it be seconded.

Rule X. All committees shall be appointed by the President unless otherwise ordered.

Rule XI. The reports of all committees shall be in writing and shall be entered on the minutes, unless otherwise ordered.

Rule XII. Before the final adjournment of the meeting, the minutes of the last day's proceedings shall be read, corrected if necessary, and approved.
