## THE BISHOP'S ADDRESS

I regret very much that I was unable to greet you yesterday in your own meeting, though, of course, I did have the pleasure of greeting you together with the Council in the opening service. May I say that I think that that united service, that Corporate service of those three bodies on the opening day of the Council is really an inspiration to us all. That was such a splendid service yesterday. I don't think we ever had a finer opening nor a greater interest in our Council than we have this year, and I am deeply grateful for this.

There are just a few thoughts, that I want to leave with you this morning. The first is the thought that is always in my heart when I come into the presence of the women of the Auxiliary, and that is of thankfulness—of thankfulness for everything that you have done—and you cannot realize what it has meant to me this year. I particularly enjoyed the pleasure of attending all of the District meetings except one this year. Those little meetings, while not largely attended in some of the districts, are really among the most interesting and thoroughly enjoyed events of the whole year for me. I feel that the first word I always want to say when I come into the presence of a woman of the Auxiliary, or the women of the Auxiliary, is thank you for all that you are doing, because I do thank you.

There is another thought though that I have in mind this morning—it is exemplified so convincingly by your presence,—the thing that I think is the most precious thing, the most needed thing and the most valuable thing in our Church work, and that is loyalty. Loyalty! It sounds like carrying coals to Newcastle to speak to the women of the Auxiliary about loyalty, but I do so want to thank you for your loyalty and I want to thank Miss Margaret for her loyalty. When once we can get into the minds of our men and women all over this Diocese, and all over this Church of ours, that a real Christian is always a loyal Christian—one that is loyal to Jesus Christ—we will have accomplished a great deal. You women, I think, are more loyal than men; in fact I know that. I know what you have to put up with with men. Some one said the woman was made to be patient with man, and I know that you know that that is true. Women certainly are loyal when men are not.

We have not had many disturbances in the Diocese, and the little that we have has not amounted to very much. Here and there a little squabble or a little disagreement, and I find that though some of the women squabble a good deal more than the men, when it comes down to the real test, they are more loyal than the men are in the Church, and I think it is because the women sense this: that their first loyalty is, not to the Parish, or to their President of the Auxiliary, or even to the Bishop, but that their loyalty is to what these stand for, and are trying to stand for, our Lord Jesus Christ and His Kingdom.

I did go into one little parish not long ago where they were having some trouble, and people were coming to me to



tell me about this thing and that thing, and one man came to me and said "I am not going to Church, and I have a good many friends who are not going to Church, and we are not going to do anything; that is all there is to it." And I said "Why aren't you?" And he said "Well we just don't like Mr. So-and-So." I said, "Brother, you are an American Legion man; you had a captain of your Company. Did you like him?" He said "Yes, I liked him." I said "Suppose you had not liked him—would it have made any difference with you in the kind of fight you put up overseas—wouldn't the Cause have made you overcome your dislike for that leader that was over you, even though you thought you might know more than he did, and better than he did, how to command that Company?" The Cause which the Church represents is big enough to claim our loyalty, and when once we can get out of our minds,—I know it is hard to do so at times—the things that upset us, things caused by personalities—and see the person, and see his Cause clearly, as it were through the eyes of Jesus, we won't have troubles. I am grateful, most of all, to you women and to Miss Margaret Weed for your loyalty because I know that you have had to put up with a good deal, yet I think you have been patient, I want to thank you for that.

Now as to your year's work. I am sorry I have not been able to sit in with you and hear more of your meetings. My only regret in having this Convention meet at the same time as the Council is that I can not sit in with you, as I did with the Daughters of the King the other day.

Your work is the work of the whole Church. It is all of the work of the whole Church, and I believe the interest in that work is growing more and more among the women of our Diocese. It seems to me that while the Diocese has had to stand still in some respects, yet I would not have you forget that we have come a long ways in the last three or four years, and you women have gone right ahead in your Auxiliary undertakings.

And my last word to you is just this: the best way to make your year's work and your program of work better each year is to be loyal to Jesus, and when you are loyal to Jesus and loyal to His Church, you will find the secret of ever-increasing satisfaction and success in your work. I was talking recently with a man who raises oranges; not only raises oranges, but sells oranges. I understand this year that the orange market is almost glutted and prices are poor, but this man is getting about twice the price for his oranges that others are getting, and I said "How d'd you do this?" He said "My secret is just this: every year I try to raise just a little better grade of oranges; I use just a little more fertilizer or I do this thing or that thing—in other words, my one thought every year is to raise, not a **bigger** crop, but a **better** crop of oranges." And so I think that that is the thought that I can best leave with you this morning. Through loyalty there will always come a better service. May God bless you, and I thank you again for all that you have done.



## PRESIDENT'S ADDRESS

My dear Sisters:

Again, I rejoice to be able to be with you. Gathered together, not only to review the work of the past, but to look into the future and to see in what way we may help to hasten the Coming of the Kingdom of Christ. Is that not really why we are here?

First, as always however, I want to thank you for both your inspiring example and devoted co-operation. The conscientiousness of your faith and earnest consecrated effort has been my stay and encouragement.

I would like to tell you a few of the things that have happened since last we met:

You will receive a report on the Triennial and the glorious United Thank Offering service in Washington; that service in which our Thank Offerings were greater than ever before. I would like, however, to tell you of the women who made our wonderful meetings possible. Never have I seen a more interested, intelligent and consecrated group of women. Women who were there for a purpose and who lived up to that purpose. The policeman on duty near the "Mayflower" paid us quite a tribute, I thought. He said to the women whom he was helping across the street, "You have been at a convention, have you not?" and they said they had but were going home soon. "Well, I am sorry" he answered, "because you people are real Christians".

I next have to announce, with great regret, that Miss Laura Boyer, our Educational Secretary, whom we all know and love, is no longer Educational Secretary. Miss Boyer has done a wonderful work for Religious Education in stimulating the interest of the women throughout the Church, and I am sorry that we are no longer to have the guidance of her brilliant mind and consecrated spirit. Following the action of the Executive Board of the Woman's Auxiliary in December, Miss Boyer was relieved of her work. A new office—Director of Religious Education—is filled by Dr. Adelaide Case of the Teachers' College, Columbia University, and her assistant is Miss Marston of Massachusetts.

As I have said to you very often, an organization is like a good road. If we know our goal it is wonderful, we get there so much more quickly. If we don't know where we are going, it is hopeless, we are nothing but aimless joy-riders. This applies to our work for God quite as much as any work we may be doing for ourselves. We should know our type of organization and what it is accomplishing and should endeavor to find methods which we think will improve and enlarge our work. Surely, we owe to God the very best organization. Glorified by His Holy Spirit, there is no limit to what we may accomplish.

One of the principle topics of the General Convention was Personal Religion and Evangelism. The Bishop has already spoken to you himself on this subject, so I would simply like to tell you of the comment of Missionaries at the Jerusalem



Conference. Their universal testimony was that the most serious impediment they found to spreading Christ's Gospel was not the opposition or indifference of the natives in many lands but much more the lives of many of the foreigners who call themselves Christians. Does not this give us serious thought and does it not cause us to long to lead such lives that Christ may be manifested to men? Also, should we not have the courage to speak of Him? We find it hard, do we not, to talk of Him? But if He means so much to us, how much may He not mean to some other one who does not know how to reach Him? My dear Sisters, if we can "open the eyes that see not" to the vision of Jesus Christ, to give all people equal opportunity for development, service and joy, isn't it worth while? Worth while to forget ourselves, that we may aid Him in His wonderful loving purpose for the World?.

I notice, with regret, that there is a tendency to do God's work without asking Him about it. Again and again we hear of people who are planning to do something for God who say that the first thing is to organize and appoint committees. The first thing! Surely, we cannot hope to succeed if we try to do His work without Him. So, I would ask that in the coming year, you first pray, then plan for Personal Religion and Evangelism. If any difficulty arises in your parish or mission, take it to God, and in planning work that you are undertaking for Him, begin it with prayer. If we find ourselves inarticulate, there are books of prayer that I would gladly send you, so that you may be equipped for any emergency that may arise. After all, you know, my dear Sisters, if we think less about what others are thinking about what we are saying and more about God, we will not be so confused.

Some years ago, I remember I gave you as an ideal for the Woman's Auxiliary that quotation.

"To be a beacon when the light is dense,

A bower of peace and a life-long recompense."  
Take this with you through the year. Can there be anything more wonderful than that our lives shall be beacons to guide poor, confused and sometimes despairing, travelers on a sea of perplexity, doubt and discouragement, to Him who is the Light, the Truth and the Joy of the world? The world needs the Christ and it is our glorious privilege to help to give Him to the world.

May God bless and prosper your work for the coming year, and may we be in closer fellowship, with a greater understanding and a more devoted purpose to help to hasten the Coming of the Kingdom of Christ.

The President stated that while these reports showed the overlapping of Guild and Woman's Auxiliary work, they also brought out evidences of such splendid work being done by the Guilds that she wanted to express her gratification.

Mrs. Crow, Directress of the Hostess Auxiliary announced that cars were waiting to convey the women to Weed Hall, where tea would be served, and upon motion, the meeting recessed, to re-convene, Thursday morning at 10:00 o'clock.

#### THURSDAY A. M.

The President called the meeting to order at 10:00 A. M. and the women of the Auxiliary stood for prayers.

The Secretary read the minutes of the Wednesday afternoon session, which upon motion were approved.

Consideration being given to the types of work done by the Woman's Auxiliary in the different parishes, Mrs. C. L. Pridgen reported on the varying phases of work done by the Woman's Auxiliary in her parish. This report brought out the usual overlapping of Guild and Woman's Auxiliary work, and the unanswered question of "what is really the work of the Woman's Auxiliary in a parish". General discussion followed.



Upon request of the President Mrs. Z. W. Flynn took the chair while the President presented her report to the Council. Mrs. Flynn, as President of the District in which this meeting is being held, automatically assuming the office of Vice-President.

Report of the Weed Memorial was made by Mrs. J. S. Arnold. Upon motion this report was accepted.

In connection with this report Mrs. J. D. Russell stated that it was the desire of Bishop Juhan that the Woman's Auxiliary finish their part of this tribute to Bishop Weed's service, before the general drive for funds for Weed Hall is begun. She also made a stirring appeal that this be done as a tribute of love for Bishop Weed and for his daughter "our beloved President". She stated that the amount so far raised totaled \$7,500.00 the full amount to be raised being \$10,000.00.

The following resolution, presented by Mrs. C. L. Bates, was adopted.

Resolution. "That the offering of the Woman's Auxiliary, taken at the opening service, be appropriated to the Weed Memorial Fund".

The amount of this offering totaled \$48.00 and upon suggestion that it be made an even \$50.00 a collection was taken bringing the amount to \$90.50.

Mrs. W. W. Hampton moved that Delegates return to their respective Branches prepared to raise, at once, the amounts apportioned to them by their District Presidents to complete the Bishop Weed Memorial". Motion carried.

The President resumed the chair and at her request Miss Hope Baskett, Student Worker at Tallahassee, addressed the Auxiliary bringing out in a very interesting manner, the effect of personal contact on the every day life of the students. Mrs. W. P. Cornell paid a high tribute to Miss Baskett for her work, and the example of her daily life among the girl's at The State College, at Tallahassee.

Report of the Margaret Tebeau School was made by Miss Alice Thomas, Principal. Upon motion this report was accepted.

Florence Nunez, the Auxiliary Scholarship Girl, was introduced and thanked the Auxiliary for the privilege of the influence and training received at this school.

Report upon Redistricting. Mrs. Hindry, Chairman, asked that the committee be allowed further conference before presenting their report. Mrs. Helvenston moved "that the Committee on Redistricting be allowed further conference, and present their report at the afternoon session." Motion carried.

Discussion of the Bishop's Fund, and the apportionment given each Branch for said fund, brought an explanation from the President of the object of this fund, and the following resolution by Mrs. C. L. Crow, "That the recommendation of



the Executive Board, that the question of any changes in the Bishop's Fund be left to the discretion of the District Presidents, in conference with their Branch Directresses be adopted." Resolution adopted.

It being the hour of twelve o'clock M., business was suspended and the noon day prayer offered.

Business being resumed, Mrs. W. P. Cornell offered the following resolution upon the death of Colonel W. W. Hampton: during the reading of this the women of the Auxiliary stood.

"Whereas we, who are women of the Diocese of Florida, share in the great loss that our Diocese has sustained in the death of our beloved friend and consecrated co-worker and Vice-Chancellor, Colonel William Wade Hampton. Be it therefore resolved, that the 39th Annual Meeting of the Woman's Auxiliary to the National Council, does hereby express its appreciation of the influence of Colonel Hampton's character and personality through a life time of christian example, its gratitude for the constructive service he has rendered, its sense of loss in his removal from our midst, and its sympathetic sharing in the sorrow sustained by his family, his Parish and his Diocese. 'He being dead yet speaketh'.

Be it further resolved, that this resolution be sent to Colonel Hampton's family and that it be spread upon our minutes."

Mrs. J. R. Fritot presented her report as Supply Secretary. Upon motion this report was accepted.

The Women of the Auxiliary rose to receive Bishop Juhan who addressed them, thanking them for their loyalty and expressing his gratitude for the work they were doing.

At the request of the President Mrs. Flynn took the chair and the President read the report of the United Thank Offering, Mrs. B. F. Haynes, Custodian, being unavoidably absent, and also gave a very interesting account of the United Thank Offering service during the Triennial in Washington.

Having resumed the chair the President introduced Mrs. Still, a member of the Woman's Auxiliary from the Dominion of Canada, calling attention to a pin worn by Mrs. Still as life member of her Auxiliary. Mrs. Still extended greetings from the Canadian Auxiliary to which the President responded asking that Mrs. Still convey greetings from the Woman's Auxiliary of the Diocese of Florida, in Convention assembled, to her Canadian Auxiliary.

Report of the Prayer Partnership Plan was made by Mrs. W. W. Hampton, Chairman, and upon motion accepted.

Report of the Gift of Life was made by Mrs. Cornell, Chairman, and upon motion accepted.

Report of the Church Periodical Club was made by Mrs. P. C. Wolcott, Correspondent, and upon motion accepted.

The President announced that a meeting of the Execu-



tive Board was requested, immediately after the close of this session, and as she would be unable to be present she would request Mrs. Flynn to preside.

Announcement was made that a meeting of the Committee on Constitution and By-Laws had been called for immediately after the close of this session.

The hour of re-convening having been set for two-thirty o'clock P. M., upon motion the meeting adjourned.

#### THURSDAY P. M.

The President called the meeting to order at two-thirty P. M. and, after the opening prayers requested the minutes of the previous session.

The Secretary read the minutes and, after slight correction, they were approved.

Mrs. J. L. Gray, Chairman of the Committee on Resolutions, presented, with recommendation to adopt, resolutions in the following order.

##### Resolution No. 1.

The Auxiliary is asked to stand a moment in recognition of a second resolution on the death of Colonel W. W. Hampton.

"Realizing the great loss the entire Diocese, of which we are a part, has sustained in the death of Colonel William Wade Hampton, we, the Woman's Auxiliary, in Convention assembled, desire to express our sense of personal loss.

While mourning his death, we give thanks to God for his consecrated life and inspiring example, knowing that his life here will always be a source of strength and encouragement to us 'who are yet in our pilgrimage'.

A copy of these resolutions shall be sent to the family of Colonel Hampton and spread upon the minutes of this meeting."

The meeting being called to order was opened with prayer.

The President then made the following announcements.

First—That Miss Laura K. Boyer is no longer connected with the Educational Department of the National Council, which was cause of genuine regret as Miss Boyer has done valuable work. ## REPORT OF CHURCH PERIODICAL CLUB

In making out this report of the C. P. C. in the Diocese of Florida for the past year I greatly regret that it is impossible to include in statistical form much work that has been faithfully and lovingly done by the various Branches because it has been so reported that it is impossible to classify it, and because to include it all would make the report too long.

I beg each parish secretary to read her manual of work or the typewritten copy of Article 8 of the Constitution and follow more carefully the directions therein given. I shall be glad to send additional copies of these directions where they have been lost.

I urge the Pensacola branch to continue to send all the good reading matter they can to the ships. When the boys have interesting books and magazines they will spend less time idly and foolishly. This is also true with regard to the University centers.

The uplifting influence of good literature is also greatly needed in the hospitals and penal institutions and pictures and illustrated magazines are especially useful in such places.

It is necessary to insist upon an intelligent distribution of literature and when the distribution can be made personally in hospitals and institutions the individual touch and a word of cheer greatly add to the value of the gift.

Liberia is still asking for our help also Porto Rico and the West Indies.

Our hospital at Manila is trying to establish a small circulating library and is greatly in need of entertaining books; good novels and "thrillers" are greatly in demand, both for patients and nurses.

The needs are many all over the world and I am glad to say that the Diocese of Florida has done its part in the work, but I hope that having made a good beginning it will go on to larger and more earnest efforts.

The C. P. C. is an independent organization and not a part of the Woman's Auxiliary or of the Social Service department but its membership is drawn from both organizations and we urge that at their meetings they use our prayers, and I ask each parish secretary to ask her Rector to remember the C. P. C. at the Altar on May First, the day set apart for our Corporate Communion.

The things for which we pray and about which we think prayerfully are the things we do best and for which we ask and receive God's blessing, and so let us determine to carry on our work for the coming year earnestly and prayerfully, sending messages of cheer and gifts of good books and magazines to those who need them and are less fortunately situated with regard to them than we are.

He was so gratified at the work being accomplished in the District and spoke of the splendid reports which he had listened to in the morning. He expressed joy with us at the gathering at St. Mary's, this being the first meeting held here.

An invitation was extended by St. Andrew's, Panama City to meet with them in the Fall, which was gladly accepted. Much regret was expressed at losing our District President, Mrs. Tyler and the Secretary was requested to write a letter to her.

After a grateful expression by the courtesy committee for the hospitality extended to us while in Milton, the meeting adjourned. After the singing of the Doxology, Bishop Juhan pronounced the Benediction.

The second meeting was held in Panama City at St. Andrew's on November 27. We were fortunate to have with us Bishop Juhan, Rev. Mr. Matthews of Marianna, Rev. Mr. Schofield of Milton. After a celebration of the Holy Communion at St. Andrew's Church we met at the Woman's Club for the morning session.

There were about thirty present, with four branches represented.

The branch reports were heard with much interest and showed an increase over the Spring reports.

The reports of the District Officers were equally satisfactory, showing that in each department there was the spirit of co-operation which is so essential to good results.



It was with much regret that we accepted the resignation of our Educational Secretary. She has always been a source of inspiration to us and her report is ever an inspired message which she leaves with us at each meeting. We hope even tho she is not in office, she will be a silent leader to whom we may go for direction when needed.

The report of the United Thank Offering Treasurer was most encouraging. It showed an increase each year and this year amounted to \$393.36.

Mrs. Blount then made her report on the General Convention. This was most interesting and thrilled us all with the desire to make every sacrifice possible to attend that wonderful service of thanksgiving and share the privilege of meeting some of those women who have given their love, work and life in the foreign fields.

After luncheon, we met again for the afternoon session as the delegates from Marianna had to return that night. A delightful talk on the Youth of the Church was given by Mr. Matthews; Mr. Schofield interested us with his ideas on World Peace and Bishop Juhan then gave us a wonderful talk on Personal Religion and Personal Evangelism.

After discussion it was unanimously agreed that we approve the resolution as presented at the last Diocesan Meeting. That is, that we allow a representation from our colored branches to meet with us at the annual meetings.

The need of regular Corporate Communion of the branches once a month was stressed and all branches urged to have this service.

A note was to be written to Miss Weed expressing regret at her absence. The offering of the service was \$6.65 and upon motion it was decided to give this to the Bishop's Fund.

Pensacola delegation extended an invitation to have the meeting in the Spring with them and th's was accepted.

After the Doxology was sung Bishop Juhan pronounced the Benediction.

#### ST. STEPHEN'S, JACKSONVILLE

The work of St. Stephen's is largely among the children of the Sunday School, and general Welfare Work, the surrounding district being populated chiefly by foreigners, and the neighborhood constantly changing makes it difficult to keep up the interest in the Church, especially without a regular minister. Yet it has kept up to the extent that all Church assessments have been paid, the Church quota has been exceeded 200 per cent and greatly needed repairs to the rectory have been made and paid for.

We were pleased to have Bishop Juhan with us at our Christmas Celebration, when he confirmed 4 persons, 2 others who had expected to be confirmed were ill. 20 persons have been confirmed in St. Stephen's in the past 3 years. We have had few morning services, and only an occasional night service, conducted by the Young People's Service League of St. John's Church.

Arrangement has been made to have one Church service a month beginning with December, when the Rev. Ambler M. Blackford, of St. John's held service. For the next six months the Rev. Newton Middleton, rector of St. John's Church, will conduct Morning Service, the second Sunday in each month, at 10:00 o'clock A. M. Some other clergyman will serve the remaining six months of the year.

Mr. and Mrs. Charles T. Smith who have had the work of St. Stephen's in charge for nearly six years, gave up the work the beginning of this year because of ill health and the



need of rest. Mr. Middleton, who will have entire charge of St. Stephen's for the next six months will appoint a superintendent for the Sunday School.

#### THE CORPORATE GIFT OF 1929

All honor to the Women of the Auxiliary who are ever eager to spend and be spent in the Extension of the Kingdom of Our Lord.

The Washington Triennial hesitated to adopt a Corporate Gift for the triennium of 1929-1931, not because the women were weary of well doing but because of the request of the National Council that the women share with them in their effort to raise the \$3,000,000 needed for the Advance Work items of the Church, for which a Campaign is to be undertaken during the current triennium. After due consideration, however, the Triennial Meeting of the Woman's Auxiliary to the National Council passed the following resolution:

BE IT RESOLVED: That the Woman's Auxiliary undertake to raise between now and Epiphany 1930, a Corporate Gift, the sum not to exceed \$100,000, the first \$25,000 of



which shall be appropriated for the building of a Church at Santo Domingo City, Santo Domingo, and the remainder of which shall be applied to projects to be determined upon by our Executive Board in consultation with the Executive Secretary of the Department of Missions.

BE IT FURTHER RESOLVED: That this Corporate Gift of the Woman's Auxiliary shall be closed Epiphany, 1930, at which time our Executive Board shall inform the National Council of our readiness to receive directions from them as to our further Advance Work.

Mrs. Robert Burkham, of St. Louis, Missouri, has been chosen Chairman of this Corporate Gift, our Provincial Chairman is Miss Emma J. Hall, of Charlotte, North Carolina, and I have the privilege of leading you women of the Diocese of Florida, in this expression of our love for the Christ and His children throughout the world.

The Executive Board of the National Woman's Auxiliary has now voted that the amount of the Corporate Gift of 1929 shall be reduced from \$100,000 to \$50,000. The first \$25,000 received will go, as directed by the Triennial gathering, to the building of a Church at Santo Domingo—the Executive Board has promised the National Council that this amount will be in their hands by Easter.

Further designated gifts from this \$50,000 fund are as follows:

For Water Supply at St. Michael's Mission, Ethete, Wyoming .....	\$10,000
For a Dormitory at Christ School, Arden, North Carolina .....	10,000
For a Church at Silver City, Panama Canal Zone.	5,000

How gladly we, in Florida, will work for the whole fund, but we are especially happy to have the opportunity to work for Our Own Missionary, Archdeacon Wm. Wylie, at Santo Domingo City. We now have the opportunity to show him how much we appreciate his years of consecrated service and how gladly we share with him in the building of this Church which he has so earnestly striven for. Let us make every effort to pay at least one half of our parochial quotas for this Gift prior to Easter of this year, in order that we may **really** share in this endeavor. Then after Easter, we will have the rest of the year in which to pay our share towards the erection of the other three projects for which we have accepted responsibility.

Districts One and Two are asked to give \$100.00 each and Districts Three and Four, \$75.00 each towards the Corporate Gift. The Parochial Assessments will be made by the District Presidents.

In closing let me thank you one and all, in advance, for the spirit of loving and joyful co-operation that I know you are going to give, not to me only, but to all who share in the responsibility of erecting these buildings to the Glory of God, and the service of our Brothers in Christ Jesus.

## THE ORDER OF THE DAUGHTERS OF THE KING

The Order is a call to women to bestir themselves, and labor in Christ's Vineyard with faith and prayer, on the same lines and with the same rules as those of the Brotherhood of St. Andrew.

The sole object of the Order is the spread of Christ's Kingdom among women and the strengthening of parish life.

Members are admitted with a solemn service before the altar, invested with the cross, and pledged by a vow to prayer and service.

The two rules are: First, to pray daily for the spread of Christ's Kingdom, especially among women, for God's blessing upon all members of the Order, and for the spiritual growth of the parish to which the chapter owes allegiance. Second: To take regularly, some part in the worship, study and work of the Church; to make a constant effort to bring other women within its influence; and to render, at all times, such aid to the Rector as he may deem necessary for the spiritual up-building of the parish.

**Minutes of the Diocesan Assembly  
Daughters of The King.**

At 10 A. M., January 22, 1929 the twenty-first Diocesan Assembly of the Daughters of The King opened with a celebration of the Holy Communion in Holy Trinity Church, Gainesville, Fla., the Right Rev. Frank A. Juhan, D. D. being the celebrant, assisted by Rev. William S. Stoney, Rector of the Parish.



Bishop Juhan gave a helpful talk on the vital subject, "Learn of Me," and its importance as a direct command to our Order, showing that our ultimate success depends upon how much we know about Jesus.

After the service the business meeting was called to order in the Parish House, Mrs. Hendree Harrison, President, in the chair. The meeting was opened with prayer, after which a cordial welcome was extended by Mrs. Stoney, wife of the Rector, Mrs. Paul Henry Harrison of the Julia S. Stockton Chapter responding for the visitors.

The Secretary, Miss Marjorie J. Yonge being absent on account of illness, Mrs. P. H. Harrison was elected Secretary Pro. Tem.

On response to roll call the reports of chapters were read. There were eleven delegates present, every chapter of the Diocese but two being represented. The reports, including one from the Junior Chapter of Christ Church, Pensacola were read and accepted.

The Minutes of the May, 1928 Assembly were then read.

Before appointing committees, the President called attention to the fact that two diocesan officials, the Vice-President and Secretary, were completing the terms allowed to incumbents. She also urged that a full new slate be presented by the Nominating Committee, and that delegates be ready with nominations from the floor when the time for election of officers should come. The President stated she thought the Order should have a Constitution and By-Laws, hence she appointed a committee to draft same for presentation at the next annual meeting.

Mrs. Shelley Humphreys, Council Member, made a short report calling attention to certain phases of our work which were stressed at the Triennial. First: that each Daughter take care that she herself become truly evangelized; Second, that we keep in mind constantly the resolution adopted by the Triennial that the Daughters take as one of their objectives for the next Triennial the winning of 6,000 other women to Christ, which means that each Daughter must bring at least one. Third; that each Daughter thoughtfully select one or more families of her acquaintance where there are children and work constantly to bring the children to baptism, Church School and confirmation, thus establishing the most direct path to the interest of the parents. Mrs. Humphreys suggested the use of a leaflet for homes where there are children, "The Religious Training of Children in the Home", by Leon C. and Lala C. Palmer, same may be purchased from Brotherhood of St. Andrew Church House, 202 S. 19th St., Philadelphia, Pa.

The hour of noon having come we were lead in prayer by our Bishop.



Our Diocesan delegate to the National Convention, Mrs. Hendree Harrison, gave a very interesting and comprehensive report of those inspiring sessions. Following this report was a splendid paper on Personal Evangelism by Mrs. Fitz-James Hindry, which every Daughter may have the pleasure of reading in full in the Royal Cross.

One of our visitors, the Rev. C. W. Frazer told of the critical illness of a Daughter, Mrs. A. T. Williams, President of St. Mary's Chapter. Sympathy was expressed and at the suggestion of Bishop Juhan prayers were offered for Mrs. Williams, led by the Rev. Mr. Frazer.

The Assembly adjourned for lunch.

The afternoon session was called to order at 2 P. M. and opened with prayer.

A plea was made that Daughters influence all ministers to have confirmation classes open to all people of every denomination.

Motion made and carried that the book, "Christ in the Common Ways of Life", by C. S. Woodward, Canon of Westminster, be adopted by the Diocesan Assembly for use in chapter work, same to be purchased from National Office of Order.

Reports from committees were now in order.

Nominating Committee presented the following slate: President, Mrs. Hendree Harrison; Vice-President, Mrs. Paul Henry Harrison; Secretary, Mrs. A. M. Terwilligar; Treasurer Mrs. May Whiteside.

There being no nominations from the floor the Secretary was instructed to cast the ballot.

In June three new members, having served their three months probation, were admitted to the order. We lost one member who moved from the city. Our present enrollment numbers twenty-one.



By invitation of the Julia S. Stockton Chapter a joint meeting of the three chapters of the Order in Jacksonville was held in November at the Church of the Good Shepherd. A report of the proceedings of the General Assembly at Washington was made by Mrs. Shelly Humphreys, editor of our magazine The Royal Cross. Much benefit was derived from the general discussion which followed.

## CONSTITUTION AND BY-LAWS

---

1. The name of the Association shall be The Woman's Auxiliary to the National Council in the Diocese of Florida.

2. The object shall be to help in carrying out the Program of the National Council for the fulfillment of the Mission of the Church, to give such assistance in Diocesan projects as the Bishop may desire, and to work in the Five Fields of Service in such other ways as may be specified at the Annual Meeting.

3. All women who are desirous of doing this work for Christ, according to the Program of the Church, and are willing to abide by the rules, are eligible for membership.

4. The officers of the Association shall be, a President, four Vice-Presidents, being the four Presidents of the Districts, a Recording Secretary, a Corresponding Secretary, a Treasurer, an Educational Secretary, a United Thank Offering Custodian and a Supply Secretary.

5. All of these officers, except the four District Presidents, shall be elected at the Annual Meeting following the Triennial, and shall serve for three years, with the privilege of re-election for another term of three years. They shall not be eligible for a third term.

6. The Woman's Auxiliary in the Diocese of Florida shall be divided into four Districts and called by number, One to Four, inclusive. Each District shall elect its President at the first meeting of the District after the Triennial, and they shall serve three years with the privilege of a second term of three years.

7. Chairmen of Committees, Standing Committees and Custodians of Special Funds shall be appointed by the President and shall serve for terms specified by her, not to exceed three years without reappointment.

8. Each officer shall serve till the adjournment of the Annual Meeting at which time her term of three years expires.

9. There shall be a Nominating Committee of three members, one appointed by the President and two elected from the floor, who shall receive nominations, prepare a ticket, and whose chairman shall be in charge of the election. Nominations may also be made from the floor.

10. The officers, except the four District Presidents, shall for this year, be elected in two groups, and shall take office immediately.

Group One shall be elected for a term of three years each, with the privilege of re-election for another term of three years. This group shall consist of the President, Recording Secretary, Supply Secretary and United Thank Offering Custodian.



Group Two shall be elected for a term of three years each, without the privilege of re-election. This group shall consist of the Corresponding Secretary, Treasurer and Educational Secretary.

The four Presidents of the Districts shall automatically become Vice-Presidents, the First Vice-President being always the President of the District in which the next Annual Meeting is to be held.

11. The election of all officers shall be by ballot, a majority vote constituting an election.

12. Any vacancy occurring in an office during the term shall be filled by the President.

13. Each District President shall appoint the various District officers immediately after her election.

#### BOARDS

The Executive Board shall consist of the Diocesan officers, Chairmen of Standing Committees and Chairmen of any Special Funds that may be created from time to time.

#### STANDING COMMITTEES

- (1) Committee on the Gift of Life.
- (2) Committee on the Prayer Partnership Plan.
- (3) Committee on Nominations.
- (4) Committee on Constitution and By-Laws.
- (5) Committee on Resolutions.
- (6) Committee on Care of Isolated Church Women.

#### DEPARTMENTS

The following Departments shall function through the Executive Board:

- (1) Department of Missions.
- (2) Department of Religious Education.
- (3) Department of Christian Social Service.
- (4) Department of Finance.
- (5) Department of Publicity.
- (6) Field Department.

These Departments shall consist of the following members:

- (a) Department of Missions—Diocesan Treasurer of the United Thank Offering and the four District Custodians, Chairman of the Committee on the Gift of Life, and Chairman of the Committee on Prayer Partnership and Chairman of Committee on the Care of Isolated Church Women.



(b) Department of Religious Education—The Diocesan Educational Secretary of the Woman's Auxiliary and the four District Educational Secretaries.

(c) Department of Christian Social Service—The Diocesan Supply Secretary and the four District Secretaries.

(d) Department of Finance—The Diocesan Treasurer of the Woman's Auxiliary and the four District Presidents.

(e) Department of Publicity—The Recording Secretary and the four Secretaries of the Districts.

(f) Field Department—The Diocesan President and four members, one member from each District, to be appointed by her in consultation with the District President.

N. B.—The Diocesan President shall be a member ex-officio of all Boards and Departments.

#### MEETINGS

1. The Annual Meeting shall be at the time and place of the Diocesan Council.

2. The Executive Board shall meet twice a year, and the President shall be empowered to call a meeting at any time that she may consider necessary. Five shall constitute a quorum.

3. The Departments shall meet twice a year at the time and place designated by the Chairman of the Department.

4. The Standing Committees shall meet at the time and place of the Annual Meeting, and at any other time that the Chairman shall call a meeting.

#### QUORUM

1. One-fourth of the Branches of the Diocesan Woman's Auxiliary shall constitute a quorum at the Annual Meeting.

2. Five members shall constitute a quorum of the Executive Board.

3. Three members shall constitute a quorum of a Department.

#### AMENDMENTS

This Constitution may be amended at any Annual Meeting of the Woman's Auxiliary in the Diocese of Florida, by a majority vote of the delegates present, provided that the proposed amendment has previously been submitted in writing to the Committee on Constitution and By-Laws and to the Executive Board.



## BY-LAWS

## I. DUTIES OF OFFICERS

1. The President shall preside at all meetings, appoint all committees, call special meetings at her discretion and appoint officers to fill vacancies occurring during a term of office.

2. In the absence of the President, the Vice-Presidents shall, in the order of their rank, perform all the duties of that office; it being understood that the President of the District in which the next Annual Meeting is to be held, shall rank as First Vice-President.

3. It shall be the duty of each of the four District Presidents to appoint her District officers; plan and preside at one or more District Meetings each year, send list of all District officers, Parish officers and number of members to the Recording Secretary, also notify her of any changes during the year. She shall, in conference with the proper officers, arrange all special meetings in her District, and she shall submit a written report of the activities in her District to the Annual Meeting.

4. It shall be the duty of the Recording Secretary to keep a correct record of the proceedings of the Annual Meeting and of the meeting of the Executive Board. She shall keep a list of officers and number of members of the various Branches. She shall submit a written report of the proceedings of each Annual Meeting at the various sessions of the Meeting; she shall submit a written report of the meetings of the Executive Board to that body, and she shall prepare and edit the Annual Report, which shall be printed as a part of the Diocesan Journal.

5. It shall be the duty of the Corresponding Secretary to carry on all correspondence assigned by the Executive Board, or at the Annual Meeting. She shall issue notices of all meetings; read all letters and have custody of the same; send out the Annual Report; notify the proper authorities of all newly elected officers or delegates and of those who have passed into the Greater Life during the year. She shall submit a written report at the Annual Meeting.

6. It shall be the duty of the Treasurer to receive all moneys except the United Thank Offering and any Special Fund that shall be created from time to time. She shall deposit all moneys in a bank or banks in the name of the Woman's Auxiliary. She shall dispose all money as directed by the Executive Board, or the President, keep an accurate account of all receipts and disbursements and submit a written report to the Annual Meeting.

7. It shall be the duty of the United Thank Offering Custodian to increase the knowledge and deepen the interest in this offering by correspondence and visitation. She shall supply boxes and literature to all Branches, promote the distribution of boxes and literature to isolated women and "shut-ins," and make a written report to the Annual Meeting.



She shall take all moneys given for this offering in three years to the Triennial or select a deputy to do this.

8. It shall be the duty of the Educational Secretary to organize the Diocesan Branch for Educational Work and to stimulate the same by every means in her power. She shall co-operate with the Diocesan plans for educational work and submit a written report at the Annual Meeting.

9. It shall be the duty of the Supply Secretary to organize the Diocesan Branch for the Service of Supplies, to receive and disseminate all information relating to the same, and to stimulate interest therein. She shall submit a written report at the Annual Meeting.

## II. DUTIES OF BOARDS

It shall be the duty of the Executive Board to choose the policy and prepare the plans for the year's work and to see that all Branches are informed in time for them to make their plans; to execute any work assigned to it by the Annual Meeting, and to submit a written report of work done during the year at the Annual Meeting.

## III. DUTIES OF STANDING COMMITTEES

1. It shall be the duty of the Committee on the Gift of Life to keep in touch with the needs of the Mission field; to address groups of young people who are beginning to think of their life work; to get in touch with young girls who may be available for some type of mission work; to know and write to all missionaries who have gone from the Diocese, and to be prepared at all times to lay the appeal and needs of the Mission field before either individuals or groups of people.

2. It shall be the duty of the Committee on Nomination to receive and list all names sent in during the year, to present all these names for consideration at the time of election, to record all other names that may be offered from the floor and to keep a record of the names on a blackboard during the election.

3. It shall be the duty of the Committee on Constitution and By-Laws to receive any proposed changes in the Constitution and By-Laws to submit the same with recommendations to the Executive Board and present them to the Annual Meeting.

4. It shall be the duty of the Committee on Resolutions to receive all resolutions to be presented at the Annual Meeting and to make a report of the same.

5. It shall be the duty of the Committee on the Prayer Partnership to give names and addresses of missionaries to Branches and explain the plan.

## DEPARTMENTS

1. It shall be the duty of the Department of Missions to keep in touch with the Department of Missions of the Diocese,



and also with Chairmen of Special Funds for Diocesan or General Mission Work; to learn through District Presidents of special needs, either at Christmas or during the year, and to make plans to assist in meeting these needs; to be ready to speak on the Missions of the Church in general or in Diocese, whenever requested, or to furnish speakers. They shall make reports of their activities to the Executive Board at least twice a year.

2. It shall be the duty of the Department of Finance to plan the Budget for the year in consultation with the Bishop and the Executive Board and to allot to each Branch its quota before the October meeting; to receive from the Treasurer a list of Branches who are falling behind in the quota and to remind them of their pledges, after six months have elapsed. The Department shall make a report to the Executive Board at least twice a year.

3. It shall be the duty of the Department of Religious Education to promote all phases of religious education planned by the Educational Secretary; to keep in touch with the Educational Department of the Diocese; to prepare lists of names of persons available as leaders of study classes; to arrange for Institutes, and to be prepared to supply information on the subjects of pageants. This Department shall make a report to the Executive Board at least twice a year.

4. It shall be the duty of the Department of Christian Social Service to keep in touch with the Department of Christian Social Service of the Diocese; to learn of opportunities for service and to report the same to the Executive Board and to the District Presidents; to be well informed on the condition of civic and state institutions within the borders of the Diocese; to be informed of all legislation, either State or National, that concerns the physical or spiritual wellbeing of the people; to co-operate in every way possible with the plans of the Committees on the Rural Work and the Foreign Born of the National Church as well as the American Church Institute for Negroes and the Interracial Committee. This Department shall make a report to the Executive Board twice a year.

5. It shall be the duty of the Department of Publicity to keep in touch with the Diocesan Department of Publicity; to supply material for the page devoted to the work of the Woman's Auxiliary in the Diocesan paper; to send items of interest to the Diocesan Educational Secretary; to send reports of meetings to local papers and to Sunday editions of the larger papers; to do advance publicity for all special meetings, Institutes, Conferences and study classes, and to collect and publish at their discretion all items of interest on Diocesan and National Church work. They shall make a report to the Executive Board at least twice a year.

6. It shall be the duty of the Field Department to keep in touch with the Department of Stewardship and Service of the Diocese. They shall establish new Branches of the Woman's Auxiliary, and strengthen and encourage weak ones that are already established. They shall be prepared to supply literature on the establishment and conducting of Branches of the Woman's Auxiliary; and shall be ready to visit Branches when it is deemed necessary by the Executive Board.



They shall be prepared to furnish speakers when requested. They shall be thoroughly informed of the plans of the National Field Department, and at the desire of the Bishop and under the guidance of the Diocesan Department of Stewardship and Service shall be ready to supply speakers at the time of the Annual Campaign for the Church's Program or co-operate in any way that they are needed. This Department shall make a report of their work to the Executive Board at least twice a year.

#### V. REPRESENTATION

1. Branches shall be entitled to two delegates and two alternates at the Annual Meeting. These shall be elected at the meeting held two months before the Annual Meeting, and names and addresses shall be sent at once to the President of the hostess Branch.

2. Delegates to the Triennial, five in number, shall be elected at the Annual Meeting immediately preceding the Triennial.

3. Delegates to the Provincial Meetings shall be elected at the Annual Meeting immediately preceding the Provincial Meeting.

4. Any vacancy occurring among the delegates, to either the Triennial or the Provincial Meeting, shall be filled by the President.

#### VI. FISCAL YEAR

The Fiscal Year of the Woman's Auxiliary shall be from January 1st to December 31st.

#### VII. AMENDMENTS

These By-Laws may be amended at any Annual Meeting of the Woman's Auxiliary by a two-thirds vote of the members present, provided that the proposed amendment has been submitted in writing, during the first hour of the first morning session of the Annual Meeting, to the Committee on Constitution and By-Laws.
