## THE BISHOP'S ADDRESS

My dear Women of the Auxiliary:

As we read the Epistle for the day before partaking of our Family Feast from God's altar it seemed to me that there was one phrase in that Epistle which St. Paul put there expressly for me and for us at this time: "Rejoicing in Hope." And it is with this saying I greet you today, and give you Paul's words as a Motto and a Watchword as we begin another year of work for the Master in and through His Church.

We have had our troubles this year-more of them than usual because of financial depression and difficulties all around us, and yet as I stand before you and know as I do of the powerful spiritual incentive in the Woman's Auxiliary which has sustained and strengthened you and enabled you to achieve so much for the whole Church under trying conditions, I cannot feel despondent.

I would be a confirmed pessimist if in the face of the interest and enthusiasm as bespoken by your reports I uttered a hopeless note. Rather do I rejoice because that in spite of difficulties behind us and difficulties ahead I know that your body of women, and others like you all over the Diocese, are prepared to meet them with a confidence born of the knowledge that ours is God's work in which we are all called to share and that He will never fail those who put their trust in Him.

I rejoice and am always grateful for your generosity. I rejoice and am always grateful for your spirit of unity. I rejoice and am grateful always for your prayers! What better reasons for hope could a Bishop have?

You will be happy I know when I say I have just come from the Council where there has been much discussion on the subject of our Diocesan Quota to the National Church, and the Council has again, thank God, assumed and pledged this Quota in full for the coming year. I know that you are already pledged as a true Branch of the Woman's Auxiliary to stand behind every effort to see that the Diocese, through its Parishes and Missions, meets this Quota to the General Church Program.

God bless you all and "Rejoicing in Hope," may you go on furnishing the means through which the women of the Church may serve the Church in all its general work and seek to help every Churchwoman to realize the blessed privilege of such service.

My Dear Sisters:

When you honored me by electing me your President, I told you that I could not preside at the next Annual Meeting as I expected to be in Egypt: Well, here I am—but I find that absence of body *does not* mean absence of heart and mind. I am thinking of you more and more as the time for your meeting approaches and praying God's blessings on your deliberations.

I know that you will give our dear Vice President, Mrs. Russell, the same loving support that you have always given me, and which always so encouraged and strengthened me. I trust that you will plan much forward work for Christ.

May I at this time again thank you for the sympathy so lovingly expressed by individuals, Branches, and the Diocesan Branch. When one walks near the "valley of the Shadow" one feels very lonely, and words of sympathy are truly a blessed comfort. With all my heart, I thank you.

I am enclosing some suggestions of subjects for discussion and for outside speakers. Use them if you find them helpful; if not, discard them.

Since coming to the East I have realized more than ever the privilege and responsibility of being a Christian. In this land where so many forms of religious thought exist the teachings of Jesus Christ are acknowledged as wonderful, but it is how His followers obey them that is the test. The daily lives of Christians are closely watched, and when they fall short the Christian religion suffers. Is this not true, also, in our own dear country? Realizing it, can we not resolve to know the teachings of Jesus Christ more thoroughly, and strive to bring them more and more into our daily lives? In the coming year there will be many days. Let us put Christ into each one of them—Into our work, into our play, and into the way we serve Him. It is by our consecrated enthusiasm, intelligence and perseverance that our real interest in "The hastening of His Kingdom" will be made manifest. Remembering this, I am sure that there will be no place in your meeting for "snap shot" judgements, hasty decisions, indifference, or poorly made plans. As questions arise, you will, I know, give them earnest consideration, and well-thought-out decisions, and you will plan news methods of study and work. I should like to ask each District President to send a copy of the Budget of each Branch in her District to our Treasurer, Mrs. Gray, when she sends them to the Branches. It will be a great help to Mrs. Gray in keeping up with the work during the year.

Every night, in Damascus, after I went to bed, I heard the voice of the Muezzin calling, from a nearby minaret, "God is great. There is no God but God. Come to prayer". It was wonderful to go to sleep with that in my ears. Would it not be more wonderful to awaken with that thought and to carry it in our hearts throughout the day? So many things call us away from God. Often we are tempted to put people or things in God's place in our hearts, and so many



ideas and occupations crowd God out of our daily lives that there seems very little time to pray. Yet, we know if we begin our year resolved to carry that cry in our hearts, that at the end of the year we will be much nearer to God and, perhaps, will have drawn some others nearer also.

The Arab farewell is so beautiful that I will use it in saying goodbye, to you whom I love so well. It is, "May peace abide with you". So, dear Sisters, may peace and love and joy abide with you throughout the year, and may we give to Christ most devoted and joyous service.

Let us have more Quiet Days, more Corporate Communion, and by so doing become strengthened and fortified to be faithful workers for Christ, giving ourselves to His service and working in all fields.

Let us try to get young women in the Auxiliary. Get them interested, give them work to do. We shall find that they can give us so many new and fine ideas and we shall be helped by their youth and enthusiasm.

I trust that this year will be a banner year, showing increase in members and in interest and a desire to be better informed in all branches of the Church's work.

I wish to thank all who have been so loyal and helpful to me, it has been a very great pleasure to work with you women and in closing let me pray that "All our works may be begun, continued and ended in the Lord."

Bishop Juhan spoke briefly about the Synod meeting held in Columbia. He told us that Mrs. Cornell has been elected Vice-President of the Fourth Province of which we feel very proud. The Bishop said he felt very grateful to find the District meetings so well attended and the women so interested in the work to be carried on. Our hostess branches at both meetings showed true Southern hospitality and our visits were enjoyed by all.

I feel that on the whole, progress has been made in District No. 1 and though in some cases we have not reached our goal I trust that 1930 will see us not only reaching our goal but going well over the top.

I wish to take this opportunity to thank all District Officers and Branch Presidents for their splendid cooperation in all the work, and to wish all a happy year, trusting that we may go forward in the work for our Master.

Thinking that the "prayers of the righteous availeth much," I took the liberty of adding Mr. Wylie's name to our list and we have received several very interesting letters from him.

The Chairman of the Corporate Gift read her report.

### Report of the Corporate Gift

The National Corporate Gift, adopted at the General Convention, in Washington, in October 1928, is completed. The women of the Church have, as always, met the obligation they assumed at that time and the fact that again in this national gift they



have exceeded their goal, is an evidence of the joy our Auxiliary women take in furthering the Kingdom of Christ and His Church.

The National Goal for 1929 was \$50,000.00. This sum, you will remember, was to be distributed as follows:

To the Building of a Church in Santo Domingo, Dominican Republic .....	\$25,000.00
To Water Supply at St. Michael's Mission, Ethete, Wyoming .....	10,000 00
To Dormitory at Christ School, Arden, North Carolina ..	10,000.00
To a Church building at Silver City, Panama Canal Zone..	5 000.00

The report to date, received from Miss Nannie Hite Winston, the national treasurer of the Corporate Gift, tells us that as her books close, she has received \$58,209.41. All of the above named Mission stations have received their gifts and in addition the sum of \$2,000.00, being the interest accrued from the Gift of 1928, pending the use of several of the appropriations, was given to St. Catherine's School, in Porto Rico. What will be the designation of the \$8,209.41 balance of the 1929 fund will be decided by the National Executive Board when it holds its next meeting in February.

The women of Florida pledged \$300.00 towards the National Gift. Not only have we met our pledge in full dear friends, but we have exceeded that amount by \$83.00. We have forwarded \$383.00 in all towards the grand total offering. Let me thank you now, in the name of your Executive Board, for your loyal and willing cooperation at all times. Truly we have recognized the fact that we must share in the Great Commission of our Lord and Saviour.

But what of our Corporate Gift for 1930? Perhaps you have read in the Spirit of Missions that our Executive Board at the National Headquarters contemplated the continuance of this effort throughout the current year. This plan has, however, been abandoned. After consultation with the National Council of the Church it was decided that the Auxiliary should throw its entire strength behind the National Council in carrying out the Advance Work Program outlined for 1920 and 1931. This program, we are told, has been received with much enthusiasm by many of our Bishops and it is felt that the carrying out of so great a project would be interfered with by the counter-attraction of a separate Corporate Gift on the part of the Woman's Auxiliary. Therefore, the men as well as the women of the Church will, in common effort during these two years, work for the Advance Work Program of the Church, already too long delayed.

We in Florida, have not, as yet, been notified of the share we will be asked to take in this great undertaking. We are told that certain items in the Advance Work Program will be allotted to our Diocese, as a whole. I know well that you women, who have given so generously this year, will give with equal generosity, and perhaps even greater generosity, when you are called upon to share with our Bishop and with our fellow Churchmen of Florida in this expression of the reality of our faith and of our appreciation of the Christ who is within us.

A new committee on the Care of the Isolated having been formed, Mrs. Russell asked the Rev. Ambler M. Blackford, under whose Department of Religious Education the general plan for this Diocese is being worked out, to outline the duties and opportunities afforded by this Committee. She also stated that Mrs. Annie C. Jones, of Interlachen, has accepted appointment as Chairman of this Committee. The Rev. Mr. Blackford said that the work of reaching families and individuals who do not have access to the Church and her ministry are covered under the opportunity offered by this plan. Primarily, the Auxiliary has appointed a Chairman to work with the Department of Religious Education. Secondly, All Auxiliary women are urged to send the names of families and individuals thus isolated to Mrs. Jones, the Chairman of the Committee, as they become known to them. Thirdly, Definite steps will then be taken to get in touch with these families and individuals and to make them realize their fellowship with us. An effort will be made by the Department of Religious Education to find out the needs and desires of such groups and individuals and these needs and desires will be met in so far as this may be possible.

Mrs. Wolcott, the Correspondent of the Church Periodical Club reminded the meeting that much of the work which Mr. Blackford has outlined is included in the scope of the Church Periodical Club.

The Chairman of the Committee on the Gift of Life read her report.

### Report of the Committee on the Gift of Life

Our report is, as in former years, somewhat intangible. Our District Chairman wrote me that their branches, as a rule, write them—"We have nothing to report. We pray for our representatives in the field and we keep in touch with them. We send a dollar for the Christmas gift which the Diocesan Committee sends them." Some few report that they hold monthly Corporate Communion for their committees or their branches. The colored branch at St. Cyprian's, mission, Pensacola, has this year sent a box, through its Gift of Life Committee, to George F. Johnston, a Negro boy from St. Philip's, Jacksonville, who is studying at St. Augustine's College, Raleigh, and who hopes later on to enter the ministry of the Church.

We cannot look upon these reports as an indication that our women do not enter into the spirit of this most essential committee. Our prayers, our communions, our gifts, our thoughts, are surely blessed and are of value. Yet, I feel that we are not seeking and winning recruits for the Church's service, whether it be at home or abroad, as we are capable of doing. The most effective work being done in this line, that I know of, is at the Florida State College for Women, where a small group of some half dozen earnest, consecrated girls, members of the College branch of the Auxiliary, meet weekly with their leader, Miss Baskette, and strive to fix their minds on things spiritual because it is their will to one day, should God so call them, enter the active service of the Church.

I feel that the time has come for this Committee on the Gift of Life to take an active interest in these girls and to help to direct their lives in such ways as may bring to fruition their present will to serve the Christ through His Church. Under new business, I hope to bring before you some definite suggestions towards this end. In preparation for such a consideration of plans



I shall, directly, have the pleasure of presenting to you a woman from my old home diocese of Upper South Carolina, who will tell you of the work of the Gift of Life Committee throughout the two South Carolina dioceses. She will, I know well, give to you somewhat of the vision that I carry in my soul and I look forward to the day in the near future when we in Florida will develop our work so that it may take on a more tangible form than it at present bears.

Before closing this report, we must speak for a moment of our only representatives in the Mission field—the Rev. and Mrs. William Wyllie. They continue to serve faithfully and with power in the Dominican Republic. Our committee sent to them at Christmas time a check for \$15.00, with the assurance of our constant love and prayers. They write most gratefully of our remembrance and the Archdeacon says “It is such a comfort to know that you are helping us so much and so systematically with your prayers and your gracious thoughts and money.” Someday he promises to come home to us to visit and speak with us. Let us continue instant in prayer for these two consecrated servants of our Lord.

In addition to our gift to the Wyllies at Christmas time, we were enabled to send cards and small gifts to our five Postulants and three Candidates in training for Holy Orders. The total amount received from the parish branches for these Christmas remembrances was \$21.00.

At the close of this report, Mrs. Cornell introduced Mrs. Joseph E. Hart, of Upper South Carolina, and asked her to outline the practical plan in operation for some years past in her diocese for recruiting young women and for sending them into the Church's service. Mrs. Hart told of the work of the Committee on the Gift of Life and outlined the work done especially in Rock Hill, where Winthrop College, the state College for Women, is situated and where a splendid student work is carried on. Each year the opportunity of life and part time service is presented to the Episcopal girls in this institution and each summer, several girls volunteer to serve from one to three months in one of the mountain mission stations. Their expenses are borne by the Diocesan Auxiliary. This plan serves to relieve the missionaries and to allow them to take much needed vacations, and it serves to interest the girls in mission work and not infrequently it leads to life service in the mission field for those who have this experience.

Hymn No. 49. “The Son of God Goes Forth to War.” was sung and Mrs. James R. Cain spoke to the meeting on the subject of “The World Program of the Church.”

The outstanding thoughts presented by Mrs. Cain were, first the need for a personal consecration of life and substance to our Lord in order that our home and outside contacts shall recognize the sincerity of our witness. She then stressed the obligations and opportunities of Parish, Diocese, Nation and World and urged that we recognize ourselves channels through which the Christ will work if we will let Him. She pled for creative thinking and definite action with regard to the problems and opportunities that are all about us as we seek to extend the Kingdom of Christ. Speaking of the Program of the Church, she urged that we translate it into a Program of Human Need and pled with us to set



our creative thought there to, to help our Parishes and Diocese, not only to meet but to exceed the quotas laid upon them for the evangelism of the world. Mrs. Cain closed her address by reminding us that when Our Lord wanted a Messenger to carry to the world the news of His Resurrection, He chose Mary, a woman who loved Him—a woman like you and me, who could say to the world gladly and joyously "My Lord is living today."

The President announced that the offering of the women at this morning's service was \$80.57. This offering will be given to the Bishop's Purse. It is one of the largest offerings ever given at an opening service of our Annual Meeting.

After routine announcements, the President dismissed the afternoon session with prayer and the blessing.

### FRIDAY MORNING SESSION

The Friday morning session was called to order at 9.45 a. m. Hymn No. 37, "The Church's One Foundation," was sung and the Rev Charles A. Ashby, rector of the Church of the Good Shepherd, opened the meeting with prayer.

The minutes of the Thursday afternoon session were read and approved.

The President stated that she must attend the Council to read her Auxiliary report and asked Mrs. M. C. Whidden, President of the 4th District, to take the chair.

Mrs. P. C. Wolcott read her report for the Church Periodical Club.

### Report of the Church Periodical Club

The Church Periodical Club this past year has reflected the generally depressed economic conditions in Florida, and only eight branches have sent in reports.

Many have said that their activities were so few that they were scarcely worth reporting. On the contrary I believe that even the least activity is worth reporting and that we shall have a better report for the current year.

Remember that while I may know of work being done in particular places I cannot make a proper return to the national organization unless reports came to me in proper form.

The Church Periodical Club needs the help and mothering of the Woman's Auxiliary and I urge that the various branches of the Auxiliary interest themselves in this work.

Remember that it is the little deeds of thoughtful kindness that develop our own Christian character, and that it is with small things that we contribute to the impressive totals of the work of the Church Periodical Club. It is a work in which every one has a share and in which every one can help.

Our outstanding needs are for books and good periodicals for the nurses and other workers in the lonely foreign fields; stories of cheerful human interest, adventure stories and "thrillers" of the better sort; books and magazines which you yourselves enjoy reading.

Write and tell me whatever you have to send and I will supply you with addresses. With the first number you send enclose a little note and ask for a reply.

Then last, but not least, pray for the Church Periodical Club and observe the day of Corporate Communion which is May first.

May God bless you all and increase your interest in this good work.

Discussion of the Lenten Study Class Program was postponed until after Mrs. Cain had made her address.

The President returned to the Chair and Mrs. James R. Cain, President of the Woman's Auxiliary in the Province of Sewanee spoke on the subject of Our Provincial Objectives.



### Our Provincial Objectives

At the meeting in Columbia last November the Auxiliary in the Province of Sewanee decided that a more definite organization was needed in order that detailed plans for the carrying out of the program of the General Church might be more effectively worked out and that through unity of effort and objective the Churchwomen of the Province might be drawn more closely together.

Such an organization was effected by the delegates at that meeting and a request was made for a Provincial Program which should serve to "further the Program of the the National Church, unite the Branches of the Woman's Auxiliary and strengthen the life of the Church within the Province."

It has seemed to your President that it would be wise at this time to try to concentrate the thought of the various Branches upon those already adopted objectives which seem to serve the purposes set forth above rather than to set up a new program. The following outline is offered in the belief that it is already receiving the support of both Diocesan and Parish Branches and that to offer it as a Provincial program will serve to bring to it only that additional enthusiasm and inspiration which comes from a knowledge of cooperation in interest, in work and in purpose. The objectives are taken from "the Program of the National Church" and if they are stressed with sincerity and earnestness there can be no doubt but that the result will be "the uniting of the Branches of the Woman's Auxiliary" and the "strengthening of the life of the Church."

1. Personal Religion and Evangelism: The striving to make of our whole life a "devotional life"; to make of all our relations with our fellowmen a channel through which Our Lord may reveal Himself to His world.

2. Recruiting for Service: First of all, ourselves; then striving to bring others, into confirmation classes, into training for leadership, into training for life service. The Church offers many opportunities—it is our responsibility to make those opportunities known.

3. The Great Gift for Advance Work: To this effort the Auxiliary has definitely pledged its experience, its loyalty, its devotion, its machinery; let us put into the work all that has served in the past to make of our own Corporate Gifts such an inspiring success.

4. Support of the Provincial Department of Religious Education: This is the Department which has developed and fostered our Provincial consciousness; to it we owe much, upon it we must depend for much in the carrying out of our program; we have promised to aid it through appropriations in the budgets of the various Diocesan Branches.

The Chairman of the Department of Religious Education took charge of the discussion of Lenten Study Classes, and spoke of the leaflet on Parliamentary Law recently published by the Church Missions House (281 Fourth Avenue, New York City) at 5 cents per copy, of which Mrs. Cain is the editor. She likewise paid tribute to the value to the presentation of the Provincial Pageant, "What Price Youth," and urged parishes throughout the diocese to make use of this method of arousing interest in the work of religious education.



Mrs. Joseph L. Gray read the report of the Margaret Tebeau School, in Gainesville, and also a letter from our scholarship girl, Florence Nunez as follow:

### **Report of the Margaret Tebeau School**

This month ends the first semester with an enrollment of nineteen pupils.

Mr. Edwin B. Hampton has succeeded in having the property removed from the city and county tax books.

The school owes no debts.

We thank our kind friends and Kirby Smith Chapter, United Daughters of the Confederacy for prizes to be awarded at the close of school.

Both faculty and pupils have enjoyed the services and instructive talks given in our Study Hall by the Rev. W. S. Stoney.

### Report of the Committee on the Bishop Weed Memorial Fund

This committee is happy to report that \$9,633.11 of the \$10,000.00 required has been contributed. The interest on this amount will, in one year, complete the Fund. But there are still some branches and individuals who have not yet contributed as they have wished to do—and—that they may not miss this opportunity to do honor to their beloved Bishop, the Fund will be kept open a few months.

It is well to mention that the bulk of this Fund has been given within this Diocese by a generation who knew and loved Bishop Weed and many of whom were confirmed, married or baptized by him.

This committee was appointed at the Annual Meeting of the Woman's Auxiliary in Pensacola in 1925, and consisted of three members. In that year five thousand booklets, explaining the Bishop Weed Memorial Fund, were distributed.

At the Annual Meeting in St. Augustine, the presidents of the four districts were added to the committee.

The committee is very grateful to the many willing contribu-



tors who made the completion of the Fund possible. Not all of them were Episcopahians, some having known Bishop Weed only as a noble citizen of Jacksonville and Florida.

We wish to remind the Auxiliary of the collection of old gold and silver articles and jewelry, being made to provide a communion set for the Weed Memorial Chapel.

A second Roll Call showed an addition of some 25 women in attendance upon the meeting.

Mrs. B. K. Hall, chairman for the Gold and Silver Offering for the Communion Service for Weed Memorial Chapel outlined the plan and urged that this offering be completed before the spring meetings of the Districts. Mrs. Fred Kettle, of St. Augustine, urged that this offering be made in the spirit of a memorial to loved ones.

The President announced that while waiting for the Bishop to make his address, several branch reports would be read.

Mrs. George M. Chapin moved that only branches having delegates present would be allowed to have their reports read—this motion was seconded and carried.

Reports were read from St. Peter's, Fernandina; St. Mary's, Green Cove Springs; Bethany Hall, Hilliard; Jacksonville, Good Shepherd; Good Shepherd B; St. John's; St. Mary's; Grace, Orange Park; St. Mark's, Ortega; St. Paul's, South Arlington; All Saints', South Jacksonville.

The meeting was here privileged to listen to Miss Florence L. Drinker, veteran missionary in the mountains of Western North Carolina, in whose work the women of Florida have long been interested.

Bishop Juhan entered and after explaining his delayed appearance because of a heated debate in the Council as to whether or not Florida would this year pledge her full quota of \$13,000.00 to the General Church, which he stated the Diocese had been authorized to do—applause followed this statement—he delivered his annual address to the women of the Auxiliary.



Mrs. Cornell urged the women to stand behind the Bishop and the Council in raising the full quota this year and offered a resolution that "The women of the Auxiliary, in convention assembled, request Bishop Juhan to express to the Council their joy and deep gratitude for its action in maintaining its vision of full responsibility to the National Program of the Church, and pledging to the Council their cooperation in the raising of this quota." The resolution was seconded and adopted.

Mrs. Jessie R. Fritot made her report for the Supply Department.

Recess was declared for luncheon at 1.05 p. m.

## FRIDAY AFTERNOON SESSION

The afternoon session was called to order at 2.15 p. m. Hymn No. 6, "Go Forward Christian Soldier," was sung, prayer offered, and the minutes of the morning session read and approved.

Mrs. L. F. J. Hindry, chairman of the Committee on Re-Districting, presented the report of the Committee.

District No. 5—Apalachicola, Trinity; Panama City, St. Andrew's; Marianna, St. Luke's; Quincy, St. Paul's; Carrabelle, Ascension Mission; River Junction, St. Mark's.

Mrs. Koberus of Tallahassee expressed the opinion that since only the branches now included in the Third and Fourth Districts were directly concerned in the plan of re-districting, only delegates from these sections of the Diocese should be allowed to vote on the question.

Mrs. Cornell moved that "only the delegates from the Third and Fourth Districts be allowed to vote on the question of re-districting, but that it be understood that the delegates from the other two Districts would be allowed the privilege of a voice in the discussion." This motion was seconded and carried.

Mrs. M. C. Whiddon moved that "A Fifth District be created, the lines to be determined by further discussion." The motion was seconded and carried.

The original question as to whether or not the delegates from all four Districts should be allowed to vote on the lines of the new district was again brought up for discussion. On motion of Mrs. Cornell, the action of restricting the vote to the delegates of Districts Three and Four was rescinded.

Mrs. Whiddon moved that an Arbitration Committee be appointed to present proposed lines for the new District, and that the branches concerned agree to abide by the decision of this Committee. The motion was seconded and carried.

Mrs. Cornell moved that the present Committee be discharged with an expression of appreciation for their services and that an Arbitration Committee be appointed from the representatives of the Branches concerned, and that this Committee be asked to withdraw immediately with the request that it bring in a report to this body before the close of the session. This motion was seconded and carried and the President appointed the following Committee:

That this plan be tried for one year and that no less than a full grown Quota be given to the new District. The Committee moved the adoption of this report. The motion was duly seconded and carried.



Mrs. Correy moved that the salient points of the Parish Branch Report be hereafter embodied in the District President's Reports and that these Parish Branch reports shall not be read at future Annual Meetings of the Diocesan Branch. The motion was seconded and carried.

It was moved and carried that the Parish Branch Reports remaining unread at this meeting be omitted. The motion was seconded and carried.

Miss Drinker was offered an opportunity to again speak of her work and at the close of her talk, she offered to make addresses to any individual Branches which might like to hear her message.

Mrs. Cornell announced that the Committee on the Gift of Life would communicate with District meetings with regard to the possible sending of Summer Volunteers to the Mountain Mission Field this summer.

Miss Hope Baskette, Student Worker at the Florida State College for Women spoke a few words with regard to the work of the Student Auxiliary which is very active at the present time. She feels that her small Committee on the Gift of Life, which meets at regular intervals, gives promise of real spiritual power.

The President called for miscellaneous business—There being none presented, Mrs. John G. Ruge, Chairman of the Committee on Courtesy read her report:

This recommendation was turned over to a committee for the Diocese who had funds to meet the expense and in due time the repairs were made.

The Flower and visiting committees were diligent in performing the duties they had assumed.

As a means of raising funds to carry on its work, the Guild was divided into four circles. Thus \$139.00 was realized. An additional sum of \$118.55 was earned by means of a Christmas Bazaar. Five dollars was donated and the yearly dues amounted to \$22.00. These sums together with a balance from 1928 of \$52.05 gave the Guild a budget of \$336.60.

The total expenditures of the year being \$199.75 the Guild now has a balance of \$136.65.

Note:—Bills for \$62.50 for chairs and a rug for the Parish House and \$14.25 for candy for the Sunday School and St. Augustine's Mission were paid after the yearly report had been handed in—hence did not appear in the treasurer's report at the Parish meeting.

To the regular charity fund of \$60.00, \$21.00 was added to aid two needy families.—Total \$81.00.



Five dollars was given to Child Welfare, \$5.00 for music for an "At Home" given for students at the University; \$14.25 for candy for Sunday School and St. Augustine's Mission.

For Lenten work the Guild, as has been its custom for several years, bought material and made garments which were given to the needy children of the Public Schools.

A vacuum cleaner was purchased, the Woman's Guild paying one half. The cost amounted to \$21.00.

Again, with St. Martha's Guild, each paying half, the Woman's Guild bought some furniture and a rug for the Parish House. Cost, \$62.50.
