My dear Women of the Auxiliary:

Those of you who are familiar with the resolutions adopted at our recent Annual Convention, are no doubt wondering what has become of the committee appointed to raise the \$500.00 Special fund which is to be our contribution this year to the Diocese of Florida and the American Church Institute for Negroes, looking toward the much to be desired securing of the Florida Normal and Industrial School for Negroes, situated in Saint Augustine, as one of the Institute Schools.

At the present time Florida and Kentucky are the only states in the Province of Sewanee that do not claim an Institute School as a part of their educational work among their Negro populations. The Colyer Normal and Industrial School is a \$350,000 plant and it is the hope of its founder and owner, Professor Collyer, that it may be taken over by our Church. It was at the suggestion of the American Church Institute that we women of the Auxiliary took the initial step in the effort to raise \$1,000 this year as an expression of our interest and faith in this definite work of Church extension within our own diocesan limits. The Council of the Diocese has likewise appointed a committee to raise \$500.00 for the project in view.

We very much hope that every branch of the Auxiliary in the Diocese of Florida will take some part in fulfilling this resolution. We feel quite sure that each one of our Colored branches will make a contribution. To this end we are suggesting a minimum contribution, which we hope will be forthcoming from each branch in the diocese. Please see the attached list for the goal which the committee has set for your parish branch.

You will find the officially adopted resolution on page 145 of the Diocesan Journal now being mailed you. Please familiarize yourself with it and make it known to the women of your parish.

We would call your attention to the fact that if the plans for the securing of this School fall through, the Auxiliary women have designated their gift to the American Church Institute for Negroes, the Missionary District of Liberia, the Orient and the Domestic Mission field. Bishop Juhan asks us to impress upon you the fact that, while he sincerely hopes the school project will be successfully culminated, he feels that the alternative gift to the Department of Missions of the National Council- a gift which will greatly increase Florida's share in the world-wide obligations expected of her- will be essentially helpful and worth while.

Please present this matter to your women at their June meeting and send in your pledge to the Chairman of the Committee.

OPENING SERVICE

The opening service of the Forty-sixth Annual Meeting of the Florida Branch of the Woman's Auxiliary to the National Council was held in Holy Trinity Church, Gainesville, on May the 14th, 1936, in conjunction with the opening service of the Ninety-third Annual Council of the Diocese of Florida. The service took place at 10:30 A.M., the Bishop of the Diocese being the Celebrant, assisted by the Reverend Messrs Ambler M. Blackford and Harris Mallinckrodt, representing the Standing Committee, and the Reverend Messrs. Francis B. Wakefield and Hamilton West, representing Holy Trinity Parish. The Bishop delivered his Annual Address at this service.

BUSINESS SESSION

First Day—Morning Session

The Forty-sixth Annual Meeting of the Florida Branch of the Woman's Auxiliary to the National Council was called to order in the First Presbyterian Church, in Gainesville, shortly before noon on Thursday, May the 14th, the retiring President, Mrs. J. D. Russell in the chair.

The business session was opened with hymn and prayer, the latter being conducted by the Rev. Basil M. Walton.

INTRODUCTIONS

The President introduced Miss Rachel E. Gregg, as the newly appointed Educational Secretary to fill the unexpired term of Mrs. O. Z. Tyler, resigned. She announced that Miss Bertha Henry, the newly appointed Christian Social Service Secretary was unable to be present.

The following guests of the Annual Meeting were introduced by the President: Mrs. Henry J. MacMillan, President of the Womans' Auxiliary to the National Council in the Province of Sewanee; Deaconess Harriet M. Bedell, United Thank Offering Worker among the Seminole Indians of South Florida.

A welcome to the Diocese was formally extended to Mesdames Malcolm W. Lackhart and Richard G. Urban, whose husbands have recently become rectors of Good Shepherd, Jacksonville and St. James', Lake City, respectively.

Mrs. Robert L. Gordon, wife of the Priest in charge of St. Michael and All Angels, Tallahassee, and Miss M. E. Lomas, Directress of the St. Michael's branch of the Auxiliary were welcomed to the meeting, it being the first time that this branch has had representation at an Annual Meeting.

Appreciation was expressed to the Rev. U. S. Gordon, Pastor of the First Presbyterian Church, and his congregation for the use of their Church building for the business sessions of the Auxiliary.

The Executive Board was asked to lunch together in order that some important business might be discussed.

Announcements were made regarding the luncheons in the parish house both today and tomorrow and the Dio-

cesan Banquet, to be held this evening in the New Century Club at 8:00 P. M.

The meeting recessed for luncheon at 1:00 P. M., after setting the hour for the afternoon session at 2:15 P. M.

First Day—Afternoon

The afternoon session was called to order at 2:15 P. M. with the singing of a hymn and prayer offered by the Diocesan President.

The President read her Annual Address as follows:

ANNUAL ADDRESS OF THE PRESIDENT

It is with deep appreciation to all members of the Woman's Auxiliary, but with regret for not having done all I might have done to further the work of the Auxiliary in this Diocese, that I now make my final address as your President.

I do feel that much progress has been made. The various departments are very active and the Chairman of each has certainly worked to make the work known and has had splendid cooperation from the District Chairman. The reports have been sent in better than ever before, partly I think owing to the unfailing interest and repeated reminders of Mrs. W. P. Cornell. She has been untiring in her efforts to get complete reports. I am sure no one knows or realizes the amount of work and the many days given to the getting out of the Year Book. The work could have been lessened if requests for reports had been met promptly. The Year Book is one we may all be very proud of, thanks to the ability and efforts of Mrs. Cornell. At the last annual meeting a resolution was passed that no reports be read unless asked for so I beg of you to read all reports and by so doing know what has been done and what we hope to do in all phases of our work.

We have two new Diocesan Officers, one the Chairman of the Christian Social Service, Miss Bertha Henry, and the other, Miss Rachel Gregg, Chairman of Religious Education, both of whom are willing and anxious to give of themselves in carrying out the work of their departments and in so doing help to serve God as true Disciples. Please give them your cooperation.

Let me remind you that half of the Triennial is over. What about our United Thank Offering? So far the amount has not come up to our hopes and expectations. We must renew our efforts and tell more women about the work that is being carried on through this offering and pray earnestly that we may give as God has given and blessed us.

The Supply Work has gone forward as well as usual. Much interest is taken in filling these allotments and trying to visualize

the joy that is brought to those to whom the things are sent. I wish we could be there at the opening of some of these boxes.

The work of the Periodical Club has grown tremendously as we can well see on reading the reports.

Let us give more time and thought to Religious Education. Most branches are having more interesting meetings with really good programs and also study classes twice a year.

I was happy to attend nearly all the Spring and Fall District Meetings. It is truly an inspiration to be at these meetings and hear the reports from faithful women of what is being done to further the work of the Church. Without exception you hear where all are having Corporate Communion, Study Classes, Days of Prayer, and all participated in the Quiet Day of Prayer, November 11th. I hope next year the World Day of Prayer will be observed by our women of the Church as a whole and some United Service be arranged. I am sorry it was not done this year.

We have all obtained much help and inspiration from the Forward Movement leaflets. I trust we will always heartily cooperate in the Movement and pass it on to those who have not as yet used the books.

I want to thank you all for your loving loyalty and cooperation in all things. I am sure no leader ever had a more loyal band of women and I ask you to give that same loyalty and support to your new President. It means so much to a leader to know she has this support. It gives her courage and inspiration to go forward. Let us always pray for our leaders.

I want to thank Bishop Juhan for his help and guidance. He has always been ready to give of his time and advice in all matters and has been such an inspiration to me, never impatient, never discouraged, always going forward with such faith and calmness that I felt ashamed when I got discouraged as I often did and would try to carry on again with some of his faith.

In closing let me suggest that we all try to know God better and may I pass on to you the following suggested ways of learning to know God which I recently read and which I hope will be helpful.

"There are four definite ways of learning to know God—Solitude, Service, Contact and Fellowship. In Solitude we are better able to feel the Presence of God. In Contact and Fellowship through prayer we are able to draw nearer the source of our strength, and in Service the knowledge of God is put to practical use."

"Daily our lives would show weakness made strong,
Toilsome and gloomy ways brightened with song,
Some deeds of kindness done
Some souls by patience won
Dear Lord to Thee."

Immediately following Mrs. Russell's address, Mrs. John L. Oldham, as the representative of the Diocesan Auxiliary Branch, presented the retiring President with a beautiful silver flower bowl, as a token of the love and gratitude of the Auxiliary women for her faithful and devoted leadership.

Mrs. Russell expressed her deep appreciation and her thanks with deep feeling.

MEMORIAL SERVICE

The Memorial Service was led by Mrs. Reginald White: Prayer was offered, "The strife is O'er, the battle done," was sung, and the names of the faithful Church women who have passed away during the past year were read while the women of the Annual Meeting remained standing. (See In Memoriam.)

The name of Mrs. Wm. S. Turner, of Greenville, S. C., was also read as an expression of love and sympathy to the Rev. John C. Turner, of Jacksonville, whose mother she was, and whose death occurred this morning.

Mrs. Cornell moved that a wire of love and sympathy be sent to the Rev. Mr. Turner in Greenville. The motion was seconded by Mrs. Gray and carried.

ADDRESS OF THE PROVINCIAL PRESIDENT

Quoting the Motto of the Triennial Program, "Close to Christ and forward with Him," emphasizing the various channels of service through which the women of the Church are to march forward, Mrs. MacMillan challenged the women of Florida to "fully realize what the King of all the World can mean in their lives."

Mrs. Charles P. Hale moved that a message of greeting and assurance of continued loyalty be sent to Bishop Darst, the President of the Province of Sewanee, and Mrs. McMillan's Bishop. The motion was seconded by Mrs. Cavell and carried.

OUR COLLEGE WORK

The Rev. Hamilton West told of the Church's plans and work among the young men of the Church attending the University of Florida, and extended an invitation to take tea at Weed Hall this afternoon at five o'clock.

Miss Julia Gehan told of her work among the girls studying at the Florida State College for Women, stating that there are 237 Episcopal students in the College this year. She stressed the fact that Ruge Hall is looked upon, and used, as a general meeting place for Campus groups.

Miss Alice Thomas reported on the good work of our Scholarship Girl, Juliana Davis, of St. John's Church, Jacksonville, in the Margaret Tebeau School.

REPORT OF THE MARGARET TEBEAU SCHOOL

The school is smaller this year, but all bills have been paid.

Our Woman's Auxiliary scholarship girl, Juliana Davis, has done excellent work this term. Her general average is 94.

In December, Mrs. J. L. Gray gave her a scholarship in music. In the past seven months she has completed the work usually requiring one and a half years.

We highly appreciate the gifts of Mrs. J. L. Gray, Mrs. W. W. Hampton, Sr., and other kind friends, which, with the scholarship given by the Woman's Auxiliary, has enabled us to keep the school open this term.

ADDRESS ON OUR MISSIONS

An exceptionally fine and challenging address on "Our Missions" and the implication upon Christians of the World Missionary Message, was delivered by the Rev. Francis B. Wakefield, rector of Holy Trinity Parish,

Gainesville, and Chairman of the Diocesan Department of Missions and Church Extension.

At the close of the Rev. Mr. Wakefield's address, the meeting recessed until Friday morning at 9:30 A. M.

First Night—DIOCESAN BANQUET

The Council and Auxiliary Convention, their hosts, and their guests attended the Diocesan Banquet, served in the New Century Club, at 8 o'clock. The Bishop of the Diocese presided at the banquet, Dean B. R. Van Leer of the faculty of the University was toast-master.

The speakers of the occasion were: Mrs. Henry J. MacMillan, President of the Provincial Auxiliary, who was introduced by Mrs. Russell; the Rev. Charles E. Sheerin, of St. Paul's, Chattanooga, who spoke on the Forward Movement; the Rt. Rev. Middleton S. Barnwell, Bishop Coadjutor of Georgia, who spoke on the Program of the National Church; Fred Angerholzer, of Jacksonville, who spoke of the work of the Young People's Service League, and Miss Julia Gehan and the Rev. Hamilton West, who spoke of the Student Work in Tallahassee and Gainesville.

Second Day—Morning

A number of the Auxiliary women attended the Celebration of the Holy Communion, in Holy Trinity Church at 7:30 A. M.

QUIET HOUR AND MEDITATION

A special Quiet Hour and Meditation was conducted in the Presbyterian Church, for the Annual Meeting of the Auxiliary, at 9:15 A. M. by the Rev. Douglas B. Leatherbury, rector of St. Mark's Parish, Jacksonville. This service was one of exceptional beauty and helpfulness and set a high note for the meetings of the day and for the lives of Churchmen.

BUSINESS SESSION

The business session of the second day was called to order by the President at 10 o'clock, a hymn and prayer being led by the presiding officer.

The minutes of Thursday's business session were read and with several minor corrections approved.

The President expressed for the Annual Meeting the deep appreciation felt by the women for the exceptionally helpful Quiet Hour and Meditation which the Rev. Mr. Leatherbury led this morning.

Miss Weed moved that the Annual Meeting express its appreciation of the 45 years of devoted Service, rendered the Church and the Auxiliary by Mrs. Henry E. Palmer of Tallahassee, better known to the Auxiliary as Mrs. John G. Ruge, of Apalachicola. This motion was seconded by many and adopted with a rising vote.

Mrs. Palmer spoke feelingly of this honor extended to her.

The Treasurer reported that the offering taken by the women at the opening service yesterday amounts to \$33.36.

Mrs. Cornell moved that this offering be given to Deaconess Bedell for her work among the Seminole Indians. The motion was seconded and carried, and Deaconess Bedell expressed her grateful appreciation of this gift to the extension of her work.

REVISION OF CONSTITUTION

The Committee on Constitution and By-Laws, presented through its chairman, Mrs. Joseph L. Gray, a revision of the Constitution. Mrs. Gray stated that these proposed revisions had been presented to the Executive Board and had received the approval of that body. She also stated that the Committee had brought in this revised Constitution at this time, because it felt the need of bringing certain practices of the Diocesan Branch within Constitutional provisions, and because the Committee felt it a pity to let the opportunity pass by to have the revisions made in time for publication with these minutes of the Forty-sixth Annual Meeting.

The Constitution was revised as printed herewith, save that action on the following resolution was deferred until the afternoon session.

A resolution offered by Mrs. B. C. Riley, providing that all parish and mission branch Directresses be members of the Executive Board and that the Quorum of the Executive Board be enlarged to accord with this increase in membership, was duly seconded and thoroughly discussed.

The following substitute motion was offered by Mrs. Cornell, which was seconded and carried:

Resolved: That the provision for the enlargement of the Executive Board be referred to the Executive Board for its consideration during the noon hour, and that the Board's recommendation be presented to the Annual Meeting at the afternoon session.

Because of lack of time to discuss the necessary revisions in the By-laws at this meeting, Miss Gregg moved that these revisions be left to the Executive Board to approve and present to the Annual Meeting of 1937 for adoption. This motion was duly seconded and carried.

MRS. LOCKHART SPEAKS

Mrs. Malcolm W. Lockhart, until recently Secretary of Religious Education in the Woman's Auxiliary of Louisiana, addressed the meeting on the subject of Religious Education. Mrs. Lockhart emphasized the fact that Religious Education is a very comprehensive term, and that it includes the religious education of the whole man, and is not confined, as so many seem to think, to the study of books and the carrying out of programs. The speaker closed her address with an exceptionally earnest and beautiful prayer.

ELECTIONS

The hour for elections having arrived, the Nominating Committee again stated that their nominee for President of the Diocesan Branch was Mrs. W. S. Cawthon, of St. John's Church, Tallahassee. There being no nominations from the floor, Miss Gregg moved that the Secretary be instructed to cast a **unanimous ballot electing Mrs. Cawthon to the Presidency of the Auxiliary. The Secretary did cast the ballot and declared Mrs. Cawthon duly elected to the office of Diocesan President.**

After nomination by the Committee of Mrs. Reuben Ragland, of the Church of the Good Shepherd, Jacksonville, to be Executive Vice President of the Diocesan branch, Mrs. B. C. Riley, of Holy Trinity Parish, Gainesville, was nominated from the floor. The election ballots were cast.

Noon Day prayer for the Church's Mission was offered by the Rev. Fred G. Yerkes, of St. Mark's, Starke.

The Bishop of the Diocese entered the Church and the meeting rose to greet him.

THE BISHOP'S MESSAGE

St. Paul's message to Timothy, "Notwithstanding the Lord stood with me," formed the basis of the Bishop's address. "The comfort of a stand-by, such as the Woman's Auxiliary" said the Bishop, "is a constant source of strength and encouragement." He urged that, like St. Paul, loyal Christians shall at all times depend on the Christ, who "stands by" and who "wills that we shall follow Him."

DEACONESS BEDELL SPEAKS

Deaconess Harriet M. Bedell, United Thank Offering Missionary to the Seminoles in South Florida, and Missionary to the Indians of Alaska and the great Northwest for many years, made an inspiring and encouraging report of the Church's work among the Seminoles. She urged the prayers, the love and the support of the Florida Auxiliary in this mission field within the borders of their own state.

CAMP WEED

The Rev. Gladstone Rogers, Director of the Camp Weed Leader's Conference for 1936 outlined his plans for the season, and urged attendance of Auxiliary women and the support of parish branches through the giving of scholarships if needed.

The President urged that the branches accede to the Rev. Mr. Rogers requests.

RURAL WORK

The Rev. Joseph R. Walker, Chairman of the Commission on Rural Work, spoke on this field of missionary endeavor and suggested that the five Districts plan at one of their semi-annual meetings to invite a rural worker from a neighboring District to address their meeting. He also announced that the Council had approved a plan for an interchange of missionary and parish clergy for some Sunday in the fall. He also stated that the Council had provided for the printing and distribution of the Bishop's Annual Address.

After announcements, and prayer offered for Mrs. Ambler M. Blackford who, it was announced, is seriously ill, the session recessed for luncheon.

Second Day—Afternoon

The Friday afternoon session was called to order at 2:20 o'clock. After the singing of a hymn, prayer was offered by the Rev. Richard G. Urban.

The Treasurer reported upon request that she holds in the Special Savings Account the sum of \$123.40, said sum being designated to the Diocesan Memorial Fund.

DIOCESAN MEMORIAL FUND

The President outlined the purpose for which this fund was established and led in a discussion of the present status of the fund. Mrs. Claytor, of the 5th District, which originally proposed the establishment of the Memorial Fund, brought in a recommendation from her District to the effect that the interest of this fund be used to provide financial assistance in the State Tubercular Sanatorium now being built. The motion was duly seconded but a discussion of the inauguration of the fund brought forth no positive knowledge of the designated use of the interest of this fund, although Miss Weed and Mrs. Gray stated that they felt certain the object of the Fifth District in creating this fund was to augment the Contingent Fund through the use of the annual interest.

Because of the above mentioned uncertainty no action was taken on the motion of Mrs. Claytor. The President stated that she would look up the minutes of the Annual meeting at which this fund was created and would see that the branches are notified of the action taken at that time.*

RESOLVED: That a Diocesan Memorial Fund be inaugurated to which Parish Branches, or individuals, may contribute from time to time in memory of their loved ones. Said Memorial Offerings to become a Trust Fund of the Florida Branch of the Woman's Auxiliary to the National Council, and a special Custodian to be appointed to have charge of the same.

BE IT FURTHER RESOLVED: That the interest only of this Diocesan Memorial Fund shall be used for such purposes as the Diocesan Branch may designate. (See Journal of 1933, page 111.)

*NOTE—At the Forty-third Annual Meeting of the Diocesan Branch, held in Saint Augustine, January 26-27, 1933, the following resolution was offered by Mrs. J. L. Prevost, of Panama City, in the Fifth District. It was seconded by Miss Grace Tyler, of St. John's, Jacksonville, and adopted without dissenting vote:

Miss Juliana Davis, "Our Scholarship Girl", was introduced to the Convention and spoke of her gratitude to the Auxiliary for her scholarship in the Margaret Tebeau School.

REVISION OF THE CONSTITUTION CONCLUDED

The Committee on Constitution and By-laws through Mrs. Cornell, a member of the Committee, reported that a meeting of the Executive Board, held at the luncheon hour, approved the addition of Parish Branch Directresses to the Executive Board Membership. Mrs. Cornell therefore moved the following resolution:

RESOLVED: That the Directresses of all parish and mission Branches of the Woman's Auxiliary be included in the membership of the Executive Board.

The motion was duly seconded and carried.

Miss Rachel Gregg moved the adoption of the following resolution which was duly seconded and carried:

RESOLVED: That in consideration of the fact that the Executive Board will now number some seventy-seven members, and that a quorum of eleven members would not be adequate representation, the Board recommends that the action of the body on Article 13, Section 2, be rescinded and that the Quorum of the Executive Board be increased to seventeen members.

The First Vice President, Mrs. Charles P. Hale, took the Chair and the President reported to Council to give her Annual Report to that body.

Miss Nora Norton was introduced to the Convention by Miss Margaret Weed, who stated that it was Miss Norton's dream and labor of many years that had brought to fruition the present splendid Student Center, at the University of Florida, known as Weed Hall. Miss Norton told of the beginnings of this building and of the support given by the women of the Auxiliary.

ELECTION EXECUTIVE VICE PRESIDENT

Mrs. B. K. Hall, Chairman of the Tellers, announced that Mrs. Reuben Ragland, of the Church of the Good Shepherd, Jacksonville, had been duly elected Executive Vice President of the Florida Branch of the Woman's Auxiliary to the National Council.

At the request of Miss Weed, the Treasurer presented as information the itemized budget for the current year. Mrs. Clarke urged the branches to send in their payments on the Contingent Fund so that the printer might be paid in full as soon as possible for the Year Book.

Mrs. Gray expressed for the Convention a sincere appreciation on the part of the Auxiliary membership for the helpful Year Book and Annual Report recently edited and published by the Committee of which Mrs. Wm. P. Cornell, the Recording Secretary, was Chairman.

The President returned from Council and resumed the Chair.

Mrs. Reuben Ragland was presented to the Convention as the newly elected Executive Vice President, and responded appropriately.

THE ORDER OF THE DAUGHTERS OF THE KING
