MINUTES

FIRST DAY

WEDNESDAY, April 18, 1917, 10 A.M.

The Twenty-fifth Annual Meeting of the Georgia Branch of the Woman's Auxiliary convened at the Church of the Good Shepherd, Augusta, on Wednesday morning, April 18th, 1917, at 10 o'clock.

The Rt. Rev. F. F. Reese, D.D., assisted by Rev. William Johnson, celebrated the Holy Communion. The offering, amounting to \$13.45, was devoted to the United Offering.

At the conclusion of the service the Auxiliary organized for business in the Sunday School room of the Church, Mrs. John K. McIver, Diocesan President, presiding.

The meeting was opened with prayer and an address of welcome by Rev. William Johnson.

Twenty-four delegates responded to roll call as follows:

Mrs. Annie T. Burum was elected Secretary.

An address was then made by Bishop Reese, who made an appeal to the branches to sustain him in the support of Bishop Thomas of Wyoming, Georgia having pledged to raise \$3,300 for his salary and expenses.

The Bishop then gave an account of what the missionary travelling and vocation funds had enabled him to do, and gave a résumé of the work and growth of our Church in Georgia. The present figures being, that out of sixty-six counties eight have parishes, eighteen organized missions, nine regular services without buildings; six have a few scattered communicants who are in touch with some clergyman; twenty-five without any.

The Bishop further stated that it was his desire to have in 1923 proper centenary observances (commemorating the coming of our Church to Georgia) by noonday prayers in every county.

An address of welcome from the other churches of Augusta was made by Mrs. J. F. Bransford. Mrs. A. B. Hull, of Savannah, responded.

Noonday prayer was led by Rev. William Johnson.

The President delivered her annual address, which is given in full following these minutes.

The President introduced Mrs. Biller, now Secretary of the Church Mission House. Mrs. Biller is endeared to us by the fact that she is the widow of the late Bishop Biller, of Dakota, and an appeal to the Auxiliary from one so familiar with the field made a deep impression, and we trust it will energize our work as fully as it touched our sympathies.

Rules of order were read by the Corresponding Secretary, Mrs. W. J. Brown.

Report of the Juniors by their President, Miss Mary Cuthbert.

Report of Little Helpers was read by Miss C. Carpenter, in the absence of the President, Mrs. Backus.

Miss Cuthbert explained some omissions in the Junior report, owing to illness of leaders.

Report of Secretary of Boxes was read by Mrs. Brown, Mrs. Robinson being absent.

A very beautiful screen, made by the Juniors for a hospital, was shown as a suggestion for work.

Report of Secretary of Spirit of Missions.

Mrs. McIver asked for expressions from the floor in regard to appeals which had been made.

Mrs. Hull, of St. John's, Savannah, stated she had come with instructions for definite pledges.

Miss Johnston, Section B, Christ Church, Savannah, stated her branch had given definite pledges and permission to increase according to her judgment.

Adjourned until 3:30 o'clock.

WEDNESDAY, April 18, 2:30 P.M.

The afternoon meeting was opened with prayer by Rev. Mr. Prentiss.

Minutes of morning session read and corrected.

Owing to the absence of the Diocesan Treasurer, Mrs. W. H. DeVoe, her report was read by Miss Colesberry, of Brunswick.

The deficit in the Travelling Fund was brought up by the President and new pledges were made to cover same.

Mrs. Blount, Treasurer of the United Offering, read her report.

Mrs. Haskell moved that all officers be elected annually, and that no officer be eligible for more than three years for the same office. As we were called to the meeting of the Juniors, action on the motion was postponed and made the first order of business for to-morrow.

Meeting adjourned until Tuesday morning at 10 o'clock.

SECOND DAY

THURSDAY, April 19, 10 A.M.

Rev. G. S. Whitney opened the meeting with prayer and a few words of counsel.

Minutes read and corrected.

Miss Cuthbert read telegram from W. B. Sams inviting the Auxiliary to hold its meeting in St. John's Church, Bainbridge, next year.

She was authorized to send Mr. Sams a telegram of acceptance.

Motion from previous meeting withdrawn by Miss Johnston. The substute motion by Mrs. Haskell being:

"All officers to be elected annually and be eligible for three consecutive years to same office."

The same was voted upon and adopted,—the vote standing 9 for and 4 against.

Nominating Committee was appointed by the Chair as follows: Mrs. Sheldon Leavitt, Mrs. G. W. Chapman and Miss May Hansell.

Reports of Vice-Presidents were read, and a summary of same appears in the printed report.

Report of committee to amend Constitution and By-laws read by Miss Johnston, Chairman. The amended Constitution and By-laws were read section by section and adopted.

The President introduced Mr. Ludlow, of Wuchang, China, who gave a most interesting account of the women in China, and told of his four churches being without a woman worker. He stressed the point of the serious handicap under which the hospitals labored, on account of insufficient help. Dr. James has worked seven years without a furlough.

Noonday prayer was led by Rev. William Johnson.

Pledges from the different branches, amounting to \$55, were made for the General Hospital at Wuchang.

A motion was adopted authorizing the President to appoint a representative in each Archdeaconry to work for this fund.

Report of the Educational Secretary, which was followed by a conference led by Mrs. Haskell. One of the results of the educational work has been the pledging by Section B of Christ Church, Savannah, of \$50 annually for a scholarship at St. Mary's Hall, Shanghai, China.

Motion was adopted to send a delegate from Brunswick Archdeaconry to the Blue Ridge Conference, and branches were asked to pay her expenses by increasing their pledges to the Expense Fund. As a result, an increase of \$46 was pledged.

Mrs. Blount, Chairman of "Offering of Life," reported that she had obtained no definite results as yet, and moved that a special missionary meeting be held the first evening of the annual meeting, at which an offering shall be taken to raise a fund to train a life for the mission field. The motion was unanimously adopted.

The Nominating Committee submitted the following

REPORT

Before presenting its report the Nominating Committee begs to submit the following suggestions for possible future consideration by the Auxiliary:

We suggest that the officers be divided into three groups. One group to be elected each year to serve three years. No member of any group to be eligible for immediate re-election to the same office.

Group one shall consist of the President and the four Vice-Presidents, and shall be elected at the meeting preceding the General Convention.

Group two shall consist of the Treasurer, Treasurer of the United Offering, and the Presidents of the Juniors and Little Helpers.

Group three shall consist of the several Secretaries.

At the first election under this system it will be necessary to elect one group for three years, one for two years and one for one year, in

order to bring about the proper succession of elections; but after that each group will be elected for the term of three years.

We believe that this system of rotation will tend to interest a larger number of women and will train them to be more efficient in Auxiliary work.

Our report is that we feel that we could not, for the good of the Auxiliary, better our present able management, and we therefore take great pleasure in re-nominating all of our officers.

The above was received as information, to be taken up at the next annual meeting, except that portion referring to nomination of officers for the coming year, which was adopted, and all of the present officers were re-elected to serve for the ensuing year.

THURSDAY, April 19, 3:30 P.M.

Session opened with prayer by Mrs. McIver.

Minutes read and corrected.

Delegates to the Synod to meet in Charleston, S. C., on November 13, 1917, were elected as follows: Mrs. McIver, Mrs. A. C. Haskell, Miss Mary Cuthbert. Alternates: Mrs. A. H. Hilsman, Mrs. J. P. Verdery, Miss Phoebe Elliott.

The appointment of a delegate to Blue Ridge Conference was left to Miss Lula Colesberry, Vice-President Archdeaconry of Brunswick.

Miss Taylor, Vice-President Archdeaconry of Albany, told the Convention what the Blue Ridge Conference had meant to her.

Mrs. Biller explained the work, object and method of the Church Periodical Club.

It was moved and carried that the President appoint a Secretary for the Church Periodical Club for the Diocese

of Georgia, and Mrs. George W. Chapman, of Savannah, was appointed.

Mrs. Biller then gave the closing address.

The thanks of the Convention were extended to the ladies of the Church of the Good Shepherd for the hospitality shown, and to Mrs. Biller and Rev. Thomas Ludlow for the great spiritual help that had come to all through their presence.

The President urged every branch to try and make a canvass for new members during the coming year.

The Convention adjourned to the church, where a quiet hour was observed with prayers and an address by the Rev. William Johnson, after which the meeting adjourned.

PRESIDENT'S ADDRESS

Swiftly the days of another year have passed and finds us with reports gathered up, ready to hear what we have done and now stand ready to do for the coming of Christ's Kingdom upon earth. We are for the first time trying the plan of having the annual meeting of the Woman's Auxiliary to the Board of Missions entirely separate from the Convention. We are indeed sorry that some wives of our clergy could not be present who were always at the meeting under the old plan, and there are some other reasons, too, why we are sorry not to meet at the time of the Convention; but the one advantage of meeting in our small parishes, not to speak of some others, seems to some of us at least, sufficient for trying this plan well, knowing that if it works to no special advantage, we can easily go back to the old custom of meeting at the time of our Diocesan Convention. This gives the opportunity of testing in our own work, whether or not we can say with Miss Emery, that "life is change and change is life"; and so, if on the whole this change proves good, our work will gain new life therefrom.

As your new President over the past year's work, I want to thank you, first, for your prayers, for immediately I felt that they sustained me wonderfully under the strain of those first weeks, when I so keenly felt my inadequacy for the office laid upon me, and then for your hearty coöperation in the work I have tried to do. If my duties have been filled at all satisfactorily to the Georgia Branch, attribute it as an answer to your prayers and the advice and guidance of our honorary president, Mrs. W. H. Elliott.

We have felt a wave of inspiration through our delegates to the great Triennial of 1916. I am truly sorry that illness and circumstances prevent two of them from giving their interesting reports at this meeting. However, I am glad to state that we had our full quota of five to represent the Georgia Branch last October at St. Louis. We heard much

about growth, unity, social work, brotherhood, coöperation, etc., but above and beyond them all we heard about the present necessity for prayer,—how it is our only weapon of defense against the devil, the only way of communing with our God and the great source of power waiting for each of us to make daily use of. Have we passed it by many days during the past year because we let ourselves be blinded with the crowding wants and interests of life, deafened to its tender call because of the many other sounds clamoring? If any of us have, then let us determine from this day forth that we will, by the grace of God, let nothing interfere with, or keep us from, our special noonday prayers.

I cannot refrain from speaking of the great pleasure and profit I derived from visiting twenty-two branches of the Auxiliary in our Diocese during the past few months. Everywhere I was most cordially welcomed and our women and clergy coöperated in every possible way to afford me the chance I craved, that of speaking to our women, in a heart-to-heart way, about the work pressing upon us now.

For fear of crowding too many things upon your minds then I did not speak of the importance of attending a Summer Institute. Your Educational Secretary will urge that upon you later with all her heart, but I must say a word about it, too. If you really mean to do all that you can in Auxiliary work and feel a need of information and inspiration, go to Blue Ridge, or some other; and if you can't go yourself persuade, or help, someone else, especially a Junior, to go.

An entirely new department of work was set before us this year, in that we had a week assigned the Georgia Diocese to pray for several special objects, besides any others that might lie close to us. The Pilgrimage of Prayer began with Maine and New Hampshire the first week in December and will go right on energizing Diocese after Diocese of our whole Church until it ends with all the Auxiliaries, *then* the Church the last week in November. A whole year of prayer for the great issues of our present life! What might it not mean! One of our Bishops, commenting upon it, said: "Each Diocese should be converted to prayer as a result of

such exercise." I hope that each branch in our Diocese heeded this call to prayer and kept the trust regularly each day in their homes, if they could not meet in their churches. We cannot walk with God unless we are in accord with Him; and where can we better learn His will concerning us than on our knees?

My friends and co-laborers, we, as you well know, are now facing momentous days in the history of our country; truly "no man knoweth what a day may bring forth," and perhaps we feel our helplessness as never before; we know our stronghold and doubtless will be daily "lifting our eyes unto the Hills from whence cometh our help." In the days that are to come, I ask one thing of you—"sit steady in your boat." Bishop Tuttle said at the great Triennial that the chief message he wanted to give us was obedience, as most necessary to gain victory, and by it alone could we hope to save ourselves, or help save others; therefore we must stay in the lifeboat, whether or not we thought it expedient. And so, I beg you to keep right on in the work that has been assigned you or that you have chosen for yourselves, and because of the strenuous times in which we are living, be more diligent, more painstaking, self-sacrificing and more exacting of yourselves this coming year than last. Some may be wondering about the giving even now. We should not be discouraged, when we remember that England has given more to missions since the war than before. These lines might help you, as they have helped many others:

One by one thy duties wait thee,
Let thy whole strength go to each;
Let no future dreams elate thee,
Learn thou first what these can teach.

Bishop Tucker of Kyoto, Japan, says that we must not forget that we are not only auxiliary to the Board of Missions, but also auxiliary to Christ. Might we not try to realize that amazing truth? God grant that we will pray, work, and give to missions as never before.

REPORT OF EDUCATIONAL SECRETARY

I am glad to report that we have made much progress in educational work this year. I do not believe there is a single branch in the Diocese still asleep. They at least have one eye open. The most encouraging feature of the year's work is the personal work of so many people.

Our first step towards progress was made when the Auxiliary sent Miss Susie Taylor, of the Albany Archdeaconry, as a delegate to Blue Ridge. We have not been disappointed in her work. Her Archdeaconry has done splendidly. Out of eleven branches eight have study classes, and, but for delay in getting books, two more would have had them. The branch at Albany had five classes.

Hearing that Rev. Mr. Moore had been appointed General Field Secretary, I asked him to come to our Diocese and help us. He agreed to give us three weeks. He arranged with Rev. Mr. Patton to go to Brunswick, and he also went to Thomasville, Albany, Cordele and the Church of the Good Shepherd. The clergy of these places write me that great work was done by them along educational lines and much interest aroused in Missions, and there were excellent assets. As near as I can estimate, between \$1,500 and \$2,000 was raised for Missions as a result of their work.

Much credit is due our President. I asked her to talk up study classes and programme meetings. She fairly set the woods afire with answers to letters I had written three months before, and requests for leaflets and books came pouring in.

At the request of the Bishop I wrote every clergyman in the Diocese, asking them to coöperate with the women of the Auxiliary in making the Pilgrimage of Prayer a success. They were most responsive, and of the branches re-

porting only one failed to observe the week of prayer. A few of the branches have not been heard from.

We are indebted to the Auxiliary Church, and Miss Cuthbert in particular, for the leaflet on "Pilgrimage of Prayer."

We have had twenty-classes; one hundred and seventy-six women.

Thomasville class gave \$5 and Augusta \$15 in response to Mr. Gray, the Educational Secretary, for Bishop Colmore's work at El Cato.

REPORT OF SECRETARY OF BOXES

During the past year the Woman's Auxiliary of the Diocese of Georgia reports the sending out of thirty-six missionary boxes at a total valuation of \$883.95. Of these boxes twenty-five were sent by the Woman's Auxiliary, ten by the Juniors and one by the Little Helpers.

The boxes went to the following missions: 1 to an Indian Catechist at Standing Rock Mission, South Dakota; 4 to St. Raphael's Home, Monterey, Tenn.; 1 to the Anson Dodge Home; 3 to Morgantown, N. C., for hospital workers; 3 to the Appleton Church Home, Macon, Ga.; 1 to St. Paul's School, Beaufort, N. C.; 1 to Rev. R. T. Lassiter's Mission, Asheville, N. C.; 2 to La Grange Settlement, La Grange, Ga.; 1 to Mrs. Griffin's Mission, West Carolina; 1 to Mrs. Parker, Ceylon, Ga.; 4 to Mrs. Wetmore, Arden, N. C.; 1 to Missionary at Missella Park, N. Mex.; 1 to Father Harrison, St. Andrew's School, Sewanee, Tenn.; 1 to a mountain school, Samda, N. C.; 2 to Georgia clergyman's widow; 4 to St. Mary's-on-the-Mountain,

Sewanee, Tenn.; 2 to Deaconess Lands, Graniteville, N. C.; 1 to Edneyville, N. C.; 1 to Valle Crucis, N. C.; 1 to Epiphany Mission, Sherwood, Tenn.; 1 to a Georgia missionary.

Of the Little Helpers, the only branch to report was St. Paul's, Albany. They sent their first box work to the kindergarten department of La Grange School. We deeply regret that those Little Helpers who did such wonderful work in the past two years seem to have lost interest, as they have not asked for work through the Box Secretary, nor report having done any this year.

I have written eighty-four letters and nineteen postal cards this year.

Miss Emery especially urged the Woman's Auxiliary of the Diocese of Georgia to work this year for La Grange Settlement, for the Missionary to the Dakota Indians and his helpers, and for the Rev. Mr. Lassiter's missions in Burke County, N. C. She said it is so much better to send good boxes to three centers like these than a number of small boxes to several stations. I asked for boxes for these three centers only this year, but from the numerous stations to which the boxes have gone it is evident the "personal appeals" receive most attention, it spite of Miss Emery's wishes. Conditions vary so in the different parishes that it is almost impossible to arrive at a satisfactory solution of the problem, but I hope between now and our next meeting to evolve some plan to obviate this difficulty, and will be glad to hear from any of the Leaders on the subject.

Since our last meeting Cordele has organized a Branch, with Mrs. F. L. Bartholomew as Leader. Mrs. James H. Davis is Leader in St. Paul's Church, Albany; Mrs. H. B. Allen has taken Miss Taylor's place as Leader in Calvary Church, Americus, and Mrs. E. C. Waller has the Leadership in the Church of the Good Shepherd, Augusta. To each one we extend a hearty welcome; and may I ask each of you to add to your petitions the Prayer of the Little Helpers—"God bless all the Missionaries all over the world and all the Little Helpers, for Jesus' sake. Amen."

THE CONSTITUTION

ARTICLE I

This association shall be called the Georgia Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II

The object of this association shall be to help the Board of Missions, by praying for Missions, studying Missions, and giving to Missions.

ARTICLE III

All baptized women and children of this Diocese shall be regarded as members.

ARTICLE IV

SECTION 1. There shall be a President, four Vice-Presidents (one from each Archdeaconry), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Offering, Educational Secretary, Secretary of Boxes, Secretary of Spirit of Missions, President of the Junior Department, and President of Little Helpers.

SEC. 2. These officers shall constitute the Executive Board.

ARTICLE V

Election of Officers

SECTION 1. All officers shall be elected at the Annual Meeting, and be eligible for three consecutive years to the same office.

SEC. 2. Each branch shall be entitled to one vote, provided a delegate from that branch be present.

SEC. 3. Delegates to the General Convention and to the Annual Meetings of the Synod shall be nominated and elected from the floor.

SEC. 4. Should a vacancy occur in the President's office the Bishop shall appoint someone for the unexpired term.

SEC. 5. Should a vacancy occur in any of the other offices the President shall appoint someone for the unexpired term.

BY-LAWS

ARTICLE I

Duties of Officers

SECTION 1. The President shall preside at all Annual Conventions and Executive Meetings, and shall have the general supervision of the work of the Branch.

SEC. 2. The Vice-Presidents shall have the general supervision of the Archdeaconry to which they belong, and, when requested by the President, may act for her.

SEC. 3. The Recording Secretary shall keep the minutes of the Annual Convention and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report.

SEC. 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

SEC. 5. The Treasurer shall receive and disburse all the money contributions, except the United Offering, and shall make an annual report of same.

SEC. 6. The Custodian of the United Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

SEC. 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She shall endeavor to form a Mission Study Class in every Parish and Mission, and shall have charge of and distribute the literature issued by the Educational Department of the Board of Missions.

SEC. 8. The President of the Junior Department shall guide the work of the Juniors.

SEC. 9. The President of the Little Helpers shall correspond with Parish Presidents, distribute the red barrels, collect their contents, and remit said contents to the Diocesan Treasurer.

ARTICLE II

Meetings

SECTION 1. There shall be an Annual Convention in the spring of the year, the date to be appointed by the Bishop.

SEC. 2. There shall be, if possible, an annual meeting of each Archdeaconry.

SEC. 3. There shall be, if possible, an annual meeting of the Executive Board.

ARTICLE III

Expense Fund

Disbursement of the Expense Fund shall be left to the discretion of the President and two other officers of the Executive Board selected by her.

ARTICLE IV

The fiscal year shall be from Annual Meeting to Annual Meeting.
