Pay all other Pledges by December 31st.



## MINUTES

### FIRST DAY

Wednesday, May 14th, 1919, 9 A. M.

The Twenty-seventh Annual Meeting of the Georgia Branch of the Woman's Auxiliary convened at Grace Church, Waycross, on Wednesday morning, May 14th, 1919, at 9 o'clock.

The meeting opened with a celebration of the Holy Communion by the Rt. Rev. F. F. Reese, D. D., assisted by Rev. R. N. MacCallum, Rector of Grace Church. The offering was devoted to the United Offering.

At the conclusion of the service, each delegate present registered her name and address.

The business meeting of the Auxiliary then followed with Mrs. A. B. Hull, of Savannah, Diocesan President, presiding. The meeting was opened by the singing of Hymn 261, followed by prayer by Mr. MacCallum. Bishop Reese then made his annual address, making an earnest appeal to the representatives of different Auxiliaries present, to become more inspired with the mission spirit, and to take home with them the inspiration to do nobler and greater things in their work than ever before. Mr. MacCallum followed with a few appropriate words of welcome.

In the absence of the Secretary, Mrs. Harrison Watts was requested to act as Secretary for the meeting.

Mrs. Harry D. Reed, President of the Local Branch, extended a cordial welcome to the visitors, to which Miss Mary C. Cuthbert of Augusta, responded in a few beautiful words. Mrs. A. B. Hull, as President, then delivered her annual address.

The roll of delegates was called by the Secretary, and the following Churches were represented as follows:

Mrs. W. H. DeVoe read her Treasurer's report for 1918, showing collections \$932.98 and disbursements \$845.10, leaving balance in bank of \$87.88.

The annual report of Mrs. Edward C. Blount, as Custodian of United Offering for 1918, was read by Secretary. Report showed amount on hand, account United Offering, \$1,029.54, for the three years from Triennial to Triennial.

Report from Program Committee was read by Chairman, Miss Eugenia M. Johnston. Miss Johnston stated that the programs were really the work of Mrs. Thomas Screven Bond, and Mrs. Bond was given a rising vote of thanks, and Secretary was instructed to write Mrs. Bond a letter of thanks for her kindness.

The President appointed two Committees—a Nominating Committee, composed of Mrs. F. F. Reese, Mrs. Henry C. Brown, Mrs. J. P. Stewart, Mrs. A. V. Wood and Mrs. A. J. Cobb, and a Resolution of Thanks Committee, with Mrs. James Davenport as Chairman, and Mrs. F. D. Fant assisting.

Miss Mary C. Cuthbert, President of the Junior Auxiliary, read her report for 1918, showing nine (9) months' work. She reported a cash total of \$117.60 collected for the year, and five (5) boxes sent to missions. She read a letter she had sent out to Junior Auxiliaries, urging Sunday Schools to co-ordinate with the Junior Auxiliary. A rising vote of thanks was given Miss Cuthbert for her faithfulness and efficiency in her work.

Mrs. A. H. Hilsman, Educational Secretary, read her report for 1918, and gave several valuable suggestions for Auxiliaries to carry out should they so desire, in their work at home.

A message of sympathy from the Auxiliary was sent Mrs. W. H. Elliott on the death of her husband; and a message of regret to Mrs. J. K. McIver, as she was unable to meet with the Convention.

At noon a few minutes were spent in prayer, and at 1:30 p. m. the meeting adjourned until three o'clock.

Wednesday, May 14th, 3 P. M.

The afternoon session was opened with prayer by the President.

Report of Mrs. G. W. Chapman, Secretary of Church Periodical Club, was read by Secretary.

Report of Miss Marie G. Beaufort, President of Little Helpers, was read by Secretary. Report showed \$32.20 collected, and \$32.20 spent during the year.

Report from Mrs. I. A. Sims, Secretary Spirit of Missions, was read by Miss Eugenia M. Johnston.

Miss Eugenia M. Johnston spoke for a few moments regarding conditions of Clergy House, at Saluda, N. C. She asked that it be renovated. The President appointed a committee to look into the matter, with Mrs. F. D. Fant, Chairman, assisted by Miss A. A. Nichols.

The President read a letter from Miss Grace Lindley, General Secretary to the Board of Missions, New York, in regard to Triennial of Woman's Auxiliary, which meets at Detroit, Mich., October 8th to 21st, 1919.

Mrs. W. H. DeVoe read Constitution and By-Laws of the Auxiliary, for the information of the delegates present.

The President then retired from the chair, in favor of Miss Mary C. Cuthbert, who, as President of the Junior Auxiliary, then conducted the meeting for the Juniors. Several of the local Junior Auxiliary girls with their Directress, Mrs. J. P. Stewart, were present at the meeting, and pledged to send Christmas presents to five (5) children at Saluda, N. C.

Miss Cuthbert read a letter from Rev. W. B. Allen, Rector of the Mission of the Church of the Transfiguration, at Saluda, N. C. Miss Cuthbert then addressed the Juniors present on the subject of the co-ordination of the Junior Auxiliary with the Sunday Schools, which closed the session of the Junior Branch of the Auxiliary.

The session of the Auxiliary was again resumed, the President presiding. Letter from Miss Marie G. Beaufort was read by Miss Mary C. Cuthbert.

Mrs. A. H. Hilsman was asked for her report on St. Agnes School, Kyoto, Japan. Mrs. Hilsman replied that she had considered the matter closed, as the school had been completed, but reported a check for \$54.85, which she had received, and sent to the Treasurer.

Miss Eugenia M. Johnston, as Vice-President, read her report of the Savannah District.

Report from Mrs. J. F. Bransford, Vice-President of the Augusta District, was read by Secretary.

Report from Miss Lula C. Colesberry, Vice-President of the Brunswick District, was read by Mrs. A. V. Wood.

The meeting closed for the afternoon, with the singing of the Doxology.

At 8:30 p. m., the Convention reassembled, and heard a splendid and most helpful address from Rev. John D. Wing, of Christ Church, Savannah.

SECOND DAY

Thursday, May 15th.

The Holy Communion was celebrated at Grace Church at 8:00 a. m. by Rev. R. N. MacCallum.

At 9:30 a. m., the business session was again resumed, the meeting being opened with prayer by Rev. R. N. MacCallum.

The minutes of Wednesday's meetings were read, corrected and approved.

Telegrams in response to messages sent on previous day to Mrs. W. H. Elliott and Mrs. J. K. McIver, were read by Mrs. W. H. DeVoe.

United Offering of \$30.30 for the three services was reported by Mrs. W. H. DeVoe.

Miss Eugenia M. Johnston, as Chairman, then read report of Committee on Amendments to Constitution, a few minor changes being made.

The President then asked Mrs. F. F. Reese, as Chairman of Nominating Committee, to make report. Officers were elected as follows:

The Convention gave the Nominating Committee a rising vote of thanks, and all remarked on the spirit of unity and concord that had marked all the proceedings of the meeting.

The President then read Resolutions Governing Delegates to Triennial, which convenes at Detroit, Mich., October 8th to 21st, 1919; the Diocese being allowed five (5) delegates. The President and President of Junior Auxiliary, being two of the five delegates.

The following delegates were elected: Mrs. A. B. Hull, Miss Mary C. Cuthbert, Mrs. F. F. Reese, Mrs. J. P. Stewart and Mrs. W. N. Pratt. Alternates: Miss Eugenia M. Johnston, Mrs. F. D. Fant, Mrs. A. V. Wood, Mrs. F. C. Exley, Mrs. A. H. Hilsman.

Miss Mary C. Cuthbert made a brief but pathetic report on the Boys Home in Augusta; the name of which has been changed to "Church of the Good Shepherd Home for Boys," as that Church owns it now. As a result of her talk, several pledges were made for the support of the school.

Pledges for next year were then taken; but as many of the delegates had returned home, many churches were not represented.

Discussion came up as to the women's wish, relative to women being put on the Board of Missions in New York; only one woman from each of the eight (8) Provinces of the Church serving at the same time. Mrs. F. C. Exley made the motion, seconded by Mrs. W. N. Pratt—

*"Resolved*, That the Woman's Auxiliary of the Diocese of Georgia, in Convention assembled at Waycross, Ga., May 14-15, 1919, instruct their delegates to Triennial at Detroit, Mich., to vote for the appointment of women members on the Board

of Missions, provided that this representation include a woman from each Province of the Church in the United States."

An overwhelming majority voted in favor of the motion.

It was decided that the Auxiliary wait until next year to decide as to the advisability of holding Convention at same time and place as Church Convention.

It was decided that a sufficient number of Annual Reports be printed to send a copy to each President and Secretary of every Branch in the Diocese.

Mrs. F. D. Fant then read Resolution of Thanks to the Bishop for his helpful address, and the inspiration of his presence; to Mr. Wing, for his message encouraging us to greater missionary zeal; to Mr. MacCallum, for his warm welcome and splendid service; to Grace Church and citizens of Waycross, for hospitality and kindness, and to Mrs. Harrison Watts, for her work as Secretary.

On motion, the time and place for the next annual meeting was left in the hands of the Bishop and the President of the Auxiliary.

There being no further business, the meeting closed with an inspiring address, the theme being "O, Zion, Haste Thy Mission Now Fulfilling," by Rev. J. D. Wing, with Benediction by the Bishop and the singing of the Doxology and the meeting was then declared adjourned.

## PRESIDENT'S ADDRESS

### *Members of the Woman's Auxiliary:*

Dear Friends:—When I met with you in Bainbridge last April, I little thought it would fall to my lot to act as President of the Woman's Auxiliary during the following year. Mrs. McIver's state of health, which prevents her being here today, made it necessary for her to lay down the work for which she was so eminently fitted.

At her request and our Bishop's, I took it up, and have tried, with their help to carry it on since. The last year was a trying one for us all, and I feel that perhaps under the circumstances we have done the best we could, but I am sure none of us feel satisfied with our reports. The workers at the Church Missions House, in New York, have planned so many forward movements, that I feel particularly our limitations in their eyes. The work before us for the coming year looms large, and if we are to meet our obligations, the three special lines of the Auxiliary must become a part of our daily life, namely:

- To pray for Missions;
- To study about Missions, and
- To work for and give to Missions.

The nation-wide campaign planned by the Board of Missions, and led by Dr. Patton, will show us our duty clearly. They will say to us, "This is the way—walk ye in it," and leave the choice in our own hands.

Bishop Lloyd, preaching at St. Paul's Church, Savannah, the second Sunday after Easter, said they would not ask for one penny, just place before every congregation in America the situation, and then under God, leave the matter in each individual's hands. May God give us grace and strength to measure up to our opportunities!

The change in the fiscal year of the Church has caused much confusion. It was difficult for me to advise you how to make up your reports. Finally after consultation with Bishop Reese, I sent out my last letter to each Branch. This may

have reached you too late to have complied with its requests; but I will ask you to make the reports up to date before we get out our Annual Report.

One aspect of our work, I trust you will forgive my stressing. It is, that we acquaint outsiders more thoroughly with the work of the Church and of her missionary endeavor. The only way to be interested in anything is to know about it. Therefore I urge upon you the reading of Church papers. As members of the Woman's Auxiliary, we are expected to subscribe to and read our own special magazine, "The Spirit of Missions." Failing in this, we can not understand our own object.

The Church Periodical Club is a wonderful agency to disseminate knowledge by passing on your magazines after reading, to some Mission, or person really unable to invest any amount in Church papers, which they crave so much. We did this for the soldiers during the war, so why not keep it up for our Missionaries, who are always on the firing line of civilization?

In my year as your President the work has become very vital to me, and I only wish it were in my power to give it the undivided time and attention it requires. Many conflicting duties have prevented this, and I trust in choosing my successor you will find the right woman for the place. Not one who will love or be more interested in the Diocese, but one who can and will give it the absorbing study and thought it requires.

Miss Lindley, at the Missions House leads the way, but we at this end should have almost as much time and thought to give to the problem as she does.

In conclusion will you let me say I hope it will be possible for us to have Miss Tillotson hold an Institute in the Diocese before another Convention. We had her for just one meeting in Savannah, during March, and the value of this meeting was very great. If we could have her visit some central point, and many branches take advantage of the opportunity to attend

this Institute, I think we would find the increased knowledge would give an impetus to our interest which would show in another year's work.

So hoping you will excuse my many shortcomings of the past year, and find a worthy successor to Mrs. McIver, I wish you Godspeed for the coming year.

REPORT OF RECORDING AND CORRESPONDING  
SECRETARY

As Corresponding and Recording Secretary of the Woman's Auxiliary, Diocese of Georgia, I beg to hand you herewith my report of work done during the past year.

My first work was a circular letter written by our new President, Mrs. A. B. Hull, who was appointed by the Bishop to fill the unexpired term of Mrs. John K. McIver. This letter was sent to the President of each Branch in the Diocese, also to the Diocesan officers, urging their prayers and co-operation in all work undertaken for missions during the coming year.

The next work was getting together the material for the Report of the Twenty-sixth Annual Meeting, which was published in book form. One hundred copies were made, and one sent to the President of each Branch in the Diocese; also to the Diocesan officers.

A few weeks prior to the Annual Meeting a circular letter was sent out by the President to all Branches, calling their attention to the approaching meeting, and urging each Branch to be represented by at least two women.

A program for the Annual Meeting was arranged, thirty-two copies being made.

About thirty-five letters pertaining to the work of the Woman's Auxiliary in our own Diocese and elsewhere were answered during the year.

ANNUAL REPORT OF EDUCATIONAL SECRETARY  
OF DIOCESE OF GEORGIA

My report is necessarily brief, owing to the fact that it has so few tangible features.

I have written three times to every branch of the Woman's Auxiliary, except the ones not reported last year, and I have sent sets of pamphlets to each branch three times, besides innumerable letters to individuals, in the interest of educational matters. We have all been disappointed that no one has been able to come to us, as we expected, in educational interest. Miss Tillotson made a short trip to Savannah. There have been many reasons why we could not procure them this year; influenza, other engagements, great distance, etc. There have been only about three Study Classes and three Reading Circles to report in this Diocese.

## SUGGESTIONS

I do not believe it will be out of place for me to make some suggestions that I believe will yield better results than have been sometimes procured in the past. No few letters have come to me this past year, asking me to offer suggestions for increasing the interest in their individual branches of the Woman's Auxiliary. These I have answered as best I could. In one branch, I have learned from personal observation, that very few of us know much of the workings of the Woman's Auxiliary. For this reason, I believe the women as a rule are so loath to accept office. Are we on a common working basis? When a business firm operates from a central or home office, are not the branch offices all run more or less alike?

The following points I would like for you to consider:

1. That the election of the officers in each branch take place the same day, and that the names of newly elected officers be immediately reported by the outgoing Secretary to the several Diocesan officers.

2. That the number of meetings each year be not less than twelve. In the summer months, if preferred, they may be more of a social nature, and at private homes.
3. That the meetings be planned as follows, insofar as it is possible: Eight (8) Program Meetings, two (2) United Offering Meetings (these to occur at the meetings preceding the collection of the U. O. the last of March and last of September) and these to be presided over by the United Offering Custodian. One meeting for the report of the Annual Meeting of the Diocesan W. A., and one (1) Social Meeting, to which are invited all of the church women; and an address given on Missions (preferably by the Rector) and all women who are not members urged to join.
4. That the officers have put before them clearly and simply their respective duties, and that each retiring officer consider it her duty to inform, instruct and constantly encourage her successor in office.
5. That some plan be formulated whereby the several branches within the Diocese derive immediate and practical benefit from the experience of the Blue Ridge delegate.
6. That the rule prescribing that no boxes be sent without having information from the Box Secretary, and following her direction, be strictly lived up to. (A suggestion:—Send two (2) boxes a year; one at Thanksgiving, and one at Easter; the latter to consist of garments made by the women during Lent, the other church women helping, adds so much to a much needed get-together spirit.)
7. That the office of Educational Secretary and Chairman of Program Committee be combined, and this officer feel the responsibility of energetically forwarding the formation of study classes; and those not attending the classes be urged to read the book. The leader should be procured in the early fall, and the approved study book for that year ordered for the leader. And the books for the class be ordered in due time, so there will be no delay in starting classes for Lent.

8. That every officer of every branch be sent an Annual Report of the W. A., and let each Treasurer of each branch be furnished with a report blank, ideally made out so that she may pin this in her book, and find no trouble in sending in her financial report.

The Treasurer should keep one page each year for pledges, amounts and dates, by which each should be sent in. Let the Treasurer keep every bank slip, every receipt, and by all means, give printed receipts for Auxiliary dues paid to her. It is wise for her to put down in her books the amounts of U. O. collected, and dates that they are sent to Custodian of the United Offering of the Diocese.

This shows an apparent falling off from last year; but when the abbreviated year is taken into consideration, and also the fact that there are only seven (7) branches reporting active work, as against eight (8) last year, and that two pledges of one of the branches did not fall due until after January 1st, 1919, and therefore can not appear on this report—the net result is about the same, if not, indeed, a slight increase on last year.

Of course the work has been seriously hindered, as has that of all organizations, by the influenza conditions.

The efforts of the Junior President have been directed toward the plan for the co-ordination of the Junior Auxiliary and the Sunday School; and a circular letter, accompanied by a personal one, has been sent to every member of the Clergy in the Diocese, outlining a simple form of the plan. Results are beginning to come in; and this year should see it well established.

The amount apportioned to the Junior Auxiliary in this Diocese is \$100.00 (One Hundred Dollars). Specials do not count upon this, and the sum of \$8.50 per branch, for General Missions was fixed upon us the first year of the divided Diocese, when there were twelve (12) branches, in order to cover this apportionment.

## THE CONSTITUTION

### ARTICLE I.

This association shall be called the Georgia Branch of the Woman's Auxiliary to the Board of Missions.

### ARTICLE II.

The object of this association shall be to help the Board of Missions by praying for Missions, studying Missions and giving to Missions.

### ARTICLE III.

All baptized women and children of this Diocese shall be regarded as members.

### ARTICLE IV.

Section 1. There shall be a President, four Vice-Presidents (one from each District), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Offering, Educational Secretary, Secretary of Boxes, Secretary of Spirit of Missions, President of the Junior Department and President of Little Helpers.

Sec. 2. These officers shall constitute the Executive Board.

### ARTICLE V. Election of Officers.

Section 1. All officers shall be elected at the Annual Meeting, and be eligible for three consecutive years to the same office.

Sec. 2. Each branch shall be entitled to one vote, provided a delegate from that branch be present.

Sec. 3. The Nominating Committee shall report at second session of first day; the elections to follow immediately.

Sec. 4. Delegates to the General Convention and to the Annual Meetings of the Synod shall be nominated and elected from the floor.

Sec. 5. Should a vacancy occur in the President's office the Bishop shall appoint some one for the unexpired term.

Sec. 6. Should a vacancy occur in any of the other offices the President shall appoint some one for the unexpired term.

## BY-LAWS

### ARTICLE I. Duties of Officers.

Section 1. The President shall preside at all Annual Conventions and Executive Meetings, and shall have the general supervision of the work of the Branch.

Sec. 2. The Vice-Presidents shall have the general supervision of the District to which they belong, and when requested by the President, may act for her.

Sec. 3. The Recording Secretary shall keep the minutes of the Annual Convention and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report.

Sec. 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

Sec. 5. The Treasurer shall receive and disburse all the money, contributions, except the United Offering, and shall make an annual report of same.

Sec. 6. The Custodian of the United Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

Sec. 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She shall endeavor to form a Mission Study Class in every Parish and Mission, and shall have charge of and distribute the literature issued by the Educational Department of the Board of Missions.

Sec. 8. The President of the Junior Department shall guide the work of the Juniors.

Sec. 9. The President of the Little Helpers shall correspond with Parish Presidents, distribute the red barrels, collect their contents, and remit said contents to the Diocesan Treasurer.

### ARTICLE II. Meetings.

Section 1. There shall be an Annual Convention in the spring of the year, the date to be appointed by the Bishop.

Sec. 2. There shall be, if possible, an annual meeting of each District.

Sec. 3. There shall be, if possible, an annual meeting of the Executive Board.

ARTICLE III.  
Expense Fund.

Disbursement of the Expense Fund shall be left to the discretion of the President and two other officers of the Executive Board, selected by her.
