MINUTES

FIRST DAY

Wednesday, April 21, 1920.

The twenty-eighth Annual Meeting of the Georgia Branch of the Woman's Auxiliary convened at St. Thomas's Church, Thomasville, on Wednesday morning, April 21, 1920, at ten o'clock. The meeting opened with a celebration of the Holy Communion by the Rt. Rev. F. F. Reese, D.D., assisted by Rev. W. H. Higgins, followed by a short talk by Bishop Reese on "Service," the keynote of the Christian life. The offering was devoted to the United Thank Offering.

At the conclusion of the service, the delegates assembled in the Parish Hall for their conference. The meeting was opened with prayer by Rev. W. H. Higgins, who, as Rector of the Parish, welcomed the visiting delegates. Bishop Reese then spoke on conditions in the Church at present, and asked that the Woman's Auxiliary go on with its regular work for the coming year, keeping up pledges and scholarships as heretofore. He asked that the President appoint a Committee to confer with him sometime during the coming year; to look thoroughly into the matter of the Church Service League, which has succeeded the Woman's Auxiliary in many Dioceses, and to see if the plan would be feasible in so small a Diocese as the Diocese of Georgia.

The meeting was then called to order by the President, Mrs. A. B. Hull, of Savannah. Miss S. M. Woodson, representing the local branch of the Auxiliary, welcomed the visitors with a few appropriate words of greeting, followed by response by Miss Sussie C. Taylor, of Americus.

The President, Mrs. A. B. Hull, gave the annual address, which is printed on another page.

This Report was accepted with thanks.

There was no report of Committee on Offering of Life.

The President then appointed two Committees: The Nominating Committee, composed of Mrs. F. F. Reese, Savannah; Mrs. N. W. Grimes, Albany; Mrs. G. Sherwood Whitney, Augusta; Mrs. J. S. Wright, Brunswick; Mrs. F. C. Exley, Savannah; and the Resolution of Thanks Committee, composed of Miss Susie C. Taylor, Americus, and Mrs. Harry D. Reed, Waycross.

Report of Custodian of United Thank Offering was read by Miss Susie C. Taylor. This Report showed \$21.15 for the last two months of 1919. Miss Taylor also read Mrs. E. C. Blount's (former Custodian) Report for Triennial, which showed that the Woman's Auxiliary of the Diocese of Georgia, sent to Detroit \$2,052.13.

There was no Report from President of Junior Auxiliary.

There was no Report from Little Helpers' Branch.

Mrs. A. H. Hilsman, Educational Secretary, then gave a most interesting and encouraging report of her work for 1919.

A letter was read from Bisop P. T. Rowe, of Alaska, regarding the abolishment of the canneries located at the mouth of the Yukon River, which canneries have almost exterminated the natives, as fish is their principal article of food. After discussion, motion was made and carried as follows:

"Resolved, That the Georgia Branch of the Woman's Auxiliary to the Presiding Bishop and Council in Convention assembled in Thomasville, Ga., April 21st, 1920, wishes to go on record as endorsing Bishop P. T. Rowe's

letter, relative to the bill now before Congress, in regard to the stopping of the mouth of the Yukon River by the salmon canneries; and that an official letter be sent to our Congressmen, asking their aid and influence in having this bill passed."

Report of Corresponding Secretary was then read; also her letter of resignation. It was moved and carried, that, as Mrs. Bond cannot be persuaded to accept the office another year, her resignation be accepted with profound regret, and with many thanks for her splendid work as Corresponding Secretary.

The Convention then adjourned for luncheon, served by St. Thomas Womna's Auxiliary, at the home of Mrs. J. H. Merrill.

3:00 P. M.

After a beautiful luncheon served at the home of Mrs. J. H. Merrill, the meeting again assembled in the Parish Hall of St. Thomas's Church, Wednesday afternoon, at 3 o'clock, for the afternoon session. The meeting was opened with prayer by the President.

The minutes of a called meeting of the Executive Board, January 31st, 1920, at the home of the President, in Savannah, were read and approved, and are printed on another page.

Miss Edith Johnston, Publicity Director of the Diocese, spoke for a few minutes about the work she represents, and urged that all Church women read Church papers, that they may acquaint themselves more fully with the affairs of their Church.

Report of Secretary of Spirit of Missions was read by Secretary.

Chairman of Nominating Committee gave Report of Committee. The report was accepted by the Conference, and the following officers elected for 1920:

Chairman of Committee on Amendments to Constitution and By-Laws, Miss Eugenia M. Johnston, recommended certain changes in the wording of several articles of the Constitution and By-Laws, as follows:

Wherever the words "Board of Missions" appear, to be changed to read "Presiding Bishop and Council."

Wherever the words "United Offering" appear, to be changed to read "United Thank Offering."

The Constitution, Article III, read: "All baptized women and children of this Diocese shall be regarded as members." This Article to read: "All baptized women of this Diocese are eligible for membership."

The By-Laws, Article II, Section 3, reads: "There shall be, if possible, an annual meeting of the Executive Board." Be changed to read: "Sec. 3. There shall be an annual meeting of the Executive Board preceding the Annual Convention."

The By-Laws, Article V, reads as follows: "The Constitution can be changed at any Annual Convention by a two-thirds vote of the delegates present." This Article to read: "The Constitution and By-Laws can be changed at any Annual Convention by a two-thirds vote of the delegates present, and voting."

Which recommendations were adopted by the Convention.

The President then appointed Committee on Reorganized Box Work for the Auxiliary, composed of Mrs. W. N. Pratt, Savannah; Mrs. W. L. Ball, Thomasville; and Mrs. R. E. Trexler, Waycross.

Report of District of Albany was read by Vice-President Miss Susie C. Taylor.

Report of District of Augusta was read by Mrs. G. Sherwood Whitney.

Report of District of Savannah was read by Miss Eugenia M. Johnston, Vice-President.

Report of Box Secretary, Mrs. E. C. Blount, showing for last three months of 1919, nine (9) boxes and 1 check (value \$4.00), valuing \$712.04, sent to Missions was read by Secretary.

Mrs. J. S. Wright, in behalf of St. Mark's Parish, invited the Woman's Auxiliary to meet in Brunswick for its 1921 Conference. The invitation was accepted with much pleasure.

Upon motion it was decided to send telegrams of greetings from the Convention to Mrs. W. H. Elliott and Mrs. J. K. McIver.

With the singing of the Doxology the meeting adjourned and an automobile ride through the different beautiful estates near the city was then enjoyed.

At 8:30 P. M., Rev. John Moore Walker, of St. Paul's Church, Albany, delivered a most helpful address on the subject of Missions to a large and appreciative audience.

SECOND DAY

Thursday, April 22, 1920.

The Holy Communion was celebrated at St. Thomas's Church, at 8:00 A. M., by Rt. Rev. F. F. Reese, D.D., assisted by Rev. W. H. Higgins.

At ten o'clock, the business session was again resumed, the meeting being opened with prayer by the President. The minutes of Wednesday's meetings were read, corrected and approved. The United Thank Offering for the three services was \$22.57, which was sent by Miss Susie C. Taylor to Mrs. James Davenport, Custodian United Thank Offering.

The Conference was very fortunate in having with them at their sessions, an English Sister of Mercy, Sister Elizabeth Mary, from Community of St. Peter the Apostle, Horbury, Wakefield, York, who is in America for a vacation. This godly woman, in her simple, modest manner gave a most pathetic talk on some of her experiences in her work with girls in Rescue Homes and in penitentiaries; also some of her personal experiences during the late great war. She touched the hearts of her hearers not only by what she said, but the way in which she said it, and her happy faculty of being able to smile through it all.

Report of Vice-President of Brunswick District was read by Vice-President Mrs. J. P. Stewart.

Report of Committee on Clergy House, Mrs. F. D. Fant, Chairman, was then read. This report showed that contributions to the fund last summer were very generous; that over \$100.00 was used to make necessary repairs on the roof, etc., leaving a small balance still on hand. Motion was made that the Woman's Auxiliary in the Diocese of Georgia continue the work on repairs to the Clergy House at Saluda, N. C., and that voluntary subscriptions be sent to the Committee. A new Committee for 1920 was appointed from Augusta, Mrs. E. J. Doremus and Mrs. Henry C. Brown.

The President urged upon all delegates present, the necessity of paying their pledges to the Georgia Traveling Fund and Georgia Missionary Vacation Fund, by July 1st.

Motion was made to elect officers of Parish branches at the regular December meeting; the officers to assume charge of their respective duties, January 1st. After discussion the motion carried, and Chairman of Committee Amendment of Constitution and By-Laws recommended that Section 4, Article II, be added, to read as follows:

"The annual election for officers of the various branches shall take place each year in December; the officers to take up their duties the first meeting in January."

Communications were read asking for contributions toward expense of Secretary of 4th Province; and expenses of representative of 4th Province on the Executive Board of the Woman's Auxiliary to conferences of the Board in New York which meets several times yearly. Motion was made

and carried to pay a certain amount, leaving the matter to the judgment of the President and two officers of the Executive Board.

Election of three (3) delegates to the Provincial Synod, at Louisville, in November, was as follows: Mrs. A. C. Haskell, Augusta; Mrs. F. F. Reese, Savannah, and Mrs. J. P. Stewart, Waycross. Alternates: Miss Edith Johnston, Savannah; Mrs. W. N. Pratt, Savannah, and Mrs. A. H. Hilsman, Albany.

The election of five (5) women to serve on the Nation-Wide Campaign Committee of the Diocese resulted as follows: Mrs. A. B. Hull, Savannah; Miss Eugenia M. Johnston, Savannah; Mrs. Henry C. Brown, Augusta; Mrs. J. S. Wright, Brunswick; Miss Julia Wright, Thomasville.

The President then appointed a Committee to look into the matter of the Church Service League, to confer with the Bishop some time during the coming year, and to report on same at the 1921 Convention. This Committee was composed of Mrs. O. Brownell, Valdosta, Mrs. J. S. Wright, Brunswick; Mrs. M. E. Bray, Jesup, and Mrs. T. M. Hazlehurst, Savannah.

Letter was read from Bishop P. T. Rowe, of Alaska, asking for help toward Scholarship to an Alaskan school. The following pledges were made at once by delegates present: Christ Church (Sec. B), Savannah, \$5.00; St. Thomas's Church, Thomasville, \$5.00; St. John's Church, Savannah, \$5.00; St. Paul's Church, Savannah, \$5.00; Grace Church, Waycross, \$5.00; St. Paul's Church, Jesup, \$1.00; St. Mark's Church, Brunswick, \$5.00; St. Paul's Church, Albany, \$5.00; Calvary Church, Americus, \$2.50; Christ Church, Valdosta, \$5.00; St. John's Church, Moultrie, \$5.00; Christ Church, Savannah, \$5.00; St. Paul's Church (Sec. B.), Savannah, \$5.00; Grace Church, Waycross, (Juniors), \$10.00; St. John's Church Sunday School, Moultrie, \$2.50; Grace Church Sunday School, Waycross, \$5.00; making a total of \$76.00 pledged. Motion was made and carried that if contributions from branches did not reach \$100.00, the amount of a scholarship, that sufficient sum be taken from Expense Fund to make up the amount.

Mrs. Harry D. Reed then read Resolution of Thanks to the Bishop for the inspiration of his presence and address; to Mr. John Moore Walker, for his strong and convincing message; to Mr. W. H. Higgins, Rector of St. Thomas's Church, for his cordial welcome and devoted service; to St. Thomas's Church, the choir and the good people of Thomasville, for their hospitality and kindness, and to Sister Elizabeth Mary, for her interesting talk.

The meeting closed with a few words of encouragement by the Bishop, followed by the Benediction, to meet in Brunswick, 1921.

PRESIDENT'S ADDRESS

Members of the Woman's Auxiliary:

Dear Friends: Since our meeting in Waycross last May, many changes have taken place both in the Church and in the status of the Woman's Auxiliary. Even our name has been changed, and instead of being an Auxiliary to the Board of Missions, we are now an Auxiliary to "The Presiding Bishop and Council." Rather a cumbersome title, but that may rectify itself in time. With this change of name the scope of our activities has been greatly enlarged. Besides Mission work, we can now include Social Service in any form as part of our duty. However, we in Georgia have thought it best to continue working on the same lines as hitherto. We therefore have kept our pledges as made at Waycross. It is for this Conference to decide what we shall do in the future. The Nation Wide Campaign met with a certain measure of success even tho it did not come up to the hopes and expectations of those who were at the Central office and gave so unstintingly of their time and thought to it. I am glad to say that we in the South, as a general thing, rose to our opportunity. Each week the Church papers give us an increasing number of Dioceses who have fallen into line and are helping to make the Campaign a complete success. Even as it is, the newly created Department of Missions has an appropriation of over \$2,000,000 at its disposal.

While it is not incumbent on us to keep up our old pledges and box work, they are most anxious to have us do this, and I trust we will do so.

I had hoped to have Mrs. Biller, Organizing Secretary, from the Church Missions House, with us today, to tell us of the new plans. Railroad conditions, caused by strikes and other labor troubles, prevented her leaving New York.

I have with me pamphlets concerning the reorganized box work. I hope you will study these carefully, and help Mrs. Blount carry on her most helpful work. Her report is most encouraging and shows much good work done.

We regret so much the absence of many of our officers. In view of this, I think you should decide as to whether you will continue to meet at a different time from the Diocesan Convention. As advised by the Bishop, we have tried out the experiment for three years. Do you think it wise to continue? I understand the Diocesan Convention wishes us to meet at the same time and place as they do.

I wish to emphasize the absolute necessity of your reading the Church papers in order to be informed Church women. The slogan of the Nation-Wide Campaign should be our watchword also "To inform the mind and awaken the conscience of the Church," and can this be done unless we read our own Church papers?

I am regretfully turning in Mrs. Graham's resignation as Secretary

for the "Spirit of Missions." She says she could not get a response to most of the letters she sent out regarding this magazine, which she thinks is the best Missionary Magazine she has ever seen. It seems very hard for our women to learn to answer letters. I find the same thing in other organizations, but I do think as Christian women we owe that much courtesy to the women we have put at the head of our various departments, and who cannot accomplish anything without co-operation on our part.

In conclusion, let us try to meet the new day ahead of the Church with all our powers. I am sure you feel the stirring of the Spirit in all things just now. The world is calling for the religion of Christ as never before. Surely we, His children by baptism and confirmation, should arouse ourselves and answer the Call!

May God give us grace to do this.

MINUTES OF CALLED MEETING

January 31, 1920

A called meeting of the Diocesan Officers and Presidents of the local Branches of the Woman's Auxiliary to the Presiding Bishop and Council of the Church, was held at the residence of the President of the Diocese, Mrs. A. B. Hull, on Saturday morning, January 31, 1920, at 11 o'clock.

The meeting was opened with prayer by the Honorary President, Mrs. W. H. Elliott.

Those present were: Mrs. W. H. Elliott, Honorary President; Mrs. A. B. Hull, President; Miss Eugenia M. Johnston, Vice-President of District of Savannah; Mrs. J. P. Stewart of Waycross, Vice-President of the District of Brunswick; Mrs. Harrison D. Watts of Waycross, Recording Secretary; Mrs. T. M. Hazlehurst, President of St. Michael's and All Angels, Savannah; Mrs. John K. McIver, President of St. Paul's, Savannah; Mrs. F. D. Fant, President of Section B, St. Paul's, Savannah; Mrs. F. C. Exley, President of St. John's Church, Savannah; Mrs. Thomas Screven Bond, Corresponding Secretary.

As the train on which Mrs. Stewart and Mrs. Watts arrived was late, Mrs. Bond was asked to take down the minutes.

The principal object of the meeting was to discuss a letter which Mrs. Hull had received from Miss Emily Tillotson, Educational Secretary of the Woman's Auxiliary, stating that she could visit our Diocese in March, if we so desired. Mrs. Hull had replied to her letter at once telling her that we would surely want her and would write Miss Tillotson that, although the first week in March would suit us best, whatever time was most convenient for her would be entirely satisfactory to us, and we hoped

that she would be able to give us an entire week. The character of the work during this time, also the hour of the meetings was left for her to decide. Mrs. Exley of St. John's Branch extended an invitation to the other Branches to hold these meetings in St. John's Church. As this is the most central church, the invitation was accepted with thanks. The Diocesan Officers and at least one delegate from each Branch will be expected to attend these meetings.

A report from the Treasurer, Miss Colesberry, was then read by Mrs. Bond, but as this only covered the period from May, 1919, to January, 1920, it was decided to write and ask Miss Colesberry to make out an itemized report from January 1, 1919, to January 1, 1920, our fiscal year.

A most discouraging letter was read by the President from Mrs. C. R. She also desired to tender her resignation, but as her term of office does not expire until the Annual Meeting, the Secretary was asked to write her to that effect.

This completed the business meeting. Refreshments were then served and a social hour followed, which was much enjoyed.

Before leaving, Miss Johnston invited the ladies present to a tea at her house in the afternoon at five o'clock.

ARTICLE I.

This association shall be called the Georgia Branch of the Woman's Auxiliary to the Presiding Bishop and Council.

ARTICLE II.

The object of this association shall be to help the Presiding Bishop and Council, studying Missions and giving to Missions.

ARTICLE III.

All baptized women of this Diocese are eligible to membership.

ARTICLE IV.

Sec. 1. There shall be a President, four Vice-Presidents (one from each District), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Thank Offering, Educational Secretary, Secretary of Boxes, Secretary of Spirit of Missions, President of the Junior Department and President of Little Helpers.

Sec. 2. These officers shall constitute the Executive Board.

ARTICLE V.

Election of Officers

Sec. 1. All officers shall be elected at the Annual Meeting, and be eligible for three consecutive years to the same office.

Sec. 2. Each branch shall be entitled to one vote, provided a delegate from that branch be present.

Sec. 3. The Nominating Committee shall report at second session of first day; the elections to follow immediately.

Sec. 4. Delegates to the General Convention and to the Annual Meeting of the Synod shall be nominated and elected from the floor.

Sec. 5. Should a vacancy occur in the President's office the Bishop shall appoint some one for the unexpired term.

Sec. 6. Should a vacancy occur in any of the other offices the President shall appoint some one for the unexpired term.

BY-LAWS

ARTICLE I.

Duties of Officers

Sec. 1. The President shall preside at all Annual Conventions and Executive Meetings, and shall have the general supervision of the work of the Branch.

Sec. 2. The Vice-Presidents shall have the general supervision of the District to which they belong, and when requested by the President, may act for her.

Sec. 3. The Recording Secretary shall keep the minutes of the Annual Convention and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report.

Sec. 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

Sec. 5. The Treasurer shall receive and disburse all the money, contributions, except the United Thank Offering, and shall make an annual report of same.

Sec. 6. The Custodian of the United Thank Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

Sec. 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She shall endeavor to form a Mission Study Class in every Parish and Mission, and shall have charge of and distribute the literature issued by the Educational Department of the Board of Missions.

Sec. 8. The President of the Junior Department shall guide the work of the Juniors.

Sec. 9. The President of the Little Helpers shall correspond with Parish Presidents, distribute the red barrels, collect their contents, and remit said contents to the Diocesan Treasurer.

ARTICLE II.

Meetings

Sec. 1. There shall be an Annual Convention in the spring of the year, the date to be appointed by the Bishop.

Sec. 2. There shall be, if possible, an annual meeting of each District.

Sec. 3. There shall be an annual meeting of the Executive Board, preceding the Annual Convention.
