## FIRST DAY

Wednesday, May 17, 1922.

The thirtieth annual meeting of the Georgia Branch of the Woman's Auxiliary was held in the beautiful and historic Christ Church at Savannah, Georgia, at 10 o'clock, Holy Communion being celebrated by the Rt. Rev. F. F. Reese, D. D., assisted by the Rev. J. D. Wing, D. D., Rector of the Parish, and several of the visiting clergy.

This is the first time in several years that it has been the pleasure and privilege of the Woman's Auxiliary to hold its annual meeting at the same time and place as the Diocesan Council.

At the conclusion of the Communion service, the delegates assembled in the Church School Auditorium, where after registering, the meeting was called to order by the President, Mrs. A. B. Hull of Savannah. The Rev. John D. Wing, D. D., Rector of the Parish, opened the meeting with prayer, and in the absence of Miss Eugenia M. Johnston, President of the Woman's Auxiliary of Christ Church, spoke beautiful words of welcome and praise to the women of the Church who for many years past have kept alive by prayer and works the Master's command to mankind.

The beloved Honorary President of the Diocese, Mrs. W. H. Elliott, added her personal welcome to the hearty welcome already extended the visitors.

Mrs. M. D. Dickerson, of St. Andrews Church, Douglas, replied to the address of welcome. Copy of this reply is printed in this report.

The roll call showed twenty branches, represented by thirty-nine delegates, and seven Diocesan officers, present.

The President read her report and recommendations to the Conference. The report was accepted with thanks and motion made and carried that recommendations be referred to a committee. (Report, etc., printed in this report.)

Treasurer's report was read by the Treasurer, Miss Lula C. Colesberry, and showed \$1,126.15 received, and a balance of \$72.95 on hand December 31, 1921. Report was accepted with thanks. Miss Colesberry reported that expenses increased last year \$50 instead of \$20 assessed by the Province for Provincial expenses, and a new item of \$20 to the Executive Board in New York. As the books of the Treasurer close on December 31 and as misunderstandings arise about reports to Vice Presidents, motion was adopted as follows:

"That each Branch of the Auxiliary send to their District Vice President their annual report not later than December 31st."

Report of Corresponding Secretary was read by Mrs. W. N. Pratt.

The President asked that Corresponding Secretary write letters, regretting their absence, to Mrs. A. H. Hilsman, Educational Secretary, Albany; Mrs. E. C. Blount, Box Secretary, Waynesboro, and Mrs. J. J. Wimberly, Secretary of "Little Helpers," Brunswick,

The Conference was fortunate in having with them Miss Marianna Ford, of the Diocese of South Carolina, President of the Girls' Friendly of the Province of Sewanee. She spoke on the "Aim and Vision of the Church Service League."

Report of Educational Secretary, Mrs. A. H. Hilsman, Albany, and report and letter from Mrs. E. C. Blount, Waynesboro, Box Secretary, were read by Mrs. W. N. Pratt.

Report of Custodian United Thank Offering was read by the Custodian, Mrs. James Davenport, Americus. Report showed amount on hand Dec. 31, 1921, \$2,175.43. Since that time \$650.81 has been received, making \$2,826.24 towards the \$3,000 hoped for from the Diocese of Georgia, and to be presented at the Triennial in Portland in September.

At one o'clock the session adjourned for lunch at the Colonial Lunch Room.

## AFTERNOON SESSION.

The meeting opened at 3 o'clock with the singing of mission hymn 249, and prayer by the Rev. Hobart Barber, Rector of the Church of the Good Shepherd, Augusta. The minutes of the morning session were read, corrected, and approved.

Bishop Recse spoke to the women regarding matters pertaining to all church people; calling especial attention to the condition of the Clergy House at Saluda and to the problem of educating men for the ministry who are without sufficient funds to meet expenses of training. He asked the generous co-operation of the Woman's auxiliary to these two important causes.

Motion was made and carried to rescind that motion at the morning session, namely: "That the three recommendations of the President in her report, be referred to a committee," and the recommendations be voted on separately as follows:

1. Section 1, Article 5, of the Constitution be changed to read: "All officers shall be elected at the annual meeting, and be eligible for three consecutive years to the same office, excepting Treasurer and Recording Secretary, whose term shall not be limited." Motion carried.
2. That name of "Secretary Spirit of Missions" be changed to read: "Secretary Spirit of Missions and Church Literature." Motion carried.
3. That Conference of the Woman's Auxiliary meet at separate time and place from Convention of the Diocese. Motion carried over to following session.

Mrs. D. D. Taber, of South Carolina, member of the National Commission of the Church School Service League, outlined in a clear and concise manner the aim of this new Department of Church work. She recommended especially three publications that will be of help to all interested. How the women of the Auxiliary can help with the work of religious education, "Book of Programs," and "Working Together."

The reading of the reports of Vice Presidents was as follows:

Report of "Little Helpers", with letter from Mrs. J. J. Wimberly, Secretary, was read by Mrs. J. S. Wright, Brunswick.

Mrs. F. B. Screven, Savannah, Secretary of Emery Fund, gave her report. Mrs. Screven also read resolutions on the death of Miss Emery as follows:

"We, the officers and members of the Georgia Branch of the Woman's Auxiliary, wish to put on record our gratitude for all that the life and example of Miss Julia C. Emery has meant to the Church and especially to the organization in which she was the leading spirit for over forty years.

By her great vision, her wise leadership, her devoted service, she will ever be to us a source of inspiration, influencing all those whose lives have touched hers, to follow the Master as she did."

Motion was made and carried that note of sympathy be written Miss Eugenia M. Johnston on her inability, through illness, to be present at the sessions.

Reports were made on work done in the different parishes in caring for orphans in the Near East.

St. Mark's, Brunswick, reported seven (7).

St. Paul's, Augusta, reported five (5).

Waycross, Grace Church, reported two (2).

Savannah, St. Paul's, reported one (1).

Savannah, St. Michael and All Angels, donated \$5.

Savannah, Christ, donated \$19.

There being no further business the meeting adjourned.

At 8:30 o'clock, at Christ Church, the Rt. Rev. F. F. Reese gave a most interesting and encouraging report of work done in the Diocese for the past year.

## SECOND DAY

Thursday, May 18, 1922.

By invitation, corporate communion was celebrated at 7:30 o'clock Thursday morning at St. John's Church by the Rev. Sherwood Whitney, Rector of St. Paul's, Augusta, assisted by the Rev. W. A. Jonnard, Assistant Rector of St. John's Church. At this service Mr. Whitney spoke most appreciatively of the work of the Auxiliary through the past years. About sixty women were present, and the offering of \$26.30 was applied to the United Thank Offering.

The business session was opened at 10 o'clock with prayer by the Rev. John Moore Walker of Albany.

The minutes of previous meeting were read, corrected and approved.

Letter from Mrs. H. H. McKee, Saluda, N. C., regarding condition of Clergy House at that place, was read by the President.

The body voted to reduce pledge of \$20 to expense of Executive Board in New York to \$10.

Pledges were made to the two funds spoken of by the Bishop at a previous session—one to be called the Bishop's Educational Fund, the other Clergy House Fund. Mrs. Chas. Tillman, of Quitman, was appointed as Secretary of the Clergy House Fund. Pledges were as follows:

Mrs. W. K. Miller, on behalf of St. Paul's Auxiliary, Augusta, invited the Conference to meet in St. Paul's Church in 1923.

It was the wish of this Conference to meet as for the past several years, separately from the Diocesan Convention, in order that small churches may have the pleasure of entertaining the Conference, but the Woman's Auxiliary will always be glad to have the privilege of meeting with the Council when invited.

The meeting closed with several short and interesting talks on work done by different branches. Three-minute talks on work of branches outside regular Auxiliary work were recommended by the President for future meetings.

The Doxology was sung and the meeting adjourned to meet in Augusta, in 1923.

## PRESIDENT'S ADDRESS

Dear Women of the Auxiliary:

As Dr. Wing has just told you, it is with much pleasure that we welcome you to Savannah this year. Being the hundredth Convention of the Diocese of Georgia, it is most fitting that our Conference should meet at the same time and place as this Convention. Historic Christ Church has thrown open her doors to us and it is a privilege to be her guests at this time. One more year and let us hope we will meet in Augusta to celebrate the hundredth anniversary of the organization of the Diocese.

As the oldest woman's organization in the Church, let us take stock of our work during the past year. Many calls have come to us, for it is a fact and should be a matter of pride, that the General Church looks to the Woman's Auxiliary not only to finance, but to stir up interest in all the work of the Church. We are expected to lead, and when we see the small number of women who avail themselves of the privilege of uniting and working with the one Missionary Society in the Church, it is quite remarkable what the organization accomplishes. "Pray and Work" should be our motto; these two supplement each other. Nothing can be accomplished without earnest, believing prayer, but as God in His wisdom elects to work through us, nothing will be accomplished unless we work early and late. In this connection let us remember that the greatest of the Apostles said: "I will show you my faith by my works," and "Faith without works is dead."

Because of the smallness of our numbers compared with the numbers of women in the Church, it has been advised by the Executive Council of the Church, that a Church Service League be organized in every parish in the Church. In this way every woman and every organization would take a proportionate part in the general work of the Church. Now all appeals come to the one organization, the Woman's Auxiliary, and the burden, which should be divided among all the women of each parish, would not fall so heavily on the few who assume their privilege of membership in the Woman's Auxiliary. I say all should assume their responsibility, because whether they assume it or not, by virtue of their baptism the task is theirs as much as ours.

I have invited Miss Ford of Aiken, S. C., to address you later on the wonderful idea and practicability of the Church Service League. With the material placed in our hands we have tried faithfully to accomplish the tremendous task given us by the Council, of which we are now a part.

Mrs. Blount's report will tell you of the good work done by the Supply Department, called of old the Box work.

Mrs. Davenport will report for the United Thank Offering, which I very much fear has not reached the goal of \$3,000, which we set for it. At Detroit it was my privilege to place this offering of \$2,052.00 on the Alms basin and surely whoever represents us at Portland in September will carry a check for \$3,000 from the Diocese of Georgia. We still have a chance to increase this offering, as we are to have a Corporate Communion and presentation of this offering at St. John's Church tomorrow morning at 7:30. Then we will open our little blue boxes once again before September. So dear friends, "Be not weary in well-doing," and increase our Thank Offering for surely we have much to be thankful for.

There are a few recommendations I am going to make to you, growing out of my four years' experience as your President. First, I recommend that you change Article V., Section I., of your Constitution relating to the election of officers. Make this read: "All officers shall be elected at the Annual Meeting and be eligible for three consecutive years to the same office, excepting the Treasurer and Recording Secretary, whose term of office shall not be limited."

Then change the name of the "Secretary of the Spirit of Missions" to "Secretary for Church Periodicals and Literature." Also from my experience, I advise the Conference of the Woman's Auxiliary to meet at a separate time and place from the Convention of the Diocese. My reason for this is that we can go to the small towns of the Diocese, thus taking them encouragement and gaining inspiration ourselves. Also we can concentrate on our own special work and not be distracted by wanting to be in two places at the same time.

Since our last meeting there has passed to the Church Triumphant the soul of our beloved leader, Miss Julia C. Emery. She fell asleep peacefully January 10. For forty years she had been the almost inspired leader of the Auxiliary. Her book, "A Century of Endeavor," was her last legacy to the Church whose "faithful soldier and servant" she was "unto her life's end. Would that we all could so fulfill our baptismal vows!

It is pleasant to think that our Emery Fund went so far beyond our expectations and that she knew of it. I hope proper resolutions on her life's work will be presented to this Conference and that a page of our Annual will be inscribed to her memory. "She rests from her labor and her works do follow her."

I see many new faces before me today and I hope it means new workers, new enthusiasms and a new forward movement in the organization throughout the Diocese.

In the early fall of 1921 I sent a letter to the Presidents of every Auxiliary in the Diocese, earnestly asking their co-operation,

#### REPORT OF LITTLE HELPERS, DIOCESE OF GEORGIA

May 17th, 1922.

Following is the report of the work done by the Little Helpers during the past year, ending May 1st, 1922.

I would like to state before reading my report that I have had a very hard time getting the Little Helpers reorganized. Two years ago, when the Church School Service League was formed in most of the Dioceses, the Little Helpers were in a way forgotten and disbanded. At the last convention, which was held in Brunswick, there was only one report from the Little Helpers, and that was from St. Mark's Parish, Brunswick. It was at this time I was appointed Diocesan President, Little Helpers. I appreciated the honor of being the leader of such wonderful and inspiring work. I tried so hard to bring the Little Helpers back to the standard. Letters were sent out to every Parish of the Diocese, and only six responded to the call

Some answered, saying there were so many demands of other natures that the Little Helpers could not be started in their Parish, some did not answer at all. The following is a report of the faithful few:

# CONSTITUTION

## ARTICLE I.

This association shall be called the Georgia Branch of the Woman's Auxiliary to the Presiding Bishop and Council.

## ARTICLE II.

The object of this association shall be to help the Presiding Bishop and Council, studying Missions and giving to Missions.

## ARTICLE III.

All baptized women of this Diocese are eligible to membership.

## ARTICLE IV.

Section 1. There shall be a President, four Vice-Presidents (one from each District), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Thank Offering, Educational Secretary, Secretary of Boxes, and Secretary of Spirit of Missions and Religious Literature.

Sec. 2. These officers shall constitute the Executive Board.

## ARTICLE V.

Section 1. All officers shall be elected at the Annual Meeting and be eligible for three consecutive years to the same office, excepting the Recording Secretary and Treasurer, whose term of office shall not be limited.

Sec. 2. Each branch shall be entitled to one vote, provided a delegate from that branch be present.

Sec. 3. The Nominating Committee shall report at second session of first day; the elections to follow immediately.

Sec. 4. Delegates to the General Convention and to the Annual Meeting of the Synod shall be nominated and elected from the floor.

Sec. 5. Should a vacancy occur in the President's office the Bishop shall appoint some one for the unexpired term.

Sec. 6. Should a vacancy occur in any of the other offices the President shall appoint some one for the unexpired term.

## BY-LAWS

---

### ARTICLE I.

#### Duties of Officers.

Section 1. The President shall preside at all Annual Conventions and Executive Meetings, and shall have the general supervision of the work of the Branch.

Sec. 2. The Vice-Presidents shall have the general supervision of the District to which they belong, and when requested by the President, may act for her.

Sec. 3. The Recording Secretary shall keep the minutes of the Annual Convention and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report.

Sec. 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

Sec. 5. The Treasurer shall receive and disburse all the money, contributions, except the United Thank Offering, and shall make an annual report of same.

Sec. 6. The Custodian of the United Thank Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

Sec. 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She shall endeavor to form a Mission Study Class in every Parish and Mission, and shall have charge of and distribute the literature issued by the Educational Department of the Board of Missions.

### ARTICLE II.

#### Meetings.

Section 1. There shall be an Annual Convention in the spring of the year, the date to be appointed by the Bishop.

Sec. 2. There shall be, if possible, an annual meeting of each District.

Sec. 3. There shall be an annual meeting of the Executive Board, preceding the Annual Convention.

Sec. 4. The annual election for officers of the various branches shall take place each year in December, the officers to take up their duties at the first meeting in January.

### ARTICLE III.

#### Expense Fund.

Disbursement of the Expense Fund shall be left to the discretion of the President and two other officers of the Executive Board, selected by her.
