FIRST DAY

MORNING SESSION

Augusta, Ga., April 10th, 1929.

The Thirty-seventh Annual Meeting of the Woman's Auxiliary to the National Council of the Diocese of Georgia, was opened with prayer by the Rev. Mr. Barber, after which the Auxiliary was welcomed to Augusta by Mrs. Percy H. Burum. The response to the words of welcome was made by Mrs. M. D. Dickerson of Douglas.

Mrs. H. W. Young of St. Simons Island, was introduced to the Convention, at which time she presented to the Auxiliary a gavel, made from an old tree on St. Simons. Mrs. Davenport received the gavel for the Auxiliary with thanks.

The chairman of Credentials, Mrs. Ben R. Ellis, made a partial report, showing 8 (eight) officers, 5 (five) chairmen, and 33 (thirty-three) members present, as follows:

The Committee was granted more time to make a final report. A motion was made and carried that a note of thanks be written to the Reid Memorial Church, for the use of its Sunday School rooms, for the first day's session of the Auxiliary.

The President, Mrs. J. A. Davenport, made a splendid report of the year's work, telling of the work accomplished, and her plans for the present year. This report was received with thanks.

Mrs. F. C. Exley, the Recording Secretary, showed as her report for the year the Year Book or Annual Report. This report was accepted.

Miss Lula Colesberry, the Treasurer, was unable to be present on account of illness. Her report was read by Mrs. Royal Tucker. This report showed a great increase in pledges, over \$3,000.00 (three

thousand dollars) having been contributed for all purposes. A telegram was sent to Miss Colesberry, expressing the Auxiliary's regret at her inability to be present, and of our love for her.

The noon hour having arrived, noon-day prayers were said by Mrs. A. H. Hilsman, chairman of the Prayer Committee.

The report of the Education Secretary, Mrs. Jackson Harris, was read.

The report of "The Spirit of Missions" was read by Miss Nella Cutliff.

The Custodian of the U. T. O., Mrs. W. B. White, read her report, which was given by her at the General Convention.

The report of the Supply Secretary, Mrs. Roy E. Breen, was read by Mrs. J. E. Mathis. It was decided to send Mrs. Breen a telegram of congratulation on her splendid report and also regretting her absence.

A report of the Clergy House at Saluda, Mrs. Stewart Gibbes, Chairman, was read by Mrs. W. B. White. The report showed that the cottage was enjoyed by three families during the summer. It also told of the needs of the cottage. An arm chair was especially needed. It was decided that a fund be started to get an arm chair for the house. This was done, and Mrs. J. E. Mathis was appointed to take charge of the fund.

Mrs. J. W. Griffeth appeared before the Convention and said that although there would be no camp this summer as no suitable site was available, she hoped that the districts would again give scholarships for the camp.

Mrs. J. P. Stewart, chairman of the Corporate Gift, made her report, showing that all but two Parishes had gone over the top in the three years work.

Every report showed great interest in the work of the Auxiliary, and each officer and chairman was thanked for their splendid reports.

Mrs. Harris suggested that the members of the Auxiliary study the Year Book in all of its parts, so that they might become more familiar with the work that is done by the Auxiliary.

A report from Mrs. Thomas S. Bond, Periodical Secretary, was read.

A fine report was made by Mrs. E. C. Blount, Chairman of the Gold and Silver Offering.

At one o'clock the meeting adjourned, in order that the members might attend a luncheon at the Country Club, the meeting to re-convene at 2:30 o'clock.

AFTERNOON SESSION

April 10th, 1929.

The afternoon session of the Woman's Auxiliary was opened with prayer by Bishop Reese, who also addressed the meeting. The Bishop said that he felt that his annual report given at the opening session of the Convention, at which both bodies were present, applied to the women as well as the men. The Bishop thanked the women for all they had done during the year, and asked them to continue their love and interest in all branches of their work. Especially to support St. Luke's Hospital, Tokyo, Japan, and the Fort Valley School.

The Credentials Committee made its final report and showed 11 officers, 5 chairmen and 33 members present.

Mrs. T. K. Wade, Supply Secretary of the National Executive Board, of the Woman's Auxiliary to the National Council, gave a most interesting and enlightening talk on the Box work. After Mrs. Wade's talk, many questions which had perplexed the members were asked her. Mrs. Wade answered them in such a way, that it was agreed that the work could be carried on more easily and with a better understanding than ever before.

It was decided to continue the Box work as before, hoping that the time is not far distant when this work will not be necessary—as it is hoped that the Church will finally be able to give sufficient means to her clergy—that such aid will not be needed. Mrs. Wade paid Bishop Reese lovely tributes, saying that he was beloved by all at the Mission House. Mrs. Wade was thanked for her interesting talk.

Reports of the Vice-Presidents were received. Each Vice-President showed that all pledges had been paid, and that they were fully supported by the members in their respective districts. The report of the Nominating Committee was received, and showed the following nominations:

The President gave her report as chairman in Georgia of St. Luke's Hospital Fund. Mrs. J. E. Mathis is treasurer of this fund, and reported about \$100 having been given to this cause. Mrs. E. C. Blount, chairman of the Corporate Gift, spoke of the amount wanted for this year, \$50,000 (fifty thousand dollars). It was decided to give \$500 (five hundred dollars) to this. Of this amount, \$380.00 (three hundred and eighty dollars) was pledged from the floor by the various branches.

It was reported that a new branch of the Woman's Auxiliary had been formed at Brunswick with the following officers: President, Miss Anne Smith; vice-president, Miss Sophie Robinson; secretary, Miss Catherine Peters; treasurer, Miss Beth Mustin; custodian U. T. O., Mrs. Robert Cunningham, Jr.

Mrs. Blount suggested that the Auxiliary appoint an historian to keep a file of all Year Books, and other valuable data. Mrs. Harris was appointed to consult with the Bishop about the matter.

The President had Mrs. Harris read a number of letters that had come to her, and which she wanted to bring before the Auxiliary.

The time for adjournment having arrived, the meeting adjourned.

SECOND DAY

MORNING SESSION

April 11th, 1929.

The morning session opened with prayer by the Rev. Mr. Barber. The minutes of the previous meeting were read and accepted.

Mrs. W. N. Pratt of the St. John's Church, Savannah, brought in a resolution, asking that prayers be said for the gift of life for the field from the Diocese of Georgia. This resolution was passed, and the matter will be kept before the Auxiliary by the Prayer Committee. The resolution was also sent to the Convention for consideration.

The committee appointed to receive contributions for the chair needed at the Clergy House at Saluda reported the amount raised.

Talks were made by several members, who attended the General Convention in Washington in October, 1928.

Mrs. Schaad was asked to write what was, in her opinion, the most vital questions brought out at the General Convention, and that her paper be sent to all Parish presidents and to the Church papers in Georgia.

The matter of the Annual Report was discussed—as it seems to some members the work reported in the Annual Report was late in getting to the Auxiliaries, and a motion was made and carried as follows:

“It is moved that the Executive Boardr consider the feasibility of having the annual reports of work ,and the names and addresses of officers of the Branches, who are elected in December, printed in a year book and distributed as early in the year as possible.”

It was also decided to put the addresses of all Parish officers in the Annual Report.

Delegates and alternates were elected to the Synod of the Fourth Province to be held in Coubia, S. C., in October, 1929, as follows:

PRESIDENT'S ADDRESS

Once more I greet you, dear members of the Woman's Auxiliary. The tie that binds us together in our great work grows stronger as the days pass.

What a privilege we have, living in these wonderful modern days when everything is made interesting and easy of accomplishment, if we are only willing to offer up ourselves "a reasonable, holy and living sacrifice."

The work is going forward not by leaps and bounds, but slowly and surely. There is an increase in the financial report; let us hope that is a sign of spiritual growth, otherwise we will deteriorate into a business organization doing philanthropic work—Social Service, pure and simple, without the great Christian motive underlying all our activities.

The ways and means of getting money to carry on, and the constant appeals for funds make a discordant note in our Auxiliary work. Still we are taught that cheerful giving is a part of our devotional life second only to prayer and praise.

At the beginning of this Triennium the work takes on new life and vigor. New projects are contemplated and begun; we surely wish to do our part. At the General Convention particular emphasis was laid upon Personal Religion and Evangelism. The Commission has sought the co-operation of the Woman's Auxiliary, and has issued leaflets that will prove most helpful.

The Corporate Gift will claim a large part of our time and gifts this year. Mrs. Burkhams of St. Louis, the general chairman, writes frequent letters full of encouragement and confidence of fulfilling our pledge to the National Council. It was decided by the Executive Board of the Woman's Auxiliary to set \$350,000 as our goal for the new Corporate Gift, this amount to be raised not later than Epiphany, 1930.

The first object is the Church in Santa Domingo, \$25,000 being needed. Second: Water supply at St. Michael's Mission Wind River Reservation, \$10,000; third: Chapel at Mount Hope, Canal Zone, \$5,000; fourth, Boys' Dormitory, Christ School, Arden, N. C., \$10,000. The January Spirit of Missions gives a full account of these objects.

Bishop Carson was very anxious to lay the corner stone of the church at Santo Domingo, Easter Sunday, and appealed for an advance of \$15,000, which was paid, the rest was in sight and is no doubt fully paid by now.

I am sorry we did not contribute to this first object. I deemed

it advisable to discuss the Corporate Gift at this meeting. Mrs. E. C. Blount has accepted the chairmanship. We will hear from her more fully on this subject.

Having assumed the chairmanship of the St. Luke's Hospital Drive, I should like to report that the work is going forward, not as rapidly as I had hoped. It was my original intention to have an intensive canvass through February and get through with it in order to make way for regular work. However, the money will be welcome whenever it comes, especially as the time for contributions has been extended until summer. It is hardly necessary for me to say anything more about the St. Luke's Hospital, as we have heard and read so much about it, especially those who attended General Convention. I should like to say just one word. We being an organization of women should feel keenly interested in one phase of the work, if not in all, that this great International Institution does, that is, the work done for women and children.

I attended a meeting of the Albany district in June, 1928. Miss Cutliff, the Vice-President, presided. The meeting was well attended in numbers, but the district was poorly represented, as delegates from Albany, Bainbridge and Americus only were present. The districts of Albany and Brunswick labor under greater difficulties than those of Augusta and Savannah, as the parishes are so far apart, and it is difficult to get a full representation. Much good is accomplished by these district meetings, and there should be at least one meeting each year.

I also attended the Semi-Annual Conference of the Executive Board in Albany at the same time as the meeting of the Archdeaconry of Albany. At these smaller meetings informality is encouraged and subjects are discussed more thoroughly.

I am happy to say that the Auxiliary observed St. Luke's Day as a special day of Intercession. Also February 15th was observed as a World Day of Prayer.

It was and is a matter of deep regret that I was unable to be present at the General Convention in Washington. However, our Auxiliary was well represented, and the reports will be of great interest and benefit to us.

I want to thank the officers and members of the Auxiliary for their promptness in answering letters; it so greatly facilitates the work and makes the conduct of our affairs a labor of love.

And now let me say in closing, that although our Auxiliary is small in numbers and we may not accomplish as much as we would desire collectively, that the strength of any organization is

only as strong as that of each individual member. Let us all try to strengthen our personal religion by prayer and more unselfish service.

The Semi-Annual Meeting of the Executive Board of the Woman's Auxiliary to the National Council, of the Diocese of Georgia, was held in the Parish House at St. Paul's Church, Albany, Georgia, on Wednesday morning, January 16th, 1929.

It was the occasion of the meeting of the Archdeaconry of Albany, and immediately after the celebration of the Holy Communion in St. Paul's Church, the Board adjourned to the Parish House.

Mrs. James A. Davenport, the President, presided, and the roll was called by Mrs. J. E. Mathis, Secretary pro tem. The following officers were present: Mrs. J. A. Davenport, President; Mrs. J. E. Mathis, Corresponding Secretary; Mrs. J. I. Gilbert, Secretary Religious Literature; Mrs. A. H. Hilsman, chairman Prayer Committee; Miss Nella Cutliff, Vice-President, Albany District.

Letter was read from Miss Colesberry, Treasurer, who reported that all the pledges had been paid for 1928.

Mrs. Davenport read a most interesting letter from Mrs. F. C. Exley, giving us her impressions of the General Convention.

Miss Cutliff reported that all the pledges of her District had

been met and reports turned over to Miss Colesberry.

Mrs. A. H. Hilsman, as chairman of Prayer Committee, reported that prayer leaflets had been sent to each parish on several occasions, and that special days had been observed.

A letter was read from Mrs. A. C. Haskell, expressing some dissatisfaction about the box work. Mrs. Breen, our Supply Secretary, was not present we could not learn the nature of the dissatisfaction, and decided to leave it over until the Convention.

Mrs. J. I. Gilbert, Secretary Religious Literature, reported unable to hear from the parish secretaries regarding sale of Spirit of Missions.

A letter from Miss Grace Lindley was also read, which was full of information and inspiration about the General Convention, and the work which was before us. At this time the members of the St. Paul's Woman's Auxiliary came in to listen to a wonderful address by Dr. Gaynor Banks, Mountain Lake, N. Y., of the Society of the Nazarenes.

A few miles from Albany are the wonderful Radium Springs, where a lovely luncheon was prepared in the beautifully appointed dining room. Cars were provided for us, and there we enjoyed the hospitality of the ladies and listened to wonderful talks by the ministers of the various churches of Albany, showing an atmosphere of church fellowship.

After the luncheon the Board re-convened at the Parish House and discussed letters concerning the St. Lukes' Hospital Drive. It was suggested that Mrs. Davenport appoint a general chairman, and let each parish chairman work through her.

Letters were also read regarding the Corporate Gift, but nothing could be decided about it until the Convention in April.

There being no further business the meeting adjourned, then we Americus folks left for home, feeling that the forty-mile drive through pouring rain was well worth it.

The annual meeting of the Executive Committee of the Woman's Auxiliary to the National Council of the Diocese of Georgia was held Tuesday afternoon, April 9th, 1929, at the home of Mrs. W. B. White, Augusta, Ga. The meeting was called to order by the President, Mrs. James A. Davenport, who recited the prayer for the Woman's Auxiliary and the Lord's Prayer.

The following officers were present: President, Mrs. James A. Davenport; Vice-President, Mrs. E. C. Blount, Augusta District; Vice-President, Mrs. Harry N. Walker, Savannah District; Recording Secretary, Mrs. F. C. Exley; Corresponding Secretary, Mrs. J. E. Mathis; Educational Secretary, Mrs. Jackson Harris; Custodian, U. T. O., Mrs. W. B. White; Custodian, Corporate Gift, Mrs. J. P. Stewart.

The treasurer, Miss Lulu Colesberry, was ill and unable to attend the Convention. Her report was read by Mrs. Royal Tucker. Mrs. Tucker was asked to represent Mrs. Colesberry at the board meeting. The minutes of the Semi-Annual Meeting of the Executive Board, which was held in Albany, January 16th, 1929, were read and approved.

The President brought before the Board various subjects of the Church's program, in order to see what the Woman's Auxiliary of Georgia could do more than it was already doing.

It was decided to include the Constitution and By-Laws in the 1929 Year Book. It was also decided to put on the outside cover of the Year Book, the name of the Convention City, and the date of the Convention to show more clearly the year the book represents. It was decided to state in the Year Book how many delegates were allowed to attend the Convention from each Parish, the opinion being that each Parish was allowed three delegates, but only one vote.

The President brought out the fact that Miss Colesberry's report showed that in the ten years she has been Treasurer, the amount collected had increased more than three-fold.

Mrs. J. P. Stewart resigned as Custodian of the Corporate Gift and the President appointed Mrs. Blount to take her place. A letter was read from Mrs. J. R. Cain, President of the Fourth Province, telling of the plans for the Synod to be held in October, 1929, at

Columbia, S. C. Many other letters were read and discussed but it was decided to bring the most important of them before the Convention for final action.

Before adjourning, Mrs. White served delicious refreshments.

REPORT OF PRAYER COMMITTEE

The slogan of the Woman's Auxiliary is "Pray, Work, and Give." Do the first, and the other two will follow logically.

Recently we have had a Mission in our city conducted by Dr. John Gaynor Banks, who is at present the Director of the Society of the Nazarene. The ideas set forth by Dr. Banks on the subject "Prayer," were most revealing, and the practical presentation of the truths concerning life—life abundant—involved every phase of man's being. In regard to prayer, the requirements, the rules, and fundamental principles taught—all led to a working out of the greatest of all fine arts on scientific lines.

Often times we experience a marked discouragement because of the lack of any manifestation of the success of our prayers. We either stop praying altogether or become luke warm in prayer. If; however, we continue to pray diligently and persistently at regular prearranged times, having met the requirements of prayer, we start on the road that leads to the abiding place of the Almighty. Into communion with Him which is the highest form of prayer. But persistence is necessary, also relaxation, meditation, and a practice of the Presence of God. The fact is that to learn to pray requires work, training, discipline, and concentration, particularly. Just as

does art, music, poetry, or any of the fine arts—for is not prayer the greatest of all arts.

Strange as it may seem, our bodies that have so long been spoken of as vile earth, play an important part in our ability to pray aright. As they are well ordered they become channels through which the Holy Spirit may work.

When will we be rid of the idea that God is afar off, whereas, "In Him we live and move and have our being," and "In us He lives and loves and expresses His holy Word and works.." "The Word was made Flesh and dwelt among us." "And at Pentacost the Word was made Spirit and dwells with us."

A recommendation was made to the Woman's Auxiliary, and was finally put into a motion by Mrs. Pratt, and passed, that reads as follows: We suggest that the rectors and workers stress the matter of the Offering of Life to the young people that they may catch the vision, and by the next Triennial have at least one Offering of Life from this Diocese. And it was suggested that regular prayers be said in private and prayer groups for the accomplishment of the same.

Our committee has distributed leaflets and arranged for prayer groups for each branch for special occasion twice during the year.

REPORT OF THE GENERAL CONVENTION—1928

By resolution of the annual meeting of our Diocesan Auxiliary, I was asked to give my idea of the vital things done by the Triennial meeting of the Auxiliary held in Washington, D. C.

The surroundings, the personnel—the physical part of such a gathering, are very entertaining and interesting but cannot be classed as vital. Those things which are laid upon us to be carried out, by virtue of our branch being a member of the larger organization of the whole Church, and those things suggested by resolution or otherwise which we can apply to our individual dioceses and parishes *do* form the vital things which should hold our attention for the coming three years.

First then, let us discover the key note of the whole thing. No one within the hearing of the voice of Bishop Anderson in the opening service of the convention could fail to get the key—Spirituality. Kindness, consideration for each other's views, love,

were to rule in all the deliberations of that vast assembly. Every one felt the power of the Bishop's words. Surely the Almighty directed things in that hour. For, not only was the Bishop not a well man, but so unwell that a physician sat beside him during the entire time of the address. Endless discussion, and perhaps some that was unpleasant, was expected to be provoked by certain matters which were to come before the convention. But a wonderful spirit prevailed and the convention of 1928 will go down into history as the most spiritual one ever held.

Because of our new rules of order—By-Laws—the working of the Woman's Auxiliary was the most orderly and the best conducted meeting we have had for at least the last five tri-ennials.

Too much cannot be said for our new presiding officer, Miss Elizabeth Matthews, of southern Ohio. This officer is now elected by the Executive Board instead of passing from time to time to the Diocesan President of the diocese in which the tri-ennial is held. This procedure was justified by the results of this meeting.

Since money is so necessary for the carrying on of the work of the Auxiliary, let us look at some figures. It would be well to put this table on the blackboard for the sums are so large that one can hardly encompass them by the ear alone.

But after all money is a small part of the gift. With this goes the gift of two lives. With this goes also the prayers of thousands of women who have a vital interest in the broader work of the Church. As I understand it, one of our chief concerns this year will be prayer for a gift of life from our diocese. We are glad to say that there are two persons in Augusta who are seriously considering the matter. One I believe has definitely decided.

Too many of us are inclined to think lightly of the matter of study. We expect to study any secular subject if we wish to know about it; but when the subject concerns the Church, we expect the information will come "out of the blue" in some mysterious manner without our effort. And since information does not come by that

route, we find the Church (I am speaking generally) with comparatively few well informed active workers. It is as necessary that we should be well instructed in religious matters as it is to be well instructed in secular matters. Our ability to make others see depends upon the clearness of our own vision.

In order that you may know that adult education *is* popular (contrary to the belief of some), let me tell you that 2,000 persons were in the study classes at the General Convention in spite of all the outside attractions which Washington had to offer to us all the time. Forty-eight classes in almost as many subjects were held. Many of the classes were so full that applicants were turned away. Surely if members of the National Executive Board, clergy (for the men were admitted) and other leaders in the work of the Church think it worth while to study, we, who are not so near the large centers of work, should feel even more the necessity for informing ourselves on the Church's business, and keeping ourselves better fit to be the leaders of our own work. So when our representatives name a time for and a course of study, let us all do it. There is much to be gained by concerted action in study as well as prayer.

This refers only to the Auxiliary. The Girl's Friendly and the Daughters of the King, also holding their triennial meetings, each had its own study classes. I have not their numbers. Throughout the whole organization of the Daughters of the King, there were 3,372 classes held during the triennium.

You understand that every line of work undertaken by the Church is demonstrated in one way or another at the General Convention. The newest, perhaps, is the Church Army. I had the pleasure of hearing Capt. Montford, the head of the Army in this country, when he first arrived from England. It is an English organization. The Church Army is a band of earnest laymen who go about holding Missions of the more informal type. At Washington they had an auto van provided with organ, hymn books, religious literature, etc., by means of which they illustrated how rural and small town work is carried on. Thus they take the Church to isolated communities where few opportunities are possible for religious service. So successful has the work of the Army become that headquarters have been established in Rhode Island where laymen are taught their methods of work and from which they go out to all parts of the country. By resolution, the Auxiliary recorded that appreciation of the work of the Army. During the past year, the Army held a Mission in Christ's Church, Augusta.

It would be interesting and profitable to discuss the process

by which different subject get before the meeting and how acted upon; but time does not permit. Let me assure you, however, that it is done in no haphazard way.

The subject of greatest spiritual benefit and most far-reaching importance was that of Personal Religion and Evangelism. I think I am correct when I say that every organization holding triennial meetings at this time sent memorials to the two houses of the General Convention asking that greater stress be laid upon this part of the work and pledging co-operation in it. After our own committee had studied the matter, their resolution expressed the feeling that the "Crux of the whole matter lies in ourselves"—in each one of us; that we should deepen our own religious experience and that we help others to a more complete life. Since personal evangelism cannot be carried out through set programs alone, the resolution suggests the following aids:

1—The *ministry of books*—reading and lending and constant use of Daily Bible readings, Inspirational books.

2—The *ministry of prayer*—having a quiet time with Christ each day. Use of Prayer Books and leaflets; and asking others to join for special purposes and occasions.

3—The *ministry of the spoken word*—realizing the power of the personal word passed from one to another in the power of the Holy Ghost.

4—The *ministry of the Holy Communion*—more frequent and with renewed consecration.

5—The *ministry of example*—that others may see in us what Christ hath wrought.

That each and every one of us return to our several Parishes praying that all hesitation in witnessing for Christ may be taken from our hearts, with a fervent desire to share Him with others and a sincere purpose to carry out the same.

Under the head of *domestic missions*, several resolutions concern us.

1—We are to assist in forming public opinion in favor of health clinics in centers of negro population.

2—Seek to include the foreign born women in our membership as they are taking their places in our Parishes and Church Schools.

3—Because our offerings on Good Friday for Jerusalem have been so deplorably small, we should promote interest in that offering.

4—That the Auxiliary co-operating with all woman's organizations of the Church, make the development of village and county work a definite objective for this triennium. This means, it seems to me, that we should make an effort, when holding our district

meetings, to take them to the small places and *not* concentrate on the large places which are already well organized.

Foreign Missions

Dioceses should be kept informed of the return of missionaries whom they have sent out. Inform the field of items of interest and publications carried on at home. Keep in close contact with missionaries that they may feel a real part of the Diocese at home.

Keep in close touch with any and all children of missionaries who may be in school in the Diocese. Also foreign students, and plan to bring them within the influence of Christian homes.

Observe noonday prayers.

Give due consideration to appeals made by foreign missionaries.

Social Service.

As a result of the presentation of this department of the work, the Auxiliary charges itself with the responsibility for inspiring the women of the Church.

1. To acquire an intelligent understanding of the problems of the community.
2. To help educate public opinion as to these problems.
3. To take part with Diocesan and civic social service agencies and with other communions as opportunity may be presented.
4. To recognize that co-operation with other communions is one way to promote Christian unity.
5. To realize that responsibility in the field of human relations is laid upon us by our Lord Himself, and that service to Him must include service to our fellow men.

Religious Education.

1. That the Auxiliary urge a closer and more intelligent co-operation with this department.
2. That we see to it that there is missionary education represented on the program of every Church School, local conference, and institute.
3. That we help to make the Birthday Thank Offering for Missions church-wide.
4. That we offer assistance and encouragement to the Church's work in the various colleges and universities.
5. That each Diocesan President and Diocesan Educational Secretary of the Woman's Auxiliary thoroughly inform themselves concerning the secondary school or schools within her Diocese.

6. That they endeavor to incorporate in the program of the year one of the secondary schools of the Diocese, in the Province and in the Church at large.

7. That each Diocesan Educational Secretary of the Woman's Auxiliary keep a supply of catalogues of any Diocesan school and all secondary schools in her province.

The *United Thank Offering* has been sufficiently elaborated so that you all know of that.

However, it was resolved: That to our United Gifts shall be added our united and earnest prayers, that God will put it into the hearts of many faithful women to give themselves and their substance to the work of the Master in the Mission field. You may know that there is to be placed in the Washington Cathedral a suitable tablet commemorating the fact that the first service held in the Cathedral was that of the presentation of the United Thank Offering of the Triennial of 1928.

Corporate Gift.

It may not be known that at the request of Bishop Campbell the \$20,000 designated for St. Timothy's Hospital, Cape Mount was changed to St. Mark's Hospital, Cape Palmas, Liberia.

Of the surplus, \$5,000 was given to Bishop Mitchell for water supply for the Indians at Ft. Defiance, Arizona.

The remaining amount was given to Bishop Burleson for the Hare Industrial School and for a Chapel at Piere, S. D.

The *Corporate Gift* for the new triennial is to be first, the raising of \$50,000 by Epiphany 1930. You may know that the first \$25,000 of that sum has been raised and paid for the building of a church in Santo Domingo City, Santo Domingo. The remainder is to be applied to projects to be determined upon by the Executive Board. Then we are to inform the National Council that we are ready to receive directions from them as to our further Advance Work. The remaining objects of the Corporate Gift are:

1. Water Supply, St. Michael's Mission, Ethete, Wyo.....\$10,000

Publicity and Promotion.

Under this head, there were several things stressed.

It was advised that a determined effort be made by the Woman's Auxiliary to secure a more intelligent use of the great mass of material relating to subjects upon which the Woman's Auxiliary *should* be informed and which is already available.

That new material and new methods for securing publicity and for promoting our work be a *definite* aim for the Auxiliary.

That there should be a more general exchange of material which has proved of value in other Parishes, Dioceses, and Provinces.

That we should make more use of Missionary Calendars, and magazines from the field; have greater use of the Church at Work and other publications from the National Council; increase subscriptions to Church papers; make greater use of our Diocesan papers for giving information; give wide publicity to appeals for volunteers for the Mission field; be informed as to places where Church workers can be trained; secure scholarships to summer conferences; use simple plays with the aid of the young people; make use of posters and bulletins.

Enlisting Others.

1. The isolated women and shut-ins.
2. Evening branches for the business women.
3. Organize "B" Branches for the younger women.
4. Be interested in the Y. P. S. L. organizations.
5. Keep in touch with the young college women and make use of them.
6. Organize the Little Helpers and thus keep in touch with the young mothers.

I have not given all the recommendations of the triennial but perhaps it will be possible for some of our branches to make use of some part of this to the broadening of their work and the extending of their usefulness. If so, then my efforts to give you this report are well repaid.

In closing, let me recommend the purchase (ten cents) and use of the Noon-Day Meditations which were given by Miss Lindley throughout the meeting. The Official Report closes with this: "We hope that the Meditations will be widely known and used by the women of the Church, so that the experience of the coming of Jesus among us here may be their also, and that this blessed companionship may express itself ever more clearly in our individual lives."

REPORT OF THE EDUCATIONAL SECRETARY

Madam President:

Your Educational Secretary submits the following report of activities, covering the year 1928:

Eight talks made and Study Classes conducted; numerous letters, books, pamphlets and suggestions have been sent out. Programs have been published in the Church in Georgia, with other recommendations. Bible study has been stressed, and reports show improvement over the previous year. Devotionals were emphasized, urging a careful preparation for each monthly program—the program always to precede the business session. The Lenten study of Africa was closely followed, only one parish and two missions failing to co-operate. However, serious study was conducted during Lent in every parish and in nearly all the missions. You were asked to use as the basis for monthly programs, the General Church Program; this being the first year of the new Triennium. The new study for next year is to be "The World Mission of Christianity." Personal Evangelism is being stressed earnestly in all departments of our Church life. For summer reading, our National Church leaders suggest, "Christ in the Common Ways of Life," by Canon Woodward, with helps by Miss Laura Boyer; "Roads to the City of God," by Matthews, and "A Faith

for the World," by Paton.

I hope each year may find every member of the W. A. a deeper student. Great progress can only be made through the medium of a great objective. The Christian goal is the greatest in all the world. Let us do all of our W. A. work with the purest and highest motive; studying, meditating and praying that we may increase in consciousness of God, gain knowledge of His character and love, deepen our desire to know His will and gain the power to put this greater knowledge into practice, personally and socially, individually and collectively. Ignorance is sin.

May our sincere prayer be realized—every member of this body of Christians devoting a few precious moments every day of every week to the study of the Bible, the Church and the Field. Then and only then will we be prepared to witness for Christ. "Happy is the man that findeth wisdom and the man that getteth understanding." Proverbs 3:v13.

Royal Tucker and family of Brunswick; Rev. Francis Craighill, Rocky Mount; and the Rev. F. Wilson of Hawkinsville.

We were glad to welcome the Craighill family, who arrived and took the place, no other having applied for it at that time.

It was possible by money received from the Woman's Auxiliary, to purchase a much needed oil stove for cooking. This was the latest perfection make, with cabinet and shelf. It was also made possible to buy a complete and dainty dinner set, including a dozen of each article, and to make the equipment even better, an aluminum tea-kettle and several saucepans were bought of the same material. CONSTITUTION

ARTICLE I.

This association shall be called the Georgia Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

The object of this association shall be to help the National Council in the five fields of service.

ARTICLE III.

All baptized women of this Diocese are eligible to membership.

ARTICLE IV.

Section 1. There shall be a President, four Vice-Presidents (one from each District), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Thank Offering, Educational Secretary, Secretary of Boxes and Secretary of Spirit of Missions and Religious Literature.

Sec. 2. These officers shall constitute the Executive Board.

ARTICLE V.

Section 1. All officers shall be elected at the Annual Meeting for one year and be eligible for re-election to the same office.

Sec. 2. Each branch shall be entitled to one vote, provided a delegate from that Branch be present.

Sec. 3. The Nominating Committee shall report at second session of first day; and the election take place at the first session the next day.

Sec. 4. Delegates to the General Convention and to the Annual Meetings of the Synod shall be nominated and elected from the floor.

Sec. 5. Should a vacancy occur in the President's office, the Bishop shall appoint some one for the unexpired term.

Sec. 6. Should a vacancy occur in any of the other offices, the President shall appoint some one for the unexpired term.

BY-LAWS

ARTICLE I.

Duties of Officers

Section 1. The President shall preside at all Annual Conventions and Executive Meetings, and shall have the general supervision of the work of the Branch.

Sec. 2. The Vice-Presidents shall have the general supervision of the District to which they belong, and when requested by the President, may act for her.

Sec. 3. The Recording Secretary shall keep the minutes of the Annual Convention and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report after same has been submitted to the President for approval.

Sec. 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

Sec. 5. The Treasurer shall receive and disburse all the money, contributions, except the United Thank Offering, and shall make an annual report of same.

Sec. 6. The Custodian of the United Thank Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

Sec. 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She shall endeavor to form a Mission Study Class in every Parish and Mission, and shall have charge of and distribute the literature issued by the Educational Department of the Board of Missions.

ARTICLE II.

Meetings.

Section 1. There shall be an Annual Convention in the spring of the year, the date to be appointed by the Bishop.

Sec. 2. There shall be, if possible, an annual meeting of each District.

Sec. 3. There shall be an annual meeting of the Executive Board, preceding the Annual Convention. A semi-annual meeting of the Board shall also be held.

Sec. 4. The annual election for officers of the various branches shall take place each year in December, the officers to take up their duties at the first meeting in January.

Sec. 5. The legislative and judicial power of the society shall

be vested in the Annual Meetnig. At the Annual Meeting and at the meetings of the Executive Board a quorum for the transaction of business shall consist of those present.

ARTICLE III.

Finance.

Section 1. Contingent Fund: Into this account goes all over-subscriptions on any pledges. The Fund to be kept in separate account in order that the accrued interest may be added to the principal. The Fund shall only be drawn on with the consent and approval of the majority of the Finance Committee.

Sec. 2. All other special Funds to be disbursed by the Treasurer upon instructions of the President.

Sec. 3. No bills to be paid unless approved by the President or her appointee.
