The Minutes of the Semi-Annual and the Annual Meetings of the Executive Board were read and approved.

The President, Mrs. F. B. Screven, made her report for the year; speaking of the Pentecostal Gift given by St. John's, Savannah, for the Advance work undertaken by the Diocese for 1930-31. She urged

attendance at some religious conference this summer. She told that the outstanding work among the Negroes in this country is being done by our Church and said that we must give all encouragement and help possible to Fort Valley.

At the noon hour Deaconess Byllesby led the noon-day prayer.

The Recording Secretary, Mrs. F. H. Craighill, Jr., made her annual report.

The report of Mrs. J. A. Schaad, vice-president of the Augusta district, was read by her at this time, as she had to leave.

Miss Colesberry made her report as Treasurer; stating that some few pledges were unmet which necessitated the use of the contingent fund, leaving \$25.00, which is very little.

The report of the U. T. O. Custodian, Mrs. W. B. White, was read by her. We have \$2,300 to meet by September, the time of the General Convention, if we are to equal our last United Thank Offering.

At this point the Rev. Thomas Wright, Field Secretary in this Province on College work, spoke on training our young men and women of the college age, to have an understanding of life and finding a purpose, and having them return home good Churchmen after their college days instead of full of doubts. He also cited many fields of church work to which our young men and women might give themselves in service.

Mrs. Screven read her committees.

The reports of the Vice-Presidents of districts were read and accepted; Mrs. Hunter Hopkins reading the report of the Brunswick district for Mrs. A. C. Hartridge and Mrs. Ticknor the Albany one for Mrs. H. S. Cobey.

Mrs. Thomas Bond asked Miss Mabel Claire Speth to speak on the "Gift of Life" from St. John's Church. Mrs. Angela Oglesby has offered her services in the Foreign Field and has been accepted by the National Council and is to train several months in New York and will then go to Japan where she is to be Secretary for the Bishop of Kyoto. A letter is to be written Mrs. Oglesby.

The meeting adjourned at 1:15 to attend luncheon.

AFTERNOON SESSION

April 15, 3 p. m., 1931.

The report of the Church Periodical Club Secretary, Mrs. Thomas Bond, was heard and accepted with thanks.

The Bishop visited the meeting at this point. He thanked the Auxiliary for their help in the Advance Work, and asked us to pray for a "Gift of Life" in our Diocese. He also urged our support of the Educational work for Negroes.

The report of the delegate to the Synod was read and accepted.

The Supply Secretary, Mrs. J. E. Mathis, made her usual splendid report of work accomplished in the Diocese.

Mrs. Hunton and Professor Hair of Fort Valley spoke of the commendable work Professor and Mrs. Hunt are doing at the Fort Valley Industrial School for Negroes.

A Memorial to Miss Nella Cutliff and Mrs. Hobart Barber was read by Mrs. James Davenport. She also read a list of Auxiliary members who have died since the last Convention.

The Clergy House report of Mrs. Stuart Gibbes, Chairman, was read by Mrs. Thomas Bond.

Miss Edith Johnson introduced a resolution for changing Article III of the By-Laws. This is in regard to the finances of the Diocesan Woman's Auxiliary. It was voted upon and passed, and the new By-Law will appear in the Year Book. The Finance Committee will present a budget at all Conventions hereafter to be adopted by the Meeting.

Mrs. W. B. White suggested traveling expenses for delegates, to meetings of some distance; stating that often the delegates who could go were not as capable of representing us as ones who might not be able to afford the trip. The discussion was deferred to hear more from the Finance Committee.

Miss Colesberry reported that unless pledges were slightly increased we could not meet all the items of the budget, the budget being the same as that covering last year's pledges. There was a long discussion to make it clear to all delegates.

It was moved and seconded adopting a budget of \$276.00 above our expenses of last year, covering all pledges.

It was also recommended that the first order of business after the minutes be consideration of items in the budget, for Thursday morning.

It being six o'clock the meeting adjourned to reconvene at 9:30 Thursday morning.

SECOND DAY
MORNING SESSION

April 16, 1931

The Morning session was opened with prayer and a few words by the Rev. C. C. J. Carpenter, of St. John's Church, Savannah.

The minutes of the previous meetings were read and accepted with two corrections. Miss Johnston rescinded her resolution of the afternoon before that consideration of items in the budget be the first order of business after the minutes.

A resolution was made by Miss Speth and adopted, that the Custodian of the United Thank Offering be elected for a period of three years. This change will be noted in the Constitution, Article V, Section 1.

A resolution was made by Mrs. Charles Lee of St. Simon's in regard to the number of delegates. There seems to have been some uncertainty in the past. Each branch is to be allowed two delegates. The change will be noted in the Constitution, Article V, Section 2. Mrs. Lee also called attention to some necessary changes in wording to make our Year Book up to date. This was agreed upon.

After some discussion of the various duties of the two Committees it was decided that both were too important and entailed too much work to be combined, it was therefore moved, seconded and passed that the Prayer Committee and the "Gift of Life" Committee be separated. Mrs. Screven asked for the pleasure of the meeting in regard to the Inter-Racial Work in the Diocese, and it was also voted for it to become a Committee.

Mrs. H. W. Young introduced a resolution, stating the position of the women in our Church on the question of lynching. It was moved and seconded that it be adopted and a copy sent to the Church papers.

The consideration of the budget came next. Miss Colesberry, as Chairman of the Finance Committee and Treasurer, asked that each Vice-President notify her district of the changes in the finances to the Budget System, which would thus simplify the work of the treasurer. She made it clear that branches must increase if we are to meet the budget, not including a camp or Advance Work projects.

It was announced that Sections B and C of St. John's, Savannah, were planning to contribute to the budget for the first time this year. Also Christ Church, Augusta.

Mrs. Screven read the list of former Presidents of our Diocesan

Auxiliary; those before and since the Diocese was divided.

The report of the Nominating Committee, Miss Eugenia Johnston, chairman, was read and it was voted for the Secretary to cast the ballot. The names of Diocesan officers appears at the beginning of the Year Book. Those whose names were on the ticket were declared the duly elected officers for the following year.

After hearing the appeal for a student pastor at the University of Georgia and the appeal for more help for the Educational Work among the Negroes, the Auxiliary voted to give \$50.00 (discussed in Executive Board Meetings), to Fort Valley Industrial School and \$200.00 towards the salary of a student pastor at the University of Georgia. Deaconess Byllesby moved and it was voted upon and carried, that if the money pledged by the Branches amounted to more than the \$250.00 that the remaining sum be divided evenly between the two projects.

Mrs. W. S. Daffin, chairman of the Courtesy Committee, offered the following resolution:

"I move that a rising vote of thanks be given to the members of St. Andrew's Church and to the many citizens of Douglas who opened their homes to the delegates; also to the Presbyterian Church for the use of their church for meetings of the Auxiliary.

"CHARLOTTE DAFFIN."

A list of delegates and alternates to the General Convention was read, as suggested by Mrs. Davenport. They are: Mrs. F. B. Screven, Mrs. W. B. White, Miss Mabel Claire Speth, Mrs. Hunter Hopkins, and a minister's wife. Alternates: Mrs. T. M. Ticknor, Mrs. Doughty, Miss Edith Johnston (withdrawn), Mrs. T. S. Bond (withdrawn), and a ministers' wife.

There being no further business the meeting adjourned to meet with the Convention at St. Paul's Church, Augusta, Ga., in 1932.

Resolutions and Amendments Adopted at the Annual Meeting

WHEREAS, the State of Georgia has suffered the disgrace of three lynchings within a year after freedom from such occurrences for a period of two years, therefore be it

RESOLVED: By the Woman's Auxiliary of the Diocese of

Georgia of the Episcopal Church in Convention assembled, That this Auxiliary hereby expresses its abhorrence of the crime of lynching and repudiates the belief as sometimes asserted that this crime is justifiable or excusable as a protection of the white women of the South.

They believe that lynching is under all circumstances a crime against the dignity of the State, a riotous rebellion against the peace and stability of the social and civic order, under the constituted authorities, of which, legally exercised, women and all other citizens should find the guarantee of their personal protection and safety.

AMENDMENT TO CONSTITUTION

ARTICLE V. Section 1. All officers shall be elected at the Annual Meeting for one year and be eligible for re-election to the same office; with the exception of the U. T. O. Custodian, who shall be elected for a period of three years from General Convention to General Convention.

AMENDMENT TO CONSTITUTION

ARTICLE V. Sec. 2. At the Annual Meeting each Branch shall be represented by its President or her representative and one other delegate.

AMENDMENT TO BY-LAWS

ARTICLE III.

Finance

Section 1. The Finance Committee shall present the year's Budget at each Annual Meeting to be adopted by a two-thirds vote of those present.

Sec. 2. The items in the Budget shall conform to the work of the Woman's Auxiliary to the National Council.

EXECUTIVE BOARD OF THE WOMAN'S AUXILIARY TO THE

THE SEMI-ANNUAL MEETING

The semi-annual meeting of the Executive Board of the Woman's Auxiliary to the National Council, of the Diocese of Georgia, was held in the Parish House of Christ Church, Savannah, Georgia, on Wednesday morning, February 4, 1931.

A corporate communion was held in the Chapel of the Church, Bishop Reese, celebrant, preceding the business session.

At 11:15 o'clock Dr. David Cady Wright opened the business session with prayer.

The president, Mrs. F. B. Screven, presided.

Others present were Miss Colesberry, treasurer; Mrs. F. H. Craighill, Jr., recording secretary; Mrs. W. B. White, U. T. O. Custodian; Mrs. C. H. Lee, Educational Secretary; Mrs. J. A. Schaad, Vice-President Augusta District; Mrs. Thos. S. Bond, Vice-President Savannah District, and Miss Sadie Kent, Corresponding Secretary.

Mrs. Bond of the Savannah District; Mrs. Schaad of the Augusta District; Mrs. Lee, representing St. Simon's and Brunswick, and Mrs. Craighill, representing Douglas and Fitzgerald, reported informally of the work being done in their districts. On the whole the reports showed progress and interest.

The Albany District was not represented.

Miss Colesberry, Treasurer, reported that all pledges for 1930 had been paid, and that there is a balance in the treasury.

The President stated that the pledge of five hundred dollars, made by the Auxiliary to the Advance Work, had been paid.

Mrs. White, U. T. O. Custodian, reported that she had on hand \$3,512.99. She expressed the belief that if the Auxiliaries would view the Thank Offering as a privilege and not as an assessment, that a gift in excess of the five thousand dollars presented at the last triennial, would be presented at the next.

Mrs. Lee, Educational Secretary, told something of her plans for study work throughout the Diocese. India will be studied during Lent. The books recommended are, "India on the March," and "India Looks to Her Future."

Mrs. J. E. Mathis, Supply Secretary, was not present. Her written report showed that boxes, valued at \$1,147.54, had been sent during the year to needy places.

The President read letters from Mrs. Cain and Miss Lindley and stated that copies of these would be sent the Vice-Presidents of the districts.

The new report blanks were shown by the President, and were found to be satisfactory.

It was decided to consider the following matters at the annual meeting:

Mrs. Craighill's recommendation that fifty (50) dollars be given by the Auxiliaries to the Bishop for use in the Diocese of Georgia;

Having a special committee for the Gift of Life, thus separating it from the Prayer Committee. Passed.

Changing, or rotating pledges by the Auxiliaries from time to time;

Electing the U. T. O. Custodian for a period of three years, the term of office to be from triennial to triennial. Passed.

Providing a place on the report blanks for reporting spiritual activities;

Selecting a committee for inter-racial work.

The meeting was adjourned at 1:05 p. m.

The Annual Meeting

The annual meeting of the Executive Board of the Woman's Auxiliary to the National Council of the Diocese of Georgia was held in the Rectory of St. Andrew's Church, Douglas, on Tuesday afternoon, April 14th, 1931.

The President, Mrs. F. B. Screven, presided and opened the meeting with prayer. Others present were Mrs. Colesberry, Treasurer; Mrs. W. B. White, U. T. O. Custodian; Mrs. C. H. Lee, Educational Secretary; Mrs. J. A. Schaad, District President Augusta District; Mrs. Thomas Bond, Vice-President Savannah District; Mrs. M. D. Dickerson; Mrs. J. E. Mathis, Supply Secretary; Mrs. F. H. Craighill, Jr., Recording Secretary. The Albany and Brunswick Districts were not represented.

The matters discussed at the Semi-Annual Meeting held in Savannah in February were re-discussed. The advisability of travelling expenses for delegates was discussed.

The fifty dollar pledge for educational work decided upon in February was talked of. Mrs. Screven said the Bishop would like us to give it towards educational work among the Negroes, with Fort Valley as possible recipient. Mrs. Mathis said a few words suggesting other eligible, important and worthy Negro work in our own Diocese, that receives less support. Mrs. Charles Lee told of the marvelous work of Deaconess Alexander among the colored people at Pennick.

The value of Box Assignments—Fall and Lenten—was discussed. It was agreed that an Auxiliary should anticipate the coming of the assignment Fall and Lent, and get funds together. Auxiliaries not accepting assignments were losers. Mrs. Lee recommended it as an excellent means for personal contact.

Mrs. Schaad suggested the excellent idea that when assignments came from those higher in authority we were insubordinate not to accept.

The value of the U. T. O. Custodian keeping the job for three years from triennial to triennial was touched upon by Mrs. Screven. She spoke of the excellent work of Mrs. W. B. White and the constant touch she had kept with all Branches. At this point the meeting adjourned.

The President's Message

Dear Friends and Fellow Workers of the Woman's Auxiliary to the National Council, Diocese of Georgia:

Notwithstanding the handicap our organization has had to face during the past year in having a new and inexperienced President, and in spite of a year of great financial depression, the work of our Auxiliary, as a whole, shows no evidence of discouragement or failure to carry out what they undertook to do, and we have much to feel grateful for, in the knowledge of what has been accomplished since our last annual meeting.

The regular pledges have all been met, and we responded to the appeal made by the Bishop by contributing the sum of \$500.00 to be applied to the pledge made by our Diocese of \$5,000.00 for the Advance work of the Church the two objects of which are a church at Caliente, Nevada, and a rectory at Christiansted, Virgin Islands. The United Thank Offering, the Box Work, Study Classes, Social Service work, Corporate Communions, and observance of the World day of prayer, are all evidences that our members are giving faithfully their prayers and efforts, as well as their money, toward the support of the Church's Mission.

The Vice-Presidents of the Districts of Albany, Augusta, Brunswick and Savannah, on whom so much of the responsibility of carrying on the work of the Auxiliary has rested, will give their reports of the various activities of the Branches in their Districts.

I feel that particular mention must be made of the work of the Chairman of Advance Work, Mrs. E. C. Blount, whose devoted and untiring zeal has always brought to successful completion any undertaking she has endeavored to do for the church. To Miss Colesberry, who has given twelve years of devoted labor in her office as Treasurer, we feel deep gratitude. And to our Custodian of United Thank Offering Mrs. M. B. White, who has been so untiring in her efforts to reach, and influence each Branch in the Diocese to take part in this great offering, as well as to our Box Secretary, Mrs. J. E. Mathis, and to our Educational Secretary, Mrs. Charles Lee, we indeed owe much.

Before closing this appreciation of work so ably carried forward, I must include that of our Recording Secretary, Mrs. Francis Craighill, Jr., who prepared for us our Year Book of 1930, and so ably represented our Auxiliary at the Synod Meeting in Jackson, Miss., last Fall, and is now acting as hostess at this Convention in addition to her duties as Secretary.

There are so many matters I would like to discuss with you, in which you could give your ideas and we could together formulate plans for our year's work, but in our limited time, I can make only a few suggestions, to which I hope you will add many of your own.

At this time, I would like to impress upon you the great advantage to be gained by attending one of the Summer Religious Conferences either at Sewanee or Kanuga. Realizing the untold benefit one receives from getting in touch with the leaders of our Church in its various departments, and the inspiration to be gained from the courses of study, and devotional services conducted there, I urge that anyone who can possibly arrange it, to take advantage of these opportunities our church is offering us by attending one of these conferences.

Realizing our responsibility towards the colored congregations of our church in the diocese, we should try to support the Bishop more fully in his program, by giving intelligent sympathy and help to this subject; and acting upon the advice of the Bishop, we have arranged to have an address given us by one of the leaders of the Fort Valley Industrial School, who will tell us of the fine work being accomplished there, and I hope we may be led to make some contribution towards this school, as well as towards the work Deaconess Alexander is doing at Penick, Ga.

The Triennial Meeting of the Woman's Auxiliary to the National Council is called to meet in Denver, Colorado, September 16th-30th, this Fall, and Miss Lindley has sent a letter to tell us that the following subjects are to be considered at this great meeting:

- 1st. Family Life.
- 2nd. Economic Conditions.
- 3rd. International Contacts.
- 4th. International Relations.
- 5th. Religious Thinking Today.

These subjects are to be presented in addresses, and discussion at Sectional Meetings, and she advise that the delegates selected at this Convention to attend the Triennial, should try to inform themselves on these subjects to be brought up at this meeting in order to be able to join intelligently in the discussion of these great problems which press so heavily on this generation and which only the guidance of God can lead us to solve.

Before closing I would like to call your attention to the most outstanding piece of work which I think has been accomplished by the Woman's Auxiliary in the Diocese, in that of St. John's Church, Savannah, where the project of the Rector to raise a Pentecostal

gift toward the Advance Work, was carried to a successful termination by the efforts of the Woman's Auxiliary in that church and the sum of \$850 was raised for the purpose.

Also in having three Branches of the Woman's Auxiliary in St. John's Church, they have more nearly attained the object which the Bishop says should be the aim of the Woman's Auxiliary, to try to get every group of women in our Diocese to work in one or more of the five fields of service and to be represented in the Diocesan Organization.

Praying that our spiritual life, individually and as an organization, may be deepened, to the end that Christ's Kingdom may be established upon earth,

Report of Educational Secretary

If this presence will refer to page 37 of the Annual Report, it will be seen that the duties of your Educational Secretary are defined under three headings:

It is expected of her that she "guide the educational work of the Diocesan Branch;" that she "endeavor to form a Mission Study Class in every parish and mission;" that she "have charge of and distribute the literature issued by the Educational Department of the National Council."

Taking up these duties in reverse order, we began with the third, believing that the preceding would follow a line of natural fulfilment could we but be sure that the literature put forth by the National Council would be seriously read and studied.

What then did our National Council ask of us in the early fall, and how did we respond?

Faced with the tremendously important every member canvass, we were asked to read and study as a preparation for it "Our Expanding Church," by the Rev. James Thayer Addison, and for the first time the Diocesan Field Secretary added to his list of rectors and parish chairmen the names of Woman's Auxiliary Presidents. To all were sent a circular letter asking that we accede to the request of the National Council.

During January, when the final report of the Canvass was in, your secretary sent reply postcards to every branch of the Woman's Auxiliary, the answers to report upon this canvass preparation study and the study planned for Lent. The returns were interesting if sometimes disappointing. From twenty-nine organizations came twenty-two replies. Of these, three reported no study class; only five had studied "Our Expanding Church;" and twelve were committed to the study of India, the majority selecting "India Looks to Her Future," by Oscar M. Buch. The other recommended text-book, "India On the March," by Alden H. Clark, was designed especially for young people and I rejoice to report one group of such students who under the leadership of Auxiliary Women have read and discussed this book with fine attendance at their meetings, and a keen interest in the subject presented.

Next year's course is entitled "Building a Christian Nation," and material for it will be available in May. Please begin to plan for it, and let us resolve that, God helping us, we will put our best of mind and heart and conscience into our study.

I thank you sincerely for the gracious co-operation that has

been mine from so many of you, but while "there remaineth yet very much land to be possessed" you would not have me minimize the need for greater activity.

Must we study the Church's Chief Business only once a month, or only during Lent? Upon real missionary knowledge missionary activity follows as the night the day.

God grant that both be ours.

AUGUSTA DISTRICT

It is with regret that we make our first report for the District our last. The year has been very interesting and we hope helpful as well. It has been our good fortune to have several outside speakers who have brought to us the message from the far corners.

Two of our meetings have been of a formal nature—the fall and the spring meetings. Mrs. Cain, the President of our Provincial organization, was the speaker at the fall meeting and gave us an address on a general subject, "Modern Trends of the Woman's Auxiliary." Mrs. W. P. Cornell, the Executive Secretary of the Diocese of Florida, addressed us at the spring meeting on "Life Service." I cannot speak too highly of this message. In order to have those present to whom the subject was most vitally concerned, we asked as many as possible of the members of the Young People's Service Leagues of the Parishes to meet with us. We are praying that the message may bear fruit in the giving some time of a life for the work of the Church.

At the more informal meetings, of which there have been five,

we have heard from a missionary from India; from a native clergyman from Porto Rico; from a clergyman working among the Indians of Wyoming; and a social service address by Deaconess Colesberry of Philadelphia. In May we shall have an address by Archdeacon Brown of Savannah concerning the work among the colored people of this Diocese. We also took our part in the Interdenominational Day of Prayer. By all of this, we hope our interest has been increased in the work of the General Church; and that the next year may be better than this one has been.

It is very gratifying to note that, notwithstanding the stress of times, there has been an increase in each one of the items listed.

My first work after the election to this office at the Convention in Thomasville in May was to remind the Branches of their pledge for the Young People's Camp at Tybee held in June.

St. Paul's Branch asked me to attend their June meeting, which I did, giving them a detailed account of the proceedings of the Convention.

A meeting of the District was held at St. Paul's Church on Wednesday, November 5th. The Bishop, assisted by the Rev. Mr. McGlohon, celebrated the Corporate Communion, and gave us a most inspiring address. This was followed by an inspirational meeting, after which we adjourned to the Parish Hall for luncheon. There were nearly one hundred present, including Miss Margaret Weed of Florida, members from Brunswick and St. Simons; as well as some from our Colored Branches.

Reports of the Synod meetings held in Jackson, Miss., in November, were distributed to all Branches in December.

The Annual Reports from the Branches were turned in during January.

The Semi-Annual meeting of the Executive Board was held in Christ Church Parish House on Wednesday morning, February 4th, with eight members present.

On Thursday, February 12th, we had the privilege of having with us the Rev. A. Abbott Hastings, Missionary to the Indians at Wind River, Wyoming, who gave us a heart-to-heart talk in the morning, about his work; and in the evening a talk with moving

pictures.

On the afternoon of February 20th, Christ Church was crowded for the international, interdenominational, and inter-racial World Day of Prayer—the first time our Church has been asked to have it.

Our Interparochial Study Class held weekly during Lent was well attended. Mrs. F. B. Screven was our able leader.

Feeling the press of so many duties, it was with regret that I had to decline re-election; but I wish for my successor the splendid co-operation I received and which made my work so much easier for me.

**Report of Meeting of Provisional Synod held in
Jackson, Miss., November 11-13, 1930**

I was so impressed—also oppressed—by the two day 900-mile trip over the most unspeakable, indescribable roads (after five days of rain), getting to Jackson, Mississippi, to the Synod that I simply can not refrain from mentioning it. But I want to add that the wonderful two days spent there were some of the most inspiring I have ever experienced, and I regret that our Diocese, like several others, did not have full representation who might have also had that wonderful experience—and that, although I was exhausted physically

and mentally (the return trip necessitating going to Gulfport, Mobile, Pensacola and Tallahassee to reach home) I counted it worth what we had gone through.

The meeting in Jackson was notable for the fact that, for the first time in the history of the province, the men of the Synod and the women of the Auxiliary met in joint sessions to hear reports and hold conferences on the program of the church.

The first of these joint sessions was held Wednesday morning, November 12th, at which time the report of the Presidents of the Synod and Auxiliary were read, the President of the Auxiliary presiding over the meeting during part of the session.

The second joint session was held on Wednesday afternoon when the reports and program of the Department of Religious Education was heard and discussed—and the third on Thursday afternoon for a conference on the work of the Department of Christian Social Service and on the Advance Work Program. For this last conference the Auxiliary brought Miss Grace Lindley and the Synod presented the Rev. David M. Covell, the National Council's field worker in this province.

The Woman's Auxiliary meeting was in session on Wednesday and Thursday mornings with Mrs. J. R. Cain, President, and Mrs. W. P. Cornell, Vice President, presiding.

Present were 9 Diocesan Presidents, 6 Provincial Officers and 32 delegates representing 32 Dioceses—Alabama, Florida, Louisiana, Mississippi and Tennessee had full representation.

Present as honored guests of the convention were the Rt. Rev. Hugh L. Burlson, Miss Grace Lindley, National Executive Secretary of the Woman's Auxiliary; Mrs. W. J. Loaring-Clark, Provincial President of the Daughters of the King; Miss Emma Twiggs, Provincial Field Secretary of the Girls' Friendly Society.

Noon-day meditation and prayer were led by Miss Lindley and Mrs. Loaring Clark.

Three conferences for the Auxiliary as a whole were held, the first and last impressing and inspiring me a great deal.

1. Advance Work, led by Miss Emma J. Hall, of North Carolina.
2. Rural Work, led by Mrs. W. S. Welch, of Mississippi.
3. Inter-racial Work, led by Miss Nannie Hite Winston, of Kentucky.

In the first Miss Hall asked each Diocese to report what plans were being used to raise the funds for the Advance Work. The closing words of her conference were, "My command is first advance, second

advance, third advance, but let us say advance on our knees."

In the Inter-racial conference Miss Winston emphasized the need of a Christ-like attitude toward the problem, asking all church people to consider it with an open mind and heart, in view of the fact that the negro race has proven itself capable of a valuable contribution to our national life, intellectually, culturally and spiritually. It was resolved that the year's program for church women should include Study Classes on the inter-racial problem, Woofter's "Basis of Racial Adjustment," by Ginn & Company, to be used. Miss Winston also urged the women to use every opportunity to influence public opinion toward enabling the negro to secure for himself justice in the courts, better housing conditions, a more normal economic situation and his highest racial development.

She was a very appealing and powerful speaker, and it made a lasting impression on me.

The Rev. Dr. Crittenden, the negro priest, recently added to the field department, made a short address, stressing the white race should enable the negroes to get fair treatment, contribute what they could, and that they did not want social intermingling.

The Provincial Auxiliary voted to have a Diocesan exchange of year books.

At the joint session when the Department of Missions was in charge the Rev. Robt. E. Fletcher, the provincial Deaf Mute Worker, who is a deaf mute himself, gave a very interesting and appealing report of his work among the deaf mutes in the province. I am convinced that he is doing a very worthy work with very, very limited financial help. If we are called upon to help this splendid young man in his work of spreading Christianity here in our own province, may I entreat you to help.

Mrs. Loaring Clark gave a splendid report of her work among the blind. Her work is also limited by lack of funds to get books printed in Braille.

The speakers for the evening the last night were the Rev. Thomas H. Wright and the Rev. W. Brooke Stabler, both of whom are working with College students and both of whom spoke on the Church's work with college students.

After the prayers and benediction the Synod stood adjourned.

Before I close I want to tell you an incident that happened at the Synod, and also make a recommendation.

Our Diocesan President had been asked to serve as Chairman of the Finding Committee on Rural Work, when she was unable to

attend she asked if I would serve on the Committee. I agreed, but not as chairman, as it was my first Synod.

At the first session where chairmen of the Committees were announced, Mrs. Cain read my name as Chairman of the Committee. I corrected her, telling Mrs. Screven was to have served, but that she and I didn't think I was capable of being Chairman of the Committee, but would serve on it.

Of course everyone laughed, and thereafter at the Synod I was spoken of as the little Georgia delegate who wasn't capable enough to be chairman of a committee.

My recommendation is that our Diocesan Woman's Auxiliary create funds to help with traveling expenses of delegates to Synods, etc. It sounds queer when I was the delegate this year, and I do speak feelingly, for our Ford was almost ruined and it turned out to be a much greater expense than we had expected with a small accident thrown in.

But it distressed me for our Diocese to have only one delegate, and that one was I. Often the women who will best represent us can not afford to go great distances. I talked to Mrs. Cain about the matter and she said her Diocese had a fund for such a purpose.

The next Synod is to meet in Kanuga, N. C., 1932, and the following one is to be invited to Lexington, Kentucky.

I think we were the only Diocese with only one delegate, and frankly it was more than we could afford.

I guess everyone here knows that the banks in Asheville, Hendersonville and Saluda closed their doors during the winter. This is a hard blow to poor old Saluda. Our Georgia Clergy House fund, of course, was lost. If you wish to be a help to our Bishop, you can lend a helping hand in relieving him of small things. We must carry on the good work that has been going on in Saluda. It will take about \$25.00 to do the necessary thing. The water rent has to be paid, which is \$12.00 per year. The rent on the electric meter is \$8.00, then about \$5.00 for cleaning and incidentals. I do hope everyone here will take an interest in this work and do her share.

The Rev. Mr. Burton, of Savannah, and his family occupied the house for some time last summer. They were delighted with the place. He told me that the house was most comfortable and convenient, and they hope to go back there soon.

A letter from Miss Box says: "We were able to have a set of stone steps added to the comfort of the occupants of the cottage." We supplied groceries for the first meal and also had all the beds made, which means a great deal to anyone coming in after a long tiresome motor trip.

CHURCH PERIODICAL CLUB ANNUAL REPORT

Our work in the Diocese for the past year has shown a marked improvement, which is very encouraging to the Director.

We have now on our books 18 Parish Secretaries; and if we could have known what all of them had accomplished during the year, instead of only the eleven who returned their annual reports to us, the results would have been greater.

We regret that we have not yet reached our record of several years ago on the Current Periodicals sent. When the increased postage rates went into effect, it greatly reduced the number of magazines sent; but now that the rates have been decreased, 2 ounces for 1 cent, domestic and foreign, no zoning, we hope that this part of the work will soon get back to normal. There are now only 44 being sent regularly by 25 donors.

Seventy-five Bibles were sent last year, being four more than the previous year.

A marked increase was shown in the number of theological and secular books sent—a total of 523.

More than twice as many odd magazines and papers were distributed, 7,456 having been sent to 18 institutions in the Diocese, including Orphanages, Hospitals, Juvenile Court, Home for Widows, Home for Seamen, County Farms, Jails, Salvation Army; also 2 Missions, Rural Schools and Normal College.

There were 225 Christmas and Easter cards sent, which is considerably more than last year.

Very few pictures, games and scrap books were sent; only 5 of the latter. Besides the large amount of work done in our Diocese, we have people in the Diocese sending magazines to almost every State in the Union, as well as to some foreign countries.

CONSTITUTION

ARTICLE I.

This association shall be called the Georgia Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

The object of this association shall be to help the National Council in the five fields of service.

ARTICLE III.

All baptized women of this Diocese are eligible to membership.

ARTICLE IV.

Section 1. There shall be a President, four Vice-Presidents (one from each District), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Thank Offering, Educational Secretary, Secretary of Boxes and Secretary of Spirit of Missions and Religious Literature.

Sec. 2. These officers shall constitute the Executive Board.

ARTICLE V.

Section 1. All officers shall be elected at the Annual Meeting for one year and be eligible for re-election to the same office, with the exception of the U. T. O. Custodian, who shall be elected for a period of three years from General Convention to General Convention.

Sec. 2. At the Annual Meeting each Branch shall be represented by its president or her representative and one other delegate.

Sec. 3. Each branch shall be entitled to one vote, provided a delegate from that branch be present.

Sec. 4. The Nominating Committee shall report at second session of first day; and the election take place at the first session the next day.

Sec. 5. Delegates to the General Convention and to the Annual Meetings of the Synod shall be nominated and elected from the floor.

Sec. 6. Should a vacancy occur in the President's office, the Bishop shall appoint some one for the unexpired term.

Sec. 7. Should a vacancy occur in any of the other offices, the President shall appoint some one for the unexpired term.

BY-LAWS

ARTICLE I.

Duties of Officers

Section 1. The President shall preside at all Annual Conventions and Executive Meetings, and shall have the general supervision of the work of the Branch.

Sec. 2. The Vice-Presidents shall have the general supervision of the District to which they belong, and when requested by the President, may act for her.

Sec. 3. The Recording Secretary shall keep the minutes of the Annual Convention and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report after same has been submitted to the President for approval.

Sec. 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

Sec. 5. The Treasurer shall receive and disburse all the money, contributions, except the United Thank Offering, and shall make an annual report of same.

Sec. 6. The Custodian of the United Thank Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

Sec. 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She shall endeavor to form a Mission Study Class in every Parish and Mission, and shall have charge of and distribute the literature issued by the National Council.

ARTICLE II.

Meetings.

Section 1. There shall be an Annual Convention in the spring of the year, the date to be appointed by the Bishop.

Sec. 2. There shall be, if possible, an annual meeting of each District.

Sec. 3. There shall be an annual meeting of the Executive Board, preceding the Annual Convention. A semi-annual meeting of the Board shall also be held.

Sec. 4. The annual election for officers of the various branches shall take place each year in December, the officers to take up their duties at the first meeting in January.

Sec. 5. The legislative and judicial power of the society shall

be vested in the Annual Meeting. At the Annual Meeting and at the meetings of the Executive Board a quorum for the transaction of business shall consist of those present.

ARTICLE III.

Finance.

Section 1. The Finance Committee shall present the year's Budget at each Annual Meeting to be adopted by a two-thirds vote of those present.

Sec. 2. The items in the Budget shall conform to the work of the Woman's Auxiliary to the National Council.
