

R E P O R T S

REPORT OF THE PRESIDENT

It is with real gratitude that I look back upon the four years we have been permitted to work together in our Diocese and am thankful for the Divine help which has been given us. There is satisfaction both in the fact that we have been able to keep up the regular pledges and line of work mapped out by those who have served so faithfully before us, and in the new opportunities of work and service which have opened for us in the past few years.

Foremost, in our new line of work, I would stress the privilege which has been ours in co-operating with the Department of Religious Education. In the pledge we have given towards the maintenance of Camp Reese, we are helping to provide the young people with an opportunity of training. The possibilities of this Camp have been demonstrated by providing an ideal place for our summer camps and conferences. I hope many women will take advantage of the course which is being prepared for the Adult Division this summer.

Under the influence of our Chairman of Gift of Life, who is also Chairman of the Department of Religious Education, two young women from our Diocese offered themselves last summer for volunteer missionary work and did effective work in the mountains of North Carolina and Tennessee.

In the Retreat Conferences held in the Fall of 1932-1933 we realized the value such gatherings have in developing the devotional life. This privilege we owe largely to the spiritual leadership and practical help given us by the members of St. Marks, Brunswick and Christ Church, St. Simons Island, who carried this project to a successful conclusion.

We have kept in close touch with our missionary, Mrs. Oglesby, who is secretary to Bishop Nichols, of Kyoto. Letters to her friends here at home have proved most interesting. From Dr. John B. Wood who visited the Orient last May we hear of the satisfactory assistance she is giving in that far away mission field.

Deaconess Byllesby continues her fine work among the mill workers of Augusta. Deaconess Van Varick, in the face of a constantly decreasing income continues her splendid work. The Dodge Orphanage on the Island provides a real home for the children gathered there under her care. Deaconess Alexander, a devoted worker among her own people in McIntosh County has been selected as one of the Prayer Partners by the Diocese of Massachusetts. I hope that it may lead that Diocese to take an interest in her work.

The United Thank Offering Custodian has been untiring in her efforts to influence the women of our Diocese to share in the offering of love and thanksgiving which at the Triennial will mean so much to the Church. If we have fallen short of the amount given in former years, we must realize with gratitude that it carries as much loving self-denial and gratitude as did the greater sum a few years ago.

In the past two years we have sent delegates to the Provincial Synod. The annual appropriation of fifty dollars by the Woman's Auxiliary has made this possible. The benefit derived from this procedure has been great. It has brought our members in touch with the great leaders and program of our Church and they in turn have brought us a new vision and inspiration. I trust you will continue this custom and will send a delegate to the Triennial at Atlantic City, October 10-20, 1934.

Our objective of organizing all women's groups into one central group, divided into circles, chapters or guilds stimulating in all the circles the aims of the Woman's Auxiliary, is being carried out in many of our Churches, notably st. Paul's, Augusta, St. Mark's, Brunswick, St. Michaels and All Angel's, Savannah, and many others. This plan has the approval of The Natioanl Council, varying according to local needs, and I trust may be carried out in all Churches in our Diocese.

The observance of the Quiet Day of Prayer was generally followed throughout the Diocese. The great Church-wide movement under the leadership of the Presiding Bishop has been put before you by our Bishop. The purpose of "The Church-Wide Endeavor," as it is called, is to quicken the life and faith of the Church. To each of the Branches has been sent the leaflet called "The Message in Brief."

I am giving you the leaflet, "The Way of Vision." It has been prepared for the Woman's Auxiliary by our Provincial President, Mrs. Cain. She sends it to you, trusting it may call you to share in the prayer, reading, and study being done by the women in preparation for the coming Triennial. At that time our Church will perhaps face graver problems and issues than at any other time in her history. We must be prepared.

Let us pray that our leaders may see the issues clearly and be given the wisdom and courage to carry out God's purposes as directed by Him.

REPORT OF THE EDUCATIONAL SECRETARY

In accordance with the established custom of our Diocese, statistics relating to mission-study classes are given in the reports of the District Vice-Presidents, so your Educational Secretary passes to the announcement of courses for 1934-35 and to certain important considerations in that connection.

The National Council, through its Secretary for Missionary Education, the Rev. Arthur M. Sherman, S. T. D., gives us two themes, "Japan" and "Orientals in America."

No doubt there will be ample parallel reading. Dr. Sherman recommends "Christ and Japan," by Kagawa and "World Tides in the Far East," by Basil Matthews, as valuable adjuncts to the text books announced.

The Constitution and By-Laws of our Diocesan Woman's Auxiliary states, "The Educational Secretary shall guide the educational work of the Diocesan branch. She will endeavor to form a study class in every parish and mission."

A worth while study class presupposes discipline and training, especially for leaders; and such groups have every right to look to us for educational guidance.

Feeling this very strongly, the present Secretary stresses the need for an intensive course under Dr. Sherman's guidance.

Your earnest consideration of this important matter is urged. Let us give it the right of way in extension work for 1934-35, confident in our Lord's blessing upon every high ideal.

*of the*FORTY-SECOND ANNUAL MEETING OF THE WOMAN'S
AUXILIARY TO THE NATIONAL COUNCIL
DIOCESE OF GEORGIA

MAY 16, 1934, CAMP REESE, ST. SIMONS ISLAND, GA.

MORNING SESSION

The Forty-Second Annual Meeting of the Woman's Auxiliary of the Diocese of Georgia was opened by the President, Mrs. F. B. Screven, with the Woman's Auxiliary Prayer.

Mrs. A. C. Hartridge, as Brunswick District Vice-President, welcomed the delegates.

Mrs. A. C. Hartridge, Chairman of Credentials Committee reported ten officers and thirty-six delegates present. Branches not represented were eight.

Minutes of the Annual Executive Board were read by Mrs. J. B. Walthour, and accepted as read.

The President, Mrs. Screven, made her annual report.

The program was adopted as presented.

The Reports of the Recording and Corresponding Secretaries were read and accepted.

The Report of the Treasurer was read by the Corresponding Secretary.

Mrs. W. B. White, the United Thank Offering Custodian, made her report.

Reports were read from the District Vice-Presidents: Mrs. Ticknor, Albany; Mrs. Noel Wright, Savannah; Mrs. A. C. Hartridge, Brunswick; and Mrs. H. P. Burum, Augusta.

The Educational Secretary, Mrs. C. H. Lee, made her report.

Mrs. James Mathis, the Supply Secretary, made her report.

Miss Margaret Weed, of the Diocese of Florida, led the Noon Day Prayers and brought us an inspirational message.

Miss Louise Starr, the Student Secretary at Athens, made an informal talk.

The Nominating Committee, Miss Eugenia Johnston Chairman, presented its report.

AFTERNOON SESSION

The Bishop sent greetings to the Women and regretted that he could not speak to them.

The Chairmen of the Committees were heard from. Mrs. Stuart Gibbs made a report on the Georgia Clergy House at Saluda. Mrs. J. H. Parker read the report of Miss Annie Laurie Hills, Chairman of the Prayer Committee.

Mrs. J. H. Parker made a stimulating report of Bishop Perry's Message to the Women at the Synod.

Mrs. J. B. Walthour made her report of the Synod at Montgomery.

Upon the recommendation of the Executive Board the Auxiliary voted to pledge one hundred dollars (\$100.00) toward the current expenses of Camp Reese instead of including it in the Advance Work Project.

The motion made by Mrs. Cobey that the Educational Secretary be empowered to make plans for a leadership training class at the Adult Summer Conference carried.

The motion made by Mrs. Hartridge that one hundred dollars (\$100.00) be set aside annually for a Delegate's Traveling Expense Fund carried.

The motion made by Mrs. W. B. White that the Year Book be condensed was carried.

The motion made by Miss Eugenia Johnston that the Budget be referred to the Finance Committee and the President for proration was carried.

Election of Officers followed. It was moved and passed that the Secretary cast the ballot according to the report presented that morning by the Nominating Committee. A list of Officers of the Diocesan Auxiliary appears elsewhere in this book.

The election of delegates to the Triennial to be held during the Fall of 1934 in Atlantic City followed. The results of the election are as follows:

REPORT OF DELEGATES

TO THE SYNOD AT MONTGOMERY, ALABAMA
OCTOBER, 1933.

Eugene O'Neal in that stimulating play *The Fountain of Youth*, writes "Often we see only things, not the spirit behind them. Our hearts are then as muddy as a pool in which the deer have tramped." Today it is the spirit behind the things which happened at the Synod, that I am anxious for you to see. Therefore, I shall neither list lecturers nor give you subject titles but will try to show you some of the things that germinated out of that Conference and hope that they will find a place of growth in this Diocese.

In the midst of busy Montgomery, yet apart from the crowds there was a place where delegates met many times daily in an endeavor to realize a full and creative life in the growing knowledge of God, that is to discover a way of acting; a way of making the full and creative life possible for all people.

Mrs. Cain in a most stirring talk gave us our marching orders, which were, "Go forward, with faith in yourselves, your future and your Church." If these orders are accepted there will no longer be five hundred million Church members with only a paltry thousand to spread the gospel. Our inertia will end with an adequately supported Church and we will "go forward" with creative enthusiasm to accomplish the task.

This message was again driven home by Miss Grace Lindley when she said, "Christianity should be a well of life springing up within us—not only a consolation for the sorrows of today—but a challenging hope for tomorrow." The instruments we are to use are three: first Schools, second Hospitals, and third Churches. In order to use these instruments intelligently we must have trained leadership. Hence there is a necessity for Laity Training Schools. Education, as you know, is a continual process. One is never really educated. Only through a continual knowledge of holy things combined with an actual working endeavor can one answer the question "What is the Christian destiny of man?" According to Dean Ness, "The destiny of man is to praise and serve God, for it is that only that raises us to divine levels."

The spirit behind the Synod is beautifully expressed in the following small poem:

*"Open the windows of your wondering heart
To God's supreme creation; make it yours,
And give to others your ample store;
For when the whole of you is but a part
Of joyous beauty such as e'er endures,
Only by giving can you gain the more."*

C O N S T I T U T I O N

ARTICLE I.

This association shall be called the Georgia Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

The object of this association shall be to help the National Council in the five fields of service.

ARTICLE III.

All baptized women of this Diocese are eligible to membership.

ARTICLE IV.

SECTION 1. There shall be a President, four Vice-Presidents (one from each district), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Thank Offering, Educational Secretary, Supply Secretary and Secretary of Spirit of Missions.

SEC. 2. These officers shall constitute the Executive Board.

ARTICLE V.

SECTION 1. All officers shall be elected at the Annual Meeting for one year and be eligible for re-election to the same office, with the exception of the U. T. O. Custodian, who shall be elected for a period of three years from General Convention to General Convention.

SEC. 2. At the Annual Meeting each Branch shall be represented by its president or her representative and one other delegate.

SEC. 3. Each branch shall be entitled to one vote, provided a delegate from that branch be present.

SEC. 4. The Nominating Committee shall report at second session of first day; and the election take place at the first session the next day.

SEC. 5. Delegates to the Triennial Meeting and to the Annual Meeting of the Synod shall be nominated and elected from the floor.

SEC. 6. Should a vacancy occur in the President's office, the Bishop shall appoint some one for the unexpired term.

SEC. 7. Should a vacancy occur in any of the other offices, the President shall appoint some one for the unexpired term.

B Y - L A W S

ARTICLE I.

Duties of Officers

SECTION 1. The President shall preside at all Annual Meetings and Executive Meetings, and shall have the general supervision of the work of the Branch.

SEC. 2. The Vice-Presidents shall have the general supervision of the District to which they belong, and when requested by the President, may act for her.

SEC. 3. The Recording Secretary shall keep the minutes of the Annual Meeting and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report after same has been submitted to the President for approval.

SEC. 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

SEC. 5. The Treasurer shall receive and disburse all the money, contributions, except the United Thank Offering, and shall make an annual report of same.

SEC. 6. The Custodian of the United Thank Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

SEC. 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She will endeavor to form a study class in every Parish and Mission.

SEC. 8. The Supply Secretary shall receive from National Headquarters the Advent and Lenten Box assignments for the Diocesan Branch and shall notify each Parish and Mission of its quota, based on its ability to give.

SEC. 9. The Secretary of the Spirit of Missions shall get in touch with each Auxiliary Branch in the fall, urging the members to subscribe to the Magazine. It shall be her duty to make a report at the Annual Meeting, of the number of subscriptions in the Diocesan Branch.

ARTICLE II.

Meetings.

SECTION 1. There shall be an Annual Meeting in the spring of the year, the date to be appointed by the Bishop.

SEC. 2. There shall be, if possible, an annual meeting of each District.

SEC. 3. There shall be an annual meeting of the Executive Board, preceding the Annual Convention. A semi-annual meeting of the Board shall also be held.

SEC. 4. The annual election of officers of the various branches shall take place each year in December, the officers to take up their duties at the first meeting in January.

SEC. 5. The legislative and judicial power of the society shall be vested in the Annual Meeting. In cases of emergency occurring between the time of Annual Meetings the Executive Board shall have full power to act. At the Annual Meeting and at the meetings of the Executive Board a quorum for the transaction of business shall consist of those present.

ARTICLE III.

Finance

SECTION 1. The Finance Committee shall present the year's Budget at each Annual Meeting to be adopted by a two-thirds vote of those present.

SEC. 2. The items in the Budget shall conform to the work of the Woman's Auxiliary to the National Council.

ARTICLE IV.

Committees

The Standing Committees shall be, Prayer, Gift of Life, Finance, Extension Project, Program, and Georgia Clergy House, and such other committees as may be necessary.
