

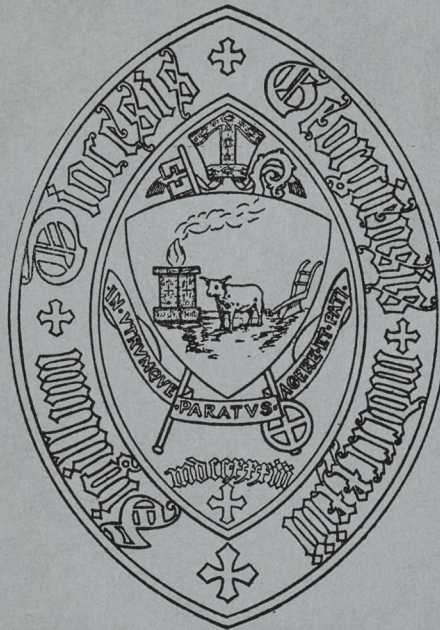

NATIONAL AUXILIARY

In the Episcopal Church in the United States are seven organizations among women that are national in scope. These are: The Woman's Auxiliary, the Church Periodical Club, Daughters of the King, Church Mission of Help, St. Barnabas' Guild for Nurses, and the League of Patriotic Service. Of these, the Woman's Auxiliary is the oldest and the largest.

The Woman's Auxiliary to the Board of Missions came into being October 16, 1871. In January, 1872, headquarters were established in a rented room in the Bible House, New York, with Miss M. A. Emery as the first Secretary. The Mission Board assisted the Auxiliary in every way possible in getting its object known and its work established in the Dioceses all over the country. The Secretary obtained the approval of one bishop after another and one priest after another and they established diocesan and parochial branches, until, in 1919, 3,678 parishes were enrolled in the Woman's Auxiliary, and diocesan branches stretched from Hankow to Texas and Porto Rico to New York.

In 1919, at the great Detroit Triennial Convention, great changes took place in the organization of the Church. Up to this time, the work of the general Church was carried on by three

boards—Board of Missions, Board of Religious Education, and Board of Christian Social Service. For nearly fifty years the Woman's Auxiliary had worked as an auxiliary to the Board of Missions. At this time, however, the Presiding Bishop and Council was created, and the work of the Church divided among six departments, of which the Department of Missions is one. At this convention the question arose as to whether the Woman's Auxiliary should become an auxiliary to one department or to the National Council. The Convention decided that it was an organization too large and too important to become an auxiliary to the Department of Missions, so the Woman's Auxiliary was asked to become an Auxiliary, to the Presiding Bishop and Council, which means that we now share in all phases of the Church's work.

MINUTES

OF THE FORTY-FOURTH ANNUAL MEETING
OF THE WOMAN'S AUXILIARY TO THE
NATIONAL COUNCIL DIOCESE OF GEORGIA

May 6th and 7th, 1936—Americus, Georgia

MORNING SESSION—MAY 6, 1936

The 44th annual meeting of the Woman's Auxiliary of the Diocese of Georgia was opened with prayer by the Reverend J. B. Lawrence.

Mrs. Mathis, on behalf of the Americus branch of the Auxiliary, welcomed the delegates.

The Secretary called the roll and reported a quorum present.

Mrs. W. B. White, the President, gave a report of her splendid work of the past year and outlined a very inspiring program for the future.

Mrs. H. P. Burum presented the program for the meeting and moved its adoption. Mrs. Young seconded the motion and the program was adopted as presented.

The reports of Mrs. C. J. Williamson, Corresponding Secretary, and Mrs. Ernest Squire, Treasurer, were read and accepted.

Mrs. Frank Sheffield, Chairman of the Credentials Committee, reported the following present: 11 officers and chairmen of the Diocese and 45 delegates, making a total of 56. Three parishes were not represented—Blakely, Cordele and Hawkinsville.

There followed a very beautiful and impressive service known as the "School of Prayer," led by the Reverend C. F. Boynton. He told us that prayer should be a thrilling thing and that if we realized that all mankind had one characteristic in common—family relationship and love—and that our relationship to God is the same as our relationship to our families then prayer for us would become real. He also said that there are five steps in prayer: First, thanksgiving; second, confession; third, petition; fourth, intercession, and fifth, adoration. Then he prayed with us showing us how easy and natural it is to pray to God just as though talking to some loved one in the family.

Mr. John Bell Towill then came before the meeting and presented the new Diocesan paper and asked our assistance in obtaining subscriptions. There are to be six editions at fifty cents a year.

In the absence of Mrs. E. C. Blount, Mrs. Davenport read the Memorial Service.

Mrs. Roy Breen, who has been appointed to fill Mrs. R. Y. Smith's place as United Thank Offering Custodian, read her report.

The reports of the District Chairmen followed: Mrs. J. E. Mathis for Albany; Mrs. Jackson Harris for Augusta; Mrs. Young read Mrs. Hartridge's report for Brunswick, and Mrs. Pratt read Mrs. E. B. Freyer's report for Savannah.

The reports of the Supply Secretary, Mrs. H. W. Young, and the Secretary of the Spirit of Missions, Mrs. F. B. Screven, followed.

Mrs. White announced that there would be a joint session of the meetings immediately following lunch.

Deaconess Byllesby gave a short talk on the work of deaconesses, saying that their training was the same as that of deacons. She also said that the difference between sisters and deaconesses is that sisters are an organization in the church and that deaconesses are officers of the church.

Deaconess Alexander, who is the only colored deaconess in the country, thanked the Auxiliary for the great honor bestowed on her and gave a short history of her life and work.

The meeting was then adjourned for lunch.

AFTERNOON SESSION

Mrs. Marshall Ellis gave a very helpful talk on the financial set-up of the Atlanta Auxiliary. Believing that every woman should bear a part of the burden, each confirmed woman of the church is assessed ten cents. This money is used for traveling expenses of the officers and delegates and for other incidentals. New workers are gained in collecting this tax by contact with the women.

Mrs. J. W. Griffith, Chairman of the Gift of Life, made her report next, and, in the absence of Mrs. Gibbes, the Secretary read the report for the Saluda Clergy House. The Secretary also read the report of the Extension Work for the Chairman, Mrs. Blount.

Mrs. White appointed Mrs. Myrick and Mrs. Cobey to the Courtesy Committee.

Mrs. Burum read the report of the Finance Committee in the absence of Mrs. Skinner. The meeting empowered the Finance Committee to make the budget fit the pledges received.

Bishop Barnwell then addressed the meeting, expressing his appreciation of the splendid work done all over the Diocese and urging us not to become impatient with our non-missionary minded brothers and sisters for time will bring them around. He also paid a tribute to our President for her fine leadership. He then told us of a \$694.00 cut in our Negro work and urged us to help raise this amount. He went on to say that selfishness is the cause of all the trouble in the world and that the Gospel of Jesus Christ is its only cure. God wants to use the Church as a channel through which to cure these ills. We must widen our religion and deepen our love.

A discussion of a central fund followed. Mrs. Cobey moved and Mrs. Harris seconded the motion that we try to contact

every confirmed woman of the church and obtain from each ten cents toward the traveling expense fund. The motion was carried.

Mrs. Hazard moved and the motion was seconded and passed to take \$40.00 from the contingent fund to add to \$10.00 from Christ Church, Savannah, to finish building Deaconess Alexander's room in Pennick.

Mrs. Screven announced that Christ Church, Savannah, had come under the National Plan for Auxiliaries and that Mrs. Shelby Myrick is their new President.

Mrs. Burum moved and Mrs. Cobey seconded the motion that the Woman's Auxiliary approve a date early in October for the meetings to be held at Camp Reese provided that the fiscal year be changed. The motion carried.

Donations for linen for the Saluda Clergy House were asked.

Mrs. White asked to have the questionnaires answered tonight and brought back in the morning.

Mrs. Harris moved that the meeting be adjourned.

THURSDAY MORNING—MAY 7, 1936

The meeting was opened with prayer by the Reverend Mr. Cobey.

The minutes of the previous meeting were read and approved.

Mrs. Henry McMillan then gave a delightful talk on the work of the Woman's Auxiliary. She told us that Discipleship was the theme at Atlantic City and that the Forward Movement has helped us carry this idea along. She spoke most feelingly on the splendid work being done with the United Thank Offering. She urged that everyone attend some summer conference, as they give you, first, a closer sense of fellowship; second, a renewed study of our faith; and, third, a deepened realization of our nearness to God. She asked that we study with care our next year's study course, "The Negro," and then she ended her talk with the hope that the leaders present might be able to make the other women at home realize their responsibility.

The Secretary then read the report of Mrs. Asbury Hull, Chairman of the Prayer Committee.

Mrs. White read the questionnaire and gave the correct answers.

The election of delegates to the Synod followed. Mrs. Mathis, Mrs. Charlton Theus, Mrs. H. P. Burum and Mrs. Flanders were elected as delegates, and Mrs. Davenport, Mrs. Screven, Mrs. Hagler, and Miss Elizabeth Stephens as alternates.

Mrs. Griffith read a very lovely message from our Prayer Partner, Mrs. Oglesby. Miss Anne Blount was asked to reply.

Mrs. Myrick read the resolutions of the Courtesy Committee which were as follows:

The delightful informality of the reception in the Parish House gave us the opportunity of renewing old friendships and forming new ones. We wish to thank our hosts and hostesses for the hospitality extended to us during our stay in their homes and for the long automobile rides given us, showing us the beauties of the gardens and homes. Some of the most beautiful flowers have adorned all parts of the Church and Parish house and we will not forget the baskets of poppies on the long board on which was heaped the true Southern bounty of a barbecue picnic. The dignity of the gathering and the grace of the services have been important facts for us to carry home with us.

We appreciate the favors of the Press and the numerous manifestations of the people of Americus and particularly of the Rector and the members of Calvary Church for the welfare of their guests.

REPORTS

REPORT OF PRESIDENT

Most of the Auxiliaries have taken as their key note for 1936 "Close to Christ and Forward with Him."

Let our one aim be to go Forward, not backward, to climb, not to slip, to reach out and get what we aim for, and with this thought I greet you.

It does not take long for a year to slip around and it has been nearly that length of time since our last convention held in Albany and I feel that we have gone forward. It has been a busy year with me.

Among the first activities after my return from Japan was a trip to Sewanee where I went to give the address of welcome to The Woman's Auxiliary of the Province of Sewanee (The Fourth Province).

In October I attended a most inspirational meeting of The Synod, held in Lexington, Kentucky, the splendid minutes of which were sent by your delegate, Mrs. Mathis, less than a week after her return.

In November five women from the Diocese of Georgia went to New Orleans to a Regional Conference conducted by Miss Grace Lindley, National Executive Secretary, Miss Beardsley of the Educational Department, Miss Wade, Supply Secretary, and Miss Anderson of the Field Department, which was, I am sure, of great importance to us all. Mrs. Wentworth Young of St. Simon's Island sent her report out of this meeting in less than ten days and it was a good one and if you read it you had a good insight into what is going on.

I have attended four District Meetings, and they were splendidly conducted and well attended. Held two executive Board Meetings in Savannah. Attended two Church Council meetings, also in Savannah. Issued a Yearly Program—which I hope has been carried on. Spoke eighteen times on "Our Missions in Japan," in Georgia, Tennessee, Kentucky, South Carolina. Compiled and written four hundred and sixty programs, circular letters, letters and post cards. Issued a call for a Quiet Day of Prayer. The World Day of Prayer and the Convention Call.

I visited Fort Valley twice and attended on May 5th, the dedication services of the Deaconess Alexander Room, thereby showing the appreciation of the Diocese of Georgia for the wonderful work done by the Deaconess for the uplift of her race. We are deeply grateful to her and may she live long to continue her work and may God's blessing rest upon her.

So much for the past year. Now, what about this year?

First let "Forward" be our watchword. Forward in getting more women interested in Auxiliary work, attending meetings regularly, aim to bring some new member to every meeting, interesting the younger women. Going to General Convention, Synod

Meetings, Conventions, District Meetings, Camps, attending Summer Training Schools, keeping informed of Church activities by reading Church papers. Know what the United Thank Offering means and what a wonderful work it does.

At Christmas and Easter send cards of a spiritual kind, not Santa Claus and Bunny Rabbits.

Parish Presidents make your meetings so interesting everyone will look forward to the next meeting with pleasure instead of saying, "Oh! Yes, Monday is the Auxiliary Meeting, Oh! My." And don't talk "Money" at every meeting. It does scare people away to know that every meeting you are to be begged. Make your pledges to the Auxiliary Work large enough to avoid this.

Let your conscience be your guide and give until you know the joy of giving and don't wait to be asked. Go some day to your President and say, "Can't I give you a contribution for some special need?" True, she may drop dead and you may have to send flowers, but try anything once.

I do hope every Parish Branch of the Woman's Auxiliary will have one or more representatives at Camp Reese Adult Conference to be held June 20th, to July 4th.

Learn your Parish problems and all your responsibilities (as a sister diocesan has said).

Are we thinking and acting fearlessly today? Are we serving and sharing unselfishly? Are we seeking humbly to learn. Are we praying and worshipping devoutly?

The call comes to us first to turn, not from the careless past, but to the glorious possibility of the present and future.

I cannot close without thanking all who have rendered such valuable assistance to me during the year past. Every officer, Diocesan and Parish, at all times has responded to every call most graciously. Without their cordial co-operation I could never have carried on, and to them I offer my renewed thanks.

Let us accept our responsibilities as Christ's disciples and carry Forward His work in 1936 and 1937 as never before.

REPORT OF EDUCATIONAL SECRETARY

When I was allowed space on the Woman's Auxiliary page of the new **Forward in Georgia** issue, I, of course, hoped to follow up in person at the Annual Meeting what was there said as to our educational work, but a fractured right wrist has put me out of the running these seven weeks, and I am grateful for the courtesy of our President and our Secretary, who enable me to send to our women an *ex post facto* message. I beg you to believe it not the less earnest because so belated.

I have been kindly supplied from the Secretary's records with information which I could not gather for myself, and I am rejoiced to learn that we have had in the Diocese this year an increase of fourteen (14) classes in Missions Study over the year

preceding, but the gain was confined to two districts, those of Savannah and Albany, while Augusta and Brunswick fell below last year's average.

As the Forward Movement says "Forward together," I need scarcely remind you that this is our ideal for Georgia, all the Diocese, all the State, in earnest and intelligent study of the missionary task.

Following our completed courses on Latin America for 1935-1936, we are assigned two, Africa and the American Negro, for 1936-1937.

**NARRATIVE REPORT OF
WOMAN'S AUXILIARY OF DIOCESE OF GEORGIA—1935**

Missionary

The missionary of work of our Diocese can be briefly stated as follows:

Two Scholarships at St. Mary's Hall, Shanghai, China, and one at St. Hilda's, Wuchcuig, which educates three Chinese girls each year.

In Sendai, Japan, we help to train young native women in church work and kindergarten teaching.

A scholarship, for a boy or girl, at Christ Church School, Anvik, Alaska, gives the advantage of school and a Christian home to an Alaskan child each year. We also maintain a bed in the Hudson Stuck Memorial hospital at Fort Yukon, Alaska. A small contribution is made for Leper work.

In our own Diocese we help our Bishop educate candidates for Holy Orders. We contribute to a Missionary Vacation Traveling Fund and maintain a house at Saluda, N. C., where ministers, or missionaries and their families may spend vacations. We also help meet the expense of educational program of our Diocesan Conference center (Camp Reese) St. Simon's Island, Georgia. We contribute to the salary of the student worker at the University of Georgia. We also make an annual contribution to the Fort Valley Industrial School for Negroes. In addition to that contribution this year we furnished a room in the new infirmary at Fort Valley which is our significant achievement for 1935 in the field of Missions.

We contributed to the work among the blind for the first time this past year and helped Deaconess Alexander (colored) at Penick, Ga. The room at Fort Valley Infirmary furnished by us is to be known as "Deaconess Alexander Room." We wanted in this way to show our appreciation of her very splendid work among her own people.

Supply

All supply assignments were filled this past year. We feel our progress was shown in this field by a more co-operative spirit evidenced in the work.

Social Service

Until the last Diocesan Convention, May 7, 1936, there was no Auxiliary Diocesan Social Service Secretary, hence no condensed report of Social Service work. But I think almost every Parish and Mission does some work that would come under this head, such as visiting the needy and sick of parish and community, preparing and distributing Thanksgiving baskets, Christmas trees and baskets, helping with Red Cross Service, etc.

All of the Augusta Churches helped Deaconess Byllesby with the work at Christ Church Mission (mill people). They help teach

in Church School, Boy Scouts, Mother's Clubs. Furnish needed clothes, both old and new. Help with sewing at her community center. Furnish refreshments for egg hunts, picnics, Christmas tree. Have done a bit more this past year than ever before. The outstanding Social Service project of the past year was, I think, the "Mother's Club" at St. John's Church, Savannah. Needy mothers met once a week and were taught sewing. Materials were furnished and the finished garments given to them. A substantial hot meal was cooked and served each meeting. St. Paul's, Augusta, has started a work along similar lines, but has not ministered to a very large group.

I dare say all Social Service Units in the larger places have what we call pensioners, for whom we pay rent each month, or for milk or groceries or drugs, etc., and families are also helped, as needed, with clothes, food, school books, etc.

Educational

I am sorry to say our Educational work is weak, though we are showing a decided increase in Study Classes and program work throughout the Diocese. Our outstanding achievements in this field the past year were:

Dr. Adelaide Case of Columbia University came to Savannah and gave a series of lectures and discussions. We were keenly disappointed that more churches outside of Savannah did not have representatives there to hear her.

At our Diocesan Conference at St. Simon's last summer we offered a better course for adults than ever before, including a course for Auxiliary workers, but it was poorly attended, except by Savannah women. We sent five women from our Diocese to the Conference at New Orleans in November.

Spiritual Life

We feel an increase in number of and attendance at Bible Classes, Prayer Groups. Increased attendance at weekly communion services—all indicating spiritual growth. The formation of Business Women's classes for Bible study, or program meetings has been encouraging. Many of us are perfectly conscious that our weakness here is the root of every short-coming in each of the other departments of our work; for to be effective and acceptable to Him in whose name it is done all our other work must be the outward and visible expression of the indwelling Spirit. Our hope for the coming year is that we shall abide more and more in Him and His words in us, that we may bring forth much acceptable fruit to the honor and glory of our Father.

More free literature.

Definite plans and suggestions for "Coming Year's Work" in hands of all Parish Educational Secretaries by June 1, at least, so she can read up on various subjects, make her plans and work out her Parish program by September.

CONSTITUTION

Article I.

This association shall be called the Georgia Branch of the Woman's Auxiliary to the National Council.

Article II.

The object of this association shall be to help the National Council in the five fields of service.

Article III.

All baptized women of this Diocese are eligible to membership.

Article IV.

Section 1. There shall be a President, a Vice-President, four Chairmen (one from each district), Recording Secretary, Corresponding Secretary, Treasurer, Custodian of the United Thank Offering, Educational Secretary, Supply Secretary and Secretary of Spirit of Missions.

Section 2. These officers shall constitute the Executive Board.

Article V.

Section 1. Officers shall be elected at the Annual Meeting for a period of three years and shall be ineligible for two consecutive terms in the same office, with the exception of the United Thank Offering Custodian, who may serve for six years, or two consecutive terms.

Section 2. At the Annual Meeting each Branch shall be represented by its President or her representative and one other delegate.

Section 3. Each branch shall be entitled to one vote, provided a delegate from that branch be present.

Section 4. The Nominating Committee shall report at second session of first day; and the election take place at the first session the next day.

Section 5. Delegates to the Triennial Meeting and to the Annual Meeting of the Synod shall be nominated and elected from the floor.

Section 6. Should a vacancy occur in the Office of President, the Vice-President shall fill the unexpired term; and thereafter, be eligible for election to the office of President on the same basis with any other candidate.

Section 7. Should a vacancy occur in any of the other offices, the President shall appoint some one for the unexpired term.

BY - L A W S**ARTICLE I.****Duties of Officers**

Section 1. The President shall preside at all Annual Meetings and Executive Meetings, and shall have the general supervision of the work of the Branch.

Section 2. The Vice-President shall perform the duties of the President in her absence.

Section 3. The Recording Secretary shall keep the Minutes of the Annual Meeting and of the meetings of the Executive Board, and shall have charge of the publishing of the Annual Report after same has been submitted to the President for approval.

Section 4. The Corresponding Secretary shall conduct all necessary correspondence of the Branch.

Section 5. The Treasurer shall receive and disburse all the money, contributions, except the United Thank Offering, and shall make an annual report of same.

Section 6. The Custodian of the United Thank Offering shall have charge of all offerings for that fund, and shall endeavor to promote interest in the same throughout the Diocese.

Section 7. The Educational Secretary shall guide the educational work of the Diocesan Branch. She will endeavor to form a study class in every Parish and Mission.

Section 8. The Supply Secretary shall receive from National Headquarters the Advent and Lenten Box assignments for the Diocesan Branch and shall notify each Parish and Mission of its quota, based on its ability to give.

Section 9. The Secretary of the Spirit of Missions shall get in touch with each Auxiliary Branch in the fall, urging the members to subscribe to the Magazine. It shall be her duty to make a report at the Annual Meeting, of the number of subscriptions in the Diocesan Branch.

Section 10. The four District Chairman shall have general supervision of the Districts to which they belong.

ARTICLE II.**Meetings**

Section 1. There shall be an Annual Meeting in the Spring of the year, the date to be appointed by the Bishop.

Section 2. There shall be, if possible, an annual meeting of each District.

Section 3. There shall be an annual meeting of the Executive Board, preceding the Annual Convention. A semi-annual meeting of the Board shall also be held.

Section 4. The Annual election of officers of the various branches shall take place each year in December, the officers to take up their duties at the first meeting in January.

Section 5. The Legislative and judicial power of the society shall be vested in the Annual Meeting. In cases of emergency occurring between the time of Annual Meetings the Executive Board shall have full power to act. At the Annual Meeting and at the meetings of the Executive Board a quorum for the transaction of business shall consist of those present.

ARTICLE III.

Finance

Section 1. The Finance Committee shall present the year's Budget at each Annual Meeting to be adopted by a two-thirds vote of those present.

Section 2. The items in the Budget shall conform to the work of the Woman's Auxiliary to the National Council.

ARTICLE IV.

Committees.

The Standing Committees shall be, Prayer, Gift of Life, Finance, Extension Project, Program, and Georgia Clergy House, and such other committees as may be necessary.

ARTICLE V.

This Constitution and these By-Laws can be changed at any annual meeting by a two-thirds vote of the Delegates present and voting, provided that the proposed change, or changes, has been given in writing to each Branch not less than one month prior to the date of said meeting.
