# CONSTITUTION AND BY-LAWS

## WOMAN'S AUXILIARY OF THE DIOCESE OF HARRISBURG

### CONSTITUTION

#### Article I — Name

This organization shall be known as the Woman's Auxiliary to the National Council in the Diocese of Harrisburg.

#### Article II — Object

The object of this organization shall be to carry out within the Diocese of Harrisburg the purposes and work of the Women's Auxiliary to the National Council, with special emphasis on its missionary activities.

#### Article III — Membership

The membership in this organization shall consist of the Parish branches of Woman's Auxiliary in the Diocese of Harrisburg.

#### Article IV — Officers

Section 1. The officers of this organization shall be the Bishop of Harrisburg ex-officio, a President, a Vice-President at Large, four Vice-Presidents (one from each Archdeaconry), a Secretary, a Treasurer, and a United Thank Offering Treasurer.

Section 2. All officers, with the exception of the four Vice-Presidents, shall be elected at the Annual Meeting by ballot of the Member branches. At the Annual Meeting preceding a Triennial there shall be elected a President

At the Annual Meeting following the Triennial there shall be elected a Secretary

U. T. O. Treasurer

At the second Annual Meeting following the Triennial there shall be elected a Vice-President at large

Treasurer

These officers shall serve for three years, with the privilege of re-election for another term of three years. They shall not be eligible to serve a third term in the same office. The limitation shall not apply to the Treasurer. Vacancies occurring among the officers during their term of office shall, until the next Annual Meeting, be filled by vote of the Executive Board.

Section 3. Each Archdeaconry shall elect (from the two or more names previously nominated by the President) its own Archdeaconry Vice-President at the meeting following the election of President.

#### Article V — Executive Board

The officers, together with the Altar Chairman, Devotional Chairman, Educational Chairman, Chairman of Christian Social Relations, Supply Chairman, Personnel Chairman, the Church Periodical Club Director and Book of Remembrance Custodian shall constitute the Executive Board.

#### Article VI — Meetings

Section 1. The Annual Meetings for the election of officers and other business shall be held the fourth Tuesday and Wednesday of October.

Section 2. Special meetings may be called by the Executive Board at any time. At special meetings only such business as is specified shall be considered.

#### Article VII — Amendments

This Constitution may be amended at any Annual Meeting by a two-thirds vote of the member branches, provided a copy of such proposed amendments shall have been sent to each branch president thirty days before said meeting.

## BY-LAWS

### Article I—Duties of Officers

Section 1. The President shall call all meetings of the organization and of the Executive Board and preside at the same. She shall appoint and fill vacancies in all committees not otherwise provided for in the By-Laws, and shall be a member ex-officio of all committees except the Nominating Committee. She shall direct the editing of the annual report.

Section 2. The Vice-President at Large shall fill the office of President, if vacancy occurs, until the time of the next Annual Meeting, and shall preside at Archdeaconry meetings in the absence of the Archdeaconry Vice-President.

Section 3. The Vice-Presidents shall encourage the organization of new branches in their respective districts, visit the member branches and assist them in their work. Each Vice-President shall prepare and submit a written report at each Board Meeting, and shall conduct at least one meeting a year in her respective Archdeaconry.

The Vice-Presidents shall represent the following Archdeaconries:

1. Vice-President of Altoona Archdeaconry.
2. Vice-President of Harrisburg Archdeaconry.
3. Vice-President of Wellsboro Archdeaconry.
4. Vice-President of Williamsport Archdeaconry.

Section 4. The Secretary shall make and keep, in permanent form, a record of the proceedings of the Auxiliary and of the Executive Board. She shall prepare and submit a report at each Annual Meeting, assist in compiling the annual report and send out all notices.

Section 5. The Treasurer shall receive and transmit all moneys (except the United Thank Offering) due the organization, and shall pay all properly approved bills. She shall present an itemized report at the Annual Meeting and an audited report of her transactions to the Executive Board each year.

Section 6. The United Thank Offering Treasurer shall endeavor to increase and deepen interest in the United Thank Offering by sending out literature pertaining to same. She shall receive and transmit to Church Missions House all the United Thank Offering moneys and make a yearly report. A bond shall be provided for this office by the Woman's Auxiliary of the Diocese of Harrisburg.

### Article II—Duties of Committees

Section 1. The Devotional Chairman, together with her committee, shall plan for devotional study and worship, and shall assist parochial devotional chairman in adapting these plans to the needs of their own branches.

Section 2. The Educational Chairman shall have general supervision of all missionary educational work undertaken by the Woman's Auxiliary, and shall work closely with the chairmen of other committees in formulating an inclusive program covering education in the various fields of Auxiliary activity.

Section 3. The Chairman of Christian Social Relations shall, in cooperation with the Education Chairman, conduct a program of education on social problems. She shall be well informed on social issues, and on the teachings of the Church in regard to racial problems, and shall be responsible for carrying through a program of Christian social action.

Section 4. The Supply Chairman shall plan the Lenten and Advent box work and material aid, and in cooperation with the Chairman of Christian Social Relations shall stimulate additional material aid programs.

Section 5. The Personnel Chairman shall conduct a program of recruiting of young people for work in the Church, through education and worship programs, vocational conferences, publicity, study of standards for Church workers within the diocese. She shall work in close cooperation with the Diocesan Youth commission and the Diocesan Department of Education.

Section 6. The Altar Chairman shall solicit and receive altar hangings and other altar furnishings and shall distribute such hangings and furnishings where ever they are needed.

Section 7. The Book of Remembrance Custodian shall have custody of the Book of Remembrance and it shall be her duty to see that names of departed members submitted to her are properly inscribed therein.

Section 8. All Committee Chairmen shall prepare and submit a written report at each Board Meeting.

### **Article III—Nominations and Elections**

Section 1. A Nominating Committee consisting of one member from each Archdeaconry shall be appointed by the President at the Annual Meeting, or within thirty days thereafter, to serve for the following year.

Section 2. The voting body of this organization shall consist of the members of the Executive Board and two delegates from each Parish. Elections shall be by ballot. Voting by proxy shall not be permitted. This same rule shall apply in the election of Archdeaconry Vice-Presidents.

Section 3. Delegates to the Triennial Meeting of the General Auxiliary shall be the President, the United Thank Offering Treasurer and three women from the membership of the Auxiliary, and five alternates from the same to be elected by ballot.

Section 4. Each Parish Auxiliary may submit to the Nominating Committee for its consideration, the name or names of candidates for nomination to the office of delegate or alternate delegate to the Triennial Meeting of the General Auxiliary, together with a statement of her qualifications of not more than 200 words, before May 1st of the year preceding the Triennial Meeting.

The Nominating Committee shall submit a single slate of not less than fifteen candidates for the office of delegate and alternate delegate to the Triennial Meeting. A copy of this slate, together with a statement of the qualifications of each nominee shall be mailed to every Parish Auxiliary and to the members of the Executive Board for study and consideration not later than September 1st preceding the Diocesan Auxiliary Meeting at which such delegates and alternate delegates are to be elected.

The three candidates receiving the highest number of votes shall be elected delegates and the five candidates receiving the next highest number of votes shall be elected alternate delegates to the Triennial Meeting.

Section 5. Each Parish Auxiliary may submit to the Nominating Committee for its consideration, the name or names of candidates for nomination to the office of delegates or alternate delegates to the Provincial Synod meeting before May 1st of the year preceding the Provincial Synod.

The Nominating Committee shall submit a slate of not less than nine candidates for the office of delegate and alternate delegate to the Provincial Synod Meeting. A copy of this slate shall be mailed to every Parish Woman's Auxiliary and to the members of the Executive Board for study and consideration not later than September 1st preceding the Diocesan Woman's Auxiliary Annual Meeting at which such delegates and alternate delegates are to be elected.

The two candidates receiving the highest number of votes shall be elected delegates and the three candidates receiving the next highest number of votes shall be elected alternate delegates to the Provincial Synod Meeting.

#### **Article IV—Finances**

Section 1. A budget covering expenditures for the year shall be prepared by a committee, appointed by the President, and presented to the Executive Board for acceptance and presented to the membership for adoption at the Annual Meeting.

Section 2. An expense fund for all necessary expenses shall be provided by this organization.

Rule 1. Twenty per cent of the total amount pledged for the Expense Fund shall be set aside for the Sinking Fund, to be used at the direction of the Executive Board. All requisitions shall be signed by the President.

Rule 2. At the Annual Meeting, the hostess branch shall entertain, overnight, members of the Executive Board, speakers on the program and two delegates from each branch. Where more delegates register from any branch they shall pay for their own entertainment.

Rule 3. Each branch shall be assessed, in addition to other moneys contributed, the sum of three dollars per year, to be used by the hostess branch to defray the expenses of the Annual Meeting; this fund to be known as the Annual Meeting Fund.

#### **Article V—Amendments**

These By-laws may be amended at any Annual Meeting by a two-thirds vote of the member branches, provided a copy of such proposed amendment shall have been sent to each branch President thirty days before said meeting.

#### **Article VI—Rules of Order**

The rules contained in Roberts' Rules of Order shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with the By-Laws or the Special Rules of Order of this organization.

## REPORT OF CHRISTIAN SOCIAL RELATIONS AND PERSONNEL

Your Christian Social Relations and Personnel Chairman has little to report in actual facts and figures for the past year. Undoubtedly a blueprint of our activities as individuals and groups throughout the Diocese would indicate that we are closely following the program of action as outlined at the Triennial meeting.

This program calls us as Christian citizens to prepare ourselves through prayer, study and discipline for aggressive action to combat with forces of good the forces for evil which we know are powerful, well-organized and active in their attempts to destroy faith in the United Nations, the National Council of Churches and the integrity of our school system.

It is therefore imperative for the women of the church, in their own groups and in cooperation with other local groups of Christian women and the Department of United Church Women of the National Council of Churches to pray as individuals and corporately; inform themselves; develop convictions; and exert their influence with reference to vital issues in the light of Christian principles.

Issues such as:

- 1) The responsibility of the United States for support of and participation in the United Nations and its specialized agencies.
- 2) Economic and technical assistance to under-privileged and under-developed areas at home and abroad.
- 3) Resettlement of homeless people and friendship to those who have settled in this country and to guests of the United States, especially foreign students.
- 4) Protection of our freedoms.
- 5) Extension of human rights to all with special emphasis on our own parishes and communities.

Finding the best possible women for church work is one of the important opportunities facing up as a Personnel Committee. This summer I was asked to interview a young lady who is interested in choosing some phase of church work as her profession. After a personal interview, I talked to her vicar and together we decided that, although she is personally interested in devoting her life to work in the church, she must first continue her education.

I sent her pamphlets concerning various phases of church work and giving qualifications necessary for each. At present she has started her college education. She is receiving financial aid from her home parish and we will follow her progress with interest.

This voluntary contribution was very commendable and I feel sure that the balance of \$9.00 will be forthcoming before my next report.

A check for \$25.00 was, also, sent to M. M. Addinsell, Treasurer, for The House of Bethany, Robertsport, Liberia.

## ALTOONA ARCHDEACONRY

The Woman's Auxiliary, Altoona Archdeaconry, is pleased to report a year of renewed growth and vigor in the parishes, especially in those parishes who now have the full time services of the clergy.

Three groups participated in Quiet Times or other special devotional services; all filled Supply requests promptly and all reported more women sharing in the United Thank Offering. This becomes very significant when it is noted that one group shared in the UTO for the first time in 1953. Only two parishes in the Archdeaconry have more than one organized group of women; in most of the parishes the W.A. includes all women of the parish and in most cases the Altar Committee functions as a part of the total women's service to the church and the privilege of serving the Altar is extended to all the women just as the W.A. seeks to reach all the women of the church through participation in the five fields of service.

Five women of the Archdeaconry attended the Provincial Conference held at Hood College in June. The vice-president was one of these and also attended the meeting of the Governing Board of this Conference, the annual meeting of the Pennsylvania Council of Churchwomen, and visited six of the parish auxiliaries in the Archdeaconry.

The spring meeting was held on April 13 at St. Andrew's, State College. Bishop Heistand was celebrant at the Holy Communion service when the United Thank Offering was presented by the UTO custodians of each parish. Following a Coffee Hour at which the Woman's Auxiliary of St. Andrew's was hostess, the 80 women in attendance were addressed by Mrs. Flynn and Bishop Heistand. The emphasis for the day was Personnel for Christians Vocations and the speaker for the afternoon was The Rev. Jones B. Shannon, rector of St. Andrew's and Chaplain to Episcopal students at Penn State.

The 1954 meeting will be held on May 3 at St. James', Bedford with the Archdeaconry's newest Auxiliary as hostess.

## REPORT OF THE HARRISBURG ARCHDEACONRY

One of the problems which many branches of the Woman's Auxiliary bring to me is how to reach more women. Paradoxically, this is a good sign, not a bad one. The program of the Woman's Auxiliary is to further the work of the church and that means to reach more people. In every case where the branch is trying to find the answer the group is a forward moving one.

In the Harrisburg Archdeaconry this is being done in the following ways: Education—this includes mission study; attendance at Diocesan and Archdeaconry meetings; sending representatives to Provincial Conference. Work—sending supply boxes as requested by the Supply Secretary and many groups add to this by sending to other missions; church school teaching; altar work. Contributions—United Thank Offering always comes first, with Diocesan pledges following; much money given to the work of the parish. To these things must be added the things which don't show in the reports sent me each year—the work for the Church which cannot be counted in hours or dollars and is unstintingly given; the comradeship which comes when we share in the tasks to be done; the feeling that we are one family.

Were these things to be set down as statistics with so many doing this and so many others doing that it would be cold and dull reading, but it has been my privilege to know that the majority of the branches are striving to reach the goal and growing because of it.

St. John's, York, was the scene of the Archdeaconry meeting on April 30th, 1953. About 165 women from 17 branches attended. The meeting was addressed by Bishop Heistand and Mrs. Flynn. The Rev. Jones B. Shannon spoke on work in the Colleges and Pennsylvania State College in particular.

All Saints, Hanover, will be hostess to the next meeting, which will be April 29, 1954.
