# CONSTITUTION AND BY-LAWS WOMAN'S AUXILIARY OF THE DIOCESE OF HARRISBURG

## CONSTITUTION

### Article I — Name

This organization shall be known as the Woman's Auxiliary to the National Council in the Diocese of Harrisburg.

### Article II — Object

The object of this organization shall be to carry out within the Diocese of Harrisburg the purposes and work of the Woman's Auxiliary to the National Council, with special emphasis on its missionary activities.

### Article III — Membership

The membership in this organization shall consist of the Parish and Mission branches of the Woman's Auxiliary in the Diocese of Harrisburg.

### Article IV — Officers

Section 1. The officers of this organization shall be the Bishop of Harrisburg, a President, a Vice-President, a Chairman for each of the four Archdeaconries, a Secretary, a Treasurer, and a United Thank Offering Custodian.

Section 2. The officers, with the exception of the Archdeaconry Chairmen shall be elected by ballot of the voting body of this organization as follows: At the Annual Meeting preceding a Triennial there shall be elected a

President

At the Annual Meeting following the Triennial there shall be elected a

Secretary

U. T. O. Custodian

At the second Annual Meeting following the Triennial there shall be elected a Vice-President

Treasurer

These officers shall serve for three years, or until their successors are elected, with the privilege of re-election for another term of three years. They shall not be eligible to serve a third term in the same office. The limitation shall not apply to the Treasurer. Vacancies occurring among the officers during their term of office shall, until the next Annual Meeting, be filled by vote of the Executive Board.

Section 3. At the meeting following the election of President each Archdeaconry shall elect its Chairman from two or more names previously nominated by the President.

Section 4. The wife of the Bishop of the Diocese shall be an Honorary Vice-President.

### Article V — Executive Board

Section 1. The officers, together with the Altar Guild Chairman, Chairman of Prayer and Worship, Chairman of Christian Education, Chairman of Christian Social Relations, Supply Chairman, Personnel Chairman, the Director of the Church Periodical Club, and the Custodian of the Book of Remembrance, shall constitute the Executive Board.

Section 2. The Executive Board shall meet at approximately the same time as the Annual Meeting and also on the first Tuesday of March of each year. Special meetings may be called at any time by the President, and shall be called by the President on the written request of five members.

Section 3. Quorum. Nine members shall constitute a quorum for the transaction of business.

### Article VI — Meetings

Section 1. The Annual Meeting for the election of officers and other business shall be held the fourth Tuesday and Wednesday of October.



Section 2. A special meeting may be called by the Executive Board at any time. At special meetings only such business as is specified shall be considered.

#### Article VII—Amendments

This Constitution may be amended at any Annual Meeting by a two-thirds vote of the voting body of this organization, provided a copy of such proposed amendments shall have been sent to each branch president thirty days before said meeting.

## BY-LAWS

### Article I—Duties of Officers

Section 1. The President shall call all meetings of the organization and of the Executive Board and shall preside at the same. She shall appoint and fill vacancies in all committees not otherwise provided for in the By-Laws, and shall be a member ex-officio of all committees except the Nominating Committee. She shall direct the editing of the annual report.

Section 2. The Vice-President shall fill the office of President, if vacancy occurs, until the time of the next Annual Meeting, and shall preside at any Archdeaconry meeting in the absence of the Chairman.

Section 3. The Archdeaconry Chairman shall encourage the organization of new branches in their respective districts, visit the member branches and assist them in their work. Each Chairman shall prepare and submit a written report at each Board Meeting, and shall conduct at least one meeting a year in her respective Archdeaconry. In the event that both President and Vice-President are absent at the time of an Annual Meeting, the Chairman of the Altoona Archdeaconry shall preside.

The Chairmen shall represent the following Archdeaconries:

1. Altoona Archdeaconry
2. Harrisburg Archdeaconry
3. Wellsboro Archdeaconry
4. Williamsport Archdeaconry

Section 4. The Secretary shall make and keep, in permanent form, a record of the proceedings of the Auxiliary and of the Executive Board. She shall prepare and submit a report at each Annual Meeting, assist in compiling the annual report and send out all notices.

Section 5. The Treasurer shall receive and transmit all funds (except the United Thank Offering) due the organization, and shall pay all properly approved bills. She shall present an itemized report at the Annual Meeting and an audited report of her transactions to the Executive Board each year.

Section 6. The United Thank Offering Custodian shall endeavor to increase and deepen interest in the United Thank Offering. She shall receive and transmit to Church Missions House all United Thank Offering funds and make a yearly report. A bond shall be provided for this office by the Woman's Auxiliary of the Diocese of Harrisburg.

### Article II—Duties of Committees

Section 1. The Chairman of Prayer and Worship, together with her com-



mittee, shall plan for devotional study and worship, and shall assist parochial devotional chairmen in adapting these plans to the needs of their own branches.

Section 2. The Chairman of Christian Education shall have general supervision of all missionary educational work undertaken by the Woman's Auxiliary, and shall work closely with the chairmen of other committees in formulating an inclusive program covering education in the various fields of Auxiliary activity.

Section 3. The Chairman of Christian Social Relations shall, in cooperation with the Chairman of Christian Education, conduct a program of education on social problems. She shall be well informed on social issues and on the teachings of the Church in regard to racial problems and shall be responsible for carrying through a program of Christian social action.

Section 4. The Supply Chairman shall plan the Lenten and Advent box work and material aid, and in cooperation with the Chairman of Christian Social Relations shall stimulate additional material aid programs.

Section 5. The Personnel Chairman shall conduct a program of recruiting of young people for work in the Church, through education and worship programs, vocational conferencees, publicity and study of standards for Church workers within the diocese. She shall work in close cooperation with the Diocesan Youth Commission and the Diocesan Department of Education.

Section 6. The Altar Chairman shall solicit and receive altar hangings and other altar furnishings and shall distribute such hangings and furnishings where ever they are needed. She shall be available for instruction in the work and organization of Altar Guilds.

Section 7. The Custodian of the Book of Remembrance shall have charge of the Book of Remembrance, and it shall be her duty to receive the names of departed members and to see that they are properly inscribed there in.

Section 8. The Director of the Church Periodical Club shall develop and increase the sending of religious literature, books and magazines to missions, the clergy and seminary students. She shall be appointed by the Bishop.

Section 9. Each committee chairman shall prepare and submit a written report at each Board Meeting.

### **Article III—Nominations and Elections**

Section 1. A Nominating Committee consisting of one member from each Archdeaconry and one from the Executive Board who shall act as chairman, shall be appointed by the President at the Annual Meeting to serve for the following year.

Section 2. The voting body of this organization shall consist of the members of the Executive Board and two delegates from each Parish of Mission participating in the work of the Auxiliary. Elections shall be by ballot. Voting by proxy shall not be permitted. This same rule shall apply to the election of Archdeaconry Chairmen.

Section 3. Delegates to the Triennial Meeting shall be the President, the United Thank Offering Custodian, and three women from the membership of the Auxiltry to be elected by ballot at the Annual Meeting of the year preseding



the Triennial Meeting. Five alternates shall also be elected by ballot.

Section 4. The Nominating Committee shall submit a single slate or not less than twelve candidates for the office of delegate and alternate delegate to the Triennial Meeting, the consent of candidates having been previously obtained.

The three candidates receiving the highest number of votes shall be elected delegates and the five candidates receiving the next highest number of votes shall be elected alternate delegates to the Triennial Meeting.

Section 5. At the Annual Meeting of the year preceding the Provincial Synod the Nominating Committee shall submit a slate of not less than nine candidates for office of delegate or alternate delegate to the Provincial Synod.

The two candidates receiving the highest number of votes shall be elected delegates and the three candidates receiving the next highest number of votes shall be elected alternate delegates to the Provincial Synod. The President shall be a delegate by virtue of her office.

#### **Article IV—Finances**

Section 1. A Finance Committee with the Treasurer as chairman shall be appointed by the President to prepare a budget covering expenditures for the year. This budget shall then be presented to the Executive Board for approval and recommended to the membership for adoption at the Annual Meeting.

Section 2. An expense fund for all necessary expenses shall be provided by this organization.

Rule 1. Twenty per cent of the total amount pledged for the Expense Fund shall be set aside for the Sinking Fund, to be used at the direction of the Executive Board.

Rule 2. At the Annual Meeting, the hostess branch shall entertain, overnight, members of the Executive Board, speakers on the program and two delegates from each branch. Where more delegates register from any branch they shall pay for their own entertainment.

Rule 3. Each branch shall be assessed, in addition to other funds, contributed, the sum of three dollars per year, to be used by the hostess branch to defray the expenses of the Annual Meeting; this fund to be known as the Annual Meeting Fund.

Rule 4. According to its strength each branch shall be assessed annually a sum from two dollars to ten dollars; this fund to be known as the Triennial Travel Fund.

#### **Article V—Amendments**

These By-laws may be amended at any Annual Meeting by a two-thirds vote of the voting body of this organization, provided a copy of such proposed amendments shall have been sent to each branch President thirty days before the said meeting.

#### **Article VI—Rules of Order**

The rules contained in Roberts' Rules of Order shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with the By-Laws or the Special Rules of Order of this organization.

## ANNUAL MEETING 1954

### MINUTES

The opening devotions were conducted by the Rt. Rev. John Thomas Heistand, D. D., Bishop of Harrisburg, followed by a meditation on "Thy Will Be Done", the Bishop's message to the convention.

Mrs. Lewis Dewart, past president of the Woman's Auxiliary of St. Matthew's, welcomed the delegates, clergy and guests.

The President's message to the meeting was an outline, month by month, of the work and duties of the Diocesan President of the Woman's Auxiliary throughout the year.

Mrs. Fred Brennaman, St. Luke's Altoona, and Mrs. Andrew Hay, Mt. Calvary, Camp Hill, presented their reports as delegates to the Provincial Synod held earlier this month in Philadelphia.

Mrs. Carlton N. Jones reported on the Shippensburg Home, its present conditions and the plans for future improvement. Mrs. Jones is carrying on the wonderful work done at the Home by her husband, the late Rev. Canon Carlton N. Jones.

Mrs. Wayne Wagenseller, chairman of Christian Education, presented a report on the theme for the year, "India, Pakistan and Ceylon", and the home topic, "The City." Mrs. Wagenseller called the attention of the delegates and guests to the display in the rear of the church of text books, devotional materials and other books related to the study subjects.

The Rev. Canon Heber Becker presented an illuminating report on the Anglican Congress held in Milwaukee in August.

Dinner was served at the Presbyterian Church at 6:15.

At the evening Mass meeting held at St. Matthew's, the Rt. Rev. John B. Bently, assistant to the Presiding Bishop, and Vice President of the National Council, addressed the assembly on "The Overseas Mission of the Church". Beginning with the birthday of the Church at Pentacost, Bishop Bently traced the history of the missionary work of the Church throughout the ages, and by means of a "flying carpet", took us to a remote mission on the barren coast of Alaska, then to the southernmost part of Brazil, across the Atlantic to the hinterland of Liberia and from there east or west to Japan, outlining the work being done by the missionaries of the Church, in each of these far-flung places.

At 7:30 a. m. Wednesday, October 27, the service of Holy Communion was celebrated by the Rt. Rev. J. Thomas Heistand, assisted by the Rev. George Shilling, the Ven. Frederick Holmes, and the Rev. E. The morning session convened and was called to order by the President at 9:30 a. m.

As the minutes of the previous meeting were printed in the Year Book the reading of the minutes was dispensed with.

Thirty-eight Branches and 14 members of the Executive Board responded to roll call.

Mrs. Marc Bodine, chairman of the Committee to amend the By-Laws, presented the revised By-Laws, explaining the changes which had been made. Mrs. Bodine moved that the amended By-Laws be accepted as presented. Mrs. Fleming seconded the motion. The motion was carried.

Mrs. Flynn announced that 1955 is the 50th anniversary of the Woman's Auxiliary in the Diocese of Harrisburg, and asked that anyone having any notes in regard to the history of the W. A. send them to Mrs. Edward Fleming to be used in preparing the program for the next meeting. She also announced that Miss Anne Lamberton is home from her mission station in the Far East, and will go on to Puerto Rico for three years, where she will be joined by her sister Mary Miss Elizabeth Falck is coming home on furlough. Mrs. Flynn called the attention of the delegates to the radio program, "Another Chance", which will have to be obtained for use on local stations as it is not possible to reach the entire Diocese from one central broadcasting station.

Mrs. Flynn presented the Rev. Clarence C. Reimer, of St. Johns, Bellefonte, who spoke on the work being done by the Brotherhood of St. Andrew, particularly in York and Bellefonte, and offered to help bring the work into any parish desiring to organize a Brotherhood.

Mrs. Fleming presented the treasurer's report. The report was accepted.

Mrs. Fleming then presented the tentative budget and special gifts. Mrs. Fleming moved that the budget and special gifts be accepted. Mrs. Nye seconded the motion and it was carried.

Mrs. Flynn presented the Rt. Rev. Quentin K. Y. Huang, D. D., Bishop of the Holy Catholic Church in China, Associate Rector of St. Stephen and the



Incarnation, Washington, D. C. Bishop Huang spoke on the means by which the Communists took over the Church in China, which was made easier for them due to lack of Christian workers and lack of funds. By 1950 the Communists had stopped all work in mission schools and hospitals, no services were allowed in rural areas. By 1952, Christianity was a crime and must be swept away. In his city 10,000 were arrested, Bishop Huang among them. He was imprisoned for seventy-nine days subjugated to Red indoctrination, forced to manual labor and mental torture, but by the Grace of God he was able to withstand a tempting offer to work for the Communists and to escape, over the Burma Road. In China today, western churches are denounced, a new national church is organized, schools and hospitals have been taken over and the orphanages are training children for the Party. The theological seminaries have Russian professors arriving to organize propaganda and Christians are being eliminated. Work seems hopeless, but nothing is impossible with God. There are 4,000 Chinese studying and working in the U. S. who hope some day to return to their homeland and Bishop Huang begged that Christian homes be opened to them to give them the right impression of America so that they may build for the future. Bishop Huang expressed no regrets over his prison experience because he had learned to many valuable lessons, suffering, patience, appreciation of freedom, and security in God, having faith that Christianity is the Armor of God.

One of the greatest fears in the world today is the fear of being alone, of being left out. As we take our place in Corporate Worship and study our brothers round the world, we shall develop a sense of our relationship in God's great family and realize that we are never left out and that we can never be alone.

Report of the Church Periodical Club to the Diocese of Harrisburg, October 26, 1954:

"If you only knew what the CPC means to me" this phrase appears again and again, in the letters that come to me as Church Periodical Club Director. They appear in letters from missionaries abroad, in letters from missions at home, in letters from seminary students, in letters from institutions. And I sometimes think we become so enmeshed in the mechanics of the Church that we lose sight of our true ideal. We become so busy in bringing the Church to the uninitiated that we fail to remember that we are representing Christ.

The Diocese of Harrisburg make a good showing in the Provincial CPC but nothing spectacular. We place a contribution in all the earmarked funds, but a very small contribution. In other words we are conforming but is our heart in it. Why won't 21 of our parishes do any CPC work even when the worth of that work has been explained over and over? Why is it that half of the parishes who are doing CPC work have to carry the load financially and the other half only do the least possible?

Be sure to follow it with some discussion and plans for action. Did you read the new version of Tell Us About Personnel in the September issue of Churchways? Recruitment, Vocational Conferences, Testing and Training Program, and Scholarships are all important phases of the Personnel Department. Today more than ever before the Church needs the services of Women Workers if it is to go forward in its evangelistic, educational and social mission.

Our quota was \$190, but one check for \$2.00 was mistakenly sent to Japan and I have not so far been able to trace it, and the other \$2.00 I trust will soon be forthcoming.

## ALTOONA ARCHDEACONRY

The Woman's Auxiliary Altoona Archdeaconry, held its Spring meeting on May 3 at St. James', Bedford. Every parish auxiliary was represented and exchanged information with each other as to the women's work in the parishes. This exchange brought out the very exceptional work the women are doing in the field of Christian Education and Christian Social Relations. A presentation of the United Thank Offering took place at the Holy Communion Service. Mrs. Edward D. Flynn addressed the 85 women present and the afternoon session was highlighted by a program of "Builders for Christ". The offering was given to the Bishop's Fund for Seminarians.

Four women of the Archdeaconry attended the Conference of the Province of Washington held at Hood College in June. The vice-president was one of these and also attended the meeting of the Governing Board of this Conference, the annual Conference of United Churchwomen of the Pennsylvania Council of Churches at Lebanon, an Archdeaconry Parish-life Conference at Grier School, a Christian Education Demonstration Conference at Peterkin Center, West Virginia and one day of the Provincial Synod held in Philadelphia.

Visits to Several Auxiliaries in the Archdeaconry have been made and the vice-president was guest speaker at St. Pauls, Lock Haven, in April and will speak at St. Mark's, Lewistown, in the Spring.

The 1955 meeting will be held at St. Luke's, Altoona, on Monday, April 25.

## REPORT OF THE HARRISBURG ARCHDEACONRY

Reports from parish branches in the Harrisburg Archdeaconry show a varied pattern as usual. Some are full of life and have many activities and others are just coasting. As a general thing an auxiliary that is extending itself and going forward in the work of the Kingdom is enlarging its membership and its giving at one time. The branch doing only what has to be done is getting nowhere. Several report on new equipment and furnishings for their home church. Many are working at sending supplies all over the world, over and above what is asked by our supply chairman. One has taken up a new activity locally in mending for a children's home. More branches are interested in entering names in the Book of Remembrance. All participate in the supply work requested, members serve on the Altar Committee, and, where there is a church school, Auxiliary women are teachers.

The spring meeting of the Harrisburg Archdeaconry was held at All Saints, Hanover, on April 29, 1954. Representatives from twenty branches attended, filling the building to capacity. As All Saints' is so new and services are conducted in a remodeled house, they were very courageous to act as hostess, but did it so commendably that they have encouraged many small branches. Holy Communion was celebrated by the Rev. George Toadvine, assisted by the Rev. Martin Knutsen, Vicar of All Saints'.

Mrs. Edward D. Flynn, Diocesan President, addressed the business meeting which followed, giving an account of Christian World News. She also explained the "Builders for Christ" campaign, and urged that delegates be sent to the Provincial conference at Hood College.

The Rev. Mr. Albert Rich was the speaker of the morning and gave a most interesting and informative account of his Field Work in Alaska. Colored slides and native handiwork gave added interest.

Following noon day prayers under Canon Clifford Best, the meeting recessed for luncheon at the Y.W.C.A. The afternoon session was opened with devotions by Mrs. George C. Graeff.



The Rev. Carlton N. Jones was to have been the afternoon speaker and his recent and untimely death was saddening to all. In his place Mr. Edwin Strite, chairman of the board of Shippensburg Home for the Aged, spoke. He paid tribute to Mr. Jones' fine work at the Home and went on to report on the conditions now prevailing there.

As Bishop Heistand was unable to be present due to a previous engagement, Mrs. Jones, presiding officer, brought greetings from him and expressed his appreciation for the Bishop's Birthday Fund with which he was able to assist several young men studying for the ministry

The meeting will be at Mt. Calvary, Camp Hill, in 1955 on April 28th.

## REPORT OF THE WILLIAMSPORT ARCHDEACONRY

The annual meeting of the Woman's Auxiliary of the Archdeaconry of Williamsport was held at St. Andrew's Church, Lewisburg, on Thursday, April 22nd, 1954, with the members of the Woman's Auxiliary Branch of that Parish, under the leadership of Mrs. W. H. McKnw, President, acting as hostesses. About 100 persons attended his meeting. Mrs. Edward Flynn, President of the Diocesan Auxiliary, gave us an excellent review of the larger work of the Auxiliary. We regretted the absence of Bishop Heistand. A part of the program which was of special interest and inspiration was the address by the Reverend Dr. Nelson Waite Rightmyer, of the Diocese of Maryland, on the subject, "A Layman Goes to Holy Communion."

A review of reports, both written and oral, given by the Branches during the year, shows that, almost without exception, the Branches follow a three-fold program of prayer, study and work, prayer in quiet days and devotions, study as a part of the program of the Branch meetings, and work in various fields. These fields of work include work within the Parish in Sunday School and Altar Guild, in the community by participation in community welfare and service projects, and in the wider field of the Church through aid to missions, mission school supply and the Shippensburg Home.

A substantial number of the Branches reported one or more Corporate Communion during the year, while one Branch reported monthly corporate Communion. All but two Branches reported participation in the United Thank Offering.

The reports also show that the work of the Auxiliary is supported in varying degrees by the women of the Parishes within the Archdeaconry. One report indicated that all, 100%, of the women participated. Others show varying percentages, running from 95% to 20%. We have a real challenge in presenting and interpreting the work of the Auxiliary and its place and purpose to some of our women.

Two activities were of particular interest as an evidence of spiritual growth and wider cooperation among the Branches. One was a quiet morning of prayer and meditation in which four Branches joined under the leadership of the Rector of one of the Parishes. The second was a retreat held by the women of one Parish which was open to and attended by women of other local denominations as well as Womens Auxiliary members from other Parishes.

The Archdeaconry Auxiliary meeting for 1955 will be held Thursday, April 21 1955, the tentative date.

## REPORT OF WELLSBORO ARCHDEACONRY

There was an attendance of approximately one hundred.

Bishop Heistand gave a stimulating presentation of the problems of the Diocese under the topic, "After Fifty Years—What?" Mrs. Flynn, in what she announced was her last report as Women's Auxiliary president, called the attention of the group to changes in Board appointments, pleaded for Thanksgiving contributions to the Shippensburg Home, reminded the women of the migrant work and the need to support the Council of Church Women. She recommended a book by Cynthia Wedel—"What of the Women?", brought news of our missionaries, Miss Spencer and Miss Falck, and spoke of the conference to be held Hood College.

The afternoon speaker was the Rev. Raymond O'Brien, Rector, Grace Church, Elmira, New York, Diocese of Central New York. Fr. O'Brien came to the meeting through the permission of Bishop Heistand and the courtesy of the clergy of the Archdeaconry. His topic was "The Theology of the Family" and he brought an inspiring and stirring message on the subject of family relationships—a fundamental concern of every Church woman.

The Wellsboro Archdeaconry would like to report a very effective use of the blue veils and the U.T.O. presentation at the opening service of Holy Communion. For this, the president is indebted to the U.T.O. Diocesan Custodian, Mrs. John Hilton, and the Women of St. Paul's Auxiliary Branch.
