ANNUAL MEETING—1955

MINUTES

The Rt. Rev. John Thomas Heistand, Bishop of Harrisburg, opened the meeting with a meditation on the theme "His Witnessing Community."

Mrs. Robert Johns, of Lancaster, welcomed the delegates, clergy and guests.

After responding to the welcome, Mrs. Bodine presented Bishop Heistand, who thanked the Woman's Auxiliary for their devotion and loyalty to our Lord and His Church throughout the fifty years of its work in the Diocese of Harrisburg. The purpose of the W. A., said the Bishop is to carry out the program planned by the National Council, lifting it to the level of a glorious venture in the fields of service, worship, and study, making it a part of that glorious army which for 2000 years has been working to bring Christ alive in us and bring the world to Him.

Mrs. Hadly Waters, vice president, took the chair to present Mrs. Marc W. Bodine who gave us a report as Diocesan President. Mrs. Bodine said that the inspiration of the Triennial is still with us. Seeing the W. A. at work in Honolulu was an outstanding experience, where the theme "His Witnessing Community" was developed throughout the program via the parish view point.

As there were no nominations from the floor, Mrs. Fred Powell moved, seconded by Mrs. Fred Brennaman, that the nominations be closed, the motion was carried.

Mrs. Bodine presented the Provincial officers who were present, Mrs. Alexander Zabrieski, vice president, and Mrs. Paul Turner, Provincial representative to the National Executive Board.

Miss Elizabeth Mansel, chairman of Christian Education, gave her report. Copy filed.

Mrs. James G. Morgan, chairman of Christian Social Relations, presented Mrs. Sawada, of Japan, who spoke on the work being done at her home for abandoned babies: In seven years they have cared for 408 children, mostly illegitimate, of mixed blood. In 1946 she opened her own home to care of these children, as she felt the need to educate the Japanese that racial purity is not

the most important thing, mixed blood having made America what it is today. Gifts and prayers from Christians uphold her in carrying the crosses of her children.

Mrs. Edward Fleming gave a report on the Joint Sessions and other events of the General Convention in Honolulu.

The meeting adjourned at 4:45 p. m.

At 6:30 p. m. the 50th Anniversary Dinner was held at the Stevens House. The guests of honor were Mrs. Harry G. Hartman, Mrs. Andrew S. Rhoades, Mrs. Edward M. Fleming, Past presidents of the W. A., and Mrs. William Rote, past C.P.C. secretary, and Mrs. Robert M. Cutchin, first custodian of the Book of Remembrance. Miss Albertine Batzel, Mrs. Edward Flynn and Mrs. Robert Jones were not able to be present. Affectionate greetings from Mrs. Hunter Wyatt-Brown were read.

A festival service of thanksgiving was held at St. John's Church at 8:00 p. m. The Rt. Rev. Robert Fisher Gordon, D. D., Bishop Coadjutor of the Diocese of Virginia, was the preacher. Stressing the theme of the Triennial, "His Witnessing Community," Bishop Gordon presented the challenge which we face in Latin America, where the British church is turning to us to continue the work they have done there. The Pacific area is also our responsibility, where the majority of the people of the world are hungry and discontented. We must support the Asian missionary churches as God wills us to unity with other members of His Body, the Church. And in our own country we must reach out to those who are different and achieve unity as His Witnessing Community.

At 7:30 a. m. October 26th the service of Holy Communion was celebrated at St. John's Church. Bishop Heistand was the celebrant, assisted by the Rev. Edward Pielow, the Ven. Allen Day, and the Rev. Canon Heber Becker. The United Thank Offering was presented and memorial prayers were read for the departed whose names were inscribed in the Book of Remembrance during the year. The morning session was called to order at 9:30 by the President.

Mrs. Fleming reported that the offerings totalled \$273.90 and that a gift of \$25.00 had been given to Mrs. Sawada for her splendid enterprise.

The roll was called, 63 delegates, representing 40 parishes, and 13 Board members, responded. The ballots were distributed and the election took place. The total registration for the meeting was 206.

Bishop Heistand introduced the Suffragan Bishop-elect Dr. Earl H. Honaman, and Mrs. Honaman, who greeted the assembly.

After benediction by the Bishop, the President declared the 50th Annual Meeting of the Woman's Auxiliary of the Diocese of Harrisburg adjourned.

REPORT OF THE SUPPLY DEPARTMENT SECRETARY

The Missions supplied by the Diocese of Harrisburg in 1955 were as follows:

1. Holy Cross and Faith Memorial Mission, Pawley's Island, South Carolina; a mission for colored people, serving about one hundred men and women and seventy-five children.
2. St. Barnabas' Hospital, Osaka, Japan, a maternity hospital with beds for one hundred and twenty Japanese women and having a baby clinic. The first of its kind in Japan.
3. Colegio San Justo, St. Just, Puerto Rico; a school for boys.

4. High Grace Mission, Castaner, Puerto Rico, which is located in the poorest section of the island where there is much tuberculosis and anemia and very little pay from the coffee industry.

5. St. Luke's Hospital, Phoenix, Arizona, which cares for tuberculosis patients from all over the country.

6. Sisseton Mission, South Dakota, which takes care of the spiritual and physical needs of about five hundred Indian men, women and children.

7. Boys' Home, Inc., Covington, Virginia, which has charge of sixty boys from six to twentyone years of age.

We have received grateful letters of thanks from these missions, showing that our efforts in sending boxes of clothing to them in Lent and again in Advent have been much appreciated.

The total value of the boxes amounted to \$1784.47 with \$158.29 spent for transportation.

REPORT OF CHRISTIAN SOCIAL RELATIONS

One big aspect of Christian Social Relations has been the responsibility of the Christian as a citizen of his community, nation and the world. It is the HOW of Christian living upon earth with which Christian Social Relations is primarily concerned. In a very real sense every activity of the Parish and its Members is social relations since everything it does has a bearing upon community life. Some activities have special significance in the social ministry of the Church and these were the subject of a check list sent to each Branch Chairman of Christian Relations this Fall. It was most gratifying to have

replies from 40 of our 58 Branches, each giving evidence of not only C.S.R. topics studied, but real social service given and social action taken by individuals, and groups as a whole

The following subjects have been studied: United Nations, Minority Groups, World Peace, Communism, Human Rights, Church Unity, Interfaith, Religion in Schools, Programs for the Aged, Marriage and Family Life, Christian Vocation, Social Security, Health Needs, Child Welfare, Juvenile Delinquency, Physically Handicapped, Mental Illness.

Participation in Community Service as individuals or as a group, through financial aid, personal service, gifts of supplies, was made to the following agencies: Council of the Churches, United Church Women, Community Chest, Child Welfare, Local Welfare, Red Cross, Recreational Agencies, Girl and Boy Scouts, Health Clinics and Agencies, Hospitals, Home for Aged, Community Forum, Public Library, Shut-Ins, New Families in Area, Migrants.

We hope these Inventories were shared by each Branch, since each and every member has a part in the report. It was interesting to note that each topic had been studied by at least one group. Many Branches were able to check each part of the second list, indicating that we are doing a tremendous job in Christian Social Relations in the Woman's Auxiliary.

We are very anxious to have our Woman's Auxiliary's program emphasize the goals of C. S. R. in the Diocese. Each Branch is an integral part of its parish and can take leadership in helping to strengthen the C. S. R. program in the Diocese.

THE REPORT OF THE DEVOTIONAL CHAIRMAN OF THE WOMAN'S AUXILIARY OF THE DIOCESE OF HARRISBURG

In making this report, I trust you will not think me presumptions in calling your attention to the important "Truth": that the whole program of the Woman's Auxiliary is based upon our obedience to our Lord in obeying His command—"That we shall love the Lord our God, with all our hearts, with all our soul and all our mind, and further, that we shall love our neighbors as ourselves"—In obedience to this command, it is imperative that, as we pray—"Thy will be done on earth as it is in Heaven"—we surrender ourselves for service in His Kingdom.

It is our devotions and our worship—that prepares us for this Service.

I believe you are familiar with the greeting cards one sees in the vestibules of many of our Churches: one most frequently used reads:

"Whoe'er thou art that entereth here,
Forget the struggling world and every trembling fear."

At first glance, one might resent these words, as they seem to counsel a cowardly retreat from the demands and duties of a stricken world. But as we meditate upon them, we realize they bespeak the kind of retreat that best prepares for active participation in the Work of Winning the World for Christ.

In our devotions and our worship, we take time away from the stress and strain of the world, only that we may return from our moment transfiguration with clearer vision, purer motives and greater strength to minister to a needy and confused world.

May I in closing this report, make the following suggestions or recommendations:

First—That every Branch of the Woman's Auxiliary make a place in their programs for a Bible Study Group, using as a guide, the Brochure put out by the Seabury Press, titled—"A Method of Small Group Bible Study."

Second—That the Branches seek the aid of our Clergy in providing Quiet Days or One Day Retreats on a Sectional or Archdeaconry Basis.

Third—a Corporate Communion for the Women of the Parish at least once a month.

CONSTITUTION AND BY-LAWS

WOMAN'S AUXILIARY OF THE DIOCESE OF HARRISBURG

CONSTITUTION

Article I — Name

This organization shall be known as the Woman's Auxiliary to the National Council in the Diocese of Harrisburg.

Article II — Object

The object of this organization shall be to carry out within the Diocese of Harrisburg the purposes and work of the Woman's Auxiliary to the National Council, with special emphasis on its missionary activities.

Article III — Membership

The membership in this organization shall consist of the Parish and Mission branches of the Woman's Auxiliary in the Diocese of Harrisburg.

Article IV — Officers

Section 1. The officers of this organization shall be the Bishop of Harrisburg, a President, a Vice-President, a Chairman for each of the four Archdeaconries, a Secretary, a Treasurer, and a United Thank Offering Custodian.

Section 2. The officers, with the exception of the Archdeaconry Chairmen shall be elected by ballot of the voting body of this organization as follows: At the Annual Meeting preceding a Triennial there shall be elected a

President

At the Annual Meeting following the Triennial there shall be elected a

Secretary

U. T. O. Custodian

At the second Annual Meeting following the Triennial there shall be elected a Vice-President

Treasurer

These officers shall serve for three years, or until their successors are elected, with the privilege of re-election for another term of three years. They shall not be eligible to serve a third term in the same office. The limitation shall not apply to the Treasurer. Vacancies occurring among the officers during their term of office shall, until the next Annual Meeting, be filled by vote of the Executive Board.

Section 3. At the meeting following the election of President each Archdeaconry shall elect its Chairman from two or more names previously nominated by the President.

Section 4. The wife of the Bishop of the Diocese shall be an Honorary Vice-President.

Article V — Executive Board

Section 1. The officers, together with the Altar Guild Chairman, Chairman of Prayer and Worship, Chairman of Christian Education, Chairman of Christian Social Relations, Supply Chairman, Personnel Chairman, the Director of the Church Periodical Club, and the Custodian of the Book of Remembrance, shall constitute the Executive Board.

Section 2. The Executive Board shall meet at approximately the same time as the Annual Meeting and also on the first Tuesday of March of each year. Special meetings may be called at any time by the President, and shall be called by the President on the written request of five members.

Section 3. Quorum. Nine members shall constitute a quorum for the transaction of business.

Article VI — Meetings

Section 1. The Annual Meeting for the election of officers and other business shall be held the fourth Tuesday and Wednesday of October.

Section 2. A special meeting may be called by the Executive Board at any time. At special meetings only such business as is specified shall be considered.

Article VII—Amendments

This Constitution may be amended at any Annual Meeting by a two-thirds vote of the voting body of this organization, provided a copy of such proposed amendments shall have been sent to each branch president thirty days before said meeting.

BY-LAWS

Article I—Duties of Officers

Section 1. The President shall call all meetings of the organization and of the Executive Board and shall preside at the same. She shall appoint and fill vacancies in all committees not otherwise provided for in the By-Laws, and shall be a member ex-officio of all committees except the Nominating Committee. She shall direct the editing of the annual report.

Section 2. The Vice President shall fill the office of President if vacancy occurs, until the time of the next Annual Meeting, and shall preside at any Archdeaconry meeting in the absence of the Chairman.

Section 3. The Archdeaconry Chairman shall encourage the organization of new branches in their respective districts, visit the member branches and assist them in their work. Each Chairman shall prepare and submit a written report at each Board Meeting, and shall conduct at least one meeting a year in her respective Archdeaconry. In the event that both President and Vice-President are absent at the time of an Annual Meeting, the Chairman of the Altoona Archdeaconry shall preside.

The Chairmen shall represent the following Archdeaconries:

1. Altoona Archdeaconry
2. Harrisburg Archdeaconry
3. Wellsboro Archdeaconry
4. Williamsport Archdeaconry

Section 4. The Secretary shall make and keep, in permanent form, a record of the proceedings of the Auxiliary and of the Executive Board. She shall prepare and submit a report at each Annual Meeting, assist in compiling the annual report and send out all notices.

Section 5. The Treasurer shall receive and transmit all funds (except the United Thank Offering) due the organization, and shall pay all properly approved bills. She shall present an itemized report at the Annual Meeting and an audited report of her transactions to the Executive Board each year.

Section 6. The United Thank Offering Custodian shall endeavor to increase and deepen interest in the United Thank Offering. She shall receive and transmit to Church Missions House all United Thank Offering funds and make a yearly report. A bond shall be provided for this office by the Woman's Auxiliary of the Diocese of Harrisburg.

Article II—Duties of Committees

Section 1. The Chairman of Prayer and Worship, together with her com-

mittee, shall plan for devotional study and worship, and shall assist parochial devotional chairmen in adapting these plans to the needs of their own branches.

Section 2. The Chairman of Christian Education shall have general supervision of all missionary educational work undertaken by the Woman's Auxiliary and shall work closely with the chairmen of other committees in formulating an inclusive program covering education in the various fields of Auxiliary activity.

Section 3. The Chairman of Christian Social Relations shall, in cooperation with the Chairman of Christian Education, conduct a program of education on social problems. She shall be well informed on social issues and on the teachings of the Church in regard to racial problems and shall be responsible for carrying through a program of Christian social action.

Section 4. The Supply Chairman shall plan the Lenten and Advent box work and material aid, and in cooperation with the Chairman of Christian Social Relations shall stimulate additional material aid programs.

Section 5. The Personnel Chairman shall conduct a program of recruiting of young people for work in the Church, through education and worship programs, vocational conferences, publicity and study of standards for Church workers within the diocese. She shall work in close cooperation with the Diocesan Youth Commission and the Diocesan Department of Education.

Section 6. The Altar Chairman shall solicit and receive altar hangings and other altar furnishings and shall distribute such hangings and furnishings wherever they are needed. She shall be available for instruction in the work and organization of Altar Guilds.

Section 7. The Custodian of the Book of Remembrance shall have charge of the Book of Remembrance, and it shall be her duty to receive the names of departed members and to see that they are properly inscribed there in.

Section 8. The Director of the Church Periodical Club shall develop and increase the sending of religious literature, books and magazines to missions, the clergy and seminary students. She shall be appointed by the Bishop.

Section 9. Each committee chairman shall prepare and submit a written report at each Board Meeting.

Article III—Nominations and Elections

Section 1. A Nominating Committee consisting of one member from each Archdeaconry and one from the Executive Board who shall act as chairman, shall be appointed by the President at the Annual Meeting to serve for the following year.

Section 2. The voting body of this organization shall consist of the members of the Executive Board and to delegates from each Parish or Mission participating in the work of the Auxiliary. Elections shall be by ballot. Voting by proxy shall not be permitted. This same rule shall apply to the election of Archdeaconry Chairmen.

Section 3. Delegates to the Triennial Meeting shall be the President, the United Thank Offering Custodian, and three women from the membership of the Auxiliary to be elected by ballot at the Annual Meeting of the year preceding the Triennial Meeting. Five alternates shall also be elected by ballot.

Section 4. The Nominating Committee shall submit a single slate of not less than twelve candidates for the office of delegate and alternate delegate to the Triennial Meeting, the consent of candidates having been previously obtained.

The three candidates receiving the highest number of votes shall be elected delegates and the five candidates receiving the next highest number of votes shall be elected alternate delegates to the Triennial Meeting.

Section 5. At the Annual Meeting of the year preceding the Provincial Synod the Nominating Committee shall submit a slate of not less than nine candidates for office of delegate or alternate delegate to the Provincial Synod.

The two candidates receiving the highest number of votes shall be elected delegates and the three candidates receiving the next highest number of votes shall be elected alternate delegates to the Provincial Synod. The President shall be a delegate by virtue of her office.

Article IV—Finances

Section 1. A Finance Committee with the Treasurer as chairman shall be appointed by the President to prepare a budget covering expenditures for the year. This budget shall then be presented to the Executive Board for approval and recommended to the membership for adoption at the Annual Meeting.

Section 2. An expense fund for all necessary expenses shall be provided by this organization.

Rule 1. Twenty per cent of the total amount pledged for the Expense Fund shall be set aside for the Sinking Fund, to be used at the direction of the Executive Board.

Rule 2. At the Annual Meeting, the hostess branch shall entertain, overnight, members of the Executive Board, speakers on the program and two delegates from each branch. Where more delegates register from any branch they shall pay for their own entertainment.

Rule 3. Each branch shall be assessed, in addition to other funds, contributed, the sum of three dollars per year, to be used by the hostess branch to defray the expenses of the Annual Meeting; this fund to be known as the Annual Meeting Fund.

Rule 4. According to its strength each branch shall be assessed annually a sum from two dollars to ten dollars; this fund to be known as the Triennial Travel Fund.

Article V—Amendments

These By-laws may be amended at any Annual Meeting by a two-thirds vote of the voting body of this organization, provided a copy of such proposed amendments shall have been sent to each branch President thirty days before the said meeting.

Article VI—Rules of Order

The rules contained in Roberts' Rules of Order shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with the By-Laws or the Special Rules of Order of this organization.
