


## FOREWORD

## MINUTES OF ANNUAL MEETING — 1956

The 51st Annual Meeting of the Woman's Auxiliary in the Diocese of Harrisburg was called to order by the president, Mrs. Marc W. Bodine at 2:30 P. M., October 23, 1956, at Trinity Church, Williamsport.

Bishop Heistand read the opening devotions, followed by a meditation.

Mrs. Frederick Lechner, president of the Woman's Auxiliary, Trinity Church, welcomed the delegates and guests to the meeting.

Mrs. Hadly Waters took the chair to present Mrs. Bodine, who gave the president's message, reporting on what she has done in office in the past year, stressing that the W. A. is doing the work of the Church as a whole. She introduced each member of the Executive Board in order that all present might know them and be able to consult with them.

Mrs. Bodine then presented Bishop Heistand who gave his message to the meeting. He said that the Church was at its best when it was a disturbing element in society, for along with apparent benefits and privileges there comes the terrifying responsibility of making our lives a living witness to the fact that we must live to do the will of God, realizing that we are a sanctified society, in His service. We must develop a Christ-like mind to continue the growth of the revival of religious interest in order to prevent a breakdown of civilization. The W. A. must have a program representative of dynamic force in order to develop to its greatest possibilities. Christian love manifests itself in all we do in the Church, by denial of self and by grasping the opportunity to work with the Mind of Christ in us.

Mrs. Brenneman reported on the Synod, telling what is being done in the Dioceses of Virginia, Maryland, and Erie, in regard to Christian Education.

Miss Elizabeth Mansel reported on the Synod, stressing the need for trained women workers in the college field, as the students need a full presentation of the Christian faith.

Mrs. S. L. Street, of the Governing Board of the Provincial Conference, reported on the Hood Conference.

Mrs. Hadly Waters reported on the United Church Women, Pennsylvania Council of Churches, its purposes and how it functions.

Mrs. Carlton Jones reported on the Shippensburg Home, explaining about its provisions and urged the women to give generously at Thanksgiving.

Bishop Honaman spoke of the needs of the Shippensburg Home, which puts into actuality what we profess to believe in ministering to those who need the services of the Home. We are faced with a decision if we are to carry on this work.

Bishop Heistand spoke about the plans for a campaign to raise funds for rebuilding the Home and said that if every adult in the Diocese would pledge \$20.00 over a period of time, the fund could be raised.

The meeting adjourned at 5 P. M., after benediction by Bishop Honaman.

Choral Evensong was held in Trinity Church at 8 P. M. The speaker for the evening was the Rev. Tollie Caution, D.D., Assistant Secretary, Division of Domestic Missions, The National Council, who brought to those present many important points on the current topic of integration, and reminded the



congregation that we are afraid to do right today because of what tomorrow will produce. A reception was held in the Parish House following the service.

At 7:30 A. M., Oct. 24, the Service of Holy Communion was celebrated at Trinity Church. Bishop Heistand was Celebrant, assisted by the Bishop Suffragan, the Rev. William B. Williamson, the Rev. L. O. Diplock, and the Ven. Harry Frownfelter. The United Thank Offering was presented and memorial prayers were read for the faithful members who have departed this life into the larger life, and whose names have been inscribed in the Book of Remembrance during the past year.

The morning session was called to order by the president at 9:30.

As there were no nominations from the floor, Mrs. Flynn moved, seconded by Mrs. Hay, that the nominations be closed. Carried.

Mrs. Fleming presented the Treasurer's report. Copy filed. Mrs. Shillington moved, seconded by Mrs. Joseph Dodd, that the report be accepted. Carried.

Mrs. Fleming paid tribute to the W. A. of Trinity Church, Williamsport for the inspiration given her when she first began her work as treasurer and expressed her affection for Miss Albertine Batzel, who was unable to be present.

The assembly stood in tribute to Mrs. Fleming for her years of devoted and faithful service.

Thirty-six parishes responded to roll call and the ballots for the election were distributed.

Mrs. Fellows presented the report of the United Thank Offering. Copy filed.

Mrs. Church, chairman of the committee to amend the By-laws, presented the proposed changes as follows:

Article II, Section 6, read as follows:

The Altar Chairman, the presiding officer of the DIOCESAN ALTAR GUILD, is appointed by the Bishop and functions under the Constitution and By-laws of the Diocesan Altar Guild. She shall be a member of the Executive Board as a representative of an affiliated organization.

Article IV—Finance, read as follows:

Section 1. A Finance Committee with the Treasurer as chairman shall be appointed by the President to prepare a budget covering expenditures for the year. This budget shall then be presented to the Executive Board for approval and recommended to the membership for adoption at the Annual Meeting.

Section 2. An expense fund for all necessary expenses shall be provided by this organization.

Rule 1. Twenty percent of the total amount pledged for the Expense Fund shall be set aside for the Sinking Fund, to be used at the direction of the Executive Board.

Rule 2. According to its strength each branch shall be assessed annually a sum from two dollars to ten dollars; This fund to be known as the Triennial Travel Fund is part of the Sinking Fund. Where there is more than one branch in a Parish or Mission a single assessment shall be made.

Rule 3. At the Annual Meeting the hostess branch shall entertain, over night: Members of the Executive Board, chairmen of reporting committees, speakers on the program and two delegates from each branch. Where more delegates register from any branch they shall pay for their own entertainment.

Rule 4. Each branch shall be assessed, in addition to other funds contributed, the sum of three dollars per year to be used by the hostess branch to defray the expenses of the Annual Meeting. This fund is to be known as the Annual Meeting Fund.

It was moved by Mrs. Church, seconded by Mrs. Jennings, that the proposed changes be adopted as presented. A discussion regarding the use of the word "assessment" followed and action was postponed until the afternoon session.

The speaker of the morning was Mrs. Samuel M. Shoemaker, Director of Prayer and Worship, The Woman's Auxiliary in the Third Province, Calvary Episcopal Church, Pittsburgh. This dynamic, inspired woman brought to all



the tremendous importance of prayer in our every day life and emphasized the fact that none of us can be a true Christian without adequate prayer each day.

Noonday prayers were led by the Rev. Edwin A. Garrett III.

Mrs. Shoemaker resumed her talk and explained that two like-minded people may, with the co-operation of the Rector, form a prayer group that will eventually grow into a strong force. All this leads us to the Altar, the central place of worship, where we will come with understanding hearts.

The morning session adjourned for luncheon.

At one-forty-five the afternoon session opened with devotions led by Mrs. Frederick Manson, who read a report on Prayer and Worship.

A motion was made by Mrs. Shilling, seconded by Mrs. Powell that the By-laws be accepted. Carried.

Miss Elizabeth Mansel reported on Christian Education.

The Altar Guild report was read by the secretary.

Mrs. Quigley reported on the Supply Work.

Mrs. Shilling reported on the C. P. C.

Mrs. Honaman reported on the Book of Remembrance.

Copies of the above reports filed.

Mrs. Bodine presented Mrs. S. L. Church, newly appointed chairman of Personnel and College Work, and then Mrs. Bodine presented the four Arch-deaconry chairmen.

A motion was made by Mrs. Fleming, seconded by Mrs. Sargent, that the secretary write a note to Miss Batzel, sending her the greetings and affection of the assembly. Carried.

Mrs. Herendeen presented the following resolutions:

Be it resolved that: I. the Woman's Auxiliary express appreciation for the presence of Bishop Heistand and the Bishop Suffragan, the Rt. Rev. Earl M. Honaman, at our 51st Annual Meeting and our sincere thanks for their untiring guidance and devotion.

II. That our appreciation be extended to the Rector, the Rev. William B. Williamson, to the Woman's Auxiliary, to the hosts and hostesses and to all members of Trinity Church for the privilege of meeting in their parish and enjoying their generous hospitality.

III. Whereas our faithful and able Treasurer, Mrs. Edward Fleming, is relinquishing her work at the conclusion of this term in office, BE IT RESOLVED that we, the members of the Woman's Auxiliary in the Diocese of Harrisburg, place on our record our affectionate and grateful appreciation of the many years that she has given us her devoted and untiring service in the efficient handling of the exacting duties of her office.

Mrs. Herendeen moved, seconded by Mrs. Costley, that the resolutions be accepted and placed in the minutes. Carried.

An invitation from St. Paul's Church, Wellsboro, was extended to hold the 1957 meeting there. The invitation was accepted.

Mrs. Bodine announced the committees for 1957.

149 members were registered, 10 clergy and 1 layman, and the offering amounted to \$244.43.

It is very apparent at Provincial and National C. P. C. meetings that in many dioceses across the country the C. P. C. is a step-child to the W. A. In our diocese this is not true, the cooperation is wonderful. However I do have a suggestion. Could we devote one annual meeting to C. P. C.? In the nine years I have been in the diocese we have featured Devotions, UTO, Supply, Christian Education, and Christian Social Relations, but never C. P. C. with a speaker from National, etc.

There are four projects for C. P. C. this year and I hope we can aid all of them. Bishop Harris needs chalk, pencils, crayons, etc. for school supplies. The new Diocese of Nicaragua, which is in the making, needs 2000 English and Spanish Readers. Many of the dioceses are pledging themselves to fill one grade, the cost \$100. Brian Somers needs money for theological books for his Brazilian Seminary. No new books were given him for 53 years. Lastly, but not least, our own seminarians need books to start their theological libraries.

Our diocese stands next to the bottom of those in our province in its contributions to the National Book Fund. We give only one sixtieth of what Virginia gives, next above us in the list is Easton who gives four times what we give. Can't we do better!

## REPORT OF CHRISTIAN EDUCATION

In the four-fold program of worship, study, service and fellowship the Christian Education program of the Woman's Auxiliary encompasses the whole area of the Church's interest. The specific program as suggested by the National Executive Board of the Woman's Auxiliary has been forwarded to the Branch Secretaries for Christian Education or Program as soon as it has been received by your Diocesan Chairman. Some of the smaller Branches have not appointed a separate officer for this responsibility and in these instances the material has been directed to the President of the Branch.

Each Branch cannot cover the whole program as it appears in its suggested form. So, each must select those portions which have the most interest for the total membership. It is hoped that the Mission Study will receive studious attention. This is in keeping with the Mission Study for the United Church Women of the National Council of Churches. This year they are The Church in Southeast Asia and Missions: U. S. A. Those Branches where a parish life educational program is in effect are encouraged to participate in every phase of adult leadership.

In an effort to carry out a more individualized and intimate program of Christian Education throughout the Woman's Auxiliary of the Diocese your Chairman expects soon to complete plans for a committee of four or five. This will provide a channel for two-way communication between your Diocesan officer and you as members of the Auxiliary. Your Chairman has not been able to be present at your archdeaconry meetings and it is hoped that through the committee members you may be assured of having materials and news brought to you at those times.

Your Chairman for Christian Education and your Diocesan President have continued to represent the Woman's Auxiliary in the Diocesan Department of Christian Education. Other Auxiliary members are also serving in that Department in other responsibilities. # CONSTITUTION AND BY-LAWS WOMAN'S AUXILIARY, DIOCESE OF HARRISBURG

## CONSTITUTION

### Article I — Name

This organization shall be known as the Woman's Auxiliary to the National Council in the Diocese of Harrisburg.

### Article II — Object

The object of this organization shall be to carry out within the Diocese of Harrisburg the purposes and work of the Woman's Auxiliary to the National Council, with special emphasis on its missionary activities.

### Article III — Membership

The membership in this organization shall consist of the Parish and Mission branches of the Woman's Auxiliary in the Diocese of Harrisburg.

### Article IV — Officers

Section 1. The officers of this organization shall be the Bishop of Harrisburg, a President, a Vice-President, a Chairman for each of the four Arch-deaconries, a Secretary, and a Treasurer, and a United Thank Offering Custodian.

Section 2. The officers, with the exception of the Archdeaconry Chairmen shall be elected by ballot of the voting body of this organization as follows: At the Annual Meeting preceding a Triennial there shall be elected a

President

At the Annual Meeting following the Triennial there shall be elected a

Secretary

U. T. O. Custodian

At the second Annual Meeting following the Triennial there shall be elected a

Vice-President

Treasurer

These officers shall serve for three years, or until their successors are elected, with the privilege of re-election for another term of three years. They shall not be eligible to serve a third term in the same office. The limitation shall not apply to the Treasurer. Vacancies occurring among the officers during their term of office shall, until the next Annual Meeting, be filled by vote of the Executive Board.

Section 3. At the meeting following the election of President each Arch-deaconry shall elect its Chairman from two or more names previously nominated by the President.

Section 4. The wife of the Bishop of the Diocese shall be an Honorary Vice-President.

### Article V — Executive Board

Section 1. The officers, together with the Altar Guild Chairman, Chairman of Prayer and Worship, Chairman of Christian Education, Chairman of Christian Social Relations, Supply Chairman, Personnel Chairman, the Director of the Church Periodical Club, and the Custodian of the Book of Remembrance, shall constitute the Executive Board.

Section 2. The Executive Board shall meet at approximately the same time as the Annual Meeting and also on the first Tuesday of March of each year. Special meetings may be called at any time by the President, and shall be called by the President on the written request of five members.



Section 3. Quorum. Nine members shall constitute a quorum for the transaction of business.

#### Article VI — Meetings

Section 1. The Annual Meeting for the election of officers and other business shall be held the fourth Tuesday and Wednesday of October.

Section 2. A special meeting may be called by the Executive Board at any time. At special meetings only such business as is specified shall be considered.

#### Article VII — Amendments

This Constitution may be amended at any Annual Meeting by a two-thirds vote of the voting body of this organization, provided a copy of such proposed amendments shall have been sent to each branch president thirty days before said meeting.

### BY-LAWS

#### Article I — Duties of Officers

Section 1. The President shall call all meetings of the organization and of the Executive Board and shall preside at the same. She shall appoint and fill vacancies in all committees not otherwise provided for in the By-Laws, and shall be a member ex-officio of all committees except the Nominating Committee. She shall direct the editing of the annual report.

Section 2. The Vice-President shall fill the office of President, if vacancy occurs, until the time of the next Annual Meeting, and shall preside at any Archdeaconry meeting in the absence of the Chairman.

Section 3. The Archdeaconry Chairman shall encourage the organization of new branches in their respective districts, visit the member branches and assist them in their work. Each Chairman shall prepare and submit a written report at each Board Meeting, and shall conduct at least one meeting a year in her respective Archdeaconry. In the event that both President and Vice-President are absent at the time of an Annual Meeting, the Chairman of the Altoona Archdeaconry shall preside.

The Chairmen shall represent the following Archdeaconries:

1. Altoona Archdeaconry
2. Harrisburg Archdeaconry
3. Wellsboro Archdeaconry
4. Williamsport Archdeaconry

Section 4. The Secretary shall make and keep, in permanent form, a record of the proceedings of the Auxiliary and of the Executive Board. She shall prepare and submit a report at each Annual Meeting, assist in compiling the annual report and send out all notices.

Section 5. The Treasurer shall receive and transmit all funds (except the United Thank Offering) due the organization, and shall pay all properly approved bills. She shall present an itemized report at the Annual Meeting and an audited report of her transactions to the Executive Board each year.

Section 6. The United Thank Offering Custodian shall endeavor to increase and deepen interest in the United Thank Offering. She shall receive and transmit to Church Missions House all United Thank Offering funds and make a yearly report. A bond shall be provided for this office by the Woman's Auxiliary in the Diocese of Harrisburg.

#### Article II — Duties of Committees

Section 1. The Chairman of Prayer and Worship, together with her committee, shall plan for devotional study and worship, and shall assist parochial devotional chairmen in adapting these plans to the needs of their own branches.



Section 2. The Chairman of Christian Education shall have general supervision of all missionary educational work undertaken by the Woman's Auxiliary, and shall work closely with the chairmen of other committees in formulating an inclusive program covering education in the various fields of Auxiliary activity.

Section 3. The Chairman of Christian Social Relations shall, in cooperation with the Chairman of Christian Education, conduct a program of education on social problems. She shall be well informed on social issues and on the teachings of the Church in regard to racial problems and shall be responsible for carrying through a program of Christian social action.

Section 4. The Supply Chairman shall plan the Lenten and Advent box work and material aid, and in cooperation with the Chairman of Christian Social Relations shall stimulate additional material aid programs.

Section 5. The Personnel Chairman shall conduct a program of recruiting of young people for work in the Church, through education and worship programs, vocational conferences, publicity and study of standards for Church workers within the diocese. She shall work in close cooperation with the Diocesan Youth Commission and the Diocesan Department of Education.

Section 6. The Altar Chairman, the presiding officer of the Diocesan Altar Guild, is appointed by the Bishop under the Constitution and By-Laws of the Diocesan Altar Guild. She shall be a member of the Executive Board as a representative of an affiliated organization.

Section 7. The Custodian of the Book of Remembrance shall have charge of the Book of Remembrance, and it shall be her duty to receive the names of departed members and to see that they are properly inscribed therein.

Section 8. The Director of the Church Periodical Club shall develop and increase the sending of religious literature, books and magazines to missions, the clergy and seminary students. She shall be appointed by the Bishop.

Section 9. Each committee chairman shall prepare and submit a written report at each Board Meeting.

### Article III — Nominations and Elections

Section 1. A Nominating Committee consisting of one member from each Archdeaconry and one from the Executive Board who shall act as chairman, shall be appointed by the President at the Annual Meeting to serve for the following year.

Section 2. The voting body of this organization shall consist of the members of the Executive Board and two delegates from each Parish or Mission participating in the work of the Auxiliary. Elections shall be by ballot. Voting by proxy shall not be permitted. This same rule shall apply to the election of Archdeaconry Chairmen.

Section 3. Delegates to the Triennial Meeting shall be the President, the United Thank Offering Custodian, and three women from the membership of the Auxiliary to be elected by ballot at the Annual Meeting of the year preceding the Triennial Meeting. Five alternates shall also be elected by ballot.

Section 4. The Nominating Committee shall submit a single slate of not less than twelve candidates for the office of delegate and alternate delegate to the Triennial Meeting, the consent of candidates having been previously obtained.

The three candidates receiving the highest number of votes shall be elected delegates and the five candidates receiving the next highest number of votes shall be elected alternate delegates to the Triennial Meeting.

Section 5. At the Annual Meeting of the year preceding the Provincial Synod the Nominating Committee shall submit a slate of not less than nine candidates for office of delegate or alternate delegate to the Provincial Synod.



The two candidates receiving the highest number of votes shall be elected delegates and the three candidates receiving the next highest number of votes shall be elected alternate delegates to the Provincial Synod. The President shall be a delegate by virtue of her office.

#### Article IV — Finances

Section 1. A Finance Committee with the Treasurer as chairman shall be appointed by the President to prepare a budget covering expenditures for the year. This budget shall then be presented to the Executive Board for approval and recommended to the membership for adoption at the Annual Meeting.

Section 2. An expense fund for all necessary expenses shall be provided by this organization.

Rule 1. Twenty percent of the total amount pledged for the Expense Fund shall be set aside for the Sinking Fund, to be used at the direction of the Executive Board.

Rule 2. According to its strength each branch shall be assessed annually a sum from two dollars to ten dollars; this fund, to be known as the Triennial Travel Fund, is part of the Sinking Fund. Where there is more than one branch in a Parish or Mission a single assessment shall be made.

Rule 3. At the Annual Meeting the hostess branch shall entertain, overnight, members of the Executive Board, chairmen of Reporting Committees, speakers on the program and two delegates from each branch. Where more delegates register from any branch they shall pay for their own entertainment.

Rule 4. Each branch shall be assessed, in addition to other funds contributed, the sum of three dollars per year to be used by the hostess branch to defray the expenses of the Annual Meeting. This fund is to be known as the Annual Meeting Fund.

#### Article V — Amendments

These By-laws may be amended at any Annual Meeting by a two-thirds vote of the voting body of this organization, provided a copy of such proposed amendments shall have been sent to each branch President thirty days before the said meeting.

#### Article VI — Rules of Order

The rules contained in Roberts' Rules of Order shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with the By-Laws or the Special Rules of Order of this organization.
