### ANNUAL REPORT.

The Thirteenth Annual meeting of the Woman's Auxiliary of the Missionary District of Honolulu was opened with a celebration of the Holy Communion at St. Andrew's Cathedral on May 25th, 1915. The Rev. F. N. Cullen was the preacher. After the service an adjournment was made to the Davies Memorial Hall, 101 delegates responding to the Roll-call. In the absence of Miss Simpson, Mrs. John E. Baird was asked to act as Secretary pro tem. The Acting President, Mrs. L. F. Folsom, read her address. She spoke of the absence of the President, Mrs. H. M. von Holt, and of the illness of Mrs. Caroline Clark. She reviewed the work of the year briefly and spoke stirring words of exhortation to the women present to rise to the needs of the Missionary situation.

After a bountiful luncheon at the Priory prepared by St. Andrew's, St. Andrew's Hawaiian and St. Peter's Auxiliaries, the afternoon session began at 2 p. m.

In the absence, on a visit to the Mainland of the secretary, Miss Gillet, the acting secretary, Miss S. J. Simpson, read the secretary's report. She reported in brief that at the last annual meeting 154 had responded to the roll-call, and that every Auxiliary and Guild in the Islands was represented.

The semi-annual meeting held in December, 1914, found 116 present. Nineteen societies had done Auxiliary work during the year, these societies having a membership of 576.

The work was varied, reaching many Missions in the Islands, giving assistance to Missions for Christmas festivals, the payment of Convocation pledges, with gifts for Missions in Japan, China, Alaska, and the southern part of the United States. The value of the work done will be found in the Treasurer's report.

The report of the Educational Secretary, Mrs. H. McK. Harrison, was read and showed that a large amount of careful work had been done, but pointed out that in many Auxiliaries, little or nothing was done to instruct the people in the great Missionary work of the Church.

Mrs. A. G. Smith made an earnest plea for the United Offering, which created a renewed interest.

The proposed new Constitution was read section by section and was adopted as amended.

The proposed By-Laws were read and after discussion they were referred to the Board of Managers to be formed under the Constitution, and to this board was delegated the power to make such changes in them as was deemed necessary and as finally adopted the Board was authorized to publish the By-Laws and Constitution together with the financial reports.

The Board of Managers was authorized to fix the apportionment.

Three branches of the Junior Auxiliary reported through their officers.

The offering at the Holy Communion, \$16.65, was voted to be divided between Holy Trinity, Honolulu, the new South Kona Mission, and The Church of the Holy Apostles, Hilo, for altar furnishings. The afternoon offering, \$18.15, was voted to the District Expense Fund.

In answer to various appeals, \$315.50 in special pledges were made. The Bishop then appointed the new officers according to the requirements of the new Constitution.

A resolution was passed that "This year's main interest of the Auxiliaries be devoted to the equipment of work among Japanese women."

The president then announced the four objects to which each parish branch is asked to contribute annually, namely:

1. The apportionment, \$200.00.

2. The United Offering (if possible), \$500.00.
3. The Altar Fund (\$1.00 from each branch).
4. The District Expense Fund, to meet current expenses: Woman's Auxiliaries, \$1.00 a year; Junior Auxiliaries, 50 cents a year.

Branches are asked to consider the pledges and to contribute to them early in the year, thus saving much work and anxiety to the Treasurer, and making it possible to have an earlier report.

Remember her books close May 10th and reports are made from April 30th, 1915, to April 30th, 1916.

*Foreign* Missions are those beyond the jurisdiction of the Government of the United States.

*Domestic* are those within that jurisdiction which includes Porto Rico, Honolulu, Philippines, Alaska.

*Diocesan* are those within our own Diocese or District.

#### ADVICE OF MISS EMERY.

The Missionary box should be valued according to *its value to the receiver*. That is to say, articles should not be valued that are not exactly what the receiver needs, or that are added for the pleasure of the recipient, as, at Christmas, toys and candy for the children. And let us remember that these "boxes are missionary, to help in the effort to spread the Kingdom of Christ throughout the world, and to bear His mark in every particular." Then the missionary boxes will reach their greatest efficiency.

#### DIRECTIONS FOR PARISH SECRETARIES.

1. Apply to the Corresponding Secretary when your branch is ready to work for a box. She will send you a list of needs of Missions and Missionaries to choose from.

2. When your branch has undertaken the work for which your selected letter calls, notify the Secretary at once, sending her the name and address in such letter, and your own address and parish.

3. Write to the Missionary at once, stating when and from whom he may expect a box.

4. Write to the Missionary as soon as the box has been despatched, also to the District Corresponding Secretary with statement concerning value of box.

5. Blanks will be sent for a report of the year's work. Read them carefully and fill them out fully. Return to the Corresponding Secretary at once. All boxes of books, single books or magazines should be reported through the Church Periodical Club Secretary.

6. Always notify the Corresponding Secretary of the names and addresses of new officers elected or changes, if any have occurred during the year.

CONSTITUTION.

ARTICLE I.

This society shall be called, THE HONOLULU BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

ARTICLE II.

The object of the society is: By systematic and united effort to diffuse Missionary intelligence, to increase Missionary activity, to promote the study of Missions, and to encourage prayer for Missions among the women of the Missionary District.

ARTICLE III.

The Church itself is the great Missionary Society, therefore all Baptized women in this District who desire it, and who work for Missions in connection with their parochial organizations, shall be regarded as members of this Woman's Auxiliary, but terms of membership in any Parish Branch may be fixed by that Branch.

ARTICLE IV.

All Parish societies of women that so desire, may become branches of this Auxiliary, first obtaining the consent of the Rector or Clergyman in charge, and notifying the President of their intention to work in unison with the Auxiliary.

ARTICLE V.

The officers shall be: A President, and a First Vice-President. Other vice-presidents may be appointed for such divisions of the Missionary District as the Bishop may counsel. There shall be a Recording Secretary, a Corresponding Secretary, a Treasurer, a Secretary of the Junior Department, a Secretary of the Babies' Branch, a Directress of the Altar Department, an Educational Secretary, a Secretary of the Church Periodical Club, and a Secretary of the United Offering. All of these officers shall be appointed by the Bishop at the annual meeting.

ARTICLE VI.

The officers of the District Branch shall constitute a Board of Managers who shall have general charge of the work under the direction of the Bishop.

ARTICLE VII.

The annual meeting shall be held at the time of the Convocation of the Missionary District, and quarterly meetings on such dates and in such places as the President may appoint.

## ARTICLE VIII.

The representatives of five parishes shall constitute a quorum.

## ARTICLE IX.

This constitution may be amended at any annual meeting, by a vote of two-thirds of the parishes or missions represented.

## BY-LAWS.

## I.

The duty of the President shall be to call meetings of the Woman's Auxiliary and Board of Managers, and to preside over the same. It shall be her duty to see that all new officers are informed of their specific duties.

## II.

The duty of the Recording Secretary shall be to give notice of meetings, to keep a record of proceedings, to prepare an abstract of the minutes for the annual report and if so ordered to issue and distribute, with the assistance of the Corresponding Secretary the annual report.

## III.

It shall be the duty of the Corresponding Secretary under the direction of the President, to correspond with the General Secretary of the Auxiliary and with the various branches of the District, to furnish them with work, to collect their report, to prepare an annual report and to assist the Recording Secretary to issue and distribute the same.

## IV.

The Treasurer shall have the custody of all money received by the District Branch and shall collect, if necessary, all sums payable to the same, in pledges made. She shall pay out money on the order of the President, and Secretary, except such sums as may be received for a definite purpose, which sums she may dispose of without formal direction. All moneys received for purposes outside of the district, shall be forwarded to treasurers empowered to receive the same.

## V.

The Secretary of the Junior Department, Babies' Branch, Directress of the Altar Department, Educational Secretary, Secretary of the Church Periodical Club, Secretary of the United Offering, shall superintend, foster, and develop by correspondence and otherwise, their several departments on consultation with Diocesan officers.

## VI.

It shall be the duty of the President, or of some person appointed by her, to visit, if possible, the Parochial Branches in order to promote the interest of the work.

## VII.

It shall be the duty of any parish branch before it discontinues a pledge, which has been made for salary or interest, and which continues year by year, to give a year's notice of its purpose at the annual meeting.

## VIII.

Each Parish Branch shall pay yearly to the expense fund of the District Branch, the sum of \$1.00, and Junior branches 50 cents. This will entitle them to seat their delegates and to vote.

## IX.

Each parochial branch is entitled to five delegates. If it is impracticable to get women as delegates who live in the parish or mission, it is permissible to elect delegates who are resident in Honolulu.

## X.

The Secretary and Treasurer of each parish branch are to make yearly reports to the Corresponding Secretary and Treasurer of the District Branch, of all work done and money given to Missions inside and outside of the Diocese, and of the value of boxes sent.

## XI.

The year of the Woman's Auxiliary shall end on April 30th of each year, the date on which the Parish and Convocational Year end, and all Auxiliary reports shall be made up to that date.

## XII.

These By-Laws may be altered or amended by a majority vote at each annual meeting.
