NINETEENTH ANNUAL MEETING.

The nineteenth annual meeting of the Honolulu Branch of the Woman's Auxiliary to the Presiding Bishop and Council of the Episcopal Church began May 31st with a corporate communion at St. Andrew's Cathedral, at the close of which the members and delegates assembled for business at Davies Memorial Hall.

The meeting was called to order by Mrs. Arthur G. Smith, the acting President, in the absence of Mrs. H. M. von Holt on the Mainland.

Mrs. Smith gave an impressive address of welcome and outlined the ideals and what should be the vision of the Woman's Auxiliary in this Paradise of the Pacific.

One hundred delegates, representing nineteen branches, responded to roll call, not including the visitors that were present. The Bishop appointed the following officers for the year 1921: President, Mrs. H. M. von Holt; First Vice-President, Mrs. A. G. Smith; Second Vice-President, Mrs. W. L. Emory; Recording Secretary, Mrs. J. A. Dominis; Corresponding Secretary, Mrs. H. B. Restarick; Treasurer, Mrs. Thos. E. Wall; Educational Secretary, Mrs. H. M. Harrison; Church Periodical Club Secretary, Mrs. Howard Clarke; United Thank Offering Secretary, Mrs. Chas. R. Hemenway; Directress of the Altar Department, Mrs. H. B. Restarick; Little Helpers Secretary, Mrs. C. C. Black; Supply Secretary, Mrs. James Wakefield.

Constitution Revised.

The first business, which occupied considerable time, was the revision of the Constitution and By-laws, after which came the reports of the various diocesan officers of the work actually accomplished in 1920 by their several departments. Mrs. Restarick, as Corresponding Secretary, reviewed the work done by the nineteen branches in 1920.

She touched upon the important resolutions recently passed by the national organization, emphasizing loyalty to Christian Standards of living pertaining to womanhood.

She also voiced the sentiments of Bishop Touret of Idaho as to the influence of motion pictures in molding the minds and characters of our young people, pleading for some sort of adequate censorship in which woman's influence should exercise a large part.

Resolutions on the death of Sister Beatrice, which occurred February 20, were unanimously adopted. Also resolutions of regret at the departure of the Rev. D. R. Ottmann and Miss Jessie Maddison, who leave the Islands on account of ill health. Another resolution was adopted expressing regret at the transfer of Miss Mabel Ruth Schaeffer to the Foreign Field.

At 12:30 adjournment was made to St. Andrew's Priory, where luncheon was served to 150 people, the Rev. J. Lamb Doty and L. Tenny Peck being the selected speakers during the luncheon.

At the afternoon session Mrs. Theodore Richards, President

of the Woman's Board of Central Union Church, brought messages of greeting and an invitation to attend the jubilee meeting of her society on Tuesday, June 7, after which Mrs. Arthur Smith returned the compliment by inviting the Woman's Board to the jubilee celebration of the national organization of the Woman's Auxiliary, to be held in Honolulu simultaneously with the one being held in New York on October 16 of this year, at which time it is expected that an offering of \$50,000 will be made, to be called the Emery Fund, to be used for women missionaries on furlough, of which Mrs. John E. Baird is the local chairman. Mrs. Baird followed with an appeal for the quota to be raised towards this fund in this Missionary District.

Mrs. Thos. E. Wall reported for the Chinese Famine Fund, stating that to the \$450 gold already cabled had been added the proceeds from the 20,000 Life-saving Stamps sold by the Woman's Auxiliary, amounting to \$734.06 to date.

The selected speakers for the afternoon were:

1. Mrs. C. C. Black, on "The Development of St. Mark's Mission."
2. Rev. James Walker, on "The Diversified Work of the Kohala District."
3. Miss Hilda Van Deerlin, "The Children at St. Mary's Mission."
4. The Rev. Jas. F. Kieb, on "The Japanese as I Meet Them."

The Rev. F. N. Cullen spoke on the subject of the need of larger funds for automobiles for the clergy of the Islands.

The Rev. D. R. Ottmann, principal of Iolani School, told of its excellent spirit and the good work of the past year, and of his regret at leaving.

The offerings, both morning and afternoon, were for two special scholarships at Iolani School.

Upon adjournment the members and their friends were entertained by the girls of St. Andrew's Priory, who gave a repetition of the entertainment at Craigside, "The Legend of Persephone," under the direction of Miss Eunice Carter and Miss Hill.

On Thursday the Educational Department of the Woman's Auxiliary, under the direction of Mrs. Roger Noble Burnham, presented the pageant "The Awaiting World," at 4 p. m., in the cloister of the Cathedral.

ANNUAL REPORT OF THE CORRESPONDING SECRETARY.

Ever since the Triennial of 1919 the Church, in all its branches, has been in a state of reorganization, from the Presiding Bishop and Council, with all their tremendous responsibilities, down to the Little Helpers.

The effects of this reorganization have been felt even in the most distant outposts, and we of this Missionary District have been gradually trying to adjust ourselves and our problems to the new order of things. But it must of necessity be slow, for we are far away from the busy Church centers, the laborers are few, and our lack of leaders retards our progress.

We women of the Auxiliary profess our allegiance to the Holy Catholic Church every time we repeat the Creed, but are we living our Creed?

Every woman who worked heart and soul for the Red Cross in the late war not only professed but lived the Creed of that organization, which was: "I believe in my duty to my country; to love it; to support its Constitution; to obey its laws; to respect its flag and to defend it against all enemies." The Red Cross did not fail for lack of leadership.

Loyalty was the watchword! Aroused to the danger that threatened us as a nation, how we rallied to the defense of it!

Would to God that every woman could be aroused to the danger that confronts us as a nation today! Would to God that we realized the responsibility that is laid upon the Church to put down the evils that are rampant! The Prince of Darkness is abroad in our land, winning young and old to the idea that pleasure and amusement are the chief aims of life.

The Church's Voice, which is the Voice of the Holy Spirit, pleads in vain. It is true that Duty towards our neighbor is being emphasized in all sorts and forms of Social Service, but unless such work is undertaken in His name and we love our neighbor because we love the Christ who first loved us, our work can have no real value or permanency.

The vision of the Woman's Auxiliary for fifty years has been service to God and man. It has always put duty to God first, as the first four Commandments explicitly teach us.

I was struck with one of the beautiful tributes paid to a notable leader of the Woman's Auxiliary who died recently. In enumerating her virtues, loyalty came next to consecration. "Loyalty to principle, to duty, to authority, to friends, to everything which makes for high ideals—never absent from her pew in Church or from her chair at a meeting except for a justifiable reason."

Just at this time the Woman's Auxiliary is placing itself on

record strongly emphasizing loyalty to Christian standards of living pertaining to womanhood. This can only be raised by religious education—propaganda, if you like that word better. We have committed ourselves to this in a very definite way to try to reach indifferent women, college women, working women and isolated women. To this is added Social Service; but let us bear in mind this fact, that Religious Education and Social Service are ADDED responsibilities and not *substitutes* for the real Missionary work that we have always done and shall continue to do.

Miss Lindley has said: "We must keep our own self-governing, separate existence as the Woman's Auxiliary to the Presiding Bishop and Council." We are now governed by an Executive Committee of sixteen members, of which Miss Lindley is the Executive Secretary.

It is my special province to review the year's work of the Woman's Auxiliary in this Missionary District, but it has seemed fitting to preface my report with general facts showing our relationship to the national organization and its aims as a whole.

Foreign Missions.

In the Foreign Field my hope was that we should reach the \$500 mark in cash given in 1920. We did not do this, but our Diocesan Box sent to St. James' Hospital, valued at \$189 gold, added to the cash \$327.45 gold, brings the total to over \$500 in gold.

Our Foreign work last year was confined to the Missionary District of Anking, under Bishop Huntington, to the two Institutions of St. James' Hospital and St. Lioba's School under the Sisterhood of the Transfiguration.

Domestic Missions.

We have helped four objects in the Domestic Field: St. Mary's-on-the-Mountain, Sewanee; St. Agnes' Hospital for Negroes, Raleigh; Valle Crucis School, N. C., and the Mary E. Hart Memorial School at Farmington, N. M.

Diocesan Missions.

We have helped twenty-one objects within our own Diocese to the amount of \$2,542.97, which is two and a half times as much as our total for Diocesan Missions in 1919.

But in spite of this gain I am sure you will be disappointed and surprised to hear that our grand total for 1920 is more than \$1,000 *less* than in 1919. This should arouse us to renew our efforts from now to the end of 1921. Our Apportionment, or

Nation-wide Quota as it is now called, and our United Offering have both fallen behind in 1920.

This loss is partly accounted for by the fact that three Branches have been discontinued. The Hawaiian Women and Juniors have consolidated and become one Branch of the Woman's Auxiliary, and the two Branches at Epiphany Mission have discontinued for the present and no new Branches have been organized.

You may recall that last year Christ Church, Kealakekua, gave more per capita than any other Branch. This year Mrs. Ault's Juniors at St. Andrew's is the Banner Branch, with a tie between St. Andrew's Woman's Auxiliary and Christ Church for second place.

Of course reckoning by totals St. Andrew's leads, as it should do.

Now as to pledges for 1921. Early this year each Branch received a list of objects decided upon by the Executive Committee, but so far very few have been heard from. We hope that at this time every Branch will pledge its full share to the limit.

The Kamaka Kawaihoa Memorial Scholarship has never received the full amount of \$150, and Iolani has now raised to \$170. If we are to pay this scholarship in full, every Branch must increase its pledge.

The District Automobile Fund is sadly inadequate. Three of the Clergy must have help from this Fund: Rev. James Walker at Kohala, Rev. D. D. Wallace, Kealakekua, and the Rev. F. N. Cockeroff at Lahaina. My suggestion would be to assess this sum, instead of asking for voluntary contributions.

The District Expense Fund is wholly insufficient, for it is supposed to cover the expenses of the Educational Secretary as well as the current expenses of printing, stationery, etc.

The District Branch as a whole asks for pledges for only fourteen objects this year, nine of which are specials.

To my mind one of the urgent calls to the women of the Auxiliary in this Mission District is the creation of a fund for the education of the children of our Clergy. Situated as some of our missionaries are in isolated places, where educational advantages are denied their children, it would not be strange if this obstacle stood in the way of getting good men to accept work in these Islands.

In the Diocese of Connecticut for forty years such a Fund has been maintained for the *daughters* of Clergymen, and since 1875, 150 girls have thus been assisted in getting an education. It should be patent to all how infinitely greater is the need in this Missionary Jurisdiction.

REPORT OF THE RECORDING SECRETARY.

At the Quarterly Diocesan Meeting, held January 18, 1920, the President, Mrs. H. M. von Holt, announced that Mrs. B. L. Marx had resigned as Diocesan Treasurer on account of ill-health and that Mrs. Thos. E. Wall had been appointed to serve in her place.

The report that \$2,000 of the debt of the Cluett House had been cancelled was met with applause.

Canon Ault gave a very interesting report on the Triennial Convention, held in Detroit in October, 1919. The Auxiliary Day was, of course, of intense interest. There were over 1,000 communicants, and the offertory amounted to \$468,721. Letters from our delegates, Mrs. Raymond, Mrs. Kroll and Mrs. Dominis, were read.

A letter was read from Miss Van Deerlin, in which she asked for assistance in caring for the children living at St. Mary's.

Miss Pierce spoke of Valle Crucis and the need of money to rebuild the house destroyed by fire.

The last Quarterly Meeting for 1920 was held on Monday, November 1, 1920, in the Parish Hall.

The Treasurer announced that the "All Saints' Day" offering for the District Altar Fund amounted to \$24.70.

Mrs. H. Clarke, the Periodical Club Secretary, said that the Executive Board suggested that the Secretary organize and maintain a circulating library for the priests in charge of the outlying Churches. Those in this Diocese who had books were asked to contribute to the library, bringing them as a part of their Thanksgiving Offering to the Parish House on November 24th.

Mr. Ottmann spoke on the Kamaka Scholarship and said that it was not being used by any boy at present, and asked what were the wishes of the Auxiliary in the matter.

The President gave a very interesting address, in which she said: "On Bishop Restarick's first arrival, 18 years ago, he appointed me First President of the St. Andrew's Branch of the Woman's Auxiliary, and from that day to this, in all the different capacities in which it has been my privilege to serve, I have felt and appreciated his support. Before we meet again we may have our new Bishop LaMothe here, and though we know little about him, that little is interesting and delightful. May I bespeak your united interest and support of him as he comes to this field which will be so new and strange to him."

In closing the following resolution was adopted: "Whereas, the failing health of our Bishop has caused him to send in his resignation, which has already been acted upon, we, the women of the Diocesan Woman's Auxiliary of Honolulu, do tender him our sympathy and affectionate appreciation of his great labor, and hope that with a well earned rest he may be restored to

health and enjoyment of life here, where he has decided to make his home."

The President then welcomed Dr. Motoda, President of St. Paul's College, Tokyo, Japan, who gave an illuminating address upon the "Education of Japanese Women and the Place Women Are Taking and will Take in the Christian Civilized World." The subject of Japanese women being one in which Christian women of these Islands are vitally interested, Dr. Motoda was able to throw light on many obscure points, and he was listened to with rapt attention.

After voting the offering of \$12.75 to the District Expense Fund, the meeting adjourned.

REPORT OF THE EDUCATIONAL SECRETARY.

Although but five reports out of a possible fifteen have been received, we are not to be discouraged, but must hope and pray for more next year. As each of these five are different they must be reported separately.

St. Andrew's Woman's Branch read aloud Archdeacon Stuck's last book, "The Alaskan Missions of the Episcopal Church," during their weekly Lenten Sewing meetings.

The St. Andrew's Hawaiian Cottage meetings were so fortunate as to have instruction from the Rev. D. R. Ottmann on the Prayer Book services—especially the Sacraments—and Church History.

Miss Van Deerlin of St. Mary's gave a lengthy report. She said it was the one word "Alaskan." She gave her girls the stories told by Archdeacon Stuck.

At Christ Church, Kealakekua, during their Lenten Sewing meetings the Rev. D. D. Wallace read "The Life of the World to Come."

At Holy Innocents', Lahaina, the Rev. F. N. Cockeroff used the "Spirit of Missions."

At St. Andrew's Cathedral we had two delightful study classes during Lent—both on Alaska and both ably led by Mrs. Clive Davies. We feel particularly grateful to Mrs. Davies for taking her time while here on a visit. She slipped back into her old place as Mission Study Class leader. Just here, too, I should like to say that it is to Mrs. Davies that we owe the starting of Mission Study classes, as twelve years ago she brought out sets of books on Missions in India and China for the Missionary Union and led them herself. In these two classes were representatives of St. Andrew's, St. Clement's, Trinity Mission, Epiphany, and St. Mary's. The attendance was good throughout, and on Maundy Thursday the members united in a corporate Communion Service, the offering being devoted to the Bishop Rowe Fund.

We hope to close our work this year with the United Offering pageant "The Awaiting World." For this we are deeply indebted to Mrs. Roger Noble Burnham, who has graciously given her time and is so successfully instructing those who are kindly taking part in it.

I should like to make a few recommendations and ask for some from those who may have thoughts along these lines. It came to me, why always be asking people to go into plays and pageants who either decline or go into them only to be helpful. I know there are those who really enjoy it. Why not enroll those and get them to band together for mutual pleasure and benefit?

As for the Parishes and Missions in the country: Mr. Wallace has made a notable beginning at Kealakekua this year in reading a devotional book to his Auxiliary. Why cannot others follow? Cannot Priests and Auxiliary Presidents, in planning for their work, have Missions in mind and tuck in missionary reading at meetings, and also pass on the Mission Study Book, with which they are always supplied, from one to another?

There is a supply of the "Survey" on hand, but nothing has been done with it yet, as it seemed wise to await the coming of our new Bishop.

ANNUAL REPORT OF THE CHURCH PERIODICAL CLUB,

The intelligent, unfailing and constructive interest which the members of the various Church organizations throughout the diocese have taken in the C. P. C. has sent its routine work forward most satisfactorily the past year.

A few magazines which were pledged for remailing have not been sent forward as promptly as would have given the best results, and a few direct subscriptions sent in for priests in the outlying parishes have not been received. But another year we hope to correct both of these failures.

There has been contributed for diocesan work \$204.50.

23 priests, schools or missions have benefited from this fund.

27 magazines have been pledged within the diocese for remailing.

61 direct subscriptions have been sent in.

23 subscriptions were asked from the New York office.

181 books were turned in to the C. P. C. and have been redistributed.

1 book was purchased by special request.

650-odd magazines were turned in and have been redistributed.

Among them were a sufficient number of duplicates to allow of the extension of our work to the Oahu Prison and the city jails.

Just here let me say that there is a constant and ever increasing demand for books and magazines of every type, and the Sec-

retary urges that this be kept in mind by each of you. Any such material may be left in the office of Canon Ault, and it will be called for by the Secretary.

Two new pieces of work have been turned over to the C. P. C. this year. One is the raising of as large a fund as may be possible for St. Paul's College, Tokyo. The sum of \$15,000.00 has been pledged by the Episcopal Church of America for the library at that institution, and the getting of the fund together has been turned over to the Secretaries of the C. P. C. Miss Mary E. Thomas, our ex-Secretary, wrote out from New York asking what we could do in this diocese. The response which has been made to the call has been most gratifying, and I now have in hand \$224.00. It has been especially inspiring to have the students in our schools and those at our missions respond so generously. I hope, however, that every parish, every school, and every mission will have given at least one book before the last plates are sent in.

Our Japanese students have responded with especially pleasing generosity. As yet, however, the Japanese residents and business men have given nothing and have made no definite pledge. But Consul Yada and the Rev. P. T. Fukao, who have been so good as to assist me in presenting the matter to them, gave me reason to expect that they will cover in full all other gifts.

The Secretary wishes to take this opportunity of thanking all those who have shown such keen interest in the work of the C. P. C., and also have contributed so generously to its support.

ANNUAL REPORT OF THE JUNIOR AUXILIARY.

We report but 275 members and eight Branches of Juniors this year, Epiphany having discontinued Auxiliary work for the present, and what has been the Banner Branch for many years, the Hawaiian Juniors, having been merged into the Hawaiian Woman's Auxiliary, making a loss of two Branches.

In spite of this falling off the Juniors gave in cash \$986.12, and the Box work amounted to \$93.95, which brings the total up to \$1,080.07, which is only \$135.56 less than in 1919.

You will find the exact figures in the summary of the advance sheets, page 8, which I hope all will read carefully.

To Diocesan Missions they did not give as much as in 1919, but still a goodly sum, \$758.90.

To Domestic Missions they gave more than in 1919, and more than the Woman's Auxiliary this year, viz., \$140.57.

To Foreign Missions, not as much as in 1919, but almost as much as the Women, \$154.50 gold.

To the Nation-wide Campaign Quota, or Apportionment for General Missions, they gave \$68.50.

In the United Thank Offering they fell behind the previous year, but gave \$56.75.

St. Andrew's Junior Auxiliary is now the Banner Branch, as they gave \$7.30 per capita, which is considerably more than any other Branch per capita. Our Juniors have helped 19 Diocesan objects in cash and boxes, three places in the Domestic Field and four in the Foreign Field, besides their Nation-wide Campaign Quota and the United Thank Offering.

In the large Dioceses the Juniors have been separated from the Woman's Auxiliary and organized into the Church School Service League. We hear that it is working well, but so far I have not heard of its practical working out in any Missionary District, so for the present it looks as if we must continue in the same way which has been quite successful for 19 years.

It is not believed that we could so organize in more than one Sunday School of this District, viz., St. Andrew's, but there are certain features that might be introduced, such as the Duplex Envelopes. It is advocated that every child should have these envelopes as well as the grown-ups, each child pledging a certain amount for the Parish and another for Missions every Sunday.

The organizing of the Church School Service League, and the general oversight of it, is put into the hands of the Rector or Priest-in-charge of the Parish or Mission Sunday School. He it is who appoints a Committee of three to be responsible for the Mission work of the children of the Parish. In small Parishes or Missions one leader would be sufficient, probably, but in all cases the members of the committee or the leader should be considered members of the Church School staff.

THE UNITED THANK OFFERING.

I am not going to try to make a report as United Thank Offering Secretary, for I am altogether too new in the work, but I do want to ask all you women of the Auxiliary to help me in that work, for unless there is co-operation by all the women of all the Branches in the District I can do little.

All Branches may not be able to work in the same way, and while, of course, the plan of giving by way of the individual blue boxes is undoubtedly best, yet if that plan is not possible in every case, cannot at least one box be taken so that each Branch may have a share, and the offering be a united one?

The Pageant, to be given here in the Cloister on Thursday by the Educational Department, speaks for itself.

As you all know, the last Thank Offering sent from here to Detroit in 1919 was large, but unless a great deal more interest can be aroused than has been shown, our offering in 1922 will not reach the desired goal of \$1,000, an object worth striving for. The real objective, however, is to help along this great work. While more important than all else, it seems to me, is the thought so beautifully expressed by Bishop Manning in his address to the United Thank Offering Treasurer of New York, when he said: "And you who are taking your share in the Thank Offering, however small the gift may be that goes into the mite box, it represents a gain in the soul of the giver, and stands for a spiritual gain in the life of the Church out of all proportion to the amount the box may contain."

REPORT OF THE LITTLE HELPERS FOR 1920.

After my appointment as Secretary of the Little Helpers in February, 1920, I distributed a number of boxes and issued a call for a meeting in June, to which five mothers with their babies responded, and the contents of the boxes turned in amounted to \$2.77.

I think, perhaps, the idea is not fully understood and that those who have received boxes may easily have mislaid them during the interim between the time they received them and the date set for collection.

Although I may not report the first four months of 1920, the interest is more encouraging, and I am quite sure by the end of this year, if returns continue as they have begun, I shall have quite a substantial sum to report. It would simplify matters greatly if the clergy could find it convenient to mail me a list of baptized babies in their parishes or missions about twice a year. Then I could correspond with the mothers and proceed to enroll them in the Little Helpers.

I think it would not be amiss to say that to date December 31, 1920, I have received \$15.00, and that Kauai has responded with the names and mite offerings of six earnest, newly enrolled Little Helpers.

Twenty Branches contributed to this Diocesan Altar Fund, 16 giving only the amount prescribed by the by-laws and five going over that amount.

Again I would call the attention of each Branch to the Resolution passed several years ago, making November 1st (Festival of All Saints) our Corporate Communion Auxiliary Day throughout the Diocese, when in every parish and mission the offering is for this Fund.

At the Cathedral, envelopes are given out at the door to the several Branches represented, and in that way each Branch is credited with its offering on that occasion.

Almost invariably new Clergy coming to this Missionary District bring cassocks of heavy woolen material, unsuitable for a tropical country, and it is here that the Woman's Auxiliary can be of assistance to the Missionary, who has incurred many expenses in making the long journey to Hawaii. Clerical vestments are a heavy drain upon the Missionary purse, which women usually consider their duty and privilege to lighten.

Before next All Saints' Day I should like to see a movement begun to honor the memory of our beloved Sister Beatrice, as November 2nd would have been her 92nd birthday. One of the last things she did was to hand me her dues for the Auxiliary to the end of 1921, and as long as she was able she made Eucharistic Vestments for the Clergy.

RESOLUTIONS ON THE DEATH OF SISTER BEATRICE.

Whereas, it has pleased God in His infinite goodness and wisdom to take to Himself our beloved friend and member of the Woman's Auxiliary, Sister Beatrice, and to give her rest from her earthly labors;

Whereas, her lifelong devotion and consecration to the service of God and His Holy Church have been a precious example to all; her deeds of charity and self-sacrifice will long be remembered with gratitude, and we shall miss her cheery smile of interest and encouragement in all good works;

Whereas, in the death of Sister Beatrice, on February 20th, 1921, the Church and Auxiliary have met with a great loss, it is fitting that we should give expression to our recognition of the great missionary work she did, particularly among the Hawaiian people, and of her educational work in connection with St. Andrew's Priory, covering an active period of thirty-five years; therefore be it

Resolved, That we women of the Missionary District of Honolulu do give expression to our feelings of love and appreciation for the beautiful life, and do record our grief for her loss. We give thanks for her example of Christian faith and loyalty, and we unite in sympathy for her bereaved companion, Sister Albertina, and all those near and dear to her. Full of years and honor, loving and being loved by all who knew her, she fell asleep as one to whom had been vouchsafed a heavenly vision. Of her we can truly say "she served God faithfully and has departed this life having the testimony of a good conscience, in the communion of the Catholic Church, in the confidence of a certain faith, in the comfort of a reasonable, religious and holy hope, in favor with God and in perfect charity with the world." And be it further

Resolved, That these resolutions be recorded in our minutes and a copy sent to her only surviving sister in England.

CONSTITUTION.**ARTICLE I.**

This Society shall be called The Honolulu Branch of the Woman's Auxiliary to the Presiding Bishop and Council.

ARTICLE II.

The object of the Society is: By systematic and united effort to diffuse Missionary intelligence, to increase Missionary activity, to promote the study of Missions, and to encourage prayer for Missions among the women of the Missionary District.

ARTICLE III.

The Church itself is the great Missionary Society, therefore, all Baptized women in this District who desire it, and who work for Missions in connection with their parochial organizations, shall be regarded as members of this Woman's Auxiliary, but terms of membership in any Branch may be fixed by that Branch.

ARTICLE IV.

All Parish and Mission societies of women that so desire, may become branches of this Auxiliary by first obtaining the consent of the Rector or Clergyman in charge, and notifying the President of their intention to work in unison with the Auxiliary.

ARTICLE V.

The officers shall be: A President, a First Vice-President, a Second Vice-President and a Third Vice-President, who shall act as Secretary of the Junior Department. There shall be a Recording Secretary, a Corresponding Secretary, a Treasurer, a Secretary of the Little Helpers, a Directress of the Altar Department, an Educational Secretary, a Secretary of the Church Periodical Club, a Secretary of the United Offering and a Supply Secretary. All of these officers shall be appointed by the Bishop at the annual meeting.

ARTICLE VI.

The officers of the District Branch shall constitute the Executive Board, which shall have general charge of the work under the direction of the Bishop.

ARTICLE VII.

The annual meeting shall be held at the time of the Convocation of the Missionary District, and quarterly meetings on such dates and in such places as the President may appoint.

ARTICLE VIII.

The representatives of five Branches shall constitute a Quorum.

ARTICLE IX.

This Constitution may be amended at any annual meeting, by a vote of two-thirds of the Branches represented.

BY-LAWS.

1. The duty of the President shall be to call meetings of the Woman's Auxiliary and the Executive Board and to preside over the same. It shall be her duty to see that all new officers are informed of their specific duties.
2. The duty of the Recording Secretary shall be to give notice of meetings, to keep a record of proceedings, and to prepare an abstract of the minutes for the annual report.
3. The duty of the Corresponding Secretary, under the direction of the President, shall be to correspond with the Executive Secretary of the Auxiliary and with the various branches of the District, to collect their reports, to prepare an annual report, and to issue and distribute the same.
4. The duty of the Supply Secretary shall be to furnish each Branch with work, and to keep a record of the number and the value of Boxes sent. She shall also present a report at the annual meeting.
5. The Treasurer shall have the custody of all moneys received by the District Branch and shall collect, if necessary, all sums payable to the same, in pledges made. She shall pay out money on the order of the President and the Recording Secretary, except such sums as may be received for a definite purpose, which sums she may dispose of without formal direction. All moneys received for purposes outside of the District shall be forwarded to treasurers empowered to receive the same.
6. The Secretary of the Junior Department, the Secretary of the Little Helpers, the Directress of the Altar Department, the Educational Secretary, the Secretary of the Church Periodical Club and the Secretary of the United Thank Offering, shall superintend, foster, and develop by correspondence and otherwise, their several departments on consultation with Diocesan officers.
7. It shall be the duty of the President, or of some person appointed by her to visit, if possible, each Branch in order to promote the interest of the work.
8. It shall be the duty of any Branch, before it discontinues a pledge, which has been made for salary or interest, and which continues year by year, to give a year's notice of its purpose at the annual meeting.
9. Each Branch shall pay yearly to the District Expense Fund such sums as it shall be assessed therefor by the Executive Board. Such payment shall entitle it to seat its delegates and to vote.
10. Each Branch shall pay yearly to the District Altar Fund at least one dollar from the Woman's, and fifty cents from the Junior Auxiliary.
11. Each Branch is entitled to five delegates. If it is impractical to get women as delegates who live in the parish or mission, it is permissible for each Branch to appoint delegates who are resident of Honolulu. If a Branch fails to appoint delegates one week before Convocation, they shall be appointed by the Executive Board.
12. The Secretary and Treasurer of each Branch shall make yearly reports to the Corresponding Secretary and Treasurer of the District Branch, of all work done and money given to Missions within and without this Missionary District, and the value of Boxes sent.
13. The year of the Woman's Auxiliary shall end on December 31st of each year, the date on which the Parish and Convocational year ends, and all Auxiliary reports shall be made up to that date.
14. These By-Laws may be altered or amended by a majority vote at each annual meeting.

ANNUAL REPORT OF THE BOX SECRETARY FOR THE
YEAR ENDING DECEMBER 31, 1920.

The year 1920 has been marked by a reorganization of the Box or Supply Department. The name Supply is now used instead of Box, and the Diocesan Officer in charge is now called the Supply Secretary.

The most vital change has been in the method of assigning work, but these plans were not carried into effect in the Eighth Province, of which we are a part, until this year, so far as I have been able to learn.

In February last we were informed by Mrs. Touret, the Chairman of our section of the Eighth Province, that a Supply Depot is to be opened in Pasadena, Cal., under the able and efficient Mrs. B. M. Wotkyns, who has had large experience in Auxiliary Box work and Red Cross war work. She it is who will send us our quota of Box work, and if requested, she will send us at wholesale rates materials and garments already cut according to standard patterns, as was done in the Red Cross work.

As we in this Missionary District do our Box work only through the Lenten season, and we have done all we could this year, I do not see how we can hope to try out these new methods until Lent, 1922.

Last year, in response to a request from Dr. Taylor, in charge of St. James' Hospital, Anking, China, where we support the Alice Mackintosh Memorial Bed, thirteen Branches responded to the call for a Diocesan Box, which was valued at \$189.34 gold.

St. Mary's Juniors sent a Box to St. Martha's School, Nanking, China, valued at \$11.45 gold.

St. Andrew's Juniors, besides contributing to the China Box, sent a Box of scrap books to the Children's Hospital, Honolulu, and another Box to St. Mary's orphans.

St. Andrew's, Honolulu, and Christ Church, Kealakekua, remembered Iolani School with a Box valued at \$54.66.

The total number of Boxes for 1920 was 23, and the valuation \$305.45.

When we consider what an anxious year 1920 was, owing to the high cost of everything, we did pretty well, but we are doing

much better this year, and the 1921 report will show a substantial increase.

For years our institutions have received no help in boxes from the Mainland, but the tide is turning, and we are assured by the General Supply Secretary in New York that our needs will be supplied very largely by the end of 1921.

This good news should not make us relax our efforts, but rather encourage us to do more in Lent, 1922, for Mrs. Wade says, "The calls for linen from all our Church Institutions are very heavy, and if we can be relieved by your help we shall be most thankful."

Mrs. Touret, the wife of the Missionary Bishop of Idaho, writes: "The report of the Honolulu Branch of the Woman's Auxiliary is wonderful. You certainly have set a great pace for the rest of us Missionary Districts to follow. You speak of your organization as an Auxiliary being unusual. It is unusual in the amount of work you accomplish, but I think its organization is practically that of many of the domestic Missionary Districts. Certainly it is like that of Western Colorado and Idaho. I should judge that you are somewhat nearer together than we are. Our distances make co-operative work so very difficult, and in the struggling missions the women work so hard to meet the bare expenses that they do not seem able to work for anything outside their own missions with much enthusiasm. You speak of the Convocation Expense Fund being used to pay the traveling expenses of the wives of the Clergy. How I wish that we might have a like fund for Idaho, but from our very distant posts it would cost about five, or nearer six hundred dollars, I should think, to bring the wives of our Clergy together. We are hoping next year to have a traveling secretary, and thus bind our Branches nearer together."

It has been proposed that in our missionary study we take up the several Missionary Districts. This would be particularly interesting, and we should learn a great deal from each other.
