MINUTES OF THE EDUCATIONAL CONFERENCE

The Educational Conference of the Diocesan Woman's Auxiliary was held on Monday morning of Convocation Week, February 6th, 1933 in Davies Memorial Hall. Owing to the illness of Mrs. Walter Coombs, Diocesan Educational Secretary, Mrs. William Thompson, President of the Auxiliary, was chairman of the meeting.

The meeting was opened with a hymn led by the girls of the Priory under the direction of Sister Deborah. The period of devotions was taken by the Rev. C. Fletcher Howe, Rector of the Church of the Good Shepherd, Wailuku, Maui. His inspiring message was to hold the Christ motive in life and work; with a splendid determination to know nothing but Christ; in action to do all in the name of Christ; and to dare hold Christ before men.

A review of Re-Thinking Missions was given by the Rev. Tanner Brown of St. Clement's Church. This book is the result of the laymen's inquiry or appraisal recently completed regarding the missionary work of seven denominations of the United States at work in India, Burma, Japan and China. The speaker reviewed the book without argument over this very controversial production.

Mr. Harvey Freeland, head of the vocational schools of the Islands, gave a fine discussion of Vocational Education, stressing the facts that vocational training deals with practical agriculture, home-making, and trade; that the underlying motive is to earn while the pupil learns; and that the schools do not train pupils in numbers larger than demanded by the positions to be filled.

Mrs. S. Harrington Littell concluded the morning's program fittingly with a paper on "Art, an approach to Religion."

MINUTES OF THE ANNUAL MEETING, 1933

The thirty-first annual meeting of the Honolulu Branch of the Woman's Auxiliary to the National Council was held on Tuesday, Feb. 7, 1933 in the Tenney Memorial Auditorium, preceded by Communion in the Cathedral.

The meeting was called to order by the President, Mrs. William Thompson. After singing hymn 101 there were prayers by Bishop Littell. Mrs. Thompson told of the pleasure all felt in having at this meeting Bishop and Mrs. Paul Matthews of New Jersey and asked them to come to the platform. Amid applause of welcome they were decorated with leis by Mrs. Hayes. Roll call by the Secretary showed 97 delegates present, representing 22 Branches.

The President's address followed. See page 11. After this a letter from Miss Grace Lindley, Executive Secretary, New York, was read by Mrs. Sloggett. The Treasurer's report, printed and distributed to

all present, showed that \$7591.01 had passed through the Treasurer's hands during the year. The Treasurer thanked the Branches for their cooperation, calling attention to the fact that five Branches had already paid their assessments in full, beginning with the baby branch, St. Stephen's, Waialua. This has never happened before.

In the absence of the Educational Secretary, Mrs. Coombs, who is very ill, the splendid report of the Educational Department was read by Mrs. White. This was followed by prayers by Bishop Littell for the Educational Secretary.

A report of the District Council of the Young People's Service League was read by the President, Miss Florence Johnson. This was followed by Mrs. Hayes, whose report on the United Thank Offering showed more money on hand at this time than three years ago. In order to save time the reports of the District Altar Secretary, the Church Periodical Director, the Supply Secretary, the Secretary for Oriental Work and the Chairman of the Devotional Committee were not read but are to be printed in the Journal.

The Chair announced that reports would be interrupted to hear from the representative from the Woman's Board of Missions of the Pacific Islands. Mrs. Forbes, President, responded, expressing the pleasure all felt in meeting here for the first time in this beautiful new building. She told how glad she was to bring greetings from the Woman's Board which was meeting in Manoa that afternoon, and of the help and inspiration that is furthered by this interchange of visits each year.

Mrs. Lowrey, Chairman of our year's "Special," the Bishop's Purse, told of the satisfaction felt by every one in having completed the fund. Miss Von Holt, reporting for the Christmas Cheer Fund for Missions, told of \$487.50 raised and distributed to 19 Missions. Mrs. Morgan gave a verbal report on the Book of Remembrance. The making of this book is something that cannot be hurried, so it was found impossible to have it finished for this meeting as had been hoped. The cover was on display under glass and is the work of Sister Clara.

Mrs. Morgan reported on Memorials, as follows:

RESOLVED, that we, the members of the Woman's Auxiliary of the Missionary District of Honolulu, do hereby place on record our sorrow at the passing from this life of these loyal servants of our

Lord Jesus Christ; and be it further

RESOLVED, that the names of the foregoing be placed upon the memorial page of the Journal of this meeting.

This was followed by prayers for the departed by Bishop Littell.

Bishop Littell then announced the appointment of the officers of the Honolulu Branch of the Woman's Auxiliary for the coming year. The list will be found on page 4. In making these appointments the Bishop called attention to the new names on the list and said how glad he was to welcome these new members.

Mrs. Anderson reported on the revision of the Constitution and By-laws to read as follows:

CONSTITUTION

Article V

The officers shall be: A President, whose term of office shall be three years, and who may be reappointed at the discretion of the Bishop; a First Vice-President, a Second Vice-President and a Third Vice-President. There shall be a Recording Secretary, a Corresponding Secretary, a Treasurer, a Directress of the Altar Department, an Educational Secretary, a Secretary of the Church Periodical Club, a Secretary of the United Thank Offering, a Supply Secretary, an Assistant Supply Secretary, and a Secretary for Oriental Work. All of these officers shall be appointed by the Bishop at the annual meeting.

Article VII

The annual meeting shall be held at the time of the Convocation of the Missionary District, and other meetings on such dates and in such places as the President may appoint.

BY-LAWS

Article 1

The duty of the President shall be to call meetings of the Woman's Auxiliary and the Executive Board and to preside over the same. It shall be her duty to correspond with the Executive Secretary of the Auxiliary, and to see that all new officers are informed of their specific duties.

Article II

The duty of the Recording Secretary shall be to keep a record of proceedings, and to prepare an abstract of the minutes for the annual report.

Article III

The duty of the Corresponding Secretary, under the direction of the President, shall be to give notice of all meetings, to correspond

with the various Branches of the District, to collect the reports of the various Secretaries, to prepare an annual report, and to issue and distribute the same.

Article XI

Each Branch is entitled to seven delegates. If it is impractical to get women as delegates who live in the parish or mission, it is permissible for each Branch to appoint delegates who are resident of Honolulu. If a Branch fails to appoint delegates one week before Convocation, they shall be appointed by the President and Corresponding Secretary.

Article XII

The Secretary and Treasurer of each Branch, through its President, shall make yearly reports to the Corresponding Secretary and Treasurer of the District Branch, of all work done and money given to Missions within and without this Missionary District, and the value of boxes sent.

It was moved by Mrs. Harrison that these amendments be accepted as read and approved as a whole. This was seconded and carried.

The Chair asked for a motion regarding the morning offertory of \$25.53. It was suggested that this be left to be voted upon in the afternoon when the pledges are being made. In agreeing to this postponement the President said that she hoped St. Margaret's House, Berkeley, California, would not be forgotten.

The President then called upon the Bishop for a ten minute talk. In his response Bishop Littell said that he was very pleased with the tone of Convocation and that he felt that he had never taken part in a meeting that had been on a higher spiritual plane. He told about the many things that he was able to do because of help for his discretionary fund and the wonderful impetus given to the work by the new Memorial Hospital on Molokai.

With all standing the noon tide prayers were read by the Rev. Kenneth Perkins.

The Rev. Edgar Henshaw then gave a demonstration of the Birthday Thank Offering in Church Schools with the help of two persons from the Mission, St. John's by the Sea. The Chair announced the World Day of Prayer to be held this year in the new Japanese Church, Makiki Castle on Pensacola St. on Friday, March 3, Bishop Baker of the Methodist Church to be the speaker. She also announced that Bishop Perry, the Presiding Bishop of the Episcopal Church in America will be in Honolulu on Thursday, March 2, while the Empress of Canada is in port and that a diocesan meeting will be held that afternoon at 4:15 so that all may have an opportunity to meet Bishop Perry.

The Chair then announced an intermission for luncheon and invited all present to proceed to the Blue Room of the Young Hotel

where luncheon would be served.

Afternoon Session

Promptly at one-thirty o'clock the meeting was again called to order and opened with the singing of hymn 249. This was followed by a ten minute talk on the Hawaiian Church Chronicle by the Rev. E. Tanner Brown. Because of ill health Bishop Restarick finds it necessary to give up the position of Associate Editor and the work is to be taken over by Mr. Brown who said that he very much desired to have a correspondent in each mission and parish. Mr. Brown said that every one on the staff of the paper gives his services, the only expense being for printing. There is not even an allowance for postage. He asked that the Chronicle be put on the list for voluntary pledges.

Mrs. Arthur G. Smith gave a ten minute address on the scholarships for Ernest and Helen, reading a most inspiring paper on "Mother-love". She told about Ernest who has been a Woman's Auxiliary charge for a number of years and Helen Seu, who is following in the footsteps of her god-mother, Sara Chung, and is training to be a worker in mission fields.

Mrs. Corey next gave a most interesting account of the work in Hilo, telling of the new Hawaiian Mission that has been started by three devout members of the Hilo Church. Land has been secured for the Mission and they hope some day to build a church. At present they are working in an old building that soon must be pulled down.

Bishop Littell told of the need of an increased automobile fund for Missionaries and the Church Army. At present most of such expense must be paid for out of their stipends which have already been cut 10%.

Mrs. Helmick read a very stirring paper on St. Stephen's, Waialua, the baby branch of the Woman's Auxiliary. It started a year ago with six members; they now have twelve of varied ancestry. They have a plan for the coming year by which they hope to raise \$500.00, having one money making event each month. In Waialua there are hundreds of children, born on American soil, who need religious training, a wonderful field, all ready for the sowing. Deaconess Swinebourne followed, telling of the start of the playground and equipment, made possible by the money from Mrs. Littell's classes; of the Sunday School with an enrollment of 49 and an average attendance of 42; of the very small quarters in which the services are conducted; of the five baptisms and five confirmations during the past year. Like Mrs. Helmick the Deaconess feels that here indeed is a ready and waiting field, waiting for the seed to be sown. Upon the completion of the Deaconess' plea, the following recommendation was made by Mrs. Anderson: The Executive Board recommends that, for its special project this year, the diocesan Woman's Auxiliary undertake to

raise \$1500.00 toward the maintenance of St. Stephen's Mission, Waialua. It was moved by Mrs. Henshaw that the recommendation of the Executive Board be adopted. This was seconded and carried.

The afternoon offertory was taken and the Treasurer reported that it amounted to \$38.98, making a total of \$64.51 for the day. Pledges were asked for and came in thick and fast with totals as follows:

The Chair announced that all present were invited to tea at the Bishop's House to be served by St. Andrew's Jr. Auxiliary. After singing the Doxology the meeting adjourned.

REPORT OF THE PRESIDENT

To the pleasure of greeting the Bishop and clergy, the Church Army and the delegates to this 31st annual meeting of the Honolulu Branch of the Woman's Auxiliary is added this year the delight of welcoming to our Islands Bishop and Mrs. Matthews. There is always something lacking about a Convocation that hasn't some member of the Mathews family present. Another cause for rejoicing this year is that we are meeting in these beautiful new memorial buildings and in this Tenney Auditorium which is itself a perpetual memorial to a faithful and devoted member of our Auxiliary.

The past year has been one of hard work and quiet achievement on the part of our Branches and while our Treasurer's statement shows a falling off of about \$1400.00 in total receipts from last year, this is practically accounted for by the smaller amount undertaken under our "Special" for the year. All but one of our Branches have been able to fully meet their requirements and pledges in this year of financial stress,—a simple statement, not very thrilling, but back of it lies stories of devotion, prayer, hard work, sacrifice and faith, and we feel it is a matter for congratulation and rejoicing. Under Mrs. Lowrey's able chairmanship, our "Special" for the year, \$1500.00 for the Bishop's Purse, has been completed.

May I call your attention to the statement of the total amounts given for diocesan and general missions and the United Thank Offer-

ing by our various Branches, which has been distributed by the Corresponding Secretary. You will see that the record made by some of our Branches is really remarkable, especially when the number of members is taken into consideration, and this statement says nothing about the substantial help given by each Branch to its own Parish or Mission. You will hear later in the day about our baby Branch, St. Stephen's, Waialua, which began life last January and is really a most remarkable infant.

There have been two changes in our Executive Board during the year. Mrs. Lester, after three years of valuable service, found it necessary to resign and Mrs. Bode was appointed by the Bishop as District Altar Secretary. Miss Hall, and her sister, Miss Marian Hall, who have given unstintedly in work and time in directing the work of the Supply Department for seven years, resigned on account of ill health last summer. We are most fortunate in having Mrs. Lange and Mrs. Carnes to take over the work and we feel sure they will have such loyal and enthusiastic support from all the Branches that instead of an arduous task their work will be pure joy.

We are happy that Mrs. Churchill, in retiring as 2nd Vice President will, as President of St. Clement's Auxiliary, still be on the Executive Board to give us the help of her wide experience and spiritual insight. Mrs. Hayes, also, is retiring after serving four years as United Thank Offering Secretary. As a tribute to her work it will be noted that our United Thank Offering has steadily mounted and that at the present moment, in spite of hard times, we have on hand considerably over \$100.00 more than we had three years ago. Mrs. Plum, our faithful and efficient Corresponding Secretary finds it necessary to resign. No one but her husband, the President and her Master knows the hours of labor given willingly and joyously by her but even if she no longer has the office, I feel that her technical knowledge and skill will always be available.

Since last meeting nine meetings of the Executive Board have been held at the various missions on Oahu, and two diocesan meetings. June 29th, after our Memorial service for Bishop LaMothe, we came together to hear the report of our delegate, Mrs. Dudley N. Carpenter, to the annual meeting of the Woman's Auxiliary of the Province of the Pacific, held at Sacramento, Calif., April 19 to 22. At this meeting a resolution was passed that contributions be asked for from every Parish Guild and Auxiliary in each diocese and district of the Province, to be used for the extension work of St. Margaret's House, Berkeley, Calif. While in California last Spring I had lunch at St. Margaret's House and was charmed with the beauty of its setting, the splendid work it is doing and the delightful atmosphere of home which it radiates. As you know from Miss Vera Day who has told about it at our Branch meetings, St. Margaret's is the School for Christian Service and Deaconess Training School of the Province of the Pacific. Its advantages belong to Honolulu, so I am

sure we will want to have a share in its upbuilding. I would like to suggest, if it meets with the approval of the delegates, that our morning offering be devoted to St. Margaret's House, Berkeley.

On August 18 we held a diocesan meeting in honor of the Rev. Kenneth D. Perkins and the Rev. Kenneth A. Bray who had just arrived to take up work in this Missionary District. The annual party in honor of the faculty members of our Church Schools was held at the home of Dr. and Mrs. James A. Morgan on October 14.

The President's travels have taken her over considerable ground during the past year. Early in April, with the United Thank Offering Secretary, Mrs. Hayes, I visited Maui and we spoke to our women at Wailuku, Lahaina and Kula. On Saturday, April 23, an unexpected visit was made to Hilo on my way to California, and in response to a wireless from the Bishop, a meeting of the Auxiliary was called in my honor. During the two months I was in California, I attended a number of most interesting Woman's Auxiliary meetings and was invited to tell about our work in the Islands at the Oakland Convocation in Berkeley, in Fresno on Cathedral Day and at the Church of the Incarnation, Santa Rosa, where a special meeting was held in my honor with Holy Communion at eleven A. M., followed by luncheon and my talk. I found everyone intensely interested in our work and unanimous in thinking that we have a wonderful Bishop. I was told that after our Report was read at the Provincial meeting in Sacramento, the whole tone of the meeting, which up to that time had been depressed by reports of hard times, was changed and everyone cheered up. I tell this, not in any spirit of boasting, but with profound thankfulness and so you may know what people away from here think of you and your work.

During the past month I made a tour of the Island of Hawaii and a visit to each of our five Branches and the Church Army. No one who has not visited them can appreciate the patient bravery and courageous striving of the small isolated Branches. It is my earnest hope that it may be possible sometime in the near future for Mrs. Littell, as the President's representative, to visit the other Islands. I can think of nothing that would bring such inspiration and help, not only to the women but to the clergy, the Church Army and the people of the community, as a visit from Mrs. Littell. We know what she has meant to us here in Honolulu and as a thank offering I feel we must make every effort to share her with the people on the Islands.

As we look ahead into the coming year, what a wonderful privilege and opportunity opens before us. More than ever before the Woman's Auxiliary may set a standard of courageous faith. Let us not limit our goal to what seems humanly possible in these difficult days. With God there is no depression. There has been no change in the eternal verities,—no diminution in Christ's bountiful promises of help, in God's power to provide for His own. His Holy Spirit still seeks entrance into our hearts and will abide there if we do the Father's will. The supply of God's power is still limited only by the

degree of our faith and Christ is still the light of the world.

Let us then through the coming year, keep our vision clear, our footsteps steady, our faith strong, striving at all times to display that "courageous faith in everyday living" which is gained through daily and hourly contact with our Source of Power.

EDUCATIONAL SECRETARY'S REPORT

The Educational Secretary's Report for the year 1932 will not follow the conventional lines of previous reports, which have been a general summing up of how many study books, calendars and pamphlets have been sold, how many magazine subscriptions have been taken, nor the Secretary's contacts on the outlying islands. These have all received the proper attention at the right time.

The growth of the Religious educational work is marked this year by an entirely new feature, work done by inspired laymen and clergymen for the different parish congregations of the diocese.

The Rev. D. A. McGregor in a recent article for one of the church papers says: "Religious education is getting a grasp on how to do those things that we want to do in the fields of life with which religion especially deals. It is finding out how to be Christian men and women ourselves, and how to have a Christian society to live in."

Christian Education in the truest sense is not *learning things*; it is *finding life*.

Religious Education is the deep longing for more study of the mind of Christ, a knowledge of the Holy Bible, a knowledge of theology and of church history, the latter almost entirely lacking on the part of many lay people.

The work this year has been a joy and inspiration on account of its breadth: for instance, our contribution to the Board of Religious Education, with its enrollment of over six thousand children, helping to make it possible for each child to receive ninety hours of religious education per year; the two 45 minute periods per week, in the High School of Iolani, where systematic religious education is given, under a special instructor; the Young Peoples group at St. Elizabeth's, under the direction of Canon Kieb, where regular study is made of the Bible and the Prayer Book; Sister Deborah's work with different classes at the Priory, especially the evening branch of the Woman's Auxiliary, and her untiring mental ministration to the inmates of various homes and hospitals; and the full plan of religious education, the Sunday Study and Worship, and the Week Day Instruction Class carried on by Rev. E. Tanner-Brown at St. Clements. The Young Peoples Study Club had as its incentive "The Creed and Christian

Convictions". Throughout the year there has been a weekly study group at St. Clement's.

The Rev. Joseph Mason, of Epipany, Kaimuki, has laid especial stress on Sunday School work and instruction the past year.

The Program for the Young Peoples Conference held at Mokuleia in September included a class on "How to use the Bible," another on "Everyday Religion for the Youth" and still another on "Church Symbolism". There are many more instances of the high quality of work carried on in our diocese, the enumeration of which would make this report too long.

During Lent, Rev. E. Tanner-Brown gave a twenty-minute talk each Friday at the inter-parochial sewing meetings on "Church Current Events". This new feature covered a wide field and was much enjoyed.

Beginning on January 14th, Mrs. Littell gave four lectures on "Christian Art of the Italian Renaissance". The Academy of Arts kindly cooperated with us in the loan of beautiful pictures on the subjects introduced. These lectures were widely attended by a representative group of women of Hawaii.

The Mission Study Classes during Lent were led by Mrs. Littell, at her home in Emma Square, the subject being "The American Indians", covering three periods: "The History of the North American Indian", "The Conquest of the Indians", and "Preparation for absorption of the Tribes into other Races". Points developed were adequate education, health, vocational opportunities, and Christian training. These classes had the largest attendance of any Study Classes we have ever held. The subject each week was presented so graphically that interest held until the last word was spoken.

Again in October Mrs. Littell started a series of Bible Classes on "The Sources of Authorship". The rooms were filled to their capacity for the entire seven lectures. Many people have remarked that these lectures awakened in them a real longing to read and know their bibles better. Could anything be more inspiring?

"The truth forever must be shown

If new or not;

For there is nothing much unknown

But much forgot".

May I express here the deep appreciation of the women of our church family for the many fine things Mrs. Littell has given us throughout the year.

For Advent, Rev. Kenneth L. Bray spiritually revived us with three meditations:

"Advent as Preparation for the Church Year"

"Advent as a Preparation for the Incarnation"

"Advent as a Preparation for the Christian Life"

The attendance was excellent—many people of other denominations were present, showing the hunger in the hearts of all to really know the covenant of prayer. Five points were stressed—1st, to Prepare; 2nd, to Ponder; 3rd, to Practice; 4th, to Pray; and 5th, to Promise—bringing us a clearer knowledge of the true meaning of Meditation, or applied Prayer Thought.

In closing this report, may I say how deeply I feel in tendering my resignation as your Educational Secretary. It has been a mighty tower of strength and learning for me. It does not "signify my lack of interest in its future progress, nor my separation from the work, but on the contrary the desire that new and vigorous elements may give it an impetus" so that it may continue to be an efficient factor in the development of religious life in Hawaii Nei.

REPORT OF THE UNITED THANK OFFERING SECRETARY

A very interesting visit was made by our President Mrs. William Thompson and myself to Maui last April, which proved very successful.

Our first visit was at St. John's, Kula, with the Rev. C. Fletcher Howe. About eight members were present. The object of the blue box was explained to them and with the earnest help of Mrs. Shim the sum of \$18.15 was received from this district. We also visited the Branches at Lahaina and Wailuku, and at both places interesting meetings were held.

Good work has been done by smaller Branches such as Papaaloa, Kohala, Hawaii, at St. Stephen's, Waialua, Oahu, at St. John's By-The-Sea, Kahaluu, Oahu, and St. James, Hilo.

Over two hundred blue boxes were distributed the past year and the sum of \$480.75 was collected during this period.

As we all know, our aim is to make a 10% gain each Triennial. The United Thank Offering is like a flower which blooms every three years. We do not dig it up every now and then to know just how it is growing, but the latest reports from the gardeners or Diocesan Treasurers, seem to indicate that it is growing fairly well in most dioceses. If we remember, it was a very big plant in 1928.

It would keep on growing if we all sought to carry out this aim:
Every woman with a blue box,
Every blue box with a daily offering,
Every daily offering with a prayer.

REPORT OF THE CHURCH PERIODICAL CLUB

During 1932 we have subscribed to 75 magazines, 56 of these are gift subscriptions to our clergy and missionaries, and 19 are being passed on regularly from the original subscriber to another individual.

325 books have been given to clubs, schools, missions, and to individuals, 57 have been added to our diocesan circulating library in Davies Hall at St. Andrews.

6029 odd magazines have been collected and distributed. These are the figures that have been reported. Many more have been distributed that were not reported.

32 packets of cards and pictures have been given to church schools, 14 phonograph records and 18 games have been placed.

We wish that you who contribute magazines to the Church Periodical Club could follow them on their journey and see the happiness they bring and the good that they do.

Those who contribute English, Australian, Japanese or Chinese papers may know that they are given to cheer the heart of some fellow countryman who is lonely and far away from home. Mothers with little time to spend in the shops, or little money to spend for clothes, see Vogue fashions and read short cuts and helps in sewing and housekeeping in the various magazines for women. Boys' and Girls' Clubs have had material given them to start circulating libraries. Seamen in the city over night, or laid off here out of employment, remain at the Seamen's Institute reading rooms, reading, looking at pictures, working out Crossword puzzles or chess problems, or playing cards or games, instead of seeking less desirable diversion. A negro with a broken back, lying in a plaster cast in one of the City and County Homes and other invalids, have easily handled reading matter to help them pass the long and weary hours. Boys and girls have game clubs, and play dominoes, authors, checkers and parcheesa, instead of roaming the streets. Men in our missions and in the Church Army have books, papers and pictures for their own use and to help them in their work. Boys and girls educated in the

public schools who have learned to love books, but whose homes have no books, are given the nucleus for a home library, to their great pride and joy.

In their name and in our own name, we thank you for your cooperation, and ask your continued interest and help in this part of the work for Christ's Kingdom.

REPORT OF THE SUPPLY SECRETARY

Our quota from the Supply Department in New York was for All Saints' Girls' School, Bontoc, P. I. and was the largest we have had for some time, 638 garments being made, and 24 blankets as well as dispensary supplies being provided. The attendance at the inter-parochial sewing meetings in Honolulu on the six Fridays in Lent was 248, and sewing was taken by seven Branches on this and other Islands whose members were unable to attend,—Good Shepherd, Wailuku; Holy Cross, Molokai; St. Stephen's, Waialua; Holy Innocents' Lahaina; All Saints', Kapaa; Holy Apostles', Hilo and St. Luke's (Korean), Honolulu. The Friendly Friday organization of St. Andrew's Guild and Auxiliary finished up the garments that were not completed during Lent.

The various Branches and individuals contributed the cost of the materials and Parcel Post which amounted to \$291.23, and the estimated value of the labor was \$374.15, making the total value of the box, \$665.38.

And a third cause for thankfulness is the arrival of Mrs. Ikezawa, the wife of the priest in charge of the mission of the Good Samaritan in Palolo Valley. She is a gentlewoman of great charm and dignity and the fact of her having been an Auxiliary woman for

forty years and that plans for starting a branch in their mission are already under way is encouraging. That little mission is greatly blessed in counting among its members the Ito family and Mrs. Tuta Ogai. Because of the latter member the brass altar furnishings have recently been given as a thank-offering for the many years of loving service and the companionship with her by a friend of hers and the missions.

CONSTITUTION

Article I

This Society shall be called, **THE HONOLULU BRANCH OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL.**

Article II

The object of the Society is: By systematic and united effort to diffuse Missionary intelligence, to increase Missionary activity, to promote the study of Missions, and to encourage prayer for Missions among the women of the Missionary District.

Article III

The Church itself is the great Missionary Society, therefore all Baptized women in this District who desire it, and who work for Missions in connection with their parochial organizations, shall be regarded as members of this Woman's Auxiliary, but terms of membership in any Branch may be fixed by that Branch.

Article IV

All Parish and Mission societies of women that so desire, may become branches of this Auxiliary by first obtaining the consent of the Rector or Clergyman in charge, and notifying the President of their intention to work in unison with the Auxiliary.

Article V

The officers shall be: A President, whose term of office shall be three years, and who may be reappointed at the discretion of the Bishop; a First Vice-President, a Second Vice-President and a Third Vice-President. There shall be a Recording Secretary, a Corresponding Secretary, a Treasurer, a Directress of the Altar Department, an Educational Secretary, a Secretary of the Church Periodical Club, a Secretary of the United Thank Offering, a Supply Secretary, an Assistant Supply Secretary, and a Secretary for Oriental Work. All of these officers shall be appointed by the Bishop at the annual meeting.

Article VI

The officers of the District Branch and the Presidents of the Parish Branches, or some one appointed by them, shall constitute the Executive Board, which shall have general charge of the work under the direction of the Bishop.

Article VII

The annual meeting shall be held at the time of the Convocation of the Missionary District, and other meetings on such dates and in such places as the President may appoint.

Article VIII

The representatives of five Branches shall constitute a quorum.

Article IX

This Constitution may be amended at any annual meeting, by vote of two-thirds of the Branches represented.

BY-LAWS

1. The duty of the President shall be to call meetings of the Woman's Auxiliary and the Executive Board and to preside over the same. It shall be her duty to correspond with the Executive Secretary of the Auxiliary, and to see that all new officers are informed of their specific duties.
2. The duty of the Recording Secretary shall be to keep a record of proceedings, and to prepare an abstract of the minutes for the annual report.
3. The duty of the Corresponding Secretary, under the direction of the President, shall be to give notice of all meetings, to correspond with the various Branches of the District, to collect the reports of the various Secretaries, to prepare an annual report, and to issue and distribute the same.
4. The duty of the Supply Secretary shall be to furnish each Branch with work, and to keep a record of the number and the value of Boxes sent. She shall also present a report at the annual meeting.
5. The Treasurer shall have the custody of all moneys received by the District Branch and shall collect, if necessary, all sums payable to the same, in pledges made. She shall pay out money on the order of the President, and the Recording Secretary, except such sums as may be received for a definite purpose, which sums she may dispose of without formal direction. All moneys received for purposes outside of the District shall be forwarded to treasurers empowered to receive the same.
6. The Directress of the Altar Department, the Educational Secretary, the Secretary of the Church Periodical Club, the Secretary of the United Thank Offering, and the Secretary for Oriental Work, shall superintend, foster, and develop by correspondence and otherwise, their several departments on consultation with Diocesan officers.
7. It shall be the duty of the President, or of some person appointed by her to visit, if possible, each Branch in order to promote the interest of the work.
8. It shall be the duty of any Branch, before it discontinues a pledge, which has been made for salary or interest, and which continues year by year, to give a year's notice of its purpose at the annual meeting.
9. Each Branch shall pay yearly to the District Expense Fund such sums as it shall be assessed therefor by the Executive Board. Such payment shall entitle it to seat its delegates and to vote.
10. Each Branch shall pay yearly to the District Altar Fund at least one dollar from the Woman's and fifty cents from the Junior Auxiliary.
11. Each Branch is entitled to seven delegates. If it is impractical to get women as delegates who live in the parish or mission, it is permissible for each Branch to appoint delegates who are resident of Honolulu. If a Branch fails to appoint delegates one week before Convocation, they shall be appointed by the President and Corresponding Secretary.
12. The Secretary and Treasurer of each Branch, through its President, shall make yearly reports to the Corresponding Secretary and Treasurer of the District Branch, of all work done and money given to Missions within and without this Missionary District, and the value of boxes sent.
13. The year of the Woman's Auxiliary shall end on December 31st, of each year, the date on which the Parish and Convocational year ends, and all Auxiliary reports shall be made up to that date.
14. These By-Laws may be altered or amended by a majority vote at each annual meeting.
