

THE BISHOP'S LETTER

Nantucket, Mass., May 26, 1924.

My Dear Mr. Ashworth:

Your letter of May 7 tells me that early in June there will be published an abbreviated Journal. Perhaps you would like to insert this brief letter as a message to my dear friends in the Church in Idaho.

The last three months have been spent in a way that I never planned when last we met. March and part of April I was in the Presbyterian Hospital in Chicago under the care of Dr. B. W. Sippy. Just before Easter I was allowed to leave the hospital and after a few days at a hotel in Chicago, with Mrs. Touret and William, I came on to Massachusetts. We stayed for three weeks at the Groton Inn, Groton, Mass., and week before last we came here to our island cottage where we expect to remain until Fall.

We all miss Idaho. I am extremely sorry not to be making my Spring visitations. I cannot possibly put into words my disappointment that ill health has made necessary these all too frequent rest periods. All I can say is that I am gaining in strength and hope and pray that this long vacation may bring a definite result.

The Council of Advice, I know is carrying on well and I rejoice that I can leave behind a group of Church men so devoted and so efficient. Letters tell us that the institutional life is going on well. I think constantly of St. Luke's Hospital, St. Margaret's School and the Indian Mission.

I am glad our places are all well manned and that there are no vacancies. Such a contrast to the situation just a few years ago!

God bless you one and all. Remember me in your prayers as I remember you. Do not forget your responsibility in the corporate life of the Church both in terms of service and in terms of financial support. Our four years together have been happy fruitful years. Keep up the high standard that we have tried to maintain. And believe "the best is yet to be."

REPORT OF THE EASTERN DEANERY

The third meeting of the Boise Deanery was held in St. James' Church, Payette, Idaho, May 14th, 1924. Convocation opened with a celebration of The Holy Communion at 10 a. m., Rev. Thos. Ashworth being celebrant.

After a short recess the meeting was called to order by Dean Roberts as chairman.

The first order of business was the election of a Secretary which resulted in the choice of Mrs. Mabel F. Gunn.

The minutes of the Second Deanery Meeting were read and approved. Mrs. Kurtz moved that a telegram of greeting and good wishes be sent to Bishop Touret and Mrs. Touret at Nantucket, Mass. The motion carried, and the Secretary was requested to send the message. Moved by Mr. Gunn that the Rev. Mr. Newman be invited to a seat in the Deanery meeting with privilege of the floor. The Chair then called on Mr. Ashworth to speak on the topic "What Place can the Deanery Fill." Mr. Ashworth extended a hearty welcome to the delegates attending, then dwelt on the various benefits derived in the way of social contact and spiritual uplift.

The Chair, following this, called the attention of the meeting to the needs of THE IDAHO CHURCHMAN. He stated that the Bishop was

finding it very difficult to make the paper pay owing to the fact that so few Church People in Idaho were taking it. The Dean stated that the Cathedral plan was to place the paper in every Church family at half price and the cost of it made a part of the regular budget. Mr. Ashworth also stated that the same plan was being followed in Payette and Weiser. Motion was made by Dr. Virgil, duly seconded and carried, that the same plan be recommended and urged in all the parishes and missions of this Deanery. The Secretary was instructed to send a copy of this motion to every parish in the Deanery not already having adopted this plan. The Dean urged sending in news items, or having a regular correspondent in each place and stated that all copy must be in the hands of the editor by the 8th of the month.

The Dean called attention to the general offering which was ordered by THE NATIONAL COUNCIL to be taken on May 25th for reconstruction work in Japan, and urged the necessary publicity be given to it. Mr. Redway, of Caldwell, spoke on the need of better acquaintance and suggested the value of an exchange of visits among the congregations of the Deanery.

Mr. Hanft, Organist of the Cathedral, addressed the Deanery on the subject of "Cooperation in Choir Work." He suggested that the Cathedral folio music might be available for all places that could use it if it could be used and returned. He recommended exchange of choirs and stated that the Emmett Choir had recently sung at the Cathedral and were now using some of the Cathedral music. He recommended also the holding of a general choir festival at the Cathedral preferably in the fall of the year. Mr. Gunn spoke of the Boy Choir as peculiar to our Communion especially and that we should make the most of it. He thought much help might be derived by groups of boys from the Cathedral making tours to the outside places and assisting in special services when it was possible. Mrs. Roberts moved that an effort be made for an exchange of choirs, which was seconded and carried.

Mr. Redway asked permission to call attention to THE BISHOP TUTTLE MEMORIAL, as the Bishop had requested him to act as local chairman for the fund, and requested that names of all old time friends and acquaintances of Bishop Tuttle be sent to him.

At this point the Deanery adjourned to the Hotel Bancroft where luncheon was served. At the close of the luncheon a motion was made by Mrs. T. D. Farrar that a rising vote of thanks be tendered the members of St. James' Parish, Payette, for their fine hospitality.

On reassembling the question was raised as to who might be accredited delegates of the Deanery. The Chair ruled that all who were interested to attend the meetings from the various Parishes and Missions would be counted regular delegates.

The question of the time and place of holding the next meeting of the Deanery was discussed. It was agreed to meet early in October at Emmett and that a committee of five be appointed by the Chair on program and general arrangements. Later the following names were handed to the Secretary by the Chair as said committee: Mr. E. R. Brance, Mr. Paul G. Hanft, Mrs. J. T. Updike, Mrs. Lauren Dean and Mr. W. H. Redway.

A telegram of greeting was read from Mrs. Howard Stoy, Vice President of the Auxiliary. She especially urged that all the local branches provide themselves with *Life of Miss Julia C. Emery*, recently published, and use it in group study the coming year.

A letter from Rev. Louis P. Nissen, Director of Religious Educa-

tion, containing many helpful suggestions, was presented by the Dean. The Rev. I. Q. Wood of Ontario, was then introduced. He brought greetings from Eastern Oregon, and addressed the meeting on "Social service in rural communities."

Miss Elise Armitage Roberts spoke on the Work of St. Margaret's School, outlining their program and indicating the general prospects ahead.

The Dean spoke of The Home Missions Council of Idaho, an inter-denominational organization, whose purpose was to cooperate in mission work and avoid overlapping and competition in the Home Mission field. He stated that both the Bishop and he were members of it, and he thought that our Church people generally should concern themselves in it. Mention was made, under this head, of the Inter-church Council of women, and that a Prayer Day was being observed by them in various places.

A motion was made that a vote of thanks be given to W. J. Hughes, manager of the Emma Theatre of Payette, and to his operator for the generous offer of their house and services in showing the Japanese films which the Dean had expected to have but which did not arrive. A vote of thanks was also tendered the Rector and members of St. James', Payette, for their hospitality, and to the Rev. Mr. Wood for his message from Eastern Oregon.

The session then ended with prayer and a benediction by the Dean.

REPORT OF THE NORTHERN DEANERY

The Rev. D. J. W. Somerville, Dean

The Northern Deanery of the Missionary District of Idaho was called to order by Dean Somerville at 9:45 on the morning of June 4th, 1924, at Lewiston, Idaho. The Very Rev. Paul Roberts, Dean of St. Michael's Cathedral, Boise, and the following members of the Northern Deanery answered roll call: The Rev. D. J. W. Somerville of Lewiston; the Rev. H. H. Mitchell of Moscow; the Rev. W. H. Ward of St. Maries; the Rev. F. W. Pratt of Coeur d'Alene; and Messrs Darwin of Lewiston and Butterfield of Moscow.

There was a celebration of the Holy Communion at 8 a. m., the Rev. H. H. Mitchell officiating.

Prayer was said by Dean Somerville.

In the absence of the Rev. F. D. McCabe, the Rev. F. W. Pratt was elected secretary.

Upon request by the Chair, Dean Roberts addressed the meeting giving his impressions as received from his survey of the Missions in the Northern Deanery. He pointed out the lack of suitable signs on several of the churches he had visited and urged that this lack be remedied at once. He suggested that adult Bible classes be formed in more of our Missions and that our people be urged to take up the study of Church literature. He also spoke of a series of cards bearing questions and answers in regard to the church, same to be used in conjunction with books to be suggested by the clergy, for the improvement in knowledge of the church.

Upon motion duly made, seconded, and carried Messrs Darwin and Butterfield with the Editor of the Idaho Churchman were chosen as a committee to draw up a map of the State showing the locations of

the Church's stations where a clergyman has his headquarters by a line drawn around it, with other lines running to his out-stations.

Moved, seconded, and carried that the Secretary of this meeting be required to send copies of the minutes of this meeting to the Presidents and Secretaries of the Deaneries of this District.

The Rev. H. H. Mitchell, upon request by the Chair, presented a most forceful and interesting paper on "Religion and Medicine." Upon conclusion of the paper recess was taken for luncheon in the Parish Hall with the Vestry and other members of the Church of the Nativity.

At 1:00 p. m. the meeting was reconvened and discussion opened on the Rev. Mitchell's paper.

The Idaho Churchman then came up for discussion. Those present expressed themselves as being greatly pleased by this excellent publication. Attention was called to the need of renewed subscriptions, and parochial cooperation.

Discussion was had as to the feasibility of arranging a "traveling library" for the use of the Clergy and isolated communicants.

Upon motion duly made and carried Dean Somerville and the acting Secretary were made a committee to arrange next Convocation.

Adjournment was made at 3 p. m. for a drive and picnic supper at Winchester.

REPORT OF THE SOUTHERN DEANERY

The meeting began with a service in Trinity Church, Pocatello, Wednesday, June 18, at 8 p. m. Addresses were given by the Rev. J. C. Ingham, on Publicity, and by the Rev. L. P. Nissen, on the Importance of Religious Education.

The clergy present at the service were the Venerable H. Stoy, Archdeacon; the Rev. C. H. L. Chandler, dean of the Pocatello deanery; the Revs. L. P. Nissen, Twin Falls; J. C. Ingham, Blackfoot; W. J. S. Dumvill, Shoshone; B. C. d'Easum, Rupert.

There was a Celebration of the Holy Communion in Trinity Church at 8:30 a. m. Thursday, June 19. The Celebrant was the Rev. J. C. Ingham; the Rev. C. H. L. Chandler was Gospeller, and the Rev. W. J. S. Dumvill was Epistoler. The Venerable H. Stoy gave an address on Fellowship.

Following the service the clergy were entertained at breakfast at Trinity Rectory by Mrs. Chandler.

Business sessions began at 10:30 a. m. in the vestry room, Trinity Church. Clergy present were: the Venerable H. Stoy, Archdeacon, Pocatello; the Very Reverend Paul Roberts, dean of the Cathedral, Boise; the Rev. C. H. L. Chandler, dean of the Pocatello deanery; the Revs. J. C. Ingham, Blackfoot; M. B. Nash, Idaho Falls; L. P. Nissen, Twin Falls; W. J. S. Dumvill, Shoshone; B. C. d'Easum, Rupert.

The meeting was opened with prayer by Dean Roberts.

The Rev. C. H. L. Chandler asked the Rev. L. P. Nissen to act as temporary chairman. Upon motion, the Rev. B. C. d'Easum was elected secretary of the Pocatello deanery.

The subjects of Missions, Nation Wide Campaign—the matter of the "Whole Church Facing its Whole Task," were discussed.

Ingham-Dumvill. "That a committee be appointed to plan a fall campaign programme to be presented at the next meeting of the deanery." Carried.

Chandler-Stoy. "That the fall meeting of the deanery be held during or near the week beginning September 21, the date to fit in with the dates of the meetings of the other deaneries; and that the Council of Advice be asked to furnish a speaker for the fall meeting of the Pocatello deanery." Carried.

Dumvill-Stoy. "That the various parishes and missions in the Pocatello deanery be asked to make an offering to help towards paying the cost of the deanery meeting in the fall." Carried.

The Japanese Reconstruction Fund came up for discussion, the clergy in general reporting lack of enthusiasm.

Prayers for Missions were offered at noon by the Rev. L. P. Nissen. Upon motion of Archdeacon Stoy the meeting adjourned until 2:45 p. m.

Afternoon Session

Clergy present as before. The Rev. C. H. L. Chandler asked the Rev. M. B. Nash to act as temporary chairman.

Dean Roberts and others urged the need of supporting the Church paper, The Idaho Churchman.

Chandler-Nissen. "That every parish and mission in this deanery send a list of families to whom The Idaho Churchman may be mailed each month at a cost of fifty cents a year." Carried.

It was suggested that the cost of these subscriptions should come from the parish budgets.

Dean Roberts drew attention to the fact that this year was the twenty-first anniversary of the coming of Archdeacon Stoy to the Missionary District of Idaho. The Dean spoke of the Archdeacon's arduous and faithful work as a builder and torch-bearer of the Church in Idaho. The Revs. C. H. L. Chandler and B. C. d'Easum also spoke feelingly of the Archdeacon's untiring zeal and devotion.

Chandler-d'Easum. "That a committee be appointed to draft a resolution expressing an appreciation of the great work done for the Church by the Venerable Howard Stoy during his ministry of twenty-one years in Idaho." Carried with a standing vote of all the clergy.

The Archdeacon replied in a few fitting words.

The Chair appointed the Revs. C. H. L. Chandler, B. C. d'Easum and W. J. S. Dumvill to draft the resolution.

Nissen-Dumvill. "That a telegram be sent to Bishop Touret, pledging the loyalty of the clergy of the Pocatello deanery, and expressing their sympathy with him in his illness." Carried.

The Chair instructed the secretary to send the telegram.

"The clergy of the Pocatello deanery in meeting at Pocatello today express their sympathy and loyalty. They pray that your health may soon allow you to return to Idaho.

The secretary was also instructed to send a letter to Mrs. Stoy, enclosing a copy of the resolution drafted to express appreciation of Archdeacon Stoy's splendid services to the Church.

Chandler-Nissen. "That the clergy of the Pocatello deanery en-

dorse the work of the Home Missions Council." Carried.

Dean Roberts and others spoke of the work of the Home Missions Council.

The subject of Church School work was discussed by Dean Roberts, the Rev. L. P. Nissen and others. Several of the clergy asked Dean Roberts to furnish them with sets of his Question and Answer cards for use in their Church Schools.

Nissen-Ingham. "That the Church Schools in this deanery take part in the work of the Church Service League and that they use the chart of the Five Fields of Service as a record." Carried.

Nissen-Stoy. "That the clergy of this deanery be asked to consider the advisability of making the Sunday after Christmas Day a 'Family Day,' when parents and children shall be urged to be in their places in Church as families." Carried.

This resolution was moved in the hope that it might be the means of stimulating "family attendance" at the services of the Church.

A discussion followed on the subject of the Young People's Fellowship League.

Mrs. R. S. Stringfellow gave a talk on her work as Field Secretary for St. Margaret's School at Boise. The clergy pledged themselves to use every effort to support this Church institution.

Votes of thanks were passed to Mrs. Chandler, Archdeacon Stoy and to the Rev. C. H. L. Chandler for hospitality extended to the visiting clergy.

Dean Roberts closed the meeting with prayers.

REPORT OF ARCHDEACON

To the Bishop and Council:

It is my privilege to present a summary of official acts and duties performed during the Convocational year ending January 24.

To particularize all the items that occur in such an administration pertaining to the general office of service would require more than a single column. Not only in the special matter of the spiritual, but also in the essential affairs of the temporal are requirements that fall to the function of the Archdeacon. During the past period I have continued to act as active warden of the Indian Mission of the Good Shepherd at Fort Hall and its connected interests, supplying services there during part of the year and giving general oversight until October. I also supplied services at the Government Indian School and maintained pastoral supervision and services at stated times at the following named places: American Falls, Mackay and Montpelier, assisting and officiating also at other Churches. I held two services in memory of the late President Harding, one at the Government Indian School by the request of the officials which was largely attended by the employees and others of the Reservation.

As a member I have attended several administrative conferences of the Bishop and Council and the Council of Advice. During the summer I made a trip to Montana in the interest of St. Margaret's Hall, attending the commencement of the same institution. During the Spring I formulated and directed the service of the laying of the corner stone of the Government Hospital.

Having been appointed by the Bishop to represent the Church in Idaho, I took part in an important survey of Southern Idaho, suggested by the Board of Federated Churches which was represented by secretaries of the several denominations.

The result and recommendations of the survey have been printed by the organization in Idaho. The data obtained relates to over-churched communities and neglected rural districts. This information has been the basis of intelligent or harmonious cooperation on the part of the various church interests. I have occasion to observe that the Church properties are in a commendable condition.

Frequent removal of church families do not affect one church or locality alone, but is a condition which presents a problem of no light consideration.

REPORT OF FORT HALL INDIAN MISSION

The following is an abbreviated report of Fort Hall Indian Mission which I preface with the statement that the Rev. J. C. Ingham was appointed in October to take charge of the spiritual direction of the Mission with same general spiritual oversight of the Reservation. Previous to that month this responsibility devolved upon me—since that month religious services have been held regularly every Sunday afternoon and on days of special observance. The year ending December 31 marks a successful period without any serious illness or accident among the pupils. The young Indian girls, the number averaging 24, made most commendable progress in every way under the efficient direction of the devoted women in charge. Through strict economy on part of the management all obligations financially have been met.

The current expenses during the year ending December 31, 1923,

amounted to \$2,720.53, independent of salaries excepting that of the assistant in domestic science which is included in the above statement. The resources from farm rental includes besides cash received, services rendered, repairs, improvements, supplies, together with irrigation tax and the installing of the heating plant and coal expense which represent the rental of \$1000. This amount together with salaries from the Mission Board (not including services of the missionary acting chaplain) represents approximately the sum total of \$5,160.50 for the past year.

Various contributions of small sums were received, also a few scholarships. We mention particularly those from Kellogg, the Juniors of Idaho and Mass.

During the past years the school has been materially helped by a number of scholarships from churches and schools. These have lapsed. It is hoped that interest may be revived through these agencies to meet the demands for the extension of this special work of the church.

The Mission is indebted to a number of our church organizations and fields which have donated on several occasions, fruits and eatables. The maintenance of the school is mainly derived from the general church support.

The government furnishes aid only the grant of land of 160 acres, partly under cultivation, but assessed fully for water rights.

By a special act of congress this grant is insured to the church for perpetual use.

Clothing for our Indian charges is supplied through the agencies of the Woman's Auxiliary.

Children and others also on the Reservation at Christmas-tide are recipients of toys and clothing provided by the church.

There is needed another addition to the well appointed plant, Through the efforts of the Bishop a most essential laundry and bath room was provided(followed by the addition of a light and spacious school room. A building suitable for recreation and healthful exercise during stormy weather and the winter months, is a necessary requisite and it is hoped that it may be acquired in the near future.

We pass from the essentials of this report to add a closing comment: Creditable provision has been made by the government for the general welfare of the Indian, but influences exist affecting the moral and spiritual life which come within the province of the church to counteract, and challenges a wider program of service.

We had an increase of 209 in the total admissions and an increase of 2.7 in the daily average number of patients treated in the hospital. Many persons have been refused admission during the year on account of lack of room.

No repair work of any account, except the absolute necessities, has been done. The rooms have been so constantly occupied that any more than the very necessary cleaning was impossible. No painting or calsoining of any account has been done, or any furniture replaced. It seemed advisable, if possible, to wait until some definite decision was made concerning the proposed wing.

The financial statement shows a slight increase in the average daily maintenance. This is caused by the character of the service rather than in increased cost of supplies. Following is an excerpt from the financial statement:

It will be seen how utterly impossible it would be to maintain the hospital on the receipts from the patients. Besides the gifts of money, several boxes of linen have been received from the Women's Auxiliary of the Eastern Dioceses, and several substantial gifts of linen and fruit from the churches and societies in and around Boise.

Two changes were made in the personnel of the staff: Miss Cora

W. Palmer resigned her position as night supervisor, and Miss J. Evelyn Fox, the maternity supervisor, was called home on account of illness. Mrs. Dorothea Povey and Miss Adelia Stonedahl were appointed to fill these vacancies.

Of those students who resigned or were dismissed four left before the end of the probation period.

Two classes were admitted, one in February and the other in September. There has been a marked increase in the number of applicants for admission to the school, and we have admitted all the students we can house.

The class work has been carried on much better than usual. Miss Williams has held 224 classes for beginning students, besides demonstrations and practical instruction in the wards. The members of the medical staff have held 97 classes and lectures, and 244 hours of instruction have been given by the superintendent and her assistants.

The work of the Training School has been very gratifying this past year, and shows much improvement. We ask for especial interest in this very important branch of education and hospital service. We need more teaching equipment and a larger reference library,

We wish to thank the members of the medical staff, the friends of the hospital and our trustees for their loyalty and support.

ST. MARGARET'S SCHOOL REPORT

Boise, Idaho, June 19, 1924.

To The Right Reverend Bishop of Idaho and to Board of Trustees:

I herewith submit the following report of St. Margaret's School for the year 1923-1924:

June 2, 1924, was Commencement Day at St. Margaret's School and we feel that it closed a year of earnest and worth while endeavor.

The School opened September 12th, 1923, with an increase of students over the previous year. There were twenty boarders and sixty day scholars. What was more significant than numbers was that the type of girl was decidedly finer than in the previous years. This was due to two causes—

First:—The scholastic standard of the School demands a real desire for an education. The State Supervisor of High Schools, Miss Redfield, for the second consecutive year inspected St. Margaret's November 1923, and she recommended to the State Board of Education that St. Margaret's School be retained on the accredited list of High Schools, which recommendation was ratified by the Board. In her report she spoke of the high morale that was apparent in the various phases of the work and life of the School.

Second:—The General Church recognizing that religious education is an essential in the development of the young womanhood of Idaho,

gives St. Margaret's School such a generous sum that it is possible to offer scholarships to students who otherwise would not be able to attend the Church Boarding School. This means that a careful selection was made from many applicants for scholarships.

Permanent repairs are done as finances permit. The Church Schools of Idaho gave a generous sum to the School for class room equipment. We are indebted to many Eastern friends for additions to our library and household supplies.

Cooperation and loyalty on the part of the various members of our household account for any measure of success during the year.

The best summary for the year and perhaps the most encouraging aspect is that the undergraduates are eager to return to St. Margaret's in September.

JAPANESE RECONSTRUCTION FUND

Statement

Acting under instructions of the National Council, this Committee presented to the people of the Church the needs of the Church in Japan, due to the earthquake and fire of last September. The schedule of reconstruction required for its completion the sum of \$2,400,000, in addition to the sum already in hand toward the cost of St. Luke's International Hospital and the cost of new land, which is to be provided through the use of property now owned in Tokyo.

The Committee determined upon a plan of campaign having three distinct features, the first being the solicitation of the people of larger means by direct representatives of the Committee, the second being a selective canvass in each parish by a parish committee of all able to give or pledge in amounts of \$10 and upward, and the third being the general offering on May 25th.

From reports so far received from dioceses and parishes the Committee estimates that there has been given and pledged to date something less than \$700,000.

The Committee would again emphasize the vital character of this work, in order that the fruits of sixty years of intensive effort may

be realized. Practically the entire equipment of the Church in Tokyo and vicinity has been destroyed. This must be replaced in order that the Church's work shall not be permanently crippled in the face of unequalled opportunity for effective service.

The Committee proposes to go right on with its work until its duty has been fully discharged and will keep the Church informed.

With the funds now in hand or assured by pledges, it will be possible to proceed with some of the most immediate needs.

The Committee desires to express its deep appreciation to those who have given and to those who have labored earnestly for this great cause.
