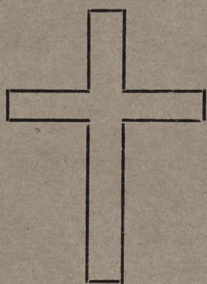

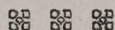

# Journal of the Proceedings

## of the Twenty-first Annual Convocation

OF THE

### Protestant Episcopal Church

IN THE

### Missionary District of Idaho

---

BOISE, IDAHO, May 6, 1929

The Twenty-first Annual Convocation of the Protestant Episcopal Church in the Missionary District of Idaho met, pursuant to the call of the Bishop, on Monday, May 6, 1929, at St. Michael's Cathedral, in Boise, Idaho.

At 8:00 A. M. there was a Celebration of the Holy Communion in the Cathedral, at which the Celebrant was the Rev. D. J. W. Somerville, assisted by the Rev. L. A. Cook.

Convocation convened at 9:30 A. M. in the Cathedral and proceeded to organize under the presidency of the Bishop of Idaho, who offered the opening prayers.

The Bishop appointed the Rev. H. H. Mitchell, the Rev. D. J. W. Somerville and Mr. R. S. Butterfield as a Committee on Credentials.

There being a quorum, the Chair declared the Convocation duly organized.

Upon motion the privileges of the floor were accorded to the Right Reverend Edward M. Cross, D.D., Bishop of Spokane, who, upon being introduced by the Bishop of Idaho, was most heartily welcomed.

Nomination was made of the Rev. Thomas Ashworth for Secretary of Convocation, and it was moved and seconded that the unanimous ballot of Convocation be cast for his election. This motion was carried, and the Chair declared the Rev. Thomas Ashworth duly elected.

Mr. Rolston S. Butterfield was nominated for Treasurer of the District, and it was moved and seconded that the Secretary cast one ballot for his election. The motion was carried, the Secretary reported that he had cast the ballot, and the Chair declared Mr. Butterfield duly elected.

Upon motion duly made and carried, the Rev. Thomas Ashworth was elected Treasurer for the funds of the General Church and District Program.

Mr. Walter Ashton of Boise was nominated for the office of District Auditor, and upon motion was unanimously elected.

The Chair announced the appointment of the following committees:

The Bishop appointed the Ven. Howard Stoy to be Rural Dean of the Boise Deanery, in place of the Very Rev. Paul Roberts, who has left the District, and the Rev. B. C. d'Easum to be Rural Dean of the Pocatello Deanery in the place of the Rev. J. C. Ingham, who was transferred to the Diocese of Oregon in the fall of 1928.

At 10:00 A. M. Convocation adjourned to meet in joint session with the Woman's Auxiliary. At this time the Bishop of Idaho read his annual address. (*Appendix I.*)

The Secretary read an official communication received from the Secretary of the House of Deputies, General Convention, in accordance with Canon 51, Section 1, Sub-Section 4, relative to the alterations of the Constitution proposed in the General Convention of 1928, to be finally acted upon in the General Convention of 1931, in accordance with Article 11 of the Constitution.

#### COUNCIL OF ADVICE

The Secretary read the report of the Council of Advice, which was accepted and ordered filed.

A motion was made and duly carried that the consideration of the Report of the Committee on the Bishop's Address be made a special order of business for 2:00 o'clock this afternoon.

#### THE BISHOP AND COUNCIL

Reports were called for from the various departments.

The Rev. H. H. Mitchell, Vice-Chairman of the Departments of Religious Education and Publicity, presented reports from these departments, which were received and ordered filed.

#### DEPARTMENT OF FINANCE

The vice-chairman of this department, the Rev. Thomas Ashworth, presented the following reports:

Report of the General Church and District Fund for 1928.

This report was received and ordered printed in *The Journal*. (*Appendix 2.*)

Report of the General Church and District Fund up to May 5, 1929.

This report was received and ordered printed in *The Idaho Churchman*.

Report of the Church School Lenten Offering, 1929.

This report was also received and ordered printed in *The Idaho Churchman*.

The District Treasurer, Mr. R. S. Butterfield, presented his report for the year 1928.

This report was received and ordered printed in *The Journal*. (*Appendix 2.*)



A hearty vote of thanks was accorded Mr. Butterfield for the valuable service he has rendered to the District as Treasurer.

#### DELEGATES TO THE SYNOD OF THE PACIFIC

The Chair stated that nominations were now in order for three clerical and three lay delegates to the Synod.

The following clerical delegates were nominated and were unanimously elected: The Very Rev. Frank A. Rhea, the Rev. H. H. Mitchell and the Rev. D. J. W. Somerville.

The following lay delegates were nominated and unanimously elected: Mr. Walter Ashton, Emmett; Mr. H. Goldsmith, Idaho Falls; and Dr. G. Morey Miller, Moscow.

The Rev. I. Q. Wood, Twin Falls, was elected clerical alternate. No other alternates in either order were elected.

#### ST. MARGARET'S SCHOOL

The annual report of Mrs. Stratte, the Principal, was read and was ordered filed. Upon motion, the Secretary was instructed to convey to Mrs. Stratte the appreciation of the Convocation of the admirable manner in which she has served the Church at St. Margaret's.

The noon hour having arrived, the Rev. R. S. Stringfellow offered prayers for Missions.

Convocation adjourned until 2:00 P. M.

### Afternoon Session

Convocation resumed at 2:00 P. M. and proceeded to a consideration of the special order of business, which was the report of the Committee on the Bishop's Address as follows:

Your committee desires to express its appreciation of the very clear and able analysis of the Church situation in this District, and trusts that the Church people of Idaho will steadily progress towards achieving the goal of self-support. We feel gratification in the report of the financial condition and the fact that our field has not suffered any disruption of the work, even in the face of a radical reduction in support from outside.

There are two matters which call for special comment, viz: The policy of our missionary efforts within our own District, at this time exemplified by the situation at Salmon, and the building program at Moscow.

Your committee recommends that receipts for the General Church and District Program be applied in the following order of priority:

General Church Quota .....	\$ 5,300.00
Executive Secretary's Salary .....	750.00
Expenses for travel, printing, etc. ....	400.00
To supplement Clergyman's salary at Salmon .....	600.00
Moscow Building Program .....	3,750.00

(In case of the Salmon allotment not being called for, that amount is to be added to the Moscow Building Fund.)

We cannot stress too strongly the importance of each place meeting its General Church and District Program Quota in full in 1929.

The second item in the Bishop's Address calling for special consideration is the Moscow Building Program, and, outstanding in this connection is the alternative given to us by our Bishop, of abandoning the program in its entirety. Your committee cannot too strongly rule out any consideration on our part of such a thought, and urge that we stand pledged to complete the program in full at the earliest possible date.

Your committee recommends at this time the appointment of a committee given power to act to purchase at the earliest opportune time such new property and to sell such property now owned, so as to bring under our control a suitable building site at Moscow.

We note with great satisfaction the effort of our Bishop to have confirmations more often in our parishes and missions, and, as this will bring a closer pastoral touch, we heartily recommend this program to the clergy.

The report was received and it was resolved to consider the same item by item.

Dr. G. Morey Miller addressed Convocation with reference to the location of the proposed buildings at Moscow, and, with the aid of a plan, explained the present property holdings of the Church and the lots upon which the Church has options.

It was moved, seconded and carried:

That the application of funds of the General Church and District Program for 1929 as recommended by the committee be adopted.

It was moved by the Rev. D. J. W. Somerville, seconded and carried:

That a committee be appointed with power to act to purchase at the earliest opportune time such new property and sell such property now owned so as to bring under our control a suitable building site at Moscow.

It appearing that St. Michael's Parish, Boise, had been paying a special rate for the use of the inside page in *The Idaho Churchman*, it was agreed that in future no extra charge be made for this privilege.

The Secretary reported that a levy of 5 per cent upon current expenses should be adequate to meet the above budget.

It was moved, seconded and carried:

That the above budget be adopted and an assessment of 5 per cent upon the current expenses of each parish and mission for 1928 be levied accordingly.

#### BISHOP AND COUNCIL

The Bishop appointed as members of the Bishop and Council the Very Rev. Frank A. Rhea, the Ven. Howard Stoy, the Rev. Thomas Ashworth, Mr. R. M. Davidson, Mr. T. A. Purton, and Mr. William Northrop.

The following were elected without a ballot: The Rev. D. J. W. Somerville, the Rev. H. H. Mitchell, the Rev. L. A. Cook, Mr. R. S. Butterfield, Mr. F. H. Wheeler, Mr. Walter Ashton.

#### REPORTS OF COMMITTEES

The report of the Committee on State of the Church presented by the Rev. D. J. W. Somerville was received and ordered filed.

The Chair ordered this committee continued for another year.

#### DEPARTMENT OF MISSIONS

Reports from the Archdeacons were received and ordered filed. Archdeacon Stoy made a verbal report on the work of the Indian Mission at Fort Hall.

The Committee on Canons reported that no business had been assigned to it.

The Committee on Resolutions reported as follows:

The members of Convocation desire to express their thanks and appreciation of the hospitality shown them by the people of Boise, and to assure them that they have fully enjoyed the time spent in the city.

Upon motion this report was unanimously adopted.

Convocation adjourned at 4:00 P. M. to visit St. Luke's Hospital.



## Second Day

Convocation met in business session at 9:30 A. M.

Opening prayers were said by the Bishop of Idaho.

The minutes of yesterday's session were read and approved.

The Chair announced the appointment of the following committee for the Moscow Building Program, in accordance with the Resolution adopted by Convocation yesterday: The Bishop of Idaho (Convener), the Rev. Thomas Ashworth, Mr. Abe Goff of Moscow, and Mr. Stanly A. Easton of Kellogg.

### REPORTS OF COMMITTEES, ETC.

The Secretary read the report of St. Luke's Hospital, which was received and ordered printed in *The Idaho Churchman*. It was moved by the Very Rev. Frank A. Rhea, seconded by the Rev. W.R.R. Simmons, and carried:

That the Secretary be instructed to write to Miss Emily Pine, Superintendent, expressing the deep appreciation of Convocation for the absolutely invaluable services she has rendered to the Church, not merely as Superintendent but for her unselfish devotion in the task of bringing the building of the new St. Luke's to such a successful conclusion.

It was further moved, seconded and carried:

That Convocation desires to express its appreciation of the services rendered to the Church's work by the medical staff and the nursing staff of St. Luke's, and especially the services of Mr. William Northrop for his devoted and able supervision of the new building.

The Committee on Necrology reported by its Chairman, the Rev. D. J. W. Somerville. The report was ordered printed in the Journal. Convocation stood in silence while the Bishop offered prayers in memory of the departed.

### SACRAMENTAL WINE

It was moved by the Rev. H. H. Mitchell, seconded by the Rev. Thomas Ashworth:

*To the Governor of the State of Idaho:*

RESOLVED, That this Convocation, taking note of the fact that the transportation of wine is forbidden by law in the State of Idaho, and no exemption is made for Clergy who find it necessary to transport wine for sacramental purposes, we therefore beg the Governor of the State of Idaho to bring this matter to the notice of the Legislature of this State with a view to altering the law in this respect.

Carried unanimously.

### SUMMER SCHOOL

A discussion ensued relative to the date of the Summer School originally planned for the month of June.

Moved by the Rev. V. E. Newman, seconded and carried:

That the Summer School at Coeur d'Alene be held from Tuesday, July 16, to Thursday, July 25.

The Chair congratulated the people of Lewiston upon the splendid interest shown by them in the Moscow Building Program and the fine example of leadership which they have given to the rest of the State. Convocation heartily concurred in this commendation.



## THE CHURCH'S PROGRAM

The Executive Secretary, the Rev. Thomas Ashworth, made a brief address relative to the plans for the field work in the coming fall, and made an appeal for support in carrying out more effectively the methods adopted by the Field Department of the National Council which have proved so successful elsewhere.

## PLACE OF CONVOCATION IN NINETEEN-THIRTY

The Rev. D. J. W. Somerville of Lewiston extended a hearty invitation to Convocation to meet in Lewiston in 1930. Upon motion the invitation was accepted and Convocation will therefore meet in Lewiston upon a date to be determined by the Bishop.

The reading of the minutes was dispensed with.

Closing prayers were said by the Bishop and Convocation adjourned sine die.

## ROGATION SUNDAY, MAY 5, 1929

At 7:00 A. M. the Bishop of Idaho, assisted by the Very Rev. Frank A. Rhea, Dean of St. Michael's Cathedral, celebrated the Holy Communion in the Chapel of the new St. Luke's Hospital and the Chapel was formally dedicated.

There was a celebration of the Holy Communion in the Cathedral at 8:00 A. M., the celebrant being the Rev. B. C. d'Easum, assisted by the Rev. I. Q. Wood.

The Corporate Communion service of the District was held in St. Michael's Cathedral at 11:00 A. M. The Bishop of Idaho was the celebrant, assisted by the Ven. Howard Stoy and the Ven. M. B. Nash and the Rev. Thomas Ashworth, Executive Secretary. The Preacher was the Right Rev. Edward M. Cross, D.D., Bishop of Spokane, who took as his text S. Matt., 27:22, "What shall I do then with Jesus which is called Christ?"

## APPENDIX I

### BISHOP'S ADDRESS TWENTY-FIRST ANNUAL CONVOCATION Missionary District of Idaho

*My Brethren:*

We come to the end and the beginning of another year with gratitude to God for His goodness to us. There have been many worth-while accomplishments and some disappointments. The accomplishments remain with us as permanent gains. The disappointments merely mean that certain things which we hoped to accomplish this year will have to be deferred. There is this difference between a disappointment and a failure. A failure is something which we thought to do and found we could not do. A disappointment is something which we had hoped to do this year and found it necessary to postpone. I do not think that we have failed in any of our corporate undertakings. In some things, perhaps, we have made the rather commendable mistake of trying to do too much in too short a time. But God has all the time there is, and I feel very sure that in His own good time all our dreams will come true. St. John speaks of "the Kingdom and patience of Christ." Perhaps at times we have tried to bring the feverish unrest and drive of this world over into the Kingdom, which is as a seed growing secretly. Perhaps we have tried to force a growth here and there when God knew it to be unwise. We must work at God's Kingdom, yet learn Christ's patience. Sometimes we aspire to set the cross on top of God's temple, when God has called us to lay foundations. It may be that God sends disappointments to teach us this lesson. There have been achievements and disappointments. If we thank God for the one and learn something of God from the other, then we have a right to be thankful and to look God and our work in the face—unafraid.

There have been some clerical changes since our last gathering. The Rev. Mr. Dumville has left us and gone East, but to date has not asked for a transfer to any other diocese. The Rev. Mr. Ward has accepted work in Arizona and asked for and received a letter of transfer to Bishop Mitchell. The Rev. Paul Roberts has been transferred to the Diocese of Colorado, and his place at the Cathedral has been most satisfactorily filled by the Rev. Frank Rhea, who comes to us from the Diocese of Texas. I cannot permit this moment to pass without expressing my own deep satisfaction at the way in which Dean Rhea has taken hold of the local situation. As a pastor and preacher, as chaplain of St. Margaret's and St. Luke's Hospital, he has already endeared himself to the whole community. There has never been a time when the work in Boise was in a more flourishing condition, nor under more constructive and consecrated leadership.

The Rev. Mr. Ingham, who served so faithfully at Blackfoot, was transferred last September to the Diocese of Oregon. In March of this year he passed into the Paradise of God after a short illness contracted during a missionary journey through inclement weather. He gave his life in the service of his Master. I am very sure that the end of his earthly life was just exactly as he would have had it. The new parish hall at Blackfoot, which was built under Mr. Ingham and as a result of his faithful leadership, has been called by his name. For years to come "Ingham House" will stand in that city as a living memorial to one whom we all loved. At the proper time I shall appoint a committee to prepare a suitable resolution to be adopted by this house and sent to his sorrowing family.



Archdeacon Stoy, who has served so long and well as Archdeacon of Southern Idaho, has transferred his headquarters from Pocatello to Boise. He did this at my request, as I desired to have him nearer to me, where I could avail myself more often of his advice and counsel in matters pertaining to our common enterprise. He has taken active charge of Grace Sunday School, Boise, Mountain Home and Caldwell, in which latter place he is assisted by a lay reader from the Cathedral, Mr. Ernest Williams. The Rev. Mr. Wood has been transferred from Caldwell to Twin Falls, succeeding Mr. Ward. The Rev. Mr. Stringfellow has recovered his health sufficiently to take on active work again, and is in residence at Pocatello, looking after the missions adjacent to that city, which were formerly under the active care of Archdeacon Stoy. Mr. Gunn has been transferred from Nampa to Rupert and Burley. The Rev. L. A. Cook has been transferred from Kellogg and Wallace to Nampa. The Rev. Mr. d'Easum has been transferred from Coeur d'Alene to Blackfoot and Idaho Falls and Archdeacon Nash has gone in residence at Coeur d'Alene, retaining charge of the northern mission field. From this you will see how we have economized to meet our reduced appropriations from the National Council. Mr. Nash is doing the work formerly done by himself and Mr. d'Easum. Mr. d'Easum is doing the work formerly done by Mr. Dumville and Mr. Ingham. Glenns Ferry has been added to Mr. Simmons' field, so that he at Glenns Ferry and Archdeacon Stoy are doing the work formerly done by Mr. Newman. The Archdeacon and a lay reader are doing the work formerly done by Mr. Wood at Caldwell, who is now at Twin Falls. In this way we are saving the salaries of several men, and I herewith express my deep appreciation of the willingness of our missionaries to take on additional work in order that in the face of reduced appropriations the work shall not decline. Other economies are being effected in our institutional work. St. Margaret's Hall is operating on a decreased appropriation each year, and we have surrendered all help from the National Council so far as St. Luke's Hospital is concerned. In addition to this we are developing greater self-support in many of the mission stations, thus preparing the way for the time when our work shall be self-sustaining.

The one point about which I am greatly concerned is Salmon. Here we have a fine group of loyal Church people, but the isolation of this point is such that it cannot be combined with any other mission point. The only solution of the problem that I see is a resident minister there, but where his salary is to come from I do not know. It may be that the solution lies in our taking over Salmon as a District Mission Field, supplementing the salary of the priest in charge from the district missionary funds handled by Mr. Ashworth. This would be in line with the policies laid down by the Committee on Evaluation of the Mission Work of the Church, appointed by the New Orleans General Convention in 1925, which stipulates that work in points which show no promise of self-support should be maintained as missions of the Diocese rather than of the General Church. I trust that the Secretary of Convocation will include this matter in the agenda of Convocation and that you will discuss it fully and reach some decision in regard to this as a matter of District Policy.

We come to the whole question of self-support and of our relation as a Missionary District to the General Church. When I came to Idaho as your Bishop, the appropriation of the General Church to Idaho was, in round numbers, \$62,000.00. For the present year it is \$44,000.00. This means that during the past three and a half years we have absorbed a reduction of \$18,000.00 a year. This has been done, as I have indicated above, in three ways: first by re-allocation of fields, giving to each man a wider territory and more mission points from which to draw his living. This effects a double saving. It makes it possible for fewer men to do the same work, thereby making it necessary to supplement fewer salaries,



and the supplement from my office is less for each man involved, as he draws a larger portion of his salary from the field he serves.

The second way in which we have effected this saving of \$18,000.00 a year has been in asking and receiving more toward missionaries' salaries from the mission stations. The third way has been in the increase of income and decrease of expenditures in our institutions. There is yet a fourth way we have not tried as yet—that which I have suggested in regard to Salmon. It is quite possible for us to develop our missionary giving to the point where we can pay our apportionment to the General Church and yet have between five and ten thousand dollars available for our own district needs. It is my own feeling, however, that except in the possible case of Salmon we are not quite ready for anything of this kind, as we shall have to use our surplus missionary giving over and above what is required for payment to the National Church, for such local developments as the Church work at Moscow for some years to come.

I am convinced that we can hold our present appropriation of \$44,000 from the National Council for this triennium. What lies beyond that I cannot even guess. That it will never be more is certain. That it will be less and less as years go by is highly probable, and personally I think also highly desirable. We are never going to lead our people to a more generous support of their own work so long as they feel that the National Church stands in back of them to make up whatever deficits accrue. There are certain points in Idaho which will never be self-supporting, but there are certain others which ought to be looking forward to self-support in the near future. And not only self-support, but self-support plus sufficient missionary giving to enable us to carry our weaker points with a minimum of help from outside—ultimately with no such help at all. It is my opinion that Idaho is perfectly capable of becoming self-supporting within five or six years at the outside. Kellogg and Wallace and Moscow and Lewiston, Nampa and Boise, Twin Falls and Pocatello are all capable of being built up into self-supporting parishes, paying their fair missionary quotas. In addition to this the missionary fields of Coeur d'Alene and surrounding territory, Payette and Weiser, Blackfoot and Idaho Falls, Emmett and Caldwell, are all capable of supporting a minister without outside assistance. This would leave a few rural communities such as Mr. Simmons' field, Mr. Opie's field, Mr. Gunn's field, St. Anthony, Mackay and Salmon, which could be self-supporting in part, with salaries supplemented from the missionary giving of the stronger points mentioned above. The Indian work at Fort Hall will and of a right ought to be always a National responsibility. St. Luke's Hospital is already self-supporting and St. Margaret's school will ultimately have to become so or else go out of business, for I have been given to understand again and again that the National Church does not intend to carry on these private schools in the mission fields in our own country indefinitely. There are fields in the world which are utterly Christless, and into which our Church ought to go. One of these I think is India. There is a vast section of India from which the English Church is going to have to withdraw for lack of funds. They have issued a call to their sister Church in America to come over and help. We have so far declined to go for lack of missionary money. Growing states like these in our western country are calling and calling for the Church's missionary funds, and thereby making it impossible for the National Church to go into parts of the world which are utterly Christless with the healing message of the gospel. And it is not that we are too poor. We can ride in the newest of cars; we support our schools and lodges unending, our luncheon clubs, chambers of commerce, and a multitude of kindred interests. It is not fair, and it is not altogether true when we say we cannot support the Church. The simple truth is that our people do not want the Church badly enough to pay for it, and it is our task as Church leaders to make them want it. Ultimately the people of Idaho, and I think the same is



true of most of these western states, will have to pay for their Church or lose it. There is no other alternative, for the Church at large is not going to carry us as missionary liabilities indefinitely. I say this again and again, and we have made and are making progress. I say it again and again, and shall continue to say it until it has burned itself into the consciousness of our people; until they realize their obligation to God—and themselves.

I shall say but little of the work of our various institutions, as you are already familiar with them, and moreover those in charge of them spoke for themselves at the Missionary meeting Sunday night. Suffice it to say that the School at Fort Hall, under the devoted leadership of Miss Larery, St. Margaret's under the leadership of Mrs. Stratte and the careful business management of Mrs. Cole, who is also my most efficient helper in business matters pertaining to the work of the District, and without whom I could not possibly proceed; St. Luke's Hospital, under the very finest superintendent it has ever been my lot to know, Miss Emily Pine; suffice it to say that all these enterprises are doing well. I am sure that no bishop in the world is more blessed than I with loyal and efficient helpers. This is true of every man and woman in any way officially connected with our work in Idaho. I am in the fortunate position of being able to delegate a task to anyone in Idaho and then to forget it, knowing that it will be done and done well. It is largely to this fine spirit of loyal cooperation that we owe the progress we have made during the past few years.

I would say one special word of thankfulness for the new St. Luke's. It is finished and operating. We are now engaged in overhauling the old buildings. When this is finished we will have a hospital with a capacity of 110 beds. If there is anything finer than our new building in the whole country, I have not seen it. It has, however, cost far more than we anticipated, and this has affected us in another way, of which I now come to speak.

At the opening of this address, I dwelt somewhat on the difference between a failure and a disappointment. I now come to a disappointment in the matter of the proposed new buildings for church work among the students at the State University. In many ways I believe this to be the most important piece of work in the State, for out of this university are coming those young men and women who will be our leaders tomorrow. In large measure the church of tomorrow will be just what those boys and girls make of it, and we have the chance to shape their souls for good and for God today. It would be impossible to over-estimate the value of the work we are trying to do in Moscow.

It was because of this that we undertook last year to raise a sum of money sufficient to provide new buildings at this point. Upon the recommendation of the local committee we had previously purchased a large lot on a very desirable street, upon which we had paid the sum of two thousand dollars. Subsequently we had purchased other lots, partly for the erection of a parish house and partly as an investment. Upon these lots we have paid \$1,275.00. It was my hope that in the state-wide campaign we conducted last year, we could secure at least thirty or forty thousand dollars in cash and pledges. To this I expected to add a like amount which I would raise outside the State. This would have given us seventy-five or eighty thousand dollars, which would have been ample for all our needs.

The campaign was conducted without costing the Church in Idaho a single cent. The expenses of this effort were entirely paid by friends of mine outside the State, who chose this method of making their contribution to our work. Every cent which has been paid into our office for the work in Moscow, both from the funds of the District Missionary Treasurer and as a result of the canvass we conducted last spring, has either been spent on real estate in Moscow or is on hand in the local bank today.



A complete financial statement has been multigraphed and is ready for distribution at this Convocation. Briefly, the results are as follows:

Of the unpaid pledges, we shall probably collect about twenty-five or twenty-six hundred dollars. This, with cash on hand, gives us just about five thousand dollars upon which we can count for future development. There are a few points where a canvass has not been held. None has been held in Boise because the local people are still paying their pledges to St. Luke's Hospital, and we thought it unwise to ask them for another contribution until this latter matter was entirely out of the way. No canvass has been made in Kellogg or Wallace, as the canvasser was called back east before the work was quite finished. And there are a few smaller points as yet unreached. No canvass has been held in Moscow. It was thought wise to hold that point back until we could see what the rest of the State would do. Inasmuch as this building project was for them a local project as well, it was contemplated that their response would be particularly generous, and it was also contemplated that our present Church property there would be sold, adding a considerable sum to what the people themselves could give. Possibly, by spreading payments out over a term of years, we could secure seven or eight thousand dollars for our property there, and probably the people of the town could give another five thousand dollars. This, coupled with Boise, Kellogg and Wallace and the smaller points as yet untouched, would give us a possible outside expectancy of around \$24,000 or \$25,000. And for the realization of this sum we would have to wait two years at least. It would take that long to make the remaining canvasses, collect deferred pledges and make satisfactory sale of property. And \$25,000 would only half build the Church we need, to say nothing of parish house and rectory. These figures constitute our first disappointment in the matter of Moscow.

The second disappointment is in regard to the money I expected to secure outside the State, and here is where the new St. Luke's Hospital cuts across our plans. When we began St. Luke's, we contemplated spending a quarter of a million dollars, and I knew pretty well where that sum was coming from. As a matter of fact, to date we have raised about fourteen thousand dollars in excess of that quarter of a million, so that if we had been able to keep St. Luke's within our original estimate it would today be entirely paid for, and I would have fourteen thousand dollars on hand which I could devote to Moscow, and in addition some thirty-five or forty thousand dollars which I shall secure in the near future. But, alas, the hospital cost us seventy-five thousand dollars in excess of our original estimate of a quarter of a million, so that I shall have to devote not only the excess fourteen thousand dollars already secured, but also the other amounts now in immediate prospect to the payment of hospital notes, which are now falling due with embarrassing regularity. It is now requiring all the money I can secure to finish paying for the hospital, and this is the very money I was counting on for the buildings at the University. It will probably be two years at least before I can clear the hospital matter away, and until that is done, there is no chance for me to put any considerable sum into the University project.



Now it remains for you gentlemen of this convention to say what shall be done. I want to keep faith with those subscribers who have, as a result of our canvass, given the sum of \$3,149.55. Undoubtedly they gave with the understanding that we would push this project to immediate completion, but of course it is evident that the very smallness of this sum makes such a course impossible. My own belief is that those who gave will understand our difficulty, and that they would be willing to have us use their gifts along with what we can have from the District Treasurer and what I can secure in small amounts in the near future, for the securing of some additional land which will be needed when we push this project to completion, and the finishing of payments on land already purchased. I am satisfied that with the resources on hand and soon to be available, we can at least secure and hold the necessary desirable property adjacent to the University. This will entrench us on the site and insure the ultimate construction of the buildings. The other alternative is to return the gifts to those who have made them, to sell all the property we have purchased near the University, to wash our hands of the whole affair, and leave things as they are. If we do this, we will at least have had a valuable experience and come out with money in the bank which we can use for something else.

I hope for a full discussion of this problem, and I shall be guided by your decision in the matter.

On July 15 last, I advanced the Rev. Victor Newman and the Rev. James Opie from the diaconate to the priesthood in St. Michael's Cathedral. Since last Convocation I have confirmed two hundred and ninety-three persons. This is more than we have been averaging, but this is no cause for elation, as the council met in January in 1928, and we have had two series of spring confirmations since that time. I cannot urge too strongly the fallacy of relying upon one confirmation service a year for the garnering in of candidates. In these migratory days there are bound to be extensive losses under this arrangement. Confirmations need not necessarily be on Sunday, and while I have a limited number of Sundays available during the year, there come many weeks when I am at home between Sundays, and when I would be glad to go anywhere to confirm even one person. By the use of the open confirmation class method outlined in the booklet recently sent the clergy, which is the method most highly recommended by the National Commission of Evangelism, by use of the new Office of Instruction which appears in the revised prayer book, persons may be in process of coming to confirmation at any time of the year. Our present system makes extraordinary demands on the Bishop's time during the late spring, and leaves large parts of the year unused so far as confirmation is concerned. The nationwide campaign and the necessity of going after many gifts for St. Luke's Hospital have taken me out of Idaho for the fall period in years past, but these things will make fewer demands upon my time in the future, and I recommend that wherever possible classes for confirmation be prepared this coming fall.

Again I urge upon you the importance of your cooperation in making the summer school at Coeur d'Alene a success. On July 16 our fourth session will begin. Each year has marked an increase in interest and attendance. I hope this year will see all records broken. I request that immediately upon returning to your homes you begin to arouse the interest of your people in this worth-while enterprise. Any information desired may be had by addressing the Rev. Mr. Mitchell, who is again in charge.

With thankfulness to God for His many blessings upon us and our work during the past year, and with faith that His abounding mercies will continue ours forever, I wish you all Godspeed in the work of this convention and in the work in your respective fields in the coming year.

## REPORT OF EDUCATIONAL SECRETARY, MRS. R. S. BUTTERFIELD

April 29, 1929.

*To the President and Members of the Woman's Auxiliary of Idaho:*

I am pleased to give you my report of work as Educational Secretary, covering the period since last Convocation, February 1, 1928, to April 29, 1929.

I have written two general letters to thirty-two Guilds, urging study programs and suggesting the use of the textbook, "The New Africa," by Donald Fraser, as recommended by the National Council. In addition to these I have written numerous other letters relative to the work. I have sent out one copy of "The Church Awake," four copies of "The New Africa," five scrap books, and a number of miscellaneous pamphlets.

The response to my last general letter has been very good and is most encouraging. I hope all of the Guilds which are at present interested in program work of any nature will continue the work, and that more of the Guilds will take it up next year.

The Treasurer of the Idaho organization sent me \$10.00 for expenses. In addition to this I have received \$3.35 from Guilds for textbooks and



other literature, making total receipts of \$13.35. I have expended this money as follows:
