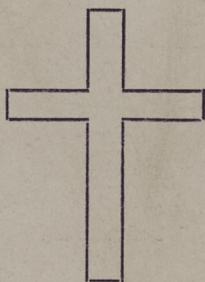

Twenty-second Annual Convocation
OF THE
Protestant Episcopal Church
IN THE
Missionary District of Idaho

On Sunday, May 4, 1930, being the second Sunday after Easter, the Twenty-second Annual Convocation of the Missionary District of Idaho convened in St. Michael's Cathedral, Boise. The District Corporate Communion was celebrated at 11:15 o'clock in the morning, by the Bishop of the District, the Rt. Rev. Middleton Stuart Barnwell, D.D. The Venerable M. B. Nash read the Epistle, and the Venerable Howard Stoy read the Gospel. Bishop Barnwell delivered his annual Convocation Address in lieu of a sermon. (*Appendix I.*)

Evening Prayer was read in St. Michael's Cathedral at 8:00 P. M., the Rev. B. C. d'Easum taking the service, and Mr. Ernest Williams reading the Lessons. The Rev. E. R. Allman preached the sermon.

MONDAY, MAY 5

At 8:00 o'clock Monday morning there was a Celebration of the Holy Communion in the Cathedral, at which the Rev. H. H. Mitchell was the Celebrant, assisted by Dean Rhea. This service was designated as the Corporate Communion of the Woman's Auxiliary of the District.

Convocation convened at 9:45 A. M. in the Chapel of St. Michael's Cathedral and proceeded to organize under the presidency of the Bishop of Idaho, who offered the opening prayers.

The Bishop appointed the Rev. H. H. Mitchell and Mr. R. S. Butterfield as a Committee on Credentials.

The roll call of the Clergy canonically connected with the District was ordered by the Chair. The following answered to their names:

There being a quorum, the Chair declared the Convocation duly organized.

Nomination was made of the Very Rev. Frank A. Rhea for Secretary of Convocation, and it was moved and seconded that the unanimous ballot of Convocation be cast for his election. This motion was carried, and the Chair declared the Very Rev. Frank A. Rhea duly elected.

Mr. Rolston S. Butterfield was nominated for Treasurer of the District, and it was moved and seconded that the Secretary be instructed to cast one ballot for his election. The motion prevailed, the Secretary reported that he had cast the ballot, and the Chair declared Mr. Butterfield duly elected.

Mr. Walter Ashton, of Boise, was nominated for the office of District Auditor, and upon motion was unanimously elected.

The Chair then appointed the following committees:

State of the Church—The Rural Deans of the five Deaneries.

The Bishop appointed the Ven. Howard Stoy to be Rural Dean of the Boise Deanery, the Ven. M. B. Nash to be Rural Dean of the Coeur d'Alene Deanery, the Rev. H. H. Mitchell to be Rural Dean of the Lewiston Deanery, the Rev. B. C. d'Easum to be Rural Dean of the Pocatello Deanery, and the Rev. Ernest R. Allman to be Rural Dean of the Twin Falls Deanery.

Committee on Unfinished Business—The Rev. Ernest R. Allman and the Rev. Victor E. Newman.

Committee on Canons—The Rev. H. H. Mitchell and the Rev. Joseph W. Gunn.

Committee on Resolutions—The Rev. Victor E. Newman and Mr. Ernest H. Williams.

Committee on Necrology—The Rev. B. C. d'Easum and the Rev. James Opie.

Council of Advice—The Very Rev. Frank A. Rhea, the Ven. Howard Stoy, the Rev. I. Q. Wood, Mr. R. M. Davidson, Mr. T. A. Purton, and Mr. William N. Northrop.

Trial Court—The Very Rev. Frank A. Rhea, the Ven. Howard Stoy, and the Rev. L. A. Cook.

Examining Chaplains—The Very Rev. Frank A. Rhea, the Ven. Howard Stoy, and the Rev. H. H. Mitchell.

On motion, the nomination and election of Chancellor was postponed. The Committee on Unfinished Business reported that they found no item to present.

A motion was made and duly carried that a special committee on finance and quotas be appointed and their report be made the special order of business at 2:00 o'clock this day.

DELEGATES TO THE SYNOD OF THE PACIFIC

The Chair stated that nominations were in order for three clerical and three lay delegates to the Synod of the Pacific, meeting in San Francisco May 7-8-9, 1930.

The following clerical delegates were nominated and unanimously elected: The Very Rev. Frank A. Rhea, the Rev. L. A. Cook, and the Rev. B. C. d'Easum.

The following lay delegates were nominated and unanimously elected: Mr. R. S. Butterfield, of Moscow; Mr. R. M. Davidson, of Boise; and Mr. William N. Northrop, of Boise.

No alternates in either order were elected.

BISHOP AND COUNCIL

The Bishop appointed as members of the Bishop and Council the Very Rev. Frank A. Rhea, the Ven. Howard Stoy, the Rev. H. H. Mitchell, Mr. R. M. Davidson, Mr. T. A. Purton, and Mr. R. S. Butterfield.

The following were elected upon nomination by Convocation: The Rev. E. R. Allman, the Rev. B. C. d'Easum, and the Rev. L. A. Cook; Mr. F. H. Wheeler, of Lewiston; Mr. Walter Ashton, of Boise; and Mr. H. B. Goldsmith, of Idaho Falls.

REPORTS

The report of the Council of Advice was read by the Very Rev. Frank A. Rhea, and was accepted and ordered filed.

The Department of Religious Education presented its report through the Rev. H. H. Mitchell. The report was received and ordered filed. Upon the basis of a recommendation incorporated in this report, it was moved by the Rev. Mr. Gunn, and seconded by the Rev. Mr. Newman, that it is the mind of this Convocation that a Church School worker for the District should be secured.

A substitute motion, presented by the Very Rev. Frank A. Rhea, seconded by Mr. R. S. Butterfield, that this matter be referred to the Finance Committee, was lost, and the original motion prevailed.

It was then moved by Mr. R. S. Butterfield, seconded by the Rev. Mr. Gunn, that the matter be referred jointly to the Finance Committee and the Department of Religious Education to suggest ways and means of financing this work. The motion was carried.

The Department of Publicity presented its report through the Rev. H. H. Mitchell. The report was received and ordered filed.

The report of the District Treasurer, Mr. R. S. Butterfield, was presented. This report embodied a recommendation that the basis of assessment for the District Budget be increased from five to six per centum. Upon motion, this matter was referred to the special finance committee.

Upon motion by the Rev. Mr. Mitchell, seconded by Mr. Ernest H. Williams, the report of the District Treasurer was received and ordered printed in *The Journal* (Appendix II), and a hearty vote of thanks was accorded Mr. Butterfield for the valuable service he continues to render the District.

It was moved by the Rev. Mr. Gunn, seconded by the Rev. Mr. Newman, that the parishes and missions of the District be instructed to remit,

and the District Treasurer be authorized to receive, the offerings as stated on the back of *The Journal*. This motion was carried.

It was moved by the Rev. Mr. Mitchell, seconded by the Rev. Mr. Cook, that the Fort Hall Indian Mission Offering be changed from that of Christmas Day to that of Ash Wednesday.

A substitute motion, presented by Mr. W. N. Northrop, and seconded by Mr. Frank Kinyon, that this matter be referred to the special finance committee, prevailed, and the original motion was declared by the Chair to be lost. The matter was so referred.

The report of the Church School Lenten Offering for 1930 was received and ordered printed in *The Journal* (Appendix II).

The report of the Moscow Building Fund was presented and ordered printed in *The Journal* (Appendix II).

The report of the Examining Chaplains was presented by the Very Rev. Frank A. Rhea, and ordered filed.

The Ven. Howard Stoy presented his report as Archdeacon of the south.

The hour of noon having arrived, the Convocation adjourned to the Cathedral, where the Woman's Auxiliary was in session, and prayers for missions of the Church were offered by Bishop Barnwell.

Convocation adjourned until 2:00 P. M.

Afternoon Session

Bishop Barnwell, being detained at home by unavoidable circumstances, appointed the Rev. H. H. Mitchell to take his place in the chair. The Rev. Mr. Mitchell assumed the chair and led the opening devotions.

By unanimous consent of Convocation, time was given to receive the report of St. Luke's Hospital and Nurses' Training School, which was presented by Miss Emily Pine, Superintendent.

It was moved by the Rev. Mr. Newman, and seconded by the Rev. Mr. Cook, that this report be received, ordered filed, and that a rising vote of thanks be extended to Miss Pine for her inestimable services to St. Luke's and the District. This motion was unanimously carried.

The Convocation then proceeded to a consideration of the special order of business, which was the report of the special committee on finance. This report was presented by the Very Rev. Frank A. Rhea, and contained three recommendations, which were acted upon *seriatim*:

- (1) That the following budget be adopted for the year 1930:

Upon motion this recommendation was adopted.

- (2) That the recommendation of the District Treasurer, viz., that the basis of the District Assessment be increased from five to six per centum of the current expense item of each parish and mission.

Upon motion this was adopted.

- (3) That the date of the stated offering for the Fort Hall Indian Mission be changed from Christmas Day to Whitsunday.

Upon motion this was adopted.

It was moved by Mr. R. S. Butterfield, and seconded by the Rev. Mr. Gunn, that whereas it appears that in some instances the quotas on the

Field Department Budget appear to be excessive, that proper adjustment in such cases shall be made by the Bishop and Council. Motion carried.

The report of the General Church and District Fund for 1929 was presented and ordered printed in *The Journal*. (Appendix II.)

The report of the General Church and District Fund up to May 4, 1930, was presented and ordered printed in *The Idaho Churchman*.

The report of the Committee on the State of the Church was presented by the Ven. Howard Stoy, and ordered received and filed.

On motion, it was determined to include in the report of the Committee on Necrology only those who have been active in the affairs of the District.

The report of the Committee on Necrology was presented by the Rev. Mr. d'Easum. On motion, this report was received by a rising vote, and the Chair offered fitting devotions to Almighty God.

The report of St. Margaret's Hall was presented by Mrs. Mary Scarp Stratte, Principal. On motion by the Rev. Mr. Gunn, seconded by the Rev. Mr. Cook, this report was received, and a hearty vote of thanks was extended to Mrs. Stratte for her tireless efforts in behalf of St. Margaret's.

Bishop Barnwell returned and assumed the chair.

Upon nomination, Mr. J. L. Eberle, of Boise, was unanimously elected Treasurer for the funds of the General Church and District Program.

Upon nomination by the Chair, the Rev. Joseph W. Gunn was unanimously elected Registrar and Historiographer.

It was moved by the Rev. Mr. Mitchell, and seconded by the Rev. Mr. Newman, that the item for \$600.00 for the Salmon salary account be changed to read: "For the Advance Work Program of the General Church." The Bishop stated his willingness to transfer the Salmon salary item to his salary account, and the motion was carried.

Mrs. R. S. Stringfellow presented a verbal report for Fort Hall Indian Mission.

The report of the Ven. M. B. Nash, Archdeacon of the North, was presented and ordered received and filed.

A verbal report was presented by the Rev. I. Q. Wood, delegate to the Synod of the Pacific, 1929.

The Committee on Canons reported that no business had been referred to it.

The Committee on Resolutions reported as follows:

The Convocation desires to express its deep feeling of sympathy to the Rev. W. R. R. Simmons in his illness, and prays for his speedy restoration to health and strength. We regret that he cannot be with us as usual.

The Twenty-second Annual Convocation of the District of Idaho, assembled in St. Michael's Cathedral, Boise, May 5, 1930, extends to the Rev. Thomas Ashworth its deep appreciation for his many years of faithful service as devoted priest and most efficient Secretary of the District, and Treasurer of the General Church and District Funds, as well as his many other activities.

Keenly aware of the loss sustained in his removal by all who have known him, we pray for his continued success and happiness in his new field of labors.

It is with a feeling of deepest sorrow that your Convocation regards the untimely death of the Reverend D. J. W. Somerville, of revered and loving memory, who for many years was an active member of our Convocation, and was held in the highest esteem by all who were privileged to enjoy his gracious fellowship. In his call from this earth, the Church has suffered a grievous loss, not only in that which he contributed in loyal service, but also in the example of a pious and devoted life, and we bless the name of our Heavenly Father for this devoted servant departed this life in His faith and fear, and pray that he may continue in His love and service in that Heavenly Kingdom with those who from their labors rest.

RESOLVED, That a hearty vote of thanks be extended to the Cathedral Parish, to St. Margaret's Hall, and to St. Luke's Hospital for the generous hospitality given the delegates to this Convocation.

Upon motion, this report was unanimously adopted, and the resolution touching the death of the Rev. Mr. Somerville was adopted by a rising vote, after which the Chair offered appropriate devotions.

Upon motion the place of the Convocation for the year 1931 was determined as St. Michael's Cathedral, Boise, and the date was left to the call of the Bishop.

Upon motion by the Rev. Mr. Newman, seconded by Mr. Northrop, Convocation, by a rising vote, extended to Bishop Barnwell and Mrs. Barnwell their affectionate greetings and best wishes as they begin their journey to England in attendance upon the Lambeth Conference.

Convocation adjourned at 4:30 P. M., *sine die*.

RECEPTION AT ST. MARGARET'S HALL

The inclemency of the weather prevented the presentation of the May Fete at St. Margaret's. In its place, on Sunday evening, a reception and art exhibit was most thoroughly enjoyed by the delegates and visitors to Convocation. The excellency of the instruction in the art department was amply illustrated by the display of work done by the girls. A delightful tea was served by the members of the department of domestic science.

ST. LUKE'S GRADUATION

The concluding event on the Convocation program was the graduation of St. Luke's Hospital and Nurses' Training School, held in St. Michael's Cathedral Monday night, May 5, at 8 o'clock.

The Rev. I. Q. Wood read Evening Prayer, and Bishop Barnwell delivered the graduation address. He also delivered the diplomas to five young women who composed the graduating class.

Later, a reception in honor of the graduates was held in the Bishop Tuttle House, when a large number of friends felicitated the graduates and enjoyed the festivities of the occasion.

In Memoriam

THE REV. DAVID JAMES WATSON SOMERVILLE

"On December 28, 1929, the Rev. David James Watson Somerville passed from this life into the Paradise of God. Mr. Somerville was born in Ireland in 1869. Educated at Queens College and the Royal University of Ireland, he came to this country and graduated from Seabury Divinity School in 1895. He was ordained deacon the same year, priest a year later. Coming to Idaho in 1904, he served the Church of the Nativity as rector for more than twenty-five years. He was a faithful priest and a friend to all with whom he came in contact. He was as well known in the county poor farm as he was in the homes of his own parishioners. Prominent in civic affairs, as well as in his Church, there was no better known or loved citizen in all north Idaho. We do miss and shall ever miss this our brother in Christ. His faithfulness and devotion will ever be an example to us all."—*From Bishop Barnwell's Convocation Address.*

BISHOP'S ADDRESS

TWENTY-SECOND ANNUAL CONVOCATION, MISSIONARY DISTRICT OF IDAHO

St. Michael's Cathedral, May 4, 1930

My Brethren;

We come to the end of another Council year with gratitude to God for His many mercies. The year has been marked by no unusual achievement anywhere in the District, so far as I know, but it has been characterized the steady maintenance of interest and work in our various parishes and missions. Again I must regret that much of my time has been spent out of Idaho. Last fall I was compelled to make a trip East in the interest of St. Luke's Hospital, a considerable amount of which yet remains to be paid for, and during January and February I was at work on a special committee for the National Council in and around New York, securing additional funds for the national budget for the year 1930, so that the work would not have to be cut once more. In this effort we were entirely successful, and it has worked to the great advantage of the missionary enterprise all over the world. Coming home to begin spring visitations, I was cut down by illness and spent the whole of Lent undergoing and recovering from an operation. The net result of all this has been that I have been compelled to defer some official visitations until fall. This could not be helped and the clergy have been very considerate in fitting their own plans to the existing conditions. I am hopeful that another year will see St. Luke's completely financed and remove from my shoulders what has been a very heavy burden.

During the past year there have been some clerical changes. The Rev. Thomas Ashworth, after many years of faithful service, went to Butte, Montana. The Rev. A. S. Kean, who had been in charge of Pocatello, went to Nevada. The Rev. D. J. W. Somerville died as the result of a tragic accident last December. Mr. Ashworth is being succeeded by the Rev. Ernest Taylor, who graduates from the Virginia Seminary next month. Mr. Kean was succeeded by the Rev. Mr. Wood, whose place at Twin Falls was filled by the Rev. Ernest Allman, from the Missionary District of Spokane. So far no one has been called to Lewiston. The service there have, however, been regularly maintained by the Seniors Warden, Mr. F. H. Wheeler, who has been licensed as a lay reader. Mr. Wheeler, assisted by other members of the vestry, has also cared for the missions of Orofino and Grangeville. The Rev. Mr. Gunn, after many years of faithful service, has resigned as of May 1. He has reached his seventieth year, and has spent his life in the service of the Church, largely in the mission fields. He has been a devoted priest and pastor. We are happy in the thought that he will make his home in Nampa, where he served for so long. We pray that he may be spared to us for many years to come, to enjoy that peace and rest which he has so well earned. No provision has been made as yet for filling his place at Rupert and Burley.

Archdeacon Stoy and the Rev. Mr. Stringfellow have exchanged residences, the Archdeacon coming to Boise and Mr. Stringfellow going to Pocatello. From Pocatello Mr. Stringfellow now is serving the outlying missions in the eastern part of the State. He ranges all the way from Salmon down to Lava Hot Springs, and has, I suppose, one of the large parishes in the United States. The Archdeacon continues to be the tower of strength he has always been. While Mr. Stringfellow is taking services at Fort Hall, where he presented a class of thirty-two last Sunday, the Archdeacon continues to act as official adviser to the Bishop and Miss Larery. His parish at present ranges from Fort Hall to Weiser, a distance

of 350 miles. The Rev. Mr. Opie has moved from Shoshone to Glenns Ferry. He serves Glenns Ferry and the Wood River country up as far as Ketchum. Shoshone has been put under the care of Mr. Allman, who drives over from Twin Falls Sunday evenings. Mr. Allman has also reopened the work at Jerome, which has been dormant for many years. The other men continue as heretofore. Mr. Newman is developing the work at Kellogg and Wallace along very satisfactory lines. Archdeacon Nash continues to serve his vast parish, which reaches from St. Maries on the south to Bonners Ferry up near the Canadian line. Mr. Mitchell continues at Moscow, Dean Rhea, Mr. Ashton, Mr. Cook and Mr. d'Easum continue their work without change. But for the vacancies at Lewiston and Rupert, I believe the work to be in better shape at all points than it has been for a long time. We hope to have these vacancies filled by the time fall work begins.

Slow progress is being made toward the realization of our hopes for the development of the student work at Moscow. Five lots near the University have been bought and paid for. We also have a fine piece of property in the midst of fraternity houses on a very desirable street. Your committee has not yet determined just what is the best thing to do with the money available. We have about \$3,400 in this fund, which is at interest in the savings department of the Boise City National Bank. Statement of this account today is in the hands of the Secretary.

INSTITUTIONS

Fort Hall Indian School

Our work at Fort Hall continues on a satisfactory basis, so far as it goes. Miss Larery is daily proving herself a most capable successor to Miss Parsons, and she is ably assisted by Mrs. Creasey and Miss Williams. We do all that can be done for the children and the results with them are all that can be expected. The weakness of our work at this mission, so far as the Church's especial task is concerned, is that we are forced to turn the children over to the Government school just at the time when our efforts ought to begin to bear fruit. The Government school seems very well run, and the authorities there cooperate with us in every possible way, but I feel that we would accomplish far more, so far as character building is concerned, if we could carry the girls on through the high school period. This, of course, is impossible with the limited equipment and means at our disposal, and we are leaving work among the adults largely untouched. Some work among these latter is being attempted elsewhere on the reservation by the Presbyterians, with what success I do not know, and the Roman Catholics are coming in at yet another point. There is no semblance of rivalry between these groups and ourselves, as there is more than enough for all of us to do. It is my hope that some time in the future the National Church will recognize its duty to the Indians more than it has done in the past, and enable all of us in the west who are working among them to do the work as it ought to be done.

St. Margaret's School

We are just closing what I believe has been the most successful year in the history of St. Margaret's School. I cannot say too much for the leadership and business management of Mrs. Stratte and Mrs. Cole, nor for the loyal and efficient work which has been done by the best staff of teachers we have ever had. There has been no semblance of any of those difficulties and problems which often arise in connection with girls' boarding schools, and the work done by the pupils has been of a high order. It is difficult to single out any one department for commendation when all are splendidly run, but in the departments of music and art results can not only be measured, but can be heard and seen. The glee club has been

notably successful in competition with other similar groups and the exhibit by the department of art at the school is well worth your attention. The needs of the school continue to be chiefly financial. While we are not running behind, but living well within our income, the fact remains that we could not maintain the school at all without the constant assistance of the National Council. What is needed is that more of our people throughout the State shall appreciate what a good school this is, and how much we can do for their children if they will give us a chance. To this end we must count on the continued loyalty and work of our clergy in their respective fields. A normal part of the work of every missionary in Idaho should be the constant presentation of the claims and advantages of St. Margaret's.

St. Luke's Hospital

A detailed report of the work at St. Luke's will be presented to the convention in the due course of business. Last fall the older portion of the building was thrown back into service after having been thoroughly repaired and renovated. This gives us a capacity of 110 beds—not all of which are available, however, due to the fact that we are compelled to use some of the hospital rooms for the accommodation of nurses. Naturally the nursing staff has been greatly increased. There are about 103 beds available for patients at the present time, and we are running about eighty per cent full all of the time. We are doing just about double the work we did before the new building was begun. The past few years have been difficult ones for all of us. Upon the Board of Trustees fell the burden of financing the new work. Upon Miss Pine and her splendid staff fell the burden of carrying on during building and repairing operations. But the work has gone on and the job is all but finished, and we now have a plant of which the Church may well be proud, and are doing as fine a piece of Christian hospitalization as I know of anywhere. Last year two thousand seven hundred and sixty-four patients passed through the hospital. Of these nearly one hundred were entirely free, and nearly twelve hundred were charged only part of their normal bill. And those remaining ones who paid in full for services received were served at a cost far less than is made in similar institutions located elsewhere. I do not know of any agency of any kind in Idaho which is rendering so large a service to the people of the State. And it ought to be a source of pride to us to realize that this great service is being rendered in the name of Christ and His Church. The Chapel continues to be the center of the hospital's life. Daily prayers are said there for the nurses as the night shift goes off duty and the day shift comes on, and the Dean as Chaplain is tireless in his visiting of the patients and in his development of the spiritual life of the girls in training. I had a chance this spring to see the work of St. Luke's from the inside, and all that I saw made me very glad.

Most of us think of a hospital as a place where sick people are made well. It is this, and if St. Luke's did no more than this it would be enough. But there is another side to it. It is not only a hospital, but a boarding school, where many splendid girls are trained and fitted for lives of service. These girls in training have come from all over southern Idaho, and when their training is done, for the most part they stay here in the Northwest and make their contribution to the health and happiness of us all. But not all stay in Idaho or the Northwest. Graduates of St. Luke's are at work all over the world. To read the record of our alumnae is thrilling. The following are a few of them:

Emma Van Dyne, helped establish a hospital in LaGrande.

Sally McCarter, first Superintendent of hospital in Gooding.

Lulu Hall, Superintendent of first hospital in Twin Falls.

Lilla Swift, now Superintendent of the Children's Hospital in Los Angeles.

Nathalie Waale, eighteen months overseas duty during the war.

Nettie Parkinson, twenty-two months overseas duty during the war.

Lulu Sweet, Philippine Islands in 1913; served in Shanghai; has been with Rockefeller Foundation in China since 1917.

Here is one with a position in a hospital in New York City.

Here is one doing missionary work in Africa.

And four of our own girls are back at St. Luke's on the faculty, doing graduate work and helping train the classes now.

These are but a few shining lights among many. Who can measure the good that comes from such work as this?

As I survey these three Church institutions in Idaho, I can truthfully say that I consider each of them as fine a work of its kind as there is in the entire Church.

And now we turn from these thriving, busy institutions to consider our missionary work in the smaller towns. Inevitably the contrast strikes us. No one knows this so well as the missionaries themselves, for day by day they are face to face with the lack of enthusiasm, and sometimes of loyalty, on the part of people upon whom we ought to be able to depend. In every mission station there is a handful of devoted church people. In every mission station there are many who ought to be helpful and loyal and whose interest we seem unable to arouse. In every town where we have work there are very, very many people who give no loyalty to any church; who seemingly are as pagan as the natives in the heart of Africa. Here is the discouragement of missionary endeavor, and here is its challenge.

The hardest work in the whole Church is in these small towns. Not hard so far as labor is concerned, for men are happiest when they are busiest. Work in these small towns is hard because it is discouraging. Because faithful people are forever moving away, and we are faced with the never-ending task of replacing them. It is a simple fact, of which I have long been convinced, and which now seems to be borne out by the present United States census, that the average small town in Idaho is growing very slowly, if at all. Some of them have even shown losses in population during the past ten years. Boise has been practically stationary. I think the same thing is true of practically every town in southern Idaho. One or two of the northern towns have shown gains, notably Coeur d'Alene, but some of them up there have fallen back. This is particularly true of the lumber towns. What does all of this mean? Simply this, I think: that we need be under no delusions about the future of the work in Idaho. It cannot well grow faster than the country itself. There will be no sudden booming into self-support on the part of many of our missions, for the people and the money are simply not there. There are, of course, towns where we ought to have self-supporting work and have not. There seems to be a wide disparity between what is done in the different places in the way of self-support, which disparity seems to have but little to do with the population of the town involved. Here is a town of one thousand people paying \$56.00 a month toward a minister's salary. Here is one with nine thousand paying \$25.00 a month. And here is one of seven thousand paying \$200.00 a month. And here is one of four thousand paying nothing in salary and \$5.00 a week traveling expense to the missionary who goes in every week. These are some of the contrasts. Of course, we do not judge the worth of a place by the amount of self-support which comes from a field, but we can judge of the interest of the people, for people support that in which they are interested. There are a few shining examples which I would like to hold before the district. Lewiston, with about seven thousand people, pays two hundred dollars a month toward a minister's salary. Moscow with less than four thousand pays \$125.00 a month. Hailey with less than a thousand pays

\$56.00 a month. Lest it be thought that this is a reflection on the men at work in certain fields, I hasten to say that I do not believe it, for some of the best missionaries I have ever known are serving communities which pay almost nothing toward their salaries. I am free to confess—after studying this situation for five years—that I do not know the answer. I merely lay this problem before you and hope that some discussion will be had on the subject. There is not a man on the clergy staff in Idaho who is not doing splendid work. The cause has to be sought elsewhere.

But I would say one word to those at work in the difficult places: God does not judge us by results. He judges by the labor and love we put into the work. Again I say as I have often said to you personally, that we are not responsible for results. That is God's business. We are responsible for putting ourselves into God's work. With that our task begins and ends. I think of a little mission down in Alabama where the minister grew discouraged; of a little mission which was finally abandoned, and yet out of that little mission had come a young man who became John Gardner Murray, the first man to be elected Presiding Bishop of the Church. God will take care of results if we give to him the best we have.

I call your attention to the Lambeth Conference which meets in London this summer. I am sailing for England next week and will take part in this conference before returning home. The Lambeth Conference is a conference of all the Anglican Bishops from all over the world. It has no powers of legislation. It is a clearing house for the discussion of matters in which we are all interested, and it will doubtless attempt to define this Church's position on certain matters of universal interest. Such definitions will have no binding force in themselves. They will go back to the various national Churches with nothing in back of them except the judgment of the Bishops. By these national Churches they may or may not be made the subject of legislation. The chief object of this conference as I understand it is the forming of public opinion in the Church. Along this line it doubtless will have great influence.

Chief of the matters to come before us are:

1. The Christian Doctrine of God:
 - a. In relation to Modern Thought;
 - b. In relation to Non-Christian religions and ideals.
 - c. As determining the character of Christian Worship.
2. The Life and Witness of the Christian Community with reference to Marriage, Sex, Race, Education and Government, Peace and War.
3. The Unity of the Church; World Conference on Faith and Order; Schemes and Proposals of Union; Relations of Anglican Communion to Particular Churches.
4. The Anglican Communion; Its Ideal and Future.
5. The Ministry; supply of men for Holy Orders; the training of Clergy before and after Ordination; supplementary ministries; Deaconesses and Voluntary Clergy. (I am deeply interested in this last topic, as it may offer some help to us in Idaho so far as scattered and weak work is concerned.)
6. Youth and Its Vocation.

The procedure of the Conference will be about as follows. The first week will be devoted to the general presentation of these problems, and the selecting of committees to work over them. For three weeks these committees will be at work. The final week will be given up to hearing and acting on these reports.

You can readily see that we have a full program before us. There will be abundant need as ever for the guidance of the Spirit. What will come out of it God knoweth. The only thing I know about it is that there is great need for the Church to speak with wisdom and conviction concerning many of these most important matters. I ask your prayers for a safe journey and return on the part of those attending, and for the guidance of God as we settle to our task.

You may have gathered from the foregoing paragraph that I shall not be with you for summer school at Coeur d'Alene this year. How I shall miss you all you do not know! To me these days on Coeur d'Alene with our own people, gathered around the Altar in the morning and the campfire in the evening, united in one common purpose, have ever been the happiest time of the whole year. May I urge the clergy to take immediate steps to get out a large attendance, and the lay people to take advantage of these days of instruction, inspiration and fellowship. This summer gathering has meant so much to us already in Idaho in the way of coming to know each other better. There is in it the promise of a yet larger future usefulness. The efficient and cheerful Mr. Mitchell will be in charge, as usual, and I have asked Dean Rhea to function as Camp Chaplain. There is no reason why my absence should make any difference—except to me. And I shall be with you in spirit every day.

Tomorrow we go about the business of the Lord. There are several matters of importance coming before us. I ask your prayers that we may be guided aright, and that our labors may be to the Glory of God, and that through our love and our willingness to serve, He may build His Kingdom in the mountains and deserts, the fields and cities of Idaho.

REPORT OF DISTRICT TREASURER

MOSCOW, IDAHO, April 30, 1930.

BISHOP BARNWELL AND MEMBERS OF CONVOCATION,
Boise, Idaho.

Gentlemen:

I am pleased to present herewith my annual report as District Treasurer. The receipts total \$2,092.01 and the disbursements \$1,517.04, leaving a balance on hand of \$574.97.

In analyzing the receipts, we find the District assessments are \$1,210, which is not quite enough to take care of the District budget. In other words, for the past two years we have levied a five per cent assessment on the current expenses, whereas formerly we levied seven per cent; but I am of the opinion that we ought to levy not less than six per cent, so as to be always on the safe side. Among the items that will be larger this coming year in our budget is the assessment for the Province of the Pacific, which has been raised from \$125 to \$180.

On the itemized schedule which is shown below the recapitulation, I am pleased to call your attention to the splendid response in payments for the past year by the Parishes and Missions of the District; and I wish to take this opportunity to thank you one and all. My only recommendation is that the assessment be increased from five per cent to six per cent as a safety factor.

Bishop Barnwell closed the meeting with noonday prayer.

AFTERNOON SESSION

The afternoon session of the Woman's Auxiliary was called to order by the President at 2:00 P. M.

REPORT OF THE EDUCATIONAL SECRETARY

To the President and Members of the Woman's Auxiliary of Idaho:

I am pleased to give you my report of work as Educational Secretary, covering the period since last Convocation, held in May, 1929.

I have written two general letters to thirty-two Guilds, urging study programs and suggesting the use of the text books recommended by the National Council. In addition to these I have sent out one copy of "The New Africa," three copies of "Roads to the City of God," three copies of "The World Mission of Christianity," a number of miscellaneous pamphlets, and have written numerous letters relative to the work.

The response to my letters has been fairly good this year, but should be much better. I hope more of the Guilds will take up program work this coming year. The subject recommended for study this coming year is India. Miss Marston, the National Educational Secretary, writes me that two courses are available—one for those wishing to make a serious study of India and one for groups with less experience. For the latter the background book will be "India on the March," by A. H. Clark, and for the more thorough study, "India Looks to Her Future," by Oscar Buck. Either of these books can be procured for 60 cents a copy from your Diocesan Educational Secretary, or direct from The Book Store, 281 Fourth Avenue, New York.

Last May the Treasurer of the Idaho organization sent me \$15.00 for expenses. In addition to this I have received \$3.00 from Guilds for literature, making total receipts of \$18.00. I have expended this money as follows:

ADDRESS OF AUXILIARY PRESIDENT

To the Women of the Missionary District of Idaho:

For many days the thought of these few minutes that I am privileged to have to speak to many of the women of the District has been ever present in my mind.

It is a great pleasure to be with you, but it is a great responsibility to speak at the beginning of our meeting and to undertake to point out the essential problems of our work together. I have been longing with all my heart for the ability to put into words the keynote of all Auxiliary effort and to be able to convince you of the importance of your position in the life of the Church today. Much is depending on you.

Some of you come after many years of District meetings, eager for the advancement of work. Some may be here for the first time, and are probably feeling that there are many things with which they are unfamiliar. There will be reports from all of your officers covering the work for the year. If you could take each report separately and analyze it, you would find the underlying principles of them all the same: the love of God and each individual's responsibility to carry out the great commandment: "Thou shalt love the Lord thy God with all thy heart, and with all thy soul and with all thy strength." I ask you, as you listen today to these reports, to feel these two things as the basis of all that you hear.

A detailed report from your President would mean much repetition, and so I do not expect to give one, except to the convention which is now assembled.

Although the "Message" was sent out from New Orleans and has already been the background of much of our work, we need one and all to keep it ever present in our minds and use the objectives more than ever.

The Auxiliary is one channel through which we have the privilege of working for the establishment of Christ's Kingdom. If we can bring about a realization of this in every one of our Auxiliaries, and gain the feeling that the work is His, then the responsibility for it will become a tremendous happiness and privilege. Many officers write to me that they carry out the Program and that they do all that is asked of them in a financial way, but that they do not seem to get a sense of genuine spirituality into their work. Others say that all of their work is done by the same group of devoted women who never fail.

Study the report on Personal Evangelism which is in the minutes of the Washington Triennial, and use all of the suggestions. We need to awaken all of the women in our own organization to a deeper sense of their responsibility.

Every W.A. meeting should begin and close with prayer for the Church's mission and include some presentation of the work of the Church outside the parish.

Our Department work includes: United Thank Offering, Corporate Gift, Box Supply Work, Study.

U.T.O. is a channel through which may flow in money value an expression of the love and thankfulness of all the women of the Church. Our custom in Idaho is to present this Offering twice each year at a corporate Communion on Ascension Day and All Saints Day. You will remember that Miss Lindley told us how close this Offering brought us to our sisters in other lands. We send our gifts and prayers for those on the firing line in our places. The U.T.O. supports 194 in the field, of which 67 are employed in the United States, either in Missionary Districts or in Dioceses, and 125 in extra-continental domestic and foreign fields. Twenty-four retired workers are cared for from the U.T.O. Fund. Nine girls are in training.

Mrs. Rhea will tell of the Corporate Gift.

The Box Secretary includes with each list of articles to be sent in a story of the Mission to which our boxes are sent. This forms a subject for the afternoon's study hour. We can only be interested in places or people we know something about.

STUDY

This year's book on the Jerusalem Conference, when carefully studied, should have united us with the entire Christian world.

Our program should cover the Five Fields. Sometimes one feels floored by the wealth of suggestions for programs. "The Woman's Auxiliary in the Life of the Church" you will find most helpful. I would like to ask

each President to take home a copy, and also one of "The Church's Program." Under this heading I would like to stress the importance of our magazine, the oldest missionary magazine, *The Spirit of Missions*. Most Guilds see that it is in the town library.

I would like also to draw your attention to our Summer School, which will be held at Coeur d'Alene Lake July 15-25. Miss Mabel Cooper will conduct classes, and I hope, too, that classes can be arranged for the study of next year's book on India. India is Mr. d'Easum's birthplace, and I have asked him to talk to you this afternoon for a few minutes.

The editor of *The Idaho Churchman* will give us a page each month, provided items reach him before the 16th.

Your Secretary will read a letter I received from Miss Lindley a few days ago, which tells of the Advanced Work of the Church. Idaho is to help build a parish hall in Sweetwater, Texas, and a parish in the East will help St. Luke's Hospital in Boise.

This year I have visited several Guilds in southeastern Idaho. They are all doing splendid, loyal work. Distances in Idaho are great, even in motor cars.

The Presidents of the Boise and Pocatello Deaneries will tell about Miss Lindley's visits to those places. All who are privileged to hear her always get real inspiration from her deep and sincere spirituality. Miss Lindley's booklets, "Noonday Meditations," should be used in every Guild. Miss Lindley says:

"I came away from Washington feeling that there is almost nothing which the Woman's Auxiliary is not willing to undertake. We want our Lord to ask great things of us. I am tempted to believe that one of the greatest things He can ask is what may not appear so great, the quiet adding, almost one by one, of those women who do not yet share in the Church's work to the list of those who have learned to love the whole work of the whole Church."

Here is an opportunity for us to enlist young women recently confirmed and give them an active part in Church work.

Mrs. Lance, President of the Eighth Province, asks me to draw your attention to St. Margaret's House, Berkeley. "Here is the powerhouse; the educational and spiritual center for the training of women religious workers and leaders in the West. We have gone on record at our provincial meetings as endorsing St. Margaret's and recommending some financial assistance from each Diocesan and District branch in the Province. New growth brings new needs. St. Margaret's is looking forward to being in her new home by the opening of the fall semester. May I commend St. Margaret's to your earnest prayers and generous aid."

"O, God, give me an opportunity today and make me equal to it." God has something for each one of us to do. The world is richer or poorer for our being here. God give us grace today to take the high way of sacrifice and service, with a song in our hearts."
