

The Twenty-third Annual Convocation of the Missionary District of Idaho was convened with a Celebration of the Holy Communion in St. Michael's Cathedral, Boise, on the morning of Whitsunday, May 24, 1931, at 11:15 o'clock. The Rt. Rev. Middleton Stuart Barnwell, D.D., Bishop of the District, was the Celebrant; the Ven. M. Belknap Nash read the Epistle, and the Ven. Howard Stoy read the Gospel.

This service was not only the Corporate Communion of the District, but was also the Baccalaureate Service of St. Margaret's Hall. Dean Rhea preached the sermon, using the text: "Be ye perfect even as your Father which is in heaven is perfect." (St. Matthew 5:48.)

At 5:00 o'clock P. M., Evening Prayer was read in St. Michael's Cathedral by the Rev. B. C. d'Easum and the Rev. Victor Newman. The Rt. Rev. William Procter Remington, D.D., Bishop of Eastern Oregon, preached the Convocation Sermon.

On the following morning, Monday in Whitsun Week, the Holy Communion was celebrated in the Cathedral at 8:00 o'clock. This service was designated as the Corporate Communion of the Woman's Auxiliary; the Rev. Theodore M. Burleson was the Celebrant, assisted by the Rev. I. Q. Wood.

At 10:00 o'clock, Convocation was convened in the Chapel of St. Michael's by Bishop Barnwell. Devotions were read by Dean Rhea. Convocation proceeded to organize under the presidency of the Bishop of the District.

The Bishop appointed the Rev. H. H. Mitchell and Mr. R. S. Butterfield to act as the Committee on Credentials.

(The above-named, except Mr. Sinsel and Mr. Dirks, were present at roll call. They were in attendance later. Mr. J. W. Hodge, of Boise, was substituted later for Mr. Sinsel.)

There being a quorum, the Chair declared the Convocation duly organized.

The name of the Very Rev. Frank A. Rhea was placed in nomination for the office of Secretary of the District, and it was moved and seconded that the unanimous ballot of the Convocation be cast for his election. The motion was carried, and the Chair declared the Very Rev. Frank A. Rhea duly elected.

Mr. Rolston S. Butterfield was nominated for Treasurer of the District, and it was moved and seconded that the Secretary be instructed to cast one ballot for his election. The motion prevailed, the Secretary reported that he had cast the ballot, and the Chair declared Mr. Butterfield duly elected.

Mr. J. L. Eberle was nominated for the office of Treasurer of the General Church and District Program. By motion, duly seconded and carried, the Secretary was instructed to cast the ballot of Convocation for Mr. Eberle, and the Chair declared him elected.

On motion, the nomination and election of Chancellor of the District was held in abeyance.

On motion, the election of deputies to the General Convention was postponed.

REPORTS

The report of the Council of Advice was presented by the Very Rev. Frank A. Rhea, and on motion, was accepted and ordered printed in *The Journal*.

The report of the Examining Chaplains was presented by the Very Rev. Frank A. Rhea, and on motion, was accepted and ordered printed in *The Journal*.

The report of the Treasurer of the General Church and District Program was read, and on motion, was accepted and ordered printed in *The Journal*.

A motion was made that a committee of three be appointed by the Chair to raise the balance due on the Advance Work item allotted to the District.

A motion to table was lost, and the Rev. Mr. Burleson offered an amendment, instructing the committee to confer with the Woman's Auxiliary of the District as to plans proposed by that body. The amendment was duly seconded and carried, and the Chair was instructed to appoint the committee.

On motion by Mr. R. S. Butterfield, duly seconded, the Chair was asked to appoint a committee of two on publicity. The Chair appointed the Rev. H. H. Mitchell and Mr. Walter Ashton.

The report of the Moscow Building Fund was presented, and on motion, accepted and ordered printed in *The Journal*.

The Church School Lenten Offering was presented, and on motion, accepted and ordered printed in *The Journal*.

The Chair announced the appointment on the Committee on the Bishop's Address as follows: The Ven. Howard Stoy, the Ven. M. B. Nash, the Very Rev. Frank A. Rhea, and the Rev. H. H. Mitchell.

On motion, the report of this committee was made the order of business for 10:30 A. M. Tuesday.

A telegram was read from the Secretary of the Missionary District of Eastern Oregon, conveying the prayerful interest of our neighboring District in our deliberations.

The hour of noon having arrived, prayers for missions were said by Mr. H. B. Goldsmith.

Convocation adjourned until 2:00 o'clock P. M.

Afternoon Session

A joint session of Convocation and Woman's Auxiliary was held in St. Michael's Cathedral at 2:00 o'clock P. M., Bishop Barnwell presiding. The annual address of the Bishop was delivered.

Miss Ruth Osgood, Field Secretary of the Woman's Auxiliary, was presented by Bishop Barnwell, and gave an inspiring address on the work of the Auxiliary.

Miss Miriam Stoy, field worker in Sunday Schools in the District, gave

an illuminating address on the progress of religious education in the District, particularly in the fields covered by her within the last year.

Mrs. Jeanne L. Anderson presented the work of the Daughters of the King, urging further use of the Order throughout the District.

Mrs. William P. Remington was introduced by Bishop Barnwell, and in inspiring words carried her hearers into a vision of the more abundant life.

At 4:00 o'clock there was a pilgrimage to Christ Church, originally St. Michael's, and erected in 1866. Evening Prayer was read by the Rev. R. S. Stringfellow, the Rev. W. R. R. Simmons, and Mr. Walter Ashton. Mr. Ashton gave a brief historical address.

Tuesday Session

There was a celebration of the Holy Communion in St. Michael's Cathedral at 8:00 o'clock Tuesday morning. The Rev. Arthur P. Stembridge was the Celebrant, assisted by the Rev. L. A. Cook.

Convocation was called to order at 10:00 o'clock by the Bishop of the District, who read the opening devotions.

The minutes of the previous session were read and approved.

DEPUTIES TO GENERAL CONVENTION

Convocation proceeded to the election of deputies to the General Convention. It was agreed that the nominee having the largest number of votes would be declared deputy, and the next highest would be alternate. The Chair appointed the Rev. Victor E. Newman and Mr. H. B. Goldsmith to act as tellers.

The report of the tellers showed that the Very Rev. Frank A. Rhea had been elected deputy and the Ven. M. Belknap Nash alternate.

In the election of lay deputy, Mr. Rolston S. Butterfield was declared elected deputy, and Mr. Frank S. Kinyon alternate.

DELEGATES TO PROVINCIAL SYNOD

The Bishop appointed as members of the Bishop and Council the Very Rev. Frank A. Rhea, the Ven. Howard Stoy, the Ven. M. Belknap Nash, Mr. R. M. Davidson, Mr. W. N. Northrop, Mr. Walter Ashton.

The following members were elected by Convocation: The Rev. Ernest R. Allman, the Rev. B. C. d'Easum, the Rev. H. H. Mitchell, Mr. R. S. Butterfield, Mr. Laurel Dean, Mr. Harry G. Darwin.

OTHER ELECTIONS

On nomination, Mr. Walter Ashton was unanimously elected Auditor.

On nomination, the Rev. B. C. d'Easum was declared elected Registrar and Historiographer of the District.

REPORTS

The Ven. Howard Stoy presented his report as Archdeacon of the South.

Mr. Rolston S. Butterfield presented his report as Treasurer of the District. The report was accepted and ordered printed in *The Journal*.

The Ven. M. Belknap Nash presented his report as Archdeacon of the North.

The Committee on Canons reported that no matters had been referred to them.

The Committee on Necrology reported that no names had been referred to them.

The Committee on Resolutions reported that no resolutions had been referred to them.

The Department of Religious Education was presented by the Chairman, the Rev. H. H. Mitchell. The report was accepted.

The Department of Publicity reported that it had no report to offer.

The Rev. R. S. Stringfellow reported on the work of the Mission of the Good Shepherd at Fort Hall Indian Agency, including the Mission School.

The report of St. Luke's Hospital and Training School was presented by Miss Emily Pine, Superintendent.

The reports of clerical delegates to the Provincial Synod of 1930 and 1931 were presented.

On motion, an appropriation of one hundred dollars was approved towards the expense of the lay deputy to General Convocation.

The Bishop announced the appointment of the Rural Deans as follows:

A communication from St. Paul's Mission, St. Maries, was read and referred to the Committee on Finance.

The report of the Committee on the Bishop's Address was presented by the Rev. H. H. Mitchell, and on motion was accepted. It included a revised schedule of salary apportionment as related to the Bishop's share and that deriving from the missions.

The Finance Committee presented the 1931 budget for the General Church and District Program:

On motion, this budget was adopted, with the understanding that any surplus will be applied to the Advance Work of the General Church.

The Finance Committee presented the 1931 budget for the District.

On motion the budget was adopted as presented, except that the item for the Province be the same as that in the 1930 budget.

On motion the Finance Committee was instructed to draw up the quota schedules for the year 1932 and send them to the parishes and missions in time for use in the fall Every Member Canvass.

On motion, Convocation adopted a resolution of thanks to the members of St. Michael's Cathedral Parish for gracious hospitality extended.

On motion, the selection of the place of Convocation in 1932 was left to the decision of the Bishop and Council of Advice.

The reading of the minutes was dispensed with.

Closing prayers were said by the Bishop, the Doxology was sung, and Convocation adjourned sine die.

Appendix I

BISHOP'S ADDRESS

TWENTY-THIRD ANNUAL CONVOCATION, MISSIONARY DISTRICT OF IDAHO

St. Michael's Cathedral, Boise, Idaho, May 25, 1931

MY BRETHREN:

We come to the beginning of a new Convocation year with a sense of thankfulness to God for his many blessings. It has been a year filled with happy interest and profitable work. For me, it began with a summer in England, where I was in attendance upon the Lambeth Conference. With the work of this conference you are all familiar. Returning home in August, I tarried in the East for a week or two, calling upon interested churchmen in behalf of our work in Idaho, notably St. Luke's Hospital, which still has quite a large debt hanging over it. I began visitations early in the Fall and have continued them with regularity until now, this regularity broken in upon by four trips east, all in the interest of our work in Idaho. Since the last Convocation met I have traveled by steamship, rail and car at the rate of about a thousand miles a week, and in between trips have made a greater number of official visits to parishes and missions in Idaho than in any year before. So far as I am concerned, it has been at least an active year.

So far as the work in the field is concerned, it has been a profitable year. The clergy have been faithful and active beyond measure. We have sustained no losses by death or removal, though the Rev. Joseph Gunn has retired from active work after many years of faithful service. I am happy to record that he continues to live among us, and from time to time renders useful service in filling vacancies temporarily without pecuniary reward. I pray that God will grant him many more happy years with us. We have added two priests and two full-time lay people to our active staff. The Rev. Ernest Taylor has come to us from the Virginia Seminary and is awakening new life in Weiser and Payette. The Rev. Arthur Stembridge has succeeded Mr. Gunn at Rupert and Burley. Both of these men are bringing the enthusiasm of youth to bear upon their problems. Mr. H. B. Goldsmith, who for many years was an active layman at Idaho Falls, has left the business world and is at work at Salmon, where he is reading for orders. Miss Miriam Stoy, daughter of our beloved Archdeacon, is at work as Educational Secretary, and has been since last October. During this time she has brought new life to the work at Rupert and Burley, Shoshone and Jerome. In addition to these new workers, we shall soon have with us the Rev. Hamilton West. Mr. West will be remembered as one of the Alabama boys we had with us at summer school three years ago. He worked as a layman for one winter and spring at Kellogg and Wallace. He then entered the Virginia Seminary and graduates next week. He will be ordained in my old parish church in Birmingham on June 7, and come to us about July 1. This is a matter of great personal interest to me, for I have known Hamilton and have been largely responsible for his spiritual training since he was a boy of seven. I prepared him for confirmation when he was twelve years old. I regret that local engagements prevent me from being present at his ordination to the diaconate next month, but I look forward to ordaining him to the priesthood next year. So life moves on. We do our work and pass away, but the Church renews its youth from generation to generation. Men live and die but the Church of God remains eternally young.

Still another contribution of Idaho to the Church is Stanley Ashton. Mr. Ashton is finishing his college work at Kenyon College in Ohio. I spoke to President Pierce about him two weeks ago, and learn that he has

been nominated for a position of trust in the senior class next year, which is unusual in the case of a man who has been in the college but one year. Having done two years' work at the College of Idaho and the State University, he is making an enviable record in one of the most exacting colleges in the East. He enters the seminary after next year.

In addition to these, we will soon have a full-time woman worker in the north. The National Council has voted an appropriation for the salary of a U.T.O. worker at Bonners Ferry and Sandpoint. She will work under the direction of Mr. Nash.

I do not think that there ever was a time in the history of the Church in Idaho when the work was as well manned as it is today. And this in the face of the fact that we are receiving from the National Council about seventeen thousand dollars a year *less* than we received when I came to Idaho five and a half years ago. For this admirable result full credit is due to the faithful clergy, who have expanded their fields of action without additional compensation, and to the awakening interest of the lay people, who are taking on an ever-increasing share of local support. This line of development must continue. We must do more and more and each year expect less from the national Church. The time is rapidly coming when the Church will expect these western states to stand upon their own resources. For this we are preparing and must prepare *today*. When I press—as I continually do—upon the mission stations to increase their gifts for ministers' stipends, it is not that I love to be a hard taskmaster. On the contrary, I bitterly regret it. But I am constantly in touch with the mind of the National Church, and I see the drift of Church opinion. The day is fast approaching when those in Idaho who know and love the Church have got to support it. Failing this, they lose it. This last result, I dare not contemplate. I therefore press, as I am pressing now, for an ever-increasing sense of local responsibility.

The Indian Mission at Fort Hall continues to do good work. I never stand in the presence of those devoted women there without an acute attack of the inferiority complex. They are making sacrifices for the Kingdom of God far greater than most of us will ever be called upon to make. They live in congested quarters in a bleak and treeless plain. They know dust and heat in summer and ice and cold in winter and wind and mud in the spring. And with great regularity they present large classes for confirmation. This year their class was the largest in the district, exceeding in size that of even the local Cathedral. Miss Larery and Mrs. Creasey, not having anything to do to keep them busy in mothering and schooling thirty-five youngsters of their own, have gone over to the Government School and established their Bible Classes. In this work they are assisted by the Rev. R. S. Stringfellow. Between the three of them they are making a real impression on the life of the Indians on this reservation. It is little short of tragic that we are unable to put a full-time clergyman and his wife in residence on the Fort Hall Reservation. If we had the means, I believe that in a small way we could duplicate the remarkable work the Church has done among the Indians of South Dakota. Credit should also be given to Miss Margaret Williams, who has been serving for some years as a teacher. As a matter of fact, she has almost wrecked her health in this work. We are seeking for means to lessen the load these faithful workers have been carrying.

St. Margaret's School again is finishing its most successful year. We have decreased our askings of the National Council another twelve hundred dollars a year. We live within our appropriation and keep out of debt. Our teaching staff—I believe—is the best in any preparatory school in Idaho. Its members are not only graduates of splendid schools and universities and young women of adequate experience, but in addition are women of gentleness and culture. In the life of this institution there is everything to develop a girl into full Christian womanhood. If there is

any clergyman who is not continually holding the advantages of St. Margaret's before the parents of girls, he is overlooking one phase of his pastoral responsibility. The existence of this school is a real blessing to the people of Idaho. If they do not realize it, the fault is largely our own.

St. Luke's Hospital carries on. Tomorrow night we graduate one of the finest classes in the institution's history. Two of these girls have volunteered for service in our mission hospitals in Japan. We minister to more than three thousand patients each year. Our full charges are just about half of what they are in similar institutions elsewhere, and more than half of our patients are either charity or part-pay. In spite of all this we get along admirably without any help whatever from the National Church. There is still a heavy debt remaining from building operations, due in large part to the nation-wide depression, but I have good hope that this debt will be materially decreased during the present year. We meet our interest charges regularly and gradually nibble at the principal. I am not at all worried about the finances of St. Luke's. My only regret is that we cannot undertake new and needed developments in other parts of the district until this obligation is fully met. As in every other year, we pause to mention Miss Emily Pine and her splendid corps of assistants. These women are the life of St. Luke's. Without them the new hospital would not have been built. They are its very heart and soul. On the occasion of his recent visit Bishop Creighton, the new Domestic Secretary, said that St. Luke's was the finest thing of its kind he had seen in the Church. I am sure this will gladden the hearts of those who have worked to make St. Luke's possible.

There is but little to note in the life of the missions. Jerome is a point where an old work has been reopened. We have a nice church there which was closed many years ago in what proved a fruitless effort toward a community church. This movement failing, as such local efforts are almost sure to do, the Rev. Mr. Allman has begun work, and assisted by Miss Stoy has achieved remarkable results. I attended a Deanery meeting there this spring and confirmed a class on the occasion of another visit. The work is promising and is supported by a fine group of people.

At Idaho Falls we hope to have a full-time clergyman as soon as Hamilton West comes out to us. At Weiser we have a new rectory. Under Mr. Taylor and his splendid wife the work is developing rapidly. We believe that Weiser is destined to become an important center for a large section of the country, and that before long we shall be compelled to enlarge and modernize our equipment. We own a very valuable piece of property, and from its sale ultimately we can secure enough money to go far in this proposed development.

Coeur d'Alene is springing to new life. At the time of my last visit there in April, plans were launched looking to the completion of the new parish house and rectory. Considerable money has already been pledged toward this end, and I have every hope that before another year has passed, great improvement will be noted there. We are as yet unable to do very much toward the new building at Moscow. Most of the money we raised for this purpose has gone toward completing payments on the property purchased. Hard times have prevented the pushing of this campaign for funds. In the meanwhile we are firmly entrenched in a strategic location. When conditions improve throughout the country generally we are prepared to go ahead. We are at work on tentative plans for a building looking toward this end.

The other mission points pursue the even tenor of their way, with confirmations this year slightly above the past averages.

The Summer School meets at McDonald Point, Lake Coeur d'Alene, on July 15, continuing through July 24. We have prepared a most attractive program. The young people will be looked after by the Rev. Hamilton West and Miss Miriam Stoy. Miss Osgood, an Idaho girl who is

doing field work for the National Woman's Auxiliary, will be with us. Dr. Laney of the State University, whom we remember with such pleasure on the occasion of his visit to us a few years ago, will be with us again. Mr. Mitchell will be in charge as usual, assisted by Miss Pauline. Dean Rhea will be Camp Chaplain, and I will take over the evening talks and the camp fire hour. Mr. Mitchell will again be editor-in-chief of the *Daily Prevaricator*. I urge you as you return to your several fields of service, to do all in your power to interest your people in this school. Many of them are overlooking what can be made for them a most delightful and helpful experience. Your people will be better parishioners and more loyal cooperators as a result of a visit to McDonald's Point.

The "Pay as You Go" plan adopted at the New Orleans Convention (which has, in fact, degenerated into a "Pay as You Please" plan) has again reduced our income—this time to the extent of more than two thousand dollars a year. At present, I am running behind nearly a hundred dollars a month on account of salaries. And a new clergyman is coming out in July. I cannot continue to run a deficit, for I am required by the National Council to balance my books by the end of each year. There are only three possible solutions. One is to reduce salaries, and this we will not do. One is to close up certain mission points and ask a faithful clergyman to seek work elsewhere, and this I dread to contemplate, though it has been done in some other Missionary Districts. I do not know where a man would go to look for work at a time when we are all facing the common problem of reduced income. The third alternative is the assumption of a larger share of clergy salaries by the missionaries themselves. It is along this last line that we must seek for a solution of this problem. Some of the missions I shall not ask to increase, for they are doing all that is humanly possible. Hailey is a notable example of this—a little mining town of eight or nine hundred people, most of them out of work while the mines are closed, yet paying \$56.75 every month on the minister's salary. If other points in Idaho were doing as well proportionately, we would be independent of the National Church. I am submitting to Convocation at one of the business sessions a revised salary schedule, which I know to be well within the power of each mission point involved. Unless the conditions of this schedule are approximately met by the missions concerned, I shall have no alternative but to withdraw the minister in charge. If the Church has served any given community for a long term of years, and if during all those years the people of the community have not learned to love it enough to make some sacrifice for it, I cannot see that the Church is doing them very much good. I do not see that anything is gained by trying to force the Church upon communities which will not adequately support it. I am of the opinion that too much of this has been done in the West in the past, and this belief is shared by most of the present Missionary Bishops. It was stated again and again at the recent conference held in St. Louis. These are simple facts that we might as well face. I shall prepare a statement covering these points and ask that it be read to all the congregations in the state, and have it published in *The Idaho Churchman*. With a knowledge of these facts before them, I am confident that our people will rise to meet the emergency.

May God bless us in our work, and grant that through our labors the Kingdom of God in Idaho may be built and grounded on love and peace.

MINUTES OF THE TWENTY-THIRD ANNUAL MEETING OF THE WOMAN'S AUXILIARY TO THE MISSIONARY DISTRICT OF IDAHO

MAY 25-26, 1931

The Corporate Communion of the Woman's Auxiliary having been celebrated in the Cathedral at 8:00 o'clock A. M., its twenty-third annual meeting convened in the Bishop Tuttle Church House on Monday, May 25, at 10:00 o'clock A. M., the President, Mrs. B. C. d'Easum, in the chair.

The session was opened with the singing of the Hymn No. 493, "Oh Master Let Me Walk with Thee," and was followed with prayer by the President.

Upon motion, the reading of the minutes of last year's meeting was dispensed with and they were adopted as printed in *The Journal*.

The President named the following committees:

Committee on Resolutions—Mrs. Stringfellow, Pocatello; Mrs. Hamilton, Weiser; Mrs. Allman, Twin Falls; Mrs. Goore, Pocatello; Mrs. Armstrong, Lewiston.

Committee on Letters—Miss Sonna, Boise; Mrs. Cage, Boise.

Courtesy Committee—Mrs. Cook, Nampa; Mrs. Donald Whitehead, Boise.

The President read her address, stressing the keynote of the whole Convocation, "Witnesses for God," and reviewed the work of the Auxiliary in Idaho for the year and made many valuable suggestions for the work in the future.

The Treasurer's report, showing a balance on hand of \$54.58, was read and upon motion duly seconded was adopted.

Mrs. Remington, of Eastern Oregon, addressed the Auxiliary, bringing greetings from our neighbor diocese. She gave a most inspirational address on the work of the Woman's Auxiliary, stressing advance program and United Thank Offering.

Mrs. Dean, of Emmett, gave a report for the Boise Deanery; one meeting, at which Miss Beardsley was the special speaker.

Mrs. Nash, of Coeur d'Alene, gave a report for the Coeur d'Alene Deanery; two meetings, of which one was at Wallace and the other at Coeur d'Alene. Special speakers from Spokane helped make the session inspirational.

Mrs. Nash brought greetings from the Montana Auxiliary assembled in annual Convocation.

Miss LeBaron, of Lewiston, gave a report for the Lewiston Deanery, which has but two parishes and two missions.

Mrs. Goldsmith, of Salmon, reported for the Pocatello Deanery; one meeting at Blackfoot, with Miss Beardsley as special speaker.

Mrs. Hays, of Twin Falls, gave a report for Mrs. Williams of Twin Falls for the Twin Falls Deanery, which has had one meeting. Mrs. Hays stressed the value of definite programs, telling something of P.T.A. methods.

Miss Miriam Stoy addressed the Auxiliary, telling of her work in the Twin Falls Deanery. She talked especially of Church School methods and young people's organizations.

The report of the Educational Secretary, Mrs. Gunn, of Nampa, was given, and the course of study, "Building a Christian Nation," for the coming year was presented.

A balance of \$18.61 in the Educational Secretary Fund was reported.

In answer to a question, it was announced that Miss Ruth Osgood is the Prayer Partner for the Woman's Auxiliary of Idaho. Miss Osgood was then introduced and addressed the meeting, telling much of interest in her work and bringing to us a new vision of what Woman's Auxiliary work might be.

Bishop Remington led in noonday prayer. The meeting adjourned until Tuesday morning, to have luncheon served in the Church House by the Second Section Woman's Auxiliary of St. Michael's and to attend the joint session of the Convocation in the afternoon in the Cathedral.

TUESDAY, MAY 26

The Woman's Auxiliary convened for business in the Bishop Tuttle Church House at 10:00 o'clock A. M. The meeting was opened with Hymn No. 502, followed with prayer by the President:

The following memorials to Mrs. Rhea and Mrs. York were read by Mrs. McDonnell:

"Inasmuch as it has pleased our Heavenly Father to take from our midst Edith Hottenstein Rhea, the devoted wife of Dean Rhea of St. Michael's Cathedral, Boise, and an earnest co-worker with us, we, the Idaho Branch of the Woman's Auxiliary, knowing what her life meant to her husband and her family, and her interest and thought for others, the pains she took to make everyone happy, feels that in a sense life here seems poorer with her physical presence gone, but in reality it is richer, inasmuch as she has become so large a part of it and the memory and sweetness can never be taken away.

"I will lift up mine eyes unto the hills whence cometh my help." Catherine Brady York, whose loss we mourn, spent the days of her youth upon the mountain top where were received the first rays of the morning sun and were the last to be bathed in darkness when the stars appeared to replace them. These sun rays found an abiding place in her heart and grew with her growth till, coming to the valley to dwell, they were so strong that all in the home or without with whom she came in contact were warmed and bettered by their reflected brilliance. Now that she is in the presence of His glory, we are blinded and she is lost to our vision for a time, but we are sustained by the hope that, when these mortal eyes have put on immortality we may behold her in intensified radiance reflected from the Giver of all Light."

"Remember Thy servants, O Lord, according to the favor which Thou bearest unto Thy people and grant that increasing

in knowledge and love of Thee they may go from strength to strength in the life of perfect service in Thy heavenly kingdom, through Jesus Christ, our Lord, who liveth and reigneth with Thee and the Holy Ghost, ever one God, world without end. Amen."

A motion that these memorials, written by Mrs. Stoy and Mrs. McDonnell, be printed in *The Journal* and copies be sent to the families, was made, seconded and carried.

A motion was made that a letter of congratulation and good wishes upon the sixtieth anniversary of their wedding be sent to Mr. and Mrs. Hartung of Hailey. The President asked that letters be sent to Mrs. Funsten, Mrs. Touret, Mrs. Jennings, Mrs. Kurtz, Mrs. Hartung, Mrs. Ashton, Mrs. Somerville, Mrs. Sommercamp, Mrs. Ingham and Mary Louise Johnesse.

Upon request of Miss Sonna, chairman of the Committee on Letters, the President added the names of Mrs. Hamilton, Mrs. Rosevear and Mrs. Hottel to the committee.

The minutes of the previous session were read and approved.

Mrs. Carl Dirks read a report of the Box Supply for 1930-31. Boxes had been sent to Alaska and to Arkansas, an extra box of used clothing going to Arkansas for the negroes in the drouth-stricken area. She acknowledged gratefully the generous response of many Auxiliaries toward the deficit of the previous year.

Mrs. Franklin I. Coats gave a report of the work for the Isolated Churchmen. She told of her difficulty in finding them and asked that secretaries of Deaneries notify her of isolated Churchmen in their districts.

Mrs. Trafton, of Idaho Falls, gave a report of the study on India as used in the Pocatello Deanery.

Mrs. Johnesse made a report of the United Thank Offering, showing a balance up to May 1, 1931, of \$473.55. The report was accepted.

Upon request, Mrs. Johnesse told the history of the gavel presented to the Woman's Auxiliary of Idaho by Mrs. Funsten when she was leaving Idaho. It had been a gift to Bishop Funsten, made from a branch of a sycamore tree growing on the campus of William and Mary College.

Mrs. Nash, of Coeur d'Alene, suggested that the United Thank Offering be presented at the Denver Triennial in a purse to be obtained from the Fort Hall Indian Mission.

Miss Ruth Osgood addressed the meeting, telling most interestingly of Deaconess Newell and her work at St. Margaret's House, Berkeley, and of her own experience in the drouth area of Arkansas.

Upon motion, the meeting now adjourned to the Cathedral for noon-day prayer in joint session, after which luncheon was served in the Church Home by the ladies of the first section of the Woman's Auxiliary of St. Michael's.

AFTERNOON SESSION

The Woman's Auxiliary convened in the transept of the Cathedral at 2:00 o'clock. The meeting was opened with the prayers and responses especially prepared for the Woman's Auxiliary. The minutes of the forenoon session were read and approved.

The President addressed the assembly on Advance Work and made an appeal for help toward our own pledge. She also brought words of greeting to the Woman's Auxiliary from Mrs. Touret.

A letter of thanks from Deaconess Newell for our gift to St. Margaret's House was read.

Miss Osgood, in answer to questions about the course of study at St. Margaret's, a training school for women entering upon church work, spoke at length again about that school. Upon completing the course, the graduate is awarded a B.A. from the University of California and a certificate from the Pacific School of Religion, the students taking many of their courses in these two educational institutions.

That a member from each branch be appointed to instruct the groups of girls in Altar Guild work, with the manual compiled by Mrs. Perry as guide.

That each branch appoint a United Thank Offering custodian.

That each branch use the "Spirit of Missions" as a basis for discussion and study at meetings; and urge members to subscribe for the "Spirit of Missions."

A motion was made and carried to adjourn and Miss Osgood closed the Twenty-third Annual Meeting of the Woman's Auxiliary with prayer.

ADDRESS OF AUXILIARY PRESIDENT

To the Women of the Missionary District of Idaho:

Once again it is my privilege to greet you, officers and members of the Woman's Auxiliary of this Missionary District of Idaho.

It has become the custom for the President to strike the keynote. At the Twin Falls Deanery meeting, in Jerome, our Bishop gave as his text: "Sanctifying ourselves for others." I would like to add to this the outstanding idea given at the Lambeth Conference—that of "Witness," "Ye shall be My witnesses."

There passes before us a mighty procession of those who have borne witness in the past. We think of our beloved friend, Mrs. Rhea, who for nearly two years was our Educational Secretary and Chairman of the Corporate Gift. Mrs. Stoy has written a memorial which will be read later.

One of the greatest adventures of the road we travel is our work together; the understanding we have for each other; the joy of the work we share and the enlisting of others to share this work and fellowship. The whole end and aim of our work is to deepen our spiritual life individually and as an organization, to the end that Christ's Kingdom may come upon earth.

Our horizon must be broadened beyond our parochial needs. The aim for this year has been every Guild a branch of the Woman's Auxiliary. The suggestion has been made that at least one meeting each month be given to gaining a greater understanding of our Church work. Every baptized woman is a member of this Missionary Society.

Several branches report fine interest in the study of India. Good programs were sent in to the Educational Secretary. A member of St. John's Guild, Idaho Falls, will tell of love and sympathy gained for the women of India through this year's study. A book by Elizabeth Williams, entitled "Understanding India," was added to the two regular study books, "India Looks to Her Future," and "India on the March." Answers to roll call, "Current Events in India," have created fine interest. Benefit has been found in having programs come before the business meetings. Some plans for this study of India were made at last year's Summer School at Coeur d'Alene.

This year our study will be the General Church Program.

BUILDING A CHRISTIAN NATION

As we have studied Africa, the World Mission of Christianity, and India, in these past three years, we have been forced to face the fact that if we would build a more Christian world we must be concerned with making Christian every area of life in our own land.

In preparation for the Triennial meeting the following subjects will be considered.

- (1) Family Life;
- (2) Property and Economic Conditions;
- (3) Inter-Racial Contacts;
- (4) International Relations;
- (5) Religious Thinking of Today.

We are having prepared for our special use a symposium edited by the Right Reverend Frank Hale Touret, retired Bishop of Idaho, on the work of the Church in city, town and country; in colleges and among certain racial groups, notably the Indian, the Negro and the Oriental.

We want to visualize the Woman's Auxiliary to the National Council as it exists today: a fellowship of women bound together for worship, study, work and manifold self-offering. Its central ideal is wholly unselfish and impersonal. It is the Auxiliary of the National Council, an organ of the Church which helps in every forward movement, yet is content to merge its offerings and its service in the greater offerings of the whole Church.

"So we find in every place where it is alive and earnest, the members of the Auxiliary pledging definite support to the Advance Work program of the diocese or parish, rather than seeking a separate project of their own."

Idaho, this year, has undertaken to send one thousand dollars to Sweetwater, Texas. We are glad to have a part in this Advanced Work program. Our Treasurer has received small gifts from several Guilds.

UNITED THANK OFFERING

All Saints' Day and Ascension Day have been appointed as special days in each year for the presentation of this offering at Corporate Communion. This year there will be added one other day before September.

We picture that glorious company of women in Denver Cathedral. Let us each have a part in that offering of prayer and gifts and joyful service. The 1928 funds are almost exhausted. May I call your attention to the article on U.T.O., by Miss Lindley, in the May number of *The Spirit of Missions*.

Long distances in Idaho may be an obstacle to frequent meetings, but the deanery meetings are always well attended. Last November Miss Beardsley spent several days in this Missionary District and gave inspiring talks at deanery meetings in Boise and Blackfoot. Miss Ruth Osgood, Field Worker for the Woman's Auxiliary, has been working in Idaho since the middle of May. She is an Idaho girl. Some of you may remember the occasion five years ago when Dean Roberts presented a silver cross to Miss Osgood on her leaving to take up church work in Mexico. Our prayers have followed her in all her work, and we are happy to have her with us at this Convocation, as well as Mrs. Remington and Miss Miriam Stoy.

It was decided some years ago that the diocesan officers visit all the guilds. The deanery Presidents have cooperated splendidly, as you will know from their several reports. My journey book shows that I have traveled on official business since last Convocation. Small groups of loyal women carry on the work in many of the out-of-the-way towns, with only occasional church services. Idaho roads are good, but they are very long ones. St. John's Guild, Idaho Falls, bought a car for their Vicar. With this Ford several journeys have been made more quickly and cheaply than by train. I would like to make special mention of happy gatherings at Hailey and Shoshone.

There are in Idaho thirty-one organized Guilds, with a total membership of 580 and reporting an average attendance of 312.

The World Day of Prayer was observed by several branches.

Some branches may discontinue regular meetings during the summer, but arrangements should be made for reports of this Convocation to be given by the delegates to their Guilds at specially called meetings.

I would like to finish with a few recommendations:

That this Convocation send a gift of money to St. Margaret's House, Berkeley, California, our Provincial Training School.

Buy a brick in the National Cathedral, Washington, D.C. The cost is ten dollars.

That a member from each branch be appointed to instruct groups of girls in Altar Guild work, with the manual compiled by Mrs. Perry as a guide.

Use *The Spirit of Missions*.

Send delegates to Summer School at Coeur d'Alene.

That each Guild buy and use some religious book recommended by the clergyman.

I would like, at this point, to express my sincere appreciation to the officers, committees and members who have worked so faithfully and efficiently during the past year.

In the words of the late Bishop Anderson, "Two things stand out prominently in the life of the Woman's Auxiliary—high ideals and splendid accomplishments. Its methods have been to study, to learn and to pray. The results have been cheerful giving and magnificent benevolence throughout the whole Church. Its present aim is to make progress more progressive. I wish it 'good luck in the name of the Lord'."

REPORT OF THE EDUCATIONAL SECRETARY OF THE WOMAN'S AUXILIARY

*To the President and Members of the Woman's Auxiliary to the
Missionary District of Idaho:*

I herewith submit the report of the Educational Secretary for the period covering May 5, 1930, to May 25, 1931.

The Rev. H. H. Mitchell, Camp Director of the Summer School, gave a place on the 1930 program for talks, pointing to the year's study of India. These talks were given by the Rev. B. C. d'Easum and Mrs. d'Easum. The Very Rev. Frank A. Rhea spoke of the Jerusalem Conference. The women were privileged to hear the Rev. Frederick Bartlett in his talks on the Advance Work Program.

I have written forty-seven letters on the study program, and have distributed ten "General Church Programs" to groups of women desiring them. I have ordered seventy copies of the United Thank Offering number of *The Spirit of Missions* for October, 1930, and have sent two copies to each place that might not otherwise see the magazine.

I have obtained from the Council of Women for Home Missions and the Federation of Women's Board of Foreign Missions of North America twenty copies of the pamphlets, "Ye Shall Be My Witness," by Kathleen W. MacArthur of Canada.

I have ordered eight copies of "India on the March" and eight copies of "India Looks to Her Future." Also one Leader's Manual.

I received from New Plymouth a request for Bishop Talbot's book, "My People of the Plains." I forwarded this request to Miss Margaret I. Marston, Educational Secretary, and she forwarded the book at once from the Lending Library at the Church Mission House, New York City.

I have received word from three Guilds that have this year made study a part of their programs.
