CONSTITUTION.

ARTICLE I.

This association shall be called the Iowa Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

The object of this association shall be the same as those of the General Auxiliary.

ARTICLE III.

All parochial missionary societies of women, and all baptized women of the Diocese desiring it, who contribute prayers or gifts to missions, shall be considered members of this association.

ARTICLE IV.

The officers shall be Honorary President, President, First Vice-President, Second Vice-President, Recording Secretary, Treasurer, U. O. Treasurer, Correspondent Church Periodical Club.

ARTICLE V.

These officers shall be elected by the women in their annual meeting, during Convention of each year, and shall serve until their successors shall be elected.

ARTICLE VI.

The duty of the President shall be to call meetings and to preside over them.

ARTICLE VII.

The Vice-President shall preside over meetings in the absence of the President.

ARTICLE VIII.

The duties of the Secretary shall be to give notice of meetings and keep record of them; to correspond with Parish secre-

taries and with the Secretary of the Auxiliary; to obtain yearly reports from the Parochial Branches and incorporate them into an annual report for the Diocesan Branch.

ARTICLE IX.

The duties of the Treasurer shall be to receive and disburse the moneys of the Diocesan Branch; obtain reports yearly from the Parish treasurers and make up from them an annual report.

ARTICLE X.

The officers, as a committee, shall use such efforts as lie in their power to increase missionary knowledge and zeal among the women of the Diocese, and to encourage the formation of Parochial Branches.

ARTICLE XI.

An annual meeting shall be held each year, at the time and place of the Diocesan Convention. Special meetings may be held during the year, upon the united call of three Parochial Branches, for the purpose of increasing interest.

ARTICLE XII.

This Constitution may be altered or amended at any annual meeting, by a vote of two-thirds of the members present.

ARTICLE XIII.

Two delegates or two alternates shall be sent from each Parochial Branch to attend each annual meeting.

BY-LAWS.

The officers shall hold an executive meeting before each general meeting, and at one other time during the year, at the call of the President.

The regular order of business for the annual meetings shall be as follows:

1. Prayers.
2. Roll-Call.
3. Minutes of Meetings.
4. Report of Secretary.
5. Report of Treasurer.
6. Election of Officers.
7. Miscellaneous Business and Addresses.

By-laws may be amended at any meeting, by vote of a majority of those present.

PRESIDENT'S ADDRESS.

Dear Friends—In reporting upon the status of our Woman's Auxiliary work one year ago it was said that the visitations of the twelve-month then closing had reached almost every, at the time, available point in the diocese. How fully this described conditions, may be realized by stating that of all the parishes named on our diocesan list of last year but five were without an organization of the Woman's Auxiliary, of which five three are essentially missions, so that there are in Iowa but two points where we have anything like self-supporting work, in which at least the seed of this fruit has not been planted. Beginnings have been made in a number of missions also, in some cases with most hopeful prospects.

Such being the condition as regards the work of organization, the past year has not been one in which the number of our branches could feasibly be increased; indeed it has been thought wise to strike from our list two which had existed for a number of years in name only, without prospect of anything more substantial—those at Clermont and Durant. It is realized that there must first be a congregation of the faithful, not necessarily large nor wealthy, but with its own life centering in the worship and work of the Church, before this life can reach out to touch and enrich other lives. It is therefore as the Church in our diocese develops itself from unorganized to organized missions, from missions to parishes, that the work of the Woman's Auxiliary, following where in the nature of things it cannot lead, must look for the extension of its field.

But there is an intensive as well as an extensive growth, and in this direction the largest room in the world, the room for improvement, constantly opens before us. We may not in every season increase the mere number of our branches, but may we not increase their zeal, their faith, their efficiency? The seed has been planted broadcast, it may be, but in many places it has but just begun to germinate, and all the period of fruit-bearing is yet to come. Nor is a vigorous sapling to be reckoned as a full-grown tree. To what may it not in time attain?

Much, very much, depends upon our fundamental conceptions, the standards by which we work. Is our thought only to do as we did last year, to do our share, measured by what some neighbor's equally low standard may be, then surely we shall not advance, we shall even, by God's eternal law of progress, slip backward. But if we strive, con-

tinually, to reach up to higher and larger things, to make each year a stepping-stone to something better, to grasp more fully the great mission of Christ's Church to every living creature, and our own individual relation to that mission, then we shall also grow continually both in grace and in all good works.

We do see many hopeful signs of such growth and give thanks for them, but we look for yet other and better ones. We are learning to work with more of purpose, and we believe of definite knowledge, to redeem and even more than redeem our pledges, to give of our best thoughts and plans and purposes, but we are still children in this school as compared with the infinite possibilities. As children let us look forward to learning much and doing more, not as though we had already attained. Neither let us be narrow, desiring that every stirring of missionary zeal among the women of the Church should find record in our reports. It is not so measured. Not a missionary offering is ever taken up "in the great congregation" to which women do not give a notable proportion—we are assured of that. Our Auxiliaries give evidence of but a part of all that the women of the Church are yearly doing for its upbuilding—how large a part is known only to Him who while on earth did not disdain their ministering love.

That ministry has never since failed. May we be worthy bearers of it, so that in both the present and the future growth of our beloved Church, not only in Iowa but throughout the world, we may never cease to bear our glad and loving share, by our gifts, our personal efforts and our prayers.

MINUTES OF THE FOURTEENTH ANNUAL MEETING.

MAY 21, 1901.

Promptly at 2 o'clock the gavel in the hand of the President, Miss Henriette Henningsen fell, and the 14th annual business meeting of the Woman's Auxiliary opened. The roll call showed 21 branches, represented by 30 delegates as follows:

The President read an interesting letter from the General Secretary, Miss Emery; in which she made three suggestions, viz:

First—That the United Offering of the Woman's Auxiliary should be presented at the Triennial in one great whole, as an Aged and Infirm Clergy Fund, the offering to be placed in an envelope having on the exterior a picture of the oldest Mission Church in the Diocese.

Second—That Iowa prepare an Historical Missionary Exhibit and elect a chairman to take it in charge.

Third—That a selection of a prayer to be used as a Noon-day Prayer be made.

In regard to the object of the United Offering, after some discussion, a motion was made and carried to lay the matter on the table until the meeting of the following day. Mrs. Morrison moved that the office of the United Offering Treasurer be created. Motion was seconded and carried. The selection of a Noon-day Prayer was also laid on the table for future action. Next came the Historic Exhibit, which means that each Parochial secretary should collect together anything old, and of interest, pertaining to the Parish and send to the chairman of said exhibit. The matter was finally settled by a carried motion to prepare an Historical Exhibit. The election of the chairman of the exhibit was placed on the table for action the following day. Next in order came the report of the secretary and treasurer of the condition of the pledges revealing:

The report was accepted and placed on file. Mrs. Morrison then moved that the three pledges be renewed as formerly made. Mrs. Morrison amended the motion to read, pledges renewed with all surpluses of all pledges added. Vote was favorable.

Under the head of new business, Hospital work was taken up and it was suggested that each branch do something or give gifts to the New Hospital for Women at Shanghai. Mrs. Morrison moved that the matter be left to the judgment of the branches to decide as to whether or not anything should be done. Motion carried.

General hospital work was then discussed and Mrs. Morrison suggested that that work should be confined to Church hospitals only; upon which Mrs. Rogers moved that the Diocese be divided into two districts, one to work for St. Luke's, Davenport, the other to work for St. Luke's, Cedar Rapids. Each branch to be given option to take up this work or not. Carried.

The needs of the Perry Memorial room was presented by Miss Kimball, resulting in considerable discussion, closing with a carried motion offered by Mrs. T. J. Foley that the Woman's Auxiliary provide for the Perry Memorial room for five years.

Mrs. Mahon read her report as Treasurer, which was adopted.

The secretary also presented her financial report, which was received and adopted.

Mrs. T. J. Foley in presenting her report on Junior work said:

I beg leave to submit my report as Second Vice-President in charge of the Junior Auxiliary to the Board of Missions, since my election to office one year ago.

I have written 97 letters in the interest of the Junior Auxiliary work in our Diocese, letters to the Clergy and Sunday School Superintendents; I do not think any have escaped me as I believe we number only 45 Parishes, 31 organized Missions and 9 unorganized, a total of 85. I am pleased to report that I have received 45 very pleasant encouraging replies to my letters.

The Easter Offerings of the Sunday Schools for 1900 sent to the General Board of Missions amounted to \$601.44, an increase over the previous year of \$68.50. It is gratifying to observe that only two of these offerings were for Domestic Missions, which shows the Missionary spirit is spreading in our Diocese, thanks to our Bishop.

The Offerings of the Junior Auxiliary from specials and birthday boxes for Diocesan and General Missions are as follows:

I find the birthday boxes quite a pleasant feature in our own Parish, as the children and teachers enjoy giving their pennies on their birthdays, and it teaches the lesson so necessary for us all to learn "It is more blessed to give than to receive." I know of no better way to instill in the hearts of our Sunday School children the Missionary spirit than by teaching them to give on their birthdays in place of receiving. May this department of our work expand until its light shineth forth among all people.

Miss Weare presented the following on the work of the Church Periodical Club, which was accepted.

Madam, President and Members of the Woman's Auxiliary:

In making this my first report of C. P. C. work, it is important that the Woman's Auxiliary understand more fully what it is, what it does, what it needs. Dr. Greer says: "The Church Periodical Club needs no advocate—no arguments to commend it as a good work—all that is required is a larger knowledge of it. There is this peculiar value about a book, that when you read it, and get out of it all you can it is just as good for the next person as for you. Books do really over and over again clothe the naked and feed the hungry as no other clothing and food can do. When Moses was sent out by the Lord, he had only the little rod which he had picked up some where in the desert—but with that rod he brought water out of the rock, he cleft the waters of the Red Sea, he made a passage through the river Jordan, he led the people over on dry land. The C. P. C. has only a book—a paper, but

with that, it, too, can bring water out of the rock, and make the wilderness blossom as the rose. The C. P. C. stands for something little, but it stands for something large, and it is the little after all that does the large work."

1. What it is: It is a Society formed for the purpose of supplying periodicals and books to those of the clergy and laity who are unable to procure good literature in any other way.

2. What it does: I. It obtains from the different Bishops, names and addresses of those persons who need books and periodicals.

II. It appeals to those who have periodicals to send them, when read, regularly every week or month, to the persons who ask for them, always prepaying postage.

What it needs—I hope to be able to tell each Parish individually.

When the Church Periodical Club was founded twelve years ago, its object was simply to utilize current papers and magazines, which had once been read.

The Founder, Mrs. Mortimer Fargo, had just returned to New York from traveling through some of those parts of the country where the dearth of literature so impressed itself upon her mind that she formulated this work on the simplest basis, with the endorsement of the Bishop, and all the assistance the Domestic Branch of the Woman's Auxiliary could offer.

Devoting a room in her dwelling to the work, with the assistance of the few who were interested, Mrs. Fargo tried to impress upon those who wished to be of use, and help on the work, the great need of sending the magazine, or book, directly—with, as Mrs. Fargo said—for work, wrapping and addressing the magazine, book, or books—for expense, the postage—and for the blessing of God, the little prayer which she hoped would speed the package on its mission.

Iowa has done little, but it has done something:

Council Bluffs, St. Paul's, send five copies of New York Churchman to five of the clergy.

Lyons, Grace, one box to Penitentiary at Anamosa, containing 50 magazines, 30 pamphlets and 10 books.

Council Bluffs, Grace—One box of reading matter to penitentiary at Anamosa.

Send one copy of Churchman, letters written 30, letters received 23.

The General Missionary meeting proved extremely interesting and in his informal talk Bishop Morrison was so full of enthusiasm that those who listened became imbued with the same feeling. The reports of the various officers showed an increasing and steady growth in the Parochial and Junior Branches. Perhaps the best feature of the meeting was the address of Miss Crummer, the missionary from China. Surely as she described her work, it seemed as though our work should increase and our sympathy be greater rather than less for China. Miss Buffington, principal of St. Katherine's Hall, emphatically demonstrated that for educational purposes the young girls of Iowa need not go out of the state, and a generous offering of \$50.00 was given to the Woman's Auxiliary ere the service closed.

Again at 1 o'clock a bountiful luncheon was provided by the women of St. Paul's; the convention closing with a reception tendered to the women of the Auxiliary in honor of Mrs. Morrison by Mrs. Simon Cassady.

Minutes Second Day's Business Session Women's Auxiliary,
Wednesday Morning, May 22, 1901.

The adjourned meeting was held in the crypt of St. Paul's and was called to order by the President, Miss Henningsen. The first business was the election of officers. The president requested the Honorary President to take the chair and we proceeded to elect the president. Nominations from the floor were called for, but as only Miss Hen-

inningsen's name was presented Miss Henningsen was re-elected by acclamation. The First Vice-President, Mrs. Casady. The Second Vice-President, Mrs. T. J. Foley; and Correspondent of the Church Periodical Club, Miss Susanna H. Weare, were also re-elected by acclamation.

Before the election of Secretary and Treasurer, Mrs. Taylor offered a motion toward dividing the office of Secretary and Treasurer. A spirited discussion resulted, but the motion carried in favor of division.

Election of Secretary being in order the ballot was cast and Mrs. Catherine Taylor was declared duly elected.

Election of Treasurer followed and on report of the tellers Mrs. L. H. Greer was declared elected.

Mrs. A. C. Stilson received the election to the office of Treasurer of United Offering.

By a carried vote, Article 4 of the Constitution was amended to read as follows:

The offices shall be Honorary President, President, First Vice-President, Second Vice-President, Recording Secretary, Treasurer, Trustees of United Offerings.

All the re-elected and newly elected officers expressed their intention of attending the Triennial, and a vote was taken to elect the alternates by acclamation and the following were declared duly elected:

The business of the previous meeting laid on the table was then taken up. First the matter of the United Offering as an Aged and Infirm Clergy Fund was settled by an unanimous vote of the delegates present in favor of that object. Second laid over business. Mrs. Morrison was elected chairman in charge of Historical Exhibit.

The selection of a Noon-day Prayer was left to the discretion of the delegates present at the Triennial.

Under order of new business, on motion of Mrs. Jackson a rising vote of thanks was given to Mrs. Mahon for her efficient and valuable work as Diocesan Secretary and Treasurer.

Mrs. Morrison then moved that the credential system be abandoned, said motion carried.

Mrs. Caldwell offered a resolution embodying the sincere gratitude of all present to the ladies of Des Moines for their generous hospitality. This was heartily responded to by a full rising vote. A carried motion giving power to the Advisory Board to revise and amend the By-laws, was followed by a motion to adjourn.
