CONSTITUTION.**ARTICLE I.**

This Association shall be called the Iowa Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

The object of this Association shall be the same as those of the General Auxiliary.

ARTICLE III.

All parochial missionary societies of women, and all baptized women of the diocese desiring it, who contribute prayers or gifts to missions, shall be considered members of this Association.

ARTICLE IV.

The officers shall be Honorary President, President, First Vice-President, Second Vice-President, Secretary, Treasurer, United Offering Treasurer, Correspondent Church Periodical Club.

ARTICLE V.

These officers shall be elected by the women in their annual meeting, during Convention of each year, and shall serve until their successors shall be elected.

ARTICLE VI.

The duty of the President shall be to call meetings and preside over them.

ARTICLE VII.

The Vice-President shall preside over meetings in the absence of the President.

ARTICLE VIII.

The duties of the Secretary shall be to give notice of meetings and keep record of them; to correspond with Parish Secretaries and with the Secretary of the Auxiliary; to obtain yearly reports from the Parochial Branches and incorporate them into an annual report for the Diocesan Branch.

ARTICLE IX.

The duties of the Treasurer shall be to receive and disburse the moneys of the Diocesan Branch; obtain reports yearly from the Parish Treasurers and make up from them an annual report.

ARTICLE X.

The officers, as a committee, shall use such efforts as lie in their power to increase missionary knowledge and zeal among the women of the diocese, and to encourage the formation of Parochial Branches.

ARTICLE XI.

An annual meeting shall be held each year, at the time and place of the Diocesan Convention. Special meetings may be held during the year, upon the united call of three Parochial Branches, for the purpose of increasing interest.

ARTICLE XII.

This Constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present.

ARTICLE XIII.

Two delegates or two alternates shall be sent from each Parochial Branch to attend each annual meeting.

BY-LAWS.

The officers shall hold an executive meeting before each general meeting, and at one other time during the year, at the call of the President.

The regular order of business for the annual meeting shall be as follows:

Minutes of the Fifteenth Annual Meeting.

FIRST DAY.

The Fifteenth Annual Meeting of the Woman's Auxiliary of the Diocese of Iowa convened in Davenport on Tuesday, May 20, 1902. The Holy Communion was celebrated in the Cathedral, and, after a delicious luncheon served by the ladies of the Cathedral congregation, the Auxiliary reassembled in the Cathedral for the Bishop's address, but owing to a delay in the organization of the Convention it was found advisable to adjourn to Trinity Church and proceed with the programme for the afternoon. It was found that thirty-five delegates representing twenty-three different branches had registered, as follows:

There were also in attendance, of the diocesan officers, the Honorary President, the President, the Second Vice-President, the Treasurer and the Treasurer of the United Offering, with a number of interested visitors,

making a total attendance of about sixty. The President, Miss Henningsen of Lyons presided. Owing to a vacancy in the office of Secretary, Mrs. Stilson of Des Moines served as Secretary *pro tem.*

Upon motion of Mrs. Jackson of Council Bluffs the reading of the minutes of the last annual meeting was omitted.

The report of the Special Committee on Revision of the Order of Business was accepted.

An Auditing Committee was named, consisting of Mrs. Jackson, Council Bluffs; Mrs. Taylor of Ottumwa, and Miss McCormick of Chariton.

Next came the President's summary, a review of the work accomplished during the year, showing all the pledges except that to the Babcock Fund as paid in full. Upon motion of Miss Bennett of Oskaloosa the deficiency, amounting to \$21.63, was more than made up by an offering from those present, leaving a surplus of fifty-seven cents.

A resolution by Mrs. Jackson of Council Bluffs, "That in future all resolutions of importance be submitted in writing, with the name of the mover attached thereto," was carried.

Miss Kimball of Davenport presented a motion "That the three pledges — to the Bishop's Fund, for theological students, the Babcock Fund, and the one to the General Board — be renewed as they stood last year." Carried.

Moved by Mrs. Symons of Des Moines "That delegates present, as far as they feel free to do so, make pledges for their Branches." Carried, and a number of pledges were at once made to the Babcock Fund: Des Moines, St. Paul's, \$5.00; Independence, \$5.00; Council Bluffs, St. Paul's, \$5.00; Ottumwa, \$5.00; Burlington, \$5.00; Chariton, \$3.00; Lyons, \$5.00; Sioux City, St. Thomas', \$5.00; Davenport, Cathedral, \$5.00; Davenport, Trinity, \$5.00, a total of \$48.00.

A resolution offered by Mrs. Reilly of Clinton "That in future Parish Auxiliaries instruct delegates to the Diocesan Convention to pledge the amount of their contributions to the various diocesan pledges," was adopted.

Moved by Mrs. Jackson "That in future the Diocesan Secretary send blanks to the secretaries of the various Branches in which to fill out their annual reports," carried.

A letter of greeting from Miss Emery, of New York, our General Secretary, was read. In it she expressed the wish that, as far as possible, generous gifts be made to the General Board of Missions.

Moved by Miss Bennett "That a committee of three be appointed by the chair to revise the Constitution." Carried, and Mrs. Foley of Council Bluffs, Mrs. Reilly of Clinton, and Miss Bennett of Oskaloosa, were appointed, the committee to report at the next Convention.

Moved by Mrs. Taylor, of Ottumwa, "That the Committee on Revision of the Constitution adopt some manual of parliamentary law as the standard of government in the annual meetings." Carried.

A discussion on the best methods of conducting meetings in the Parochial Branches closed the work of the afternoon.

SECOND DAY.

The General Missionary meeting at the Cathedral was held at 9 o'clock Wednesday morning. The annual report of the Auxiliary work was presented and addresses made by Mr. John W. Wood, Corresponding Secretary of the General Board of Missions, by the Rev. John Henry Hopkins, of Chicago, by Mrs. John Henry Hopkins, and by the Rt. Rev. Samuel C. Edsall, D.D., Bishop of Minnesota. After the closing prayers by the Bishop of Iowa the members of the Auxiliary adjourned to Trinity Church and proceeded to the business of the second day without waiting until the time named on the programme (2 P. M.).

First in order was the reading of the minutes of the first day's session, which were accepted and ordered filed.

Next came the report of the Auditing Committee and one from Miss Kimball upon the Perry Memorial Room. Both were accepted and the committees received a vote of thanks from the Auxiliary.

Miss Kimball and Mrs. Allen of Davenport were reappointed committee on Perry Room.

The regular reports for the year followed—Church Periodical Club, the Junior Work, the United Offering, and the Treasurer's—and were all accepted, and after a rising vote of thanks to the officers for their work, which was suggested by Mrs. Arnold of Burlington, the meeting adjourned for lunch, which was served by the ladies of Trinity Church in their Guild Hall.

Immediately after lunch the delegates re-assembled and listened to the Secretary's report, which was accepted. Next came the election of officers, Mrs. Foley moving that all nominations be made by an informal ballot. Carried.

Mrs. Morrison in the chair appointed as tellers Mrs. Foley, Mrs. Greer and Mrs. Jones.

President's Summary.

Dear Friends and Fellow Workers — In rounding out this fifteenth year of the existence of our Diocesan Branch we close a season which, in many respects, has marked a decided advance in our work.

Iowa's participation in the Triennial Meeting of last October, distant as the place of meeting was, both in the number in attendance, in its share in the Missionary and Historic Exhibit, and in the intense interest displayed in all the notable features of that distinguished gathering, was much greater than ever before. We cannot but feel that this coming in touch with the larger features of our common work will broaden our own vision for the future and make our pathway more clear.

In the matter of organization we also took a decided forward step when, by the action of our last year's meeting, our staff of Diocesan officers was increased by the addition of two Treasurers. Such changes always involve a certain amount of work and readjustment, therefore, we cannot say that in this first season labor has thereby been lightened, but the lasting benefit of this change in accommodating and extending our growing work cannot be questioned, neither can the zeal and efficiency with which these new officers have performed their duties be too highly praised.

Another step in systematizing and advancing our work was in the drawing up of an Order of Business adequate to our present needs — the one which has stood in our By-Laws for years having been a dead-letter almost from the first. We believe that the interest and efficiency of our Annual meetings will be decidedly advanced by this change.

I would also earnestly recommend that a committee be appointed at this present meeting to revise the Constitution and bring in its report

next year. Our Constitution, as it now stands, defines the duties of some officers and not of others, and in various respects should be harmonized and brought up to present requirements.

It is a pleasure to be able to report that the total of our work shows an increase, as it has done for several seasons past. The advance in a number of our branches has indeed been very marked, and while local and temporary causes have brought about a decrease in some others, yet there are only a few points where conditions seem really discouraging. This applies to what we call our *working* branches; we carry on our list some in which the Auxiliary is a name only, and in which, season after season, shows, so far as we have knowledge, no distinctively woman's missionary work done. We carry them because from the little seed sown a harvest may yet spring—has sprung in more than one instance in the past, and we can afford to wait, and hope, and pray.

The total of our box work varies little from year to year, our growth being, as is most desirable, in the direction of cash offering. There is a notable increase, however, this season, in the proportionate value of boxes going outside the Diocese, which is also a step in the right direction. I would again urge that as many branches as possible, more particularly those making of boxes for the personal use of missionaries and their families, take up this work early in the season, instead of waiting for Lent.

Besides the objects taken up at our last annual meeting a special (the Twing Memorial) has occupied our attention during the season. This last awakened much interest and in the short time allowed a goodly number of our branches responded, but on some of our regular pledges we have not done so well. The General Missions pledge is somewhat ahead of last season's; with the help of a surplus, which we shall not again have, our Bishop's pledge has barely been redeemed, while the Babcock pledge lags seriously behind, being short \$21.63. This has not happened during my term of office, and I am sure it is not the desire of any one present that we close our year with a deficiency. I would therefore recommend that offerings be called for this afternoon to redeem the pledge, so that we may go before the Convention tomorrow morning with a clean balance sheet.

While on the whole the increasing efficiency and stability of our work is really marked, yet our weakness calls for attention. In making reports of the year's work there is great room for improvement; usually the smaller the Branch and the fewer the items covered, the more imperfect the report. The existing vacancy in the Secretaryship and my own tabulation of this year's reports give me opportunity to know the exact conditions in this respect. Let me say that of 50 places 12 were not heard from at all, having apparently done no work during the year, while 12 others failed to send in any such formal report as was called for, leaving the dio-

cesan officers to glean from the statements of the Treasurers, and from correspondence during the year, the items of their work as best they could—surely a failure of duty on the part of the local Secretaries. Again, of the remaining 26 only *eight* sent in reports absolutely correct—that is, requiring neither change nor explanation. I am at a loss to understand some of the errors, but they come mainly under three heads—omissions, seeming to show that no correct record of gifts has been kept—duplications, by which the same dollar is made to do duty several times over, and confusion of funds, such as when money which has been sent for the Babcock pledge is afterwards reported as given to the Bishop's pledge, etc. Every such error greatly increases the labors and anxieties of the diocesan officers in their efforts to keep their funds and balances even, and this whole matter is called to your most serious attention in order that greater care may bring about an improved condition of things.

That the hearts of an increasing number of women throughout the diocese are in this work we are firmly persuaded, and so with thankfulness for the fruits of the past year, with an earnest appreciation of the cordial co-operation received from the various workers, and with prayers for a blessing upon your deliberations here, as well as upon the efforts of the future, your President closes this summary of our Fifteenth season.

Report of Special Committee on Revised Order of Business.

The special Committee, consisting of the diocesan officers, appointed by vote of your last annual meeting to revise the By-Laws as regards the Order of Business, in conformity with the present needs and conditions of the work, would respectively report that on call of the chairman the committee met at San Francisco on Oct. 2, 1901, with seven of its eight members present, and at that conference and by much subsequent correspondence they have agreed to recommend to you, for adoption, the following Order, the same having been also examined in detail by Bishop Morrison and approved by him.
