PROCEEDINGS OF THE MEETING

The Iowa Branch of the Woman's Auxiliary to the Board of Missions met in annual session in Des Moines May 29th and 30th, 1910.

An executive session of the Diocesan officers was held Saturday evening, May 28th, in the Guild rooms of St. Paul's Church.

On Sunday morning special services were held in each of the three Des Moines Churches. The Rt. Rev. James Fielding Sweeny, D. D., Bishop of Toronto, was the preacher at St. Paul's Church; the Rev. William C. De Witt, D. D., Dean of the Western Theological Seminary, Chicago, at St. Mark's Church; and the Rev. T. P. Thurston of St. Paul's Church, Minneapolis, at St. Luke's Church.

The members of the Woman's Auxiliary were invited to hear the address given to the Brotherhood of St. Andrew in St. Paul's Church on Sunday afternoon, and afterward to attend the meeting of the Daughters of the King in the lecture room of the church. Mrs. G. Z. Burton, President of the Local Assembly in the Diocese of Chicago made an address to the Assembly.

The Missionary Mass Meeting held in St. Paul's Church in the evening was presided over by Bishop Morrison. The speakers of the morning were again heard. An address was also given by Mr. W. R. Sterling, of Chicago.

MONDAY, MAY 30TH

The officers and members of the Woman's Auxiliary attended the opening of the Diocesan Convention in St. Paul's Church

and after hearing the Bishop's address retired to the lecture rooms of the First Presbyterian Church, where the business meetings were held.

After a short devotional service, led by the Rev. Robert B. H. Bell, the meeting was called to order by the president, Mrs. Arthur.

The Very Rev. Marmaduke Hare, M. D., introduced the Rt. Rev. James Fielding Sweeny, Bishop of Toronto, who gave a very inspiring address, the spirit of which pervaded the conferences of the day. He spoke from the scriptural text, "The Love of Christ Constraineth Us," which is the motto of the Toronto branch of the Woman's Auxiliary, and suggested that the Iowa branch adopt it as theirs also. A rising vote of thanks was extended the Bishop and he was asked to carry greetings of love and good-fellowship from the Woman's Auxiliary in Iowa to the Woman's Auxiliary in Toronto.

On motion the motto, "The Love of Christ Constraineth Us," was adopted.

Mrs. Weber, of Des Moines was appointed as special secretary to report for the press.

The minutes of the last annual meeting were read and approved.

Other than those named, there were some thirty or forty Des Moines ladies in attendance.

The annual report of the Treasurer was read and accepted.

The annual report of the Secretary was read and approved, but left open until the close of the meeting for reference.

The annual report of the Treasurer of the United Offering was read and accepted.

The report of the Correspondent of the Church Periodical Club was read and approved.

The report of the Committee for the Perry Memorial Room was read by the secretary and accepted.

The following Committee on Resolutions was appointed by the President:

Mrs. Jackson of Council Bluffs, Mrs. Briggs of Dubuque and Mrs. Mayne of Sioux City.

At noon a message was received inviting the members of the Auxiliary to the parlors of St. Paul's Church, where luncheon was to be served by the ladies of the three Des Moines churches.

On motion the meeting adjourned until 1:30 p. m.

AFTERNOON SESSION.

This session was opened by singing and prayer, led by the President.

The Secretary read the report of Junior work and also a letter from Miss Emery. Miss Emery's letter will be printed in the Iowa Churchman.

The convention then listened to the President's annual address, which appears elsewhere in the Journal.

The Rev. Seth M. Wilcox spoke to the Auxiliary concerning St. Katharine's School for Girls. He reported it in a very flourishing condition and asked parents to consider this institution when planning to send their daughters away to school.

The Auxiliary was next favored by a visit from the Rev. C. C. Rollet, Secretary of the Sixth Missionary Department. He spoke of bringing about the Brotherhood of Man as the great work to be accomplished in the present century.

Miss Leoni McMillen read a carefully prepared paper on the spiritual side of Missions.

Mrs. E. S. Earhart, of Des Moines, and Mrs. H. L. A. Fick, of Independence, each had excellent papers on the Junior work. Mrs. Earhart being called away from home a few days before, her paper was read by Mrs. Geo. W. Holton.

The financial side of Missions was taken by Mrs. Devin, who spoke on the United Offering, and Miss Henningsen, who explained the plan of the Apportionment. Discussions followed these papers as much as time would permit.

The President announced that the election of officers was next in order, and that at least two new officers must be elected, as

the Second Vice-President and the Secretary had each notified her that it would be impossible for them to serve longer.

Mrs. W. D. Williams and Mrs. W. G. Mercer were appointed tellers.

An informal ballot for President was taken. The tellers announced that all ballots cast were for Mrs. Arthur. The Secretary was instructed to cast the whole ballot of the Convention for Mrs. Arthur. The ballot was so cast.

An informal ballot for First Vice-President was taken. Mrs. Loring received all the ballots cast. The Secretary was instructed to cast the whole ballot for Mrs. Loring. The ballot was so cast.

An informal ballot for Second Vice-President was taken. The tellers reported thirty-two ballots cast, thirty of these were for Mrs. E. S. Earhart of Des Moines. The Secretary was instructed to cast the entire ballot of the Convention for Mrs. Earhart. The ballot was so cast.

An informal ballot was taken for Secretary. The tellers reported all but three ballots were for Miss Mary Newell Watson, of Iowa City. The Secretary was instructed to cast the whole ballot for Miss Watson for Secretary. The ballot was so cast.

A motion prevailed that the rules be suspended and Mrs. Cooper, Mrs. Devin and Mrs. Hinkle be re-elected to the offices which they now hold, viz: Treasurer, Treasurer of United Offering and Correspondent of Church Periodical Club; and that the Secretary be instructed to cast the unanimous vote of the Convention accordingly. The vote was so cast.

Moved by Mrs. Morrison that the Auxiliary pay the whole cost of printing the journals. Carried.

Moved by Mrs. Cooper that a nominal sum of ten cents be asked for each Journal to meet the cost of printing. Upon discussion it seemed better that the Branches should increase their contributions for current expenses rather than collect for the Journals, and the motion was lost.

A motion was carried that we ask the Secretary of the Diocese to print the Auxiliary Journal with the Journal of the Convention.

Miss Weare reported that the Convention had voted to meet in Sioux City next year, and in behalf of her Parish, invited the Auxiliary to hold its annual meeting there at the same time. The invitation was accepted with a vote of thanks to the Churchwomen of Sioux City.

By motion of Mrs. Cooper a vote of thanks was given the retiring Secretary for faithful service rendered during the five years she held the office of Secretary.

Mrs. Arthur suggested that our newly adopted motto, "The Love of Christ Constraineth Us," appear on our stationery, programs, etc.

The report of the Auditing Committee was read and accepted.

The Committee on Resolutions presented the following report, which was adopted:

WHEREAS, A loving Heavenly Father, in His infinite wisdom, has called unto the life eternal the following beloved members of our Auxiliary: Mrs. George Weare, Sioux City; Mrs. Jane White, Cathedral Branch, Davenport; Mrs. George Watson, Iowa City, therefore be it.

Resolved, That we, the members of the Iowa Branch of the Woman's Auxiliary here assembled express our loving appreciation of their work, our sorrow that their efforts may no more be used for the spread of the Master's Kingdom on earth, and that our labors together are ended until we meet "over there"; may it be truly said of them "they rest from their labors, and their works do follow them."

To those members of their families who are left to mourn their loss, and particularly to our dear past President, Miss Weare, in the loss of her beloved mother, we extend our most loving sympathy in their hours of sorrow and bereavement and pray the Comforter may be given them most abundantly.

Some of our most valued members have been very near the "Dark Valley" since last we assembled together, and our grateful thanks go out to our dear Heavenly Father who has spared them for, we hope, many years of further usefulness and activity in His service in our Diocese.

Resolved, That our hearty thanks be extended to the able and efficient officers of this Iowa Branch of the Woman's Auxiliary, who have served us so faithfully during the past year.

Resolved, That we, the Iowa Branch of the Woman's Auxiliary realize we have been unusually favored by the presence and counsel of the Right Rev. James Fielding Sweeny, Bishop of Toronto; we wish that every word of encouragement and admonition received from him could have been heard by every member of every Branch of the Woman's Auxiliary throughout this Diocese; we desire to express our grateful thanks to him for his timely and appropriate suggestion of the beautiful text to be our motto, and whenever we repeat, "The love of Christ constraineth us" our loving thought and appreciation will go out to the Bishop of Toronto.

Resolved, To other members of the Clergy who have so willingly assisted in the success of this meeting, to Mrs. Burton who so kindly came from her home in Chicago to give us words of greeting and good cheer, and to the officials of the Central Presbyterian Church for their kindly use of their parlors in which to hold our meetings our most sincere thanks are due and herewith tendered.

Resolved, That our hearty thanks are extended to the good friends of the Churches in Des Moines for their kind hospitality and generosity; they have made our sojourn among them most pleasant and enjoyable, their hearts and their homes have been open to us, and their gracious kindness will long remain a pleasant memory in our hearts.

Resolved, That these Resolutions be adopted by a rising vote, and a copy of same be spread upon our records.

PRESIDENT'S ADDRESS

Another year has passed and we are met together here in Des Moines in our twenty-third annual Conference. We have a great deal to be thankful for and to rejoice over and some few things to regret. God has been very good to us. We have lost but few of our members by death; no Diocesan or Parish Officers. Our work has grown in interest, strengthened by prayer and study. The results are seen in the substantial offerings made which has enabled our Treasurer to meet all pledges and bills made by the Auxiliary of the Diocese of Iowa. Our United Offering Treasurer reports the \$1,000 and more in hand towards our great Triennial Thank Offering.

Three very interesting and profitable Deanery Meetings have been held this year. These meetings have been especially helpful to me as at each one there were two Diocesan Officers present and several delegates from Parish Branches, giving an opportunity for conference and helpful discussion and extending acquaintance among the women of the Diocese. I hope that we may have such meetings in each Deanery the coming year, with even better results.

One new branch has been organized and some have been revived and are doing excellent work. Your President has visited only two branches and attended three Deanery meetings. Many letters have been written asking for the prayers, interest and co-operation of our Church women throughout the Diocese. And I believe we can say, as did St. Paul, as he drew near Rome and met the brethren, "We thank God and take courage."

We have to regret that our Junior work is making very little progress. And because of this we have not paid our apporportion-

ment of \$365—\$325 for the women, \$25 for the Juniors, and \$15 for the Babies—asked for by the Woman's Auxiliary towards the \$100,000 pledged to the Board.

We also regret that there have been no volunteers from our Diocese, the gift of selves for the great work of winning souls for the Master. Let us pray earnestly that God will put into the hearts of some of our girls a desire to go forth full of love, zeal and courage.

“Pray that there never may be lacking a due supply of men and women, intense in spirit, keen to see the things that abide, full of courage and spirited vision. Remember that these must grow from the soil of the Church, thrown up as the flower from the roots; and the roots are the thousands of praying, devoted, selfless men and women who, working out of sight, are doing their part to provide leaders who will guide the Church of the future. As I listened not long ago to Deaconess Routledge, one of our United Offering Missionaries from the Philippines who does settlement work in Manilla. I thought, ‘What a useful life hers must be! And why should we shrink from having our girls seek to uplift down-trodden, neglected women and helpless little children to whom the name of Christ and the comfort of the blessed Gospel are unknown. What greater success in life could we wish for them.’”

Let us realize that the spirit of Christ is the spirit of Missions. And the more our children are filled with missionary enthusiasm the more like Him they will become. “Let us pray Him to bless the children of this Church, that in their work for Missions many may hear the call to Missionary service. Let us pray for the parents that “They may not withhold their children from the service of the Church at home or abroad,” remembering always the words of a favorite poem of one of the grand old Bishops of our Church,

“Howe’er it be, it seems to me
’Tis only noble to be good;
Kind hearts are more than coronets,
And simple faith than Norman blood.”

In regard to our Triennial thank offering, I would like to quote the words of a faithful Church woman who said, "I think we get our United Offering money much more easily since we have inaugurated the plan of asking the women to bring the money to the Church at special service and I think the custom of making individual offerings anonymous a good one. I feel strongly that our gifts should be as unto the Lord and not as unto men. They are the gifts that help, for they bless the cause and the giver. We must do our best the next four months. It is wonderful how much can be accomplished if we work in the right spirit. Really caring, and really trying, and all for the sake of our dear Lord." I call this the true Auxiliary spirit, the spirit we all must cultivate more and more if we wish success to crown our efforts.

Last year at Sioux Falls the women passed a resolution that we set aside the Feast of Saint Michaels and All Angels (Sept. 29) as a day of prayer, and supplication for God's blessing upon our work, every part of our Church work, a union meeting of all the women of our Parish beginning with corporate communion, followed by appropriate prayers and Scripture reading and address from our Rector. The idea is that it is the only proper way to begin the Church activities after the summer vacation.

The leaflets from the Prayer League, also cards of membership spoken of in Miss Emery's letter, have been provided for distribution, also several other valuable tracts from the Church Missions House. It is hoped that you will all help yourselves to them and follow the example of your President by signing the card and sending it into the League, thereby becoming a member. It will cost you nothing and there is a great deal to be gained, if you read the Quarterly faithfully, with your hearts attuned to God and the extension of His Kingdom.

In conclusion let me say a word about our Journal, our annual report. It is a harmless looking book, but it costs a goodly sum of money for printing it and paying freight and postage to get it into circulation. Please study it carefully, and note the value of its contents. Nearly everything you want to know

about the Woman's Auxiliary of the Diocese of Iowa is contained in our Journal. "A word to the wise is sufficient."

I know of no better way to end this summary than to quote some words printed in the Ontario Churchman and copied by another Diocesan President.

"There is in your Church a young lady who will join the Auxiliary or Guild if you ask her; a woman who will send her children to Sunday School if you ask her; a woman waiting for an invitation to join; and still another, tender in sorrow, who will make a special offering if you ask her; another, who, out of great gratitude, will make a special offering if you ask her; a man who will become an honorary helper if you ask him; there is a man and a woman who will subscribe for a Church paper if you ask them, also for missionary papers for the children; another who will ask a friend to subscribe for them also if you ask them; a woman who will pray for Mission work if you ask her; perhaps there is another who will give herself to the work if you ask her. The Master is waiting for you, and you, and you to do His work."

BY-LAWS

ARTICLE I.

NAME AND OBJECT.

Section 1. This association shall be called the Iowa Branch of the Woman's Auxiliary to the Board of Missions.

Sec. 2. The object of this association shall be the same as that of the General Auxiliary.

ARTICLE II.

All Parochial Missionary Societies of women, and all baptized women of the Diocese desiring it, who contribute prayers or gifts to Missions, shall be considered members of this association.

ARTICLE III.

OFFICERS AND DUTIES.

Section 1. The officers shall be: Honorary President, President, First Vice-President, Second Vice-President, Secretary, Treasurer, United Offering Treasurer, and Correspondent Church Periodical Club.

Sec. 2. The President shall have general supervision of the Auxiliary work in the Diocese, shall call meetings, preside over them and perform such other duties as may pertain to her office.

Sec. 3. In the absence of the President, the Vice-Presidents—in the order of the office—shall perform the duties of the President. The First Vice-President shall be editor in charge of the Auxiliary columns in the Iowa Churchman, and perform such other duties as may be assigned her by the President or the Bishop. The Second Vice-President shall have charge of all the Junior work, and shall make a report of the same at the annual meeting.

Sec. 4. The Secretary shall give notice of meetings and keep a record of them; shall correspond with Parish Secretaries and with the General Secretary of the Auxiliary, and perform such other duties as may pertain to her office. She shall obtain yearly reports from the Parochial Branches and incorporate them into an annual report for the Diocesan Branch.

Sec. 5. (a) The Treasurer shall receive all moneys (excepting the United Offerings), including those from the Junior and Babies' Branches, keep an accurate account of the same as received and disbursed by her, pay all bills upon written order signed by the President, and perform such other duties as pertain to her office, making a complete report of the same at the annual meeting.

(b) The United Offering Treasurer shall keep an accurate account of the United Offering Fund, collecting said funds from the Parochial Branches the 1st of September, each year, giving a receipt therefor, distribute United Offering boxes, and make a complete report at the annual meeting.

Sec. 6. The Correspondent of the Church Periodical Club shall try to interest all Parochial Branches in this department of the work, shall supervise the distribution of all literature and make an annual report of the same.

Sec. 7. A box shall be provided, called "The Mission Supply Box," which shall be in charge of some member of this Auxiliary to be appointed by the President for the purpose of receiving such contributions from weak branches of the Auxiliary as are anxious to assist in this part of the good work, but feel unable to assume the responsibility of filling a complete box alone.

Sec. 8. The officers, as a committee, shall use such efforts as lie in their power to increase Missionary knowledge and zeal among the women of the Diocese and to encourage the formation of Parochial Branches.

Sec. 9. Vacancies in office shall be filled by the Bishop's appointment.

ARTICLE IV.

MEETINGS.

Section 1. An annual meeting shall be held each year at the time and place of the Diocesan Convention.

Sec. 2. Special meetings may be held during the year upon the united call of three Parochial Branches, for the purpose of increasing interest.

ARTICLE V.

DELEGATES.

Three delegates or their alternates shall be sent from each Parochial Branch to attend each annual meeting, one of these delegates being the Rector's wife, if he have one.

ARTICLE VI.

AMENDMENTS.

This Constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present.

I.

EXECUTIVE MEETINGS.

The officers shall hold an executive meeting before each general meeting, and at one other time during the year at the call of the President.

II.

ORDER OF BUSINESS.

The regular order of business for the annual meeting shall be as follows:

FIRST DAY.

1. Opening Service and Corporate Communion.
2. Bishop's Address.
3. Organization and Minutes.
4. Appointment of Committees.
5. President's Summary.
7. Business.
8. Conference.

SECOND DAY.

1. General Missionary Meeting, with Addresses and Reports to the Convention.
2. Minutes of First Day's Session.
3. Reports of Committees.
4. Annual Reports in Order.
5. Election of Officers.
6. Unfinished Business.

III.

CONDUCT OF BUSINESS.

All meetings shall be conducted by the rules of Parliamentary Law.

IV.

ELECTION OF OFFICERS.

1. The Bishop's wife shall be the Honorary President. The other officers shall be elected by the women in their annual meeting during Convention of each year, and shall serve until their successors are elected.
2. They shall be nominated by informal written ballot, and the two receiving the highest number of votes shall be considered nominees for that office.

V.

AMENDMENTS.

1. These By-Laws may be amended at any meeting by a vote of a majority of those present.
2. By unanimous consent any article of these By-Laws may be suspended for one regular meeting.
