JOURNAL

PROCEEDINGS OF THE MEETING.

The Iowa Branch of the Woman's Auxiliary to the Board of Missions met in annual session in Burlington May 25th, 1913.

The services on Sunday were held in Christ Church. The Right Rev. Sidney C. Partridge, D. D., Bishop of Kansas City, was the preacher at the morning service.

At the Mass Meeting in the evening, the speakers were Mr. George Henry of Des Moines, Bishop Partridge and the Right Rev. Harry S. Longley, D. D., Suffragan Bishop of Iowa.

MONDAY, MAY 26.

At 7 A. M. there was a celebration of the Holy Eucharist, the Rev. Wm. D. Morrow, Celebrant.

The officers and members of the Woman's Auxiliary attended the opening of the Diocesan Convention in Christ Church and, after hearing the Bishop's address and an address by the Suffragan Bishop, retired to the Parish House where the business meetings were held. After prayers said by Bishop Longley, the meeting was called to order by the President.

Bishop Partridge gave an interesting talk on Japan. He was followed by the Rev. Charles C. Rollit, who urged the use of the Duplex envelope and the necessity of interesting children in Missions.

The Junior Branch held a short session during the morning with Mrs. Fick.

It was moved and seconded that the Diocesan officers be accredited delegates.

The Treasurer's report was read and accepted as far as completed. The Offering amounted to \$20.50.

The subject of the money on hand for a lace teacher for the Tama Indians was then discussed. It was decided to leave the money on deposit.

The Meeting then adjourned to the Church for Noon-day prayers.

AFTERNOON SESSION.

At 2 P. M. Bishop Longley addressed the Auxiliary on Diocesan Missions, urging all to interest persons in the work.

Moved and seconded that the usual order be dispensed with and the Auxiliary listen to Mrs. H. L. A. Fick on the "Iowa Idea" and to Mrs. Longley on the "Value of the Mission Study Class."

Moved and seconded that Mrs. Longley's paper be printed in the "Iowa Churchman."

The President then appointed Mrs. Morrison, Mrs. Fick and Mrs. Jackson a Committee on Resolutions for the "Iowa Idea". Which resolution was read and carried.

RESOLVED: That the Iowa Branch of the Woman's Auxiliary to the Board of Missions, endorses the "Iowa Idea," which suggests the sending of money, as a substitute for the boxes formerly sent to Missionaries, excepting in such cases, where a Missionary expresses his preference for a box, or where a Parish Branch is unable to make such substitution. The sum of money substituted shall represent the money value placed upon the box and shall be known as a "Special Supplementary Stipend Fund."

Wherefore, we, the Iowa Branch of the Woman's Auxiliary agree to discontinue from the time of this Annual Diocesan Convention, May 26, 1913, placing a value on the boxes sent out by this Diocesan Branch.

Mrs. Jackson reported that the Convention had voted to meet in Council Bluffs next year and in behalf of her Parish invited the Auxiliary to hold its Annual Meeting there at the same time.

The following annual reports were then read and accepted: Secretary's, United Offering, Treasurer's, Perry Memorial Room, Deanery Chairman's, Necrology Committee and the Educational Secretary's.

Moved and seconded that the Iowa branches study "The Emergency in China" during the coming year.

The Resolution passed by the Pennsylvania Auxiliary, viz: That the United Thank Offering of 1916 be devoted entirely to the training, sending and support of women for Mission work at home and abroad, and to the care of such as are sick or disabled, was read and favorably received.

Moved,—That the Iowa Churchman be asked to print the Pennsylvania resolution in order that the delegates may be able to study the resolution before the General Convention, and act according to their judgment.

After serving the Auxiliary faithfully for five years, Mrs. Arthur asked to be released from work, again she was un-

animously re-elected President, but declined.

RESOLVED: That we extend a most hearty welcome to Mrs. Harry S. Longley, wife of our Suffragan Bishop, and rejoice to know that we have gained such a valuable addition to our Auxiliary.

RESOLVED: That our preciation be extended to the

Parish of Christ Church, Burlington, for their delightful reception and most hospitable entertainment given the clergy, delegates and visitors of the diocese.

RESOLVED: That we extend our hearty thanks to the Iowa Branch of the Woman's Auxiliary to the Board of Missions who have served us so efficiently and faithfully during the past year.

RESOLVED: That these resolutions be adopted by a rising vote, and a copy of the same be spread upon our records.

Moved and carried that the Secretary be instructed to call the attention of the Board of Missions to the "Iowa Idea.

The following motion was made and carried:

Moved by Dean Hare and seconded by Rev. Mr. Sage and carried,- Forasmuch as it is reported that offerings sent by the Woman's Auxiliary, which apply on the Parish Apportionment for several Missions, are often long delayed in reaching the treasurer of the Board of Missions in New York City, and in consequence thereof considerable time often lapses before the Parish is given credit for such offering.

RESOLVED: That the delegates from the Woman's Auxiliary of the Diocese of Iowa, be requested at the Triennial meeting in New York, to ask for some action looking to a more prompt remittance of the offering from the Woman's Auxiliary, which apply on the apportionment to the New York office, and that this action be reported immediately to the Meeting of the Auxiliary now in session.

ADDRESS OF THE PRESIDENT.

To the Members of the Woman's Auxiliary in the Diocese of Iowa:

I began my address last year by saying, "Today we celebrate our twenty-fifth Anniversary." I must correct that statement, for recently, while looking over some old papers, I found the account of the first annual meeting of the Woman's Auxiliary in the Diocese of Iowa, and it was held in Burlington May fifteenth, nineteen hundred eighty-eight. Mrs. Samuel Watson of Iowa City, was the President and Mrs. E. C. Rock of Cedar Rapids, was the Secretary. It is interesting to note that Miss Mary Watson, our present Secretary is a sister-in-law of our first President and that Mrs. Morrison of Iowa City was one of the delegates present at that meeting and again represents her Branch as a delegate at this our twenty-fifth annual meeting in Burlington.

I believe I can report a fairly prosperous and successful year. In some ways we have not advanced. We still have as our chief aim the establishment of a branch of the Woman's Auxiliary in every Parish and Mission in the Diocese, there have been no new ones reported this year.

Five deanery meetings have been held during the year, at Boone, Muscatine, Waverly, Lyons and Le Mars. At each one there was given a good program and much interest by attendance and by generous offerings.

I believe the benefits were greatest in places where the Dean very graciously arranged for a joint session in the afternoon of Clergy and Woman's Auxiliary, with addresses and discussions in which both participated. This certainly furnishes a fine opportunity to co-operate more successfully in the work we are striving to accomplish—The Extension of the Kingdom of Christ at Home and Abroad, through intelligent and systematic study methods.

The most gratifying report I have to record is the Missionary Institute which was held in Des Moines last January, conducted by Miss Emery and Miss Lindley who came via Kansas City to Des Moines from the Church Missions House N. Y.

For three days, more than twenty women from all parts of the state, representatives of all five Deaneries, studied "Japan Advancing," with Miss Lindley as leader and teacher. And each day we had a Conference with our beloved

Miss Emery on Woman's Auxiliary Methods, United Offerings, Duplex Envelope, Systematic Giving, Spiritual Growth, Program Meetings, Study Classes and indeed all phases of the work were earnestly discussed and thoroughly explained.

The value of such an Institute can only be estimated by those whose privilege it was to attend. We hope that there may be more Institutes for us in the future.

Again the angel of death has visited us and removed from our circle a goodly number of faithful women.

Miss Susanne Weare who, for five years labored lovingly with us as President, helping to lay deep and strong foundations upon which we are building the structure of our organization. We miss her cheerful presence and devoted efforts. It was she who said that a five year term of office for the President was her ideal as it gave opportunity for renewed life and influence to pursue all more thoroughly and thereby we shall accomplish greater things. I believe she was right, therefore I am now at the close of my fifth years service, laying down the work I love to do and which has blessed and helped me more than anything I have ever done before. that another may take it up and carry it ever onward and upward to greater perfection. I pray that she too may receive the blessing and the inspiration which surely comes to all those who work and pray and give for the Glory of God and the Salvation of Men. I ask that you give to her the loyal support and the affectionate consideration that have been my comfort and encouragement during the years we have worked together.

I thank every one of you, and our dear Bishop for the glorious privilege which has been mine, and I ask our Father in Heaven that success may always crown the efforts of the Woman's Auxiliary in the Diocese of Iowa.

CONSTITUTION

ARTICLE I.

Name and Object.

Section 1. This association shall be called the Iowa Branch of the Woman's Auxiliary to the Board of Missions.

Section 2. The object of this association shall be the same as that of the General Auxiliary.

ARTICLE II.

All Parochial Missionary Societies of women and all baptised women of the Diocese desiring it, who contribute prayers or gifts to Missions, shall be considered members of this association.

ARTICLE III.

Officers and Duties.

Section 1. The officers shall be, Honorary President, President, First Vice-President, Second Vice-President, Secretary, Treasurer, United Offering Treasurer and Correspondent Church Periodical Club.

Section 2. The President shall have general supervision of the Auxiliary work of the Diocese, shall call meetings, preside over them, and perform such other duties as may pertain to her office.

Section 3. In the absence of the President, the Vice--Presidents—in the order of their office—shall perform the duties of the President. The First Vice-President shall be editor in charge of the Auxiliary columns in the Iowa Churchman, and perform such other duties as may be assigned her by the President or the Bishop. The Second Vice-President shall have charge of all the Junior work, and shall make a report of the same at the annual meeting.

Section 4. The Secretary shall give notice of meetings and keep a record of them; shall correspond with Parish Secretaries and with the General Secretary of the Auxiliary, and perform such other duties as may pertain to her office. She shall obtain yearly reports from the Parochial Branches and incorporate them into an annual report for the Diocesan Branch.

Section 5. (a) The Treasurer shall receive all moneys (excepting the United Offerings), including those from the Junior and Babies' Branches keep an accurate account of the same as received and disbursed by her, pay all bills upon written order signed by the President, and perform such other duties as pertain to her office, making a complete report of the same at the annual meeting.

(b) The United Offering Treasurer shall keep an accurate account of the United Offering Fund, collecting said funds from the Parochial Branches the 1st of September, each year, giving a receipt therefore, distribute United Offering Boxes, and make a complete report at the annual meeting.

Section 6. The Correspondent of the Church Periodical Club shall try to interest all Parochial Branches in this department of the work, supervise the distribution of all literature and make an annual report of the same.

Section 7. A box shall be provided, called "The Mission Supply Box," which shall be in charge of some member of this Auxiliary to be appointed by the President for the purpose of receiving such contributions from weak branches of the Auxiliary as are anxious to assist in this

part of the good work, but feel unable to assume the responsibility of filling a complete box alone.

Section 8. The officers, as a committee, shall use such efforts as lie in their power to increase Missionary knowledge and zeal among the women of the Diocese and to encourage the formation of Parochial Branches.

Section 9. Vacancies in office shall be filled by the Bishop's appointment.

ARTICLE IV.

Meetings.

Section 1. An annual meeting shall be held each year at the time and place of the Diocesan Convention.

Section 2. Special meetings may be held during the year upon the united call of three Parochial Branches, for the purpose of increasing interest.

ARTICLE V.

Delegates.

Three delegates or their alternates shall be sent from each Parochial Branch to attend each annual meeting, one of these delegates being the Rector's wife, if he have one.

ARTICLE VI.

Amendments.

This constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present.

BY-LAWS

I.

Executive Meetings.

The officers shall hold an executive meeting before each general meeting, and at one other time during the year at the call of the President.

II.

Order of Business.

The regular order of business for the annual meeting shall be as follows:

First Day.

1. Opening Service and Corporate Communion.
2. Bishop's Address.
3. Organization and Minutes
4. Appointment of Committees.
5. President's Summary.
6. Business.
7. Conference.

Second Day.

1. General Missionary Meeting, with Addresses and Reports to the Convention.
2. Minutes of First Day's Session.
3. Reports of Committees.
4. Annual Reports in Order
5. Election of Officers.
6. Unfinished Business.

III.

Conduct of Business.

All meetings shall be conducted by the rules of Parliamentary Law.

IV.

Election of Officers.

1. The Bishop's wife shall be the Honorary President. The other officers shall be elected by the women in their annual meeting during Convention of each year, and shall serve until their successors are elected.

2. They shall be nominated by informal written ballot, and the two receiving the highest number of votes shall be considered nominees for that office.

V.

Amendments.

1. These By-Laws may be amended at any meeting by a vote of a majority of those present.

2. By unanimous consent any article of these By-Laws may be suspended for one regular meeting.
