# Proceedings

## PROCEEDINGS OF THE MEETING.

The Iowa Branch of the Woman's Auxiliary to the Board of Missions met in annual session at Council Bluffs, May 17, 1914.

The services on Sunday were held in St. Paul's Church, the Rt. Rev. Nathaniel C. Thomas being the preacher at the morning service; at the Mass Meeting in the evening, the speakers were the Rev. Samuel H. Bishop, Secretary of the American Church Institute for Negroes, Miss Alice French and the Rev. Stanley Kilbourne, Head of the Collegiate Department of the General Board of Education of the Episcopal Church.

At seven o'clock, Monday, May 18th, there was a celebration of the Holy Eucharist, the Rev. William D. Morrow being the celebrant. At nine o'clock, the members of the Woman's Auxiliary assembled for the opening of the Diocesan Convention, and after listening to the addresses of the Bishop and Bishop Suffragan, retired to the Public Library, where the business meetings of the Auxiliary were conducted.

Bishop Longley said the opening collects and gave a short talk, reporting a very good year's work in the missionary field of the Diocese and looking forward to a greater work in the coming years.

The President then took the chair and called the meeting to order. The Rev. Samuel Bishop addressed the meeting, telling of the great need of the negroes for more schools and better teachers.

The meeting adjourned to go to St. Paul's for noon-day prayers.

After luncheon the meeting was called to order, at two o'clock. Bishop Morrison gave a very helpful address on the need of consecrated women for church work. He made the suggestion that instead of our annual gift to Ste. Mary's, Keokuk, that sum be given to the mission at Atlantic; as the Advent Offering of the Sunday Schools would take care of Ste. Mary's needs.

The Secretary's Report was omitted, as it was printed in the Journal.

The Treasurer's Report was read and accepted.

The United Offering Treasurer's Report was read; and the Treasurer, Mrs. Crawford, read, also, some items from the Report on United Offering from the Church Missions House.

The resignation of Miss Watson was read and accepted with regret.

The Auxiliary then listened to an inspiring address by the President. (This address is printed in our Journal.)

It was moved and seconded that a Committee be appointed to amend the Constitution and By-Laws. The motion was carried and Mrs. Grant, Mrs. Moore and Mrs. Rohrer were appointed on the Committee.

It was moved and seconded that a Committee be appointed to reconsider the Resolution on the "Iowa Idea"; and to report at this meeting. So ordered. The Chair appointed Mrs. Shutt, Mrs. Allingham and Miss French.

Mrs. Grenier, Mrs. Weber and Mrs. Cox were appointed a Committee on Resolutions.

The Parishes represented were asked to make their pledges for the coming year.

It was moved and seconded that the pledges be apportioned according to the discretion of the Executive Board. Discussion followed. An amendment was offered that the words "except where a pledge has been made for a number of years," be added to the original motion. The amendment carried; and the motion as amended was carried.

A Conference on Woman's Auxiliary work was held, Mrs. Shutt conducting. Those taking part were Mrs. Cooper, Mrs. Crawford, Mrs. Jackson, Mrs. McKune, Mrs. Grant and Mrs. Weber.

Miss Babcock, of Japan (for whose work we have given for many years, and to whom we still give through the General Missions pledge), told us in a most interesting way of her life and work.

Adjourned.

#### TUESDAY, MAY 19TH.

The day began with a special Memorial Service for our Honorary President, Sarah Swazey Morrison. We all took part in our great memorial and sacrificial service, the Holy Eucharist. The celebrants were the Rt. Rev. Harry S. Longley, and the Very Rev. Marmaduke Hare, Miss Alice French and Mrs. Simon Casady paid fitting tribute to our friend and leader.

The business meeting of the day was held in the Public Library.

The minutes of the preceeding meeting were read and approved. The pledges as apportioned by the Board were then read. The President made an appeal for an additional sum of one hundred dollars to be given to Bishop Thomas and to Mr. Bishop (fifty dollars for each) to be used in their respective missionary work.

The fifty dollars for Bishop Thomas was raised in a few minutes; and the fifty dollars for Mr. Bishop was then raised. (The amounts and parishes giving will be found on the Pledge Page of this journal.) A letter from Miss Herrick was read, making a special appeal for "*The Spirit of Missions*."

A letter was read relative to the summer Conferences, asking for co-operation.

The following Branches reported study classes: Cedar Rapids, Burlington, St. Paul's, Sioux City, St. Paul's, Des Moines, St. Luke's, Des Moines.

A letter was read in regard to the Provincial Council. Greetings were sent to the Nebraska Branch, meeting in Omaha.

On motion, the Secretary was directed to express the sympathy and regret of the Auxiliary at their absence, (caused by sickness), to Mrs. Tinley and Mrs. Froom.

It was moved and seconded that a note of love and regret be sent our former President, Mrs. Arthur, who is leaving the diocese. So ordered.

It was moved and seconded, that we send to our retiring Diocesan Secretary most cordial greeting and hearty expression of love and good wishes on the new relations which she is about to assume, combined with our sincere regret that we must lose her from our Diocesan work. So ordered.

A Junior Conference followed, led by Mrs. Longley. Those taking part were Mrs. Shutt, Miss Robinson, Miss Susong, Mrs. Thorndyke.

The Committee on Resolutions submitted the following Report, which was adopted by rising vote:

RESOLVED, That the Iowa Branch of the Woman's Auxiliary sincerely condole with the families of the deceased and commend them for consolation to Him who orders all things for the best.

RESOLVED, That we express our sincere gratitude to our Bishop, the Rt. Rev. Theodore N. Morrison, D. D., to our Bishop Suffragan, the Rt. Rev. Harry S. Longley, D. D., to the Rt. Rev. Nathaniel S. Thomas, the Rev. Samuel Bishop, and to Miss Babcock, our missionary in Japan, for their interesting and instructive addresses; and to the Very Rev. Marmaduke Hare, M. D., Miss Alice French, Lt. D., and Mrs. Simon Casady for their beautiful tributes to our beloved Honorary President, at the Memorial Service.

RESOLVED, That we extend our grateful appreciation to Dr. and Mrs. McCrae for the delightful reception given at their home; and to St. Paul's Parish for the delicious luncheon given at the Grand Hotel, and the most hospitable entertainment given our delegates and visitors during this convention; also to the Library Board and Miss Armstrong for the use of the Auditorium.

It was moved and seconded that, according to Miss Lindley's recommendation, a Junior Board be created in this Diocese, the President being the First Vice President of the Woman's Auxiliary. So ordered.

\* Mrs. Cole declined the office and Mrs. Cooper was appointed by the Bishop and consented to take the office for another year.

A letter from Mrs. Fick relating to Junior work was read.

Mrs. Longley gave a short address on the remarkable work of Ste. Monica's Home, our own Diocesan work for the fallen girl.

Reports were read from the Girls' Friendly Society, and Miss Urban gave a report of the work of the Daughters of the King.

The Committee on Proposed Changes in the Constitution reported the following changes, which were adopted unanimously:

In Article III, Section 3. Exchange duties of the First and Second Vice Presidents, so that the latter part of the section shall read: "The First Vice President shall have charge of all the Junior work, and shall make a report of the same at the annual meeting. The Second Vice President shall be Editor-in-Charge of the Auxiliary columns in *'The Iowa Churchman'*, and shall perform such other duties as may be assigned by the President or the Bishop."

In Article III, Section 5, after the words, "the first of September," insert the words, "and the first of March."

In the By-Laws, in By-Law No. III, add the words "as prescribed in Roberts' Rules of Order."

The Committee on the "Iowa Idea" reported as follows:  
Madame President, Officers and Members:—

Your Committee appointed to consider the desirability of making a change in the Resolution to substitute the equivalent of the value of boxes sent missionaries, in money (generally known as the Iowa Idea), passed at the Convention in 1913, would submit the following resolution as a substitute resolution:

*Resolved*, That the Woman's Auxiliary to the Board of Missions in Iowa be urged to send boxes as in the past, under the direction of the Board of Missions as heretofore; and valued as has been the custom of the Auxiliary before the passage of Resolutions in the Convention of 1913. At the same time, the Auxiliary in Iowa is urged most earnestly to raise a fund of one hundred dollars (\$100.00), to be held by the diocesan treasurer, subject to call in whole or part by Miss Emery for the needs of any missionary; and further, your committee recommend that any parishes willing to give money instead of boxes, raise the amount and place it in the hands of the diocesan treasurer, subject to call by Miss Emery for any *Iowa* missionary who may desire money instead of a box.

Your committee recognizes the validity of the objections urged against the adoption of the Iowa Resolutions in their original form as presented to the Woman's Auxiliary at the late Triennial Convention of the Church, namely, the unwillingness of the great majority of Branches to abandon their accustomed and successful methods and the economy, value and personal acceptability of the boxes in many cases, as well as the unexpressed but equally cogent argument of the practical difficulties of the change.

\* NOTE. Mrs. Hutchinson of Ottumwa has consented to take this office.

But your committee, while understanding the position of the opponents of the Iowa Idea in its first presentation, involving the whole nation and the entire Auxiliary, still feel that the idea, itself, is just and wise, and heartily desire that the diocese attempt the experiment on a small scale of trying its practical working.

The Report was accepted and the Substitute Resolution adopted.

It was moved and seconded that a rising vote of thanks be given Mrs. Cooper, who has so faithfully served the Auxiliary as treasurer for the last seven years, and who had declined a re-election. Carried unanimously.

Mrs. Weber, on behalf of the Auxiliary at Des Moines, invited the Auxiliary to meet in that city next year at the time of the Diocesan Convention. On motion the meeting adjourned.

#### PRESIDENT'S ADDRESS.

To the Members of the Iowa Branch of the Woman's Auxiliary to the Board of Missions:

In looking back over the work of the past year, we are not able to see any great gains made, or any large increase in membership.

We are glad, however, to welcome three new branches that have been organized in the southeastern part of the state by a rector and a deaconess; also the promising Juniors of Des Moines, who have taken up the work of the Woman's Auxiliary so enthusiastically.

Five Deanery meetings were held last year, at Chariton, Sioux City, Mason City, Maquoketa and Des Moines. Because of conflicting dates, your president was not able to attend all of these meetings, and she wishes to make grateful acknowledgment of the kindness of your past president, Mrs. Arthur, who had charge of two meetings.

We gratefully appreciate this opportunity made for us by the Bishop and Deans of meeting the earnest women in the Diocese, and holding conferences on the work of the Woman's Auxiliary.

While we may not at present see any great results, we feel that the Deanery meetings may become a means of education and growth for the women of the Auxiliary.

As these meetings are of local character, the interest and enthusiasm of the session is dependent on the women of the town where the Deanery is held, and I wish to appeal to the loyalty of the members of the Woman's Auxiliary, for without that, the Deanery meeting cannot accomplish its object.

We have had this year the blessing and the inspiration that comes from the Triennial Convention of the Woman's Auxiliary. Three of the five delegates elected at your last Diocesan convention were able to attend. Two alternates were also present as accredited delegates, so that our Diocese had its full representation.

Our Triennial United Offering showed an increase over the offering of 1910, but the gain was not so large as we wish it were.

The offering in 1910 was \$1,375, and in 1913, \$1,539, making an increase of about \$164. Can we not begin now to work for a greater gain for 1916? Let us keep our blue boxes in plain sight. Let us not forget our daily prayer and our daily gift.

We have had one year of practical demonstration of the "Iowa Idea." The appeals of three clergymen who desired money instead of boxes have been answered. One parish sent \$116.25 to a clergyman in Colorado; three parishes sent \$25.00 to a missionary in the Diocese of Ashville; eleven parishes united in sending \$60.00 to a missionary in Oregon.

We recommend that the members of the Woman's Auxiliary continue their endorsement of the "Iowa Idea," but in order that it may become better understood, and that all delegates may carry back to their branches this fact, that because this resolution has been adopted in convention assembled, it should have the sympathy, and so far as possible, the support of all the parish branches, we would recommend that a committee be appointed to bring this matter before this convention.

We take great pleasure in announcing our new Secretary to the Spirit of Missions, Miss Herrick, of Independence. In our Diocese, of over 7,000 communicants, there are now only 156 copies of the Spirit of Missions being received. Our new secretary has a fine opportunity for work, and I bespeak for her your co-operation and support.

Some of the Dioceses now have an Educational Secretary, who visits the different parishes, organizes branches of the Woman's Auxiliary, conducts study classes and institutes, and furnishes information on the literature published by the Board of Missions and the Woman's Auxiliary.

We have long felt the need of such an officer in this Diocese, and we hope that when the work starts in the different branches next fall we shall have found some earnest woman who has the interest and the leisure to take up the duties of this office.\*

Our secretary, after many years of faithful service, tendered her resignation, to take up happy duties in a new home in the East. Her resignation has been accepted with regret, and the vacancy filled by the appointment by the Bishop, of Mrs. Longley, who has most capably performed the duties of the office.

We regret to lose from the Diocese Mrs. Leete, correspondent of the Church Periodical Club.

In August of last year, our entire Diocese was saddened by the death of our beloved honorary president. We miss the encouragement and the wise counsel which were our help and our guidance. We miss her spiritual vision, which was our inspiration. We trust that some fitting memorial be raised by the women of this Diocese in memory of one who served the community with broad-mindedness and self-forgetfulness, who served the church with devotion and self-denial.

# Constitution

## ARTICLE I.

### NAME AND OBJECT.

Section 1. This association shall be called the Iowa Branch of the Woman's Auxiliary to the Board of Missions.

Sec. 2. The object of this association shall be the same as that of the General Auxiliary.

## ARTICLE II.

All Parochial Missionary Societies of women and all baptised women of the Diocese desiring it, who contribute prayers or gifts to Missions, shall be considered members of this association.

## ARTICLE III.

### OFFICERS AND DUTIES.

Section 1. The officers shall be, Honorary President, President, First Vice President, Second Vice President, Secretary, Treasurer, United Offering Treasurer and Correspondent Church Periodical Club.

Sec. 2. The President shall have general supervision of the Auxiliary work of the Diocese, shall call meetings, preside over them, and perform such other duties as may pertain to her office.

Sec. 3. In the absence of the President, the Vice Presidents—in the order of their office—shall perform the duties of the President. The First Vice President shall have charge of all the Junior work, and shall make a report of the same at the annual meeting. The Second Vice President shall be editor in charge of the Auxiliary columns in the Iowa Churchman, and shall perform such other duties as may be assigned her by the President or the Bishop.

Sec. 4. The Secretary shall give notice of meetings and keep a record of them; shall correspond with Parish Secretaries and with the General Secretary of the Auxiliary, and perform such other duties as may pertain to her office. She shall obtain yearly reports from the Parochial Branches and incorporate them into an annual report for the Diocesan Branch.

Sec. 5. (a) The Treasurer shall receive all moneys (excepting the United Offerings), including those from the Junior and Babies' Branches, keep an accurate account of the same as received and disbursed by her, pay all bills upon written order signed by the President, and perform such other duties as pertain to her office, making a complete report of the same at the annual meeting.

(b) The United Offering Treasurer shall keep an accurate account of the United Offering fund, collecting said fund from the Parochial branches on the 1st of September and on the 1st of March each year.

Sec. 6. The Correspondent of the Church Periodical Club shall try to interest all Parochial Branches in this department of the work, supervise the distribution of all literature and make an annual report of the same.

Sec. 7. A box shall be provided, called "The Mission Supply Box," which shall be in charge of some member of this Auxiliary to be appointed by the President for the purpose of receiving such contributions from weak branches of the Auxiliary as are anxious to assist in this part of the good work, but feel unable to assume the responsibility of filling a complete box alone.

Sec. 8. The officers, as a committee, shall use such efforts as lie in their power to increase Missionary knowledge and zeal among the women of the Diocese and to encourage the formation of Parochial Branches.

Sec. 9. Vacancies in office shall be filled by the Bishop's appointment.

#### ARTICLE IV.

##### MEETINGS.

Section 1. An annual meeting shall be held each year at the time and place of the Diocesan Convention.

Sec. 2. Special meetings may be held during the year upon the united call of three Parochial Branches, for the purpose of increasing interest.

#### ARTICLE V.

##### DELEGATES.

Three delegates or their alternates shall be sent from each Parochial Branch to attend each annual meeting, one of these delegates being the Rector's wife, if he have one.

#### ARTICLE VI.

##### AMENDMENTS.

This constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present.

# By-Laws

## I.

### EXECUTIVE MEETINGS

The officers shall hold an executive meeting before each general meeting, and at one other time during the year at the call of the President.

## II.

### ORDER OF BUSINESS.

The regular order of business for the annual meeting shall be as follows:

#### FIRST DAY.

1. Opening Service and Corporate Communion.
2. Bishop's Address.
3. Organization and Minutes.
4. Appointment of Committees.
5. President's Summary.
6. Business.
7. Conference.

#### SECOND DAY.

1. General Missionary Meeting, with Addresses and Reports to the Convention.
2. Minutes of first day's session.
3. Reports of Committees.
4. Annual Reports in Order.
5. Election of Officers.
6. Unfinished Business.

## III.

All meetings shall be conducted by the rules of Parliamentary Law, as prescribed in Roberts' "Rules of Order."

## IV.

### ELECTION OF OFFICERS.

1. The Bishop's wife shall be the Honorary President. The other officers shall be elected by the women in their annual meeting during Convention of each year, and shall serve until their successors are elected.
2. They shall be nominated by informal written ballot, and the two receiving the highest number of votes shall be considered nominees for that office.

## V.

### AMENDMENTS.

1. These By-Laws may be amended at any meeting by a vote of a majority vote of those present.
2. By unanimous consent any article of these By-Laws may be suspended for one regular meeting.
