

Proceedings.

The Iowa Branch of the Woman's Auxiliary to the Board of Missions met in annual session at Des Moines May 16, 1915. The services began on Sunday, May 16th, in St. Paul's Pro-Cathedral with a celebration of the Holy Eucharist at 7 o'clock, the Rev. Harry S. Longley, D. D., being celebrant, and Holy Eucharist at 9 o'clock, the celebrant being the Rev. William C. Hengen, 11 o'clock Holy Eucharist, the Rt. Rev. Theodore N. Morrison, celebrant, Epistoler, Rev. E. H. Rudd, D. D., Gospeler, Rev. George W. Hinkle.

On Monday morning there was a celebration of the Holy Eucharist, the celebrant being the Rev. William Pence James, after which the women assembled to listen to the annual addresses of Bishop Morrison and Bishop Longley. At the close of these addresses the women of the Auxiliary retired to the Y. W. C. A. rooms to consider their own affairs.

The Rev. Alexander H. Grant said the collects and prayers and the President took the chair and called the meeting to order.

The Secretary's report was read and left open.

The report of the Treasurer, Mrs. Cooper, was read and accepted.

The report of the United Offering treasurer was read and accepted.

The Secretary read a report of the Girls' Friendly Society of Lyons, which was accepted.

The President gave her annual address, which was listened to with much enthusiasm.

The chair appointed the following committees:

Noon-day prayers followed and the members of the Auxiliary adjourned for luncheon at Yonker's Tea Room.

At 2 P. M. the Auxiliary assembled for business in the church rooms of the Cathedral.

The Rt. Rev. George Biller of South Dakota now addressed the members of the Auxiliary in behalf of the Sioux Indians in his diocese. Among many interesting anecdotes which he related of the "Wards of the Government," he solicited the sympathy and aid of the women in behalf of the Rev. Mr. Burt, for forty-five years a missionary to the Indians, who, at the advanced age of seventy-one years, refused to leave his post for a furlough but earnestly desired to have a Ford auto by means of which he could more easily visit his scattered congregations.

Contributions and parish pledges were taken for this object and Mrs. Cunningham of Cedar Rapids was appointed custodian of funds.

The Rev. Chas. Rollit followed this with a short speech and the meeting adjourned to allow time for the visitors and members to visit St. Monica's Home. The trip was made by automobiles and street cars and many availed themselves of an opportunity to inspect this church home for fallen girls. Bishop Longley and Deaconess Wurtz addressed an audience from the porch, speaking of the growth and needs of this institution.

Tuesday morning the Auxiliary assembled again for business, the President opening the meeting.

Mrs. Longley gave an interesting talk on Junior work and Mrs. Hutchison, the Educational Secretary, read a most interesting report of her work in the Diocese in awakening interest in Mission Study Classes.

A conference led by Mrs. A. H. Grant followed. Subject: The Woman's Auxiliary. The Junior Auxiliary retired to an adjoining room for conference, Mrs. Longley leading.

Miss Henderson, chairman of the Committee on Revision, recommended the following changes which were adopted:

ARTICLE III.

SEC. 3—To read: In the absence of the President, the Vice-Presidents, in the order of their office, shall perform the duties of the President. The First Vice-President shall be President of a Junior Board which shall have charge of all of the work of the Junior and Little Helpers' Branches, and shall make a report of the same at the Annual meeting. This Board shall be elected each year by the members of the Junior Branches. The Second Vice-President shall be editor in charge of the Auxiliary columns in the Iowa Churchman, and shall perform such other duties as may be assigned her by the President or the Bishop.

SEC. 5—To read: (a) The Treasurer shall receive all monies (excepting the United Offering and the monies from the Junior and the Little Helpers' Branches) keep an accurate account of the same, as received and disbursed by her, pay all bills upon written order signed by the President, and perform such other duties as pertain to her office, making a complete report of the same at the annual meeting.

AFTERNOON SESSION.

Reports from Deanery Meetings were read.

Mrs. L. W. Wheeler read a most interesting and thoughtful paper on "Our Deanery Meetings: Why Are They Held?"

Mrs. Casady of Des Moines reported for the Memorial Committee in the absence of Mrs. Crawford.

By motion carried the chair was given authority to continue same Committee on Memorial as served last year.

Mrs. Whipple of Slater, formerly Deaconess Wiedensee, gave an informal talk on her work in Porto Rico.

Mrs. Hinkle, chairman of Resolutions Committee, read the following:

Resolved, That we thank our Bishop, the Rt. Rev. Theodore N. Morrison, D. D., our Suffragan Bishop, the Rt. Rev. Harry S. Longley, D. D., for their inspiring addresses. Also, to the visitors, Rt. Rev. George Biller, Jr., Missionary Bishop of South Dakota, Mrs. Herman Butler, President of the Chicago branch, and the Rev. C. C. Rollit, we wish to express our great obligations for their presence and helpful words.

Resolved, That we acknowledge the gracious hospitality of Bishop and Mrs. Longley. The reception to the delegates and friends at the Bishop's residence Saturday evening was very delightful. We extend our grateful appreciation for the entertainment received by our delegates and visitors during the Convention from the members of St. Paul's Pro-Cathedral, St. Luke's and St. Mark's parishes. We extend our warm thanks to officers of the Iowa Branch of the Woman's Auxiliary to the Board of Missions, who have served so well this past year, and especially to our most faithful treasurer, Mrs. Matilda E. Cooper, who retires after eight years of faithful service.

REPORT OF THE PRESIDENT.

To the Members of the Iowa Branch of the Woman's Auxiliary to the Board of Missions:

Another year has slipped by, and we are gathered today to review what has been accomplished, and to gain strength and inspiration for what is to come. When we realize that the year is at an end, we feel a sense of regret. We think of mistakes made, of times when greater devotion might have accomplished more.

We are reminded of the story of the beautiful woman who, after this life is o'er, is about to receive her Heavenly crown. She notices that in the circle of jewels that adorn the crown, one gem is missing. She asks why the jewel is not there, and she receives the answer "that is a lost opportunity."

May we be too zealous, too enthusiastic, rather than deaf and blind to the demands of this work. It is indifference that has this opportunity of ours in its grasp, and it will crush out its life unless we are able to throw it off.

Women are everywhere putting money, strength, and energy into the problems of the day; politics, civic betterment, social welfare; all splendid and necessary, but let us not allow them to crowd out "this, our Father's business." This opportunity is the rarest, most beautiful jewel in the crown.

In looking back over the past year, we are most happy to welcome two new branches of the Woman's Auxiliary; one at St. John's, Clinton, and one at St. Pauls, Marshalltown.

At the beginning of the year, we made some changes in the plans for the accomplishment of our work. First, we decided to apportion the pledges in order that there might be no deficiency at the end of the year. The Treasurer's report has shown that this has been a success.

We have had this year the help and the guidance in our study work of a Diocesan Educational Secretary who has visited nearly every parish in the Diocese. Her report will show the increase in the number of study-classes during the past year.

We have had a Junior Board that has had charge of all work of the Junior and the Little Helpers branches. The report of the president of this board shows carefully laid and well thought out plans for the enlistment of Juniors already organized, and for the grouping of new branches of Juniors and Babies.

Four Deanery meetings have been held this year; at Fort Dodge, St. Mark's, Waterloo, St. John's, Clinton, and at Oskaloosa.

Two of these meetings were well attended; interest and enthusiasm were aroused, and they were good meetings.

The Deanery meetings, generally speaking, are not what they should be. I would recommend that every parish branch of the Woman's Auxiliary pay the travelling expenses of a delegate to these meetings. After two years' study of this question, I am convinced of this fact; the deanery meetings are falling far short of their aim, and they will continue to do so until we can make them popular, and the way to make them popular is to see that every branch of the Woman's Auxiliary is represented. Nothing succeeds like success.

In looking forward to our next year's work, let us think seriously of the United Offering. Two years of the triennial have passed. But one remains to make up our offering at the great convention. At New York, in the fall of 1913, Iowa women sent about \$1,530, a gain of only about \$162 over the offering of 1910. Let us work for a larger increase this year. Let us today resolve that this Iowa branch of the Woman's Auxiliary will send a splendid offering to St. Louis in 1916, let us start today to pray and to give for the work of the devoted women missionaries. It is woman's nature to give;

"Go, break to the needy sweet charity's bread,
For giving is living the angel said.
'And must I be giving again and again?'
My peevish and pitiless answer ran.
'Oh, no,' said the angel piercing me through,
Just give till the Master stops giving to you."

We would recommend that the committee named last year to establish a memorial to the late beloved Mrs. Morrison be continued. Their work is started, and when the war is over, and there will be no further need of the help both at home and abroad that has answered the appeals this year, this fund will be created by the church women of Iowa who knew and loved Mrs. Morrison.

These are but a few of the thoughts which I would give you to carry back home with you. Our work is ahead of us. And, in closing, I only wish to tell you again our motto, "The love of Christ constraineth us," the meaning of which I find so well expressed in the following:

BE STRONG.

"Be strong, We are not here to play, to dream, to drift.
We have hard work to do, and loads to lift;
Shun not the struggle; face it, 'Tis God's gift;
Be strong."

ANNUAL REPORT OF THE EDUCATIONAL SECRETARY OF
THE DIOCESE OF IOWA 1914-1915.

The endeavor of your Educational Secretary during the year has been to visit as many parishes as possible realizing that the personal touch is necessary for efficient work and to show results.

Clustering the visits about the dates of the Deanery Meetings saved time, energy and expense.

In preparation for the work it was my pleasure and benefit to attend the Missionary Educational Conference at Lake Geneva last August. Here 350 earnest men and women studied the best way to work for the furthering of Christian living and the development of spiritual growth. Everybody was dead in earnest and buoyant and happy. Classes kept everyone busy from eight until one and then meetings of varied interests in the evening with hours for recreation in the afternoon.

I commend this conference work to anyone; everyone, as being time well spent and fully worth while.

The date of the conference this year is August 6-15.

Then I attended a class on mission study at Davenport given by Miss Tillotson from the Church Missions House, New York. I attended the four Deanery meetings of the state, held as follows:

Western Deanery at Fort Dodge, Nov. 17-18.

N. E. Deanery at Waterloo, Dec. 1-2.

S. E. Deanery at Clinton, Dec. 8-9.

Central Deanery at Oskaloosa, Dec. 15-16.

At each of these meetings the Woman's Auxiliary was given a place on the program and the Mission Study work discussed.

Bishop Morrison designated 34 parishes for me to visit. The parishes in which I have talked Mission Study work have been:—

I came into personal touch with 23 parishes. Your Educational Secretary found in many places interest and a desire to follow the best plan

of work but once in a while there was an atmosphere so neutral that she was powerless to awaken a desire to take up the work. One place was hopeless; one place no class formed as the rector was absent.

It is very necessary to have not only the approval but the co-operation of the rector for successful work.

The general plan followed was a six weeks' intensive study during the Lenten period. The book recommended for the year was Social Aspects in Foreign Missions by Mr. Faunce—The book selected as the text book by the general Board of Missions representing all denominations in Christian work.

Personally I have found it a difficult text book and have not been surprised that a number of classes followed plans suggested for work with a different text book, or from the Spirit of Missions.

The largest meeting held numbered 60; the smallest, 7. Amount collected \$14.30 which was sent to the Treasurer. The annual expense of Educational Secretary was:—

Your Educational Secretary could not arrange dates for one cause or another, with the rectors at Boone, Le Mars, Muscatine, Dubuque, Em-metsburg, Estherville, Spencer.

Sickness at Sac City and expense prevented my going to Sac City. The report of work planned was so fine that it did not seem necessary to go to Keokuk. They reported work organized and in full swing with interest and enthusiasm which means progress. Chariton was without a rector and the guild felt it was impossible to undertake any plan of study. A date was made for Mt. Pleasant but changes at other points necessitated a deferred date which afterwards had to be dropped.

Letters were sent out to all classes formed near the end of Lent to see what had been accomplished.

Twenty-one reports were received showing progress and where they have followed new plan the interest has been stimulated and work vitalized. Two reported classes dropped. One, the work holds over until fall. One spent always two hours in class. One purchased 15 text books. Mason City gave \$10.06 to United Offering. All report attendance fairly good.

CONSTITUTION.

ARTICLE I.

NAME AND OBJECT.

Section 1. This association shall be called the Iowa Branch of the Woman's Auxiliary to the Board of Missions.

Sec. 2. The object of this association shall be the same as that of the General Auxiliary.

ARTICLE II.

All Parochial Missionary Societies of women and all baptized women of the Diocese desiring it, who contribute prayers or gifts to Missions, shall be considered members of this association.

ARTICLE III.

OFFICERS AND DUTIES.

Section 1. The officers shall be, Honorary President, President, First Vice President, Second Vice President, Secretary, Treasurer, United Offering Treasurer and Correspondent Church Periodical Club.

Sec. 2. The President shall have general supervision of the Auxiliary work of the Diocese, shall call meetings, preside over them, and perform such other duties as may pertain to her office.

Sec. 3. In the absence of the President, the Vice-Presidents, in the order of their office, shall perform the duties of the President. The First Vice-President shall be President of a Junior Board which shall have charge of all of the work of the Junior and Little Helpers' Branches, and shall make a report of the same at the annual meeting. This Board shall be elected each year by the members of the Junior Branches. The Second Vice-President shall be editor in charge of the Auxiliary columns in the Iowa Churchman, and shall perform such other duties as may be assigned her by the President or the Bishop.

Sec. 4. The Secretary shall give notice of meetings and keep a record of them; shall correspond with Parish Secretaries and with the General Secretary of the Auxiliary, and perform such other duties as may pertain to her office. She shall obtain yearly reports from the Parochial Branches and incorporate them into an annual report for the Diocesan Branch.

Sec. 5. (a) The Treasurer shall receive all moneys (excepting the United Offering and the moneys from the Junior and the Little Helpers' Branches) keep an accurate account of the same, as received and disbursed by her, pay all bills upon written order signed by the President and perform such other duties as pertain to her office, making a complete report of the same at the annual meeting. (b) The United Offering Treasurer shall keep an accurate account of the United Offering fund, collecting said fund from the Parochial branches on the 1st of September and on the 1st of March each year.

Sec. 6. The Correspondent of the Church Periodical Club shall try to interest all Parochial Branches in this department of the work, supervise the distribution of all literature and make an annual report of the same.

Sec. 7. A box shall be provided, called "The Mission Supply Box," which shall be in charge of some member of this Auxiliary to be appointed by the President for the purpose of receiving such contributions from weak branches of the Auxiliary as are anxious to assist in this part of the good work, but feel unable to assume the responsibility of filing a complete box alone.

Sec. 8. The officers, as a committee, shall use such efforts as lie in their power to increase Missionary knowledge and zeal among the women of the Diocese and to encourage the formation of Parochial Branches.

Sec. 9. Vacancies in office shall be filled by the Bishop's appointment.

ARTICLE IV.

MEETINGS.

Section 1. An annual meeting shall be held each year at the time and place of the Diocesan Convention.

Sec. 2. Special meetings may be held during the year upon the united call of three Parochial Branches, for the purpose of increasing interest.

ARTICLE V.

DELEGATES.

Three delegates or their alternates shall be sent from each Parochial Branch to attend each annual meeting, one of these delegates being the Rector's wife, if he have one.

ARTICLE VI.

AMENDMENTS.

This constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present.

BY-LAWS.

I.

EXECUTIVE MEETINGS.

The officers shall hold an executive meeting before each general meeting, and at one other time during the year at the call of the President.

II.

ORDER OF BUSINESS.

The regular order of business for the annual meeting shall be as follows:

FIRST DAY.

1. Opening Service and Corporate Communion.
2. Bishop's Address.
3. Organization and Minutes.
4. Appointment of Committees.
5. President's Summary.
6. Business.
7. Conference.

SECOND DAY.

1. General Missionary Meeting, with Addresses and Reports to the Convention.
2. Minutes of first day's session.
3. Reports of Committees.
4. Annual Reports in Order.
5. Election of Officers.
6. Unfinished Business.

III.

All meetings shall be conducted by the rules of Parliamentary Law, as prescribed in Roberts' "Rules of Order."

IV.

ELECTION OF OFFICERS.

1. The Bishop's wife shall be the Honorary President. The other officers shall be elected by the women in their annual meeting during Convention of each year, and shall serve until their successors are elected.

2. They shall be nominated by informal written ballot, and the two receiving the highest number of votes shall be considered nominees for that office.

V.

AMENDMENTS.

1. These By-Laws may be amended at any meeting by a vote of a majority of those present.

2. By unanimous consent any article of these By-Laws may be suspended for one regular meeting.
