PROCEEDINGS.

The Iowa Branch of the Woman's Auxiliary to the Board of Missions met in annual session at Davenport, May 18, 1919.

The services opened on Sunday with a communion in Trinity Cathedral at 10:30. The celebrant being the Rt. Rev. Harry S. Longley.

On Monday the annual address of Bishop Morrison was given in Trinity Cathedral and a short talk by Mrs. Gregory of Chicago, representing the Girls' Friendly Society. At 10:30 the Auxiliary retired to the Parish House. The meeting was called to order by the president, Mrs. Longley. Dean Hare lead in the creed and prayer. Mrs. Gregory spoke on the Value of Foreign Missions, as observed by her on a seven months' trip around the world.

Mrs. Longley extended a kindly greeting to all and the roll call was responded to by the number of ladies from each parish, standing.

The treasurer gave her report, which by motion was duly accepted.

The Foreign Missionary insurance was explained by Mrs. Wazek of Davenport and it was suggested that Iowa assume one full pledge or \$50.00 a year, instead of \$25.00 now given.

Committee on Amendments—Mrs. Volland, Iowa City; Mrs. Gardner, Clinton; Mrs. Mills, Waterloo.

The reading of the annual letter from the general secretary, Miss Lindley. The reading of a letter regarding the Triennial at Detroit in October.

Mrs. Watzek of Davenport presented a memorial from the Woman's Auxiliary of Iowa to the General Convention at Detroit. A motion that this memorial be adopted was made and duly carried.

A motion was made and sustained that the secretary send a telegram of greeting from this convention to Mrs. Geo. Allingham, the former secretary, now residing in Texas.

The noon day prayers for missions were given by Mrs. Jackson of Council Bluffs.

The report of the United Offering treasurer, Mrs. Copp, of Burlington, was read and accepted.

The report of the Educational Secretary, Miss Dysart, of Dubuque, was read by Mrs. Ehlers. Motion that this report be accepted and printed in the Journal.

The annual address of the president was read and greatly enjoyed.

A motion for adjournment for luncheon, which was served in the Guild hall by the ladies of the parish.

Two O'clock P. M.

The Auxiliary joined with the clergy and laity to hear the address of Bishop Longley in Trinity Cathedral. At 3:15 we adjourned to the Parish House. The meeting was called to order by the president, who

presented Rev. Paul Micou, from the General Board of Religious Education, who gave an instructive talk on the National-wide Campaign and the New Junior Plan. Reading of secretary's report, taking of pledges, discussion of Sarah Swazey Morrison Memorial Fund. Motion that the funds now in existence be united and placed in the hands of the treasurer. Carried.

A motion that an offering be taken and devoted to the Memorial Fund carried; 20.30 collected.

A letter of appeal from Valparaiso University was read and tabled.

A motion that the special this year be devoted to the Sarah Swazey Morrison Memorial fund carried.

The meeting closed with the singing of the Doxology.

Tuesday—9:15 A. M.

The meeting was opened by Dean Hare, who offered prayer and spoke briefly on the death of Bishop Greer of New York.

A questionnaire conducted by the president brought out many interesting answers regarding the Woman's Auxiliary.

A suggestion was offered that the ladies send glasses of jellies, canned fruit, etc., to St. Catherine's school and St. Monica's Home.

A report from the chairman of the committee on church extension, Mrs. Jackson, of Council Bluffs, was read and accepted.

Mrs. Farquharson of Des Moines made an appeal for the support of the Woman's Auxiliary for St. Monica's Home, Des Moines. A motion that the offering of the day, \$22.80, be devoted to St. Monica's Home carried.

Report of Perry Memorial Committee read. Motion that it be accepted and printed in the Journal.

The Chair announced the appointment of Mrs. Ficke of Davenport as chairman of the Sarah Swazey Morrison Memorial Fund to select her own committee.

A rising vote of thanks was tendered the members of Trinity Cathedral for their gracious hospitality.

PRESIDENT'S ADDRESS.

By a rising vote of thanks the auxiliary expressed to Mrs. Longley their grateful appreciation of her faithful services during her term of office as President.

The meeting adjourned and closed with the singing of the Doxology.

To the Members of the Woman's Auxiliary of the Board of Missions in the Diocese of Iowa:

Another year has passed in our work together for Christ and His church, and for our nation and fellowmen. We resolved to make this a better year than the one preceding, and we have succeeded. Our hearts were sad indeed last year over the condition of the world. We felt that many had failed in performing their Christian duties, or the war would not have been waging. Now our hearts are filled with joy that the war is over, and another opportunity given to the careless and indifferent to manifest their Christian faith with greater earnestness that this terrible history may not repeat itself. May we, as a federated body of Christian workers, again resolve to make the years to come, years filled with faith and good works, and so help others who shall follow, to profit by our example until the "earth shall be filled with the knowledge of God, as the waters cover the sea."

The executive board of the Woman's Auxiliary can report a successful year, considering the trying times, when hearts and homes have been saddened, and bereft of loved ones, from the toll of war and the influenza. Your President realizes that during her term of office the times have not been normal. Great demands for war work have been made upon our members, but in spite of this, you have sustained her in her work. She thanks you, and appreciates it, and feels she can hand the work over to the new President in the splendid condition in which Mrs. Watzek left it.

Your President has written every branch twice during the year, and has written some branches several times as necessity demanded it. The "Advent Call" was carefully planned in this diocese, which unfortunately for us, could not be very well carried out owing to the influenza. As one Auxiliary member wrote, "We could only carry it out within the walls of our own room, and after all, did not that answer the call in a way?"

Your President also planned for the follow up work, in the "call to service," also arranged Mrs. Biller's itinerary and train schedule to visit branches that were not reached last year. Splendid reports have been given of these visits. This personal touch with the workers in the Church Missions House means much to the dioceses of "magnificent distances." Your President has asked Miss Lindley, the national Secretary, if Iowa may memorialize the General Convention to have field secretaries. This memorial will be presented for your consideration at the business session.

Two new branches have been formed, and three revived during the year. Three deanery meetings have been held, and while the attendance was not as large as usual in the Sioux City and Des Moines deaneries, the meetings were very helpful. The Dubuque deanery meeting was a great success, under the leadership of the deanery chairman, Mrs. Cunningham, and with the assistance of our educa-

tional secretary, Miss Dysart. The Muscatine deanery meeting was not held owing to the influenza. The President wishes at this time to thank the deanery chairmen for their very efficient help.

Your President wishes to make an especial appeal for the united offering. The Triennial is this fall, and may Iowa have a larger offering than ever before at that time. Many of us have much to be thankful for this year. Let us not forget the little Blue Box, and what it stands for.

Remember the work of the study classes. We cannot be interested in our church missions, which we are trying to aid, unless we have some knowledge of the work and workers. Will each branch try to have instruction in our missionary work as part of the year's program.

When Mrs. Biller visited Iowa, she announced that boxes were very much needed at the mission stations; therefore, will the branches try to prepare a box this year. Mrs. O'Rourke, our Diocesan Secretary, will arrange with you for this work. The box not only does much good where it is sent, but it helps to vary the year's work in the Auxiliary. Study and programs part of the year, and box work the other part of the year will increase the interest.

While the Church Periodical Club is a separate organization, it comes under the work of the Auxiliary. Remember many missionaries cannot afford to take church and secular magazines. Help them by passing your magazines on. You can arrange for sending your magazines by consulting the secretary of the Church Periodical Club in this diocese, whose name may be obtained from the Journal.

Last, but not least, remember the future Auxiliary as it exists in our Juniors. Your President is urging you as you love the children and their interests, and what they mean to the future church, to remain to the meeting of the Juniors on the last afternoon of convention. Reports of the work, and how it is carried on will be given.

Each parish branch that is not organizing or aiding a Junior branch in the parish is not doing its full duty as a Woman's Auxiliary.

Your president trusts that many will attend the General Convention in Detroit in October. The Auxiliary is passing through a period of readjustment, and many important matters are to come up. The keynote of the General Convention of the Woman's Auxiliary will be "The spirit of service for Christ's sake," and may we in Iowa have this for our inspiration, and we will rise to this ideal if the "Love of Christ Constaineth Us."

The average amount now received annually is about twenty-five dollars. Most parishes pledge one dollar a year. If this pledge could be doubled for a few years, the new room might be furnished and kept up as a memorial room should be.

REPORT OF THE EDUCATIONAL SECRETARY.

The report of the Educational Secretary this year is brief, for two reasons:

The influenza epidemic swept Iowa last autumn, just at the time when Deanery meetings are usually held, parishes visited and the educational work for the ensuing year outlined and started. Then came the relaxation so keenly felt in all lines of work following the signing of the armistice, and this was evident also in church work.

The Des Moines Deanery in Des Moines and the Dubuque Deanery in Cedar Falls were both attended. At each of these meetings the Advent Call was explained and emphasized by Bishops, Clergy and the Educational Secretary. Several parishes were ready to undertake the plan as suggested, but the strict quarantine made it impossible to carry out the plan.

The reports of the study classes, held during Lent, have been most gratifying. Bishop Burleson's book—"Our Church and Our Country"—proved to be popular, and classes have found it both interesting and instructive.

"This is the day of the world's supreme need, and the church's supreme opportunity." An era of reconstruction. A world must be rebuilt, and forms of governments recast. There must be written anew the program of God in the constitution of nations, and in the life of the church. The policy of the church must match the policy of the nation.

The Inter-Church World Movement aims to secure a close working and effective co-operation among all the active missionary and educational agencies of the Protestant churches. It also proposes a united effort to deepen the spiritual life of the churches, to enlarge the ministry of prayer, and to increase the knowledge of, and interest in, missionary work at home and abroad.

A splendid impetus will be given our church this year through the work of the General Convention. Let me urge all who can possibly do so to attend this convention in Detroit in October. Let us follow the work of the convention in our church papers, and the spirit of the missions, and then with renewed zeal let us take up our work in our own parishes. What the Episcopal church stands for in each community is largely what we make it. Let us make it a real power. Attend church services regularly, and thus encourage others to do so. Your rector will welcome you. He will preach better sermons. He will be a more devoted pastor. Our returning soldiers will enjoy the warmth and life of the home church. Join the Auxiliary or Guild, and be ready to do your share of the work. Take a class in the Sunday school, and help to mold the lives of the little people, teaching them that the Gospel of Christ, and the Golden Rule extends to every phase of our individual and collective life. Have a Social Service Committee ready to co-ordinate all moral and spiritual forces in the problems of the neighborhood.

Join a study class! Undertake earnestly every work which is for the good of the community, and the glory of God.

Our Diocesan Secretary and Treasurer, Mrs. Grenier, was also present at this conference for part of the ten days, and was able to present the Junior work to her own parish and to the Sioux City Deanery meeting.

The Journal for 1918 was sent to every branch with my annual fall letter, but I have received few letters from Junior leaders.

By correspondence I came to know of the problems of the church school at Denison and gave advice and made suggestions along new Junior plans. In my own parish, Grace church, Cedar Rapids, we are trying to work out this new Junior plan in our own school. I believe this plan as worked out by Miss Withers, who is the Junior Secretary, is the most ideal one we have ever had, and furthermore the most practical. Those who are planning to go to Detroit in October to attend the Triennial must not fail to visit the sessions of the church schools, which are demonstrating the Christian Nurture Series along with the Junior plan.

Last year I appealed to the Woman's Auxiliary to aid the Juniors in every possible way. I wonder how many branches have given help to the struggling branches of Juniors, have prayed for its leader and her work or tried to start new branches.

I beg of you not to forget them this next year, for they are passing through a period of readjustment, and so much depends on your help and encouragement.

May the message of the Risen Lord, "Lo, I am with you always," fill our hearts with peace and joy as we labor in His vineyard this coming year.

CONSTITUTION

ARTICLE I

Name and Object.

Section 1. This association shall be called the Iowa Branch of the Woman's Auxiliary to the Board of Missions.

Sec. 2. The object of this association shall be the same as that of the General Auxiliary.

ARTICLE II

All arochial Missionary Societies of women and all baptized women of the Diocese desiring it, who contribute prayers or gifts to Missions, shall be considered members of this association.

ARTICLE III

Officers and Duties.

Section 1. The officers shall be, Honorary President, President, First Vice President, Second Vice President, Secretary, Treasurer, United Offering Treasurer, Educational Secretary and Correspondent Church Periodical Club.

Sec 2. The President shall have general supervision of the Auxiliary work of the Diocese, shall call meetings, preside over them, and perform such other duties as may pertain to her office.

Sec. 3. In the absence of the President, the Vice Presidents, in the order of their office, shall perform the duties of the President. The First Vice President shall be President of a Jnuior Board, which shall have charge of all of the work of the Junior and Little Helpers' Branches, and shall make a report of the same at the annual meeting. This Board shall be elected each year by the members of the Junior Branches. The Second Vice President shall be editor in charge of the Auxiliary columns in the Iowa Churchman, and shall perform such other duties as may be assigned her by the President or the Bishop.

Sec. 4. The Secretary shall give notice of meetings and keep a record of them; shall correspond with Parish Secretaries and with the General Secretary of the Auxiliary, and perform such other duties as may pertain to her office. She shall obtain yearly reports from the Porachial Branches and incorporate them into an annual report for the Diocesan Branch.

Sec. 5. (a) The Treasurer shall receive all moneys (excepting the United Offering and the moneys from the Junior and the Little Helpers' Branches) keep an accurate account of the same, as received and disbursed by her, pay all bills upon written order signed by the President, and perform such other duties as pertain to her office, making a complete report of the same at the annual meeting. (b) The United Offering Treasurer shall keep an accurate account of the

United Offering fund, collecting said fund from the Parochial branches on the 1st of September and on the 1st of March each year.

Sec. 6. The Correspondent of the Church Periodical Club shall try to interest all Parochial Branches in this department of the work, supervise the distribution of all literature and make an annual report of the same.

Sec. 7. A box shall be provided, called "The Mission Supply Box," which shall be in charge of some member of this Auxiliary to be appointed by the President for the purpose of receiving such contributions from weak branches of the Auxiliary as are anxious to assist in this part of the good work, but feel unable to assume the responsibility of filling a complete box alone.

Sec. 8. The officers, as a committee, shall use such efforts as lie in their power to increase Missionary knowledge and zeal among the women of the Diocese and to encourage the formation of Parochial Branches.

Sec. 9. Vacancies in office shall be filled by the Bishop's appointment.

ARTICLE IV

Meetings.

Section 1. An annual meeting shall be held each year at the time and place of the Diocesan convention.

Sec. 2. Special meetings may be held during the year upon the united call of three Parochial Branches, for the purpose of increasing interest.

ARTICLE V

Delegates.

Three delegates or their alternates shall be sent from each Parochial Branch to attend each annual meeting, one of these delegates being the Rector's wife, if he have one.

ARTICLE VI

Amendments.

This constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present.

BY-LAWS

I

Executive Meetings.

The officers shall hold an executive meeting before each general meeting, and at one other time during the year at the call of the

4. Annual Reports in Order.
5. Election of Officers.
6. Unfinished Business.

III

All meetings shall be conducted by the rules of Parliamentary Law, as prescribed in Roberts' "Rules of Order."

IV

lection of Officers.

1. The Bishop's wife shall be the Honorary President. The President shall be elected by the women at their annual meeting next preceding the General oCnvention and shall serve for three years. The other officers shall be elected at the meeting each year and shall serve until their successors are elected.

2. They shall be nominated by informal written ballot, and the two receiving the highest number of votes shall be considered nominees for that office.

V

Amendments.

1. These By-Laws may be amended at any meeting by a vote of a majority of those present.

2. By unanimous consent any article of these By-Laws may be suspended for one regular meeting.
