PROCEEDINGS

The 38th Annual Convention of the Iowa Branch of the Woman's Auxiliary met in Des Moines, January 18, 19, and 20, 1925.

The Corporate Communion at St. Paul's Church opened the Convention.

The Executive Committee met at 3 P. M. Sunday at the Y. W. C. A. for preliminary business.

MONDAY, JANUARY 19th

The Auxiliary assembled with the Clergy and Laity in St. Paul's Church to hear the annual address of Bishop Morrison.

At 10:30 A. M. the Woman's Auxiliary retired to the Crypt of the church where the meeting was called to order by the President. Prayers were given by the Rev. Mr. Upjohn, of Independence, in the necessary absence of Bishop Longley.

Mrs. Grenier, the president, appointed the following Committees: Resolutions: Mrs. Lamont, Keokuk; Mrs. A. W. Brown, Davenport; Miss Henderson, Cedar Rapids.

Credentials: Mrs. Heningbaum, Davenport; Mrs. Kerfoot, Des Moines.

The Roll Call was responded to by thirty-four Parishes. The cards, inaugurated by our President, Mrs. Grenier, were distributed by the Credentials Committee for registration.

The Diocesan Secretary read her report which was accepted.

The Diocesan Treasurer's report was read and accepted.

The report of the United Thank Offering Treasurer, which totaled \$3,823.37, was enthusiastically received. Mrs. Longley moved that the Survey be passed after the reading of the U. T. O. report. After the reading of the U. T. O. Treasurer's report, Mrs. Longley moved that our slogan be \$5,000.00 before the Triennial Convention and that the report be accepted by a rising vote of thanks for the splendid report of Mrs. Morgan. Carried.

The mid-day Prayers for Missions were read by the President. In the absence of Mrs. Worthen, the Box Secretary's report was read by the Diocesan Secretary.

Mrs. Cunningham moved that the report of the Box Secretary be accepted and a vote of thanks be sent Mrs. Worthen by the Secretary expressing the appreciation of the Woman's Auxiliary for the success of her work. Carried.

The offering taken amounted to \$25.00.

Miss Henderson moved, seconded by Mrs. Morgan, that the Offerings of this Convention be divided equally between St. Luke's Hospital, Tokio, Japan, and Student work at Ames.

Miss Henderson, President of the Church School Service League, read her report of the League from January, 1924, to January 1925. It was accepted and requested that it be printed in the Journal.

Miss Henderson then read the report of Miss Bailey on the Christmas Boxes. 542 children received a useful and a joyful gift each as a result of the Christmas Boxes. Miss Boissier moved that the report be accepted and printed in the Journal. Carried.

The President read her annual message which was listened to with pleasure. Mrs. Kerfoot moved that we acknowledge the good work done by our retiring President, Mrs. Grenier, by a rising vote of thanks. Mrs. Grenier read a report of the Provincial Synod of the Northwest, which met at Omaha, Nebr., last September, as reported at the Des Moines Deanery. It was accepted with applause.

The meeting adjourned at 12:45 P. M. for luncheon at Younker's Tea Room given by the Woman's Auxiliaries of St. Paul, St. Luke's, St. Mark's

and St. Andrew's of Des Moines, for the Officers and delegates of the Convention.

At 2:30 P. M. the Woman's Auxiliary again met at St. Paul's Church to hear the annual address of Bishop Longley after which we went to the crypt of the Church. Mr. Shelby of the Brotherhood of St. Andrew's talked on the Boy Problem saying there was scarcely a boy problem since the accumulated information of the past few years. Election of Officers followed. The President appointed as tellers: Mrs. Wycoff, Des Moines, and Mrs. Cox, Iowa City. Nominations were made by ballot. While waiting for the report of the tellers, Mrs. Cunningham moved that St. Luke's West Side Branch of the Woman's Auxiliary of Des Moines be allowed a representation of three delegates, the same as other Parishes. Carried. The Tellers reported that Mrs. Jones, Iowa Falls, received the highest number of votes for nomination for president. Miss Henderson moved, seconded by Mrs. Longley, that the rules be suspended and the Treasurer cast the unanimous ballot for Mrs. Jessie A. Jones, Iowa Falls. Carried.

It was moved and seconded that the Vice Presidents continue in office. Carried. Balloting for nominations of Diocesan Secretary resulted in Mrs. Wheeler of Fort Dodge receiving the highest number of votes. Mrs. Cox moved, and it was seconded, that the Secretary be instructed to cast the unanimous ballot for Mrs. Wheeler. Carried.

While waiting for the Teller's report Mrs. Cunningham received the pledges for 1925 from the Parishes.

Mrs. Kerfoot moved that the rules be suspended and Mrs. Cunningham be elected unanimously for Treasurer, the Secretary being instructed to cast the ballot. Carried.

Mrs. Harper, Burlington, moved that a rising vote of thanks be given Mrs. Cunningham for her faithful ten years of efficient service as Treasurer. Mrs. Nicholson, Newton, moved that the Secretary cast the ballot for Mrs. Kerfoot to continue in the office of Educational Secretary. Carried.

It was moved by Mrs. Cunningham, seconded by Mrs. Harper, that the rules be suspended and the Secretary instructed to cast the ballot to continue Mrs. Worthen in the office of Box Secretary. Carried.

Mrs. Kerfoot moved, and Mrs. Nicholson seconded the motion, that the expense of stamps and stationery be supplied the Box Secretary. Carried.

Miss Henderson moved that the President appoint the correspondent for the Church Periodical Club. Carried.

Mrs. Grenier appointed Mrs. Pollock, Dubuque, as Correspondent Church Periodical Club.

The Treasurer made a plea for the continuation of pledges and contributions for the Sarah Swasey Morrison Memorial.

Mrs. O'Rourke moved that the President appoint the delegates for the Provincial Synod. Carried.

Election of delegates to the Triennial General Convention followed. Mrs. Williams moved and it was seconded, that nominations of delegates to the Triennial be made from the floor. Carried.

Mrs. Harper, Burlington, moved that the first five names receiving the highest number of votes be elected Delegates and the next five names receiving the highest number of votes be elected alternates to the Triennial Convention at New Orleans. Carried. The Tellers reported as follows:

Mrs. Jones, of Iowa Falls; Mrs. Morgan, of Newton; Miss Henderson, of Cedar Rapids; Mrs. Cunningham, of Cedar Rapids; Mrs. Cox, of Iowa City for Delegates.

Miss Bailey, of Charles City; Mrs. Watzek, of Davenport; Mrs. Hutchens, of Burlington; Mrs. Wheeler, of Fort Dodge; Mrs. Owen, of Des Moines, as Alternates.

Adjourned at 5:30 P. M.

Several Laymen of St. Paul's Church entertained the Convention at a banquet given at Hotel Fort Des Moines at seven o'clock in the evening.

THURSDAY MORNING, JANUARY 20, 1925

The Rev. Mr. Dew-Brittian opened the meeting with prayers.

Mrs. Wycoff presented the idea of killing five birds with one stone, as it were, by sending a boy to Camp Morrison next summer, urging the Parishes to do all that was possible to promote the work of the Camp.

The President appoints as delegates to the Provincial Synod at Cass Lake, Minnesota: Mrs. Longley, of Des Moines; Mrs. Jones, of Iowa Falls; Mrs. Kerfoot, of Des Moines; Mrs. Cunningham, of Cedar Rapids; and Mrs. Morgan, of Newton.

Alternates: Mrs. Flockhart, of Sioux City; Mrs. Burroughs, of Ames; Mrs. Williams, of St. Luke's, Des Moines; Mrs. Flockhart, of Dubuque.

Miss Bagley, of Clinton, in the absence of Mrs. Lewis, read the report of the Church Periodical Club Correspondent. It was accepted.

Mrs. Kerfoot, Educational Secretary, read her report from January 1924 to January 1925, which was accepted.

Deanery Chairman reports followed. The Muscatine Deanery report was read by the Chairman, Mrs. A. W. Brown, Davenport. Accepted.

Mrs. Longley requested a change of procedure that the address of the morning might be given next. Mrs. Grenier then introduced Mrs. Barbour, a returned Missionary from St. Mary's Hall, Shanghai, China, who gave a very interesting address on the Missionary work in China.

Next the Rev. Mr. Wright, of Keokuk, spoke about the real Americans, the colored people, and the needs of our work for them in the Church of St. Mary the Virgin, Keokuk. He said, "When we have God, money will come."

Bishop Morrison came to suggest to us that we consider the question of having the Woman's Auxiliary pay the expenses of the delegates to the Annual Church Convention. The plan had been adopted by the Convention of Clergy-Laymen. Also he suggested that we consider the advisability of holding the Woman's Auxiliary at a different time than the Diocesan Convention.

Mrs. Harper moved, Mrs. Lamont seconded the motion, that each Woman's Auxiliary Branch pay their delegates expenses to the Diocesan Convention. After discussion the motion carried.

Mrs. Cunningham moved that we hold the Woman's Auxiliary Convention at the same time and place as the Diocesan Convention, seconded and carried. The offering taken amounted to \$17.80.

Mrs. Nicholson moved that a rising vote of thanks be given the Woman's Auxiliaries of Des Moines for their gracious hospitality. Carried unanimously and heartily.

PRESIDENT'S ADDRESS

There are signs of a spiritual awakening in the Diocese of Iowa. About thirty-seven of the clergy and laity from our parishes were enrolled in the various summer conferences; a very large increase over any past attendance. The organizing of a Diocesan Young People's Service League at this Convention is also a step in the right direction, and good results are bound to follow such splendid conferences as the pre-convention programs conducted by the Diocesan Board of Religious Education the past three years, and which are interesting a larger number of people each year. The Auxiliary should be very thankful for these hopeful signs and should do what we can to encourage and assist in developing these new movements in our diocese.

During the past year each branch of the Auxiliary has been working in large or small groups in the parishes and missions with little knowledge of what the others were doing. In a diocese of expansive territory there is little opportunity of gathering on account of time and expense. The annual Diocesan Convention and the Deanery Meetings are the two times in the year when we have the pleasure of this fellowship; while in the more consolidated dioceses, Diocesan Meetings are held monthly, and consequently branches are kept in closer touch with each other. Each branch has been striving to fulfill its pledges of gifts in money and its quota of supplies allotted by the Box Secretary, and you shall hear from the reports of the Diocesan Officers what the branches together have been able to accomplish.

I am sure you all appreciate the efforts of Mrs. Jones in getting the journals to you so soon after Convention, and also the untiring efforts of Mrs. Cunningham, Mrs. Morgan and Mrs. Worthen. Mrs. Kerfoot has visited most of the Deanery Meetings and several parishes and has used her efforts toward interesting the parishes in mission study and religious education. Personally I wish to thank them all and the branches also for their cooperation in the work of the Iowa Branch.

Last Fall the Deanery Meetings were held at Fort Dodge, Ottumwa, Keokuk and Charles City, and were as a whole well attended, especially the meeting at Charles City, twenty-seven from outside parishes being present, among their number several diocesan officers. The deanery chairmen sent out notices, prepared the programs and presided at the meetings, with the exception of the Chairman of the Sioux City Deanery, who having resigned, her duties were fulfilled by the Diocesan President at the meeting in Fort Dodge. I wish to thank the Deanery Chairmen for their efforts on behalf of the work of the Auxiliary in the districts under their supervision.

It is to be our pleasure and privilege to enjoy this year the great inspiring and helpful Triennial Convention, which will be held in New Orleans, La., commencing October 6th. It is to be hoped that all delegates elected and also many others shall be able to attend. At this meeting, the United Thank Offering of the Women of the Church shall be offered up. What shall that offering be? Let us strive in the time that remains to make this offering known to every woman, so that all may have the privilege of sharing in it.

The National Committee for the Bishop Tuttle Memorial, which fund is to be used for the erection of houses for women in training, are asking that if possible all money be in the hands of Mrs. Prince by May 1, 1925, the opportunity for giving continues after that date, however. It has been found that a new building must be erected for the training of Colored Women in place of remodeling the old building as was first planned. More money will be needed, and branches and individuals are urged to increase their gifts if possible.

Two new groups of women have organized for Auxiliary work during

the year, one in St. Luke's, Des Moines, west side group, and one in Fort Dodge, the first branch to organize an evening branch for women unable to meet afternoons. We are glad that these parishes are extending their influence, and hope others may follow their example.

Your president has sent out two circular letters to each of the forty-four parishes and has written numerous other letters, has prepared several items for publication in the Iowa Churchman, corresponded with the Parishes and Missions in the Sioux City Deanery and presided at the Deanery Meeting in Fort Dodge and represented the Iowa branch at the meeting of the Synod in Omaha, having been honored by being appointed to serve on the Credentials Committee.

I regret that Mrs. Lewis, who served so ably for several years as correspondent of the Church Periodical Club has moved from the Diocese, and was obliged to resign her office. A splendid piece of missionary work is being done for the isolated through this Club, and it is desired that more branches take up this work of passing on their magazines to those who are longing for them.

You have honored your presiding officer with two terms and it has been a pleasure and a blessing to her to serve you. In turning over her duties to her successor she urges the Iowa Branch to continue to go forward and to do her full share in bringing the world to Christ. We must pray more earnestly, labor more diligently, and give more liberally to make Him known to all nations as their Savior and their King.

REPORT OF DIOCESAN EDUCATIONAL SECRETARY

JANUARY 1, 1924, TO JANUARY 1, 1925

Never has there been such a period of unsettlement and unrest as we have experienced since the war, but the reaction has begun. The widespread attention and discussion which have been given religion by the public press have perhaps done a great deal of harm but on the other hand, churchmen and churchwomen have been led to examine for themselves the grounds for their belief which has renewed their conscience to loyalty and devotion to the Church.

In the Diocese there is evidence of new and vigorous life. This is shown by the increase in the number of confirmation classes and by the increase in the number of those attending Summer Conferences, and by the rapid growth of the Young People's movement. Never before have women been as interested and as well versed in social problems. This interest develops the human and spiritual side of things and helps women to develop in their children a safer knowledge of social problems. This glorious age for children, with the tremendous advances in education, would be ideal if only the mothers would do their part. The mother is the backbone of the child's life. There is a certain education which must be given in the home, Character formation, one of the most important things in the life of a child, must be based on the atmosphere of the home.

Your Educational Secretary attended three of the four deanery meetings and I want to say right here, that if you want to develop a keener interest in the church's work, just attend the deanery meetings. There is a close contact between women at these meetings. More so, than at the Diocesan Conventions, because they are not so largely attended. And it is this close contact and discussion of important church work which promotes strength and unity of purpose.

REPORT OF SUPPLY SECRETARY

To the Iowa Branch of the Woman's Auxiliary to the National Council,
Des Moines, Iowa.

Greeting:

During the year 1924 there has been much retrenchment along all lines, both personal and public; many organizations have failed to reach their usual standard of work. Under these circumstances, it is a great pleasure for your Supply Secretary to be able to report that the Diocese of Iowa has not only completed her supply quota for 1924, but has exceeded the same by about 23% over 1923. This has been accomplished by five less Branches than in 1923, as a few Branches were unable to take any work the past year.

There has appeared to be a greater desire to help in Mission work and quotas have been filled more quickly. Your Secretary does not recall an instance where a Branch objected to its quota. Several Branches sent money instead of garments thus enabling the missionary to make own selections and purchase.

The Diocese of Iowa has only one negro church, St. Mary the Virgin at Keokuk, and we are glad to know that the women of this Church helped with the box sent from St. John's Church, Keokuk.

I want especially to call your attention to the splendid report of the Girls Friendly Society, showing one more active Branch than in 1923 so far as box work is concerned, but showing the wonderful value increase, from \$42.09 in 1923 to \$188.54 in 1924. They are already working on the 1925 Supply work.

This good report could not be possible if it were not for the wonderfully fine co-operation received from all. May we not adopt the slogan, "More for Missions in 1925."

REPORT OF CHURCH SCHOOL SERVICE PROGRAM FROM JANUARY 1, 1924, TO JANUARY 1, 1925

The most outstanding meetings of the year were the two held in June in conference with Miss Withers, our National Secretary of the C. S. S. L., of New York City.

One was held in Des Moines with a few members of the Diocesan members of the Department of R. E. in attendance: I was unable to be present, as Miss Withers was to conduct a conference in Cedar Rapids following the Des Moines one. Those present were from the Cedar Rapids Deanery with the exception of Iowa City. I was much pleased with the attendance and interest shown by the clergy.

At two of the Deanery meetings we held in Charles City in the Cedar Rapids Deanery and the other in Ottumwa, I was asked to present the work of the Church School Service Program. I do appreciate the privilege given me, and wish to thank those of the Woman's Auxiliary who gave me this opportunity of presenting the C. S. S. Program to these women attending the meetings.

The most important work of the Church School Service Program has been its Christmas Joy Boxes under the direction of Miss Mary Alice Bailey of Charles City. It is a splendid piece of work—and all the credit is due to her untiring efforts to reach every parish in the Diocese and interest the Church Schools, large or small. And if there is no school but a few children, to get some member of the Woman's Auxiliary to work with the few children.

As a result of this, her report shows that she has been able to increase the work over the year 1923, and any previous one, she has held office. The figures for 1924 show 19 more parishes giving and an increase of 289 children receiving gifts. It is very gratifying to know our Diocese is getting into line and co-operating with the people in charge of the National Program's Christmas Boxes.

Seventeen different mission stations were assigned to this Diocese. There were 14 schools in Liberia, one in South Dakota, one in West Virginia and one in Kentucky. I want to thank those who helped in this splendid work and made it possible for over five hundred boys and girls to have a happy Christmas in 1924.

One of my plans for the new year is more schools giving to the Birthday Thank Offering. The money given this fund goes to Bishop Overs of Liberia for a new school building for boys to be located in the Bass country.

If your school is giving its Birthday Offering to another object, good and worthy though it may be, will you not plan to transfer it to the Birthday Thank Offering of the Church School? This fund was created by the National Department of Religious Education and approved by the National Council. There are leaflets about this work as well as the Church School Program, obtained from the Church Missions House and usually from me.

There are also prayer cards for the Birthday Thank Offering and Church School Service League.

If we are to get children for our kindergarten and primary departments of the Church School, we must begin to interest the mothers with babies. So we have the font roll in the school and the "Little Helpers' Department" of the Church School Service League.

"The Little Helpers" as the name indicates, gives even the smallest and youngest of Christ's members an opportunity to do its bit of service.

I wish we might have more enrolled in this department. There may be some who do not know that the offerings of these Little Helpers has provided kindergarten buildings in foreign lands, as well as fonts, and hospital beds at home and abroad.

This year I wish to carry out a suggestion made by Father Dew Brittain

at the Cedar Rapids Deanery meeting in the fall. He suggested that scrap books be made with pictures of our parish church, its church school, its pupils, and every thing about the life of the Parish church which would interest a group of children in a Mission School. Besides the pictures, there should be letters written by the children telling about their school activities, home and outdoor life, which would be of much interest to a child in a foreign land. Then in return, we might ask these same foreign children to send us something about their life which we would be glad to know.

So let us help to make the lives of the children less selfish by giving them something to do for others, and especially for those who need God. Let us have this as our motto: "To know Christ and to make Him known."

REPORT OF THE ANNUAL CONVENTION OF THE DAUGHTERS OF THE KING OF THE SIXTH PROVINCE

The Daughters of the King met in Des Moines, Iowa, for their tenth annual meeting at the time of the Diocesan Convention, January 18 and 19,

1925. We had Co-operate Communion at St. Luke Church at 8 o'clock, the Rev. Wilcox, of Newton, Iowa, officiating, after which breakfast was served in the Guild Hall. We attended the 10:45 service at St. Paul Church and later were guests at the homes of the ladies of the Parish.

The business meeting opened at 3:00 o'clock with a joint meeting of the Brotherhood of St. Andrew and the Daughters of the King at St. Luke Church. Prayers for the Orders were read by Rev. Wilcox. This meeting was addressed by Mr. Shelby, the general secretary of the Brotherhood. He talked about community worship and prayer, especially emphasizing the importance of prayer in the home and how much it has to do in influencing the younger members of the family as they grow into womanhood and manhood. He spoke of the Book of Prayers published by the Brotherhood of St. Andrew as being very useful in the home. At 4:00 o'clock the President Mrs. Farquharson took the chair and the Brotherhood delegates went into the Guild Hall to finish their meeting. Roll was called, twelve chapters responding. Forty-one delegates and visitors were present at this meeting. Deaconess Wirtz gave us a short talk telling us about her work and added a few remarks to what Mr. Shelby had said on family worship. Mr. Codling gave us his impression of St. Monica's Home. He told us of the wonderful environment the girls had around them and the good training and teaching they were getting. Rev. Williams closed this session with prayers for the Order and Benediction. Tea was served in the Guild Hall for the Brotherhood of St. Andrew and the Daughters of the King.

On Monday morning at 10:00 o'clock the session was called to order at the Y. W. C. A. by the President. We could not sing our hymn as we did not have any music. Deaconess Wirtz suggested that by the time of the next convention all the Daughters know the words of their hymn by heart. The Secretary's report was read by Helene Justus, secretary pro-tem, and approved. The treasurer's report was read, but as the delegates were not sure the amounts read were correct, Mrs. Gaynor made a motion and Deaconess Wirtz seconded it that each delegate take the amount for her chapter home to be verified and write the treasurer concerning it later. The reports were read from the following chapters: Christ Church, Waterloo; St. Mary's Chapter, Sioux City; St. John's Chapter, Mason City; Easter Chapter, Keokuk, sent her report as the delegate was unable to attend; Mrs. Lucy Gilbert of Algona told us what they were doing there; Grace Church, Charles City; Sarah Morrison Chapter, Independence; Bishop Morrison Chapter, Clinton; St. Cecilia's Chapter, Muscatine sent hers as the delegate was unable to attend; In as much Chapter, Des Moines; Sarah Swasey Morrison Chapter, Davenport; Marion Crandall Junior Chapter, Davenport; Bishop Longley Junior Chapter, St. Mark's, Des Moines. These reports were very inspiring and gave us all new ideas to carry to our chapters at home. We had hoped to have Mrs. Lamb and Mrs. Williams with us but sickness prevented them coming. A motion was made and seconded that a letter be written to them to let them know we were thinking of them. Mr. Lampson spoke to us of Camp Morrison, telling us the purpose of it, what they did there, how much good the boys who attended got out of it and finished up by asking each one of the chapters to send one boy and more if possible to the camp this year. He added that plans were on the way to have a camp for the Daughters of the King like this one. Deaconess Wirtz told us that at the last National Council they passed a motion that the convention held each year in January was to be called Diocesan not local.

A motion was made and seconded that resolutions be drawn up and sent to the relatives of the late Miss Iten of Clinton, Iowa, also a letter of sympathy be sent to Mrs. Hardin of Waterloo, who so graciously entertained us when the convention meet there in 1917. Deaconess Wirtz repeated the noon day prayers. Officers were then elected as follows:

THE FIFTH ANNUAL CONVENTION OF THE G. F. S. IN IOWA

The Fifth Annual Convention of the Girls' Friendly Society in Iowa was held in Des Moines January 17th and 18th.

The Convention was held in St. Mark's Church. The opening session was the meeting of the Diocesan Council at 10:00 A. M. presided over by Mrs. Anna G. Copeland, Diocesan President.

The meeting was opened with the service from the Service Cards, led by Miss May Case Marsh, National Extension Secretary. Several branches were represented.

Several matters were brought up for discussion, to be presented to the general meeting later. The most important question was the Summer Conference. After discussing last summer's Conference, which altho small in numbers, was very valuable, it was decided to hold one this summer. Mrs. Shepard of Spencer placed before the Council a proposition from Mrs. Bemis of Spencer. Mrs. Bemis, an Associate of Spencer, owns a very fine cottage at Lake Okoboji, which will give sleeping accommodations to about twenty-two people. She has offered her cottage to the G. F. S. for their summer conference.

After discussing the matter from every angle, it was decided to put the matter before the general meeting, that we hold two conferences, one at Lake Okoboji, from July 18th to July 25th; the other at McGregor, from July 27th to Aug. 3rd. The Rev. Weeks and Miss Marsh to be present at each conference.

Reports were then read from Branches who had paid their quota to the Washington National Center. Meeting adjourned. Lunch was served in St. Mark's Parish House.

The regular business meeting of the Convention opened at 2:00 P. M. with prayers by Rev. Pickworth of Mt. Pleasant, followed by an address by Bishop Longley.

Next the Roll Call was read by the Secretary, answered by eleven of 16 active Branches. Council Bluffs had the largest delegation, five members. Twenty-four members signed the register at the opening meeting.

The President then appointed her Committees. The Annual report of the President was read, followed by the Report of the Secretary and Treasurer. Next followed the reports of the various departments, several of which showed great activity, especially the Social Service and Missions.

Then followed reports of the Branches, several of which are worthy of special mention, Dubuque, Muscatine, Council Bluffs, Mt. Pleasant and Sioux City, Spencer and Rock Rapids.

Miss Marsh gave the regular address of the Convention, speaking on the work of the G. F. S. in general, and what the Society should mean to all its members. We will indeed miss not having Miss Marsh with us to give us advice and help as we are yet in the stage where we need help and need it badly.

Then followed the reports of the Committees. The Nominating Com-

mittee reported some changes in officers and the list was declared elected.
