The President's address (See page) was received with appreciation.

The diocese is to be divided into fifteen zones, headed by the following cities: Davenport, Dubuque, Decorah, Waterloo, Cedar Rapids, Ottumwa, Burlington, Marshalltown, Emmetsburg, Fort Dodge, Des Moines, Creston, Council Bluffs, Sioux City and Mason City.

The Treasurer's report was then read and approved.

An offering amounting to \$24.25 was then taken. Upon motion by Mrs. Nicholson, seconded by Miss Henderson, this amount will be devoted to the work at Ames.

Adjourned for luncheon in the Parish House.

MONDAY, 2:30 P. M.

After listening to the annual address of Bishop Longley, the session of the Woman's Auxiliary reconvened in the Parish House.

Bishop Morrison conducted devotions and made a plea for the needs of the Diocese and gave helpful suggestions for our work.

Report of the United Thank Offering Custodian was read and approved.

Motion made by Miss Henderson and seconded by Mrs. Frantz that the offering of the afternoon be sent to St. James Hospital, Anking, China. Carried. The offering amounted to \$20.17.

Miss Pauline Flint of Nashua, Iowa, a former teacher at St. Hilda's School, Wuchang, China gave an interesting talk of her work, exhibiting photos of the school and pupils, also showing some of their handiwork. The following message was sent to Deaconess Wertz, who, on account of illness was unable to be present:—

The Woman's Auxiliary of the Diocese of Iowa send love, greetings, and best wishes. Bishop Longley, in his annual address spoke most appreciately of your splendid work at St. Monica's Home. Your many friends are wishing for your restored health, and continuance in your consecrated service.

Bishop Longley opened the session with prayer. Minutes of the two previous sessions read and approved.

A communication from Mr. R. J. McKinney, director of the Davenport Municipal Art Gallery was read, extending courtesies to the delegates and visitors.

Report of the Church Periodical Club Secretary was read and approved.

Report of the Educational Secretary was read and approved.

Reports of the Deanery Chairmen were then given by Mrs. Drew of Marshalltown, Mrs. Longley of Iowa City, Mrs. Larson of Council Bluffs and Mrs. Ehlers of Dubuque. Moved by Mrs. Watzek and seconded by Mrs. Morgan that one thousand extra copies of the pledges made for 1926 be printed and be distributed to the Branches. Carried.

The report of the Box Secretary was read by Mrs. Forrest Treat in the absence of Mrs. Worthen.

The president introduced Mrs. A. A. Birney, National President, Daughters of the King, who gave a short address, stressing the point that this organization cooperates with every other church organization; the funds to carry on their work is obtained, not by money making schemes, but by self denial and thank offerings.

Sister Esther, St. Katherine's Hall, made a plea for more publicity for the school throughout Iowa, stressing the home life offered the student and the high scholastic standing of St. Katherine's. Ten states are represented this year among the students, but Iowa's quota has decreased, due probably to financial depression. The only income from which the school derives its support is from tuition and the proceeds of the Annual Fair.

Deaconess Affleck of St. Monica's Home emphasized in her address, that St. Monica's is not a maternity home. It is a place of refuge and training for those unfortunate ones who have been deprived of the proper environment. They have the three-fold problem, physical, mental and spiritual with which to contend. She stressed the need of a chapel and other buildings that the Home may function properly.

Mrs. Loomis of Mason City gave the report of The Girls' Friendly Society.

The report of the Daughters of the King was incorporated by Mrs. Birney in her address. The following recommendation from the Executive

Board was read and adopted, Resolved, that the various branches of the Woman's Auxiliary present their United Thank Offering at a Corporate Communion on the first Sundays of May and November of each year.

Report of the Service Program of the Church Schools was read by Miss Mabel Henderson and accepted.

Report of the Christmas Boxes was then read by Miss Mary Alice Bailey. Miss Bailey then took pledges for the 1926 Christmas Boxes.

By motion duly made and seconded the offering of the afternoon, amounting to \$16.22, was devoted to Tabor College.

PRESIDENT'S ADDRESS

Greetings! At this our first convention as your presiding officer, I wish to express appreciation of and thanks for the honor you have conferred upon me in giving me the responsibility and privilege of serving you in this office.

If the results of our endeavors tally with our desires and faithfulness in the work, with the help of the Holy Spirit, we will accomplish much this triennium.

Your presence here is an evidence of your interest in the work of the Master and your desire for the fellowship and inspiration to be gained in convention. The great spiritual awakening evident in Iowa and the whole Church, in its different departments, was evidenced at the General Convention at Detroit in 1919 when the National Council was created and the Woman's Auxiliary was made an Auxiliary to the National Council.

Our Diocesan Branch was reminded of our responsibility in that advance step when Mrs. Taber was sent to visit this Diocese last April. The W. A. has carried on the work as an auxiliary to the Board of Missions faithfully and well the past years. Now we are asked to expand our work to include the six departments of the National Council, of which we are an auxiliary. The Executive Board have sent "The Message" to awaken the spiritual vision of the Branches and call forth greater devotion and responsibility in our work in the Church.

Mrs. Taber was an inspiration to all of the Branches or Parishes that she visited. It is to be regretted that all of the Parishes could not avail themselves of the privilege of a visit from her.

We regret that Mrs. O'Rouke, our first Vice President, has felt that she must resign her official position as she is in Florida this winter. We will miss her from the Official Board. You will hear from the reports of the Diocesan Officers how each Branch has fulfilled its money pledges and its quota of supplies allotted by the Box Secretary. You will all commend Mrs. Wheeler's successful efforts in getting the Journal published so soon after the last Convention. Mrs. Cunningham continues her untiring efforts in her splendid work as Treasurer. Mrs. Morgan with her capable work as U. T. O. Custodian, has the honor of making our slogan \$5000.00 for the Triennial offering, more than come true. Mrs. Worthen, even though she retired from office last year, has faithfully carried on until a successor could be elected. Mrs. Kerfoot, Educational Secretary, and Mrs. Nicholson, Correspondent of Church Periodical Club, have done good work which you all appreciate, I know. Personally, I wish to thank each member of the Board and all of the branches for their cooperation in the work of the Iowa branch.

Two of the Deanery meetings met last fall before the General Conference and two afterwards. The Des Moines Deanery met at Marshalltown but through some misunderstandings the W. A. had no meeting planned but in the absence of the Chairman, Mrs. Drew, President of St. Paul's Branch called a meeting which was well attended by the women of the Parish and also, Mrs. Wycoff, the Diocesan Educational Secretary and the Diocesan President attended, the two later addressing the meeting.

The Muscatine Deanery, which I attended and addressed met at Fort Madison before the Triennial with a good attendance, but one could wish that all of the Parishes of the Deanery were represented.

After the General Convention, I attended and addressed the Sioux City Deanery which held an enthusiastic meeting at Harlan and the Dubuque Deanery, of which I was chairman, which met at Dubuque with a large representation and inspiring meetings.

The Deanery Chairman prepare the program, notify and interest the Parishes and preside at the meetings. There should be a large attendance to embrace the opportunity of fellowship and cooperation offered. I wish to thank the chairmen who carried on the work in behalf of the Deaneries.

There was no Provincial Synod at Cass Lake last fall as it was deemed inadvisable to have the meeting held so far north, as the Triennial met in the extreme south. Mrs. Leete of Evergreen, Colorado, was elected at the Provincial Synod, which met at Omaha, to represent the VI Prov. on the Executive Board. She is communicative with the Branches in a way that argues for her ability and demonstrates her interest. We wish to cooperate with her in every way possible. It was a great opportunity and privilege to go as a delegate to the Triennial at New Orleans last October. Iowa was one of the Branches to have its full representation of five delegates.

Mrs. Morgan, Mrs. Hutchens, Mrs. Cox, Miss Henderson and your President rose together in answer to the roll call with considerable pleasure in having the five delegates present.

The corporate Gift of \$100,000 dollars the W. A. voted to give to carry on advance work of the Churches Program is the *special* undertaking for this Triennium. Truly the power of the Holy Spirit manifested itself in this Corporate Gift. It was a pledge from the heart to assist those Missionaries who are doing our work for us. Our Diocese was honored by having one of her delegates—your President—placed on the Resolutions Committee of the U. T. O.

One New Branch has been organized since our Convention last year. Your President has attended two Summer Schools, the Sioux Falls Summer School and the Girls' Friendly Society Conference at Lake Okoboji; called a Board meeting which met at the home of Mrs. Longley, our honorary president, in Des Moines, November 3rd, being attended by all but three of the Board members; attended and addressed the meetings of the four Deaneries; directed Mrs. Taber's visitations to the Parishes by mail; entertained her in my home a week, at different times; sent out three circular letters to each of the fifty Parishes and Missions; prepared the articles for publication in each of the Iowa Churchman issued since my coming into this office; corresponded with the Parishes and Missions in the Dubuque Deanery and presided at the meetings of the Deanery; attended the Triennial at New Orleans as a delegate representing you at a called meeting of the Sixth Province in New Orleans; being honored by the appointment, by Bishop Morrison, to act on the Committee which represented Iowa at the two meetings of the Field Department of the National Council at the General Convention; and lastly, wrote, including the three circular letters sent out, four hundred and twenty-one letters.

As your presiding Officer may I ask that we work together with hearty cooperation, more earnest prayer and consecrated effort, this Triennium, to bring the world to Christ.

In Convention assembled, Davenport, Iowa.

Greeting:

In 1924 the Supply Secretary's Report showed an increase of 23% over 1923, so it is with a great deal of satisfaction that your Secretary is able this year to report an increase of about 35% over the shipments of 1924.

28 Branches have responded promptly, cheerfully and liberally. Quotas have been filled as assigned. Some Branches have made additional shipments to unassigned missions, and while the spirit which prompts this is very commendable, it is desired that Branches communicate with Supply Secretary before shipping anything other than as assigned, as it is possible the Supply Secretary already has a quota which could be assigned your Branch, thereby working in closer co-operation with our General Supply Secretary of Church Missions House, New York.

It is urgently requested that each Branch begin now to accumulate good second-hand garments, so they may be shipped early next Fall. Shipping instructions will be sent about August and if already collected, there need be no delay.

The Girls' Friendly Society has helped materially with the Box work and they have their assignment for 1926 and shipments will be made by Easter. The value of their boxes in 1925 shows a material increase over the year before, with ten Branches responding.

May the spirit of "doing for others" permeate our work during this year.

REPORT OF THE SERVICE PROGRAM OF THE CHURCH SCHOOL

January 1st, 1925—January 2, 1926

Again, I am making the annual report of the work of that part of the National Council, which we have come to know, or should know, as the Service Program of the Church Schools.

Possibly many have not heard of the change in name—still calling it the Church School Service League. Over a year ago our diocese adopted the former name.

Since the Triennial in New Orleans, I received a very important letter from Miss Withers, the Secretary of the C. S. S. L., from which I wish to quote a few paragraphs.

"At our conference in New Orleans I predicted that if the Church School Service League were really successful enough, the time would come when it would no longer exist as a separate organization.

"This change means that our Service Program as planned by the League and set forth in 'The Service Program of the Church School' will be carried forward in a much wider circle of parishes than heretofore. We now recognize that training in service, as Mr. Suter has said, constitutes one of the two primary functions of religious education. To make this feature of religious education more prominent, the present plan is to ask every Church School in the country to put it into effect as a *Church School*.

"My work here at the National Headquarters is the same as it was before except that it has been broadened to include the Program of Service (and Gifts) of all the boys and Girls of the Church. My contact with the diocese remains the same. Your diocesan committee will, therefore, of course continue to send to me the same annual reports as heretofore.

"The reason for making the change is simply in order to emphasize still further the fact that membership in a Christian Church School is in itself a sufficient reason for rendering service (through work and gifts) to Christ through one's neighbors. We did not wish to have it thought that in order to feel a motive for service a child need join any other organization in addition to his Church School. This will be the position taken at National Headquarters; but, as I said before, each diocese and parish will follow its own choice in the matter of nomenclature."

In our diocese reports show a steady growth both in service and gifts.

The Birthday Thank Offering which I had the honor of presenting at the Triennial in New Orleans, at the time of a special service, was \$204.67. That was more than double the amount given three years ago by this diocese. The total given by all of the boys and girls from all over the World was over \$23,000. This was for the new boys' school in Liberia.

I am much pleased with the increased interest in the Christmas Joy Boxes under the leadership of Miss Mary Alice Bailey. Her report shows a gain of 2 parishes over 1924—117 more children provided with gifts, and an increase in the value of boxes to the amount of \$93.35.

I have sent out many letters during the year. Every priest in the diocese has received samples of all the leaflets and prayer cards prepared by the National Council for the Department of Religious Education. They have been asked to use the Lenten leaflet, "Call to Service," and the very splendid posters prepared for the use of the Church School.

I have no report to make of how many were used by the schools, or if any study classes were held.

Now in regard to the work for 1926, I would mention the new

project for the Birthday Thank Offering, which is a new wing for the Hooker School for girls in Mexico City. The new literature for this, consisting of prayer cards, envelopes for offering, and description leaflets, are now ready and to be had from the Book Store, 281 Fourth Avenue, New York. Also order the study books from the latter place—the books for this year's course are as follows—Subject: *Latin America*

REPORT OF THE ANNUAL CONVENTION OF THE DAUGHTERS OF THE KING OF THE SIXTH PROVINCE

The tenth annual meeting of the Local Assembly of the Daughters of the King was held in Davenport at Trinity Cathedral, February 7 and 8, 1926; at the time of the annual convention of the Diocese of Iowa.

The Convention was opened at 8:00 o'clock with celebration of Holy Communion at the Cathedral, the celebrant being The Dean; after which a delicious breakfast was served in the Parish House by the girls of Sarah Sweesey Morrison Chapter.

At 9:30 o'clock we attended the children's Eucharist Service, Rev. Rodney Cobb being the celebrant. This was indeed a very impressive service.

Bishop Weller of Fond du lac gave an interesting sermon at the

11:00 o'clock service. At this time Bishop Morrison blessed the Eucharistic candlesticks that the Marion Crandall Junior Chapter of the Daughters of the King gave in memory of their beloved leader and advisor, Mrs. Madeline Ficke who recently was called to the great beyond.

The joint meeting of the Brotherhood of St. Andrew and the Daughters of the King was opened at 3:00 o'clock, 56 being present. Prayers for the Orders were read by Rev. J. J. Wilcock. This meeting was addressed by Mr. Wm. Pelham who is a member of the National Council of Brotherhood of St. Andrew. He spoke of the importance of having a Chapter of Brotherhood and Daughters in every parish; emphasizing the fact that each day they should do something in bringing one more person nearer to Christ. He told of several incidences where he brought men into the service of God. He said when traveling on a train or street car he always made a point to sit in the seat with a man, a stranger if possible and before the journey ended talked of the subject nearest his heart—duty and service to God. Our beloved National President, Mrs. A. A. Birney gave a short but interesting talk emphasizing what Mr. Pelham had said and giving her experiences along the same lines. She spoke of our missionaries, the funds we send to them and how they are used. Finishing up by reading an account on "The Inner Life of Christ."

At 4:15 the Daughters of the King retired to the Auditorium of the Parish House where our President, Mrs. A. J. Busby called the meeting to order. Mrs. Birney led us in saying the prayers for the Order. Ten Chapters answered roll call, 40 daughters being present. We had more than usual to be thankful for this meeting as we had with us our dear friends and co-workers, Mrs. A. A. Birney our National President of Washington, D. C. and Mrs. Lamb an honorary member of the National Council of Denver, Colorado. As our time was limited they did not give an address but answered the problems that the different chapters found confronting them. We were all glad to have the opportunity of having our difficulties solved by two who have had so much experience and knowledge along spiritual lines. They impressed on our minds that it was not the big things we do but the little acts of kindness that count the most in our everyday life. Mrs. Busby closed this session with prayers.

The next and most memorable service of all was Evensong at St. Katherine's Hall. No words I could use would describe the beauty and simplicity of this service. Rev. Burroughs of Ames gave a short address, his text being—"Almost."

At 11:00 o'clock Monday morning the business meeting was called to order in the Parish House by our president Mrs. A. J. Busby and opened with prayers and the singing of hymn number 586. A telegram was read from Mrs. Shayler of Omaha, Nebraska, telling us how sorry she was not to be able to be with us but due to illness of the Bishop it was impossible. There was a discussion about members dropping out of the chapters for awhile and then wanting to come back in again without renewing their vows. Mrs. Birney said this was not allowed. Mrs. Lamb suggested how nice it would be if each chapter in the Diocese would go in a body on All Saints Day to their church and renew their vows yearly. The Secretary and Treasurer report was read and approved. Mrs. Lucy Gilbert of Algona told us what her chapter was doing and paid her national and per capita tax for 1926, also paid those of two lapsed members in her chapter who had renewed their vows. Reports were then read from: Bishop Morrison Chapter, Charles City; Bishop Morrison Chapter, Clinton; Sarah Sweeney Morrison Chapter, Davenport; In As Much Chapter, Des Moines; Sarah Morrison Chapter, Independence; Easter Chapter, Keokuk sent a report as the delegate was unable to attend; St. Cecilia Chapter, Muscatine; Christ Church Chapter, Waterloo; Marion Crandall Chapter, Junior, Davenport;

Bishop Longley Chapter, Des Moines. From these reports we received many new ideas to carry to our chapters at home. Special stress was laid on the importance of paying dues on time so everyone will receive all copies of the Royal Cross. Mrs. Wallingford, Miss Heller and Mrs. Farquharson were appointed on a committee to draw up Resolutions to be sent to the family of the late Mrs. Ficke, who was the beloved leader of the Marion Crandall Junior Daughters of the King. It was moved and seconded that a letter of regret be written to Mrs. Shayler and Deaconess Wurtz. Mrs. Lamb suggested that a list be kept of the daughters that pass away during the year and sent to New York so they will be remembered in the floral design at the Tri-Annual Convention. The problem of making money to send a delegate or to pay half of her expenses the next Tri-Annual Convention was discussed. Mrs. Farquharson made a motion that each daughter in the Diocese be assessed 10 cents for the next two years to help toward this expense. Mrs. Wallingford seconded it. This is to take effect at once. Mrs. Busby led in saying the noon-day prayers of the Order.

THE SIXTH ANNUAL CONVENTION OF THE G. F. S.
IN IOWA

The sixth annual Convention of the GIRLS' FRIENDLY SOCIETY IN IOWA was held in Davenport, February 6 and 7, 1926.

The first meeting was held Saturday afternoon at 1:30 in the Guild Room of the Parish House. The meeting was called to order by Mrs. F. W. Shepard, Vice President. Bishop Morrison led the service, using the Service Card. He then addressed the meeting in his usual kindly manner, and incidentally learned more about the G. F. S. in Iowa. It is always a great pleasure for us to have our Bishop with us.

Next followed the Roll Call. Nine Branches answered at the opening and later, Mrs. Leedham of Lyons arrived, making a total of ten branches represented, by Branch Presidents, and six sent other delegates. Twenty-eight in all signed the register. One, Miss Clayton Nolan, of Hamilton, Ontario, attended most of our meetings. She said she had been in Davenport a year and at last she felt at home.

In 1923, at Des Moines we had six branches represented, with a total registration of 10. In 1924, in Davenport we had nine branches with a registration of 27. In Des Moines, in 1925 we had ten Branches, with a total of 23. When we remember that three Branches have to cross the state, we must know that the G. F. S. in Iowa is in earnest.

The President's report, written by Mrs. Zwemer, and read by Miss Bick, was a splendid one. It dealt with the steady growth of the Society and also the wonderful success of the Conference this year. It was thru Mrs. Zwemer's untiring efforts that we reached the peak we did this year, and we feel sure that her influence will be felt for quite a while in our Diocese. We can only think how lucky Illinois is to have such a worker drop down out a clear sky to them. The report was accepted.

No report was read from the Vice President, Mrs. Copeland. The Secretary's report was read by Miss Bick. In 1924 we had 188 members and 168 Candidates, which with the Working and Honorary Associates, made a total of 483. In 1925, we had 211 members, 110 Probationers, 220 Candidates; with the Associates, a total of 644, a gain of 161. One Branch was started this summer at Estherville and one re-organized at Iowa Falls as a result of the Conference.

The income of the Branches for 1925 was \$2246.51; in 1924, \$1642.38. The Expenses in 1925, \$1211.07; in 1924, \$660.55. Six Branches have completed their quota to the Washington Center, 10 had held Bible Classes and classes in Religious Instruction. All helped to sponsor the Conference and all gave to one or all the Missionary objects. It was accepted as read.

The Treasurer's report was read by Miss Bick. During 1925, there was deposited in the City National Bank, Council Bluffs the following:

Next followed the reports of the Heads of Departments. Miss Johnson,

of Council Bluffs read the report of the Commendation Department. This department is not used as much as it should be, but we hope, that as time goes on that it will be used every time a girl leaves the Diocese.

This report was accepted.

Mrs. Loomis, now of Mason City, gave the report of the Department of Literature. Showed that several of the Branches had classes of various kinds, Bible classes, Mission works and various kinds. Report accepted.

Mrs. Biddinger, of Rock Rapids, read the report of the Head of Candidates. This department has indeed shown great growth. With such a leader we hope to do many more times the work in 1926. This report was accepted.

Miss Myra Gault, Head of Holiday House and Conference, sent a very fine report, read by Miss Bick. Gave report of the Conference in detail. Also of various ways and means trying to be used to get a permanent summer house for the G. F. S. in Iowa. We had sums amounting to \$21.00 given to use for this purpose, the list being headed by Mr. and Mrs. W. S. Bemis of Spencer. Report accepted as read.

Miss Kennedy, Head of Missions, always has a splendid report to read. A total of \$84.90 was given to the three Mission objects. Boxes amounting to \$268.95 were sent to various Missions. United Thank Offering \$32.90, making a grand total for Missions for 1926, \$386.75. Report accepted.

Miss Thorson of Mt. Pleasant, Head of the Social Service Department, read a splendid report. Over 1,000 was given to the various charities, in boxes, parties for children, to help girls in High School, milk for babies, baskets for old folks, help to Children's homes of all kinds. It was wonderful to think that we could help in so many ways. Surely we aim to Bear One Another's burdens. Report accepted as read.

Mrs. Loomis at this time, spoke of the Traveler's Fund which we are trying to create. This fund will permit the Vice Presidents and other Diocesan Officers to visit the various Branches, especially the new and weaker ones. A discussion followed, as to the ways and means to be used in procuring this money. It was suggested that each Branch contribute to this fund. In case the Rector would not want to give all the loose offering of one Sunday in the year, it was suggested that envelopes, marked for GIRLS' FRIENDLY could be used.

The following motion was made: Moved that all the money received by the Diocesan Treasurer, not used for expenses, dues, books, supplies, and for Heads of Departments, be given to the Traveling Fund, this to be used upon the advice of the President. Motion was seconded. Carried.

Miss Deming, Chairman of the Nominating Committee, made her report at this time. She reported asking Mrs. Lyon to accept the office of President for this year. She had not learned whether Mrs. Lyon would accept or not. Was instructed to send a telegram to Miss Gault and to report later.

The following were nominated, for First Vice Pres., Mrs. Shepard.

A motion was made that the nominations be accepted and declared elected. Seconded. Carried and these officers declared elected.

Miss Myra Gault was asked to be head of the Publicity Department in connection with the Conference. Mr. Stockley, of Fort Dodge, at this time, came before the meeting and said his intentions are to make the Iowa Churchman a 16 page paper and that he would like to give the Girls' Friendly about 200 words each month. This is to be sent to Miss Gault.

Iowa Falls was inactive in 1925 but will be ready for work in 1926. Iowa City sent no report, not even that they had been inactive. Mrs. Leedham of Lyons read a good report. Miss Thorson of Mt. Pleasant reads a stronger report each year. Also Muscatine, read by Miss Kennedy. Mrs. Hough, of Newton, read the report of her Branch. We feel that Mrs. Hough went home with the determination to grow lots this year.

At this time the meeting adjourned in order that all might enjoy the meeting of the Department of Religious Education. Following this meeting all attended the dinner in the Parish House.

Sunday morning the Girls' Friendly attended Corporate Communion at 8:00, after which they enjoyed the breakfast served in the Parish House. Several attended the Children's Eucharist, followed by the service at 11:00.

The afternoon session which was to begin at 2:30 was opened at 2:45, Mrs. Shepard, acting as President. Bishop Longley led the service and also gave a talk and in turn learned of some of our work. Then followed the regular business of the meeting.

Mrs. Evans, President of the Ottumwa branch, read a splendid report and showed activities of many kinds. We were very glad to have Mrs. Evans with us, as also Mrs. Hunter and Mrs. Hough for their first G. F. S. Convention.

Rock Rapids report was read by Mrs. Biddinger. She reported growth since last year.

Sioux City did not have a regular report but the enrollment, and other information was read from their Branch report by Miss Bick. Sioux City also has shown that the Friendly is growing in Iowa. With Miss Helen Gooch as president, and several strong groups already in the field, we may expect to hear more from them next Convention.

Mrs. Shepard read the report of the Spencer branch. It too had accomplished a great deal this year.

Next was the reading of the report of the Head of the Finance Committee, Mrs. Loomis. She reported that six branches were quota branches in the National Center project, that is, are all paid up, for two years assessments. Others are planning on making some headway this year. She reported that in 1924 we paid in to the W. N. C. \$234.90; in 1925, \$288.00; in all, \$522.90.

At this time a telegram was received from Miss Gault, saying that Mrs. Lyon could not accept the nomination, so nominations for President were in order. Miss Deming and Miss Johnson were nominated. Miss Johnson declined so a motion was made that Miss Deming be unanimously elected. This was seconded and carried, and Miss Deming, the new President took the chair.

The resolutions Committee were instructed to send a letter to Miss Marsh and to Mrs. Zwemer, regretting their absence and assuring them of our love and devotion.

The awarding of the Banner was the last on the program for 1925 business. Sioux City, Muscatine, Rock Rapids, Council Bluffs, and Newton were entered in the contest. After seeing the fine red banner brought by Rock Rapids we all began to feel that the banner would go there again this year, as in fact, it did. They had completed each of the requirements set down by Miss Marsh, as had Muscatine, but Rock Rapids had a greater number of members admitted by service during the year. Council Bluffs also came near, as did Sioux City, which needed the mission objects to complete their work. It was wonderful to see how many points the small branch of Newton had completed. So you see, in 1926, each will work still harder to acquire this beautiful banner.

Before adjourning, it was decided not to make any definite plans for the Conference at this time. It had been discussed pretty thoroughly on Saturday, but no decision could be reached. President Clayton of Tabor had brought a new offer to the Convention. That a summer conference could be held at Tabor, costing a very small sum, and giving the use of the buildings. It was thought that as the Bishops and Diocese were all so anxious to help this school that it would be well for us to join this group this year. Decision to be made later. It was not considered advisable to agree to take the Y. W. C. A. camp, as it would be a large sum to make good in case the hundred did not go for the week.

The meeting then adjourned, after which the members were taken to St. Katherine's School, and then back to the Parish House as guests of the Daughters of the King. We are indeed indebted to the Daughters for the delightful way in which they entertain us when in Davenport. Our President, Miss Deming thanked them for the Society as a whole and we parted, each feeling that the meeting had been altogether too short and hurried, but with many friendships renewed and new ones formed, we will look forward to our next meeting.
