## PROCEEDINGS

The fortieth Annual Convention of the Iowa Branch of the Woman's Auxiliary to the Presiding Bishop and Council convened in regular session at Dubuque, February 7th and 8th, 1927.

### MONDAY, FEBRUARY 7TH

The Convention was opened with Corporate Communion at St. John's Church at 7.30 A. M.

Adjourning to the crypt of the Church the session was opened by Bishop Longley leading the devotions also giving an inspiring talk on the Bishop's Crusade.

The secretary read the roll-call of parish branches, twenty-nine responding. The minutes of the 1926 convention were read by the secretary.

The president appointed the following committees:

Credentials—Mrs. LeRoy Burroughs, Mrs. Richards, Mrs. Marks.

Resolutions—Mrs. W. E. Mann, Mrs. J. W. Marsh, Mrs. Martin.

The report of the secretary was read and accepted.

The president then read a summary of her year's work, which will be found elsewhere in this journal.

Owing to the absence in California of the treasurer, Mrs. Cunningham, her report was read by the secretary and is published in full in this journal.

The following reports were read and accepted;

U. T. O. Custodian, Mrs. V. H. Morgan.

Educational Secretary, Mrs. John Flockhart.

Supply Secretary, Mrs. A. W. Brown.

These reports in full will be found elsewhere in this journal.

Miss Hope Elizabeth Haupt gave an interesting talk on her work among the various Indian tribes stressing the fact, that contrary to general belief the Indian is not a vanishing race but is steadily increasing in numbers and ask, not so much our help, as justice. She urged the sending of Christian matrons to the tribes, carrying the Bible in one hand and scrubbing brush in the other.

The president asked Mrs. W. N. Wyckoff to take the pledges for the coming year.

Rev. Elmer M. Wright, rector of St. Mary's of the Virgin, Keokuk, gave an informal talk as to the work carried on in his parish, the only Episcopal Church for Americans of African descent in Iowa. Many improvements have been added to this Church during the past year, the altar rail, a gift of the Senior Warden's wife, new lighting system installed, a Mission held, and organized branches of the Woman's Auxiliary and the Girl Reserves. This year commemorates the fortieth anniversary of the founding of St. Mary's of the Virgin.

The collection taken, amounting to \$20.29 was ordered by vote of the Convention to be given to Tabor College.

The president read noon-day prayers.

Rev. Wallace Essingham, rector at Estherville, made a plea for the new building project at Ames and told of his plan for raising the \$60,000.00 necessary. Motion made by Mrs. Maria Jackson and seconded by Mrs. Nicholson that we give approval to this project and pledge our prayers and cooperation. Carried. Adjournment.

### MONDAY, FEBRUARY 7TH—2:30 P. M.

The session opened with prayers by Rt. Rev. C. P. Anderson, Bishop of Chicago. He has always "recognized the importance of the Auxiliary to the Church" and asked all to remember that they "not only give but get"



and that "the Woman's Auxiliary is a part of a steady pressure in building up Christian Civilization."

The president appointed a nominating committee consisting of M.s. J. W. Watzek, Mrs. B. M. Cobb and Mrs. Rankin.

Pledges amounting to over \$200.00 were taken for the Ames Building Fund. \$50.00 of this amount being part of a \$150.00 surplus in the Educational Fund which can be diverted to other purposes.

The Nominating Committee reported and the chairman moved that the present officers be re-elected for the ensuing year. Carried.

The following were nominated as delegates to the Provincial Synod, Mrs. E. B. Soper, Mrs. B. M. Cobb, Mrs. Jessie Jones, Mrs. Robert Flockhart, Mrs. LeRoy Burroughs. Elected by acclamation.

By motion duly made and seconded the president was authorized to fill the alternate list. Carried. The following were appointed, Mrs. John Flockhart, Mrs. J. W. Watzek, Mrs. L. W. Wheeler, Mrs. C. F. Hinton, Mrs. A. W. Brown.

Motion made and carried that the expenses of the U. T. O. Custodian to the Annual Convention be paid from the Diocesan treasury.

Motion made and carried that the operating expenses of U. T. O. Custodian be paid from the Current Expense Fund.

The committee on Constitution and By-Laws, Miss Fern Fitzsimons and Mrs. L. W. Wheeler, reported their work as ready for presentation to the Convention, having been approved by the Executive Board. The Secretary then read the new Constitution and By-Laws, after discussion they were adopted as read.

The following reports were read and accepted:

Correspondent Church Periodical Club, Mrs. R. A. Nicholson.

Gold and Silver Offering, Mrs. Forrest Treat.

Mrs. Treat asked that a collector for this Gold and Silver Offering be appointed in each Parochial Branch. The money derived from this offering will go towards the building of a school for boys and girls in Tokio, Japan.

Mrs. J. W. Watzek then presented the work of the Sarah Swazey Morrison Memorial Fund, reporting approximately \$5000.00, including interest, up to date. The Convention urged her to continue with the work, completing the amount (\$10,000.00) originally planned to be devoted to a scholarship at St. Katherine's. A rising vote of thanks was given Mrs. Watzek for her generous gift of \$1000.00 to this Fund.

An offering was then taken amounting to \$59.00 which was, by vote of the Convention, given to the S. S. M. M. Fund.

Pledges for this fund were called for from the floor, amounting to \$360.00. The remaining surplus in the Educational Fund (\$100.00) was devoted to the Memorial Fund.

Mrs. E. B. Perrigo, Field Secretary for St. Katherine's School and Kemper Hall, Kenosha, reported St. Katherine's School in it's Forty-fifth year of existence, the enrollment this year showing a decided increase over 1925 and 1926. A new departure is the opening of a kindergarten with an enrollment of sixteen. A special effort was made during the early spring and summer to make the people of Iowa better acquainted with the school. Letters and catalogues were sent out and a Field Secretary engaged to call on prospective students. This has resulted in several enrollments and in interesting many others.

Mrs. John Flockhart, Educational Secretary, gave a most instructive demonstration of a Study Class.

## TUESDAY, FEBRUARY 8TH—9:30 A. M.

The session was opened by Rev. James Colletti of Burlington leading in devotions.

Minutes of previous meetings read and approved.

## REPORT OF THE PRESIDENT

To the Woman's Auxiliary of Iowa:

In giving this report to you, at this fortieth Annual Convention of Woman's Auxiliary of this Diocese, your President is thankful to be able to note progress this past year.

We feel that your vote at the last Convention to district, Iowa has resulted in good. The fifteen Districts have functioned twice, having meetings both last May and October, with one exception. The Chairman in each District has proven her ability to lead the Districts to realize our aims which are Education, coordination of the work of all women of the Parish, fellowship, cooperation and reaching the "Isolated."

Your president in establishing the District plan has given fifteen District chairmen of Religious Education to work with the Diocese Secretary of Religious Education in carrying forward the Educational work. Also, there are fifteen District chairmen of Christian Social Service to work under a Diocesan leader. We have appointed fifteen District Chairmen of Church Extension distributed according to conditions in different District centers. Church Extension, as now used by the Extension Board, includes the departments of Missions, Publicity, Field and Finance.

In every District there is a Chairman of Publicity whose duty it is to obtain subscriptions to the Spirit of Missions. Each parish and Mission should have a Publicity Chairman. The appointing of a Publicity Chairman in one Mission, alone, resulted in fourteen new subscriptions to the Spirit of Mission's magazine.

In other Districts a chairman of the Field department has been appointed, whose work it is to locate the "Isolated" and get them to the District meetings and interest their District in those people less favored with the privileges of the church than themselves.

The District meetings will prove their usefulness more and more as we realize their possibilities of service one to another. Their purpose in having reports given by the different branches giving their methods of work. Also the opportunity given the departments of Religious Education, Christian Social Service and Church Extension to impart information and inspiration to the Districts.

It rests with each District to utilize all of its possibilities and make the meetings an increasing help in uniting the work of the women of the parish, the district and the diocese.

The three Deanery meetings were ably carried forward by the chairman of each, who will report later upon the success of each Deanery.

All of the Branches have been striving to fulfill their pledges in gifts and money as you will learn from the reports of the Diocesan officers. I am sure you will appreciate the capable work of Mrs. L. W. Wheeler, Diocesan secretary in getting out a larger journal so soon after the Convention. She has, as Chairman of the Committee on the revision of the Constitution, had much work added to her usual duties.

Our First Vice-president, Mrs. Forrest Treat, accepted the chairmanship of the Gold and Silver offering in addition to her duties as chairman of Davenport, District I. Under her able leadership a most successful District meeting was held in Lyons, Grace Church Parish House last October. The Gold and Silver offerings appeal to all in making it possible for us to aid St. Margaret's school for girls in Tokio, Japan. This year she will stress this part of the Woman's Auxiliary work. We regret that Mrs. Cunningham cannot be with us at this time. This is the first Convention that she has missed since holding the office of Diocesan Treasurer for the past ten years. She has sent a complete report to be read.



We all appreciate the untiring efforts of Mrs. Morgan as Custodian of the United Thank Offering, which is larger than it was three years ago at this time. We cannot commend too highly the progress made in the department of Religious Education by Mrs. John Flockhart, as you will learn from her report. Many more Branches have undertaken some kind of Educational work under her leadership. Mrs. A. W. Brown has overcome many difficulties this past year in her work as Box or Supply Secretary of the Diocese. Not the least of which was the filling of the unusually large quota assigned to this Diocese. We all rejoice with her in her success in overcoming all obstacles.

The Correspondent of the Church Periodical Club, Mrs. Nicholson, has had many difficulties and deserves appreciation at our hands for all she has accomplished. When Mrs. Watzek accepted the chairmanship of the Sarah Swazey Morrison Memorial Fund, its success was assured. Mrs. Watzek has led the way with her very generous gift of \$1000.00 to this Memorial and our expression of thanks will be voiced from the floor at the proper time.

You have emphasized to a far greater extent this year the devotional life through the message and the two days of intercessions. The first one, October 15th, was observed by all of the Branches as a day of prayer. Friday, January 28th, was observed in like manner. Both of these days were set aside by the Commission on Evangelism for intercessions for the Bishop's Crusade. It has been a privilege, which I have enjoyed, in Des Moines. Your Diocesan Board met in Des Moines last September in a called meeting in the interest of the Woman's Auxiliary work in this Diocese.

Miss Grace Lindley, National Executive Secretary of the W. A., sent to your President a sum to be used in furthering the District plan in our state. It was all used for that purpose. Among other things in paying the railroad fare of the speakers who addressed the October District meetings. The speakers were: President Fredrick Clayton of Tabor College; the Rev. Harry S. Longley, Jr.; the Rev. Wallace Essingham and the Rev. James Creede. We owe them a debt of gratitude and more appreciation than I can put into words for their unselfish service in behalf of the work of the women in this church.

The May District meetings were addressed by Miss Edna Beardsley, new Field worker of the Executive Board. She gave instruction and information as well as inspiration to all who had the privilege of hearing her. This year we have added eight Branches, new or revived, to the Woman's Auxiliary. Our interest in St. Mary's the Virgin, Keokuk, has been rewarded by the organization of a new branch in that church. We are thankful that these parishes and missions are extending their influence and hope others will follow their example.

At the Provincial Synod at Sioux Falls, South Dakota, last September all of your delegates present and responded to roll call as follows: Mrs. John Flockhart, Mrs. Robert Flockhart, Mrs. E. B. Soper, Mrs. Biddinger, and Mrs. Jessie Jones, your president. Mrs. Biddinger was appointed to take the place of Mrs. Longley, who was unable to attend.

It was also, my privilege to attend the Summer Conference at Sioux Falls last June. You will wish to hear the names of our six Missionaries in the Field from Iowa: Miss Charlotte Anderson, Wauchang, China; Miss Frances Merrill, Boone University, Wauchang, China; Miss Pauline Flint, home on furlough, St. Hilda's, Wauchang, China; Miss Laura Moffit, St. Andrew's Hospital, Wusih, China; Miss Rachel Revell, (Ames), Tokyo, Japan; Miss Elizabeth Ruley Miller, (Ames) St. Andrew's Priory, Honolulu; Miss Clara B. Whitmer in a Hospital in China (Independence, Iowa)



Your President has sent out 442 letters, mailed to all Branches the card prayers and the leaflet, "Prepare ye the way" for use during and after the Bishop's Crusade, made the itinerary and dates for the speakers for both the May and October District meetings, visited thirty-six parishes and missions and addressed 41 meetings. I have edited the page in the Iowa Churchman given to the Woman's Auxilliary to the National Council giving each department of the Diocesan Board an opportunity to present their work.

The hospitality of St. Katharine's school was extended to me giving me the pleasure of a visit to the school. The inspiration gained from that visit gave me great enthusiasm for the work being done at St. Katharine's for the higher Education, Culture and Christian training of our girls.

When in Des Moines I accepted an invitation to visit St. Monica's Home and talked to the girls. I found it a homelike place with a mother, in Deaconess Affleck, that the girls look up to and love. The following day, Sunday, I attended St. Luke's Church in Des Moines and saw eight of the St. Monica girls confirmed by Bishop Morrison. That speaks for the training they get and the reclamation going on. Let us make it our aim this year to ~~strengthen~~ whatever is weak in our individual lives and in our life together as a branch, as a district and as a diocese. "No chain is stronger than its weakest link."

"To every man there openeth  
A way, and ways, and a way;  
And the high soul climbs the high way,  
And the low soul gropes the low;  
And between on misty flats  
The rest drift to and fro.  
But to every man there openeth  
A high way and a low,  
And every man decideth  
The way his soul shall go."

## REPORT OF THE DIOCESAN EDUCATIONAL SECRETARY TO THE WOMAN'S AUXILIARY

FROM JANUARY, 1926 TO JANUARY, 1927

Your Educational Secretary is pleased to make the following report for the year which just closed. I feel the report indicates greater interest in the matter of Religious Education on the part of the Diocese as a whole as well as on the part of the Woman's Auxiliary.

Because the Woman's Auxiliary is an Auxiliary to the National Council and, because our work is similar to the work of the National Council, the Auxiliary would not be covering all fields of work unless it maintained a department whose sole purpose was the education of people—the spreading of propaganda. It is a fact taken for granted that we are trying to make people missionaries, either at home or abroad in the world, but we cannot make them missionaries either in head or in heart by saying to them, "Be a missionary." People must be trained and educated to be missionaries in their lives as well as intelligent, missionary-minded people.

That is the task of the Secretary of Religious Education as your present secretary interprets it.

Education is the basis of all work and interest in the Auxiliary. There is no possibility of intelligent prayer or work without study. It is a fact well recognized in the business world that lack of knowledge results in lack of interest and, very generally, in prejudice. Articles are sold because of a very thorough system of advertising, institutions are supported because of campaigns of information putting the needs and values of the institutions before the public; great causes are upheld by systems of education. Strange to say, we all fully realize this in our everyday life, but, in our religious life, we fail woefully to apply this same principle and yet we expect people to be interested in the Church and its work without knowing anything about it.

Through my office in the Department of Religious Education of the Bishop and Council of the Diocese I can report a steady growth and development on the part of the boys and girls of the Diocese in the matter of study work, gifts, and service. In my contacts with the Field Department I can report over 300,000 pieces of literature distributed to the entire Diocese within the past twelve months. The Publicity Department has urged greater circulation of the Iowa Churchman and has endeavored to have every copy of the Church at Work mailed direct from publisher to communicants in the Diocese.

Miss Edna Beardsley of New York was secured by our President as the speaker for the May District Meetings. Miss Beardsley brought to us all a new vision of the Woman's Auxiliary, a clearer insight into the value of Auxiliary work as well as greater inspiration for further study of the Church and her work in the world.

The Fall District Meetings gave us an opportunity to learn more fully from some of our own clergy what the Church and her teachings can mean to us all. Every message was worth traveling many miles to hear.

Free copies of "The World Call to the Church" were sent to every branch in October. These copies were obtained through the courtesy and cooperation of the Field Department.

As a result of the above facts together with the impetus of the Bishop's Crusade, a questionnaire to the Diocese revealed the fact that there have been 29 parishes and missions in the Diocese in which Study Work has been carried on this past year and a total of 1182 people attending the various kinds of classes. The following kinds of classes for adults were held: 25



Discussion groups, 11 Parish Institutes, 15 Normal Training Classes, and 9 Study Classes. May I add that, among the latter, one was a Parish Men's Club where the meetings were devoted to study as well as pleasure. Many reports showed that people felt that their classes were not all that they should be either in conduct, inspiration, or attendance. But, the worthwhile feature is the fact that there are some people who really want to learn, who are really interested, who really CARE.

Beside the above figures, I can report a total of 33 people at the various Summer Conferences. This does not include the attendance at Camp Morrison. With our own Summer Conference in 1927, I am sure we can all look for added interest and added enthusiasm for the work in 1928.

Your secretary has sold 19 copies of the "World Call to the Church," 28 copies of "Beyond City Limits," and filled 17 orders for books on Prayer, Church History, Church Customs, Bible Story Books, etc. Nine subscriptions to the Spirit of Missions have been taken, 4 subscriptions to the Church Missionary Calendar taken and innumerable leaflets on the various phases of the work of the Woman's Auxiliary have been distributed through the mail and at meetings. I have sent out two circular letters to the whole Diocese, written 52 letters to the District Educational Secretaries, mimeographed and mailed sufficient copies of the list of study material to the District Educational Secretaries so that they could supply every woman's organization in their district. I have also drawn up full year programs for two organizations who wrote asking me to do this, have addressed three District Meetings and two Deanery Meetings on the Educational Work.

I cannot close this report without calling special attention to the Study Book for this year, "Beyond City Limits." You will find the book a fascinating study of the great rural problem which confronts America today. Written by a man with intimate knowledge of the question from his personal contact with it, it touches on the economic, social, and religious side of the question and closes with a close-up of what the Episcopal Church is doing as her share in the question. Facts and figures have been gleaned from many sources and the pictures it represents we can all enjoy—and deplore.

One-half of America is rural. Four-fifths of Iowa is rural. In Japan, one out of every 250 persons is a Christian. In Iowa, one out of every 6,464 persons is an Episcopalian. Do these facts mean anything to us who live here in Iowa? Does it bring us any share in the solution of the problem? What are we as Church women, as individuals doing to help the Priest, the Church, the Church School in the rural sections of Iowa? What support are we giving them other than to think, Poor man! He's chucked away off there in Thrillville" and add, "Have you seen the Student Prince?"

May God grant that, in the year that is before us, each and every one of us may glean some new vision for the extension of His Kingdom.

A few branches have sent to unassigned missions, but our General Supply Secretary of Church Missions House, New York, has asked that we co-operate with them in order that the work will not be duplicated. They also urgently request that each branch begin now to accumulate good second-hand clothing to be shipped early next fall. Many calls come for simple Altar hangings and vestments.

The Girls' Friendly have done splendid work during 1926 and are now on their quota for 1927. 11 of the active 14 branches were able to accept and since then two more have been added.

As Mrs. Worthen would say, may the spirit of "doing for others" permeate our work during this year.

### II. THE CHRISTMAS BOX

Contents: A useful gift and a joyful gift for each child assigned. A two fold purpose:—(1) help to the one receiving the gift. (2) Training for the one giving the gift.

Don't overlook the importance of this second. It would often be easier for the older people to do the assignment than to supervise the children, but not so good for them. Take time and pains to direct and train the children in unselfish service. Careful supervision however, is necessary to see that the assignment is properly and adequately filled. Over 700 children assigned in 1926 to Iowa Parishes asking for assignments ranging from five to fifty children.

Ask Miss Pauline Flint of Nashua, who is in charge of the Christmas Box Work, for your assignment telling her how many children your school will care for.

## THE SEVENTH ANNUAL CONVENTION OF THE GIRLS' FRIENDLY SOCIETY IN IOWA

DUBUQUE, IOWA, FEBRUARY 5, 1927

The seventh Annual Convention of the Girls' Friendly Society in Iowa was held in the Parish House, St. John's Church, Dubuque, Iowa, February 5, 1927.

The Diocesan Council met at 9:30 with eight branches represented. The matters to be brought before the Convention were discussed.

At 10:30 the regular meeting was brought to order by the Diocesan President, Miss Elsa L. Deming. The service was led by Bishop Morrison, using the service car, and following with an address taken from the lesson on the card. It was a great pleasure to have him with us.

Next followed roll call, eight branches answering. The largest number attending were from Grace Church, Clinton with their President, one Working Associate and nine members.

Miss Deming spoke at this time of the 50th jubilee to be held in Boston in November. It was agreed to appoint as delegates from the Diocese of Iowa, Miss Susan E. White of Estherville and Miss Hope E. Haupt, of Oskaloosa.

The following new matters were brought before the Convention at this time:

Moved by Miss Haupt and seconded by Miss Thorson that we approve of the plan proposed that a member delegate be sent to Central Council. The vote in favor of this was unanimous.

Should young married women be admitted as members of the Girls' Friendly Society? This question was open for discussion. It was moved by Mrs. Hunter and seconded by Miss White that young married women be admitted. The vote in favor of this was unanimous.

The minutes of the last meeting were read and approved. The President's report was read and approved.

Mrs. Hunter, second Vice President, reported for south-eastern Iowa. Visited Keokuk and Ft. Madison but could not get a branch started at this time.

Our program was planned so that the most time could be given the Bishop's Crusade, therefore the reports were made in a condensed form.

Miss Thorson read her report on Social Service. She reported our sharing in various activities. Also reported \$43.00 given to Tabor College. Council Bluffs reported giving a large ice box to Tabor, this gift to be their donation for 1926 and 1927. It was voted to continue our aid to Tabor.

Mrs. Gibson of Muscatine read Miss Kennedy's report on Missions.

The meeting adjourned at 12:30 for lunch.

The afternoon session was opened by Rev. Flockhart of St. John's, Dubuque, who gave us a very warm welcome. This was followed by a very fine address read by Mrs. E. B. Lyon, Dubuque, on the Needs Of the ~~Modern Girl~~. Mrs. Lyon is Honorary President in Iowa and was one of the early secretaries who saw the future of the G. F. S. in Iowa and did her utmost to help it get a good start.

The Rev. Colletti of Burlington gave a talk on the spiritual side of G. F. S. and the needs of the Society to make this our foundation.



Then followed the reading of the reports, all showing the usual line of activities and showing growth and strength.

During 1926 we had branches at Burlington, Council Bluffs, Dubuque, Estherville, Lyons, (Clinton) Mt. Pleasant, Muscatine, Newton, Ottumwa, Rock Rapids, Sioux City, and Spencer. Also a start has been made at Oskaloosa, Des Moines, and Waterloo. Three splendid leaders resigned at the close of the year and we trust that their places will be filled with leaders willing to carry on the good work started.

Nine branches reported having paid their full quota to the Washington National center.

It was again voted upon that each branch make a special gift to the Diocesan Fund. Carried.

The question which we consider of very great importance was now brought for a vote. Should we assess each branch in the Diocese to support the work of a Field Secretary, part of the expenses to be shared by the National Field Division and part with Province 7? It was agreed that this receive our support.

## CONSTITUTION

### ARTICLE I.—NAME.

The name of this organization shall be The Iowa Branch of the Woman's Auxiliary to the National Council of the Protestant Episcopal Church in the United States of America.

### ARTICLE II.—OBJECT.

The object shall be to forward in every way possible, within the Diocese, the interests and plans of the National Council.

### ARTICLE III.—MEMBERSHIP

Membership shall be composed of the Parish and Mission Branches within the Diocese.

### ARTICLE IV.—OFFICERS

The officers shall be a President, First Vice-President, Second Vice-President, Secretary, Treasurer, Custodian of the United Thank Offering, Educational Secretary, Supply Secretary, Church Periodical Club Correspondent. All of whom shall constitute the Executive Board.

### ARTICLE V.—AMENDMENTS.

This Constitution may be amended at any Annual Meeting of the Woman's Auxiliary by a two-thirds vote of the delegates present and voting, provided the proposed amendment has been previously submitted in writing to each Branch at least sixty days before such meeting.

## BY-LAWS

### ARTICLE I.—Duties and Powers of Officers.

Section I.—President. The President shall preside at all meetings of this organization and of the Executive Board. She shall have general oversight of the Auxiliary activities in the Diocese.

Sec. II.—Vice Presidents. It shall be the duty of the Vice Presidents in the order of their rank, to perform the duties of the President in her absence or inability to serve.

Sec. III.—Secretary. The Secretary shall keep the minutes of this organization and of the Executive Board. She shall issue notice of meetings and shall perform such other duties as may be assigned to her by the President or the Executive Board. She shall obtain annual reports from the Parochial Branches and incorporate them into an annual Journal.

Sec. IV.—Treasurer. The Treasurer shall receive and disburse all monies of the organization, excepting the United Thank Offering, keeping full and accurate accounts of all monies received and expended. She shall make a complete report to the Auxiliary at the Annual Meeting, and her books shall be the property of the Auxiliary and open to inspection or for the information of authorized officials at all reasonable times and places. All bills shall be countersigned by the President. The Treasurer shall furnish a Commercial Surety bond, at the discretion of the Executive Board, the amount of such bond to be determined by said Board, the premium to be paid from the Auxiliary treasury.



Sec. V.—United Thank Offering Custodian. The Custodian of the United Thank Offering shall receive all contributions for that Fund, and endeavor to arouse and increase an interest in the same. She shall collect twice a year, put the amount at interest and present a check for all, including interest, at the Triennial. She shall furnish bond under same conditions as the Treasurer.

Sec. VI.—Supply Secretary. The Supply Secretary shall receive and distribute all information relating to the Missionary Boxes and all gifts of cash, clothing and materials for the same, and shall make a complete report of her work at the Annual Meeting.

Sec. VII.—Educational Secretary. The Educational Secretary shall have general supervision of all Religious Educational work of the Diocese carried on under the auspices of the Woman's Auxiliary.

Sec. VIII.—Correspondent Church Periodical Club. The Correspondent of the Church Periodical Club shall receive and disburse all magazines, books and any other material which may be used in her work and shall be a representative of the Spirit of Missions.

#### ARTICLE II.—Election of Officers.

Sec. I. The Bishop's wife shall be the Honorary President.

Sec. II. Officers shall be elected at the Annual Meeting preceding the Triennial and shall serve for the Triennium period or until their successors are elected and qualify.

A nominating committee composed of three delegates appointed by the President shall prepare two tickets from an informal ballot taken at the close of the first afternoon session of the Annual Meeting. From these nominations two tickets shall be made from the two candidates receiving the highest number of votes for each office. The consent to serve, if elected, shall be secured from each candidate. The Formal ballot shall be taken at the morning session of the second day, the election being by ballot, a majority vote constituting an election.

Sec. III. Any vacancy occurring among the officers shall be filled by appointment by the President or Executive Board.

#### ARTICLE III.—Meetings.

Sec. I. The Annual Meeting shall be held as arranged by the Executive Board at the time and place of the Annual Diocesan Convention.

Sec. II. The Executive Board shall meet at the call of the President at least twice a year.

#### ARTICLE IV.—Delegates.

Sec. I. Each Parochial Branch shall be entitled to three delegates or their alternates to the Annual Meeting.

Sec. II. Delegates to the Triennial shall be elected at the Annual Meeting preceding the Triennial, nominations being made from the floor and the election being by ballot.

Sec. III. Delegates to the Provincial Synod shall be appointed by the Executive Board.

Sec. IV. Any vacancy occurring among the delegates to the Triennial or the Provincial Synod shall be filled by appointment by the President or Executive Board.



ARTICLE V.—Quorums.

Sec. I. One third of the Parochial Branches shall constitute a quorum at the Annual Meeting.

Sec. II. Five members shall constitute a quorum of the Executive Board.

ARTICLE VI.—Parliamentary Rules.

Robert's Rules of Order, Revised, shall be the parliamentary authority.

ARTICLE VII.—Amendments.

These By-Laws may be amended at any Annual Meeting by a vote of a majority of delegates present and voting, providing the amendment has been submitted in writing on the first day of the Annual Meeting by the committee on Constitution and By-Laws.
