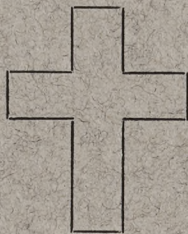
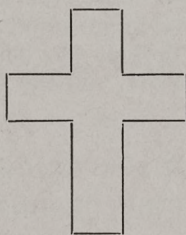

MINUTES OF THE ANNUAL MEETING

FEBRUARY 3, 1931

The Annual Meeting of the Woman's Auxiliary opened at 9:30 A. M. February 3, 1931 in Trinity Cathedral Parish House, Davenport, with Mrs. Jessie Jones, the President, in the chair.

The opening prayers were read by the Rev. Stanley Fulwood of Cedar Falls.

The President appointed the following committees: Credentials—Miss Hennigbaum and Mrs. Kimball of Davenport; Resolutions—Mrs. Wyckoff and Mrs. Longley, Jr. of Des Moines and Mrs. Griffith of Davenport.

At this point, the Woman's Auxiliary went into joint session with the Convention proper to listen to the address of the Bishop.

Following Bishop Longley's address, the President called the meeting to order and the report of the Constitution Committee was given by Mrs. L. W. Wheeler as follows:

"The Executive Board recommends that Article IV of the Constitution entitled 'Officers' be changed to read—'The Officers shall consist of an Honorary President, a President, two Vice-Presidents, a Secretary, a Treasurer, U. T. O. Custodian, Educational Secretary, Supply Secretary, C. P. C. Correspondent, Christian Social Service Chairman, Publicity Chairman, Devotional Secretary, Chairman for the Isolated, and Vocational Secretary.'" The Executive Board also recommends that Article II Section II of the By-laws referring to the nominating committee be changed to read: "A Nominating Committee shall be appointed by the President to bring in nominations for elective officers if directed by a two-thirds vote of the members present at the annual meeting."

It was moved by Mrs. Wheeler, seconded by Mrs. Enyart, that these changes be adopted. Carried.

The President appointed a Nominating Committee to consist of Mrs. Watzik, Mrs. Henry, and Mrs. Longley, Sr.

The report of the President was then read.

A letter was read by the secretary from the Rev. L. S. Burroughs of Ames thanking the Woman's Auxiliary for their generosity and splendid work for the Font at the Student Chapel at Ames.

The meeting was then turned over to the Educational Secretary who conducted a short conference on Religious Education and the problems met in carrying the work forward.

The offering was then taken and reported as \$19.07.

It was moved by Mrs. Wyckoff, seconded by Mrs. Morgan that the offerings of the Convention be used for the Font at St. John's, Ames.

The report of the Treasurer, Mrs. Lester Jackson, was then presented. Following her report, Mrs. Jackson took the pledges for 1931.

The report of the Supply Secretary, Mrs. A. W. Brown was presented.

The President appointed Mrs. L. W. Wheeler of Ft. Dodge as Chairman of the Committee on Revision of the Constitution, authorizing Mrs. Wheeler to choose her own committee.

The report of the Chairman for the Isolated, Miss Bailey, was read by the Secretary.

Moved by Mrs. Longley, Sr., seconded by Mrs. Kimball that a letter of sympathy be sent Miss Bailey expressing our regret at her absence from the convention and also expressing our appreciation of her splendid work during the past year. Carried.

It was moved by Mrs. Jackson, seconded by Mrs. Morgan that the Woman's Auxiliary go on record as advocating the appointment of an Arch Deacon for the Diocese, the Secretary to notify the Bishop and Council of the same. Carried.

Noonday prayers were then read by Mrs. Longley, Sr., the Devotional Chairman.

It was moved by Mrs. Longley, seconded by Mrs. Enyart that letters of sympathy be sent to those Diocesan officers who were unable to attend the Convention because of illness—Mrs. F. R. Lacey, Mrs. Nicholson, and Mrs. Mounsey. Carried.

The meeting adjourned for lunch.

Following a joint session with the Convention proper at which reports of work were presented by Miss Caroline Averill on the G. F. S. and Mrs. Perry on St. Monica's Home, Des Moines, the Convention of the Woman's Auxiliary was called to order at 3 P. M. by Mrs. Jones, the President.

Miss Hennigbaum gave the report of the Credentials Committee showing a total of 78 delegates present at the morning session.

Mrs. Wheeler withdrew her name as nominee for the Presidency so the Nominating Committee was forced to retire to secure other nominations.

The report of Miss Craig-Anderson, superintendent of St. Luke's Hospital, Davenport was then given while awaiting the report of the Nominating Committee.

The report of St. Katherine's School was given by Sister Esther.

The Nominating Committee then brought in their report, substituting the name of Mrs. V. H. Morgan of Newton for that of Mrs. L. W. Wheeler for President.

It was moved by Mrs. Morehouse, seconded by Mrs. Ellsworth, that these nominees as presented by the Nominating Committee be declared elected for the coming year. Carried.

The report of the U. T. O. Custodian, Mrs. V. H. Morgan was then given, followed by a short conference on the U. T. O.

Nominations for the delegates to the General Convention in Denver were then declared in order.

The following were nominated: Mrs. Henry of Des Moines, Mrs.

H. S. Longley, Sr., Mrs. H. S. Longley, Jr., Mrs. L. S. Burroughs, Mrs. V. H. Morgan

It was moved by Mrs. Jackson, seconded by Mrs. Hoag that the delegates nominated be declared elected. Carried.

The following were then nominated for alternates to the General Convention: Mrs. Jones, Mrs. Chappell, Mrs. Brown, Mrs. Jackson, Mrs. Wheeler.

It was moved by Mrs. Longley, Jr., seconded by Mrs. Ellsworth that the persons nominated for alternates be declared electer. Carried.

The report of the Devotional Secretary, Mrs. Longley, Sr. was then presented.

The report of the Publicity Chairman, Mrs. L. W. Wheeler was next presented.

Moved by Mrs. Longley, Sr., seconded by Mrs. Chappell that a Committee be appointed to draw up resolutions expressing our love and devotion and our grateful thanks to Mrs. Jessie Jones for the leadership and the inspiration she has been to us in the work in her six years in office. Carried.

The report of the Resolutions Committee was presented by Mrs. Wyckoff. The Committee on Resolutions made the following report:

"Whereas, during the past year, the Woman's Auxiliary of the Diocese of Iowa has lost by death the following members: Mrs. Empke and Mrs. McIntosh of St. Paul's, Council Bluffs; Mrs. John Kalback of St. James', Oskaloosa; Mrs. McLanahan of St. John's, Cedar Rapids; Mrs. A. J. Van Duzee of St. John's, Dubuque—

Be it resolved, that we hold them in loving memory. May they rest in peace.

Be it also resolved, that this organization go on record as expressing their love and devotion and grateful thanks to their retiring President, Mrs. Jessie Jones, for her leadership and inspiration during her six years in office.

Be it further resolved: That the Woman's Auxiliary hereby express their appreciation of the repeated hospitality of Trinity Cathedral Parish.

The offering was then taken and reported as \$6.64.

The minutes for the day were then read and approved.

The meeting adjourned to reconvene at 9 A. M. the following morning.

Wednesday, February 4th, 1931, the Woman's Auxiliary reconvened at 9 A. M. in Trinity Cathedral Parish House.

The Rev. J. D. Griffith led the opening devotions.

The Rev. Fr. Roberts, rector of St. Mary's, Keokuk, addressed the meeting thanking the women for their interest and help in his work and pleading for continued support.

The reports of the Deanery Meetings were then presented by the following people: Mrs. Longley, Jr. reported on the Des Moines Meeting; Mrs. Jones of Iowa Falls reported on the Dubuque Deanery Meeting in Cedar Rapids; and Mrs. Hoag of Burlington reported on the Muscatine Deanery Meeting in Burlington.

Reports on the District Meetings for the year were presented by various people. In practically all places where the Districts meet

regularly there has been a good response and the work is progressing judging from the reports given.

The offering for the morning was taken and reported as \$7.36.

The new officers were then introduced to the Convention.

The minutes of the morning's session were read and approved.

Mrs. Jones closed the meeting with prayer.

REPORT OF PRESIDENT

The report of your president for the 44th Annual Convention of the Woman's Auxiliary to the National Council cannot express in words all of the burning zeal that has been put into the Auxiliary the past few years, to lead the Branches into the Way that leads to a radiant Life of Service.

The Woman's Auxiliary is well organized for its work in the Five Fields of Service. In the past few years in this Diocese we have developed until there is a Diocesan Chairman of each department of the National Council. Cooperating with the Diocesan organization, the active Branches have a Parish Chairman of each department of the Woman's Auxiliary.

The very general uniting of all the women of the parish into a Guild-auxiliary has brought about all of the women of the parish working for the Parish, Community, Diocese, Nation and the World, thus fulfilling the ideal for the Woman's Auxiliary which is: "All of the women of the Church working for all of the Church." When that ideal is carried out all of the women of the Church have had an opportunity to know about the work being done for the extension of His Kingdom through study, and service, and gifts. When every parish is interested, and delegates and others attend the Convention, the Deaneries and the District meetings, they become informed, and they also may be the means of interesting the younger women, which is well, not only because the Woman's Auxiliary greatly needs the younger women, but because they sorely need what the Auxiliary has to give,—knowledge, inspiration, and spiritual growth through Service.

When we have a Diocesan Vocational Service Chairman appointed, then the Diocesan Board will be complete. The Diocesan working force is carrying out ably the work of Christian Educators, Christian Social Service, United Thank Offering, work among the Isolated, Publicity, Box Supply, Church Periodical Club, Devotional and Vocational Service.

I do not think the women of the Diocese quite realize what a splendid group of leaders these Diocesan Chairmen are. May I bespeak a careful perusal of their fine reports in the 1931 Journal as well as an efficient cooperation in their able, voluntary service for the carrying forward of His: "Go ye into all of the world," the last command He gave His disciples before His Ascension.

Mrs. Flockhart has given a most comprehensive outline for a program and for study classes. The suggested program that was mailed to you received recognition from the National Council, assuring her that her splendid piece of work would be used at Headquarters. It was so complete and fine a digest of the Church Pro-

gram for this Trienium. Mrs. Flockhart's leadership is unsurpassed. All who were privileged to hear her presentation of the Church Program at the Deaneries and the Districts felt the influence of her informing and thrilling talks.

The Journal edited by our Secretary, Mrs. Lacy, is not only an improvement over the former W. A. Journals but was published as soon as possible after the Diocesan Convention. The cooperation of the Branches helps in bringing about an early publication of the Journal.

The new Treasurer, Mrs. L. T. Jackson, has been prompt and efficient in the dispatch of the business of her office.

Mrs. Longley, Honorary President and Devotional Secretary, has done all in her power to advance interest and be of assistance in the devotional life of the Diocese.

Our Vice-President, as Publicity Chairman, has brought before you as never before, the Spirit of Missions. This Trienium year we should take the Spirit of Missions, the best Missionary magazine published, so acknowledged by all who know it.

Mrs. Morgan, U. T. O. Custodian, needs no introduction to you. She has ably presented the little Blue Box for six years.

Mrs. A. W. Brown has efficiently carried the difficult box supply work for six years as her report at this convention will prove.

Mrs. Nicholson still carries on the C. P. C. work under the same handicap in the Postal Service. One can say of her "The Lord loveth a cheerful giver," especially under adverse circumstances.

The work of Christian Social Service, under Mrs. Mounsey and work among the Isolated, under Miss Bailey, only needs the developing which time and their able, consecrated service will give.

The officers of the National Council asked the Woman's Auxiliary to give the efforts which they had used so successfully for the Corporate Gift to the carrying forward of the advance work program of the Church.

We have done so by continuing to make our Corporate Gift pledges, calling it only by another name—Advance Work.

The Advance Work project for this Diocese is a new Church for Ashikaga, Tokio, Japan. If that project has not been presented to your Auxiliary as yet, it will be presented to you soon. A leaflet on Ashikaga, may be obtained at "281" for the asking.

The two subjects which the Executive Board asked us to stress this Trienium were Personal Evangelism and the paying of our Quotas. We all know that if we are growing in Grace and in knowledge and love of our Lord and Saviour, Jesus Christ, we will pay our Quota.

It is our responsibility to see that the Rector has our cooperation in raising the Budget Quota and the Advance Work project.

When we think of the "weary, waiting, world" which is still without Christ, we realize that "unless our nation rises to its great responsibility it will be numbered with the great nations of the past of whom we sing in the Magnificat: 'He hath put down the mighty from their seat'."

In the answers to the questionnaire on the Devotional Life, sixteen out of the 22 replying, observed with other Churches the World Day of Prayer. We trust that all of the Branches observed the presentation of the U. T. O. with a Corporate Communion the first Sunday in May and the first Sunday in November. In the 6th Province All Saints Day has been set aside for a day of Interces-

sion. We cannot afford to neglect so great a privilege of prayer as these days offer us. There has not been an increase in the subscriptions to the Prayer Leaflet even though it has enlarged its plan for intelligent intercessions by making it a monthly Leaflet.

More should avail themselves of this help in making us co-workers with God through His appointed means of prayer, the greatest power in the world.

Through the interests of the Diocesan Auxiliary Board it was made possible for me to represent the Iowa Branch of the Auxiliary at the Provincial Synod of the 6th Province, which met at Miles City, Montana, the last part of September. Mrs. Kinney, of Denver, the Woman's Auxiliary President of the 6th Province was re-elected. As the Trienium meets in Denver next September, it will be of benefit to have Mrs. Kinney in active service for the Auxiliary.

Your President was elected Third Vice-President of the 6th Province.

The Woman's Auxiliary Board in session at Waterloo last September, voted to give a Baptismal Font for St. John's, Ames, not to exceed \$300 in cost. Let this objective of the women of the Diocese be met soon, that St. John's may have the benefit of the women of the Diocese be met soon, that St. John's may have the benefit of the Font of which it is in need. We hope this will be a free-will offering.

We have 47 Branches of the Auxiliary in this Diocese. The encouragement this year has been in a greater interest in the work. More are asking intelligent questions and seem anxious to cooperate in having programs, reading of the official Books on India and appointing Chairmen of the six departments of the Auxiliary.

Your President has, in addition to the routine work of the office, edited the W. A. page in the Iowa Churchman; had 50 copies of the Church Program mailed to the Parishes and Missions; attended and presided at the W. A. Convention at Davenport; attended the Bishop and Council Meeting in Des Moines, and was appointed to act on the Diocesan Committee for the Advanced Project at Ashikaga; spoke at St. Andrew's (Des Moines) Auxiliary Meeting and at St. Stevens Auxiliary Meeting at Newton; was a speaker at Sioux City District and Girls' Friendly Society in May; distributed 37 Pentecostal Leaflets; attended the two Board meetings; attended the Waterloo District meeting; was the speaker at the Emmetsburg District Meeting at Estherville and also was the speaker at St. John's Auxiliary, Ames; attended the Dubuque Deanery at Cedar Rapids, presiding in the absence of the President and sent 572 letters and 27 postals in 1930.

My time in office (as president) now draws to a close and as a parting message to the Woman's Auxiliary in this Diocese may I thank you with all my heart for your helpful cooperation during the past six years in carrying forward the work of the Auxiliary in His Kingdom. It is the faithful workers who win in any endeavor. No organization can rise any higher than the interest in the Guild-Auxiliaries until the highest good may be accomplished by them. It has been a great privilege and real pleasure to work with you. The many friendships formed will be a lasting blessing to me.

Christ says: "Herein is my Father glorified, that ye bear much fruit; so shall ye be My disciples." God grant that we bear much fruit in the coming year, that we may be called His disciples and be found worthy of the name.

REPORT OF EDUCATIONAL SECRETARY OF THE WOMAN'S AUXILIARY

FROM JANUARY 1, 1930 to January 1, 1931

In closing five years in office as Educational Secretary I can say for 1930 that we have not, at least, lost ground—though I am sure the advance made is neither as great as I would like to see it nor as great as we are capable of making it.

"In my country," said Alice to the Queen, "when you run very fast you usually get to some other place." "A slow sort of country," said the Queen. "Here it takes all the running you can do to stay in the same place."

Is that a description of our educational work?

To report statistics first: Thirty branches have returned their report to me on educational Work. Out of these 30, 28 report some sort of educational work being done in their Branches; 22 used the study book for the year; there were 15 discussion groups; 14 conducted program meetings; 3 gave missionary plays; 2 had reading circles; 2 had loaning libraries or book-shelves; and one branch sent a delegate to a summer conference.

I am delighted to report a steady increase in the number of study books sold. This is not only indicative of the fact that every branch desires to study, but also that every branch knows that there is a suggested study book for each year, and that they wish to study that particular book—in other words, to cooperate.

During the year I have secured 3 subscriptions to the magazine "Findings", 2 subscriptions to "The Prayer Leaflet", and 7 subscriptions to "News Notes". I have sold 121 study books; sold 76 prayer cards; and have mailed out innumerable free pamphlets on the Church Periodical Club, the Advance Work Program, Christian Social Service, and on Publicity.

I have written 7 circular letters, sent out a list of Lenten reading to every branch, published and mailed a suggested program for the autumn on the "General Church Program", mailed an outline on "India", written articles for the Iowa Churchman, and have written 603 personal letters and post cards.

I made two addresses at the Diocesan Convention in February, attended two Executive Board meetings, addressed three spring District meetings, addressed five fall District meetings, addressed the three Deanery meetings in the fall, and I addressed one Parish Branch meeting outside of this Diocese. In the spring I attended the National Conference of Educational Secretaries and Diocesan Officers at Racine, and was privileged to be one of the teachers at that meeting. In June I taught a course for a week at the Minnesota Summer Conference, "The Woman's Auxilliary Life of the

Church." And, in October, I addressed the meeting of the Chicago Synod of the Woman's Auxiliary which met in Springfield, Ill.

I have also acted as the Educational Secretary for this Province.

In looking forward to the future of our work, I want to call your attention to the tremendous emphasis being placed today on adult education, both secular and religious. More books are being written per year on this subject than have ever been written before.

The Woman's Auxiliary has always been a leader in Educational work through her "mission study classes". Today the Woman's Auxiliary is not an Auxiliary to the Department of Missions. It is an Auxiliary to the whole Church—which is the Body of Christ. It is an Auxiliary then, to Jesus.

Consequently, the Woman's Auxiliary offers to the women of the Church a type of study class which has as its aim "to know Christ and to make Him known."

The program of study presented is not one that will amuse or entertain us. Christ did not die on the cross that his messengers—however feebly they may present their message—might amuse us.

But the Educational work presented is one in which every group of women is given an opportunity to get together and to think out some of the problems which concern, not only our parish work, nor even our own Church's work, but problems which concern our own personal relation to our Master and to the world in which we live.

There should not be a parish or Mission in this Diocese in which the Guild or Woman's Auxiliary does not plan carefully for some kind of Educational work—study class, reading circle, discussion group, program meeting, loaning library, missionary play, etc. People are interested in and concerned about the things which they know.

May God grant that, in the year before us, we may know Christ more fully in order to make Him known to others.

A new form of parish report blank which had been discussed at Board meeting was prepared and printed. Samples were inserted in order that the officers of each branch might familiarize themselves with the form.

Twelve hundred sheets of stationery were printed and distributed to the members of the Executive Board. As this was insufficient, late in November a generous supply omitting the names of the officers was printed. This paper can be used during the interim between Board meetings.

In December, notice of an amendment to Article IV of the Constitution was sent out in accordance with Article V.

Parish report blanks have been sent out, many having been filled in and returned.

I regret that this brings to a close my fifteen months of service. It has been a real pleasure to render some service to the Woman's Auxiliary of Iowa and to have come in closer contact with its members.

CHRISTIAN SOCIAL SERVICE IN IOWA

Iowa reports an increased interest in Christian Social Service work being done through the Woman's Auxiliary or Auxiliary-Guilds.

In answer to questionnaires sent out to each Auxiliary, we note that Christian Social Service work is being efficiently done in many fields:

1. By providing needed things for the needy people within the parish and Community.
 2. Through cooperation with local Social Welfare Agencies in clinic and field work.
 3. Through cooperation with other local Christian Organizations in the study of local Social Service needs and work to be done.
- Some Auxiliaries report, "Jails visited," "Calls made at County Homes," and similar service done.

The most needy, and perhaps the most important, Diocesan Christian Social Service Institution is St. Monica's Home for Girls, Des Moines, Iowa. This is a growing institution of Christian Social Service type, and during the year 1931 much stress will be laid on its present needs; and it is hoped that definite plans will be made to provide a suitable recreational building for the girls. For several years the various Auxiliaries have sent St. Monica's gifts of linens and foodstuffs.

Another Diocesan Institution is St. Luke's Hospital, Davenport, and a great many pieces of linen, etc., have been sent annually over a period of many years by the Auxiliaries.

Besides providing for these two Diocesan Institutions, many Auxiliaries or Auxiliary-Guilds send, "by request," boxes of supplies and useful gifts to our general institutions and field.

Some of the Auxiliaries have taken up the study of Christian Social Service as part of their regular program, using literature to be obtained at 281 Fourth Avenue, New York. Articles from the Diocesan paper, and Spirit of Missions, or information as provided by the Diocesan Chairman of Christian Social Service, of the Woman's Auxiliary.

We feel keenly the loss of our teacher and leader, The Rev. Charles N. Latrop, Executive Secretary of Christian Social Service, but we take courage and pray that the courageous spirit of our dead leader may possess the new Executive Secretary, and our Church's Christian Social Service work continue to be heroic.

REPORT OF ISOLATED WORK OF THE WOMAN'S AUXILIARY FOR 1930

There are 325 names on the Isolated List,—living in 87 of our 99 counties and in 174 towns.

There are 40 counties without either Parish or Mission of our Church.

There is one area of 11 adjacent counties, and another of 8 adjacent counties without Services at all.

There are 7 counties with Parishes, and NO Isolateds. There are 5 Counties where is no Episcopalian living, that can be found.

The work has been slow. Of over 400 people written to, only 63 have replied to my letters.

I advertised in the papers, last fall, in the counties where we had no names, and found some in three of the eight counties.

I have sent lists to all the District Field Secretaries, of the names in their Districts, and notified them of each new name found.

I have kept the Diocesan Office, and the "Iowa Churchman" informed of all the changes in the list.

I have sent lists to priests of all Isolateds to whom they were the nearest Priest—to call upon when in need of ministrations.

Some of these lists were appalling. For instance, Fr. Upjohn of Estherville was sent a list of 38 names, living in 16 towns, to all of whom he is the nearest priest. Others are not quite so bad, but bad enough.

I'm hoping that when these priests become acquainted,—either by letter, or by calling—with these Isolated people, that they will report to me any names of those who may have moved away, or died, or have joined some other Church. Three reasons for removal from the Isolated List.

I have sent the lists of books available in the free Library at 281, to all who answered my letters. None have used this privilege.

Among the 63 who answered my letters, were 20 families with children. I found it necessary to state explicitly, that this work was NOT just a scheme to get more money for the Church; that I DO NOT ask the children to forsake the S. S. they may be attending; that I have NOT adopted the usual method of having written answers sent back to me for grading, etc. WHAT DO I DO?—I send my six S. S. pupils the same material that our home school has.—Quarterlies, Mite-Boxes, etc. and then, each week, I write a lesson-letter to each child, differing according to age, of course. I take it for granted, and say so, that they have read the lesson and so know what I am talking about; and then write as if they were a home class, putting in some thing of the Church Year, and the ways and customs of our Church, which are so different from others,—and WHY. Trying to give them knowledge which will make them feel at home, should they have a chance to attend Church, instead of feeling lost—strangers in a strange land.

I have sent out 11 Confirmation Instructions. One Candidate has been Confirmed and others expect to be at the first opportunity.

A wee beginning has been made along the line of Rural Auxiliaries,—a dream of mine. Four ladies have asked for the U. T. O. Boxes, as they could help a little in that way, though they were Isolated.

I sent Christmas cards to all who had answered my letters.

When I think of the great areas in Iowa without Church Services at all, my heart fails. How are these people to receive the help, strength, and comfort, the Church can give.

Another dream?—Would an Arch-Deacon be possible for Iowa? A priest without a parish, who would travel about visiting these Isolated people, and give them the various Sacraments of the Church as regularly as possible, living in the middle of the most Isolated area, to lessen travel cost.

Would it be possible for the Auxiliary to help finance such a plan, if the Diocese cannot do it alone?

Can this dream come true? What better plan can be thought of?

The expenses of this department from Jan, 1930 to Jan. 1931, have been \$28.22.

REPORT OF PUBLICITY CHAIRMAN OF THE WOMAN'S AUXILIARY FOR 1930

There seems to be little knowledge amongst the laymen of the Church as to the functioning of the Department of Publicity, which came into existence with the creation of the National Council in 1919.

From the beginning, the Department has interpreted its work to be:

1. Propaganda for the Church's mission,
2. Propaganda for the plans and activities of the several departments and of the Woman's Auxiliary,
3. Promotion of publicity throughout the Church,
4. Management of publicity for the General Convention and its Commissions.

This is a stupendous program in which all of us may choose to have his portion.

By publicity we can increase attendance at Church services; bring increased offerings for Parish and Mission support; promote success of every Parish activity. Further, it can develop sentiment in favor of the Church; keep those interested in touch with the Church throughout the world; reach the unfaithful ones, pave the way for personal work with inactive people, and remind them over and over again that the Church has not forgotten.

Publicity provides the only possible means of bringing constantly and continuously to the minds of all Church people, through opportunity for missionary service in prayer and labor and giving.

The Church moves haltingly in her missionary enterprise only because a large percentage of her members have no part in it.

If they can be informed they will rally to its support.

A clergyman of the Church has made the statement that the amount of money expended annually by the Department of Publicity brings larger returns in actual giving to missions than does any other item of expenditure by the National Council.

Yet the work is limited by the small amount at its disposal to reach the whole Church. As the Church comes to realize the productiveness of publicity in missionary endeavor, it will insist upon its wider use.

This department is responsible for the publication of the "Spirit of Missions" and for the "Church at Work." The former is limited in its circulation and is now asking for 50,000 subscribers by the time of the Triennial in September. The "Church at Work" reaches every Diocese and every Missionary District. It may not reach every member but it does reach nearly every member.

The work of your Diocesan Publicity Chairman the past year has not been arduous but on the contrary, has proven interesting and informative. Your chairman has edited items for the Auxiliary page in the "Iowa Churchman" for nearly every issue—sent out circular letters to the Publicity Chairmen of the fifteen Districts, urging them to order copies of the Thank Offering issue of the "Spirit of Missions" in order to retain the publication of this special number; also asking the appointment of a Publicity Chairman in each District.

Postals were sent out, Dec. 1st, to every Parish and Mission, 65 in all, calling attention to the Missionary Newspaper Contest published in the November "Iowa Churchman," and again asking the appointment of a Publicity Chairman in every Branch of the Auxiliary.

Concerning the little Newspaper Contest—there have been received (up to date) only two responses, which is rather disappointing, as the work breeds interest in the Church and is something that any Branch can participate in, even to one person. This has been demonstrated by the receipt of one little newspaper sent from a town where there are only three communicants, no Church or services, a most appealing and well-gotten up little paper from Mrs. Biddinger of Rock Rapids. The other paper is from Fort Dodge.

Several Branches have reported the appointment of Publicity Chairmen.

When the importance of Church publicity is brought home to each and every one of us, we will find an active Chairman in each Auxiliary Branch. As a consequence there will arise more alert, interested, and prayerful workers.

MINUTES FOR DIOCESAN COUNCIL OF THE G. F. S.

The meeting of the Diocesan Council of the Girls' Friendly Society in Iowa was held at the time of the Diocesan Convention in Davenport, February 3rd and 4th, 1931, in the Cathedral Parish House.

Because of the mid-week meeting, it was impossible to obtain a quorum at any one time during the two days, but reports were given Tuesday afternoon when the largest number was present. Votes were taken from others who came in the next day.

The roll call was responded to by Miss Thorson, Mrs. Potter of Burlington, Mrs. Loomis, Mrs. Lyons, Miss Kennedy, Miss Averill, Mrs. Longley, Mrs. Bishop of Muscatine and Mrs. Moorehouse of Davenport.

In the absence of the President, Mrs. Loomis presided. The meeting opened with the reading of the minutes of the last meeting held in Sioux City, May 10th, 1930.

The report of the President, Mrs. Suzanne Zwemer, was read. It told of four new branches, organized through the untiring and inspiring work of Miss Caroline Averill, Field Secretary. The new branches are at Rock Rapids, Iowa Falls, St. Luke's, Des Moines, and St. Paul's, Sioux City. This growth was largely due to Miss Averill's talks with rectors, with girls at summer conferences, and in parish visits, Mrs. Zwemer reported; and Iowa has become better known than ever before nationally. Under the guidance of Mrs. Biddinger we are doing pioneer work in rural fields, maintaining a high standard of work throughout the year.

The treasurer's report showed \$126.99 received, and \$86.60 disbursed, leaving a total on hand of \$40.39.

Report of State Custodian of Supplies, Mrs. Biddinger, showed a balance of \$6.08 turned over to the treasurer.

Miss Kennedy spoke of the many calls for leadership which if adequately responded to would meet and carry the responsibilities of our work. She asked for cooperation in the branches to increase the reading of the "Spirit of Missions" and the G. F. S. Record. She stated that Miss Brent, National G. F. S. Head of Missions, asked that we consider taking out a Bontoc Scholarship.

2. The result of Miss Larson's work for Activities was shown in the splendid poster display sent by all but three of the branches. The posters helped materially to present the new program of work and service to the church accomplished by the G. F. S. girls in Iowa this year.

3. For Finance, we learned that besides the amount reported by the treasurer, \$35.50 had been sent by Branches as gifts to the National G. F. S. work.

A growing list of Honorary Diocesan Associates was reported.

These church women, especially interested in girls' work, form an encouraging background for those doing the more active work of leadership among the church girls and their friends.

Mrs. Loomis presented a business-like account sheet blank, to each Branch Treasurer, to simplify their bookkeeping and yearly reports.

4. Mrs. Biddinger, for Membership and the rural work, has prepared a "Who's Who" in Iowa, to be used in the near future.

5. Miss Gooch, whose Secretary's Report was in poster form, circulated the Branch Annual Report forms, and assisted in compiling the new draft of the Diocesan G. F. S. Constitution, which accepted by vote at this Council Meeting—having been submitted for the Bishop's approval and also for that of National G. F. S.

6. The new Department of Publicity displayed a most comprehensive scrap book of the clippings of all its publicity articles for the year. This energetic Chairman, Miss Sorenson, reported 121 letters to branches, 21 to National Office, with ten articles in the Iowa Churchman, many of the nine articles sent to the Record finding their way into print.

Reports on the G. F. S. National Council in Chicago, October 1930, were sent in by the member delegate, Dorothy Dickinson of Waterloo, on "Goals in G. F. S.", "How to Plan a Program" and "Sunday Service at St. Luke's Evanston".

Miss Bessie Sorenson, of Clinton, reported the Associates' Conference, Publicity, Banquet Program and Saturday's Mission Luncheon, and Mrs. Lee P. Loomis reported the Evaluation of National Council Meetings, the Diocesan Presidents' and Secretaries' Conference, Finance and the Pageant "Sign of the Blue".
