





MINUTES OF THE IOWA BRANCH OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

January 26, 1932

The Woman's Auxiliary met in a joint session of the Diocesan Convention at 9:30 a. m., January 26, 1932, in St. Paul's Church, Des Moines, to hear the Bishop's message.

At 11:30 the Auxiliary convened at the Y. W. C. A. with the president, Mrs. Morgan, in the chair.

The President appointed the following committees:

On Credentials—Mrs. Kerfoot, Des Moines; Mrs. Rankin, Muscatine; Mrs. James, Council Bluffs.

On Nominations—Mrs. Longley, Davenport; Mrs. Chappell, Davenport; Mrs. Martin, St. Luke's, Des Moines.

On Resolutions—Mrs. Grafton, Grace, Cedar Rapids; Mrs. Evers, St. Thomas, Sioux City; Mrs. Hardsocg, Ottumwa.

The President read her report, and also brought a message to the women of the Diocese from Mrs. Jones.

The Secretary made her report.

Mrs. Jackson read her report as treasurer and answered a number of questions. She also made the plea that all parishes make an effort to pay their pledges before the first of the year. The report was accepted.

Mrs. Flockhart made her report as head of the Department of Christian Education. Following her report, she asked that branches make every effort to train leaders for this work; she also urged a more consistent and intensive study of subjects undertaken for study in the various parishes.

The offering for the morning was then taken, amounting to \$9.84.

Mrs. Longley, the Devotional Chairman, then led the noon-day prayers.

Mrs. Hanzlik of the Church Book Shop in Minneapolis gave a talk on the Shop and its functions. She emphasized their two aims—to help the women of the Auxiliary, and to help church schools. For these purposes, the Shop will send books to anyone who will pay the postage. They will also send catalogues to any desiring them.

The Secretary read the resignation of Mrs. Morgan as president. It was moved by Mrs. Longley that the resignation be accepted with sincere thanks for the work that Mrs. Morgan has done, and with regret that the resignation seems necessary. Motion was seconded and carried.

Mrs. Devin gave the report for St. Monica's School. After thanking those who had sent gifts and boxes for the girls' use, she told of the policies of the management of this "school of opportunity," of the reasons for placing girls there, of the training given the girls in their care, etc.

At 12:30 the meeting adjourned for lunch.

The Auxiliary re-convened in the Y. W. C. A. at 2:30 after a visit to a number of places of Church interest in Des Moines, and was opened with prayers by Father McLaughlin of Newton.

Mrs. Mounsey made a motion that the offering taken at the Auxiliary meetings during Convention be applied to the fund for the education of Miss Vera Grace of the Sixth Province, for future work among deaf mutes. Mrs. Mounsey explained that the Diocese has been given a quota of \$100 to be collected through the triennium for this purpose. The motion was seconded and carried.

It was moved by Mrs. Longley that a committee be appointed to communicate with Mrs. Kinney in regard to the apportioning of this sum among the dioceses and missionary districts. Motion was seconded and carried. The information came out that the father of Miss Grace conducts services for deaf mutes in a number of parishes in this diocese.

Miss Helen Gray read the report for St. Katharine's School which was written by the Sister Superior, following this by an informal report of the Bishop Morrison Endowment Fund. She told of the inception of the fund, but brought the fact home that this fund has suffered because of the financial situation of today. She stressed the plan for a number of small gifts of \$10.00 to be paid over a period of ten years in one dollar payments.

Mrs. Jackson offered a resolution which she stated as a motion. The resolution read as follows: "That a woman be appointed by each local branch of the W. A. to act as the local representative of the Bishop Morrison Memorial Endowment Fund of St. Katharine's School, whose duty it shall be to receive pledges for such fund. And be it further resolved that the parochial organizations of the W. A. sponsor in each parish and mission the securing of pledges for that fund." The motion was seconded, and, after some discussion, was carried.

Miss Craig-Anderson could not be present to make the report for St. Luke's Hospital, so the President made an informal report. Mrs. Flockhart reported that the hospital is making money.

Mrs. Harry S. Longley, Jr., gave a most interesting and thought-provoking report of the "Findings" of General Convention on "Family Life." She recommended the study of this report by Auxiliary groups. In her review, she stressed the fact that the Church has tied up family relations with holy things rather than with obscene—as has been the tendency of many writers. She spoke of the emphasis given to the permanence of marriage, with the consequent fallacy involved in so-called trial marriages. Considerable discussion followed on the subject of admitting a re-married person to the Holy Communion.

Mrs. Longley, Sr., moved that the other reports of the triennium be given in the session of the next morning because of the lateness of the hour. Motion was seconded and carried.

Pledges of the parish branches were then taken and recorded by the Treasurer.

It was moved by Mrs. Mounsey and seconded that a committee of two or three women be appointed in the Diocese to work out a means whereby the Auxiliary will help to strengthen the Church School work. Carried.

The Nominating Committee made the following report:

For President—Mrs. Merrill Gilmore of Ottumwa.

For Secretary—Mrs. Herbert Horton of St. Paul's, Des Moines.

U. T. O. Custodian—Mrs. V. H. Morgan, Newton.

The President asked for nominations from the floor. No further nominations were made, and Mrs. Longley moved that the secretary be instructed to cast a vote for these three names to fill the offices designated. Motion was seconded and carried.

It was moved by Mrs. Wheeler and seconded that the recommendation of the Board that each Branch be taxed one dollar per year for the expenses of the President to General Convention be accepted. An amendment was made that this be changed to read "president or alternate"; this was passed, then the motion as amended was carried.

The recommendation of the Board that the U. T. O. be sent semi-annually to the Treasurer of the National Council was adopted.

The offering for the afternoon was then taken and amounted to \$7.17.
The meeting adjourned for the day.

Wednesday, January 27, the Auxiliary re-convened at 9:30 a. m. The Rev. Mr. Edwards led the opening devotions.

The minutes of the previous day were read and, after one correction, were approved.

The President appointed the following committees:

Ames Font Fund—Mrs. Jackson, Mrs. Wheeler, Mrs. Harry S. Longley, Jr.

Church School—Mrs. Wyckoff, Mrs. Flockhart, Mrs. Mounsey.

It was decided that the Treasurer take up the matter of the readjustment of the Grace Educational Fund with Mrs. Kinney.

The report on Credentials was presented by Mrs. Rankin as follows: The average attendance has been 65, with registered delegates numbering 47. The parishes represented are—Christ Church, Burlington; St. Luke's, Cedar Falls; Grace and St. John's, Cedar Rapids; Grace, Charles City; St. Paul's, Council Bluffs; Trinity and St. Katharine's, Davenport; St. John's, Dubuque; St. Paul's, St. Luke's, St. Mark's, St. Simon's, Des Moines; St. Mark's, Fort Dodge; St. Matthew's, Iowa Falls; St. John's, Keokuk; St. John's, Mason City; St. Paul's, Marshalltown; Trinity, Muscatine; St. Stephen's, Newton; Trinity, Ottumwa; Calvary and St. Thomas', Sioux City; Christ Church, Waterloo.

Mrs. Reimer, who had been appointed by the Bishop to serve as a delegate at the Triennial Convention in the place of the Auxiliary President, presented her report. During the Triennial, she had chosen the group on "Religious Thinking Today" as her study group, and she made a most interesting and comprehensive report of their findings. In summing up, she said, "Our ability to interpret God to others is in direct proportion to our Communion with Him." "A direct witnessing to Christ is the only solution to our problems," she concluded.

An explanation was made of the Parish Report leaflets.

Mrs. Flockhart spoke about the possibility of using the Conference Grounds at Clear Lake for a W. A. Conference of some sort. It was moved by Mrs. Flockhart that a committee be appointed to co-operate with the committee on Religious Education for working out a program for a summer conference at Clear Lake. Seconded and carried.

Mrs. Longley then gave her Triennial report of the findings on "International Relations." Great stress was laid on peace between nations, and the fact was brought out that reduction in armaments would make the payment of war debts possible. "The Christian Church has the solution of International Relations," she said in conclusion.

Mrs. Nicholson of the Church Periodical Club made her annual report.

Mrs. Loomis made the report of the G. F. S. work in the Diocese. She emphasized the fact that this organization does the work of a junior auxiliary, and she urged that the women of the Auxiliary interest themselves in undertaking the leadership of these groups.

Mrs. Longley gave a verbal report of her work as Devotional Secretary, saying that she had tried to stress the need of a devotional secretary for each branch, urging, too, that the devotions at branch meetings be appropriate to the program of the day, and that an effort be made to get away from stereotyped prayers. She called our attention to a

very helpful leaflet, "A Litany for Our Nation," No. 55, suggested for use for this Lent.

Mrs. Wheeler of the Publicity Department advocated that all parishes make an effort to secure subscriptions to the Spirit of Missions. She also asked that items of interest be sent to her for publication in the Iowa Churchman.

Mrs. Treat was unable to be present to make her report because of illness.

Miss Mary Alice Bailey gave a fine report of her splendid work for the Isolated.

Mrs. Mounsey gave her report as Social Service Chairman.

Some discussion followed on the subject of the district meetings, and it was decided by common consent to urge the districts to take care of their own meetings without outside help this year.

Mrs. Grafton presented the report of the Committee on Resolutions as follows: "Whereas, during the past year, the Woman's Auxiliary of the Diocese of Iowa has lost by death the following members, we wish to place on record our appreciation of their faithful service, and our sorrow in our temporary separation:

REPORT OF PRESIDENT

The report of the President of the Iowa Branch of the Woman's Auxiliary to the National Council is necessarily much the same as previous years. As a state organization, we have followed the command of our Lord and Master "that we go into all the world." This has been done through our five fields of service as well as through the constant and untiring efforts of our officers.

Being the year of the Triennial the work has been in preparation for that meeting and since September we have dwelt upon the things done there.

I want to recommend to the auxiliaries of the state the study of the report of the committee on Findings from which much will probably be heard during present three years.

Iowa was honored by having Mrs. Harry S. Longley, Jr., a member of a sub-committee of the Central Findings Committee on Family Life.

The officers have carried on the work of their respective offices in the same careful, conscientious manner as heretofore.

Mrs. Gilmore, who is serving her first year as Secretary, is to be commended on the early publication of the Journal. This is a difficult thing to do but may I suggest here that cooperation of the Branches helps to speed up this work. If the reports could be filled out and returned at once the worry of assembling the material would be simplified.

Mrs. Jackson, our Treasurer, is most prompt and efficient in performing the duties of her office.

Mrs. Flockhart, as usual, has done outstanding work and I feel that I voice the sentiment of all auxiliaries when I say we look to Mrs. Flockhart for guidance in our Educational Work. All we have to do is to ask aid of her and it is given. She has visited most of the Deanery and District meetings this year. Her efforts are untiring.

The U. T. O. speaks for itself. It is a great satisfaction to know that this phase of the work is better understood. Each year the Blue Box yields more in money, but a great deal more in spiritual uplift.

The Church Periodical Secretary, Mrs. R. A. Nicholson, is presenting a much more encouraging report than heretofore, but she does need the hearty cooperation of every woman in the Church.

Mrs. Treat, the Box Secretary, has carried on her work efficiently. This year the demand has been great and it has been difficult to fill the quotas.

The work of the following other officers has been sincere and well taken care of: Mrs. Longley as Devotional Secretary, Mrs. Mounsey as Social Service Secretary, Miss Bailey as Chairman of the Isolated, Mrs. McEvoy, Vocational Chairman, and Mrs. Wheeler as Publicity Chairman. Please read and study their reports as given in the Journal.

It was impossible for me to attend the Triennial at Denver, but Iowa was represented by four delegates—Mrs. Longley, who presented the U. T. O. at that wonderful service, Mrs. Harry Longley, Jr., Mrs. LeRoy Burroughs and Mrs. Reimer. Their reports will be given at this convention.

The money for the Baptismal Font for St. John's, Ames, has not quite all been given. It is hoped this may be completed very soon and that it will be a free will offering.

Through the kindness of a devoted Churchwoman, we have had extra copies of the Pledges for 1931 printed and have distributed many of them. We are anxious to have these in your hands for study, so that you may better understand how the money sent to the Treasurer as our

pledges, is divided. It is suggested that at least one meeting be devoted to this study.

As your President, the year has been a busy one. In March, three meetings were arranged in the state, with Miss Grace Lindley, our Executive Secretary from New York, as the speaker. All who heard and met Miss Lindley were delighted. We regret that all of our Church women could not have had this privilege.

I have, in addition to the routine work of the office, helped with the W. A. page in the Iowa Churchman, attended the meeting with Miss Lindley in Des Moines, spoken at the spring District meetings at Keokuk, Muscatine, Dubuque, Cedar Falls, Cedar Rapids and Sioux City, at one fall Deanery Meeting at Ames, and sent 351 letters and post cards.

We are an auxiliary to the National Council and as such, must help to carry on the work of the Church. "Go ye unto all the World" was the command given us by our Lord and with this thought in our minds, we will go forward.

REPORT OF THE EDUCATIONAL SECRETARY

From January 1, 1931 to January 1, 1932

In preparing an Annual Report it is not possible for an Educational Secretary to quote figures to show growth. True enough, some statistics—such as those listed below—will show a growth in interest in the Educational work—and we are glad and proud to point to such figures as an indication that our work has not been in vain.

But the growth which is the outcome of Christian Religious Education is not to be measured by figures. Rather, we find that growth in character and lives, in attitudes and reactions, in Christlikeness and a wholehearted commitment to His cause.

To report statistics first: 31 Branches returned their annual report to me; 30 out of those 31 report some sort of educational work being done in their Branches; 17 used the mission study book for the year, 20 held program meetings, 3 had Bible classes, 3 presented plays, 3 had reading clubs, 4 had exhibits, and 4 had libraries or bookshelves.

The interest in the mission study book for the year again shows a slight increase, judging from the number of copies sold. This is indicative of an awareness of and a desire to cooperate in the study work.

During the year I have sold 129 study books, 39 other books, 1 missionary play, 26 copies of the Findings of the W. A. in Denver, and I have distributed by mail and in person over 500 free leaflets.

I have outlined parish programs for two Branches, have sent special leaflets to four Branches, written three circular letters, mailed an outline on "Building a Christian Nation" to every Branch, and mailed free copies of the new General Church Program to every Branch. I have also written a few articles for the Iowa Churchman and have written 411 personal letters and cards.

I attended the Diocesan Convention in January, one Spring District meeting and one Fall District meeting. Also one Deanery meeting. I also addressed two parish Branches in Peoria, Ill.

In my capacity as Educational Secretary for this Province I routed the Educational Secretary of the National Board through the Province, giving her ten days in Iowa.

In the spring I prepared a traveling exhibit of all the publications of the National Council. May I again call this exhibit to your attention? It will prove most helpful to you in deciding what to order for your Branch in the way of leaflets, etc.

I have had frequent calls for advice in regard to books for Church School teachers, pre-school children's material, Diocesan History Records, books for spiritual training in the P. T. A., etc. All of this is indicative to me of a keen desire for better lives on the part of the world at large.

Two items I should like to especially mention in closing:

First: The necessity for training leaders in our parish Branches. This cry greets me on every hand and from every corner of the Diocese "How to do the work?" I would like to especially urge every Branch to send at least one delegate to a Summer Conference, such delegate to go with the understanding that, on her return, she was to be responsible for the Educational work in the Branch. As a Diocese it is not possible as yet for us to have a Diocesan Director of Religious Education. Until it is, we must develop our own people into leaders and Summer Conferences give us excellent opportunity.

Second: I would urge the need for a concentrated period in which to do missionary study work. The fact that the one book is used as the topic for the program meetings over an entire year signifies to me the reason for our failure to appreciate the books we are given to study. Program meetings and study classes are two distinctly different matters. The one does not, of necessity, require cohesion through the year. The other demands it—or fails in the attempt to promote growth. The number of Program meetings in the Diocese is growing rapidly. Is the development of actual study classes impossible? I think not.

The Findings of the Woman's Auxiliary in Denver are the most thought-provoking messages we have had presented to us in some years. The Woman's Auxiliary has always, as Bishop Anderson used to say, "made progress more progressive." So this year, as we enter the new Triennium, these Findings are based on the conditions in the world about us. And the Woman's Auxiliary keeps step with the world in that she presents Christian attitudes towards conditions today; in other words, in showing the "spiritual growth" of the women of the Church in the knowledge and love of God and in trying to do His work in the world. We can do no better than to ponder long and question deeply the facts these Findings present.

Immediately after Christmas, the Parish Report blanks were sent to all parishes and missions; inserted with these were copies of the Pledges for 1931. At the present time, the majority of these blanks have been filled out and returned; in some instances, however, the explanation has been given that Auxiliary work in that particular mission station has had to be abandoned due to various causes.

Notices of the pre-Convention Board Meeting were sent to all officers who had not been notified personally by the President.

1931 REPORT OF WOMAN'S AUXILIARY CHRISTIAN SOCIAL SERVICE

Covering the work of 1931, fifty-eight questionnaires were sent out and twenty-seven replied.

I feel that we have pioneered in Christian Social Service work and that the time is now ripe for further advancement along the more recent developments.

This year has been unusual in its pressing need for a specific kind of relief, on account of unemployment, but we, as Churchwomen, must not limit our interest to this particular phase of the Department. I believe our chief aim for the coming year should be group study of the extensiveness of Christian Social Service, and to maintain the work, of which we are already familiar.

At all times, information on Christian Social Service may be obtained by asking your Diocesan Chairman.

Following is a brief outline that covers Christian Social Service work in the five fields of service:

Parish Work—Study Groups. The pamphlet, *The Parish Finds Its Community*, contains a most complete outline of work in Parish, Community, and Diocese.

Community Work—(a) Study of Community conditions and cooperation with all Social Welfare Agencies.

(b) Definitely cooperating with other Communions.

(c) Emphasis is now being placed upon recreational activities, under Church guidance, for young people. It is time that we, as a church, demonstrated our active interest in every phase of community Social work. The Church should be the motive power for such work.

The Diocese—An active interest in St. Monica's School, Des Moines, St. Luke's Hospital, Davenport, and Ames Student Center, Ames.

The Nation—The Episcopal Church has 79 hospitals; 55 homes for the aged; 82 children's institutions; 13 houses of mercy; and 8 shelters and settlements of various kinds. Also, the following cooperating Agencies: Church Periodical Club, Church Mission of Help, Seaman's Institute of America, Guild of St. Barnabas for Nurses.

The World—The attainment of world peace. This calls for a study of International Relations, and a book, "Christianity and International Relations," by The Rev. Daniel A. McGregor, Ph.D., may be obtained from Mrs. J. E. Flockhart, Dubuque, or 281 Fourth Ave., New York.

World Economic Conditions—A booklet, "Property and Economic Conditions," by Spencer Miller, Jr., may be obtained from the same source as above.

The following Christian Social Service Topics were discussed by the Woman's Auxiliary at the time of General Convention:

Family Relations Institute—The most significant new project developed by the Department, and the following booklets are recommended for study: "Family Life," by Mrs. Harper Sibley, and "Building Family Foundations," by The Rev. Harold Holt.

"Interracial Relationship," "The Church and Industry," "Religious Thinking Today"—These booklets are recommended for study and may be obtained from Mrs. J. E. Flockhart, Dubuque, or 281 Fourth Ave., New York.

Rural Work—Copies of the Report of the Joint Commission on Rural Work may be obtained free from the Department of Christian Social Service, 281 Fourth Ave., New York. This is of especial interest to our parishes and missions in rural districts.

And, let us not forget the Summer Schools. It is quite important that every Auxiliary-Guild send one or more delegates to a Summer School.

ANNUAL REPORT OF ST. MONICA'S SCHOOL

In spite of the economic and financial disturbances outside, the end of the year 1931 finds St. Monica's School carrying on its program of affording girls of unfortunate home conditions a happy home and an opportunity to fit themselves to take their places in the world as self-respecting and responsible citizens.

The year saw several outstanding improvements in grounds and buildings. A gift of \$500 from the Edwin Gould Foundation Fund for Children made it possible to put a new asphalt roof on the main buildings, build a cement drive, and make some much needed minor repairs.

Funds raised by the local Guilds and Auxiliary, with the cooperation of women of the Diocese, went into the purchase of two oil burners, one for each of the larger buildings. Owing to the unceasing efforts of our president, Mrs. E. D. Perry, and our bond treasurer, Mrs. T. S. Farquharson, the initial cost of \$1,000 was met in full by the first of the year 1932.

During the year thirty girls were in residence. They formed the choir in the Church School service at St. Paul's Church, Mr. Longley giving an hour of his time each week for rehearsal.

The experiment of placing ten girls in outside school proved most

satisfactory. Two girls will graduate in June of this year, one from East High and one from Lincoln High.

The outstanding recreation event of the year was the sixteen delightful days of July spent by the staff and twenty-eight girls at Bishop Morrison Lodge, Clear Lake. The holiday was made possible through the interest of the Social Service Department, of which Mr. Essingham is Chairman, St. Paul's Guild, which paid for our transportation, and Rev. Philbrook, director of the Camp. Needless to say, the girls returned in excellent health and spirits, and are all praying that we may have the same treat the coming summer.

Those interested in the School will be glad to know that the treasury has not shown a deficit in ten years, in spite of the fact that in 1930-1931 the number of resident girls was increased from 14 to 22 without an increase in budget.

The school now has in residence 23 girls. This makes it necessary to use the porch of the Cottage, or, if for some reason one of our girls placed in temporary homes, must spend a night, the davenport in the central room of the main building. However, it is a happy and developing family, each girl doing her part and learning, in her little world, the important lesson of "how to get along with others."

ANNUAL REPORT OF ST. KATHARINE'S SCHOOL

There are enrolled at present at St. Katharine's School 93 pupils—24 boarders and 68 day scholars. 10 of the boarders are from Iowa, 1 from Kansas, 1 from Delaware, and 12 from Illinois.

There are two endowed scholarships—the Helen Watsek Memorial and the Sarah Swazey Morrison Memorial. Besides these, the school is giving this year in free and partial scholarships

The Guild of the Holy Child sponsors the missionary work of the school. Last year the usual offering of \$200 was sent to the Bishop and Council for Missions. At Christmas a box is always sent by the school children to some mission designated by the National Council. This year it was sent to Epiphany Mission, Summerville, South Carolina. A Christmas box was also sent for thirty school children in Montana in answer to an appeal for help. A group of younger girls is supplying garments, which they make, for a poor family in Sewanee, Tennessee. At Christmas boxes were sent to the five children in this family. A guild composed of six of the youngest boarders, not yet old enough for the Guild of the Holy Child, sends a monthly allowance to four children at St. Mary's School for Mountain Girls, Sewanee. A Christmas box was sent to these four children.

The school has been kept in repair, and the usual re-decorating was done during the summer months. Playground apparatus for the younger children has been added to the equipment.

Last spring there was erected, as a gift of the Guild of the Holy Child, an out-of-door altar of stone. It stands upon the historic spot where one of the first Christian services in this part of the Mississippi Valley was held. On this site, still called "Mass Mound," a Jesuit missionary, more than a century ago, erected a great walnut crucifix and built a tem-

porary altar where the Holy Sacrifice was offered, and Divine protection invoked against the cyclonic storms which then devastated the region. It is a matter of record that since that day Davenport has never again been visited by hurricane or cyclone.

The Alumnae of the school have given their continued co-operation and interest. The members of the Tri-City Branch of the Alumnae Association especially have been unfailing in their help and support of the school. Branches have recently been organized at Des Moines and Cedar Rapids, and our Alumnae there are enthusiastically working for the school.

I would like to ask the co-operation of the Woman's Auxiliary in the plan recently inaugurated for the completion of the Endowment Fund in memory of Bishop Morrison. St. Katharine's has maintained its standards against heavy financial odds, and an adequate endowment is imperative. It was the Bishop's wish that the school should be endowed so that its continuance might be assured, and there is nothing that could be done which would be as fitting a memorial as this fund. I commend the plan to your prayers and interest, and earnestly beg your help in carrying it out.

There are a few women who have U. T. O. Boxes. \$22.50 came from them in 1931. The Advent Offering was \$1.00.

New work came as there are three Churchmen in the Federal Mental Hospital in Knoxville. Grown childish through the stress of war, tiny gifts appeal to them. Bright cards. They love to get mail—like all children.

THE GIRLS' FRIENDLY SOCIETY IN IOWA

Secretary's Annual Report—1931

Instead of attempting the rather difficult task of holding a Diocesan Council meeting at the time of the Diocesan Convention, we have this year initiated an experiment—that of conducting our official business through the medium of a news bulletin, the "G. F. S. Newsboy," ably

edited by our Publicity Chairman, Bessie Sorenson, of Clinton. The response thus far has more than fulfilled our hopes.

From reports sent in by Diocesan officers and Heads of departments, the following are taken and incorporated in this report, which takes the place of minutes of the usual Diocesan Council meeting:

The President: Mrs. Lee P. Loomis reports that while the year 1931 brought some discouragements, there were many bright spots, too. The first camp for girls, called "Camp Friendly," was conducted under the auspices of the G. F. S. at Camp Morrison, on the shores of Clear Lake. New branches have been organized at Boone and Cedar Falls, and another is likely to come to being at Waterloo. Several branches, inactive because of lack of leadership, show signs of being about to renew their work. There have been many inquiries about Camp and G. F. S. and much interest was shown in these things at the Convention, where G. F. S. had an exhibit and reported at the Auxiliary meeting. In the fall, the first issue of "G. F. S. Newsboy" was published, and has helped materially in carrying on the work in the Diocese. The situation seems altogether encouraging.

The Chairman, Department of Missions: Miss Lettice Kennedy reports a Diocesan gift of \$10.00 from the Summer Conference held at Camp Friendly, to go to our National project, the new Mission Chapel for Hillsboro, Oregon. Eight branches have sent boxes to Brule Indian Mission at South Dakota, with the following approximate values:

In addition to the above, St. Paul's Branch at Council Bluffs has sent \$5.00 for the G. F. S. National project. \$2.50 has also been contributed for the U. T. O., making a total for Missions for 1931 of \$101.25. Forty U. T. O. boxes have been sent to the Diocese, and next year's report should have something of interest to report on this work.

G. F. S. in Iowa regrets exceedingly having received the resignation of Miss Kennedy as Diocesan Chairman of Church and Missions. Miss Kennedy has served faithfully in this position for twelve years, and is certainly worthy of commendation.

The Finance Chairman: Mrs. S. F. Hoffman reports six sustaining memberships pledged, amounting to \$105.00, of which \$40.00 has already been paid in. The purpose of these sustaining memberships is to gain the support of women who are interested in girls' work, in enabling the National G. F. S. to be entirely self-supporting.

The Custodian of Supplies: Mrs. D. J. Gillard, reports supplies and material sold to Iowa branches, for their admission services, consisting of admission service cards, membership cards and pins. The department also handled the new National program material and candidates' supplies.

The Chairman, Department of Membership: Mrs. E. W. Biddinger, reports that the new field of rural work has claimed the most attention. Early in the year, letters were written to all Branch Presidents, urging

them to adopt rural members. Letters were written to the Diocesan office, to a great many of the clergy and to others, requesting the names of isolated girls, and some sixty letters have been written to these isolated girls thus found. As a result, three rural members have been adopted by branches, and have received the G. F. S. Magazine. Two rural members attended the Clear Lake Conference last summer. There are two prospective members, now ready for adoption. Mrs. Biddinger stresses that many more are waiting, alone and unsought, for us to hold out the helping hand and welcoming heart. May we, with God's help, seek them this coming year.

Miss Bessie Sorensen, of Publicity Department, reports that the Publicity department has attempted to keep in touch with the different branches by correspondence, receiving what news the branch publicity chairman could send. October brought the first issue of the Newsboy, which since that time has been coming each month to a total mailing list of 56, including an exchange of Diocesan papers with the Dioceses of Bethlehem, Massachusetts and Pennsylvania. She quotes a letter received from Miss Sarah Morrison, Editor of the "Record" as follows:

"I want to congratulate you on the January issue of the G. F. S. Newsboy. I am particularly interested in two things that you have done. One is your list of duties of the Diocesan officers, and the other is your using the Newsboy as the means of voting. Yours is certainly a live bulletin."

The Activities Department Chairman: Miss Pauline Larson, reported that her five committee chairmen have tried to encourage better programs in their various fields of Worship, Classes (now changed to Music), Missions, Social Service and Recreation, having been given a regular time to broadcast their information through the G. F. S. Newsboy. Outlines for the year's study were sent out to the Branches and many letters to the Committee Chairmen. The poster reports sent to the convention by the Branches last year unfortunately were lost in the mails before completing their itinerary of the Branches. Miss Larson stressed three objectives for 1932: 1. Education for Leadership among Associates and older members. 2. A Reinterpretation of religion to become the dynamic center of each individual's life. 3. Increasing co-operation with parish and community groups.
