## THE PRESIDENT'S ADDRESS

It is with some feeling of trepidation that I approach the task of writing my report as president of the Iowa Branch of the Woman's Auxiliary for its forty-sixth annual meeting. In looking over the reports of past presidents, I am overwhelmed with the realization of the immense amount of work accomplished by these splendid women, of their many visits to parish branches, of their organization of branches in many places over the diocese, of their talks before deanery and district meetings—and so on and on.

It is due to their efforts and the whole-hearted cooperation of women whom they have enlisted as officers and department chairmen, that the work and responsibility of the diocesan has been greatly reduced.

Mrs. Herbert Horton has served her first year as our diocesan secretary, and has proved herself most efficient and conscientious. I am sure that you will agree with me when I say that the copy of our Journal which reached us early last spring is wholly satisfactory and complete.

In spite of economic conditions, Mrs. Morgan's report for 1932 shows an increase in the U. T. O. over that of 3 years ago. Surely this fact



testifies to the soundness of the foundation built by our Custodian, as well as to the inspiration and loyalty with which she fires the branches to carry on this primary work of the Church: the Great Commission of Our Lord.

In spite of the keen disappointment involved in the failure of the Clear Lake Conference for which Mrs. Flockhart worked so diligently through the spring and summer, she still carries on, bringing her messages of inspiration and encouragement wherever it has been possible for her to carry it. Where she has not been able to go personally, her well-thought-out program of study for the year's work has brought her message of religious education. May I add a personal word of appreciation here for the help with which she and Mrs. Longley have responded so generously to my appeals for advice.

Those of you who are branch presidents must realize the number of hours which went into the preparation of the Social Service material sent to you by our chairman, Mrs. Mounsey. This is a department which should claim our attention increasingly through the years.

Mrs. Wheeler has relieved the presidency of a large responsibility by taking over the supervision of the Auxiliary page in the Iowa Churchman. I understand that it is a question whether or not our diocesan paper can continue publication at the present time. If it is possible to consider sending it our monthly or bi-monthly, Mrs. Wheeler will be very grateful to have any notes of special interest from the branches.

To two of our officers who cannot be present with us we are much indebted for faithful, loyal service. Miss Mary Alice Bailey who is abroad on an extended journey, has built up and maintained a very remarkable work among the isolated Church people of Iowa. Because of her protracted absence, Miss Bailey sent in her resignation to the Board of Religious Education, but we hope that another year will see her back with us in this or some other diocesan activity.

As many of you know, our C. P. C. Correspondent, Mrs. R. A. Nicholson, has been seriously ill for some months, and Miss Thomas of the National Board has been taking care of her work. Mrs. Nicholson has asked me to extend to this Convention her greetings and the assurance that her prayers will be with us through these days. She has given so much of her enthusiasm and time in developing and carrying on this activity against serious difficulties, that we all wish to see her remain at its head, and this is possible through the willingness of Miss Thomas, of the National Staff, to carry on the Iowa until such time as Mrs. Nicholson is able to resume it. Mrs. Nicholson's loyalty and faithfulness are an inspiration to all of us.

Mrs. Treat as our supply secretary has also worked against great odds, for many branches were unable to take the seemingly large quotas sent to them. In addition to the assignment of boxes, she also has charge of a diocesan supply room from which supplies may be requisitioned for diocesan or general missions—if the supplies are there.

Mrs. McEvoy, our vocational chairman, has a work that can scarcely enter into a detailed report because of its very nature.

Last, but certainly not least, we come to our Devotional Chairman, our beloved Mrs. Longley. If our auxiliaries would take to heart her advice and help, I know that we should find new spiritual life and activity animating our organizations and, through them, the parishes themselves.

As your president, I have tried to take care of correspondence, including one letter and one post-card to each branch, two letters to branches through the Auxiliary page in the Iowa Churchman and various national and provincial items. I attended the Muscatine Deanery and made a brief address,



and I also attended a meeting last April in Omaha of bishops, field secretaries, and Auxiliary presidents of the Sixth Province, called together to consider the crisis facing the Church, and the consideration of the Whitsunday Offering. Because of a lack of funds, it has been necessary for me to refuse, with sincere regret, several invitations to visit some rather distant parish branches.

It was also because of the necessity for retrenchment that our September Board Meeting was cancelled.

The great disappointment of our Auxiliary year lay in the cancellation of the conference planned to be held at Clear Lake late in August. We suppose that the small number of registrations was due to inability to finance the week's stay, and the result was the cancellation of a project from which we had hoped much for the educational and spiritual life of the diocese. I am afraid it has left some of us with a keen sense of dissatisfaction as we take a bird's-eye view of the diocesan Auxiliary year.

However that may be, we are now in a new year, and a year that will challenge the best that is in us. These times which have brought our material possessions tumbling about our ears, must bring a gripping sense of fear to many of us. It takes something like the spirit of our pioneer forebears to face the future with courage and an unshakable faith in God and man.

Can we not—or rather—must we not, make that our immediate concern for the year 1933? During the past months we have made many mental and material adjustments toward life and its needs. We are beginning to realize that old truth, that it is only the spiritual that is eternal and wholly dependable.

These years of stress are having two diametrically opposite effects religiously. Many are turning entirely away from Christianity; others are seeking in the denominations holding to an authoritative Christian teaching and practice, that rock on which they can build new lives. Of such caliber is the Church to which we yield allegiance, and it is for us to renew our faith and zeal, to get ourselves out of our religious ruts, that we may be compelling witnesses for the Church of Christ wherever our lives may be cast.

To get away from that sense of spiritual loneliness and shyness which cramps so many of us, we need to make every effort to introduce in our parishes and missions such projects as the World Day of Prayer, set for March 3rd of this year; we need to see that we have an occasional "Quiet Day," under the leadership of a priest if possible, but under some devoted woman if no clergyman is available. The Auxiliary has prepared very helpful materials for these occasions. Then, there are the small prayer groups. There could be parish days of intercession when we have the unusual experience of going into our churches and finding individuals kneeling in private or intercessory prayer in that place of quiet and peace. All of these and more—a personal effort on the part of every woman of the Church to deepen her own spiritual life by seeking a quiet time each day for her own private prayers and meditations. The Christianizing of the world has to start with the Christianizing of the individual, and the individual we must each start with is one's self. Let me close with a quotation from one of our Auxiliary booklets which sums up the thought which I have in mind, "In order to bring Christ's kingdom upon earth we must first deepen our own spiritual life, both individually and as an organization. We cannot share with others that which we have not felt ourselves and we cannot bring them into an organization of the Church from which we have



not gained spiritual strength. So the whole emphasis swings back to our need of a deeper religious experience individually and as an organization.

## REPORT OF THE EDUCATIONAL SECRETARY

FROM JANUARY 1, 1932 TO DECEMBER 31, 1932

In preparing my Seventh Annual Report as Educational Secretary of the Woman's Auxiliary in the Diocese of Iowa I have gone back over my files to glean information as to growth, results, etc. in the various branches and, while there is vast improvement along some lines to be noted during these seven years, it is interesting to note also the continuous emphasis on certain phases of the work. And, inasmuch as "repetition is the soul of education," I am again calling to your attention these same points which I would recommend as essential to the greater growth of your organization along educational lines. They are as follows:

1. That each branch appoint an Educational Secretary whose task is the furthering of educational matters within the branch.
2. That each branch try to develop leadership by sending at least one delegate to a Conference in the summer.
3. That a definite period during each year be devoted to the study of the recommended topic for the year.
4. That educational programs be presented at every meeting.

Officially I have sent three circular letters and one course of study to every branch in the Diocese. I have written 1158 personal letters and post cards. This number is unusually large this year but the increase is due to the efforts expended in planning the Conference at Clear Lake. I have addressed the Diocesan Convention at Des Moines, the three Deanery meetings at Muscatine, Waterloo, and Boone, and I addressed the Cedar Rapids District meeting at Anamosa. I have filled 61 orders for various supplies including study books, plays, leaflets, pictures, maps, etc. and totalling 284 pieces in all. I have distributed 350 pieces of free literature at meetings. I have drawn up year programs for two branches and have helped to organize one group of Juniors. I have sent dozens of suggestions to those asking and I have also written articles for the Iowa Churchman.

My deepest regret is that the Clear Lake Conference did not materialize. We had secured a splendid faculty and most worthwhile courses were offered, but the lack of enrollment prohibited us from going further and, upon advice from the Bishop, we cancelled the entire plan at the last moment. In view of prevailing financial conditions I believe it is imperative that this convention definitely decide before adjournment whether or not we are to have a conference this year, choose tentative dates for the conference, and underwrite the expenses of the conference up to a certain sum. We all know that a conference is not beyond the ability of the Church in Iowa. Let us all assume our responsibility in regard to it, both as individuals and as organizations.

At present it is often said that these days are bringing the Church more and greater opportunities than she has had since the war; that the world is



moving into a new religious climate; and that the impact of the depression is producing a responsiveness to religion which has been all but lost during the past decade in the lives of individuals.

Recently a Chinese young man said that "Christians have something to give them hope when everything is utterly hopeless."

What is it the Church has to offer of hope and encouragement? Just this: Christ's promise of power. Not the physical power which we cannot seem to master in production and distribution and consumption; but the living, vital power that enables us to overcome fear and doubt and worry.

Bishop Rogers of Ohio has recently said, "There is no unemployment in the Kingdom of God." And may I say that if every parish and mission represented in this convention were to seize the opportunities given it today, were to face the tasks confronting it today, all of our unemployed would be active and the Church would be producing that which she alone can produce. If the Church were producing financial profit today business men would be falling over themselves to invest in her—so great is the challenge.

"I have no interest in missions," said a petulant young lady. "No," replied her Aunt, "you can hardly expect to. It is just like getting interest at the bank; you have to put in a little something first; and the more you put in, the more the interest grows."

And so, may I plead for renewed interest in the educational side of the work. Its returns are large—inspiration, interest, enthusiasm—and its greatest asset is the fact that it costs nothing except the use of one's brain and the consumption of one's leisure. Our religious indifference has brought about moral destitution. Let us turn again to the only adequate way out—the way of Christ and His Cross.

## ANNUAL REPORT OF ST. KATHERINE'S SCHOOL

To the Woman's Auxiliary of the Diocese of Iowa—Greetings.

In common with all educational institutions St. Katherine's has had a difficult time this past year in meeting running expenses. However, notwithstanding the small enrollment, the standard of the school has been maintained. The friends and faculty of St. Katherine's have been more than ever helpful and loyal, and the Bishop has given much consideration to the problems with which we are faced. It is desirable that in these unsettled times, the work of Christian education be not allowed to fail a world so sadly in need of it. From St. Katherine's each year has gone a number of young women, who take leading parts in the work and worship of the parishes of the Diocese. Some of these graduates have received N. A. L. A. diplomas in addition to their school diplomas. The standards set by the National Council for membership in the National Accredited Leaders Association are high, and these diplomas mean that those who receive them are well versed in the things a Christian should know and believe as well as trained in the ways of presenting them to children of different ages and different backgrounds. Teachers thus equipped are invaluable in the mission work of the Church.

As a measure of economy the beautiful school chapel has been closed during the cold months, and a temporary oratory has been arranged in one of the libraries. The worship of the school, however, has in no way suffered on account of this. The daily services have been held, and the girls have attended the Cathedral on Sundays.

On the Feast of the Purification, which is the day of the founding of the Community of St. Mary, the school held its usual Candlemas celebration in the Cathedral. The Bishop officiated, and the Dean, assisted by a number of the clergy, celebrated the Holy Communion. The school choir sang the service. A large congregation was present, and many joined the candle procession. After the service the school gave a luncheon party, and the holy day ended in a holiday.

Lent is systematically observed at St. Katherine's. On Ash Wednesday the Lenten resolutions are offered at the altar, and the faithfulness with which they are kept would be an inspiration to many of our older communicants, could they be where they could see and know the lives of the girls.

Ways of raising money for the Easter offering have been well organized. On account of the very small enrollment, Lenten plans will have to be changed somewhat this year but a united effort is being planned.

The yearly Confirmation classes receive special instruction in addition to the regular required classes in Scripture and Religious Education.

In addressing a gathering of Church women, assembled for the purpose of giving new impulse to Christian work and worship, I have in the brief time allotted, tried to give some points that may help you to realize the religious atmosphere of the school, and its importance as a disseminator of Christian influence. There are many other aspects of St. Katherine's that could be presented for your consideration, but I leave them, as of secondary importance to you, though to many also the social and educational facilities of the school come before those of Religion. I beg your interest and prayers for the work at St. Katherine's and ask you to think of it as one of the Church's missions to the girls of today. As fellow workers in Christ's vineyard the Sisters of St. Mary ask, as they desire to give, cooperation in the blessed work of Christian Education, or perhaps it may be better stated—educating Christians.

## REPORT OF ISOLATED WORK IN 1932

It is with real regret that I must send in my resignation as Chairman of Isolated Work in Iowa, and earnestly hope that my successor may find as much real happiness in this work as I have during these past years.

There are 328 names on the Isolated List.

Last February, in an attempt to bring about a closer acquaintance, and real friendships among our Church people who lived somewhat near each other, I sent out a Round-Robin letter, to 33 groups of Isolateds. These groups covered the whole Diocese; i-e, every isolated name was grouped in among the 33. But not one of these Round-Robin letters ever came back to me, so this attempt must be written off as a failure.

The Sunday School work has grown somewhat. Last year I had eight pupils and this year 14. Each of the 14 has had a lesson-letter thought out and written out, each week, in addition to have the usual Quarterly sent them.

I had planned on making out a Course of Lessons on the Prayer-Book this fall, but had to postpone that, and now, that I find I must give up this work it will fall to my successor.

I have sent Instructions for Confirmation to two people this year. Three Confirmations have been reported to me, and one Baptism.

The Lenten Mite-Boxes brought \$6.40, and the Advent Mite-Boxes are still to come in. I will send the money to headquarters as soon as I can.

Our Auxiliary Blue Boxes have been placed with several ladies.

## THE GIRL'S FRIENDLY SOCIETY IN IOWA

### Secretary's Annual Report—1932

The year 1932 being one of adjustments to a new order of living conditions Nationally, G. F. S. in Iowa has not attempted to do extensive advance work, but to maintain the interest of the established Branches, and to keep their program one that was helpful to the girls themselves, and encouraged them to be a vital part of their parish life, and the general church's program in all its phases.

No Field Secretary was available for Iowa this year, since Miss Averill became the wife of the Rev. Lawrence Rose and moved her residence to Deer Lodge, Montana. We regretted her departure from the National office staff.

Once more G. F. S. in Iowa has conducted its business by correspondence, and held only one brief Council meeting. This was at the time of Camp Friendly, Clear Lake, June 19, when about ten officers and member delegates attending the Camp and from Mason City, talked over G. F. S. plans with the Bishop after his service of Holy Communion for the Camp. This service was followed by a G. F. S. admission service for the members of Cedar Falls' new Branch, and two diocesan members at large, Miss Harriett Merritt of Fort Dodge, and Beverly Blunk of Ottumwa.

Camp Friendly the second at Clear Lake and the fourth G. F. S. camp in Iowa, reported a most successful week, both from the standpoint of attendance, and the enthusiasm of the 73 girls present. The faculty of all church women with Father Longley, the Chaplain, gladly contributed their time and efforts to make the camp a beneficial and happy one. Mrs. McEvoy the Dean had a splendid program for the week which showed many days of preparation and planning in advance. Because Mrs. Loomis found the duties of Registrar and Camp Hostess so strenuous at times that they conflicted with her office of Diocesan President, her resignation as president is to become effective in September, when Mrs. Biddinger can assume the duties of that office.



Last spring Mrs. Gillard had to give up her offices of Secretary and Custodian of Supplies, because of ill health. These duties were temporarily carried on by Mrs. Loomis until the annual election could be held.

Annual reports from the Branches show greater activity centered around parish responsibilities this year, and they have cooperated with the other parish organizations as well as carrying out their own program. The greatest gain is shown in the Social Service Department, with \$126.45 reported in money gifts and value of contributions to Community work. The Missions Box quota sent to the Rev. James Hopper, Kinston, N. Carolina, was valued at \$45.04, and \$10.00 was sent to the National G. F. S. mission project at St. Augustines, Kohala. Both mission projects were studied at the meetings.

The "Newsboy" which has been so ably edited by Miss Bessie Sorensen the past two year with a minimum of expense, was silent this fall because of the illness of Mrs. Sorensen, but came out once more with the special election edition, which resulted in the election of the following officers. In September Mrs. Biddinger and Mrs. Loomis will exchange offices and Mrs. Biddinger will appoint a new Secretary and Treasurer living near her.

## REPORT TO WOMAN'S AUXILIARY BY DEPARTMENT OF RELIGIOUS EDUCATION

A new secretary for the Church's work among the Isolated has been appointed to take the place of Miss Alice Bailey, who has done such excellent work for the past years. Necessity has compelled Miss Bailey to leave Iowa and travel with her brother who is in poor health. We regret her having to give up the work she has so well done.

Miss Letha Davidson of Ames is the new secretary for this work. Miss Davidson is well qualified to administer the Church School lessons and the other literature that is sent out by this department. Miss Davidson is head librarian of the Ames City library and has been a Church School teacher for many years.



But there is much work that will have to be neglected if we do not have a small grant for the purchase of leaflets and payment of postage. The entire budget of the Department of Religious Education (exclusive of \$500 which is a yearly contribution towards the payment of the principle of the mortgage held on our camp grounds at Clear Lake) is \$50. That means that we have been cut to the very quick.

Being new as head of this department, I do not know what has been the custom in times past. I do hope, tho, that the Auxiliary can, through their educational secretary (Mrs. Flockhart), give a grant for Church School materials for Isolated children, prayer cards for adults, and a leaflet that comes out quarterly from New York (which costs 5c per person per year).

On behalf of the department, may I call your attention to the various camps and conferences being held at Clear Lake this summer? We hope that there will be one for Church Workers, dealing chiefly with Religious Education, Missions and Personal Religion. If so, please try to attend and to interest others in attending. Unfortunately, when our budget was cut, nothing was left for scholarships, so all attending will have to pay their own way of come as delegates from their local parishes and missions. Perhaps, tho, this is the best way after all. Those who come get the benefit and surely do not mind assisting in the expenses of the conference.

## 1932 REPORT OF THE CHRISTIAN SOCIAL SERVICE SECRETARY

Sixty-seven questionnaires were sent out to parishes and missions.

Of the eighteen who returned the questionnaire, nine have chairmen of C. S. S., eight have C. S. S. groups or committees, six are working as a group with other churches, seventeen are working with local Welfare Agencies, eleven have had discussions or study during 1932. (Quite often this meant just one meeting a year devoted to a study of some sort. Only in a few cases was there an attempt for a definite 9 or 12 month outline.)

Fourteen are doing C. S. S. work in the Parish, sixteen are doing C. S. S. work in the Community, fourteen are doing C. S. S. work in the Diocese, six are doing C. S. S. work in the Nation, five are doing C. S. S. work in the World.

Department disbursements for the year 1932 amounted to \$5.68.

The books and pamphlets that were studied in whole or part by those reporting included the following: Building The City of God, Building A Christian Nation, Property and Economic Conditions, Family Life, and Religious Thinking Today.

The humantarium side of Social Service was apparent in the replies received. Assistance was given in many ways, such as: Food, fuel, clothing, finding employment, rent, medicine, hospitalization.

An outstanding item in the splendid report from St. John's Parish, Du-buque, was a "Parish Garden," several plots of ground in which vegetables were raised last summer. The Church School boys made and worked the garden. The women of the parish canned the food, which amounted to several hundred quarts. This food was used for distribution among the needy during the winter.



The question, "What Local Welfare Agencies are you working with, and How," brought the following answers: Red Cross, Social Service League, Salvation Army, Visiting Nurse, P. T. A., Baby Fold, Sunshine Clinic, County Relief Supervisor, Community House, Emergency Relief Association, Home for the Friendless, Associated Charities, Etc. By sewing, folding bandages, joint meetings for better understanding and co-operation with local charities, donations of food and clothing through various agencies, calling, etc.

One Branch reported that several of their members were "Friendly Visitors." These were assigned certain families whom they visited from time to time, reporting needs and conditions to their chairman—this brings me to the subject of "case work."

Case work is a part of Christian Social Service, a somewhat neglected part, but nevertheless, a very important part, and sooner or later each Branch comes in contact with this particular phase of this department. So many things enter into case work that a thorough study of it should be made before anything on that line be attempted. In fact, I cannot urge too strongly the need of STUDY of Christian Social Service, individually and group, and continually, to better fit ourselves for the intelligent carrying out of the aims of this extensive department.

If I were asked to name the weak link in the work of this splendid department, I should not hesitate to reply "neglect of study." Now this means the giving of our time—because it DOES take time. But couldn't we, in purloining out a tenth of our time, give C. S. S. the share due to it.

Books recommended for case work study: Art of helping people out of Trouble, by Karl De Schwinitz. Social Problems of the Family, by Ernest R. Groves. What is Case Work, by Mary E. Richmond. The Problem Child in School, by M. B. Sayles.

## CONSTITUTION

### ARTICLE I

#### *Name*

The name of the organization shall be The Iowa Branch of the Woman's Auxiliary to the National Council of the Protestant Episcopal Church in the United States of America.

### ARTICLE II

#### *Object*

The object shall be to forward in every way possible, within the Diocese, the interests and plans of the National Council.

### ARTICLE III

#### *Membership*

Membership shall be composed of the Parish and Mission Branches within the Diocese.

### ARTICLE IV

#### *Officers*

The wife of the Bishop shall be the Honorary President.

The elective officers shall be a President, First Vice-President, Second Vice-President, Secretary, Treasurer and Custodian of the United Thank Offering, elected by ballot at the Annual meeting preceding the Triennial Convention.



## ARTICLE V

### *Departments*

There shall be the following Department Secretaries, appointed by the President: Christian Social Service, Church Periodical, Devotional, Educational, Isolated, Publicity, who shall also represent the Spirit of Missions, Supply and Vocational, also Secretary of Good Friday Offering.

## ARTICLE VI

### *Executive Board*

The above mentioned officers and department Secretaries, together with the wife of the Bishop, shall constitute the Executive Board.

## ARTICLE VII

### *Amendments*

This Constitution may be amended at any Annual Meeting of the Woman's Auxiliary by a two-thirds vote of the delegates present and voting, provided the proposed amendment has been previously submitted in writing to each Branch at least thirty days before such meeting.

---

## BY-LAWS

## ARTICLE I

### *Duties of Officers*

Section 1. The President shall preside at all meetings of this organization and of the Executive Board. She shall appoint a nominating committee of three, subject to the approval of the elective officers at least thirty days preceding the Annual meeting. She shall be ex-officio a member of all committees, be a delegate to the General Convention, and shall have general oversight of the Auxiliary activities in the Diocese.

Section 2. The Vice-Presidents in their order shall be prepared to perform the duties of the President in her absence or inability to serve.

Section 3. The Secretary shall keep the minutes of this organization and of the Executive Board. She shall issue the notices of the meetings and shall perform such other duties as may be assigned to her by the President or the executive Board. She shall obtain annual reports from the Parochial Branches, and issue the annual Journal.

Section 4. The Treasurer shall receive and disburse all monies of the organization, excepting the United Thank Offering, keeping full and accurate accounts of all monies received and expended, all bills to be countersigned by the President. She shall make a complete report to the Auxiliary at the Annual meeting, and her books shall be the property of the Auxiliary and open to inspection or for the information of authorized officials at all reasonable times and places. She shall furnish a Commercial Surety Bond, at the discretion of the Executive Board, the premium to be paid from the Auxiliary Treasury.

Section 5. The Custodian of the United Thank Offering shall receive all contributions for that fund, and endeavor to arouse and increase an interest in the same. She shall collect twice a year and remit same to the Treasurer of the National Council. She shall furnish bond under the same conditions as the Treasurer.

## ARTICLE II

### *Duties of the Department Secretaries*

Section 1. The Christian Social Service Secretary shall at all times be informed as to the needs of Social Service work in the Five Fields of Service



and in the Rural districts, and shall receive reports from the local Branches as to the service they are giving.

Section 2. The Correspondent of the Church Periodical Club shall receive and disburse all magazines, books and any other material which may be used in her work.

Section 3. The Educational Secretary shall have general supervision of all Religious Educational work of the Diocese carried on under the auspices of the Woman's Auxiliary.

Section 4. The Secretary of the Isolated shall look up and keep in touch with all Churchmen in districts where there is no Church, sending them periodicals, seeing they are baptized and confirmed and assisting them in any way needed.

Section 5. The Publicity Secretary shall look after any unusual publicity and shall solicit subscriptions for the Church periodicals—Spirits of Missions and other periodicals.

Section 6. The Supply Secretary shall receive and distribute all information relating to Missionary Boxes and all gifts of cash, clothing and materials for the same, and shall make a complete report of her work at the Annual meeting.

Section 7. The Vocational Secretary shall interview students in the Student Centers and other young people as to their future work in the Church.

### ARTICLE III

#### *Nominations and Elections*

Section 1. A Nominating Committee of three shall be appointed by the President at least thirty days prior to the Annual meeting. This committee shall prepare the ticket and present same not later than 11:30 a. m. of the first day of the Convention. The name of no candidate shall appear upon the ticket unless she has consented to serve if elected.

Section 2. The election of officers shall take place the afternoon of the first day of the Annual meeting.

Section 3. All officers are elected to serve for a term of three years or until their successors are elected and qualified. The Custodian of the U. T. O. will not take office until after the following Triennial.

Section 4. The Executive Board shall have the power to fill all vacancies occurring within its own body. The President may also be empowered to fill vacancies if deemed advisable.

### ARTICLE IV

#### *Meetings*

Section 1. The Annual Meeting shall be held as arranged by the Executive Board at the time and place of the Annual Diocesan Convention.

Section 2. The Executive Board shall meet at the call of the President.

### ARTICLE V

#### *Delegates*

Section 1. Each Parochial Branch shall be entitled to three delegates or their alternates to the Annual meeting.

Section 2. Members of the Executive Board shall be delegates to the Annual meeting by virtue of their office.

Section 3. Delegates to the Triennial shall be elected at the Annual meeting preceding the Triennial, nominations being made from the floor and the election being by ballot.



Section 4. Delegates to the Provincial Synod shall be appointed by the Executive Board.

Section 5. Any vacancy occurring among the delegates to the Triennial or the Provincial Synod shall be filled by the President, or the Bishop of the Diocese.

#### ARTICLE VI

##### *Quorum*

Section 1. A Quorum for the Annual Convention shall consist of representatives from at least eighteen Parochial Branches.

Section 2. Five members shall constitute a quorum for the Executive Board.

#### ARTICLE VII

##### *Parliamentary Authority*

Robert's Rules of Order Revised shall be the Guide on all points not contained in these By-Laws.

#### ARTICLE VIII

##### *Amendments*

These By-Laws may be amended at any Annual meeting by a vote of two-thirds of the delegates present and voting, provided the amendments have been mailed to each branch sixty days before the convention, or submitted to the Executive Board just previous to the Convention.
