6. Pray for the work, especially on the first Sunday in May.

REPORT OF THE EDUCATIONAL SECRETARY

FROM OCTOBER, 1935, TO MAY, 1936

The Report of your Educational Secretary is as follows:

I have sent three circular letters, one study outline in December and one in February completing the outlines on the topics presented at the last General Convention. I have written 267 letters and 94 post cards. I have written articles for each issue of the Iowa Churchman and for the News Bulletin of the Province. In January I routed Mrs. D. D. Tabor, one of the Field Secretaries from New York, through the Diocese sending her to twenty-two centers and making plans with the clergy in all other parishes and missions for each parish and mission to send representatives to her Mrs. Tabor at these centers. Due to the unprecedeted weather during January, most of the outside places were unable to send their representatives to the central gathering place, and the meeting in one center had to be cancelled because the trains were cancelled. However, it was little short of a miracle that Mrs. Tabor was able to complete such a full schedule in the face of such weather.

Mrs. Tabor's talk centered on the unification of the work of the womanhood of the Church and, following her visit, I again got in touch with every parish and mission, securing the name of every woman's organization in the Diocese together with the name of the president of the same for 1936. (This list is complete today with the exception of one parish where there is no priest and where I was unable to get any answer from any lay person whom I knew in the Parish). I believe this is the first time that such a list has ever been compiled in the Diocese and it must be but our first step in uniting all of the women's work in the Diocese of Iowa and, by the time of our next Convention, we ought to have, not only doubled attendance and interest in our Convention, but our work ought to be doubly strengthened in all of the Diocese.

You will recall in the Bible that the drawing of the water from the well and the carrying of it to thirsty ones was the work of women. In our work in the Church we have that Great Well to draw upon—that Well of Knowledge, of Power, of Divine Grace, of Love, and of Peace. Let us unite together with every woman in our Parish and Mission this year to carry the Water from that Well to the whole world.

MINUTES OF THE IOWA BRANCH OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

MAY 11, 1936

Whereas the Sarah Swazey Morrison Memorial Endowment was provided for said School through the efforts of the Women of the Auxiliary in the Diocese of Iowa, and

Whereas, if through foreclosure the property of St. Katherine's School should be lost to the Diocese of Iowa, the purpose of said endowment fund would be forever defeated:

Resolved that the Woman's Auxiliary of the Diocese of Iowa in Convention assembled express to the Trustees of St. Katherine's School their opinion that, in case the necessity arise, the purpose of the endowment fund will be better fulfilled by the application of such por-

tion of that fund as may be required to the saving of the property from foreclosure.

Dean Philbrook spoke to this resolution. After discussion, this resolution was unanimously accepted by rising vote.

Morehouse, 1001 Tremont Ave., Davenport, for the Davenport District, and Mrs. Craig T. Wright, 1064 Twenty-second St., Des Moines, for the Des Moines District.

Mrs. Morehouse has written twice to their Prayer Partner, Miss Elsie Reibe of American Church Mission, Ichang, China, but, as yet, there has been no reply. We shouldn't allow this to discourage us. Conditions in China being what they are at the present, the letters may not have reached her. Then too, Miss Reibe may have little inclination and less time for correspondence as she is the only foreign worker in Ichang.

But eventually, the feeling that she has a definite place in our personal interest will come to her and that, in itself, is accomplishment—of the object of the Prayer Partnership Plan.

Mrs. Wright was more fortunate in her correspondence probably because the Missionary assigned to the Des Moines District, is not so far away. She is Miss Aline Conrad, of St. Anne's Mission, El Paso, Texas. Miss Conrad replied very graciously to Mrs. Wright, and her letter has started on its pilgrimage to the various Branches in that District.

As yet it has not been possible to obtain the completed list of Auxiliaries in the Diocese and consequently, many parishes have not received the Explanatory letters which will enable them to understand and participate in the Plan. As soon as the additional names are at hand, the letters will be sent out.

The women of the diocese have been splendid in offering their work and money. Not one assignment was refused; many groups asked for more work.

A total of \$348.03 was sent out as assignments from the Church Mission House. This includes the Girls' Friendly work which was valued at \$15.90. Boxes valued at \$16.12 were sent St. Luke's Hospital, Davenport.

Mrs. Murray of Des Moines drove to Mission, So. Dak., with a box for Rev. Hugh Charging Bear and his wife. She had a most interesting visit with the missionary.

Our assignment included: 3 institutions, 2 personals, 2 women missionaries.

Iowa. The boarding department has been recruited mostly from other states. There also seems to be an awakening interest in the school, on the part of the parishes of the Diocese. This past year three parishes have sent boxes to the school. From Independence came a consignment of canned fruit and vegetables which gave variety to our menu. The ladies at St. John's, Cedar Rapids, sent some always needed tea towels, and St. John's, Dubuque, recently sent some tray cloths which were gratefully added to our linen supply. These marks of interest are encouraging. The Church school at Grace Church, North Clinton, made a pilgrimage to Davenport and visited the school. We should be glad to have other Church schools visit us in the same manner.

Financing the school is always a problem. Compared to other schools of the type, our tuition is low, yet we should like to keep it low enough to be available to people of moderate means. Any suggestions as to how we can do this, and still maintain our standard will be welcomed. Our teachers are receiving much smaller salaries than public school teachers, though the service they give is the very best. They also give much that cannot be estimated in terms of salary. I state briefly some figures that may be of interest.

We have twenty-eight boarders this year as compared to twenty-one last year. Three of these pay no tuition, as their mothers are employed in the school. There are thirteen teachers on the pay roll. The day school numbers 63. The younger children are mostly day pupils, and we note among these an increasing proportion of unbaptized children, so I feel that we have growing opportunity in our lower school.

We thank you for your help and solicit your continued interest. I hope many of the delegates will have time to visit the school before they leave Davenport.
