Two board meetings were held at the time of the Convention.

I was delighted to be a guest at the Nebraska Deanery, held in Omaha, to meet Miss Beardsley, National Council Educational Secretary, and to hear her talk on her trip around the world and of the work done in our foreign missions.

At the Church Workers Conference, held in July at Camp Morrison, Clear Lake, there was great enthusiasm shown. We have accomplished a work in the Conference quite worth while. At the board meeting at Clear Lake a copy of the new Constitution and By-Laws was read and discussed. It will be brought before the next Annual Meeting for discussion.

October was the most thrilling month with the meeting of the Triennial General Convention of the Church in Cincinnati, which I attended. The "Love and Fellowship" shown by all the women of the Auxiliary was most inspiring.

During this time I attended the annual meeting of the sixth Province when the new officers were installed, two of whom are of our Diocese: Mrs. Flockhart as Provincial Representative to the National Council, and Mrs. Jackson as Provincial Treasurer.

Three splendid meetings were held in Cedar Rapids, Des Moines, and Sioux City, at which reports were made by the delegates to the Triennial. A board meeting was held in Des Moines at the same time that the other meeting was held there.

May the new year bring more and more women into the active work of the Auxiliary, and the continued interest and devotion of all the many women now active be continued.

REPORT OF DEVOTIONAL SECRETARY

The Diocesan Devotional Secretary reports sixty-five letters sent to all Parishes and Missions listed in the Auxiliary Journal. These letters contained a special appeal for increased devotional life in all our church work. Also in these letters a request was made that, where it was possible, a corporate communion of the women of each parish be held at the same time of the corporate communion at the Triennial, when the United Thank Offering is presented.

The letter also asked that on the "Day of Prayer" on Armistice Day, that all women of the Church try to observe it. One thousand leaflets were sent out to all Parishes and Missions to be used on this day.

The Diocesan Devotional Secretary is "contact woman" with the "Central Council of Women's Church Work" in England. Journals have been exchanged and your Devotional Secretary sent Christmas Greetings to the Secretary of this organization, and received an interesting letter in return, which may be read at Convention time.

REPORT OF EDUCATIONAL SECRETARY

For the year beginning May, 1937, to January, 1938

I regret to say that my long illness during the forepart of the year has resulted to a certain extent in the curtailment of the work to be reported for the year 1937.

Unfortunately, many organizations rely on my outlines for their study programs. When no outlines were forthcoming, the work seemed to slow down in many places and so I feel personally responsible for the drop this past year.

While this plan of relying on the outlines sent out by the Educational Secretary has merits, a far more valuable plan is for each organization to consider its own needs or shortcomings, its own interest in community or world events, and then to proceed to formulate programs or to study the same from a Christian standpoint, at all times feeling free to call upon the Educational Secretary for bibliographies, maps, etc. on the same. Such a plan is more or less ideal and must be the goal toward which every organization strives in its Educational work.

In spite of lack of information going out, I find that the Negro problem was more generally studied during 1937 in the Diocese than any other mission study recommended in many years. This I believe was due to the fact that we all realize it is an issue before the whole country and so we are all concerned. I wish we would express our interest in the problem now by helping the work in Keokuk and Des Moines.

The Clear Lake Conference grows surely if slowly and enthusiasm over the 1937 Conference is greater than ever before. In 1938 the women of the Diocese will present, as their main course at the Conference, the topic of Personal Religion or the Reality of God in one's own Life. Those who have been attending the Conference each year say that a desire has been repeatedly expressed for such a course.

The study of General Convention was recommended for the autumn with especial emphasis on the actions of the Convention. The Book-store in New York now has available a packet on the General Convention at 35 cents. This contains the minutes, reports, and main addresses and will give much valuable help for study as well as for programs.

As we enter the new Triennium many interesting subjects are before us. The reports of the Oxford and Edinburgh Conferences of last summer should stimulate our thinking along the lines of Christian Unity and will give us many opportunities for co-operation with other Christian bodies in our own communities. The Forward Movement Commission continues to issue booklets on the Devotional Life for study. World Peace is a major issue at this time and the Headline

Books of the Foreign Policy Association will meet our needs there. To re-invigorate our own organization's life I suggest a study of the various phases of the work together with a study of the Bible and the Prayerbook. Religion is more or less of an unknown tongue today, the history of the Church, Church principles, etc., etc.—all need emphasis in the form of simple, elementary study. A determination to learn the A, B, C's of our religion might answer the question, "What to study?"

May I again emphasize the fact that every woman's organization in the Church is a part of the National Womanhood of the Church and, as such, is committed to carrying on the work through four channels: (1) Prayer or worship, (2) Gifts or service, (3) Study or education, and (4) Fellowship or Christian social life. No one will question the point of prayer or worship being a part of our work. Our gifts or service will depend on the local parish needs; our study will vary with our own particular interests as an organization; and our fellowship or social life as an organization will develop with our need of the same.

When any organization has incorporated these four points into their program they will have taken the first step in building a vital program.

As we enter this Triennium may we not make the adoption of these points our goal for the first year in order that our organization may be an effective instrument for the carrying out of His command, "Go ye."
