Annual Report of the Recording Secretary of the Diocese of Kansas City Branch of the Woman's Auxiliary to the Board of Missions.

*To the Rt. Rev. E. R. Atwill, D. D., Bishop of the Diocese
of Kansas City, and Women of the Auxiliary:*

As required by the constitution of our society, I here-with present my report of the work done by officers and parishes for the year from May 18, 1905, to May 17, 1906.

The three regular meetings were held in Kansas City, the president, Mrs. Atwill, presiding. Our Bishop has always been present and manifested his usual interest and given us encouragement and advice.

Mrs. Atwill appointed Mrs. T. H. Turner of St. Joseph to act as Traveling Secretary. Mrs. Turner visited several parishes, as will be seen from her printed report, and we hope much good will result.

Mrs. A. C. Hunt was elected treasurer at the annual meeting in May. Her removal from the diocese in January made her resignation necessary. At Mrs. Atwill's request, Mrs. James Stannard consented to attend to the duties of the office for the balance of the year.

As our constitution, with a few changes, under which we have been working since our organization, was not entirely satisfactory it was thought advisable to revise it. Mrs. Atwill appointed as a revision committee Mrs. Theodore Gowdy, Mrs. D. A. Weyer, Mrs. J. D. Ritchey, Mrs. C. A. Pugsley and Mrs. S. E. Woodstock. Mrs. Gowdy was made chairman of the committee and presented at the January meeting the proposed constitution as prepared by the committee. With a few amendments it was adopted and is now presented to the society. The committee regards it as a good working constitution and hopes it will prove acceptable.

A call was made during the year from the Missions House in New York for contributions to a stipend for Mr. Knapp, who assists Bishop Rowe in his work in Alaska. The response was so generous that there was a surplus and all was not needed for the purpose for which it was asked. At the suggestion of Miss Emery the amount contributed by this diocese was by vote at the January meeting transferred to St. John's Hospital, Fairbanks, Alaska.

I hope the reports here presented will not only show what has been done, but will also show how much more can be done, and how much more is needed.

CONSTITUTION.

ARTICLE I.

This society shall be called "The Kansas City Diocesan Branch of the Woman's Auxiliary to the Board of Missions."

ARTICLE II.

Its object shall be, by united effort and sympathetic action, to increase the interest, and to unite all parishes and missions in the diocese, in the missionary work of the Church.

ARTICLE III.

All baptized women of this diocese shall be regarded as members of this society.

ARTICLE IV.

The officers shall be: A President, six Vice-Presidents, a Recording Secretary, a Corresponding Secretary and a Treasurer. They shall be elected at the annual meeting.

ARTICLE V.

The diocese shall be divided into six districts, each of which shall have a President, who shall hold the office of Vice-President in the Board. The districts shall be: Kansas City, St. Joseph, Sedalia, Springfield, Carthage and Chillicothe. The districts shall be designated by the Bishop.

ARTICLE VI.

There shall be a Board of Managers, consisting of the diocesan officers and the Presidents of the parish branches. Nine of these shall constitute a quorum for the transaction of business. A preliminary meeting of the Board shall be called one month before each regular meeting of the Auxiliary.

ARTICLE VII.

Each parish and mission shall be represented at the regular meetings by its officers and four delegates chosen by the parish branch. A membership fee of *fifty cents* a year shall be paid in advance by all officers and delegates, and one of *twenty-five cents* a year by all delegates of the Junior branches.

ARTICLE VIII.

Special meetings may be called by the President at any time. There shall be three regular meetings each year, the fourth Thursdays in October and January, and the annual meeting, which shall be held on the day following the annual diocesan council. The Church or other place of meeting shall be designated by the President.

ARTICLE IX.

This Constitution may be amended at any meeting of the Auxiliary, the proposed amendment having been submitted in writing at a previous meeting, by a two-thirds vote of the delegates present.

BY - LAWS.

1. The president shall call meetings and preside over them. In the absence of the president a vice-president shall preside.
2. The recording secretary shall keep the minutes of the meetings, receive all moneys and make a record of them before paying the same to the treasurer. She shall also prepare an annual report for circulation in the diocese.
3. The corresponding secretary shall conduct the correspondence of the Society, shall send notices of the meetings, and shall make a full report of the work annually to the general secretary of the woman's Auxiliary in New York.
4. The Treasurer shall receive and disburse all moneys as ordered by the Society, presenting a report of the same at each regular meeting.
5. The president of each district shall call and preside over meetings and direct the work in her district. She shall also send to the corresponding secretary five days before the annual meeting a list of the delegates from the parishes in her district.
6. It shall be the duty of the treasurer of each parochial branch and mission to send all moneys from the various custodians to the Recording Secretary five days before the meeting at which the amounts are to be reported.
7. A current expense fund shall be raised by assessment of twenty-five cents a year on each member; members of the Junior branches shall pay ten cents a year. These amounts shall be forwarded to the Recording Secretary at least five days before the annual meeting.
8. There shall be a Nominating Committee of five, appointed by the President at the meeting previous to the annual meeting. The officers shall be elected by ballot.
9. These by-laws may be repealed, amended or suspended at any meeting by a two-thirds vote of the members present.

AIMS OF THE WOMAN'S AUXILIARY.

- (a) The increase of the funds of the Board.
- (b) The circulation of missionary publications.
- (c) The education of missionaries.
- (d) The making, collecting and distributing of articles of clothing for missionaries and their families.

MEMBERSHIP.

The membership of the Woman's Auxiliary is composed of those women who by virtue of their baptism are already members of the Missionary Society, and who recognizing the responsibilities such membership entails take an active part in this association also.

No membership fee is required by the General Auxiliary.

OFFICIAL ORGAN.

The Woman's Auxiliary Department of THE SPIRIT OF MISSIONS is, by order of the Board of Missions, the official organ of the Woman's Auxiliary.
