ANNUAL REPORT OF TRAVELING SECRETARY
OF KANSAS CITY DIOCESAN BRANCH,
WOMAN'S AUXILIARY, TO BOARD OF
MISSIONS FOR YEAR ENDING
MAY 14TH, 1908.

Number of letters written 78, number of postals written 32, number of letters received 45, number of postals received 19, number of visits made 22, as follows: Grace Church, Brookfield; St. Paul's, Kansas City; St. Luke's Mission, South St. Joseph (7); Calvary, Sedalia; All Saint's, Nevada; Grace Mission, Kansas City; St. Augustine, Kansas City; All Saints', West Plains; St. Mark's Mountain Grove; Christ's Church, Springfield; St. Philip's, Joplin; St. John's, Neosho; Church of the Advent, Lamar; St. Stephen's, Monett; St. Oswald's, Mound City.

In most of these places the communicants are few, and the faithful women are banded together in a Guild, from which everything is expected, indeed the financial welfare of the mission sometimes depends entirely on this Guild. Knowing this the Traveling Secretary knows also that a separate organization of branch of the Woman's Auxiliary would not be feasible, so in all instances has left the Woman's Auxiliary collects, asking for regular prayer, and where possible, a meeting of Guild once a month for prayer, reading and discussing some article in Spirit of Missions, in most all places has left mite boxes, sent from time to time literature obtained from Church Missions House, and at each place has urged attendance at the annual meeting of the Woman's Auxiliary. The results of these visits may not seem much in evidence in the financial columns of our report, but who can tell the result of faithful prayer, or the widespread influence of this study of missions. The Traveling Secretary has tried as your representative to be the point of contact between you and many isolated church women, to tell them of our work, of the work in the church at large for the extension of Christ's Kingdom, to have them feel that we are all together members of one body. The Church, and that the whole body, is strong only as its weakest member is strong.

In nearly all places I have been most graciously entertained and welcomed in homes and made most comfortable. Where this was not possible,—in Neosho and West Plains,—I was met at station and taken to a hotel, the bill being paid by the Women's Guild. This entertainment, I think, should be credited to Traveling Secretary Fund as much as the amounts given by branches which have made the visits possible.

REPORT OF VICE-PRESIDENT OF SEDALIA DISTRICT.

I have written letters to church women in each of the following towns: Boonville, Marshall, Fayette, Blackburn, Lexington, Warrensburg, Pleasant Hill, Harrisonville, Nevada, Clinton and Versailles, asking if there is an auxiliary, state of finances, number of church papers received by members, and whether the organization is for missionary work alone, or study of missions combined with work.

Three answers have been received by me from Warrensburg, in which the writer said there was no auxiliary, and that they did not feel equal to organizing one; another from Clinton with the report that "on account of our financial condition, we have never organized a Woman's Auxiliary, knowing our inability to make it a success," and a third from Boonville, stating that there was no regular organization, and that they did not care to form one until a priest was in charge of the parish, but that the Woman's Guild contributed annually the sum of ten (10) dollars to the auxiliary through Mrs. Woodstock.

In February I visited Boonville and met with several ladies interested in missionary work. I suggested that a mission study class be organized, and that the "Spirit of Missions" be subscribed for, but through lack of interest nothing has been done. I am hoping that great things will be done in Boonville when there is a priest in charge of the parish, as there are a number of good church people who have done much to keep the church alive.

CONSTITUTION.

ARTICLE I.

This society shall be called "The Kansas City Diocesan Branch of the Woman's Auxiliary to the Board of Missions."

ARTICLE II.

Its object shall be, by united effort and sympathetic action, to increase the interest, and to unite all parishes and missions in the diocese, in the missionary work of the church.

ARTICLE III.

All baptized women of this diocese shall be regarded as members of this society.

ARTICLE IV.

The officers shall be: A President, six Vice-Presidents, a Recording Secretary, a Corresponding Secretary and a Treasurer. They shall be elected at the annual meeting.

ARTICLE V.

The diocese shall be divided into six districts, each of which shall have a President, who shall hold the office of Vice-President in the Board. The districts shall be: Kansas City, St. Joseph, Sedalia, Springfield, Carthage and Chillicothe. The districts shall be designated by the Bishop.

ARTICLE VI.

There shall be a Board of Managers, consisting of the diocesan officers and the Presidents of the parish branches. Nine of these shall constitute a quorum for the transaction of business. A preliminary meeting of the Board shall be called one month before each regular meeting of the Auxiliary.

ARTICLE VII.

Each parish and mission shall be represented at the regular meetings by its officers and four delegates chosen by the parish branch. A membership fee of *fifty cents* a year shall be paid in advance by all officers and delegates, and one of *twenty-five cents* a year by all delegates of the Junior branches.

ARTICLE VIII.

Special meetings may be called by the President at any time. There shall be three regular meetings each year, the fourth Thursdays in October and January, and the annual meeting, which shall be held on the day following the annual diocesan council. The Church or other place of meeting shall be designated by the President.

ARTICLE IX.

This Constitution may be amended at any meeting of the Auxiliary, the proposed amendment having been submitted in writing at a previous meeting, by a two-thirds vote of the delegates present.

BY-LAWS.

1. The president shall call meetings and preside over them. In the absence of the president a vice-president shall preside.
2. The recording secretary shall keep the minutes of the meetings, receive all moneys and make a record of them before paying the same to the treasurer. She shall also prepare an annual report for circulation in the diocese.
3. The corresponding secretary shall conduct the correspondence of the society, shall send notices of the meetings, and shall make a full report of the work annually to the general secretary of the Woman's Auxiliary in New York.
4. The treasurer shall receive and disburse all moneys as ordered by the society, presenting a report of the same at each regular meeting.
5. The president of each district shall call and preside over meetings and direct the work in her district. She shall also send to the corresponding secretary five days before the annual meeting a list of the delegates from the parishes in her district.
6. It shall be the duty of the treasurer of each parochial branch and mission to send all moneys from the various custodians to the recording secretary five days before the meeting at which the amounts are to be reported.
7. A current expense fund shall be raised by assessment of twenty-five cents a year on each member; members of the Junior branches shall pay ten cents a year. These amounts shall be forwarded to the recording secretary at least five days before the annual meeting.
8. There shall be a Nominating Committee of five, appointed by the president at the meeting previous to the annual meeting. The officers shall be elected by ballot.
9. These by-laws may be repealed, amended or suspended at any meeting by a two-thirds vote of the members present.
