ANNUAL REPORT
OF THE RECORDING SECRETARY OF THE DIOCESE OF
KANSAS CITY BRANCH OF THE WOMAN'S
AUXILIARY TO THE BOARD
OF MISSIONS.

To the Rt. Rev. Sidney C. Partridge, Bishop of the Diocese of Kansas City, and Women of the Auxiliary:

I herewith present my annual report of the work done by the officers and parish branches of the Woman's Auxiliary of the Diocese of Kansas City, during the year of 1911-1912.

The three regular meetings have been held and all have been well attended. However, fewer delegates from out of town have attended this year, which we shall hope may not be the case next year.

Our Bishop has always been present and manifested great interest in all that we have done.

It might be well to state at this point that hereafter the work in connection with the Board of Missions, and the work in connection with the Diocesan Missions will be entirely separated. Bishop Partridge feels that it is hardly doing justice to the Board of Missions to longer continue the present arrangements and that in the fall he will create a new society to be composed of women in the Diocese to handle the Diocesan Mission work separately.

Our President, Mrs. S. E. Woodstock, with many others, felt it advisable to revise our constitution, and the President appointed a revision committee, consisting of Mrs. J. V. Ellard, Mrs. V. W. Gayle, Mrs. C. A. Pugsley, Mrs. M. Bland and Mrs. A. A. Maloney. Mrs. Ellard, as Chairman of this Committee, presented at the January meeting the proposed constitution as prepared by the committee, and, with a few amendments, it was adopted.

We hope that the knowledge of Missions is increasing and interest in missionary work is extending among the women of the Diocese, for we have every reason to feel the growth of our Juniors who have made such advancement under their splendid President, Miss Bryan. The intelligent and efficient training given these young workers is shown in their good work done this past year.

We hope and pray that our zeal may be increased and that our efforts may be strengthened for the coming year.

FROM MAY 18, 1911, TO MAY 16, 1912.

Letters written, 62; letters received, 30; postals written, 45; postals received, 40. Owing to the severe weather during the winter, and also to the fact that in many places, it was not convenient, or they were not desirous to have a visit from the Traveling Secretary, not as many visits have been made, as I was desirous of making. CONSTITUTION
OF THE KANSAS CITY DIOCESAN BRANCH OF THE
WOMAN'S AUXILIARY TO THE BOARD
OF MISSIONS.

ARTICLE I.

The name of this Association is The Kansas City Diocesan Branch of The Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is to increase by united effort and sympathetic action, the interest of all the Parishes and Missions of this Diocese in the Missionary work of the Church.

ARTICLE III.

All baptised women of this Diocese are regarded as members of this Association.

ARTICLE IV.

The officers of this Association shall be, the Bishop, ex-officio, a President, three Vice-Presidents (one of whom shall be elected from a parish outside of the See City) a recording Secretary, a Corresponding Secretary, and a Treasurer, all of whom, except the Bishop, shall be elected at the Annual Meeting next after the General Triennial Meeting, and shall serve three years; but the President shall not be eligible for two full consecutive terms.

The President, when elected, shall appoint and define the duties of an Educational and Organizing Secretary, a mite box Treasurer, a United Offering Treasurer, a Little Helpers' Treasurer and such committees as she may deem expedient, each to serve one year; and any vacancy occurring in these appointments shall be filled by the President for the unexpired term.

Any vacancy occurring in any of the elective offices shall be filled by appointment by the Board of Managers until the next regular meeting, at which time the vacancy shall be filled by election for the unexpired term.

The duties of the officers shall be those usually appertaining to their respective offices and such additional duties as may from time to time be prescribed by the By-Laws.

ARTICLE V.

There shall be a Board of Managers consisting of the Diocesan officers and the Presidents of the Parish Branches. This Board shall meet one month before each meeting of the Auxiliary, and at other times upon the call of the President.

It shall be entrusted with the management of the affairs of this Diocesan Branch of the Auxiliary and shall have power to transact all business that may come before it.

ARTICLE VI.

There shall be three regular meetings in each year, viz: On the fourth Thursdays of October, and January, and the An-

nual Diocesan Council. Special meetings may be called by the President at any time.

ARTICLE VII.

Each Branch shall be entitled to representation at all meetings by its officers and four delegates chosen by itself.

Each Branch shall pay in advance such membership fees as may from time to time be fixed by the By-Laws.

ARTICLE VIII.

This Constitution may, with the approval of the Bishop, be amended at any regular meeting of the Auxiliary, by a two-thirds vote of the delegates present.

BY-LAWS

1.

The order of business at all regular meetings shall be as follows:

1. Divine Service.
2. Roll Call.
3. Reading of Minutes.
4. President's Address.
5. Report of Secretary.
6. Report of Treasurer.
7. Report of Corresponding Secretary.
8. Report of Educational and Organizing Secretary.
9. Reports of Branches.
10. Reports of Committees.
11. Unfinished Business.
12. New Business.
13. Elections.

2.

The Recording Secretary, in addition to the regular duties of the office, shall prepare an Annual Report for circulation in the Diocese.

3.

The Corresponding Secretary, in addition to the regular duties of the office, shall make annually a full report of the work of the Diocesan Branch to the General Secretary of the Woman's Auxiliary in New York.

4.

Parish and Mission elections of delegates shall take place during the month preceding the Annual Meeting and be immediately reported by the Local Secretary to the Diocesan Secretary.

5.

A Current expense fund of one hundred dollars shall be provided annually for printing, postage, stationery and expenses of speakers; and this amount shall be apportioned among the various Parish and Mission Branches by a committee of three appointed by the President.

6.

All elections shall be by ballot.

Any delegate may nominate.

Unless there be an election by a clear majority on the first ballot, the chair shall declare the two names having the largest number of votes, and subsequent ballots shall be upon these two names until a majority vote is reached.

7.

Each Branch shall pay an Annual Membership fee of fifty cents for each delegate and officer and no delegate or official shall be entitled to vote unless all the dues and assessments of her Branch shall have been paid in full.

8.

No part of the current expenses of the Association shall be paid from funds contributed for Missionary purposes.

9.

Nine members of the Board of Managers shall constitute a quorum.

10.

These By-Laws may be altered or amended or suspended at any meeting by a two-thirds vote of the members present.
