CONSTITUTION AND BY-LAWS.

CONSTITUTION.

Name.

ARTICLE I.

The name of this organization shall be "The Kentucky Branch of the Woman's Auxiliary to the Board of Missions."

Object.

ARTICLE II.

The object of this organization is to increase missionary interest and activity among the women and children in this Diocese by means of united and systematic effort in prayer, study, work and gifts.

Membership.

ARTICLE III.

The Church itself is the Missionary Society. Every baptized person is a member of this society; therefore, every baptized woman and child in the Diocese should be an active member of the Woman's Auxiliary to the Board of Missions.

Officers.

ARTICLE IV.

The officers of this organization shall be: A President; a first and second Vice President; a third Vice President, who shall be the President of the Junior Department; and two other Vice Presidents, to be elected from parishes outside of Louisville; a Recording Secretary; a Corresponding Secretary; a Treasurer; an Auditor; an Educational Secretary; an Organizing Secretary of Section B; the President of the Junior Department; an Organizing Secretary of the Little Helpers (or Babies' Branch); a Secretary of the United Offering; a Custodian of the United Offering; and a Correspondent of the Church Periodical Club. These,

with the President of each parish branch, or some other active member of the branch, duly appointed, and the Chairmen of Standing Committees, shall constitute the Executive Board to which the general direction of the affairs of this Diocesan Branch of the Auxiliary shall be entrusted. When an officer of the Board is also the President of a Parish branch, said branch shall appoint a second representative.

Annual Meeting.

ARTICLE V.

Sec. 1.—The Annual meeting shall be held in the See City in the spring of each year during the week of the Diocesan Council. When the Council meets in other than the See City this Annual Meeting shall be followed by an adjourned meeting in the Parish where the Council is held. There shall be a Semi-Annual Meeting in the fall of each year.

Sec. 2. The election of Diocesan officers shall be held at the Annual Meeting by ballot, voted upon by the duly appointed representatives from each parish branch. Each Diocesan officer shall be entitled to separate vote on all questions before the assembly.

Sec. 3. A Committee on Nominations, consisting of three members, shall be appointed by the Executive Board in February; this committee shall send to each parish branch nominating blanks for names of two nominees for each office (except those of President of the Juniors, and Organizing Secretary of the Little Helpers), for re-election or for vacancy occurring. Nominations to be returned two weeks previous to the Annual Meeting.

Amendments.

ARTICLE VI.

This Constitution may be amended by a two-thirds vote of the Diocesan officers and the duly appointed representatives (present and voting) at any Annual Meeting, provided

that due notice has been given at a previous meeting of the Executive Board.

BY-LAWS.

Duties of Officers.

ARTICLE I.

Section 1. It shall be the duty of the President to preside at all meetings and to perform all other duties appertaining to the office.

Sec. 2. It shall be the duty of the first three Vice Presidents, in the order of their rank, to perform the duties of the President in her absence, or at the request of the President.

Sec. 3. It shall be the duty of the fourth and fifth Vice Presidents to try to arouse interest in the Auxiliary in their respective sections, to keep in touch with the Diocesan organization and to attend at least one Diocesan meeting during the year.

Sec. 4. The Recording Secretary shall keep a record of the proceedings of all the meetings. She shall make out the order of business for the Presiding Officer. She shall make an abstract of the minutes for the Annual Report and in the absence of the President and the first and second Vice Presidents she shall call the meeting to order, and preside until a chairman pro tem. is chosen. She shall also notify new officers of their election or appointment.

Sec. 5. The Corresponding Secretary shall issue notices of all meetings, prepare an Annual Report for circulation in the Diocese and conduct the correspondence of the organization with Missionaries, with the Secretary of the Woman's Auxiliary to the Board of Missions, and others, as directed by the Executive Board. She shall also act as Chairman of the United Lenten Box Committee.

Sec. 6. It shall be the duty of the Treasurer to take charge of all moneys sent to her for the purposes of the Auxiliary, and to disburse the same as directed. She shall act as Chairman on Credentials.

Sec. 7. The Auditor shall examine the books and vouchers of the Treasurer and present a written report at the Annual Meeting.

Sec. 8. It shall be the duty of the Educational Secretary to have the general supervision of the Educational Work of the Auxiliary in this Diocese and to secure, so far as possible, a leader of Mission study in each parish branch.

Sec. 9. It shall be the duty of the Organizing Secretary of Section B to stimulate the interest of the older girls and younger women and organize them for work.

Sec. 10. It shall be the duty of the President of the Juniors to have the general supervision of the work of the Junior Department, and to keep the department in close touch with the Executive Board of the Woman's Auxiliary.

Sec. 11. It shall be the duty of the Organizing Secretary of the Little Helpers (or Babies' Branch) to secure, so far as possible, a Secretary in each parish, giving definite instruction to each, and keeping a careful record of the work.

Sec. 12. It shall be the duty of the Secretary of the United Offering to arouse interest in this feature of the work, to call a meeting of parochial custodians at least once a year, and to present annually to each branch the object of this Thank Offering.

Sec. 13. The Custodian of the United Offering shall take charge of all moneys sent to her for that purpose. She shall attend the meeting of parochial custodians and notify each branch of the regular time of the opening of the boxes.

Sec. 14. It shall be the duty of the Correspondent of the Church Periodical Club to have the general supervision of this work in the Diocese, obtaining instructions from headquarters in New York. She shall call a meeting of parish Librarians at least once a year.

Sec. 15. Each of these officers except the Vice Presidents and the Auditor, is to present a report at each Board meeting, and a written report at the Annual Meeting.

Sec. 16. The President shall appoint one member who shall represent the Woman's Auxiliary on the Junior Board.

*Executive Board.***ARTICLE II.**

The Executive Board shall have supervision of all the interests of the organization, shall elect the chairmen of all Standing Committees and specify their duties, and shall have power to fill all vacancies in its own body.

*Dues.***ARTICLE III.**

Sec. 1. The running expenses of the organization shall be met by an annual appropriation from each branch (sum not less than \$1.00 from each parish branch, and 50 cents from each Mission). This shall form a fund, out of which shall be paid all Diocesan expenses, such as printing, postage, etc. Only those branches having paid the sum thus designated will be entitled to vote at the Annual Meeting.

Sec. 2. Each branch shall make a voluntary offering each year to form an Educational Fund.

*Meetings.***ARTICLE IV.**

Sec. 1. There shall be quarterly meetings of the Executive Board each year on the morning of the second Thursday of October, December, February and April, preceded by the Corporate Communion, when practicable. Any of these dates may be changed at the discretion of three Diocesan officers.

Sec. 2. Special meetings of the Board may be called at the discretion of the President, or by her upon the written request of three members.

*Parish Elections.***ARTICLE V.**

Sec. 1. The election of parish officers shall be held the meeting preceding the Annual Meeting, and the Corresponding Secretary shall be notified at once of the names and addresses of new officers.

Sec. 2. Each parish branch shall elect three delegates and three alternates to represent it at the Annual Meeting, each parish branch having but one vote. All elections shall be by ballot. No vote shall be cast by proxy.

Quorum.

ARTICLE VI.

Sec. 1. One-fourth of the members having the right to vote shall constitute a quorum at the Annual Meeting.

Sec. 2. Nine members shall constitute a quorum at the Executive Board meetings.

ARTICLE VII.

Sec. 1. No funds shall be raised by the Woman's Auxiliary of the Diocese of Kentucky, in any of its departments, by means of public sales, fairs, or entertainments of any kind.

Sec. 2. Being Auxiliary to the Board of Missions, and not Diocesan in its aims, all work must be as directed by the General Secretary of the Woman's Auxiliary to the Board of Missions.

Amendments.

ARTICLE VIII.

These By-laws may be amended by a two-thirds vote at any Executive Board Meeting, provided, the proposed amendment has been submitted, in writing, at the previous Board meeting.

PRESIDENT'S ADDRESS.

Another year has gone and we can congratulate ourselves that more earnest work has been accomplished than ever before.

Our Mission Study Classes have, doubtless, helped to a new awakening of thought and devotion. We may be proud of one branch of our Auxiliary in which every woman in the congregation is a member. The branches have been increased by additions to their numbers everywhere. Perhaps our Lenten Work was not as large in results as in former years, but the interest was as great and certainly the papers and addresses were far ahead of any we have had in previous years. I would urge on all the branches more attention to the raising of the Apportionment, although the Auxiliary has done better than the parishes still we need more help and more contributions. Can't we learn to raise this money first and consider it as obligatory as our house rent and living expenses? I have been asked to call your attention again to the Spirit of Missions and trust new subscribers will be found to-day.

Most heartily do I thank you for your zeal, earnestness and help and trust the work will go on with such love as shall bring greater results in the future.

MINUTES OF THE ANNUAL MEETING.

The Thirtieth Annual Meeting of the Kentucky Branch of the Woman's Auxiliary to the Board of Missions was held in St. Andrew's Church on Thursday, May 28, 1914, at 10 a. m. There was a Corporate Communion, at which the Bishop was the celebrant, assisted by the Rev. Messrs. Musson and Owens. Rev. Mr. Owens made a short address in which he spoke words of encouragement to the Auxiliary for what it has already done and words of inspiration for what it will do in the future. He said that the Auxiliary stands for unselfish speech, unselfish act, and un-

selfish love. While regretting that Kentucky, along with the Church at large, is behind last year in paying the Apportionment, he has confidence that by God's help we and the whole Church will raise our Apportionment. The Bishop had intercessions for Missions before closing the service as he said there might be some present who would be unable to attend service on next Thursday, the day he has appointed as the special day of intercession for Missions in response to the petition sent to the Council from the Diocesan Auxiliary officers.

After this service we adjourned to the Parish House, where the Bishop opened the meeting with a hymn, the creed and prayers. He announced that he had not expected to be with us this morning as he had planned to be on his way to Oregon to participate in a celebration there, but owing to the sudden death of Bishop Scadding this celebration was called off. He expressed the great loss that Bishop Scadding would be to the Church and after announcing the death of Mrs. Rowe, the wife of the Bishop of Alaska, he asked us to rise for prayers in their memory. Later this meeting by a rising vote took action upon the death of these two persons and Miss Robinson was requested to write to Bishop Rowe and Mrs. Scadding, expressing our deepest sympathy. Bishop Woodcock said he was lending us a gavel which he always used in the Council. It has been given to him by Mrs. Dudley and was used by Bishop Dudley when he presided over the House of Bishops.

Bishop Woodcock spoke words of appreciation and gratitude for what the Auxiliary has accomplished and encouraged us to do greater things in the years to come. He said that while the Auxiliary had worked for the Diocese in paying part of the Apportionment, none of its funds had been expended in the Diocese. The Board of Missions is now facing the most serious crisis in its history and in closing, he asked all the women to both work and pray that the Church may close the year without a deficit.

Mrs. Woodcock then took the chair and asked that the Corresponding Secretary send a note to our beloved President, who was unable to be present. This was received with

a rising vote. The minutes of the last Annual Meeting were read and approved. The Recording Secretary read an abstract of the Board meeting and all general meetings of the year. It now being twelve o'clock, we paused a few minutes for prayers.

The Corresponding Secretary then read her report which showed an approximate value of the year's work in boxes and money to be \$3,998.40.

The Treasurer read her report, in which she noted progress in the amount of money given. She has received \$1,404.14, which has been disbursed according to the detailed report, which is to be published.

In presenting her report, the Educational Secretary asked how we could expect the women to pray effectually and give intelligently to that about which they do not know and she asked the same hearty, warm and responsive appreciation and co-operation for the new Educational Secretary that had been extended to her.

The Custodian of the United Offering was absent, but sent her report which showed \$287.15 on hand. This is a gain of nearly seventy dollars of this time three years ago. The Secretary of the United Offering said she had placed Kentucky's offering of \$1,839.57 on the plate in New York, where the entire offering was \$306,496.66.

The Secretary of Section B reported encouragement and hopes that this section may be the means of having Kentucky share in the gift of life.

The President of the Juniors reported progress with the banner branch consisting of 66 members at St. Stephen's.

The Secretary of the Little Helpers hopes that all branches will follow Advent's lead and have an annual service, as this helps to increase the interest.

The Correspondent of the Church Periodical Club reported active work.

These reports were all approved and ordered printed in the yearly report. The Committee on the Constitution brought in a new Constitution, which was read, but as the luncheon hour had arrived, action upon its adoption was deferred until later. We adjourned to the Primary Class room, where attractive tables had been arranged for luncheon in picnic style, each woman bringing her own box of lunch, coffee and tea being served by the ladies of St. Andrew's.

Upon re-assembling at two o'clock, the Constitution and By-laws were amended and adopted. This Constitution is printed in the front of this report and therefore will not be incorporated in the minutes.

Our President having come she read her address and remained on the platform, although she preferred not to preside.

We then had our program, which consisted of a most helpful conference conducted by Mrs. Frederic B. Stevens, the President of the Michigan Branch. Mrs. Stevens began by telling us how they managed their Auxiliary work in Michigan and then helped to solve many of our problems by answering questions asked from the floor, and by encouraging our women to express their opinions on such

points as the value of educational work, which we concluded to be of paramount importance; the necessity of making meetings interesting and how to enlist interest in the Auxiliary and the United Offering. She emphasized the necessity for personal work and said we must convince all women that this was the greatest work in the world as it is simply carrying out the final command of our Lord and Master.

After Mrs. Stevens had expressed her pleasure at being with us and we, by a rising vote, our great appreciation of having her with us, Mrs. Doan, Chairman of the Nominating Committee, presented her report. The election resulted as follows:

A collection was then taken, which, with the one at the service, amounted to \$33.50, of which \$25 will be given to the Foreign Clergymen's Life Insurance Fund, and the remainder to our Educational Fund.

Mrs. Woodcock asked Mrs. Musson to explain about the Diocesan Correspondents' Branch, which we are about to inaugurate, as it was originally Mrs. Musson's suggestion. Mrs. Saunders then presented the report of the Committee with the letter to be sent, and both will be published in

this report. This committee already has the names of 381 women whom they hope to interest.

Mrs. Quinn asked for a few moments in which to express the gratitude of the Paducah Branch for all the assistance that had been given to it by the Diocesan officers. Realizing that the weakness of our Auxiliary lay in our inability to interest the parishes outside the See City, she asked that the Paducah Branch be made a committee to try to overcome this and find out just where the difficulty lay. This was granted by a rising vote, as we greatly appreciated Paducah's offer. Mrs. Quinn extended a most cordial invitation to every one present to attend the adjourned session of next year's meeting at Paducah.

Mrs. Hamilton was ill and Mrs. Moise presented the report of the Committee on Lenten work.

Mrs. Adams read a letter from Miss Emery in regard to our question about a badge, in which Miss Emery suggested that if Kentucky considered a badge desirable she bring forward a resolution concerning this to the Triennial of 1916.

There being no further business, the meeting was adjourned.

REPORT OF RECORDING SECRETARY.

Regular quarterly Board meetings of the Woman's Auxiliary were held on the first Thursday of November, and the second Thursday in December, February and May, with an average attendance of eighteen. Mrs. Dudley presided at the November meeting and Mrs. Woodcock at the other three. These meetings were all opened with the creed and prayers.

At the November meeting Mrs. Mockridge said that she was greatly impressed by the help, inspiration and power that came from the Corporate Communions in New York and it was carried unanimously that henceforth our

regular Board meetings would begin with a Corporate Communion at 9:30 a. m. in the Cathedral, the business session immediately following. It was also announced that this Triennial changed the name of the Babies' Branch to that of Little Helpers, and that hereafter we would try to reach older girls and young women by organizing them into branches of Section B of the Woman's Auxiliary. A branch of this kind has been started in St. Andrew's Church. The delegates to the Triennial in New York reported that they had pledged \$25.00 to Mr. Russell, the first native priest of Liberia to come to a General Convention for his work in Liberia and \$75.00 to Dr. Teusler for St. Luke's Hospital, Tokyo, which is such a strong Christian influence in Japan. A letter was read from Miss Emery thanking Kentucky for its part in the gift of \$16,000.00 presented to her and to her sister during the Triennial. Mrs. Musson said that there were over 3,000 female communicants in the Diocese of Kentucky who were not members of the Woman's Auxiliary, and that she felt we ought to make more effort to reach these women. She moved that we create a Correspondence Branch of the Auxiliary and that every woman in the Diocese be asked to pray daily for missions and to give ten cents yearly. This was heartily approved and a committee, composed of Mrs. Adams, Mrs. Saunders and Mrs. Moise, with Mrs. Woodcock and Mrs. Musson as advisory members, was appointed to devise some means of carrying out this suggestion. This committee reported progress at each quarterly meeting and will report in full at the Annual Meeting.

At the December meeting, it was decided to send our Lenten work to St. John's-in-the-Wilderness, Allakaket, Alaska, and to St. Mary's Sewing School, Middlesboro, Ky. There being a vacancy in our Board, Miss Buchanan was unanimously elected Secretary of Section B to try to arouse interest among the older girls and young women. A new branch of Section B at the Cathedral was reported. It was moved, seconded and carried that in future all Secretaries or Chairmen of committees will be re-imburshed for money spent for postage and printing for this Auxiliary.

At the February meeting Mrs. Brown brought forward the recommendations of a committee appointed at the Triennial, authorizing a separate Executive Board for the Juniors. After much discussion, it was decided that this was too important a matter to decide at once. The Secretary of the United Offering reported that she had been impressed in her visits to outlying parishes with how interested the women were in parochial matters and how ignorant they were about Auxiliary affairs. This discussion brought out the fact that the executive officers are more than willing to go to any branch whenever requested, unless unavoidably prevented. If the branches will send a request to the Board for information on any line some one will be sent to inform them. A new branch was reported at Emmanuel Chapel, which has reached the ideal of having every woman communicant a member of the Auxiliary. The Corresponding Secretary was requested to write to headquarters asking that some steps be taken before 1916 looking to a national badge for the Woman's Auxiliary, such as the Girls' Friendly Society and the Daughters of the King have. It was thought this would be helpful at the time of General meetings in the Church.

At the May meeting, the Corresponding Secretary read a letter from Miss Ralston, of Middlesboro, expressing her great appreciation of the boxes sent to St. Mary's Sewing School. It was decided to send \$25.00 out of the offerings at our Annual Meeting to the Foreign Clergyman's Life Insurance Fund, and to give the remainder to the Educational Fund. The Committee on Revision of the Constitution submitted a new Constitution, which after some slight changes will be recommended to the Annual Meeting for adoption.

There was a called meeting of the Board held at Mrs. Dudley's on April 16th, to discuss the recommendations about the Junior Executive Board. After much discussion it was decided to adopt these recommendations, which give the Junior Department a separate Executive Board with full power to guide and direct its work, provided that nothing ever be done contrary to the Constitution of the Woman's Auxiliary. Mrs. Adams moved that a committee be

appointed to revise our Constitution. This committee composed of Mrs. Adams, Mrs. Musson, Mrs. Brown, Miss Robinson and Miss Winston, to submit the new Constitution to the Board in May and have it put in proper form to be voted upon at the Annual Meeting. Miss Robinson announced that we would have a large Auxiliary Institute in October, and urged hearty co-operation.

On St. Michael's and All Angels' Day, September 29, a United Offering Service was held in the Cathedral. This was followed by an experience meeting in the Cathedral House, which was opened by the Bishop and presided over by Mrs. Woodcock.

On November 10th, there was a general meeting at the Cathedral House to hear Deaconess Goodwin, student secretary of the Board of Missions, tell of her work, at which the offering of \$22.55 was given to Deaconess Goodwin.

On November 19th, our first semi-annual meeting was held in Dudley Memorial Hall of the Cathedral House, at which reports were heard from our delegates to the General Convention.

United Lenten meetings were held on the six Fridays during Lent, at the Church where the United Services were held with an average attendance of 114. The general topic of our United Lenten Study was "The then and how of Missionary Work," or "The Church's Pioneer Work," with the following program: (1) "When the Church crossed the Ocean to claim a new continent," by Miss N. H. Winston; (2) A Missionary Demonstration—"The Gift of Self," under the direction of Mrs. C. E. Craik and Mrs. Tevis Goodloe; (3) "The Church at Work Among the Indians," by Mrs. Harris Mallinckrodt; (4) "The Work of the Protestant Episcopal Church in the Appalachian Mountains," by Miss Annie Anderson; (5) "When Light Arose in the Sunrise Kingdom with Healing in Its Wings," by Mrs. H. S. Musson; "The Church Methods Then and Now," by Miss L. L. Robinson. The offerings at these meetings amounted to \$73.06, two of which went to the Kentucky mountains, two to St. Luke's Hospital, Tokio, and two to the New China Fund, after the expenses of packing the boxes were paid.

At the second Lenten meeting a letter from Miss Emery was read urging us to work harder for our Apportionment, which should always be the first work of the Auxiliary. The following were appointed to serve on the Nominating Committee, Mrs. Edward Doan, Chairman; Mrs. Wm. N. Cox and Mrs. Thos. Archer.

At the third Lenten meeting, a letter of thanks was read from Mrs. Chapman, of Brevard, N. C., for a barrel of clothing sent her for the mountain work. A letter from this Auxiliary was sent to our good friend, Mr. McKellar, who so kindly sends our boxes free, when we heard he was ill.

At the fourth Lenten meeting, the Educational Secretary requested every one to bring some suggestion to the Annual Meeting as to the best way to raise an Educational Fund to defray the expenses of holding institutes. At this meeting we were authorized to use part of the offering at the Annual Meeting to pay the expenses of a speaker at that time, but as Mrs. Stevens offered to pay her own expenses, this offering will be devoted to other purposes.

At these meetings, Mrs. Glazebrook, Mrs. Poston and Miss Robinson announced that it would be impossible for them to stand for re-election. Mrs. Dudley expressed our regret and asked the parochial presidents to remember this in filling the nominating blanks.

I was privileged to attend the last meeting of one of these classes; and, as I heard the girls talking freely of one's responsibility to the missionary work of the Church, I could not help being thrilled by the thought, that perhaps through Section B and the study classes combined the Woman's Auxiliary of Kentucky might yet rise to its supreme privilege of contributing the greatest of all gifts that of life for the spread of Christ's Kingdom.

REPORT OF JUNIOR DEPARTMENT.

As we look back over our year's work, we see but little increase so far as mere figures are concerned, and still 'tis undoubtedly the best year by far that we have yet completed. The failure to increase our enrollment is very easily accounted for, for our Juniors, after a very few years of work cease to be Juniors and are ready to leave our ranks. We are delighted, therefore, to welcome this year a Section B of the Woman's Department, and we are trusting that we may look forward, in the very near future, to a regular graduation with exercises appropriate to the occasion, and in this way to definitely transfer our girls from one Department to another.

During the past year, we have added four new branches: The Boys of Advent; Department II. at St. George's, Parkland, and Grace Church, Paducah; and Department III. at Calvary, Louisville. This suggestion from headquarters to

separate our Juniors into three distinct departments we welcome as being most helpful to our work.

The year's work began most appropriately, with a splendid Institute, under the leadership of Miss Emily Tillotson, at that time Educational Secretary of Southern Ohio, but now in charge of the Educational Department of the Woman's Auxiliary at the Church Mission House. This Institute lasted four days and was regularly attended by more than thirty women, who signed a personal pledge, promising, if possible, to lead a class during the winter. The report of our Educational Secretary gives a splendid sequel.

Each day of the Institute was opened with Corporate Communion and preceding the afternoon session each day, splendid "impersonations" were given, under the auspices of Mrs. Craik and Mrs. Tevis Goodloe. On one of these days, twenty young girls from the Home School gave a most excellent debate on the subject: "Is China ready to be a Republic?" The arguments presented by the girls were most unusual and would have done credit to minds much more matured.

Following the Institute was a most successful conference for the Junior leaders. The Junior Book, "Forward March," was used as the text-book, and as a result, eight study classes were held in the Junior Department with most excellent results.

Our Annual Meeting should be seen to be appreciated. 'Tis always held late in the fall and the gifts for the United Christmas box are on exhibition. This year our 400 gifts were sent to an Indian School, at Ross Fork, Idaho, and 100 extra gifts to a Mission at Graniteville, S. C., where one of our Louisville girls was engaged in Settlement Work, under Deaconess Sands.

As a part of our program on Junior Day, the President of the Cathedral Branch gave a most beautiful monologue in costume, entitled "Singing Thrush." Seated at the entrance of a wigwam, and in the picturesque costume of her tribe, the recitation brought most vividly before the minds of our Juniors, the mode of life of the little Indians, to whom our gifts were to be sent.

We feel that the highest achievement we have reached this year is the privilege recently granted us by the Executive Board of the Woman's Auxiliary and with the hearty approval of our Bishop, namely, the privilege of having our own Executive Board.

As this suggestion has come to us directly from headquarters, being one of the recommendations offered at the time of our last General Convention, we feel that nothing but good could result.

In closing may I add just a word of appreciation to our faithful leaders. The problems of the Juniors are both numerous and difficult and your secretary feels that to our Junior leaders, a world of credit is due for the splendid results of the past year. And as we feel that our responsibilities have increased with our privileges, may we ask your heartiest co-operation and will you not add your prayers to ours for the success of the work, during the coming years.

REPORT OF LITTLE HELPERS.

It seems as though every organization has occasionally what may be called an off year and to look at the report of The Little Helpers from a purely monetary point of view it would seem as though that organization had just completed such a year.

But in no branch of the Woman's Auxiliary is money the end; and no leader of The Little Helpers should think of her branch as a means of getting money—much or little—for Missions.

The most encouraging sign of growth is that the parish Secretaries are, each year, less content to simply enroll children and receive their gifts of money, but are planning how best to develop this kindergarten of the Woman's Auxiliary. Three of our branches have reorganized this year; two very late in the spring, and I can't help from feeling that next year will be the banner year of the Babies' Branch.

If the parish leaders might meet together early in the fall for consultation and conference I think it would be of untold value to each parish leader.

With Advent setting us an example one of the reorganized branches expects to have its annual service. This service can be a great help, not only in spiritualizing the work, but by acquainting the mothers with the object and results of The Little Helpers. Each year as the children, grow too old for the Babies' Branch, pass on their names to your Junior leader. Keep the connection very close between the Juniors and Little Helpers.

The value of this department is that it exists only to train the young children to take their part in the mission work of the Church.

Let us strive in our monthly reports before the Woman's Auxiliary to reach and interest more mothers. If we could only get these mothers to realize the opportunity offered by the Little Helpers—the result would be far beyond our expectations for the Glory of God and the fulfilment of that most important of all missionary prayers.

REPORT OF THE SECRETARY OF UNITED OFFERING.

On September 29, 1913, St. Michael and All Angels' Day, the second annual United Offering Service was held in Christ Church Cathedral, Louisville. The interest in this service is growing and is most encouraging.

On Thursday, November 13th, there was held the Annual Meeting of The Parish United Offering Treasurers. This was the first meeting since the Triennial United Offering Service of Thanksgiving in New York. It was a most enthusiastic meeting and much interest was shown in hearing of that great Thanks-Offering Service and thankfulness for the offering of \$306,496.66.

Kentucky had made her largest offering, \$1,839.57, over \$200.00 more than in 1910.

The Treasurers took as their aim for the next three years—"An offering from every woman of the Diocese."

The minutes of this meeting were sent to all Treasurers, who were unable to attend.

New branches have been started in Section B of the Cathedral; St. John's, Lagrange; Russellville, Woman's Auxiliary, and Section B of Emmanuel, and Section B of St. Mark's.

I have received written reports of the work from Hickman and Paducah.

I have spoken to Section B of the Cathedral, twice at St. Luke's, Anchorage; St. James', Pewee Valley; St. John's, Lagrange; Emmanuel, Louisville; St. Paul's, Louisville; Church of the Advent, and Church of Our Merciful Saviour, Louisville.

There have been three hundred (300) boxes given out since November, 1913.
